DESCRIPTION

 FIG. 2 is a side elevation view thereof which is the same as the opposite side view thereof;

 FIG. 4 is a front elevation view thereof which is the same as the rear side view thereof; and,

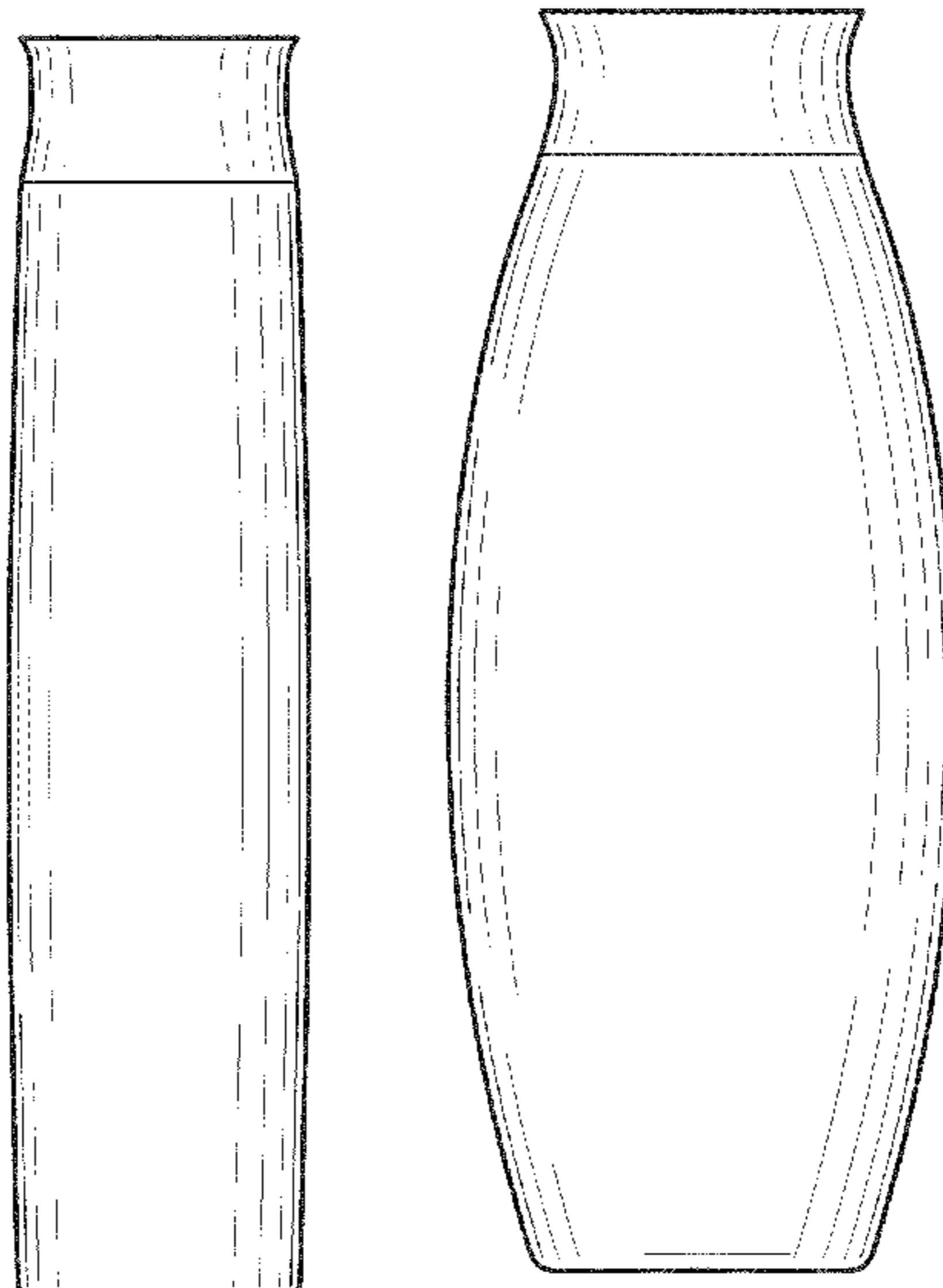

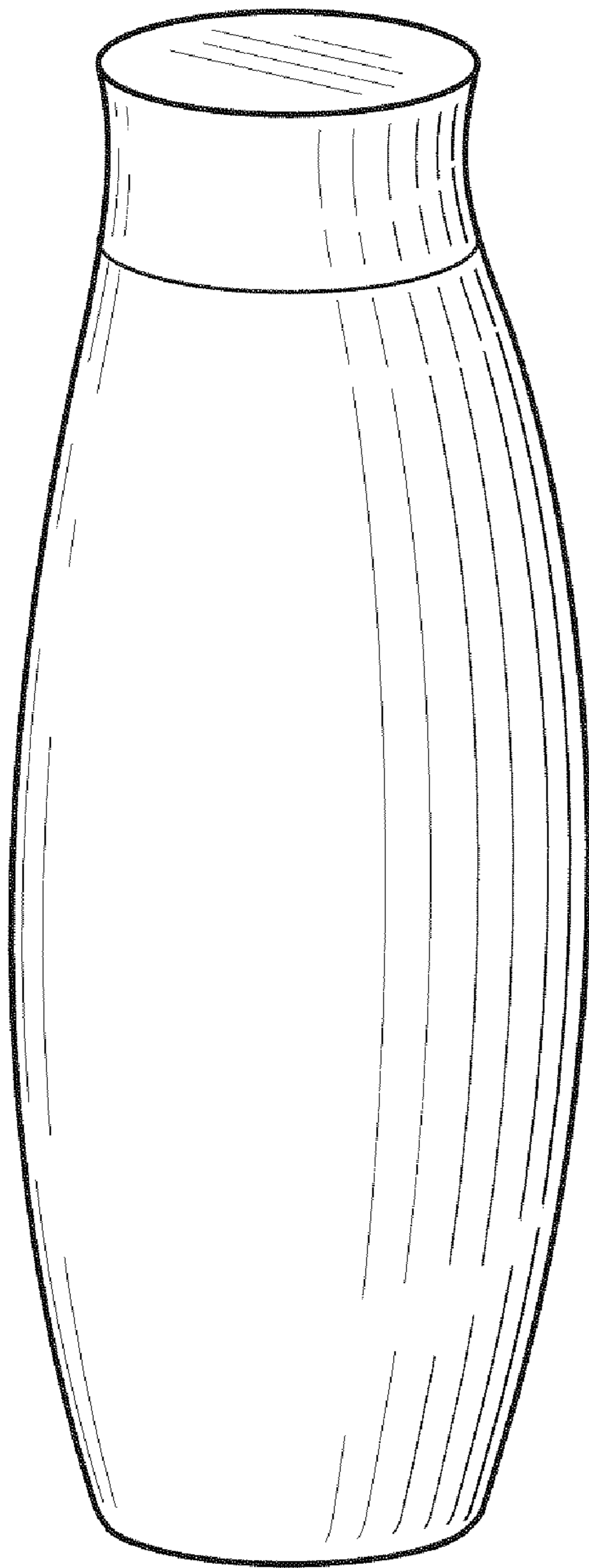

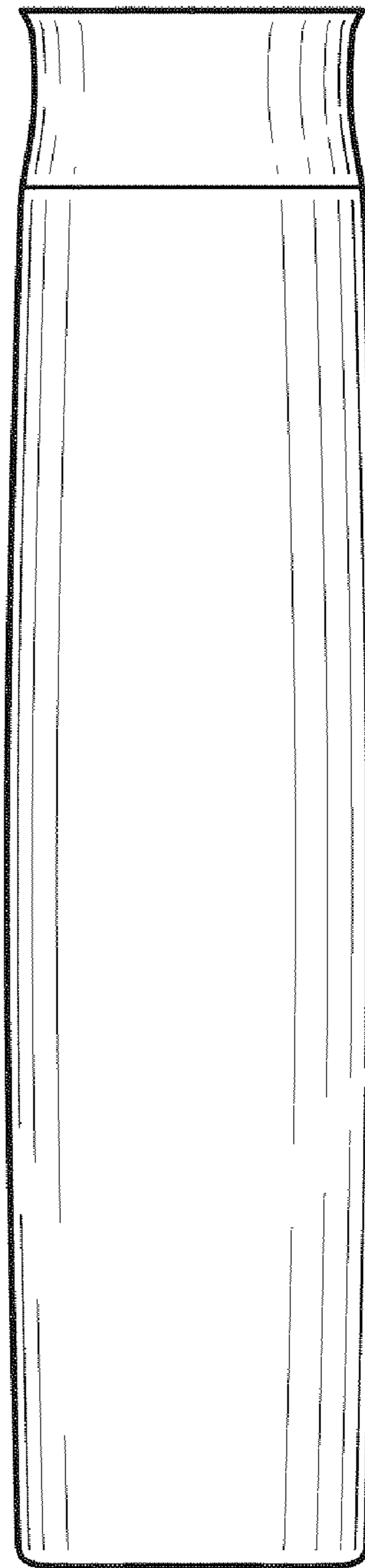

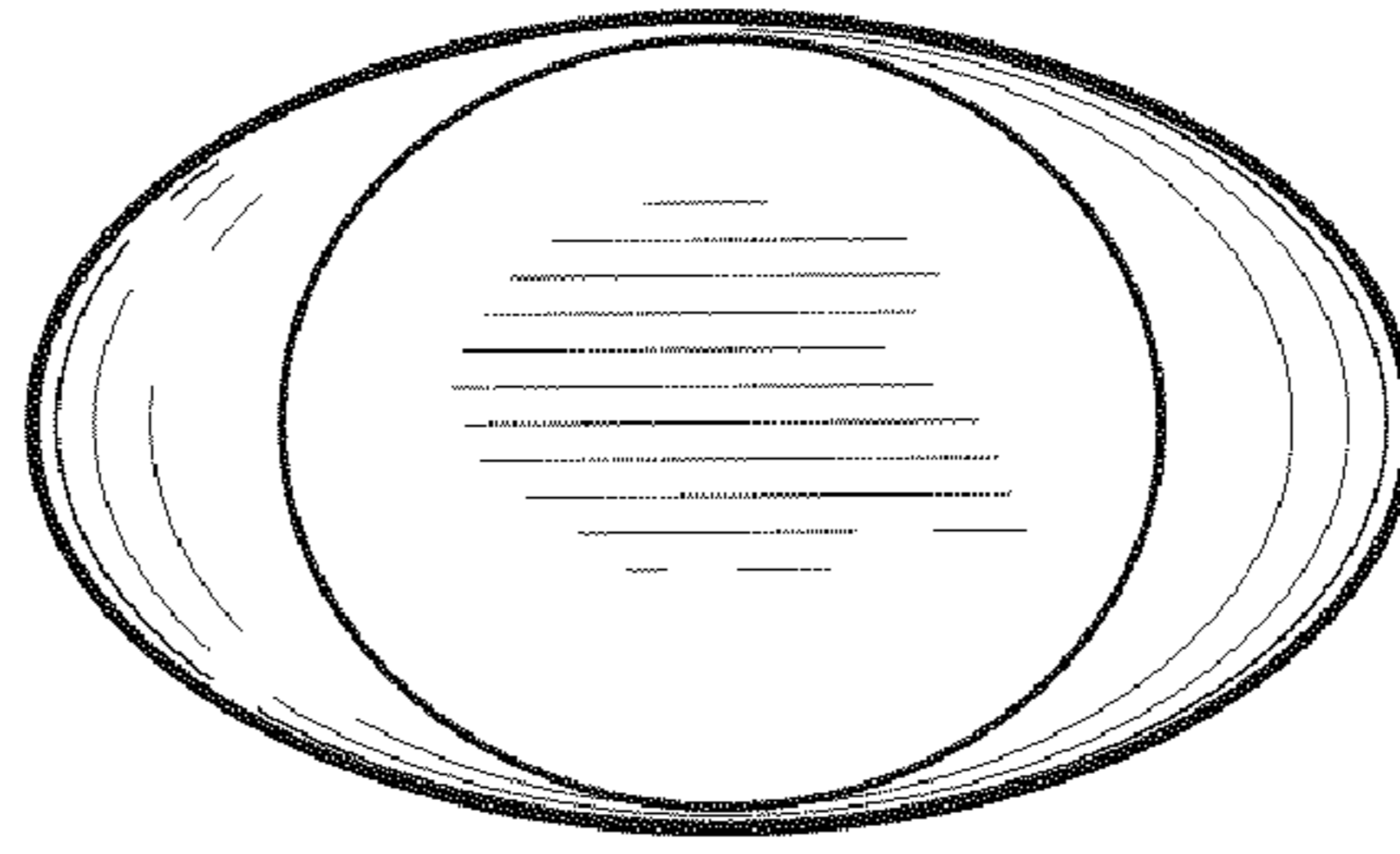

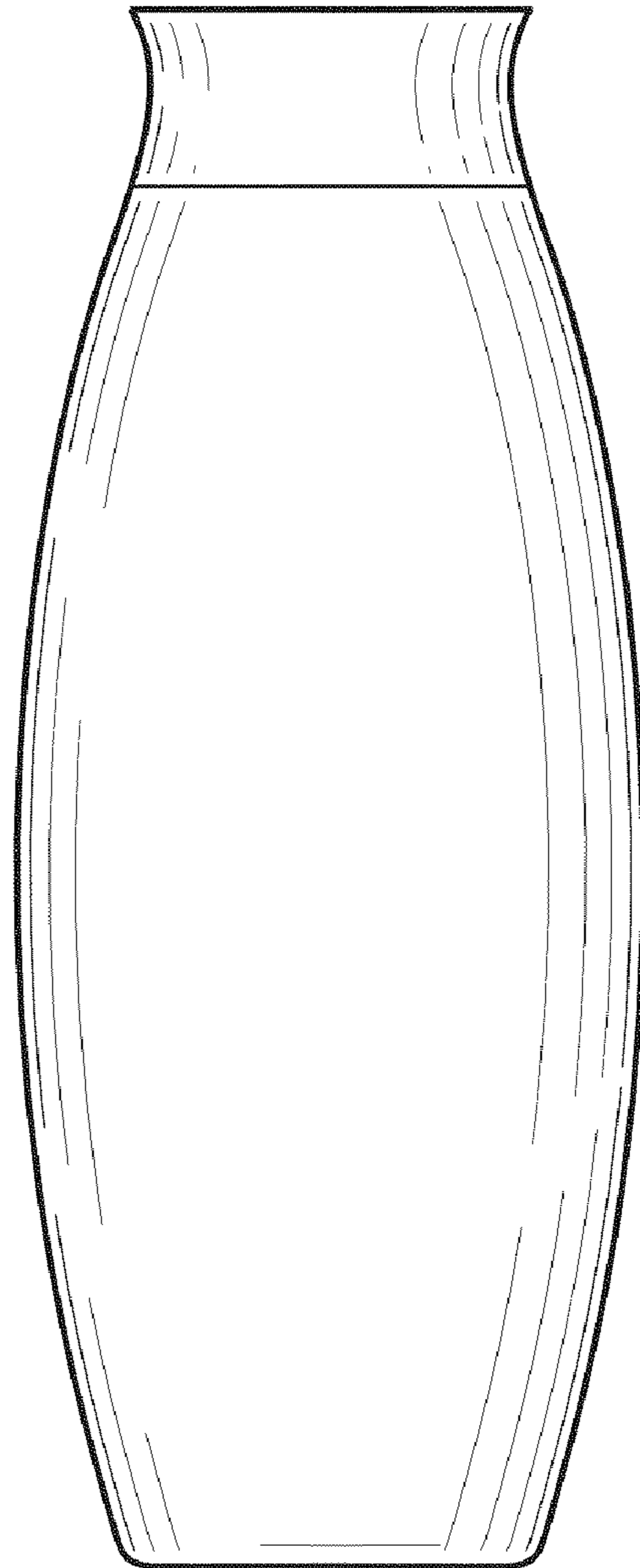
