(57) **CLAIM**

The ornamental design for a motor vehicle and/or toy replica thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side perspective view of a motor vehicle and/or toy replica thereof showing our new design;

FIG. 3 is a front view thereof, the rear view being a mirror image thereof;


FIG. 4 is a top view thereof;


FIG. 5 is a left-side view thereof; and,

FIG. 6 is a right-side view thereof.


The claimed design is indicated by the relatively dark portions in FIGS. 1–6, while the relatively light portions thereof are environmental and form no part of the claimed design.

The broken lines are for the purpose of illustrating portions of the motor vehicle and/or toy replica thereof and form no part of the claimed design.








