(57) **CLAIM**

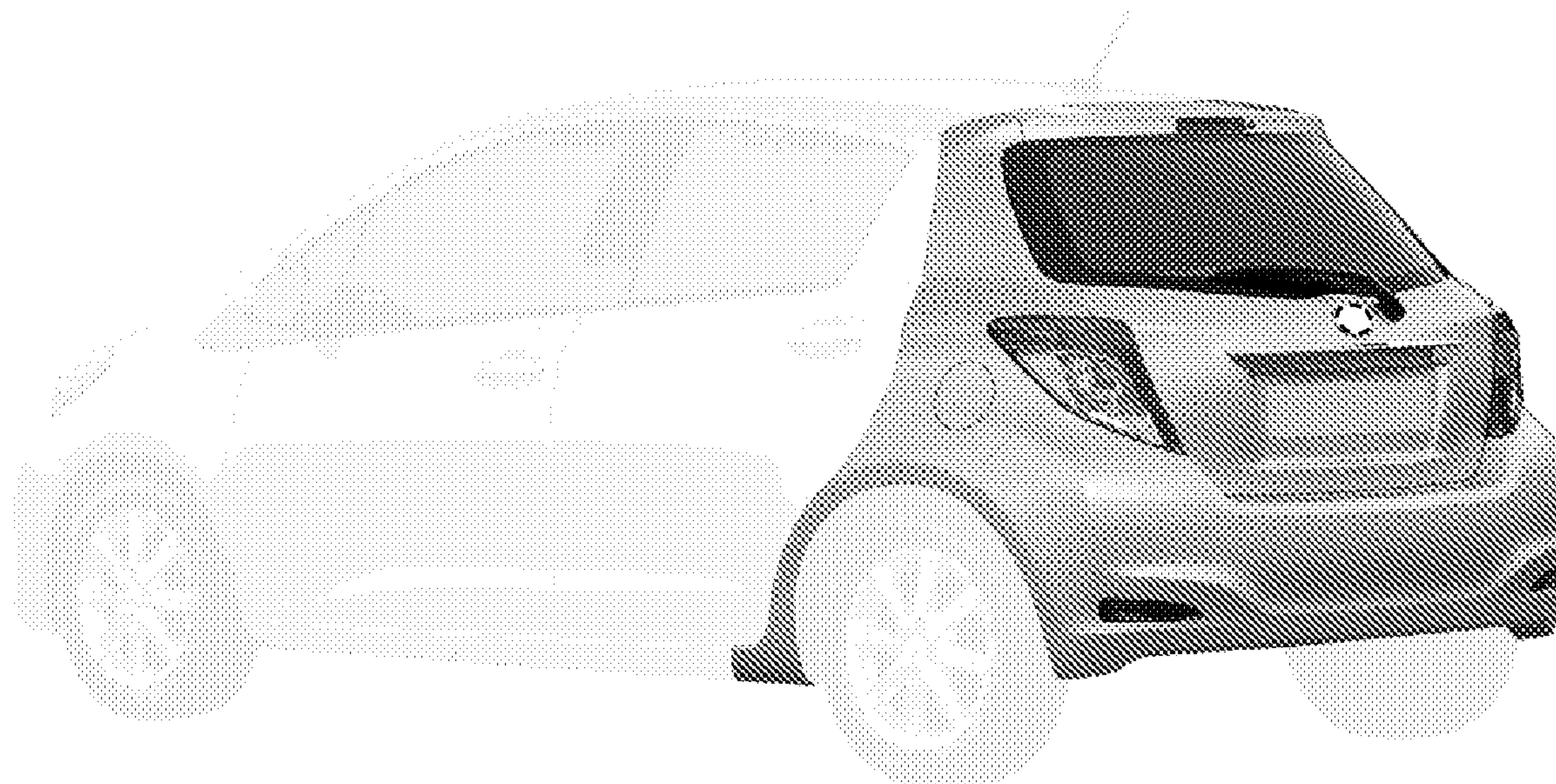
The ornamental design for a motor vehicle and/or toy replica thereof, as shown and described.

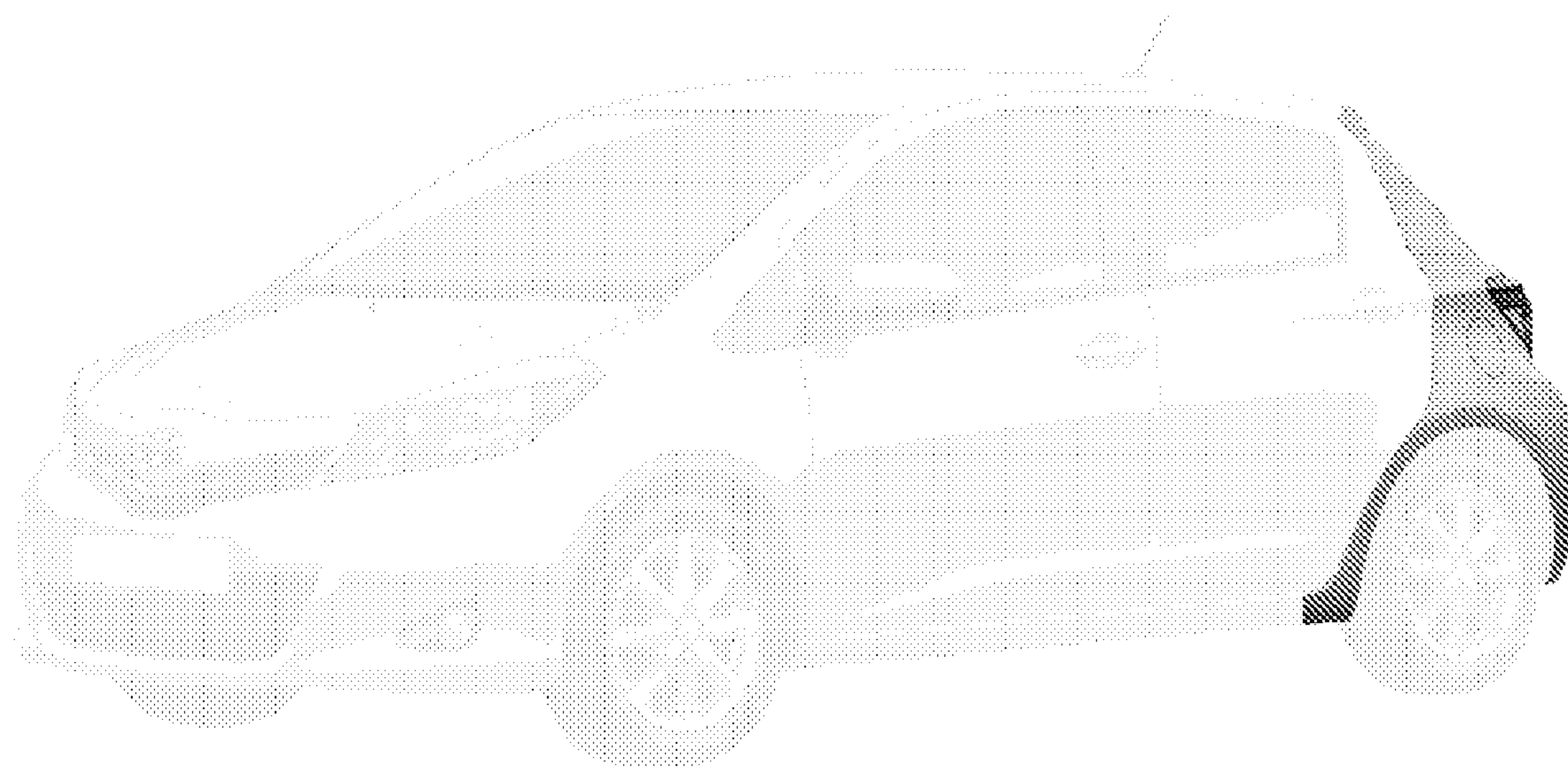
**DESCRIPTION**

FIG. 1 is a left-side perspective view of a motor vehicle and/or toy replica thereof showing our new design;  
FIG. 2 is a right-side perspective view thereof;  
FIG. 3 is a front view thereof, the rear view being a mirror image thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a left-side view thereof; and,  
FIG. 6 is a right-side view thereof.

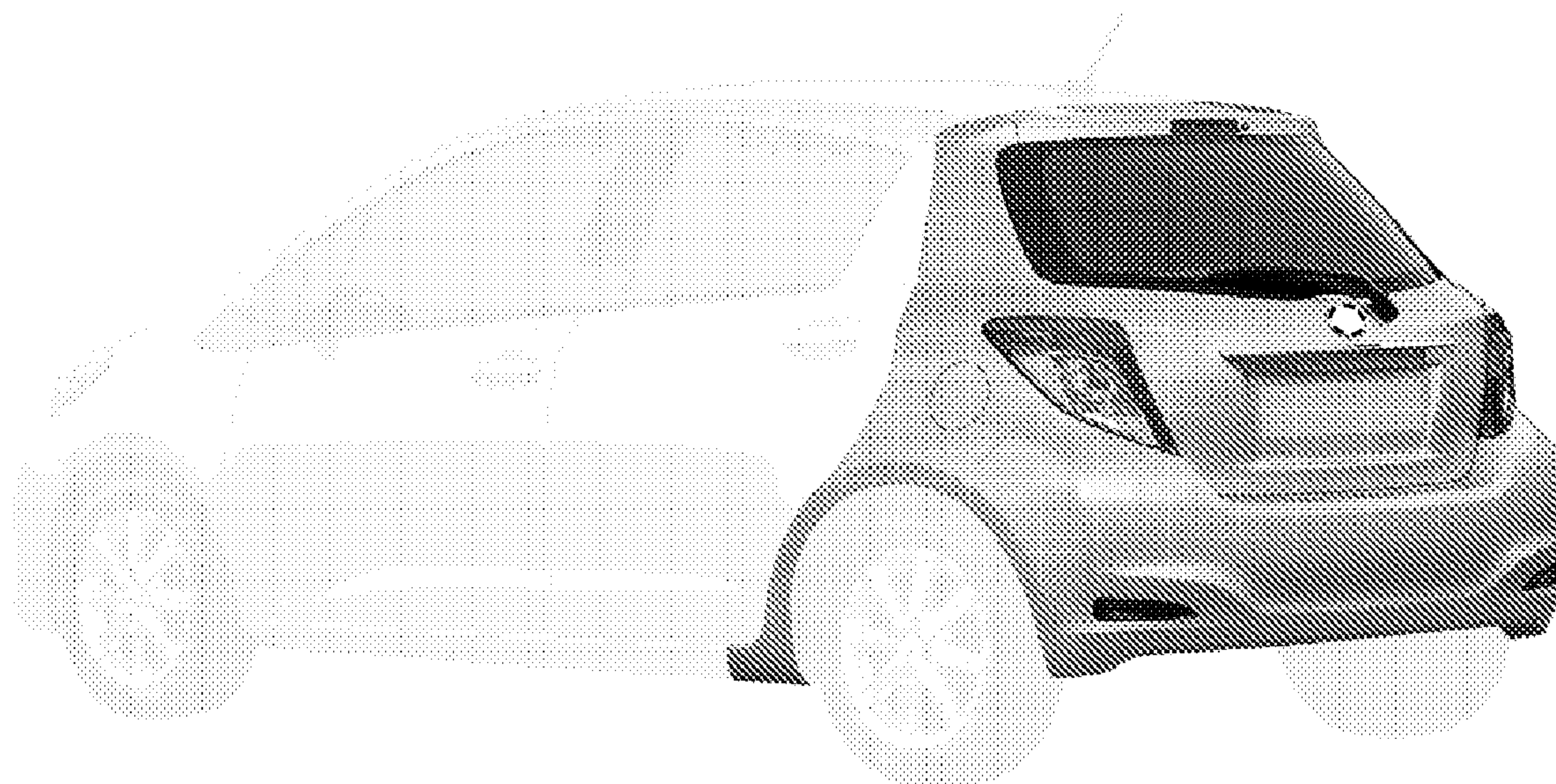

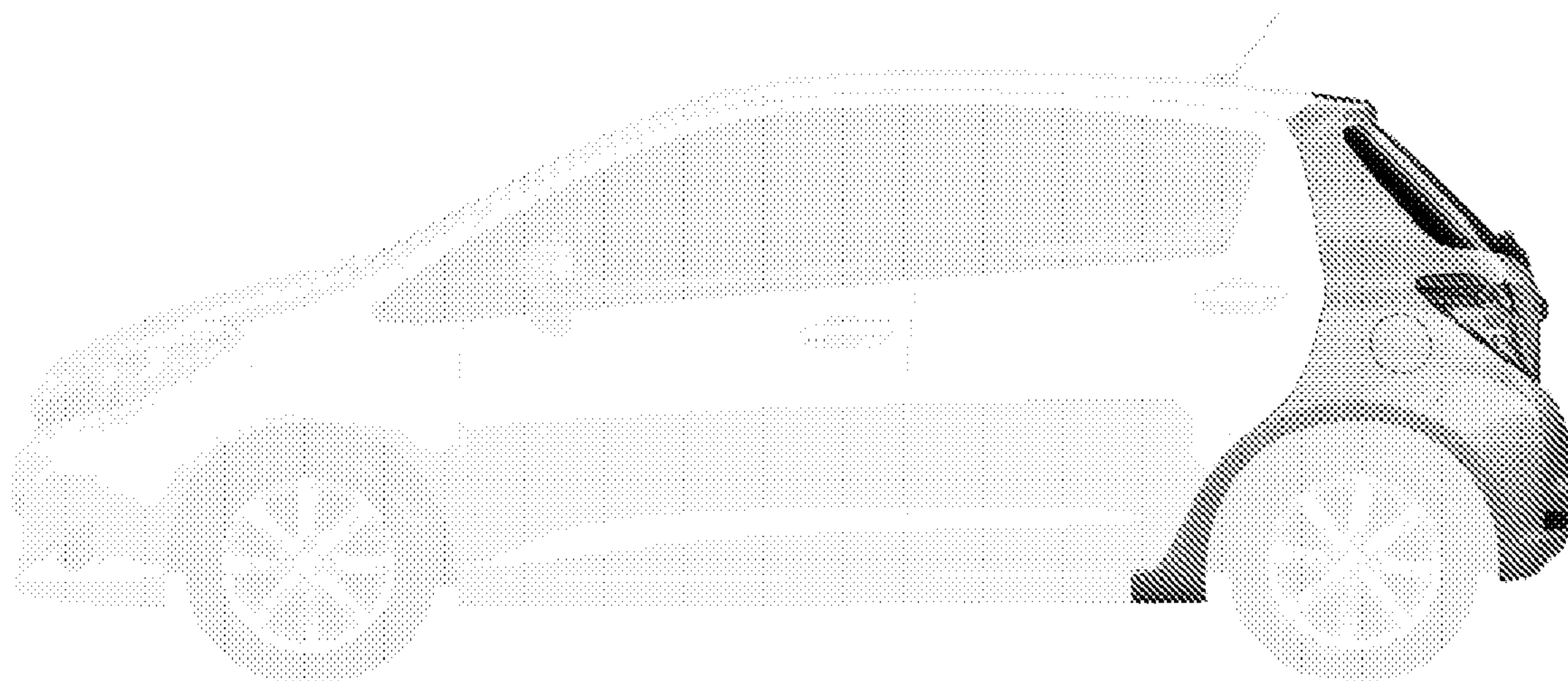

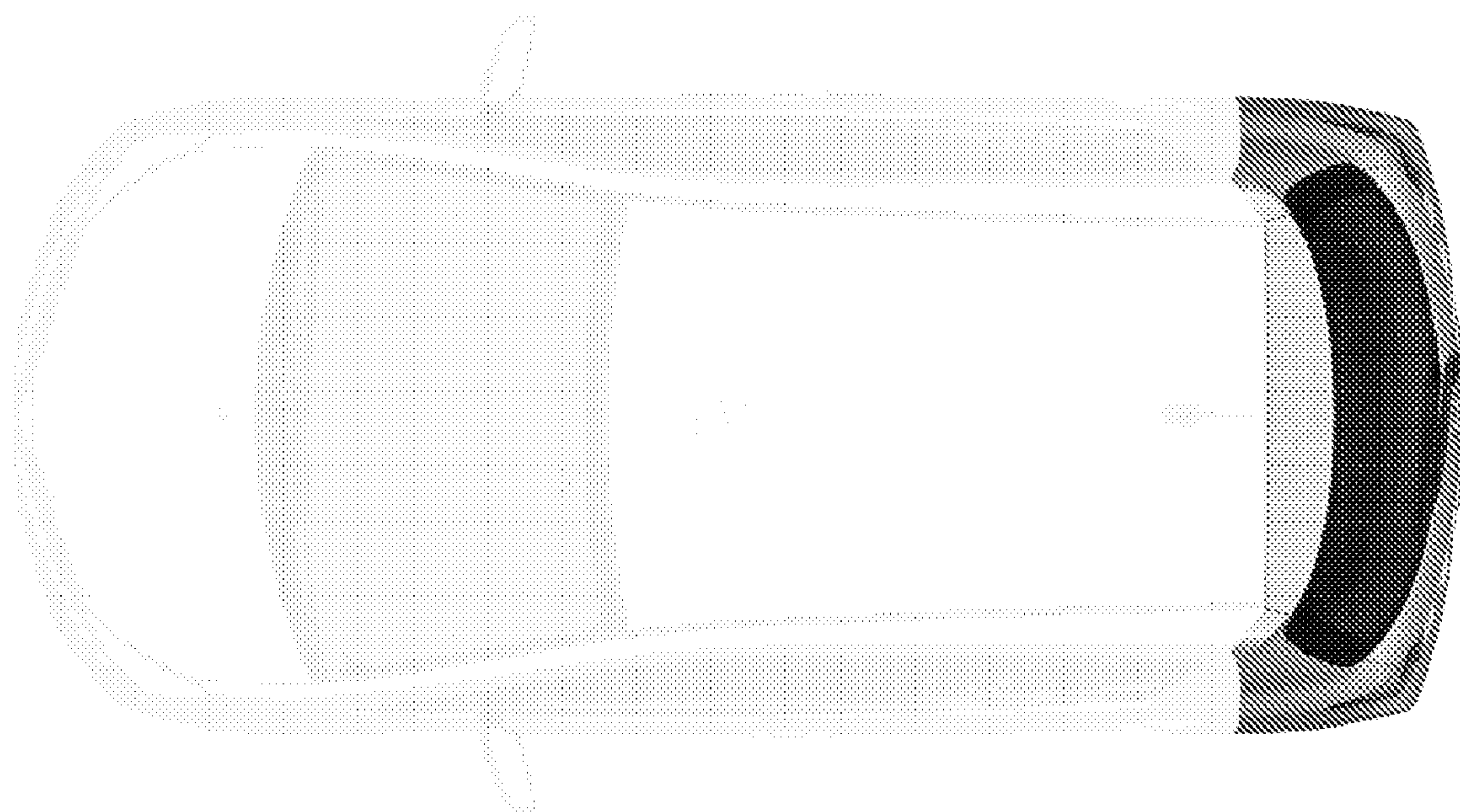

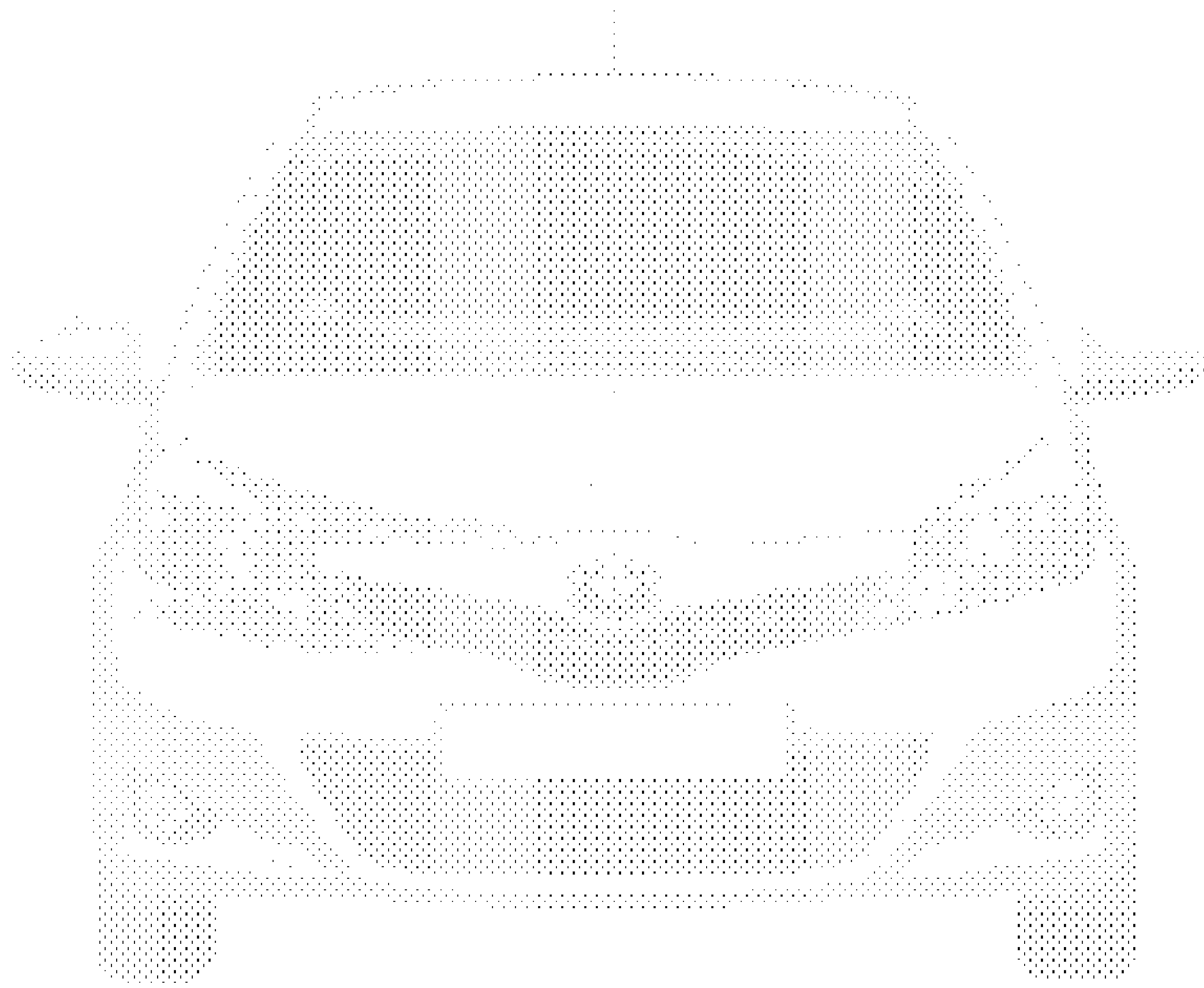




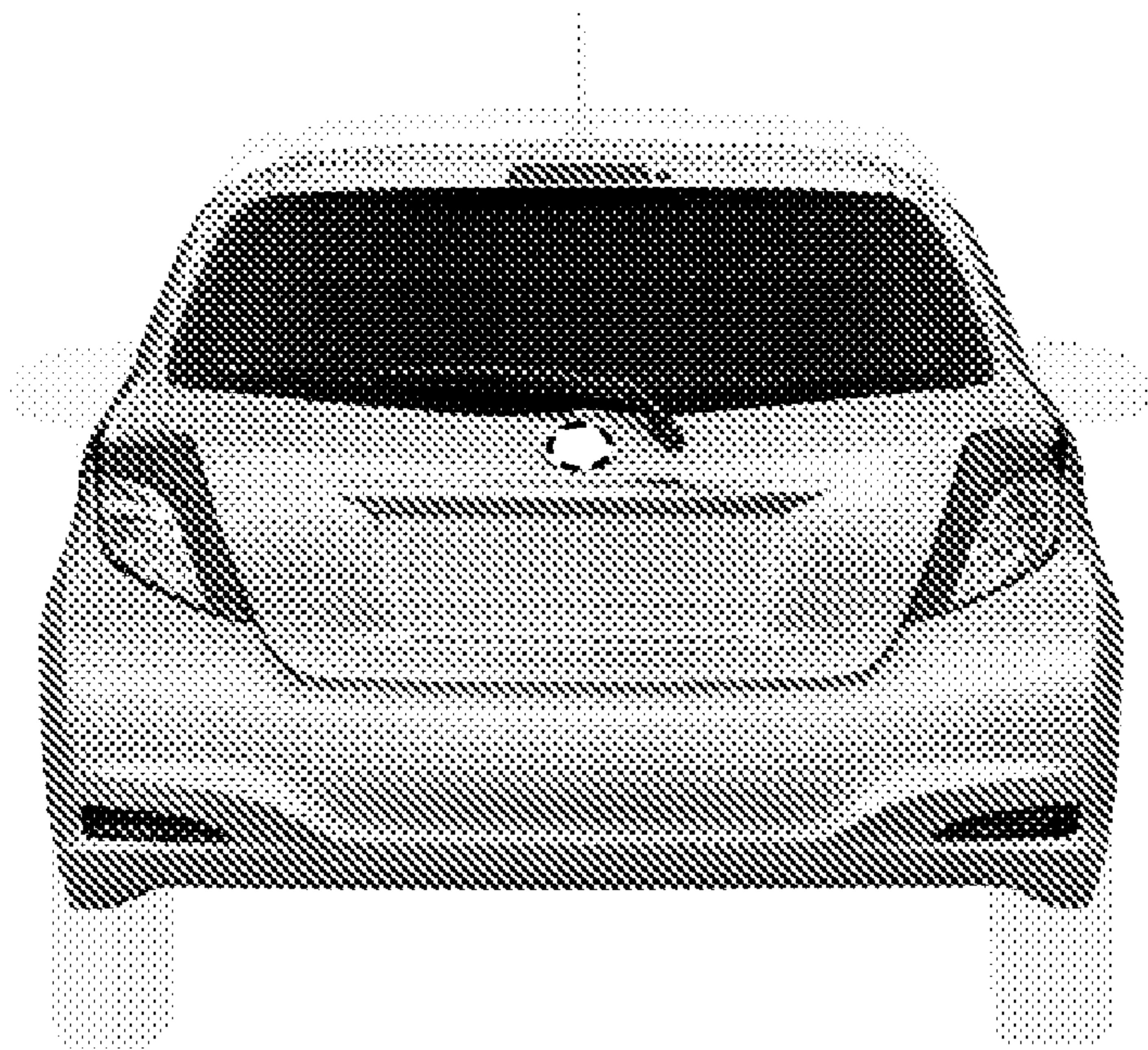
