DESCRIPTION

FIG. 1 is a front isometric view of a case showing our new
design;

FIG. 5 is a left view thereof;

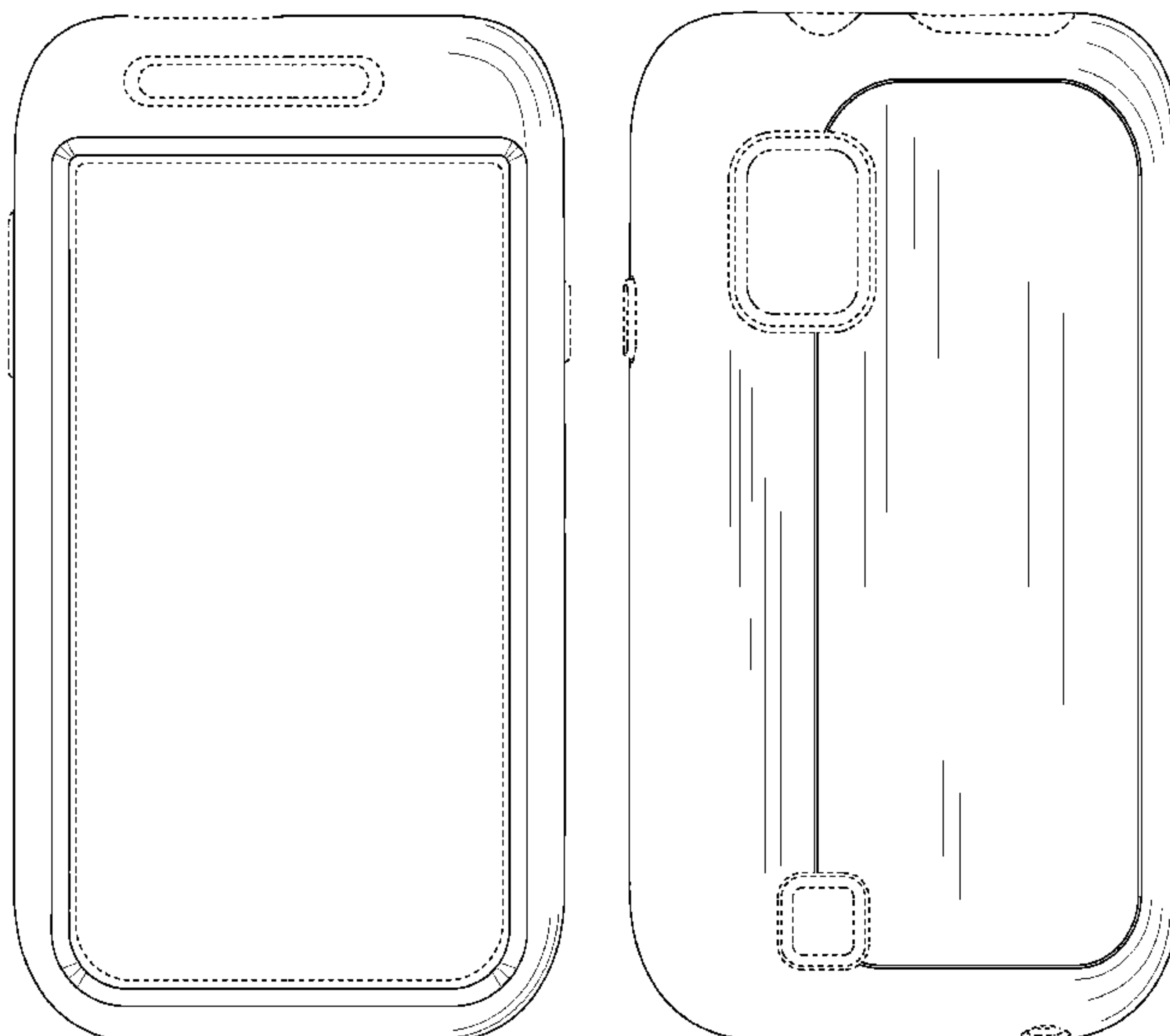
FIG. 6 is a right view thereof;

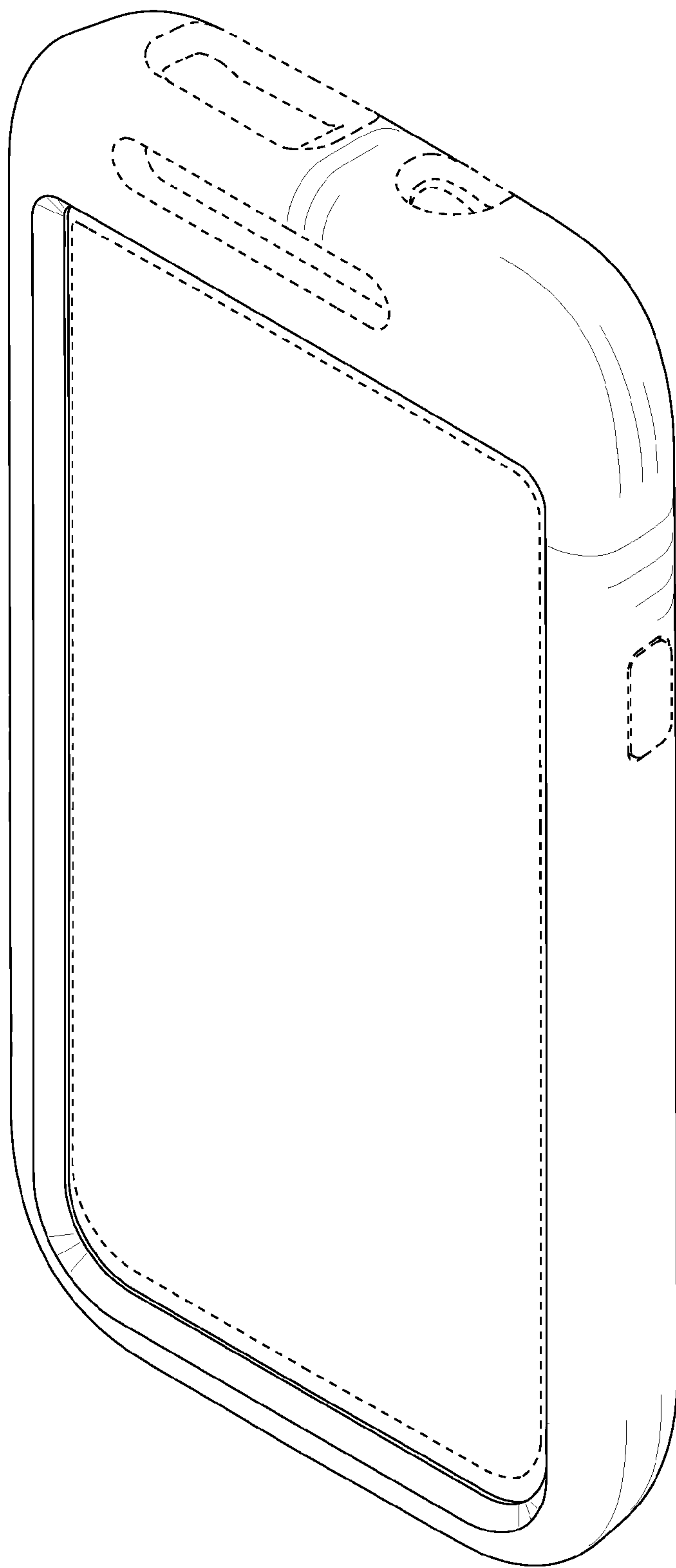

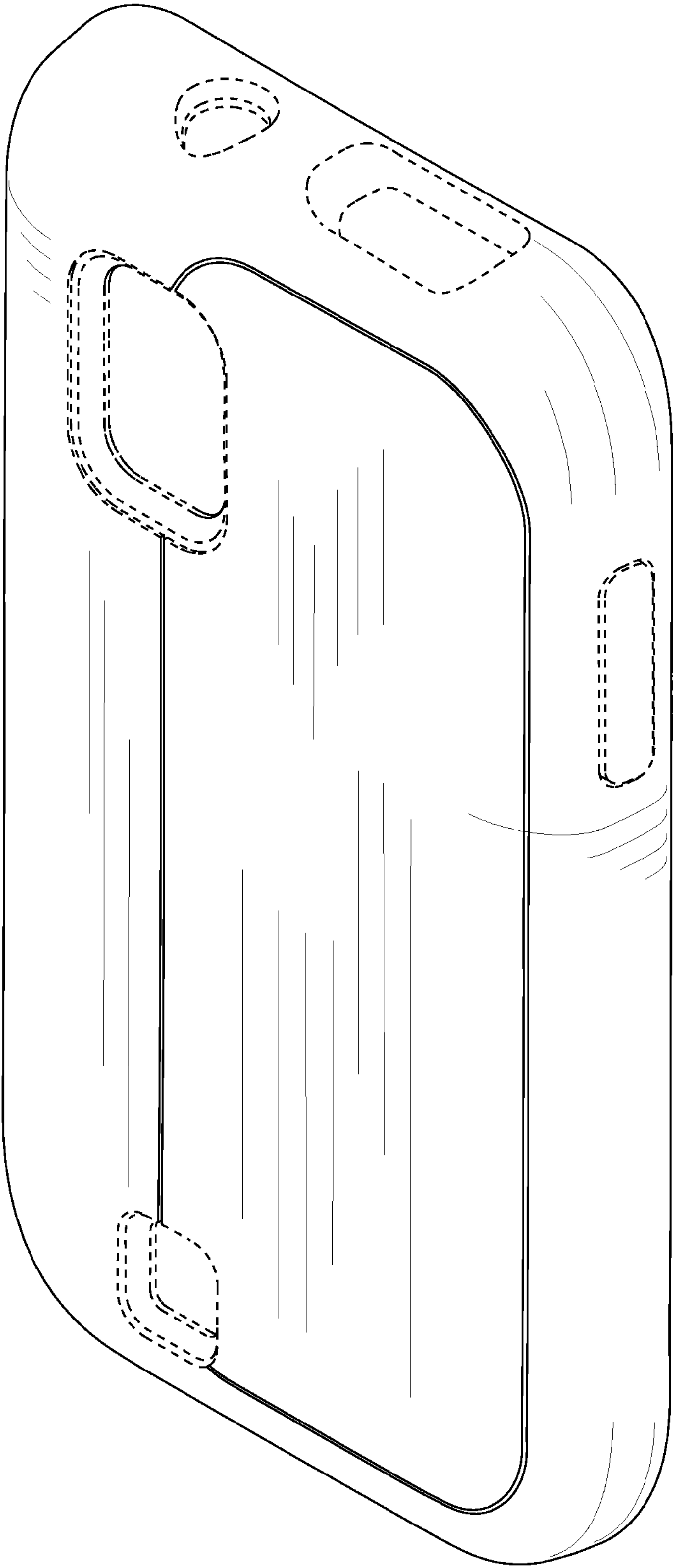

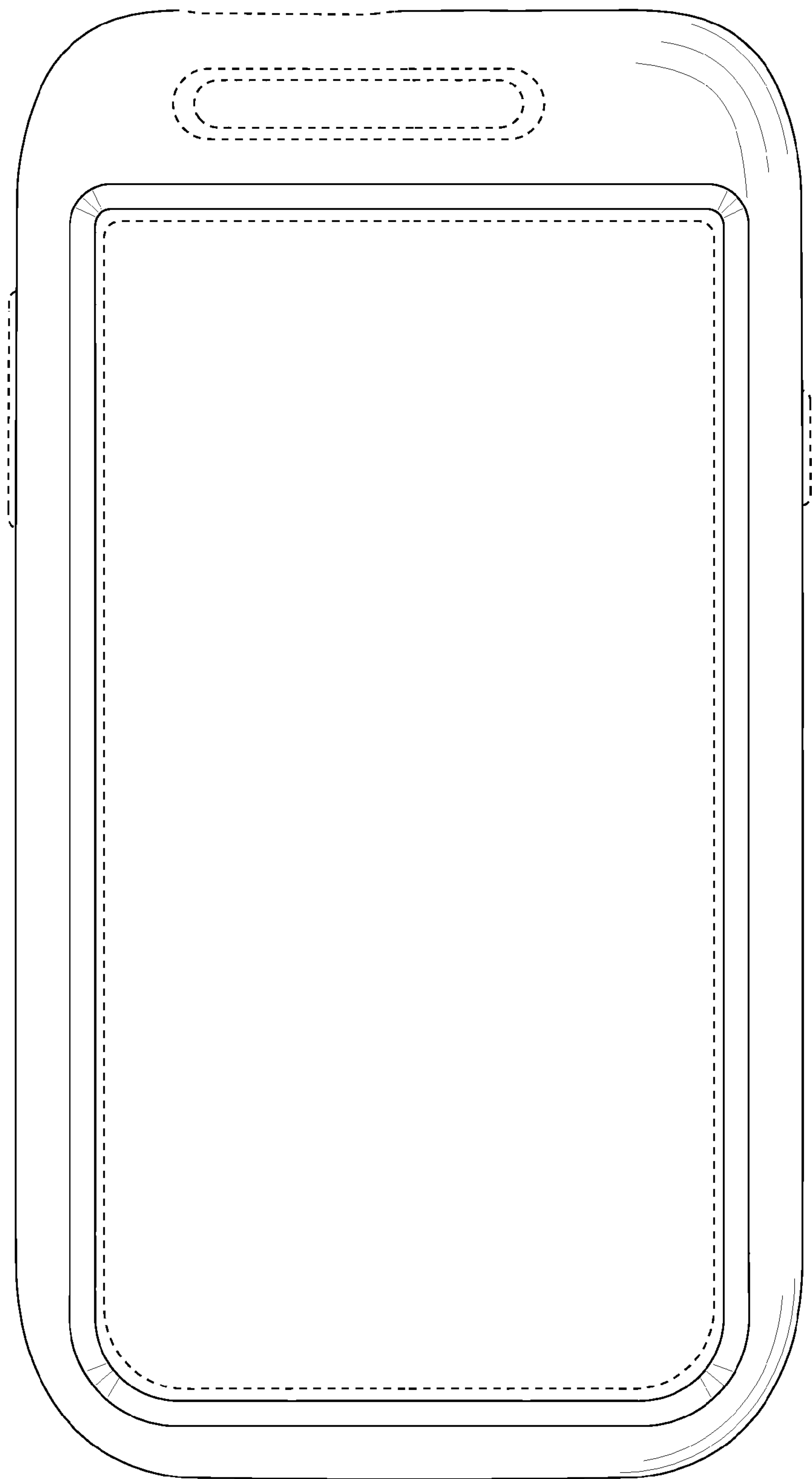

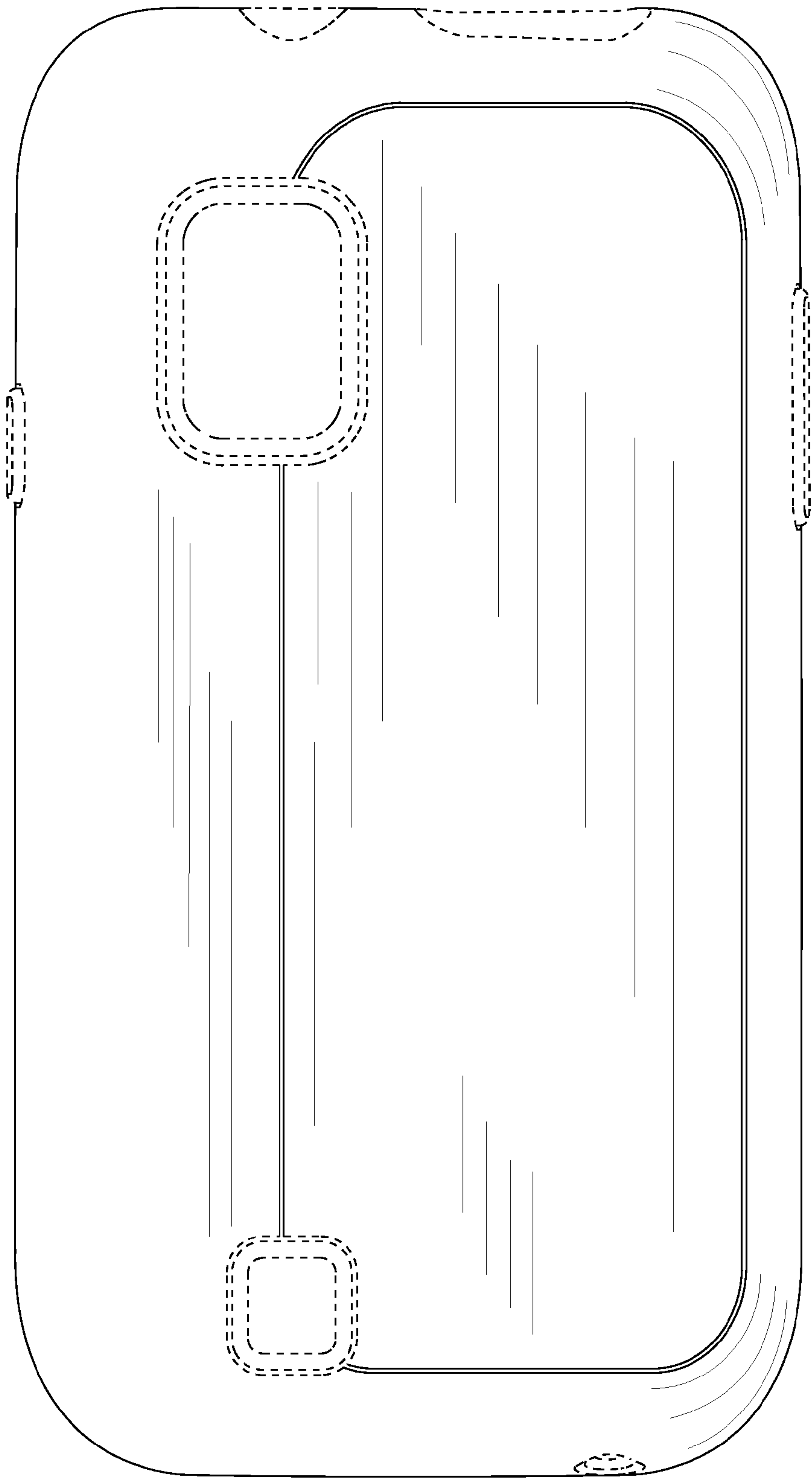

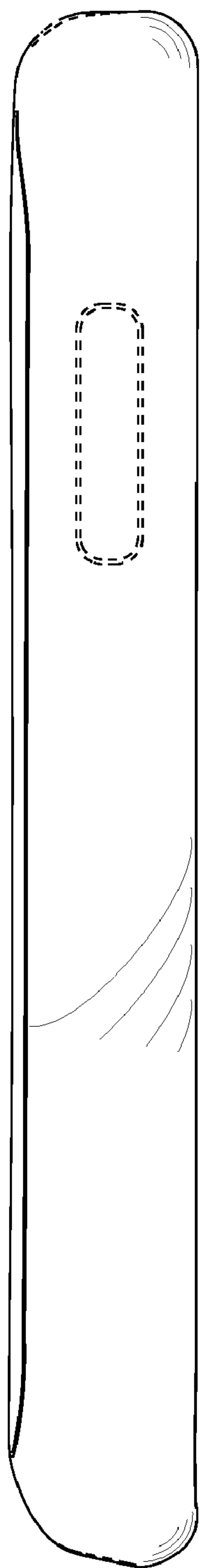

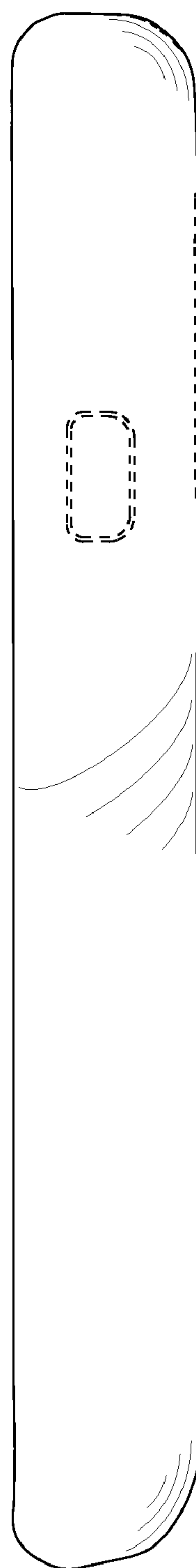

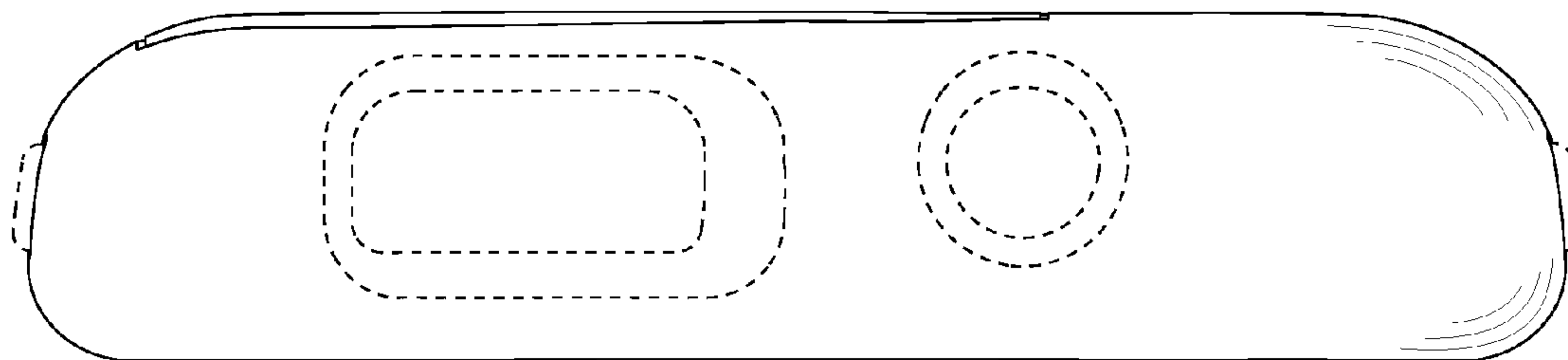
