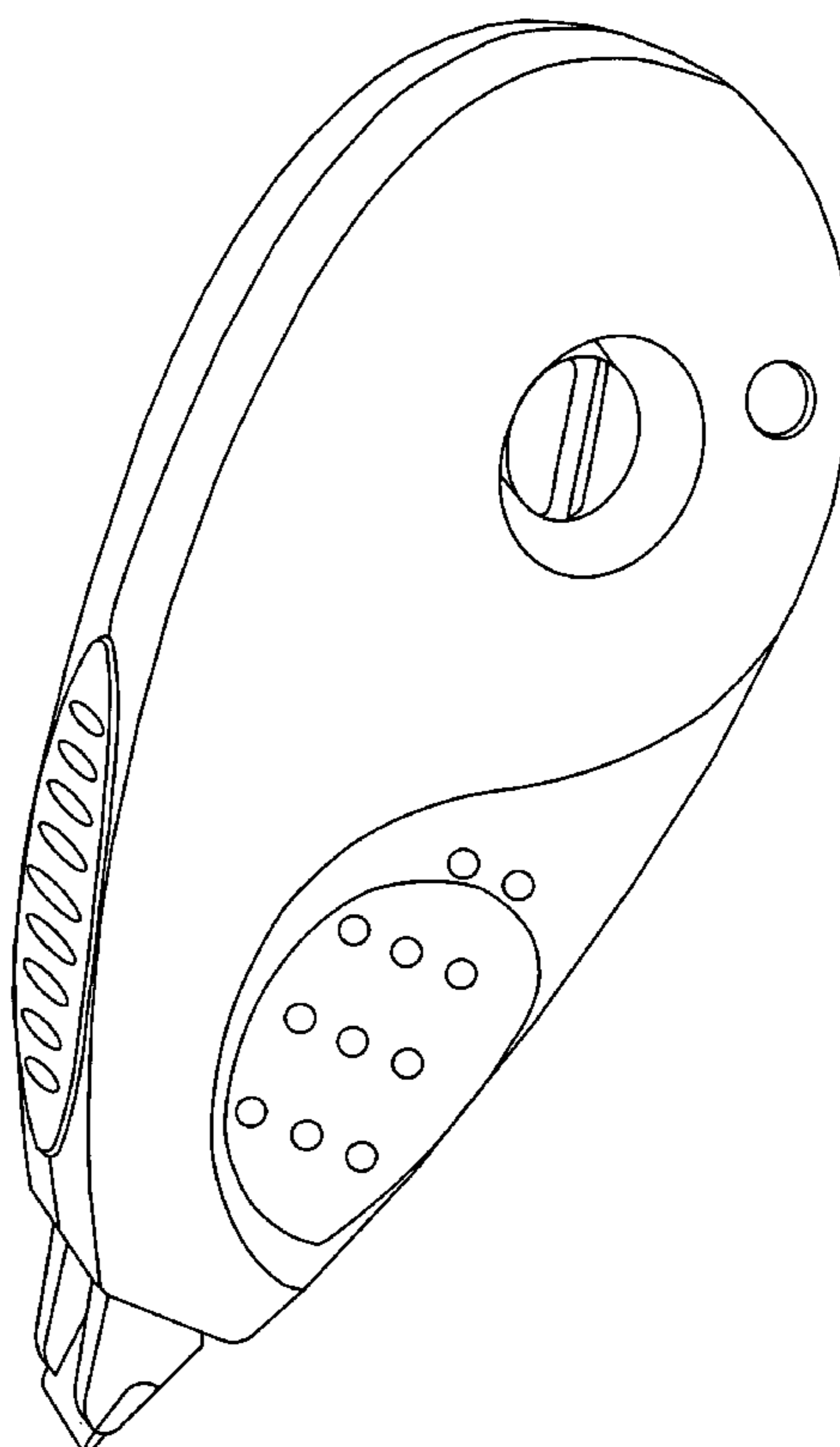

The ornamental design for a correction tape dispenser, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a correction tape dispenser according to the present invention; FIG. 2 is a front view of the correction tape dispenser of the present invention; FIG. 3 is a rear view of the correction tape dispenser of the present invention; FIG. 4 is a right side view of the correction tape dispenser of the present invention; FIG. 5 is a left side view of the correction tape dispenser of the present invention; FIG. 6 is a top view of the correction tape dispenser of the present design; and, FIG. 7 is a bottom view of the correction tape dispenser of the present invention.

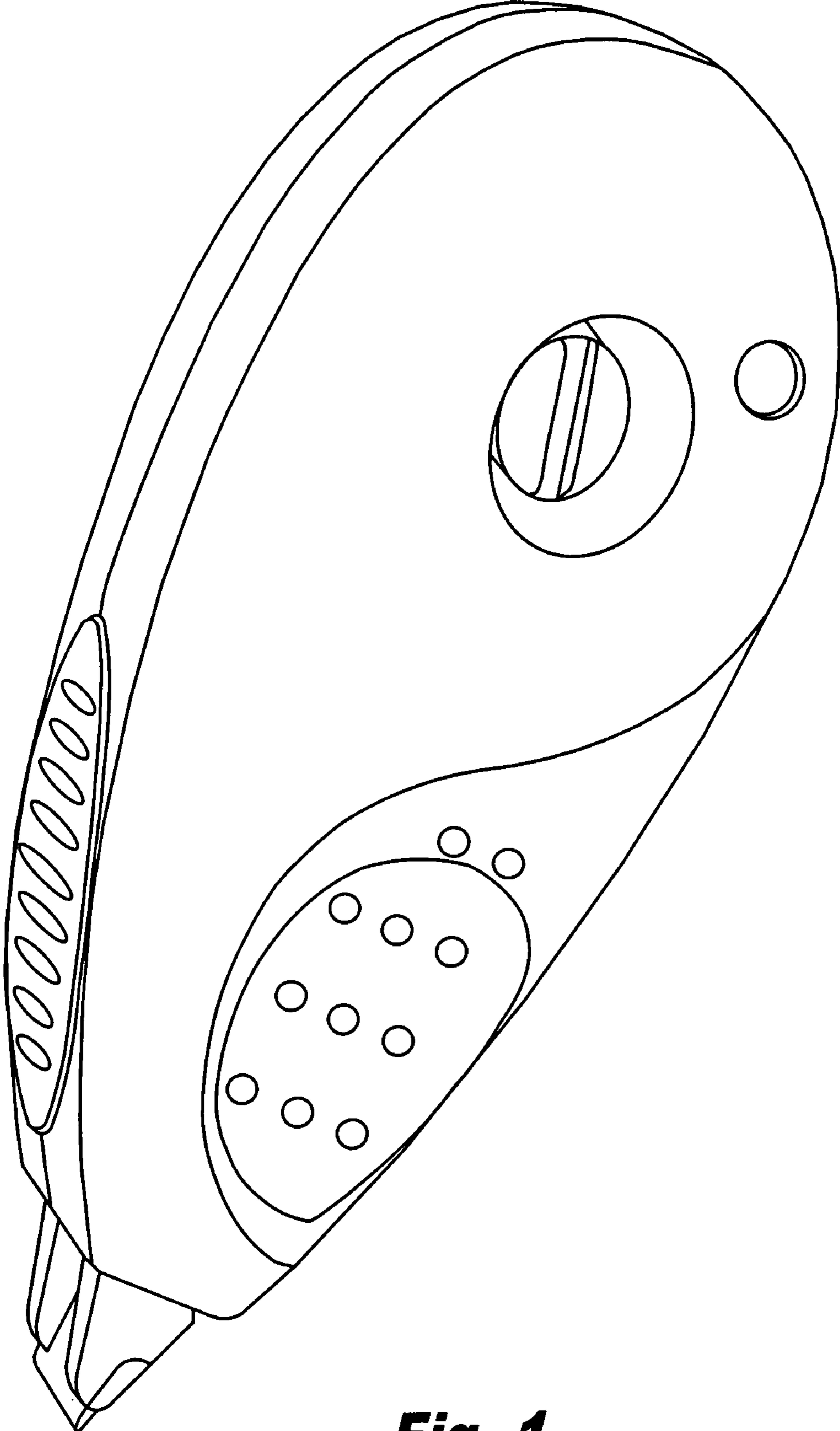

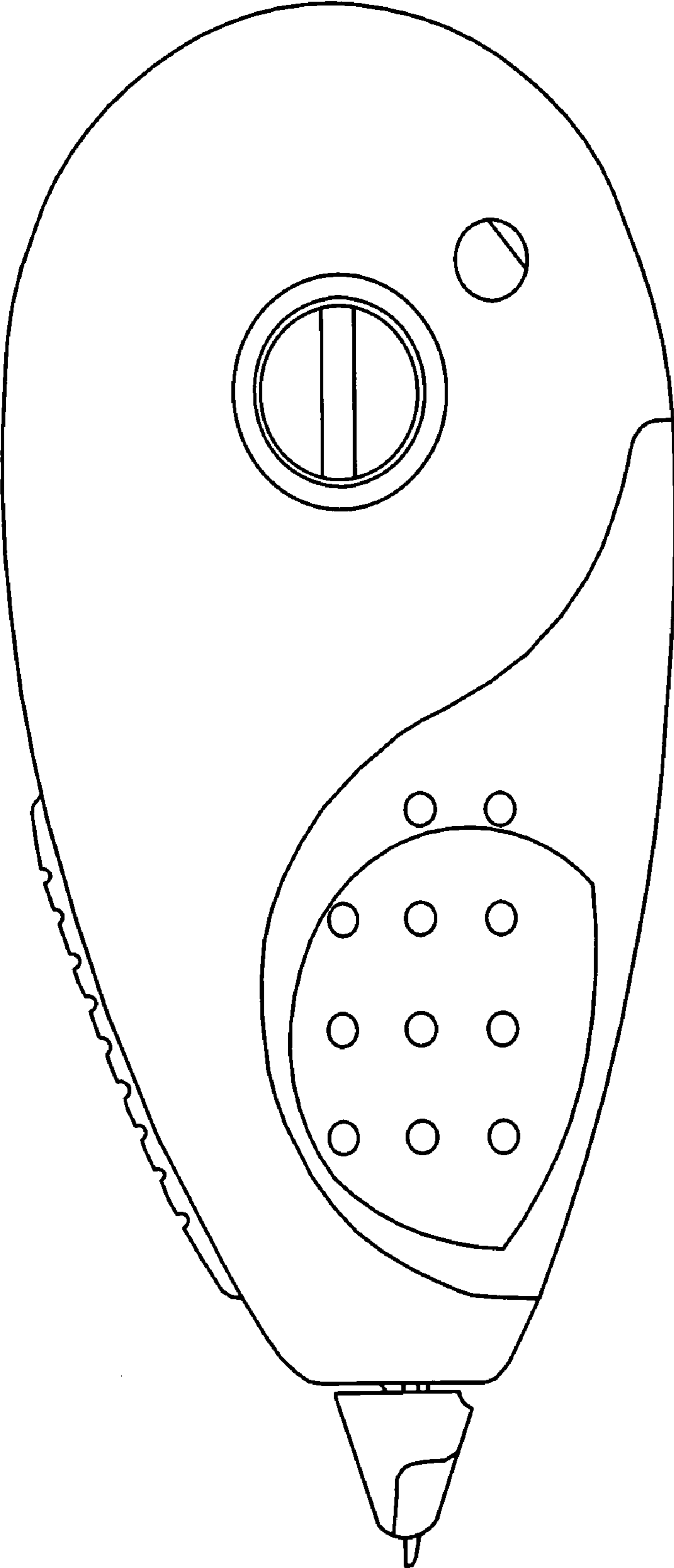

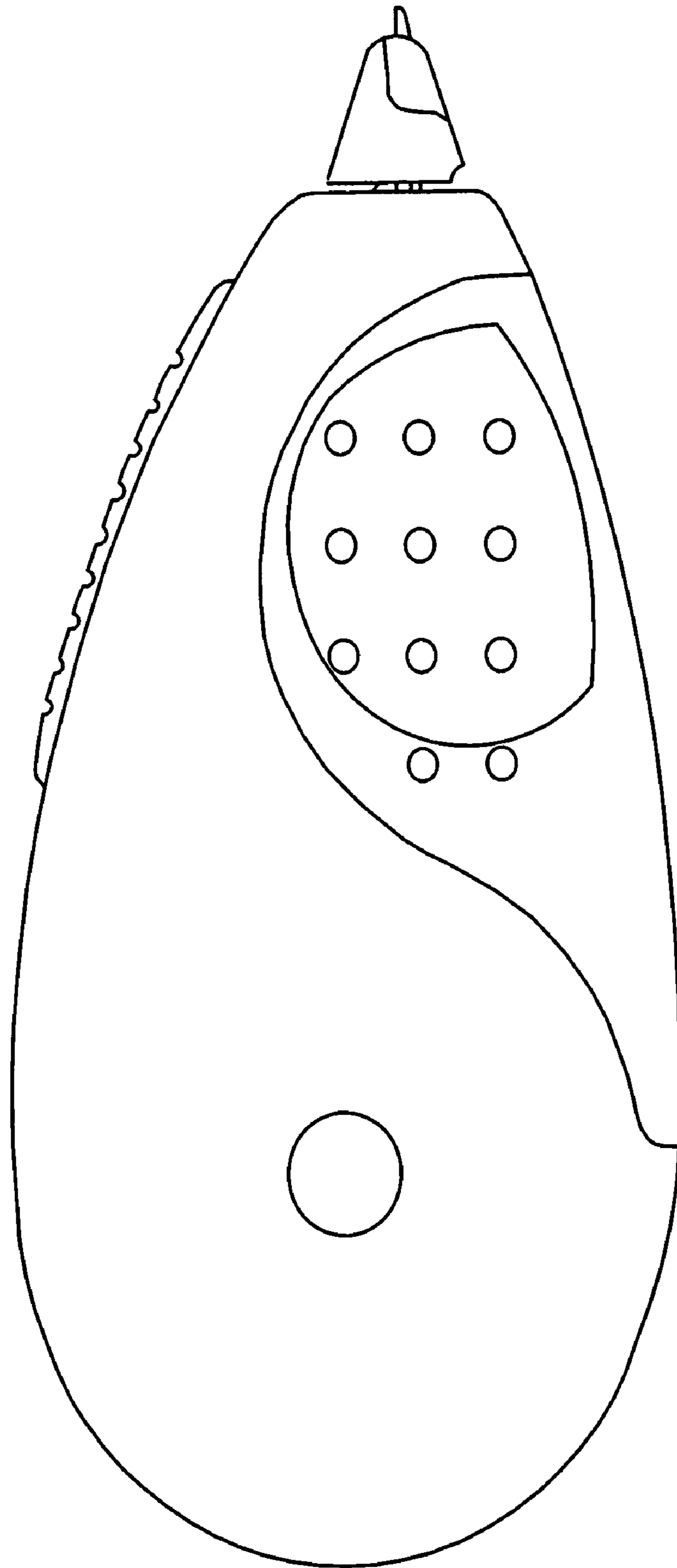

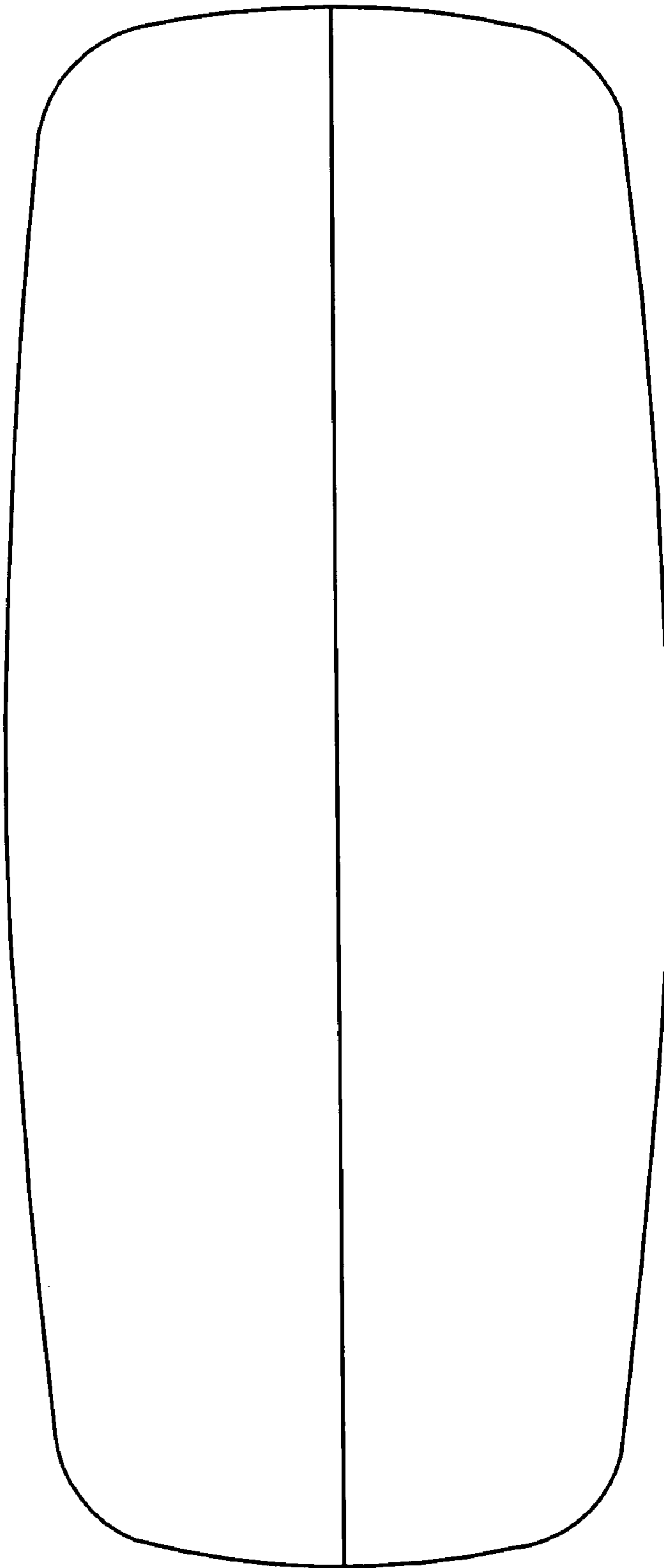

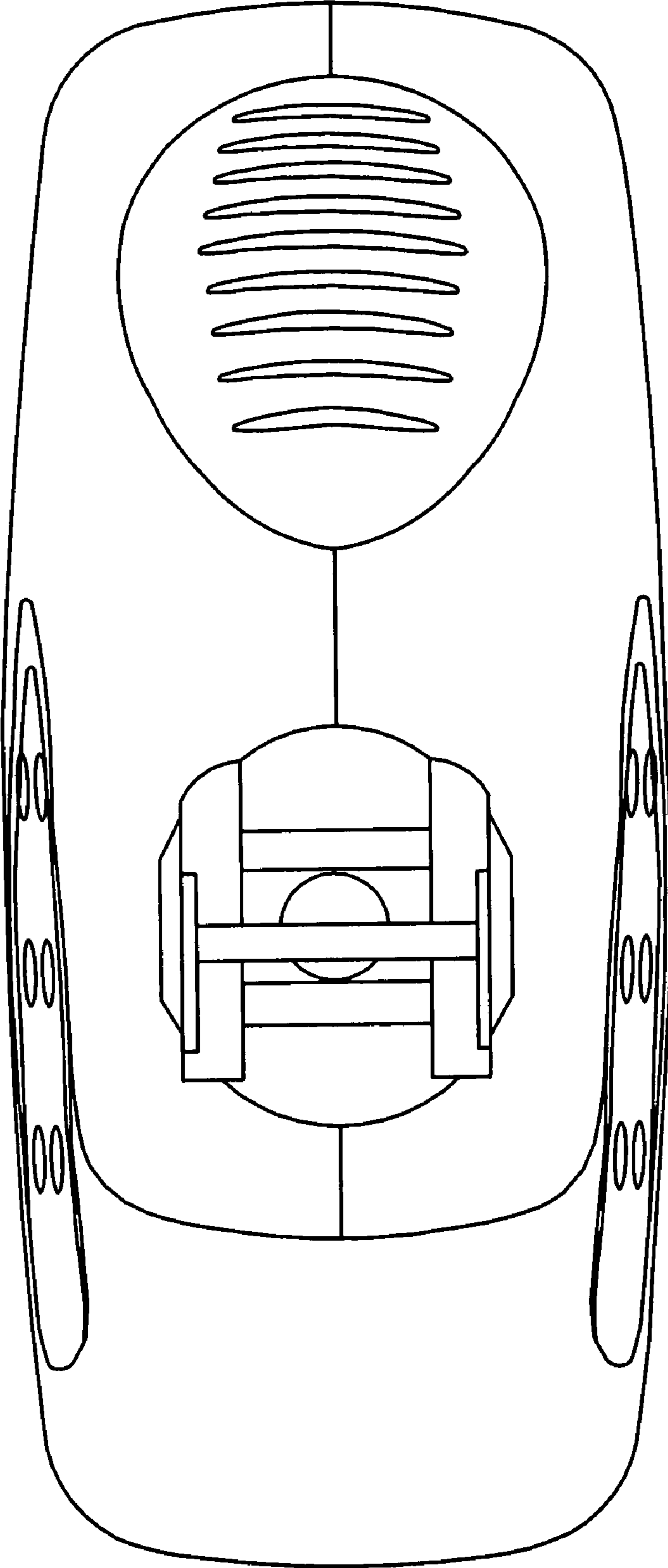

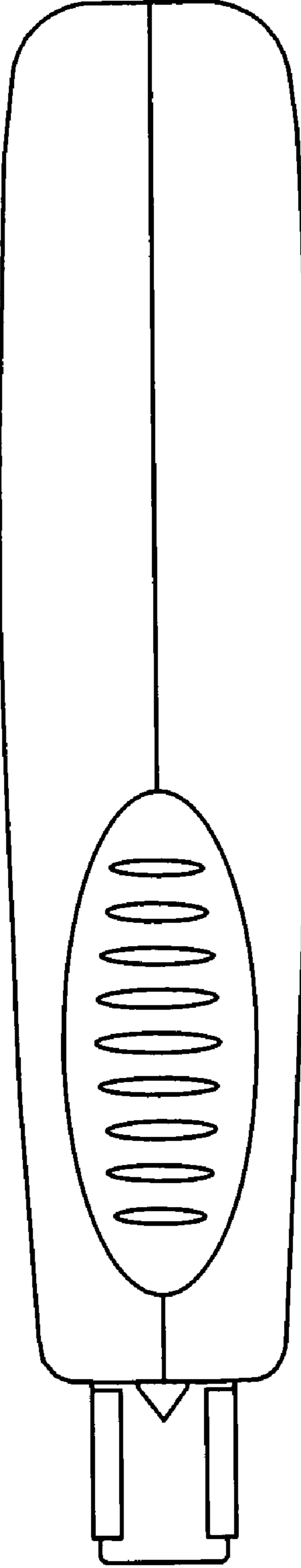

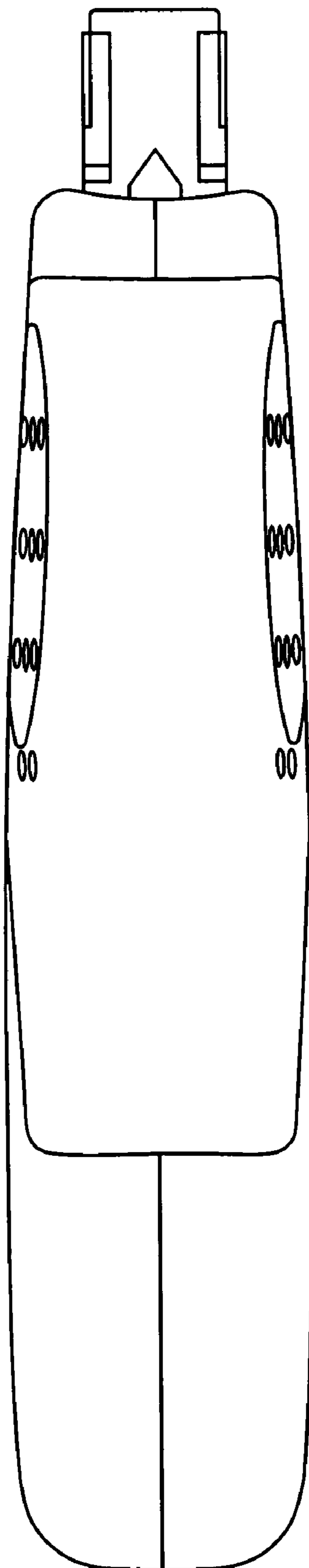
