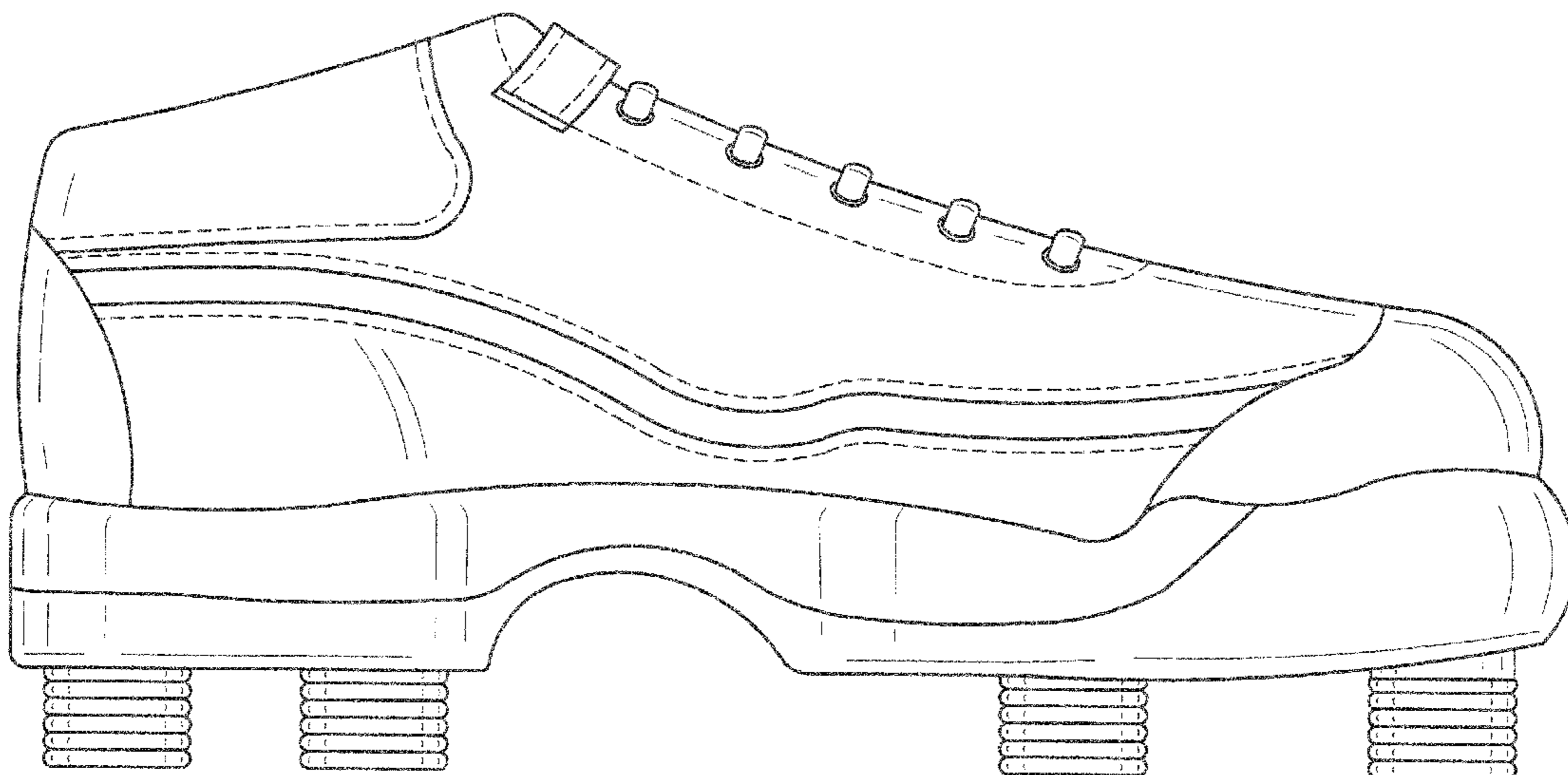
(57) **CLAIM**

The ornamental design for an exercise shoe with springs on bottom, as shown and described.

DESCRIPTION

FIG. 1 is a side view of an exercise shoe with springs on bottom showing our new design;
FIG. 2 is an opposite side view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
In FIG. 1-5, the broken lines showing are stitch marks and form no part of the claimed design.

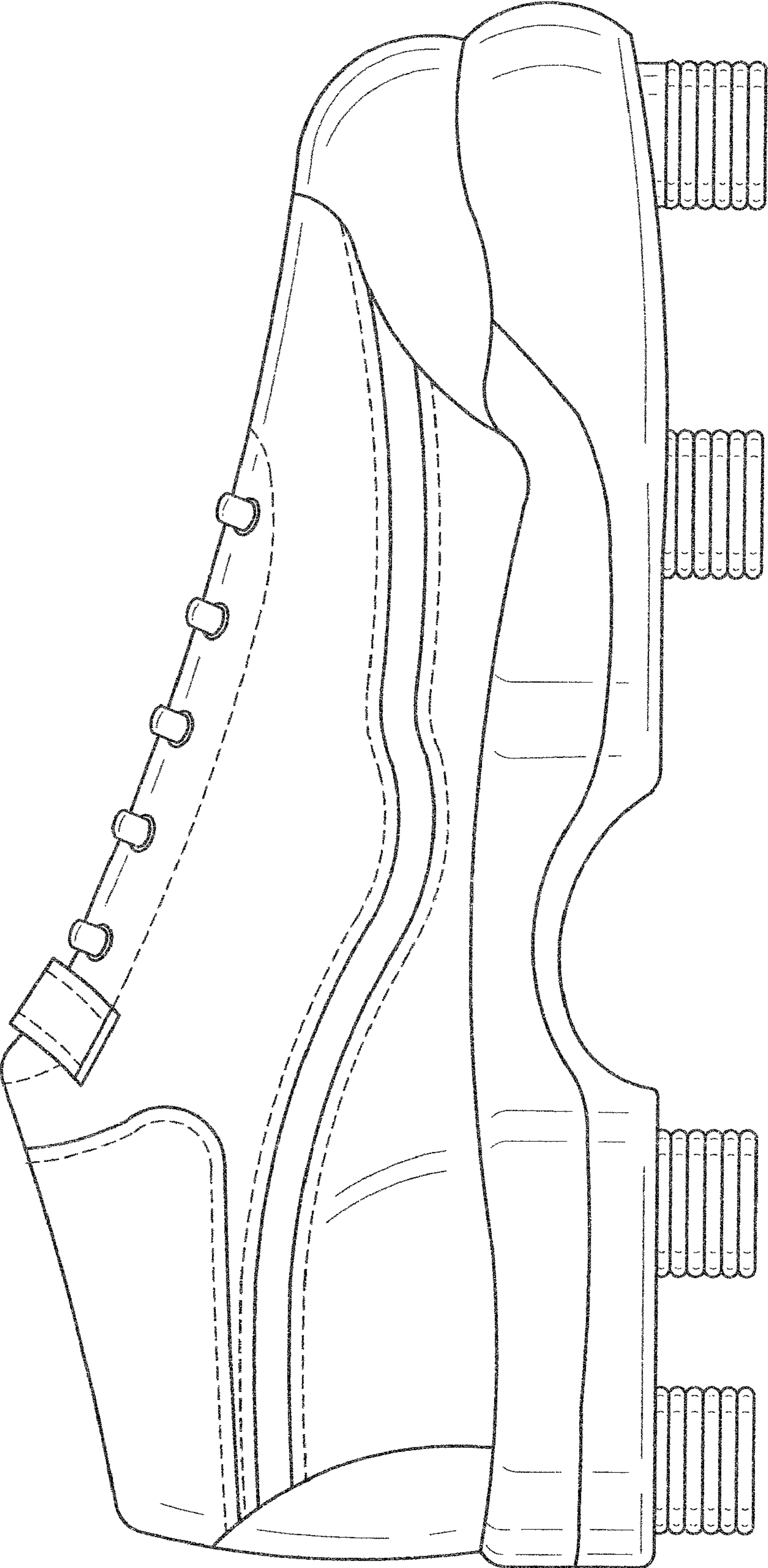

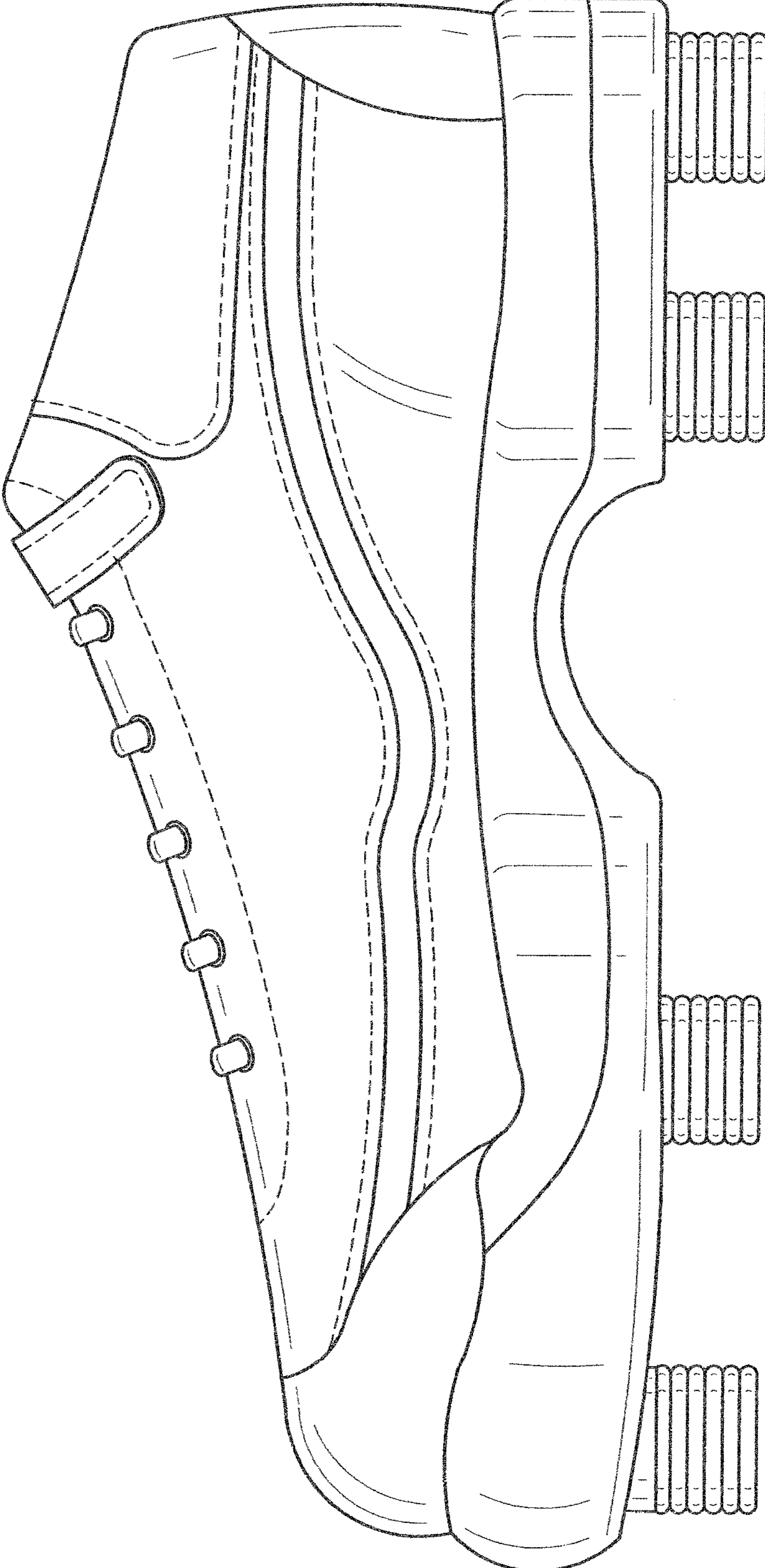

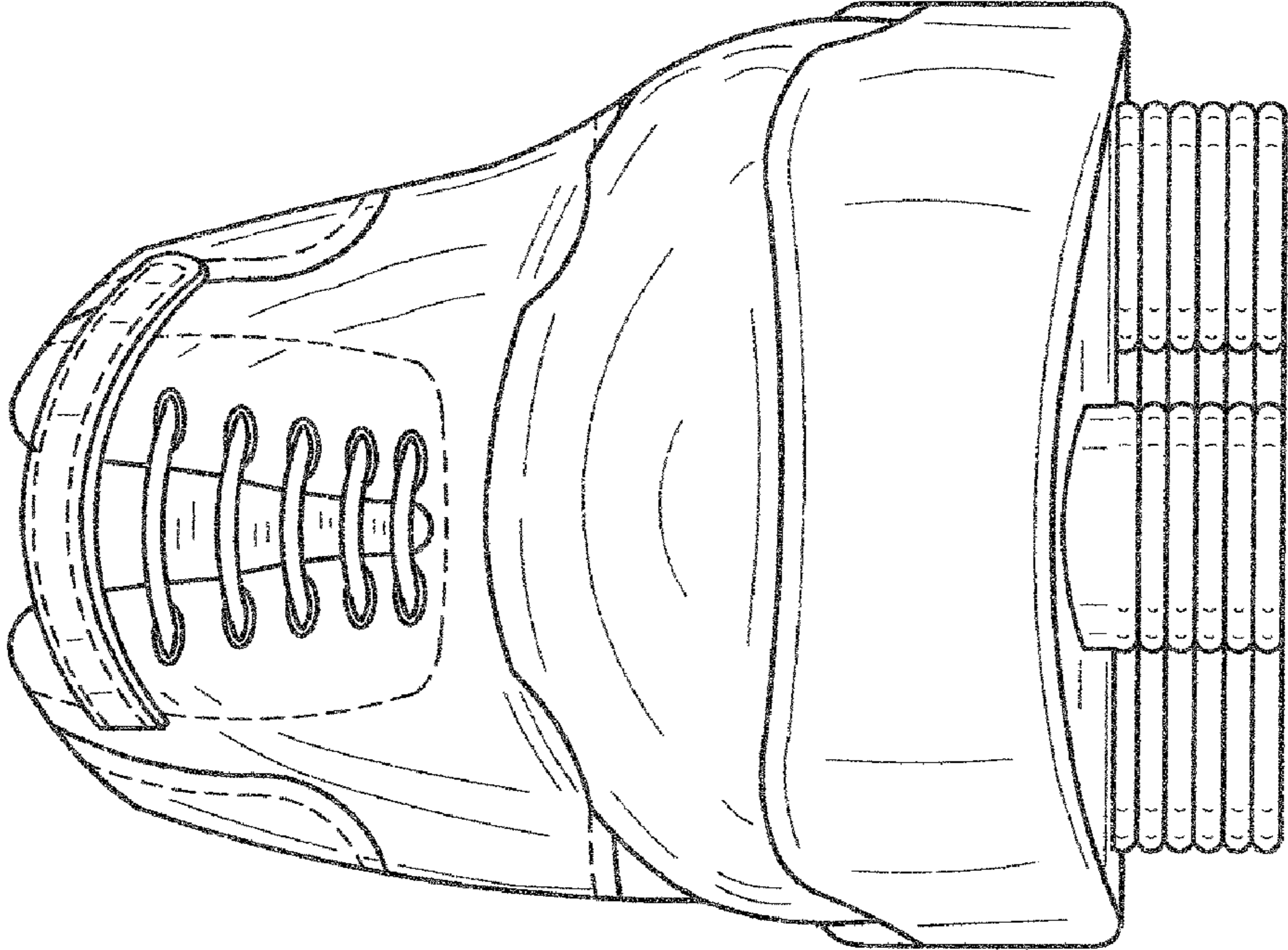

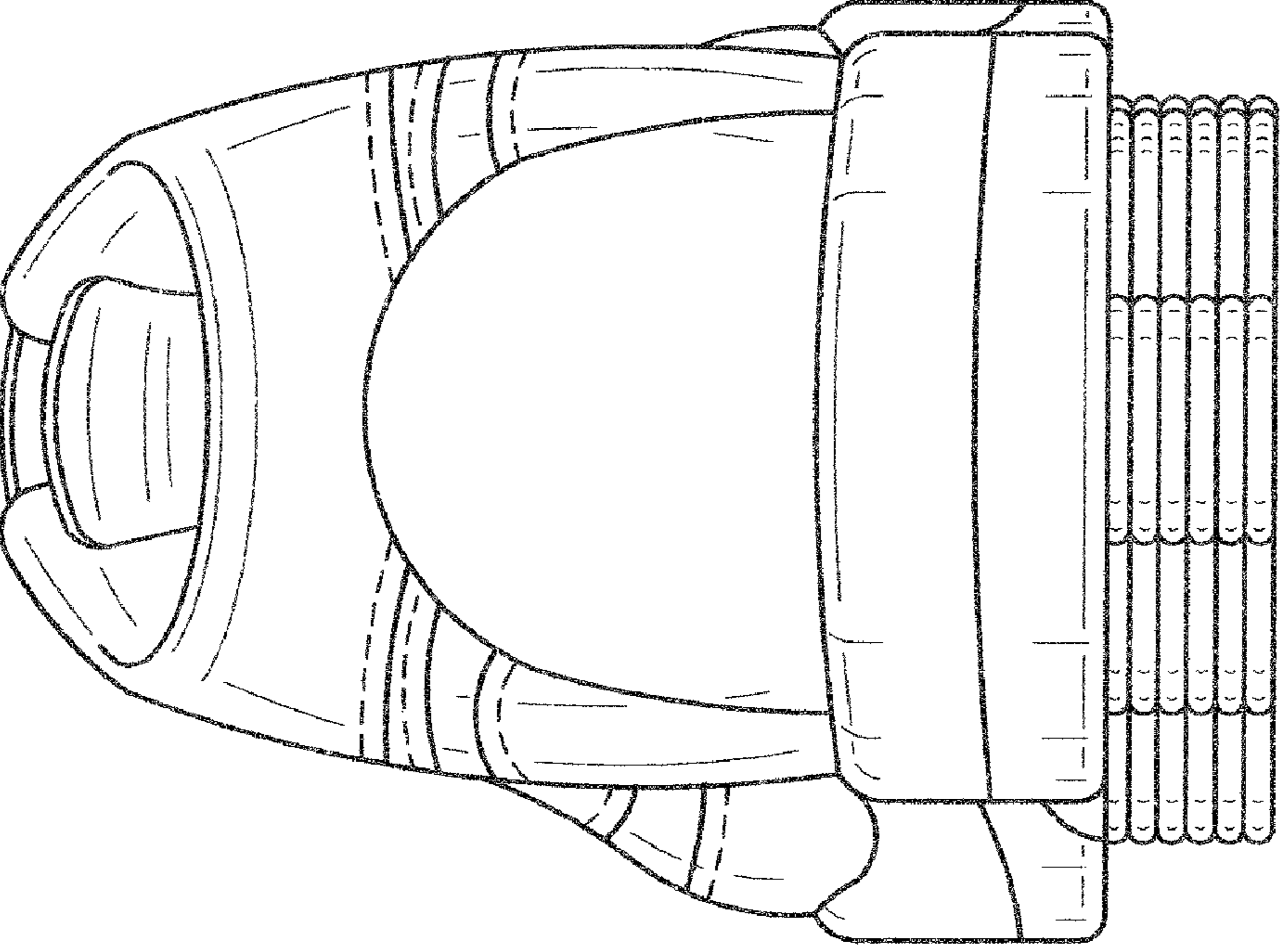

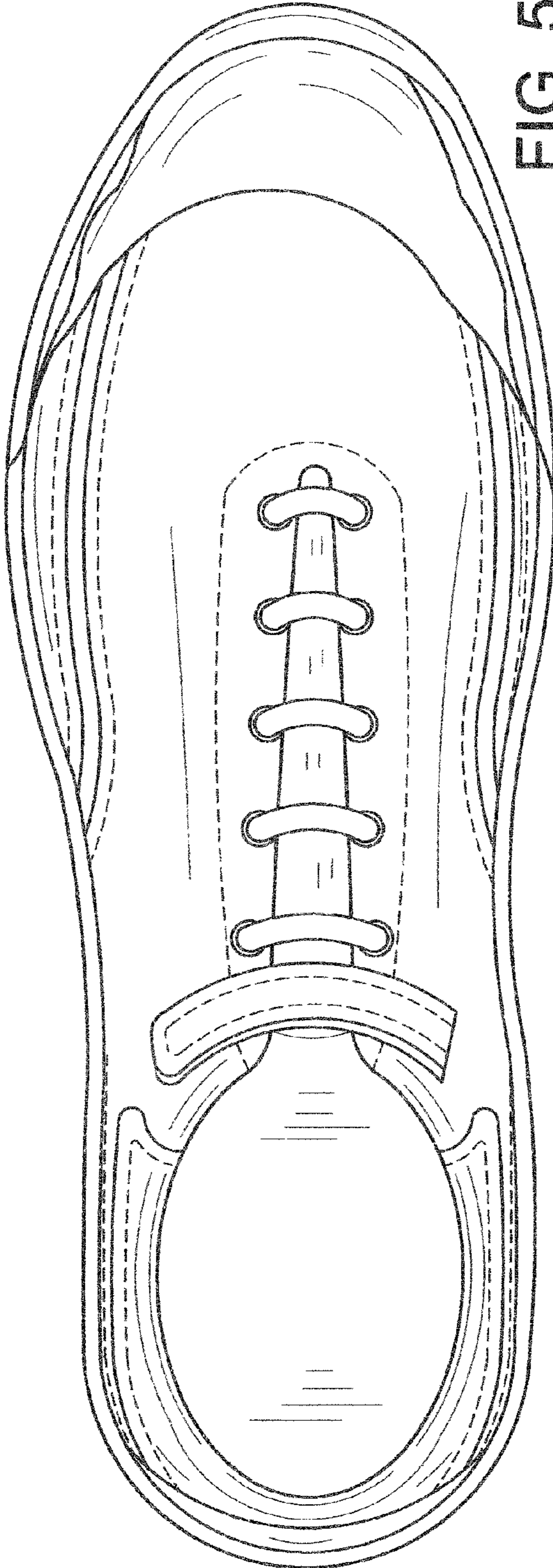

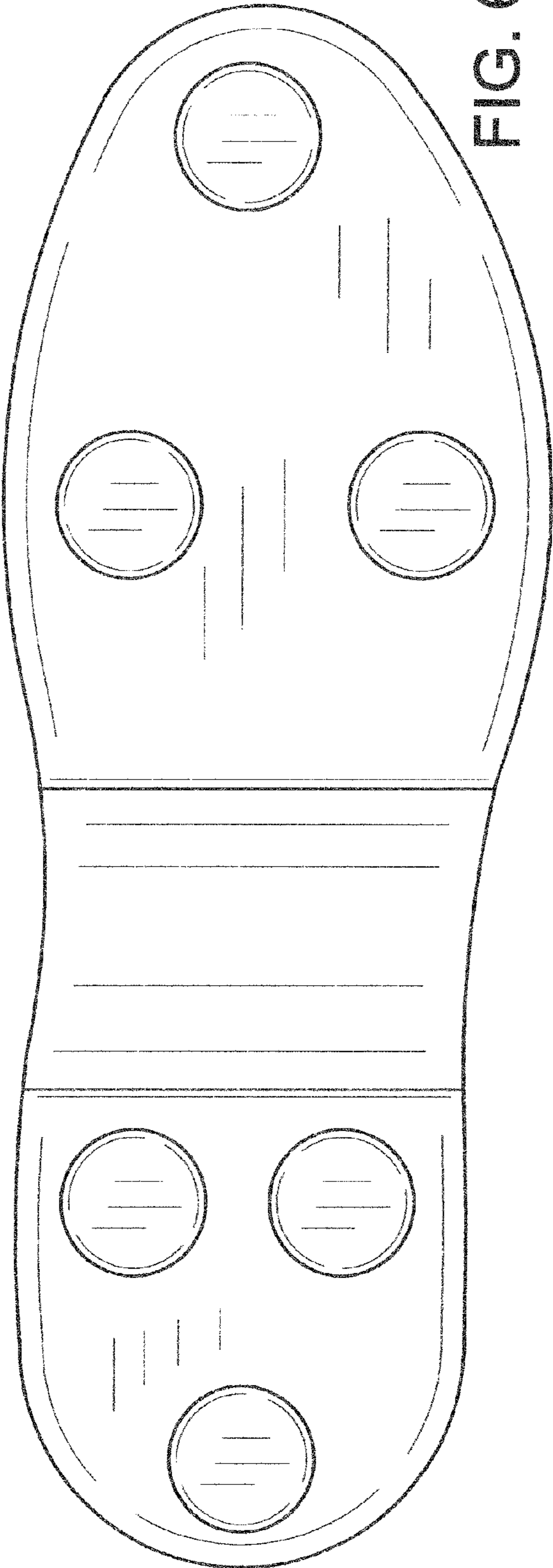
