(57) **CLAIM**

The ornamental design for a hyperthermic humidification system, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hyperthermic humidification system according to an embodiment of the present invention;

FIG. 2 is another front perspective view of the hyperthermic humidification system shown in FIG. 1;

FIG. 3 is a front view of the hyperthermic humidification system shown in FIG. 1;

FIG. 4 is a left side view of the hyperthermic humidification system shown in FIG. 1; the handle on the top of the article being shown in an alternate position;

FIG. 5 is a right side view of the hyperthermic humidification system shown in FIG. 1;

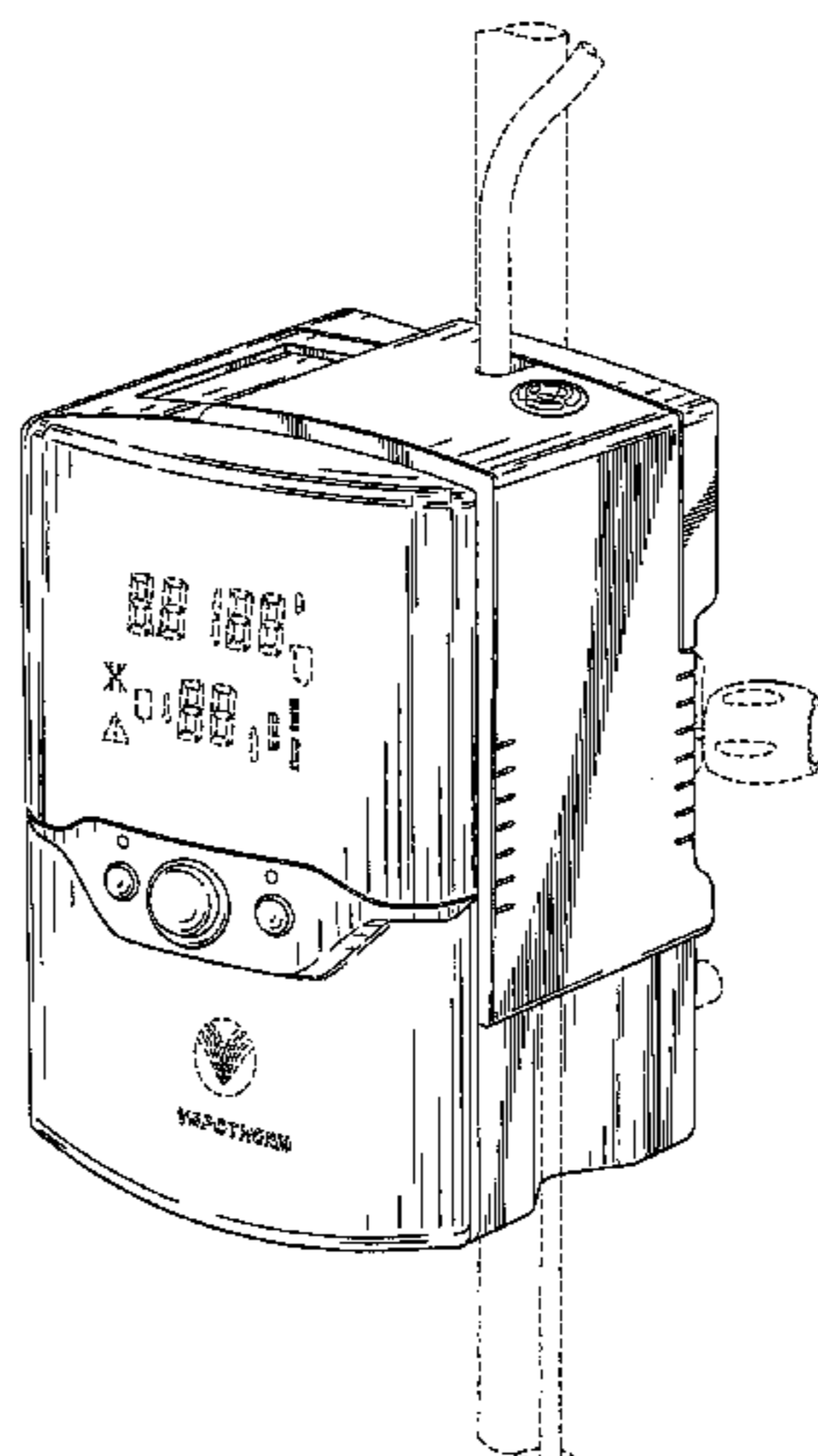
FIG. 6 is a rear view of the hyperthermic humidification system shown in FIG. 1;

FIG. 7 is a top view of the hyperthermic humidification system shown in FIG. 1; and,

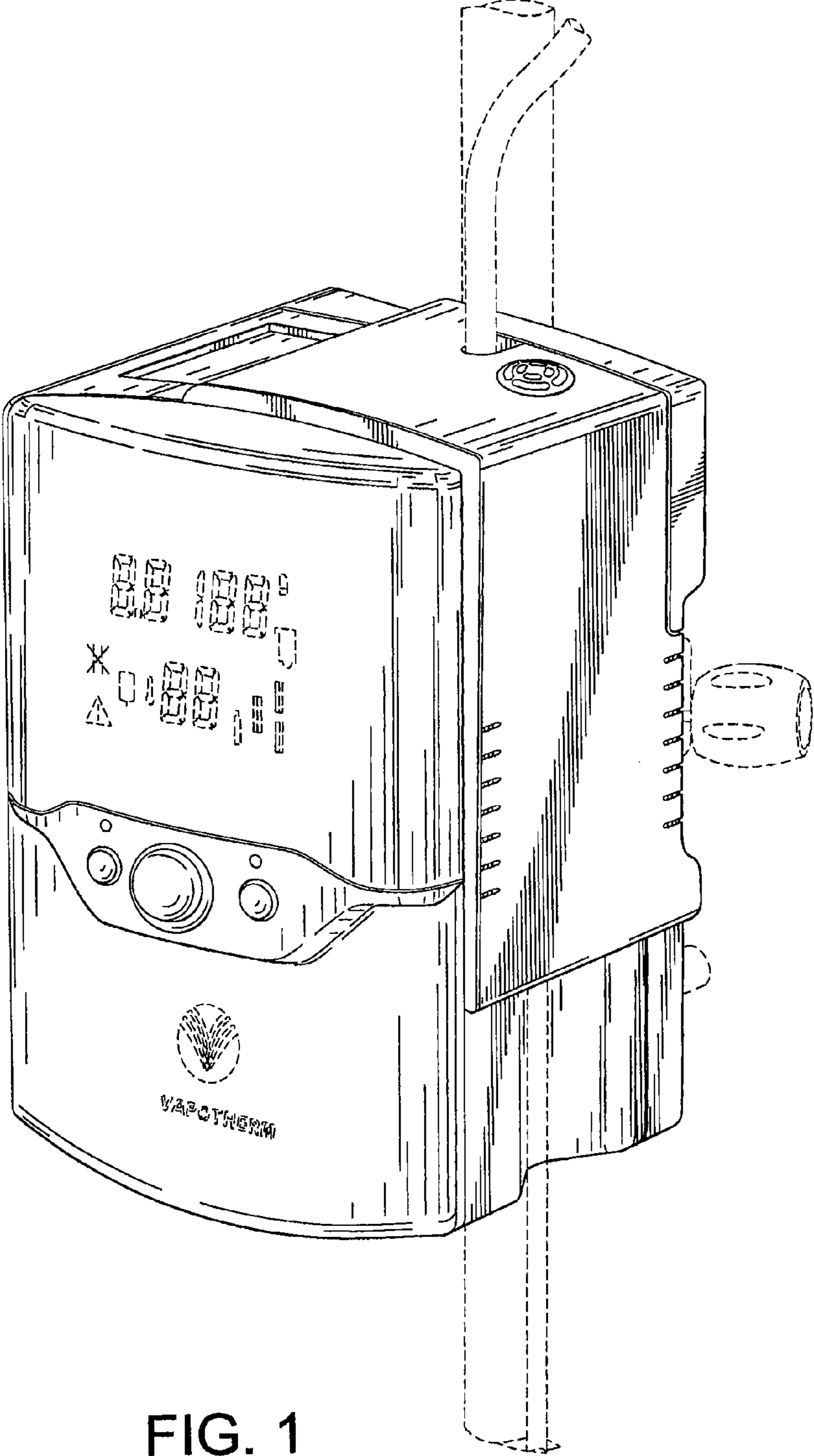

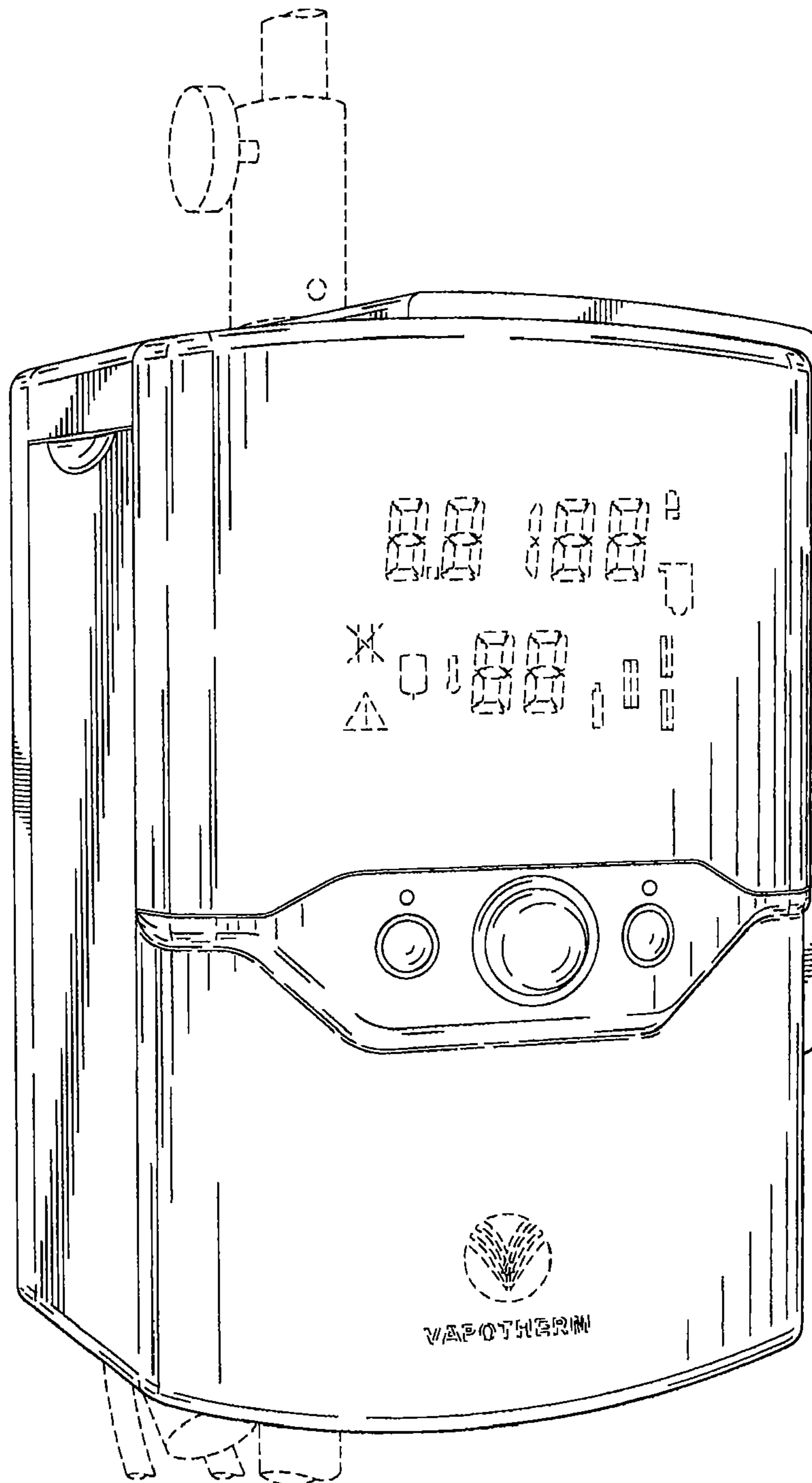

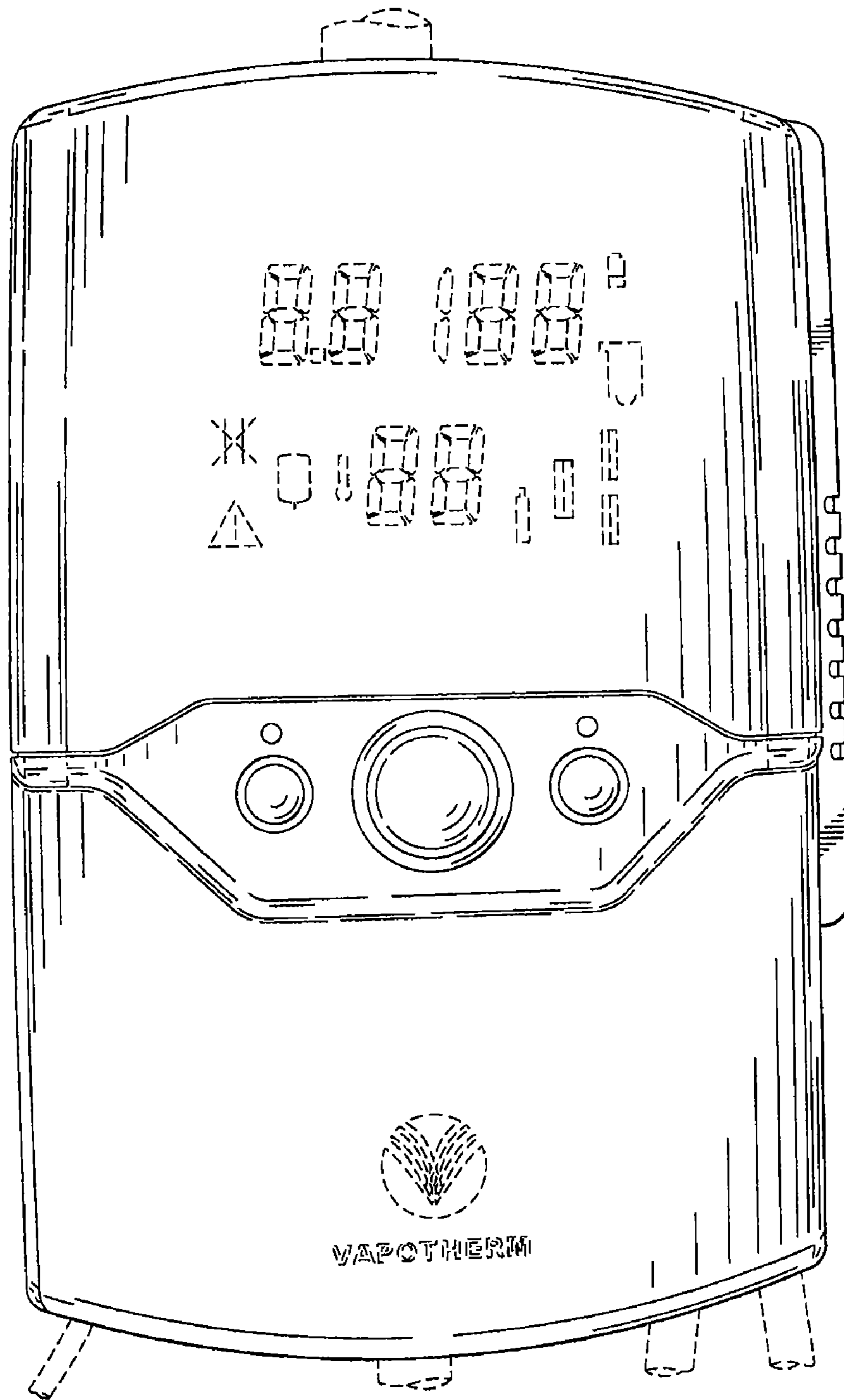

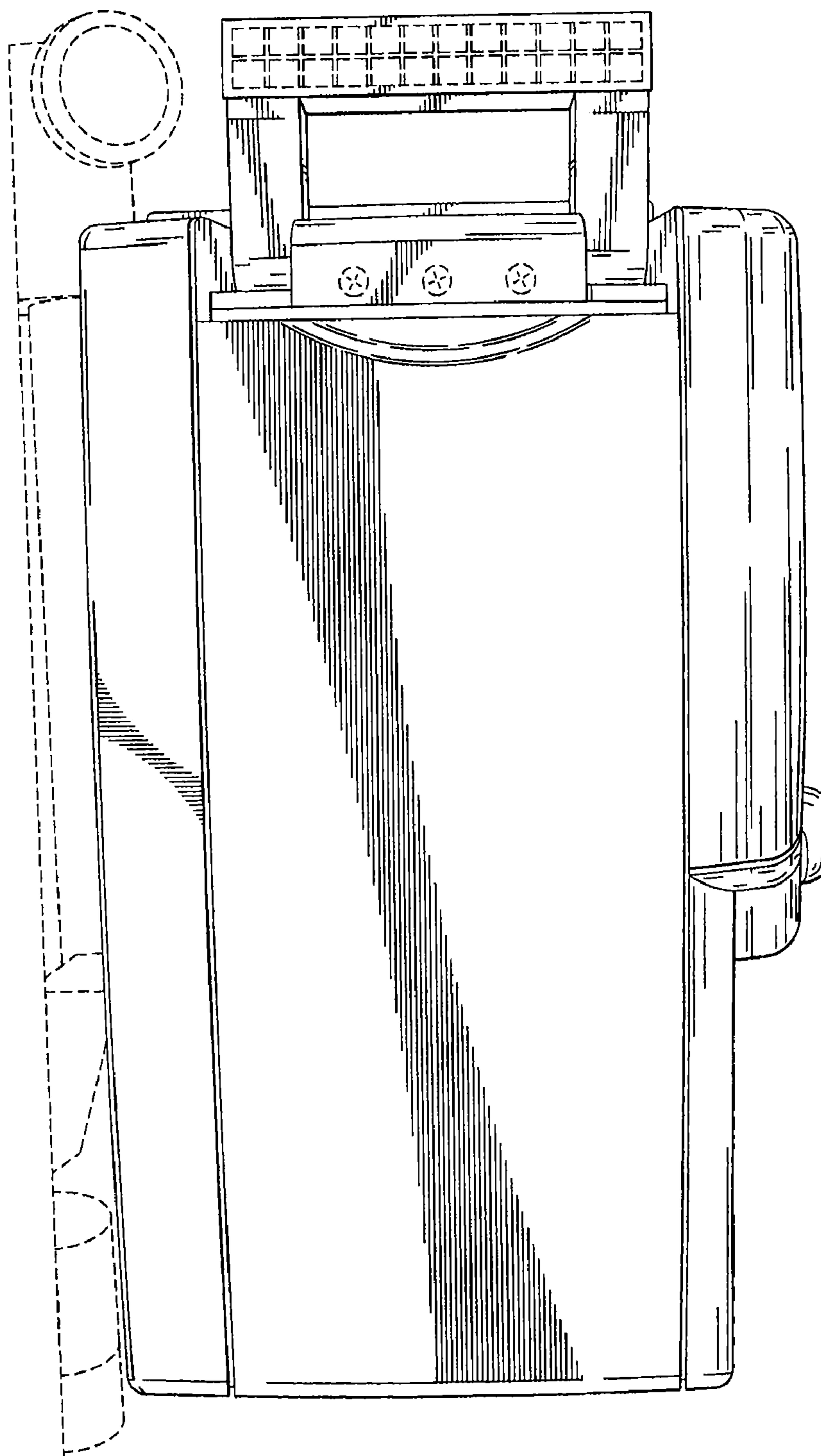

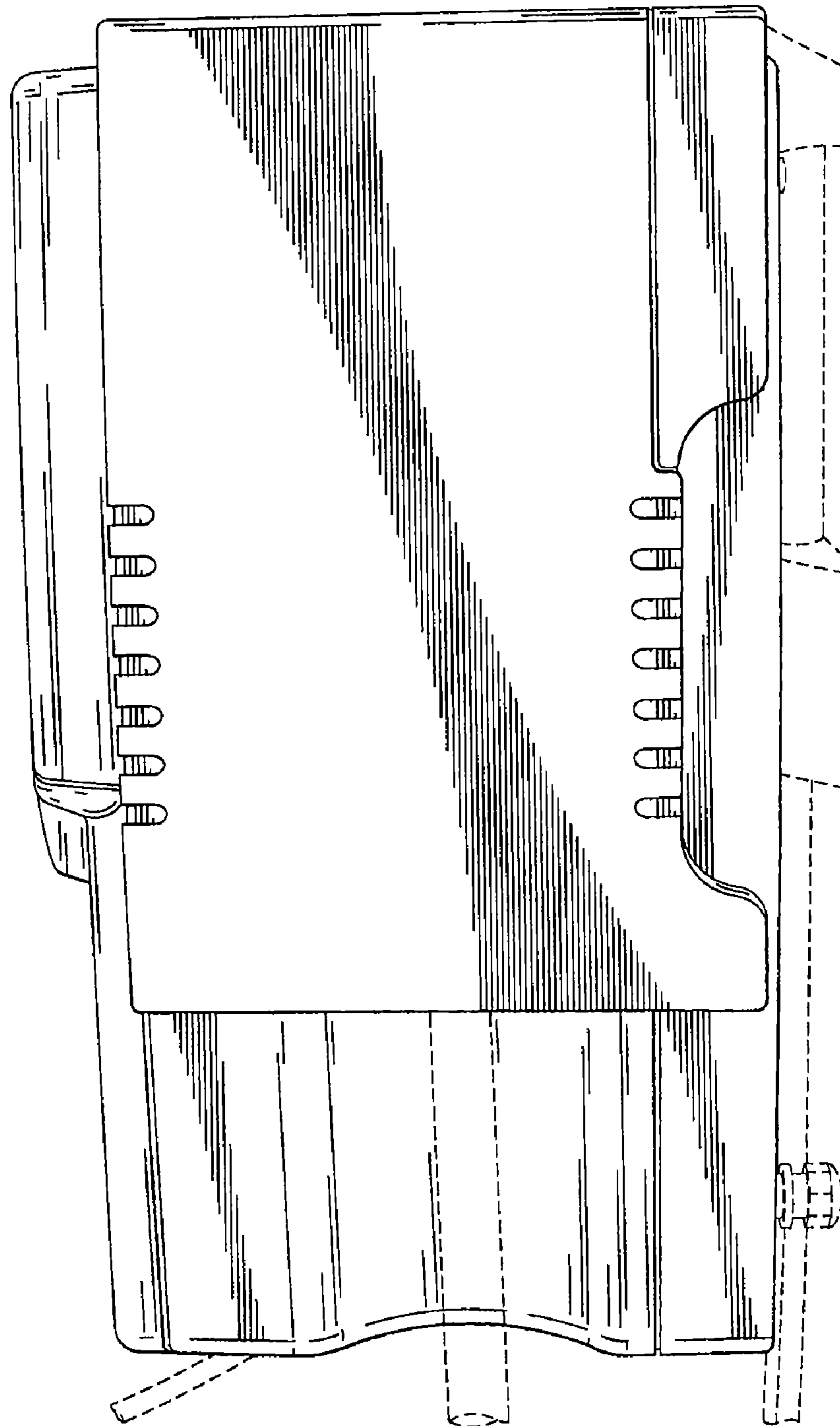

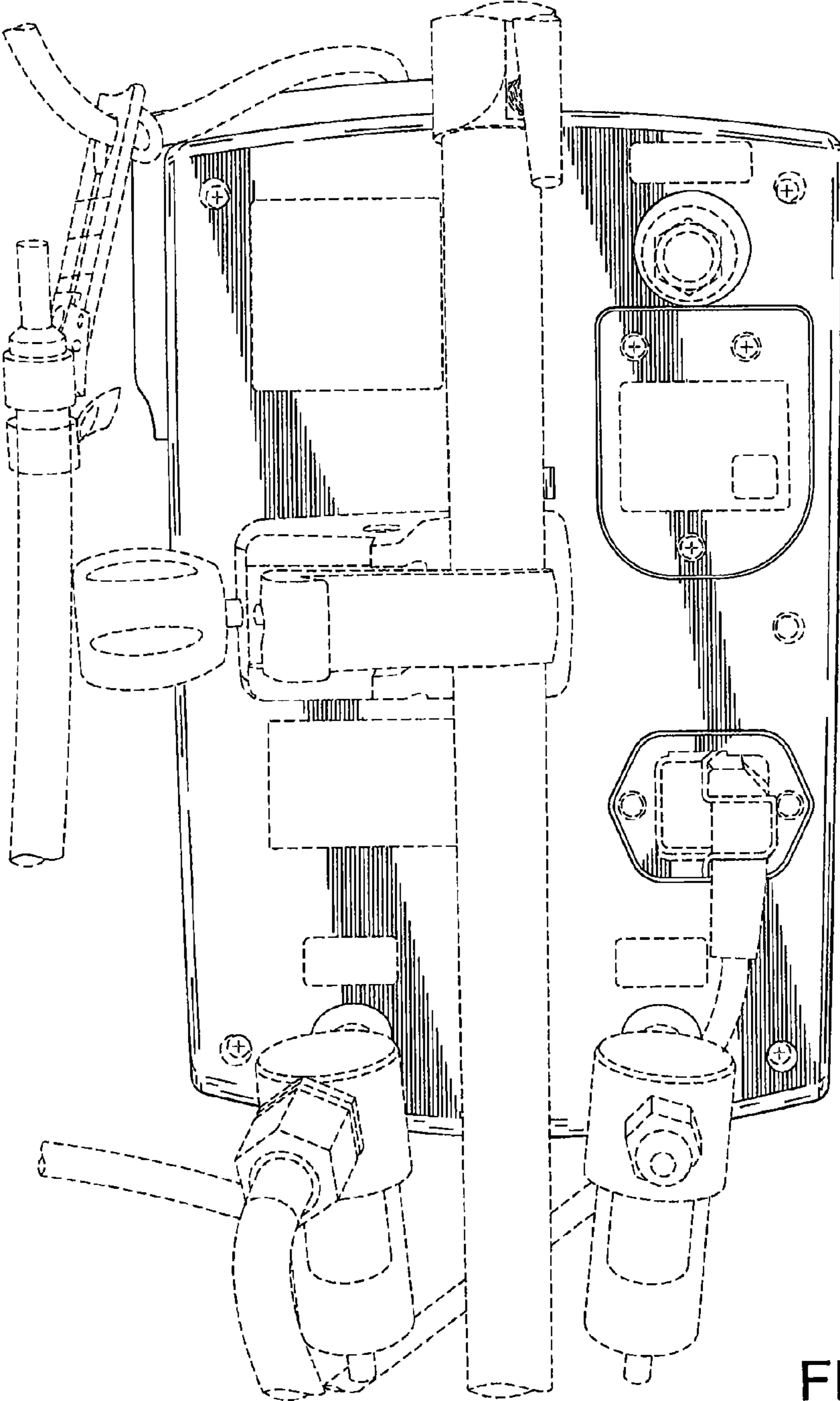

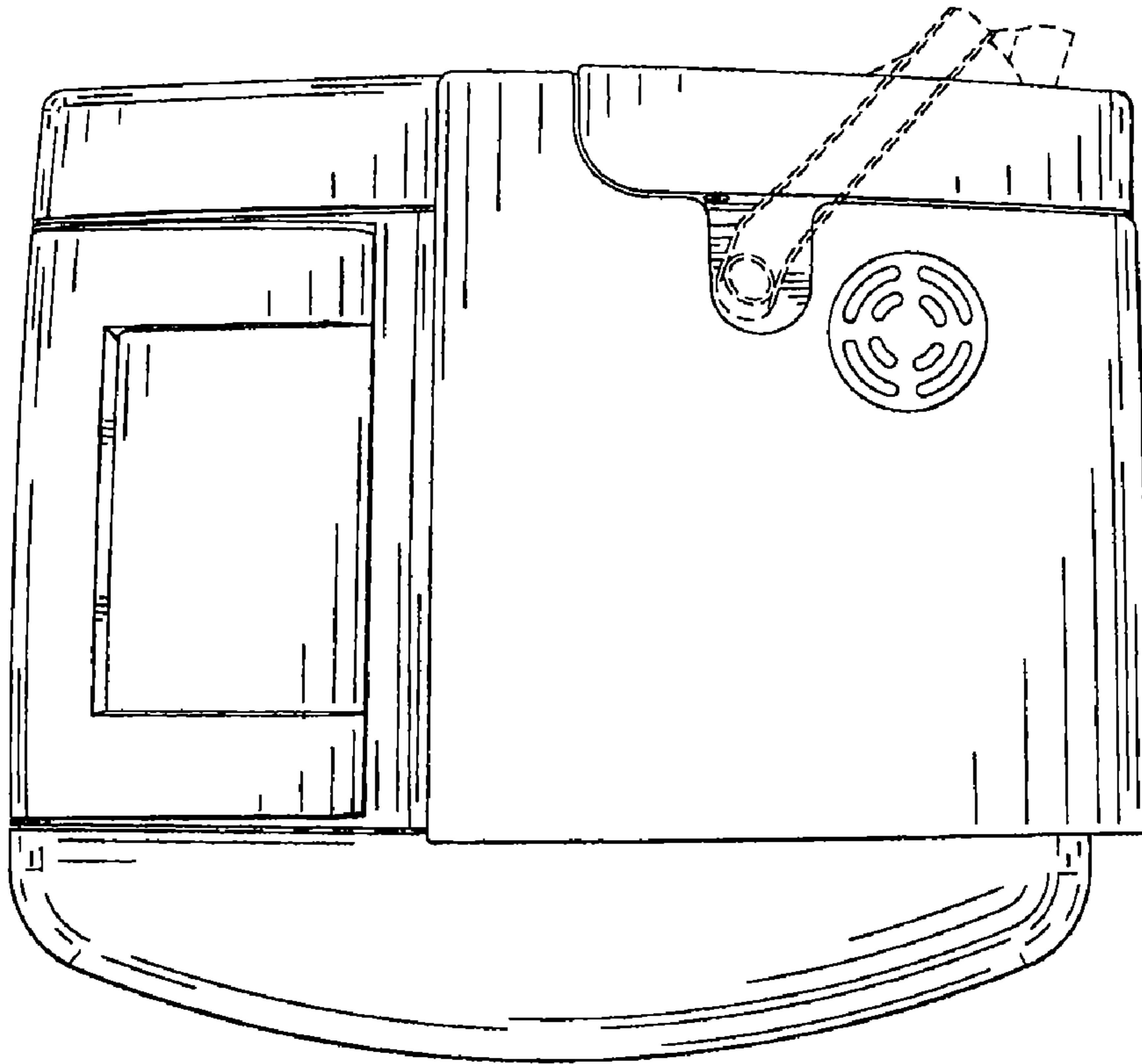

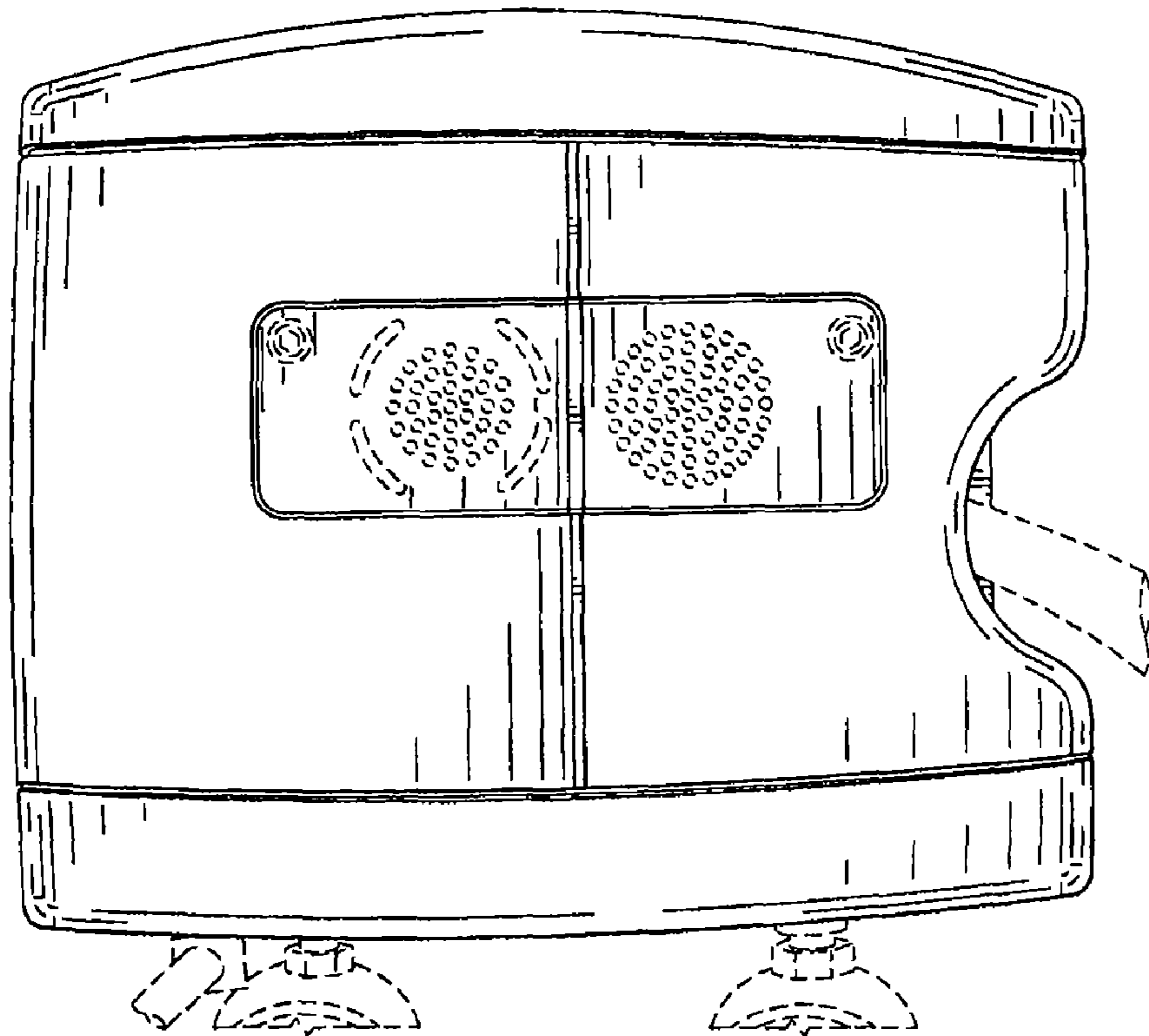
