DESCRIPTION

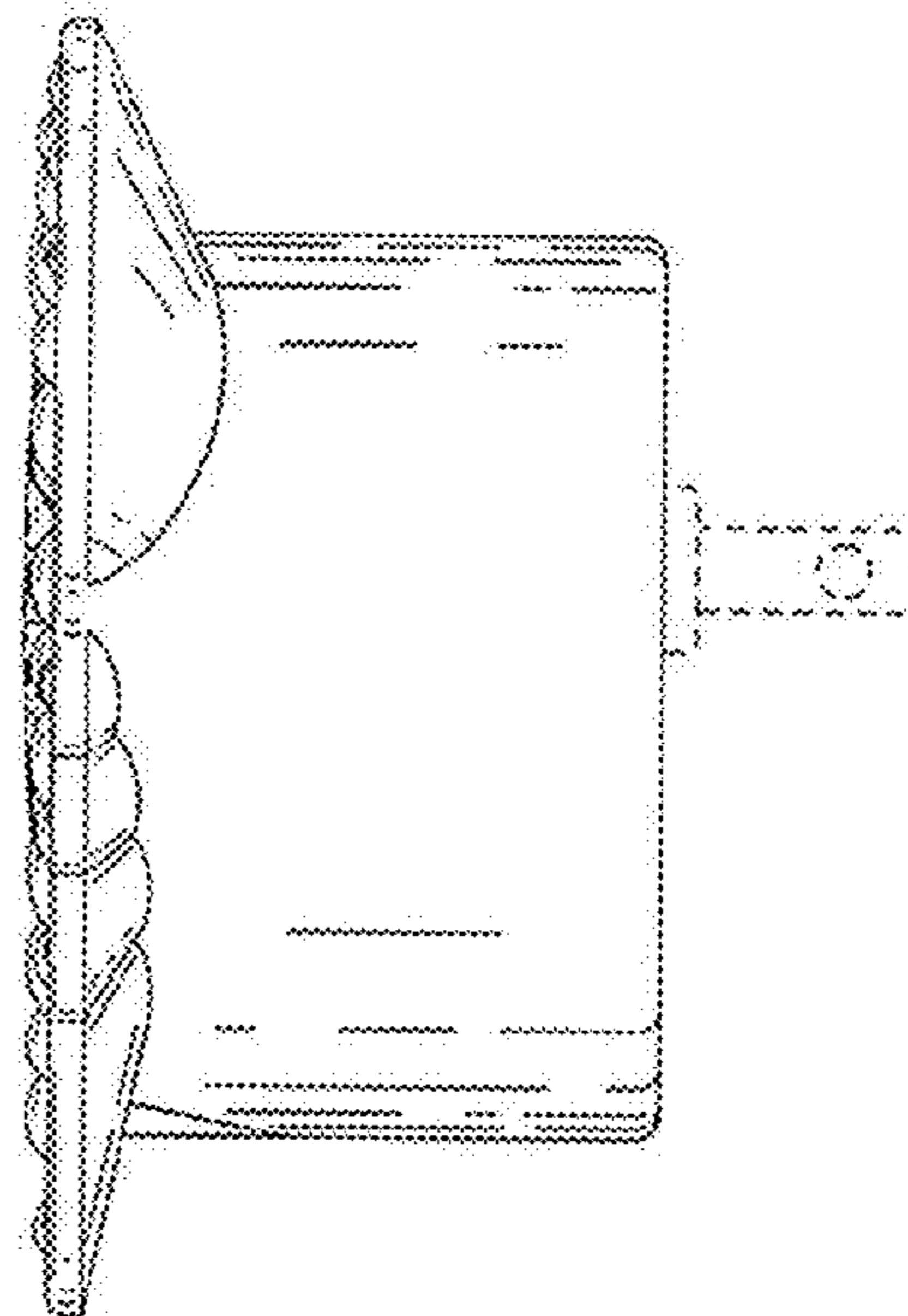
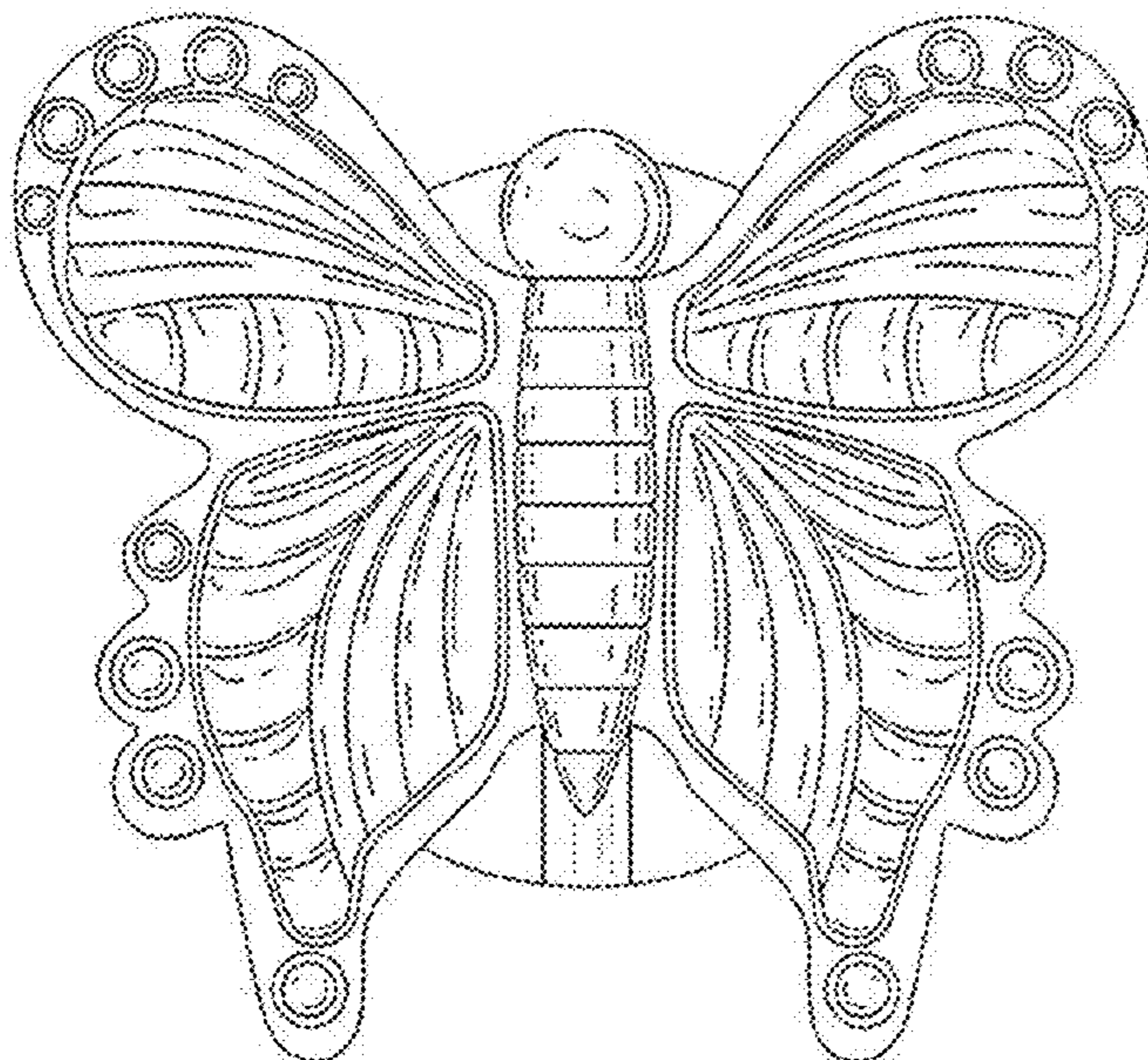
FIG. 1 is a perspective view of the butterfly night light ultrasonic pest repeller.

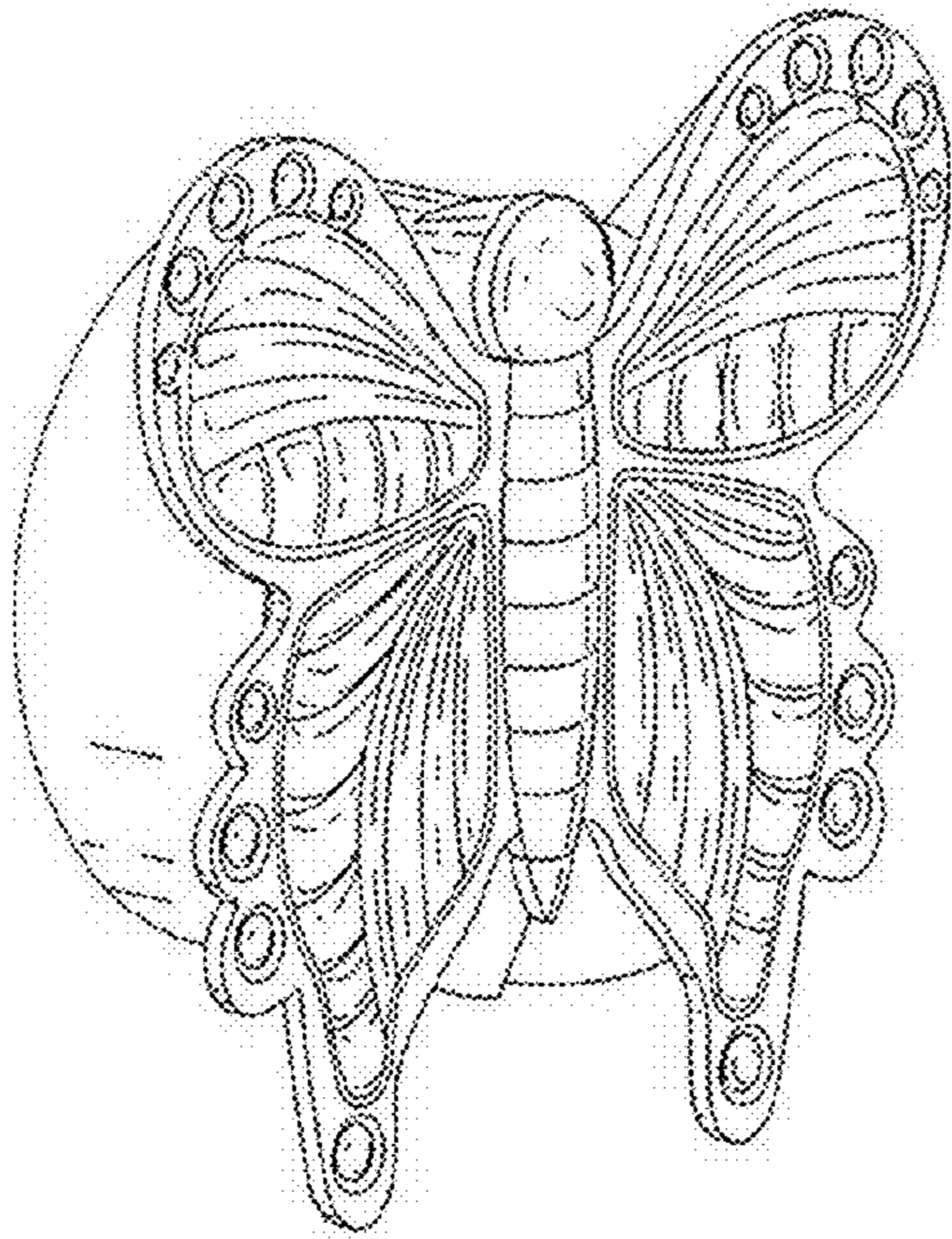

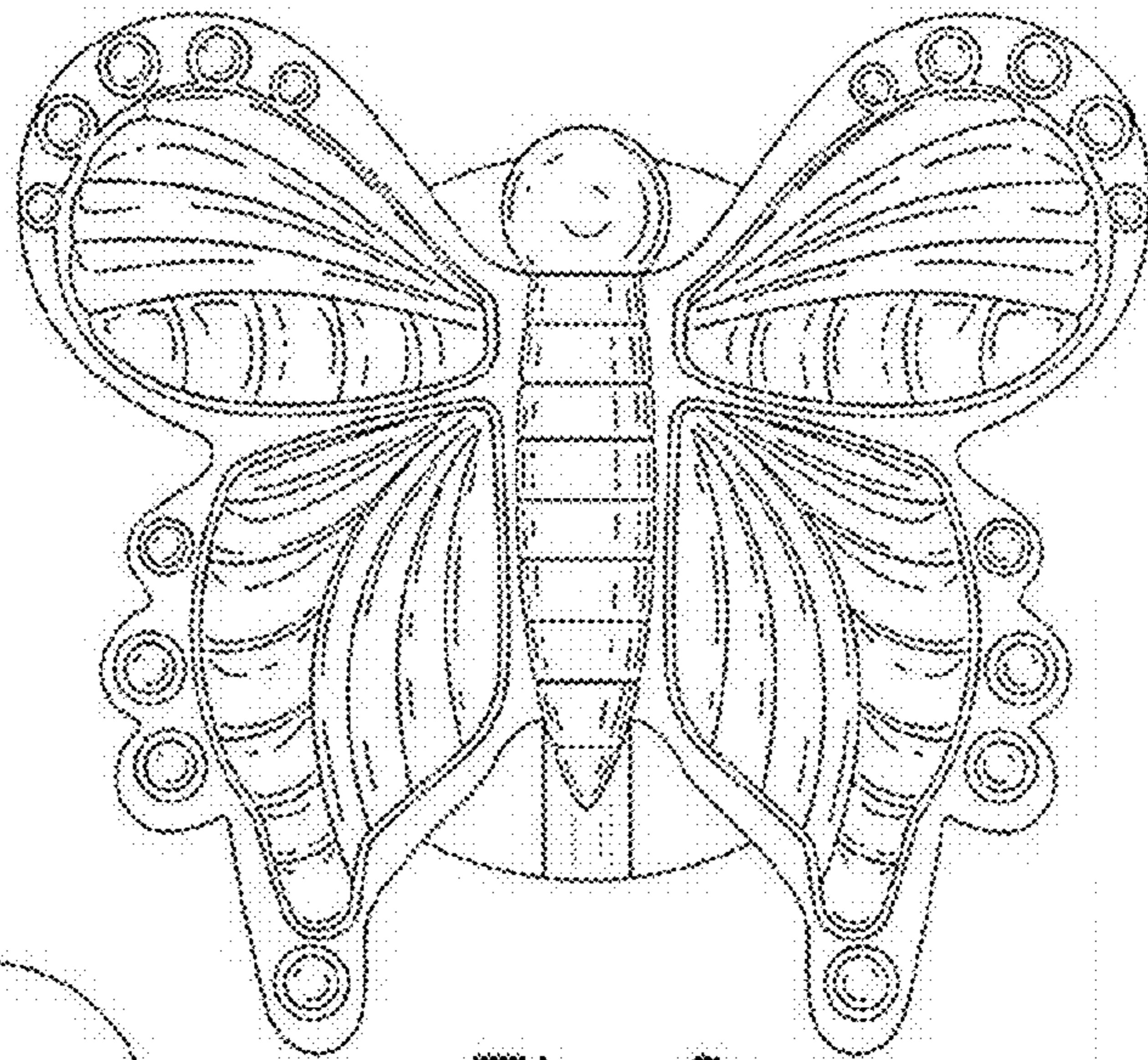

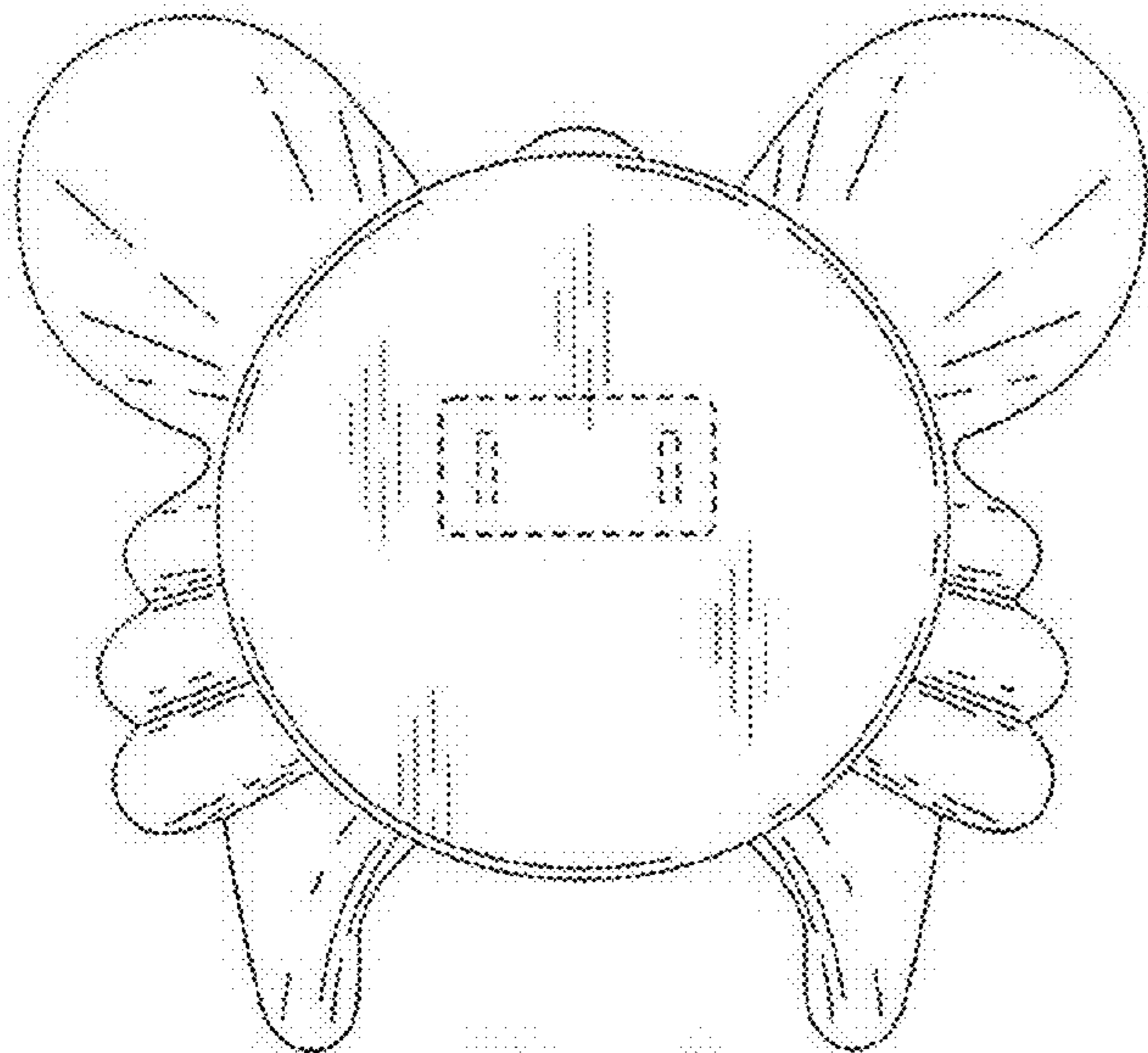

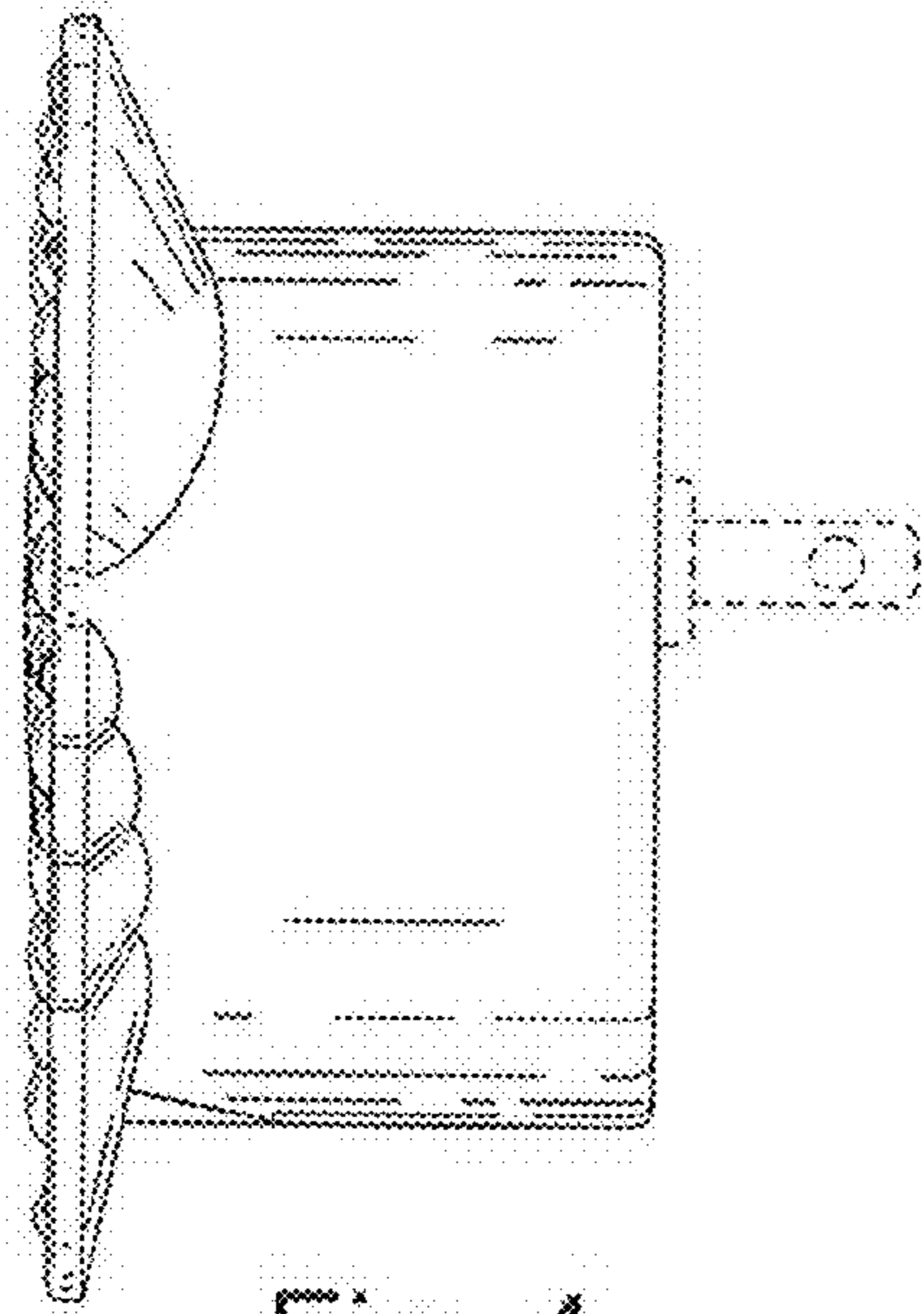

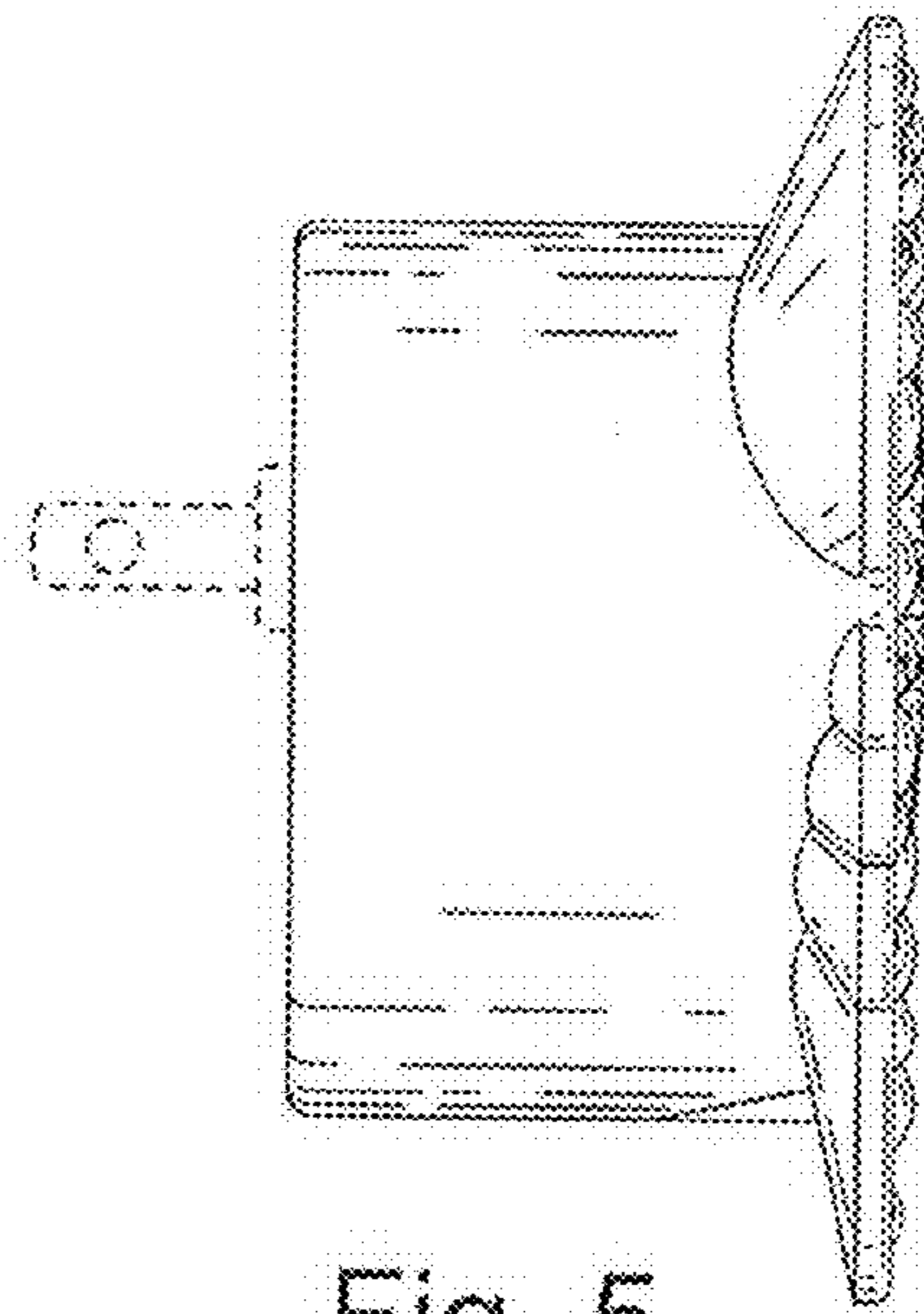

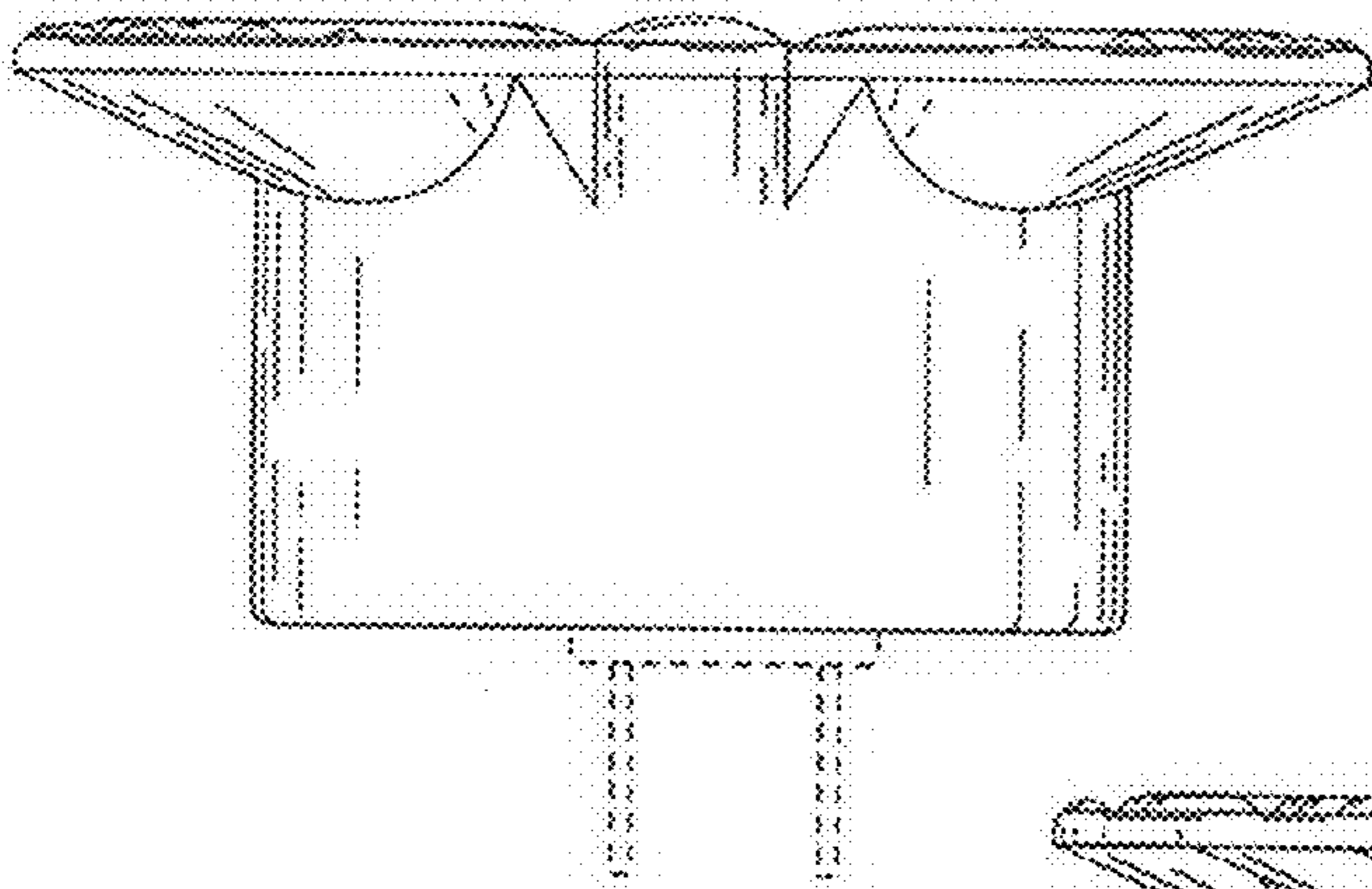

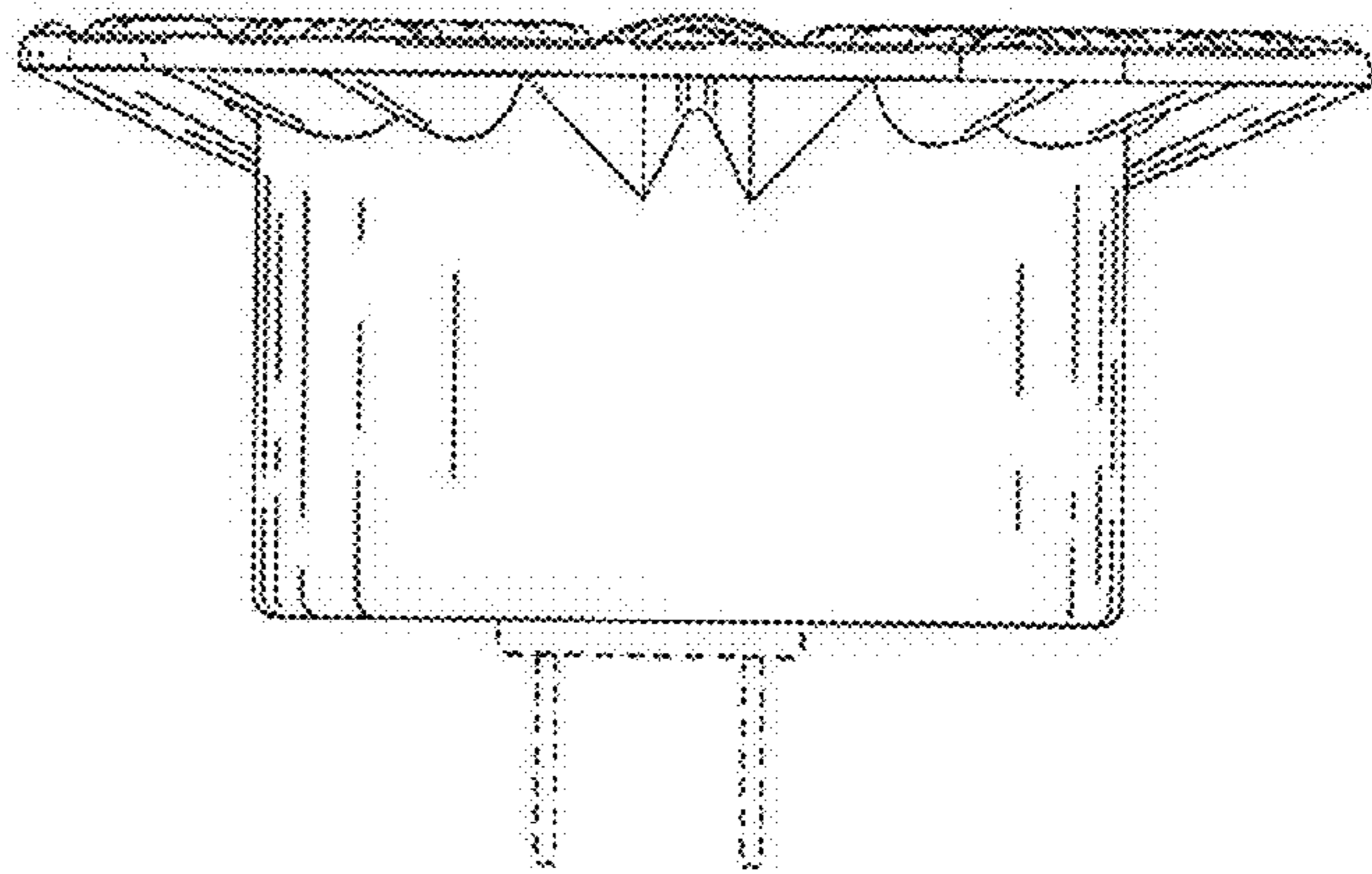
