The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the light fixture comprising my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a side elevational view thereof;

FIG. 4 is a side elevational view opposite to that of FIG. 3;

FIG. 5 is a top perspective view thereof; and,

FIG. 6 is a bottom perspective view thereof.

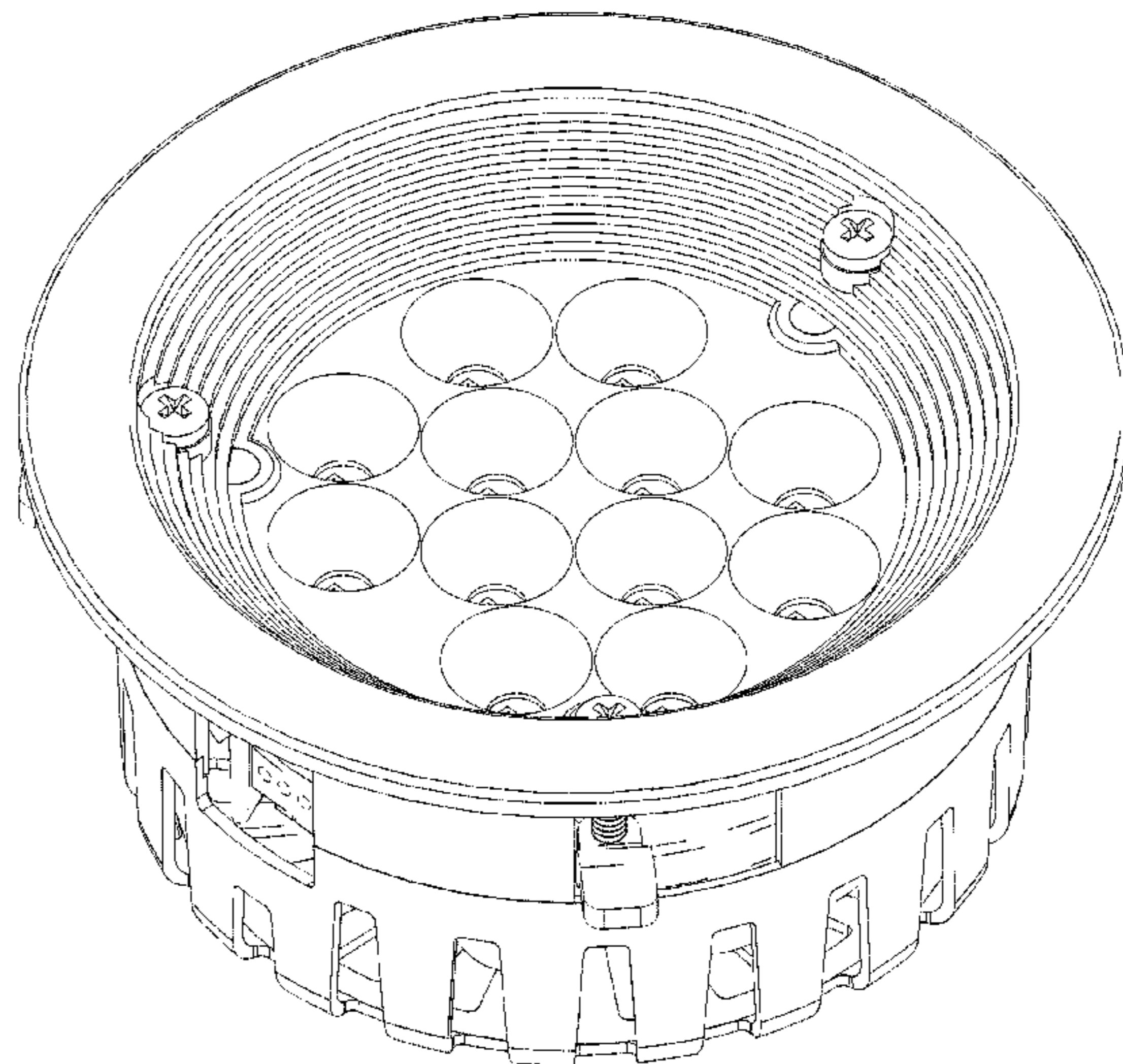
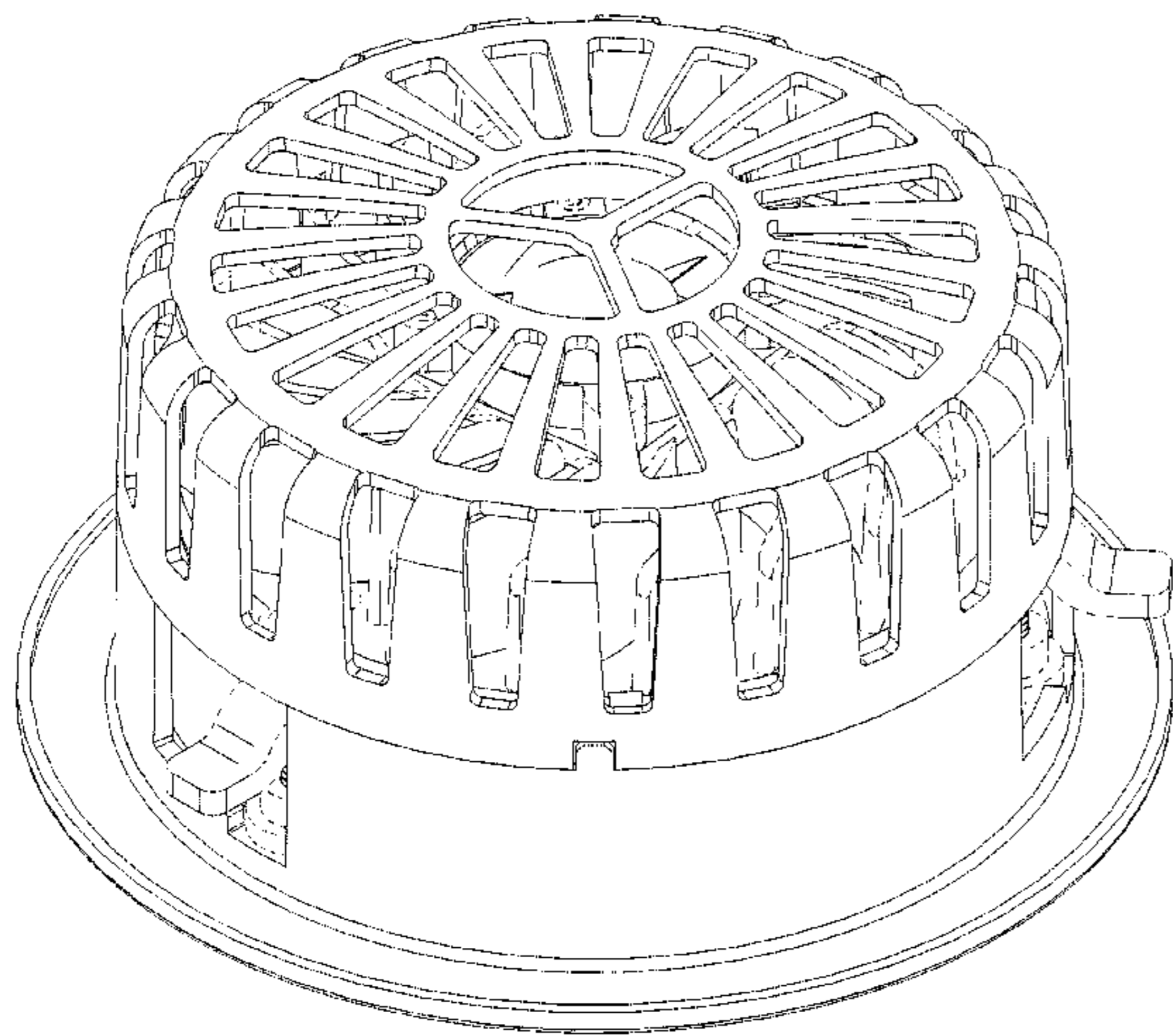

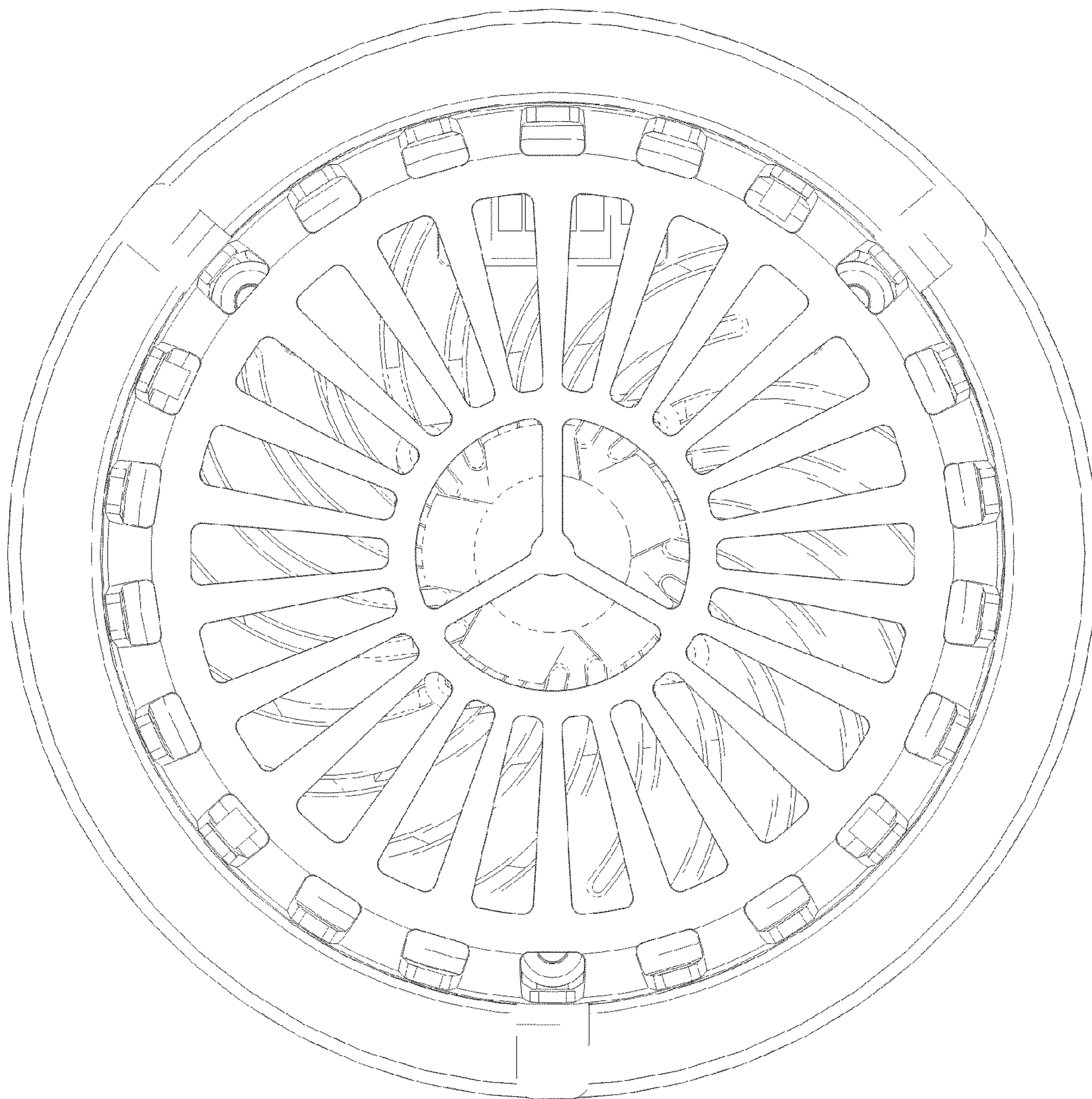

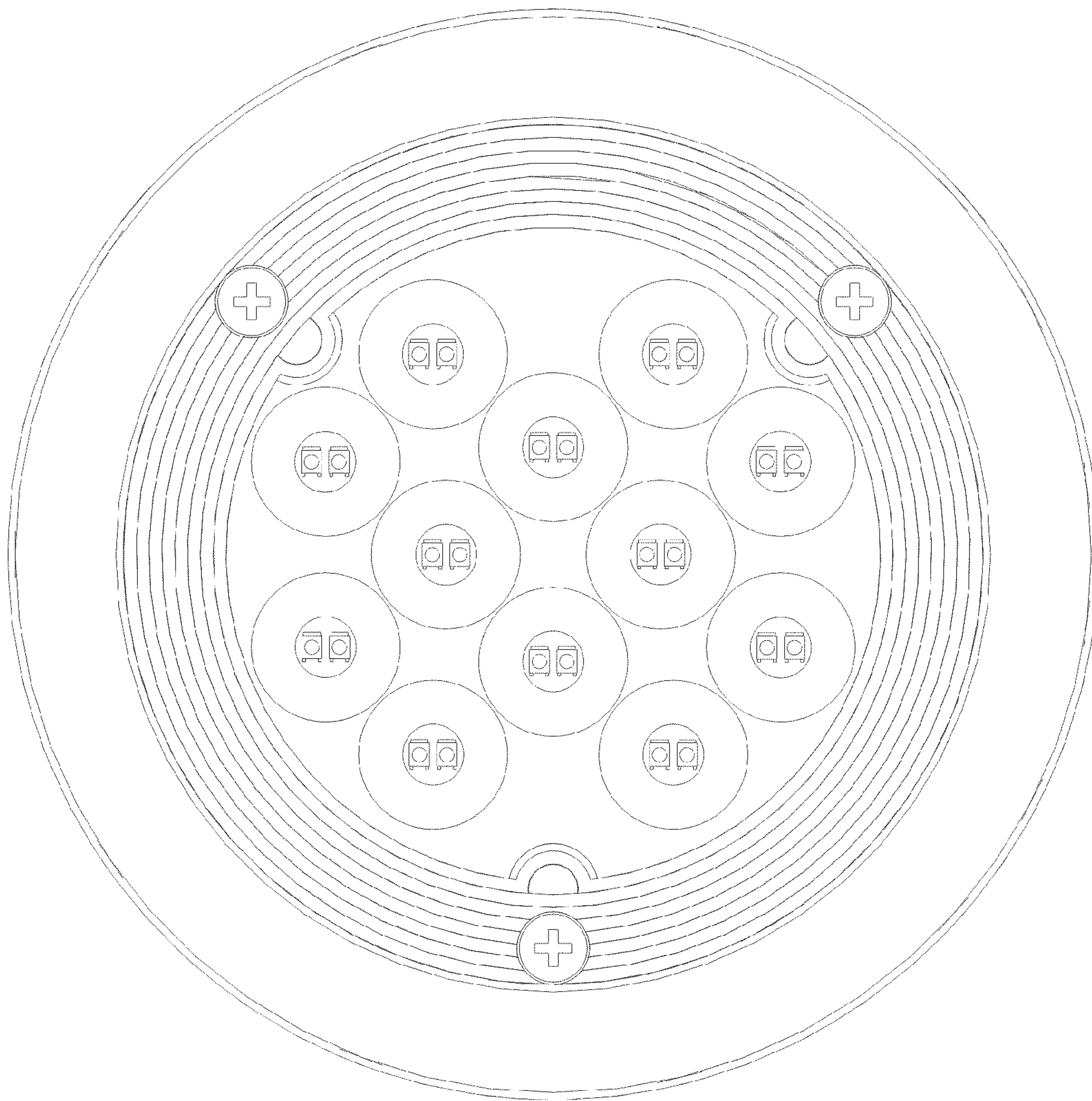

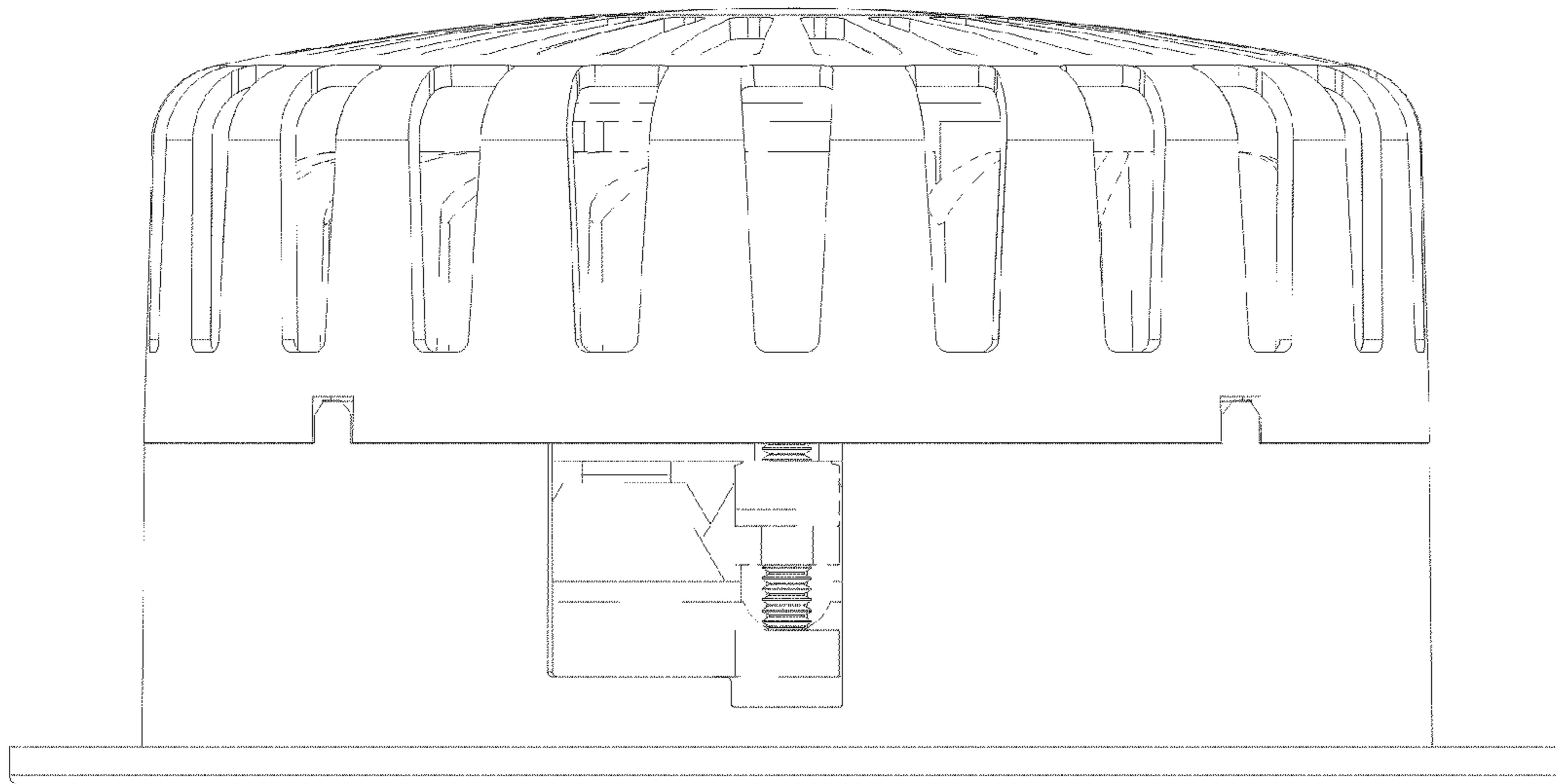

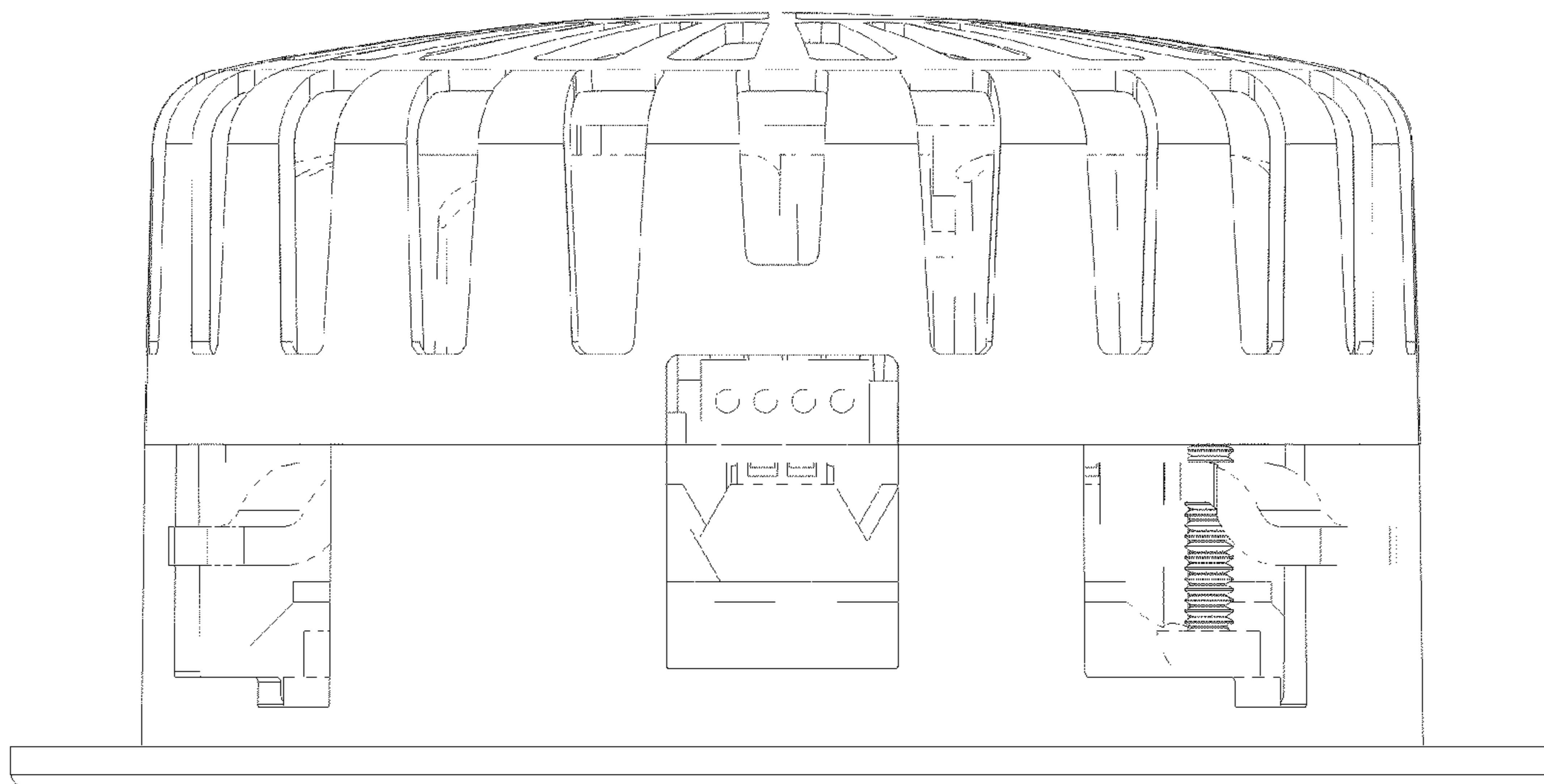

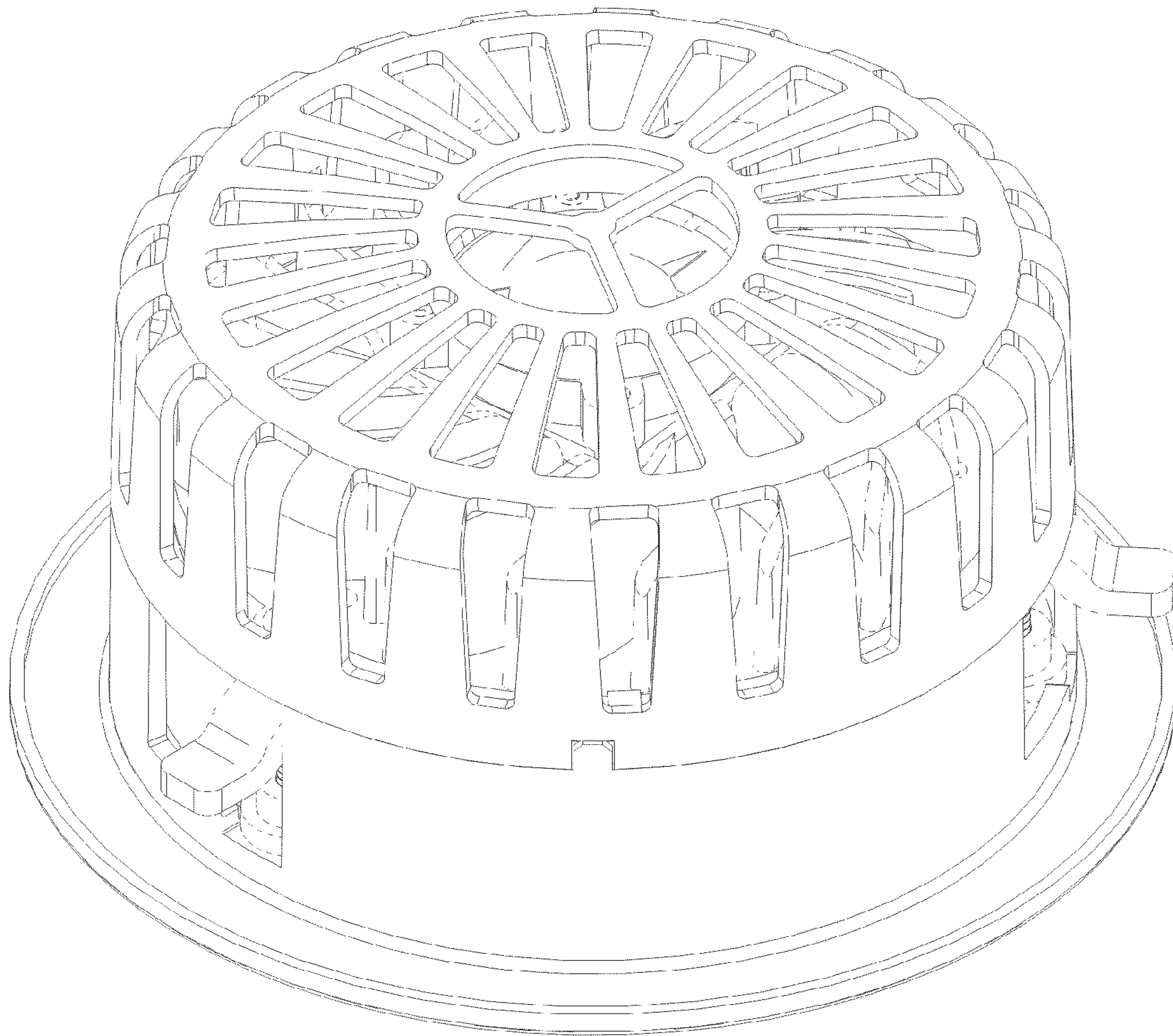
