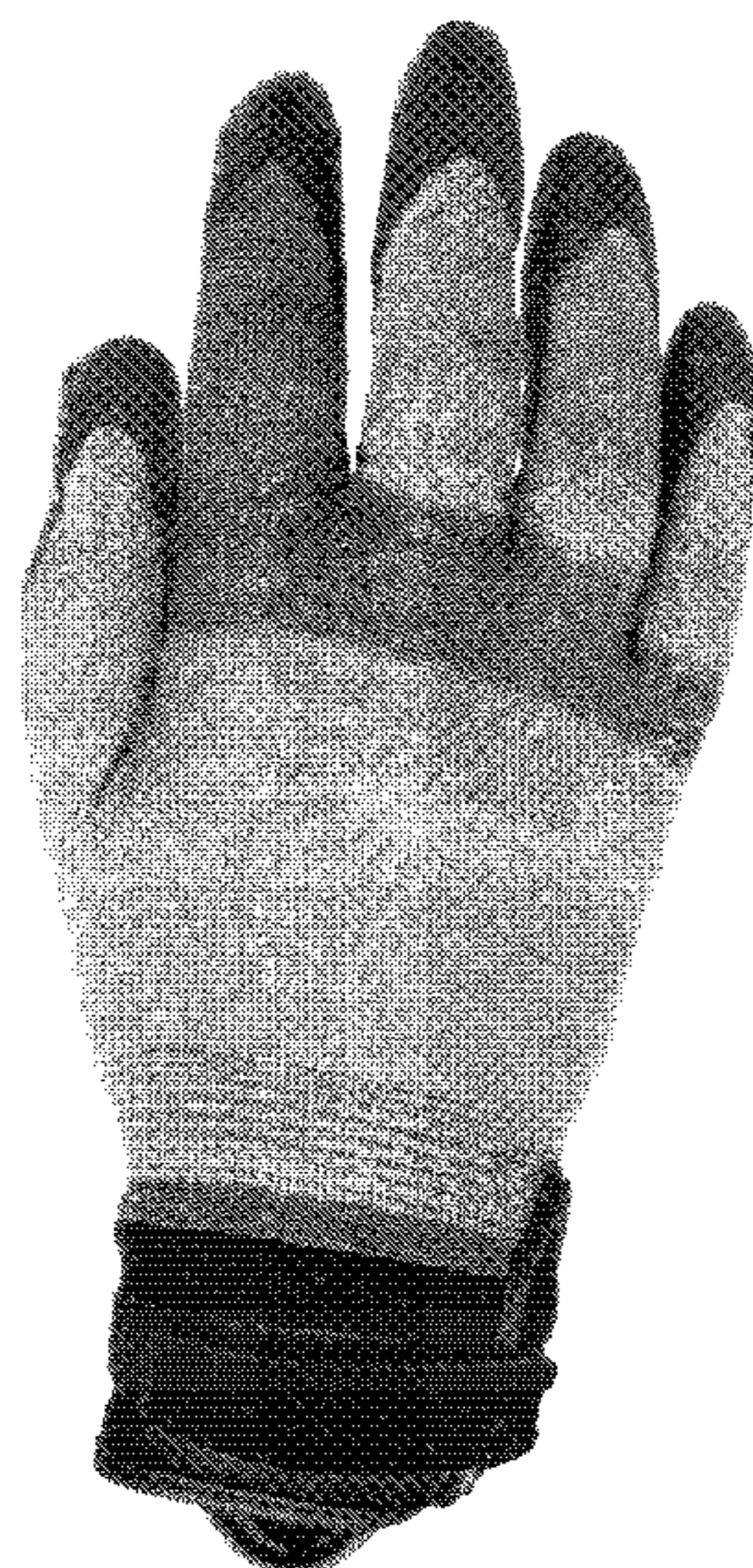
(57) **CLAIM**

The ornamental design for a glove, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a back view of a glove embodying the new design; FIG. 2 is a front view of a glove embodying the new design; FIG. 3 is a right view of a glove embodying the new design; FIG. 4 is a left view of a glove embodying the new design; FIG. 5 is a top view of a glove embodying the new design; and, FIG. 6 is a bottom view of a glove embodying the new design. All figures illustrate right hand glove designs, it is to be understood that the invention includes left hand glove designs which would be illustrated as mirror images of any or all of the view shown in FIGS. 1-6. The broken lines shown on the drawings form no part of the claimed design.

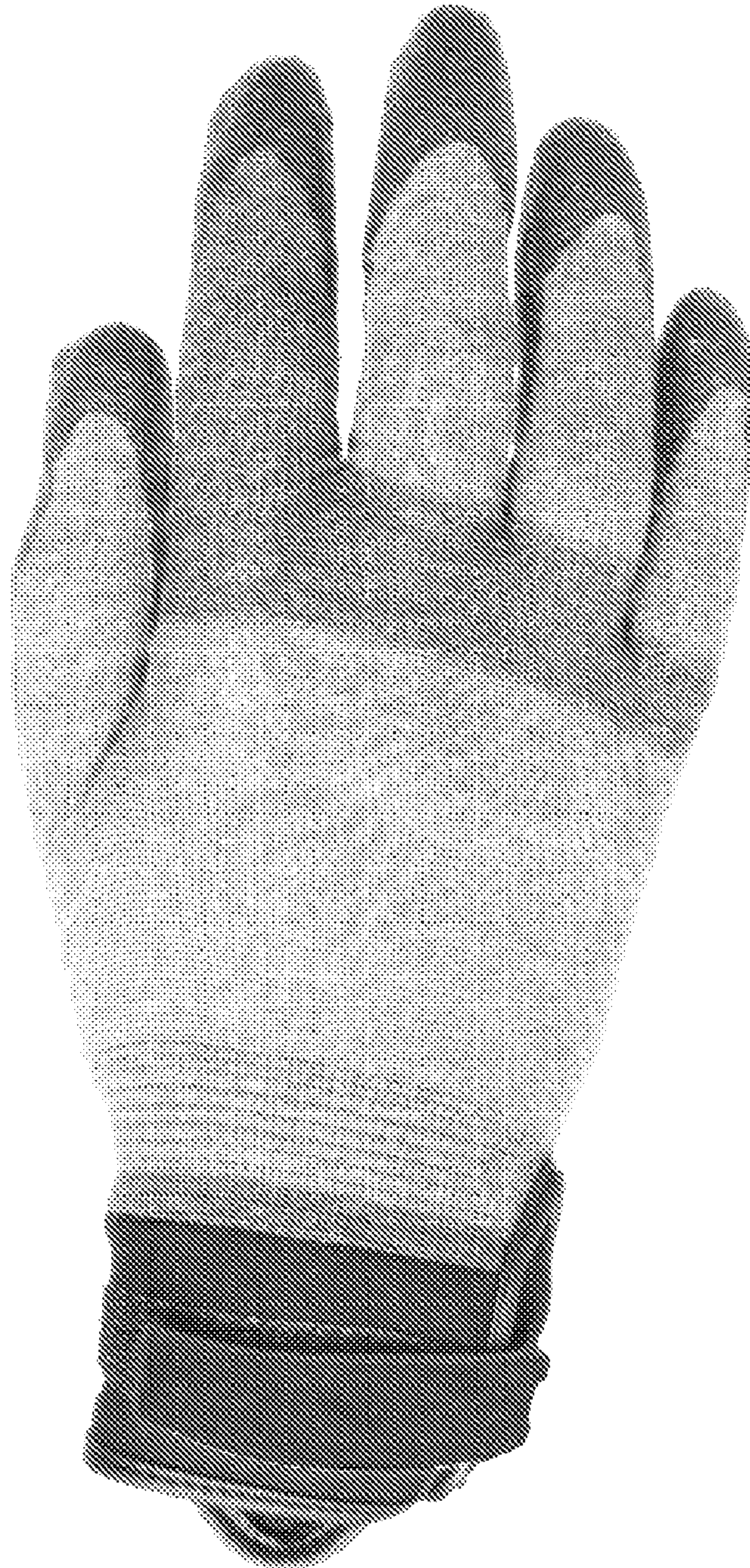

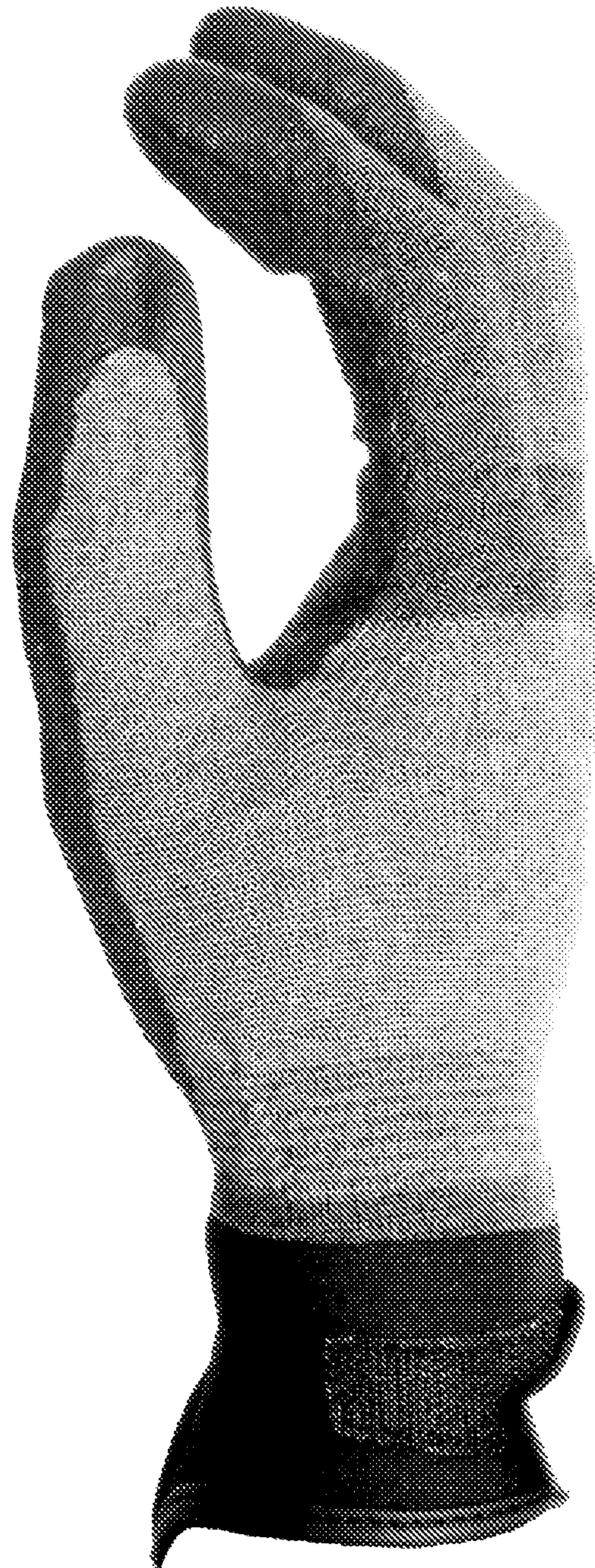

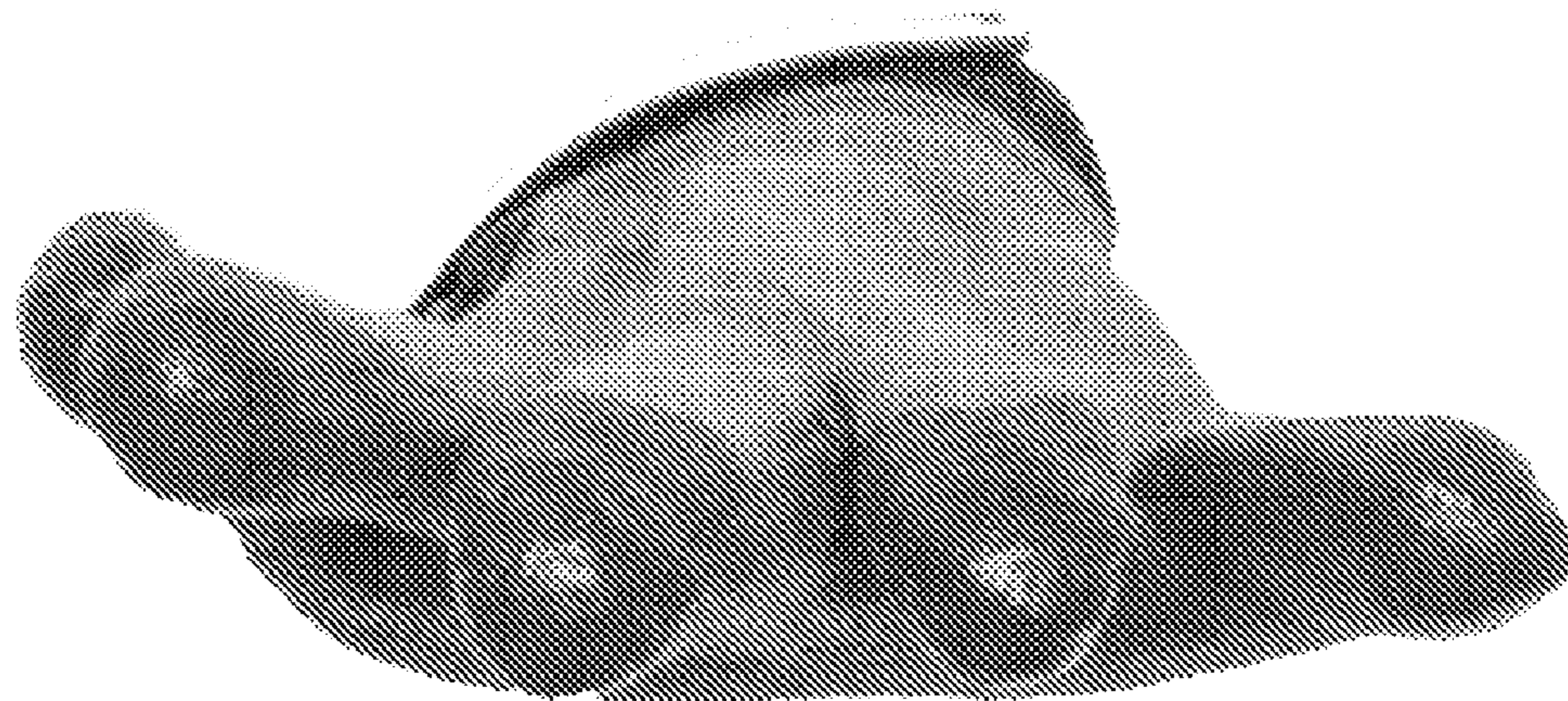

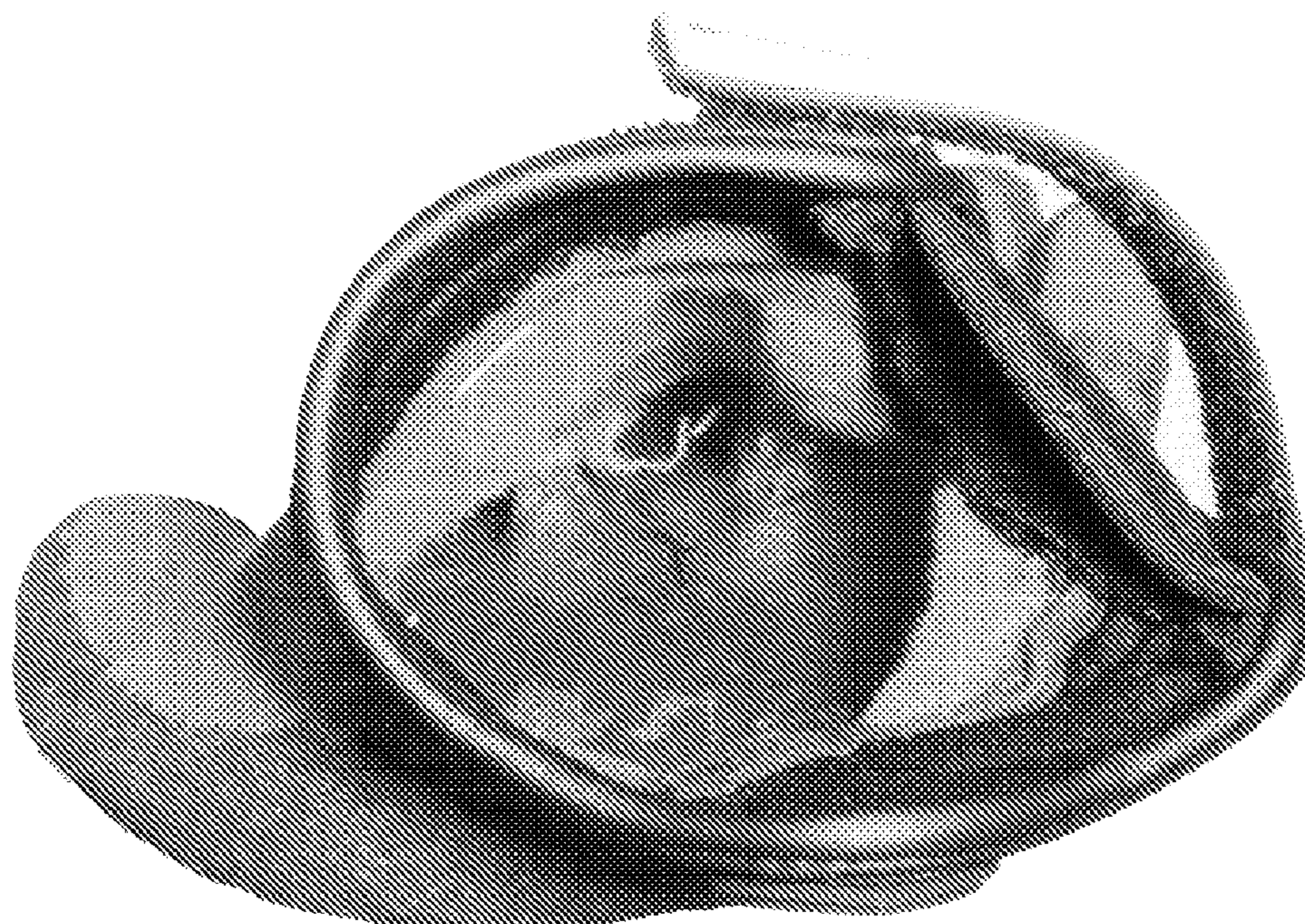
