

(57) **CLAIM**

I claim the ornamental design for a combined pet collar and lead, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the combined pet collar and lead.
FIG. 2 is a second perspective view thereof;
FIG. 3 is a third perspective view thereof in which the collar is in an open condition;
FIG. 4 is a fourth perspective view thereof;
FIG. 5 is a fifth perspective view thereof; and,






