FIG. 4 is a front view of the dog toy.

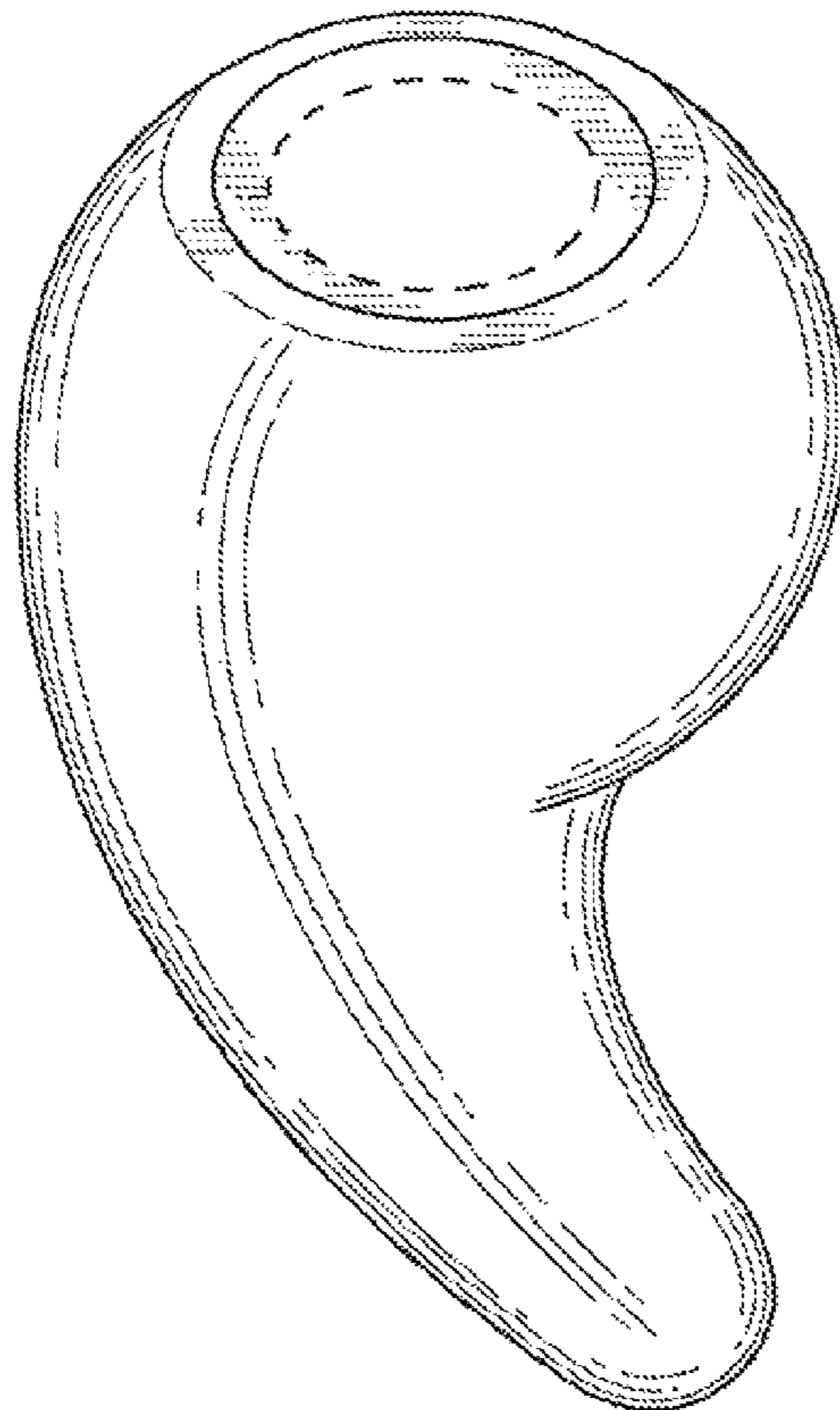
FIG. 5 is a back view of the dog toy.

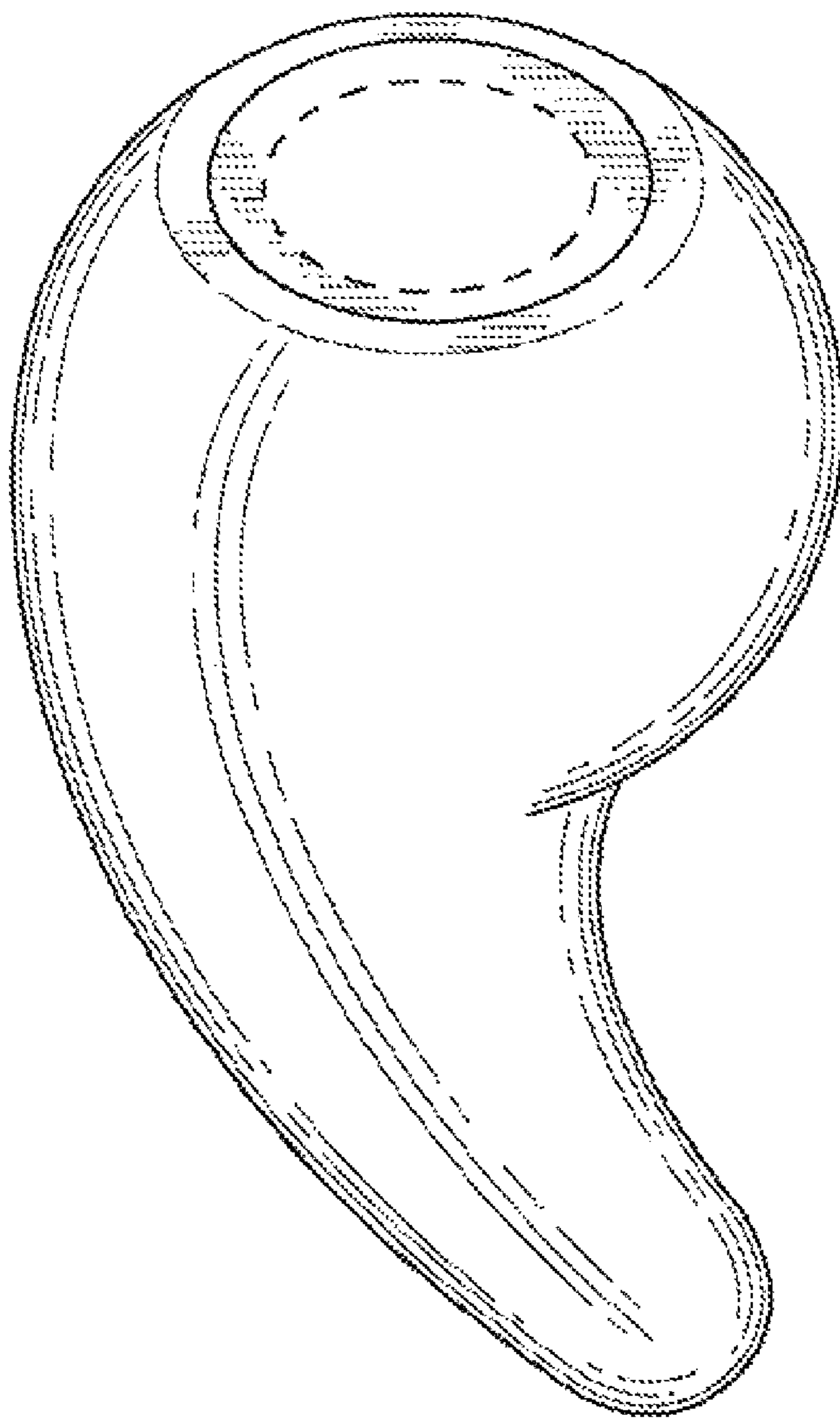

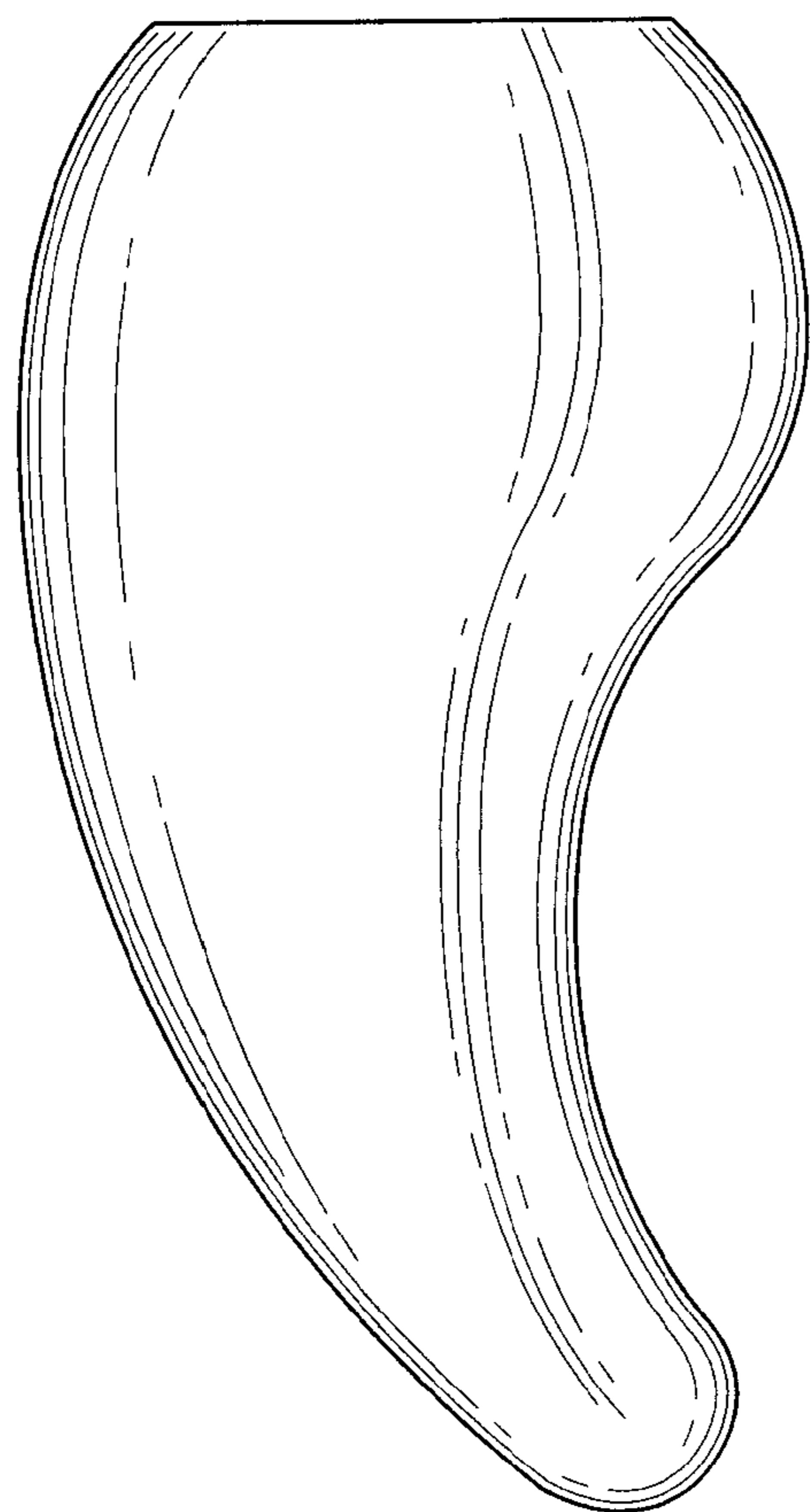

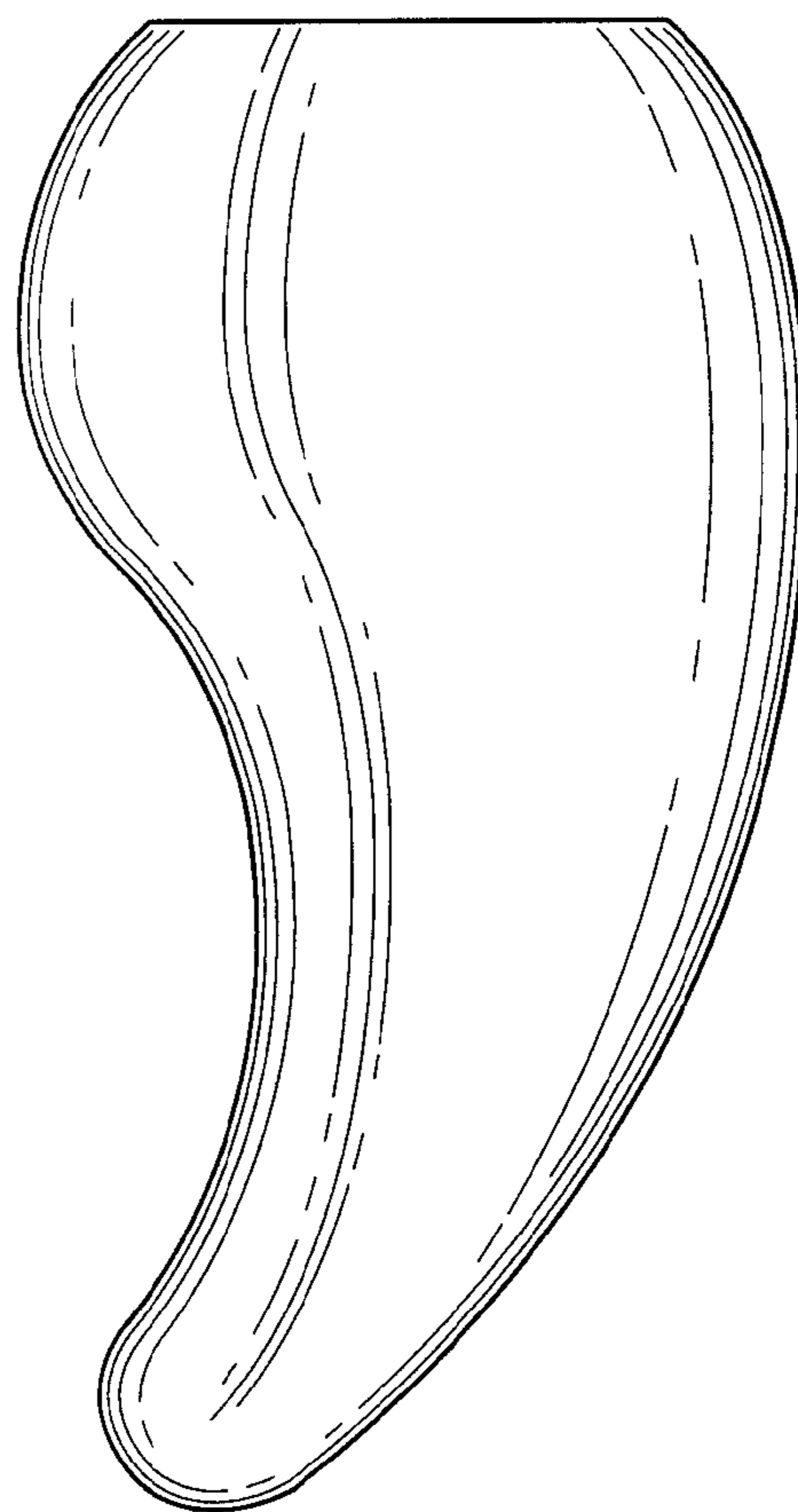

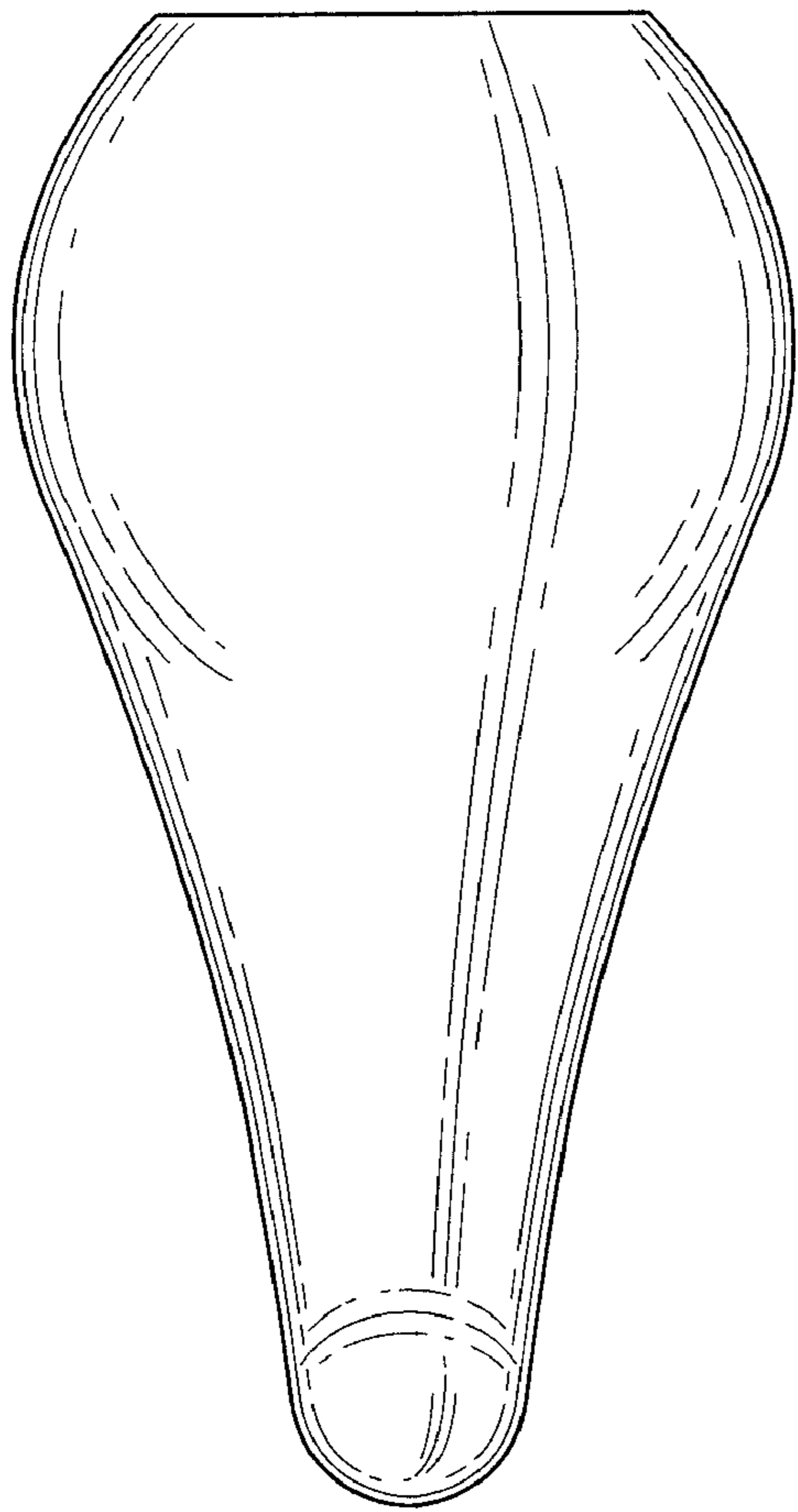

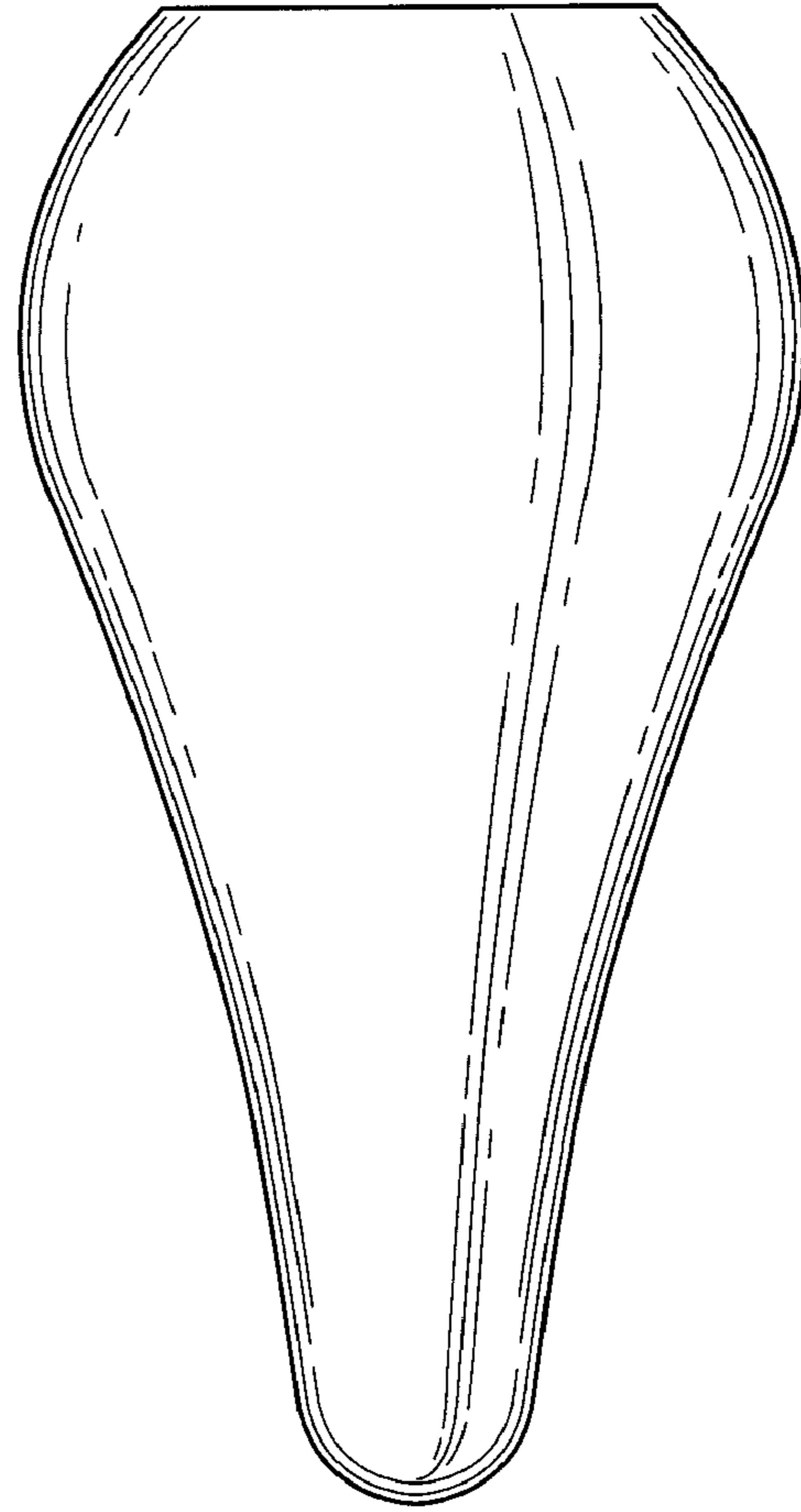

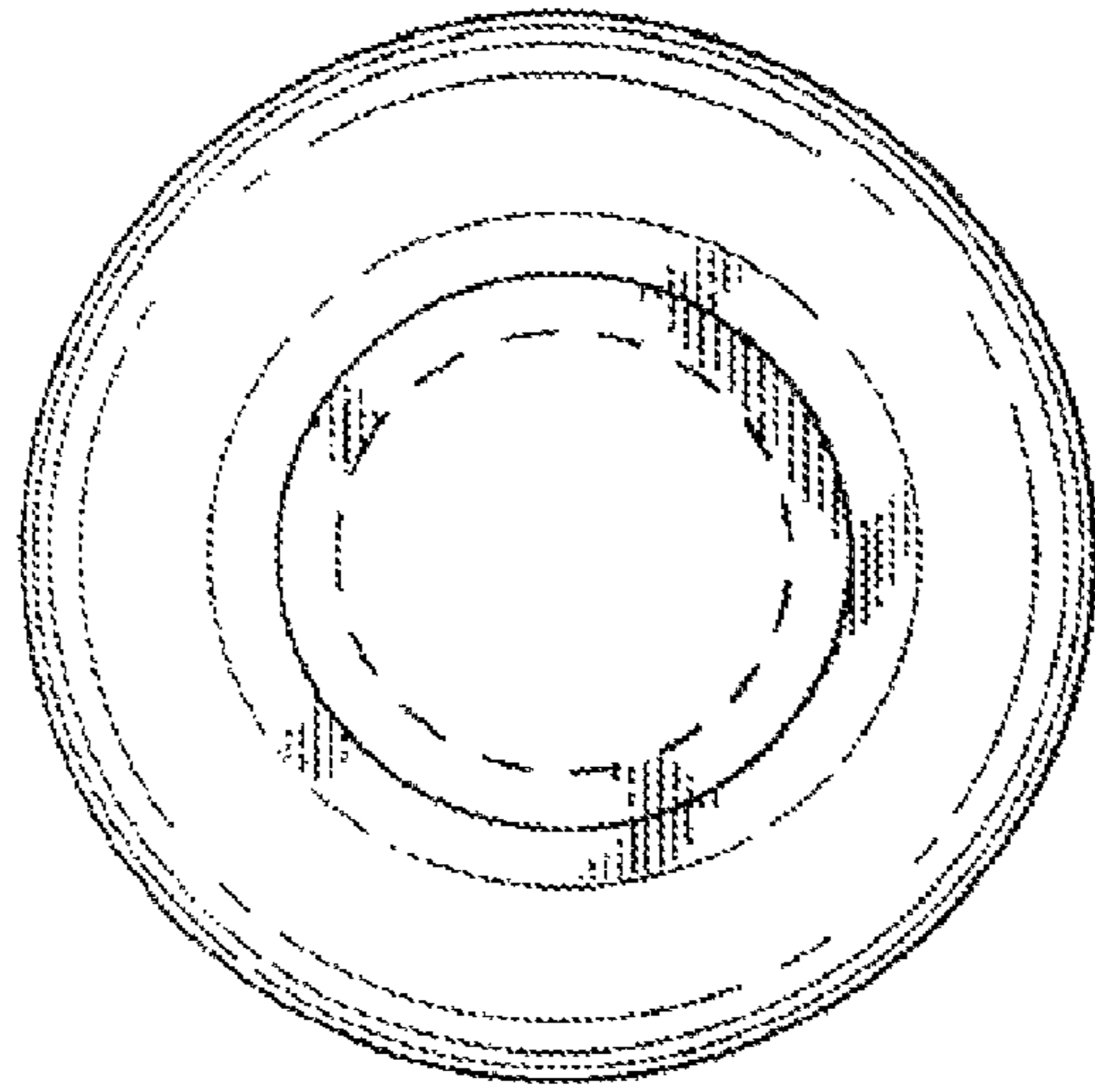

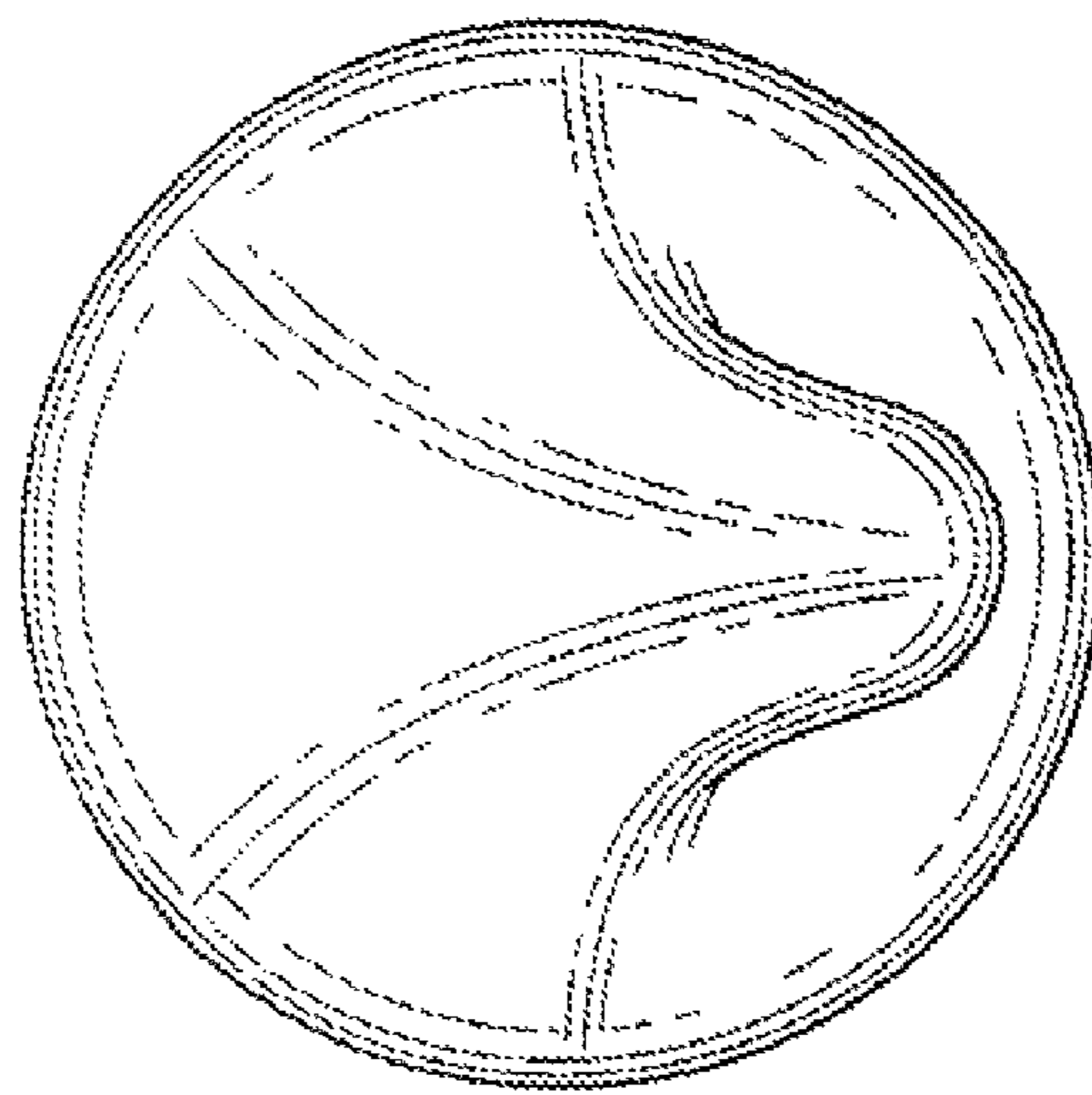
