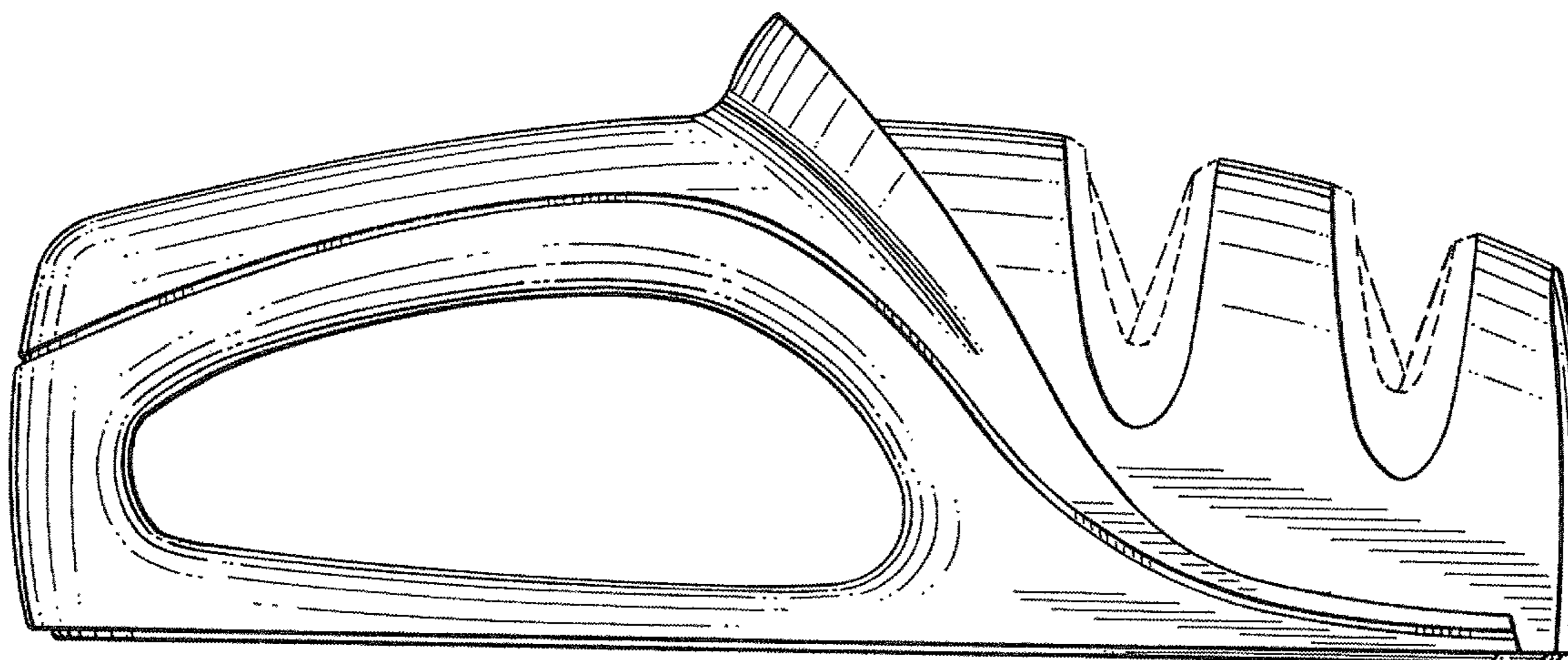
(57) **CLAIM**

The ornamental design for a two stage sharpener, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front right side perspective of our new design; FIG. 2 is a left side elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines in FIGS. 1, 2, and 4 illustrate features that form no part of the claimed design.

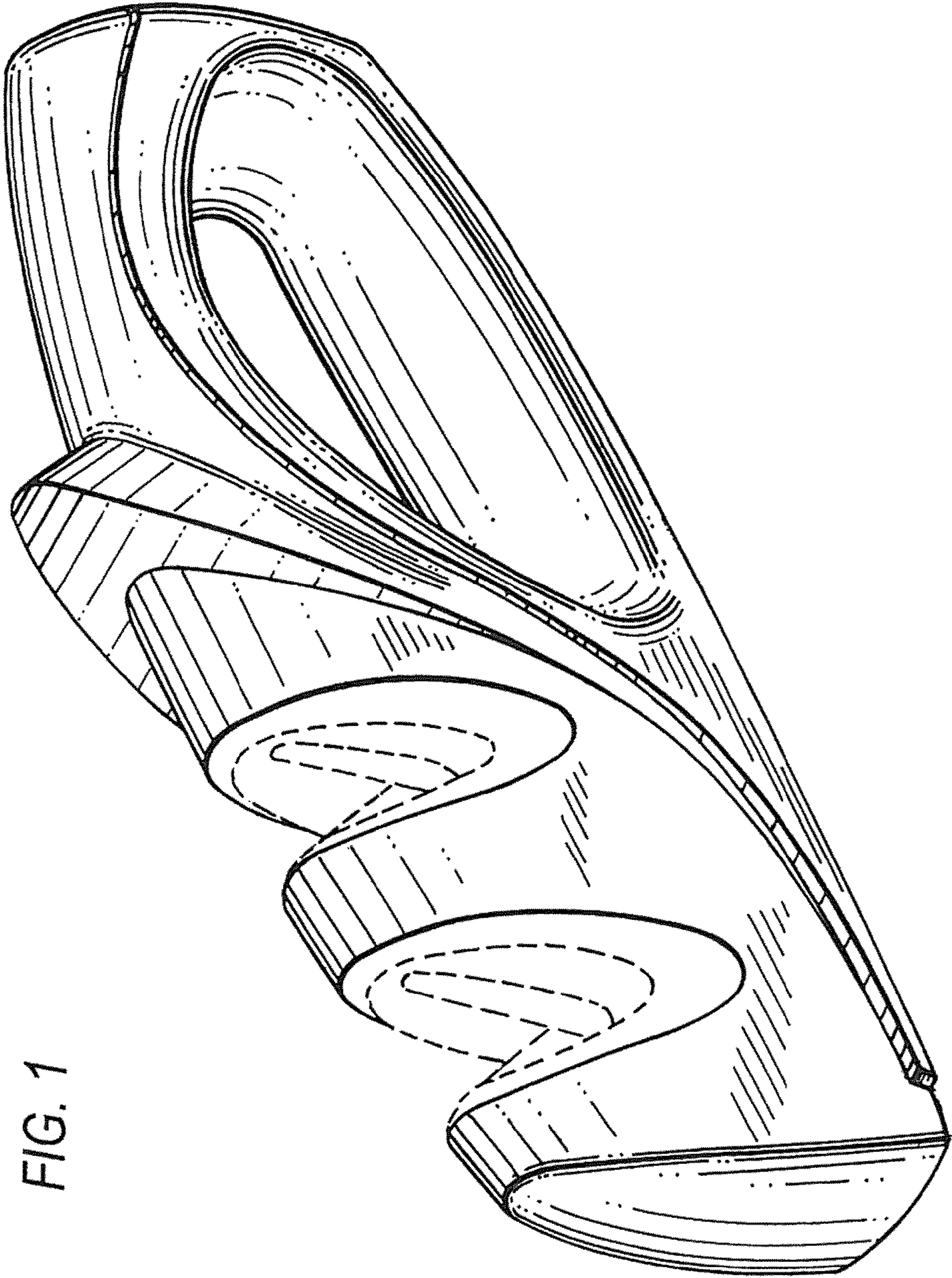

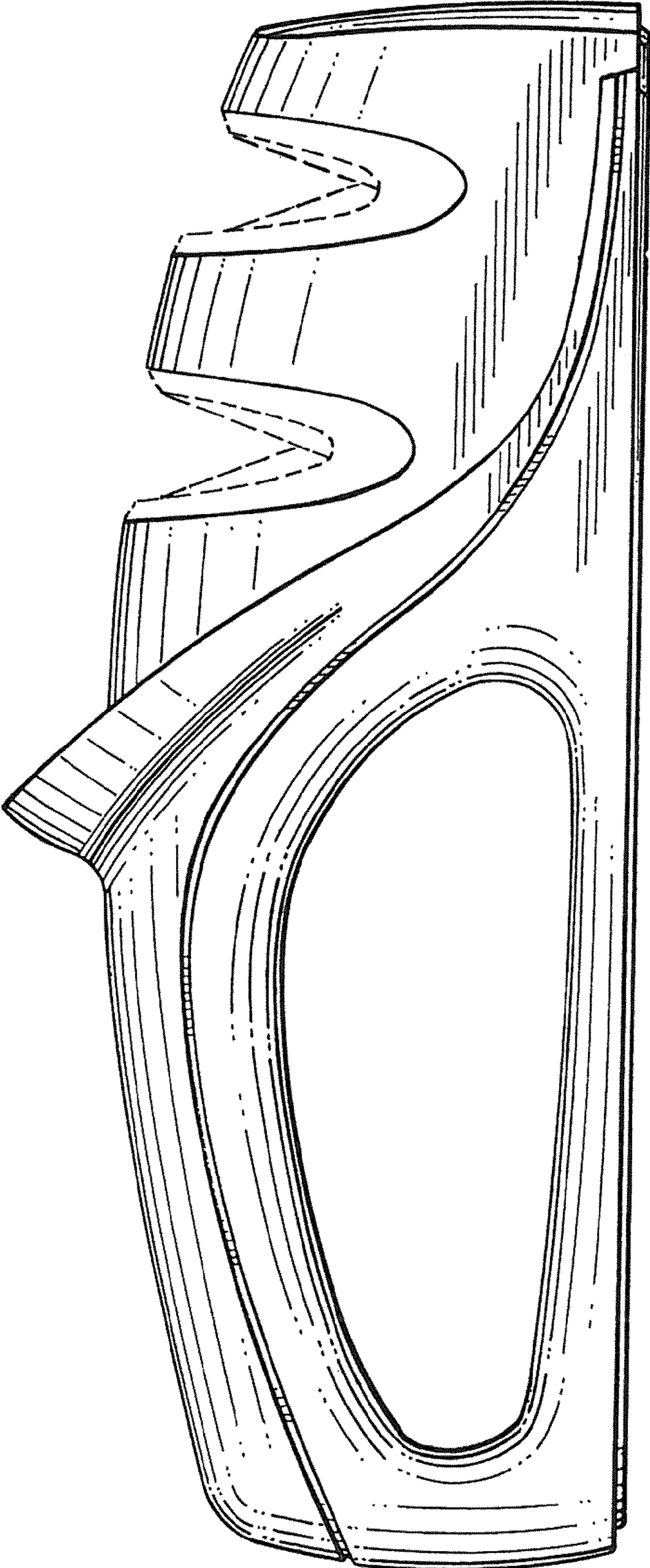

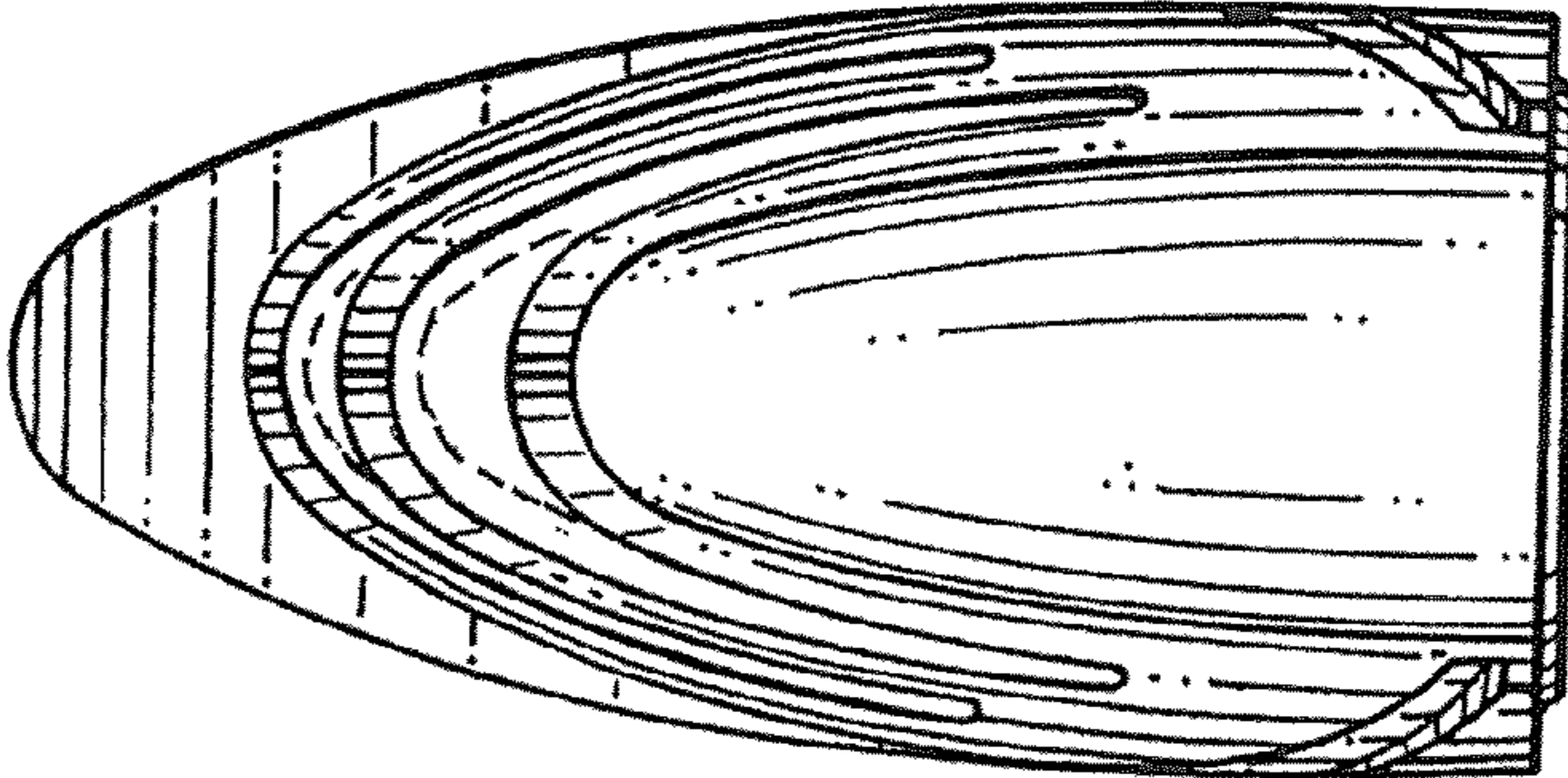

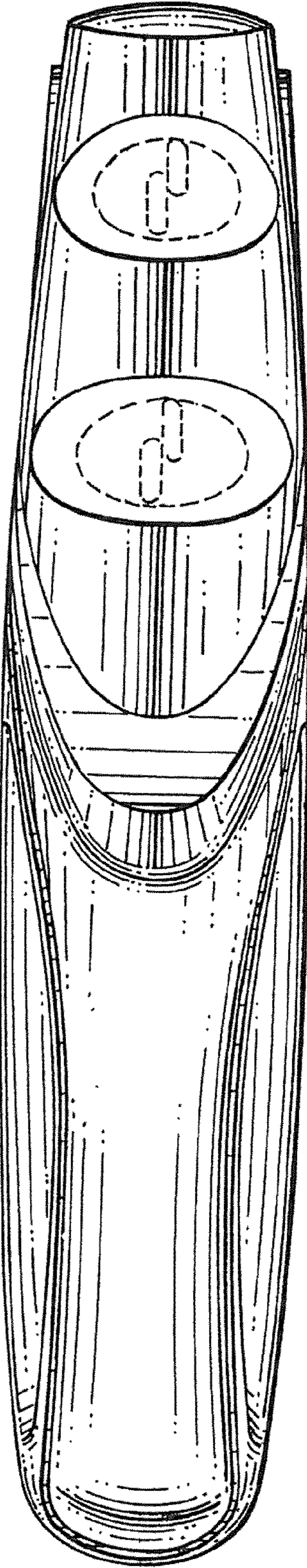

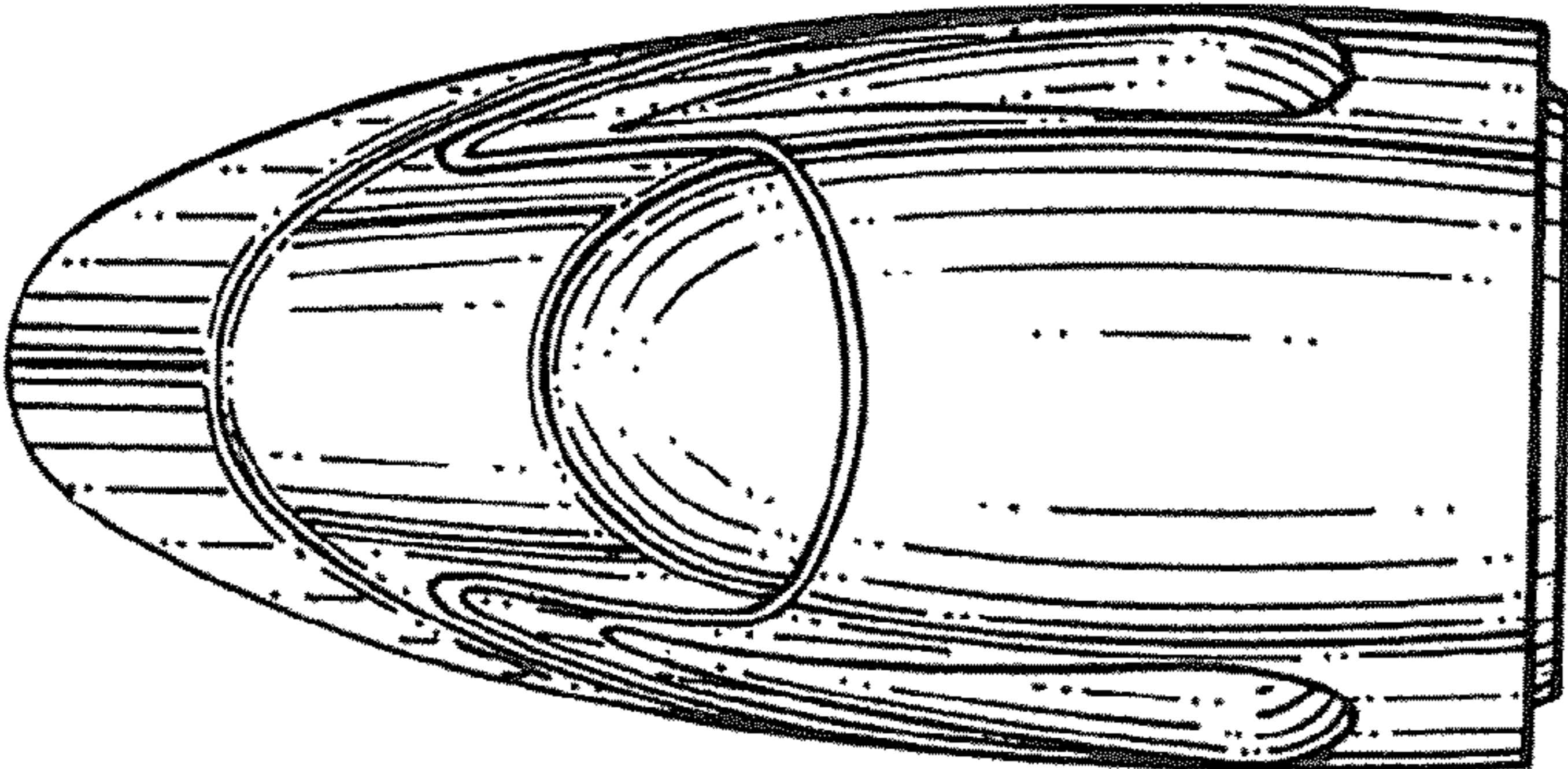

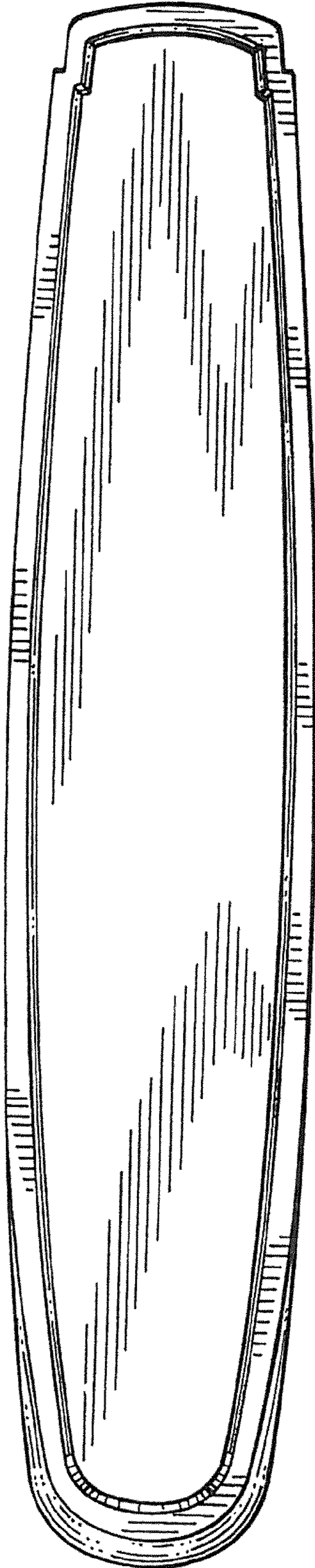
