**DESCRIPTION**

FIG. 1 is a front view of a clip showing our new design;

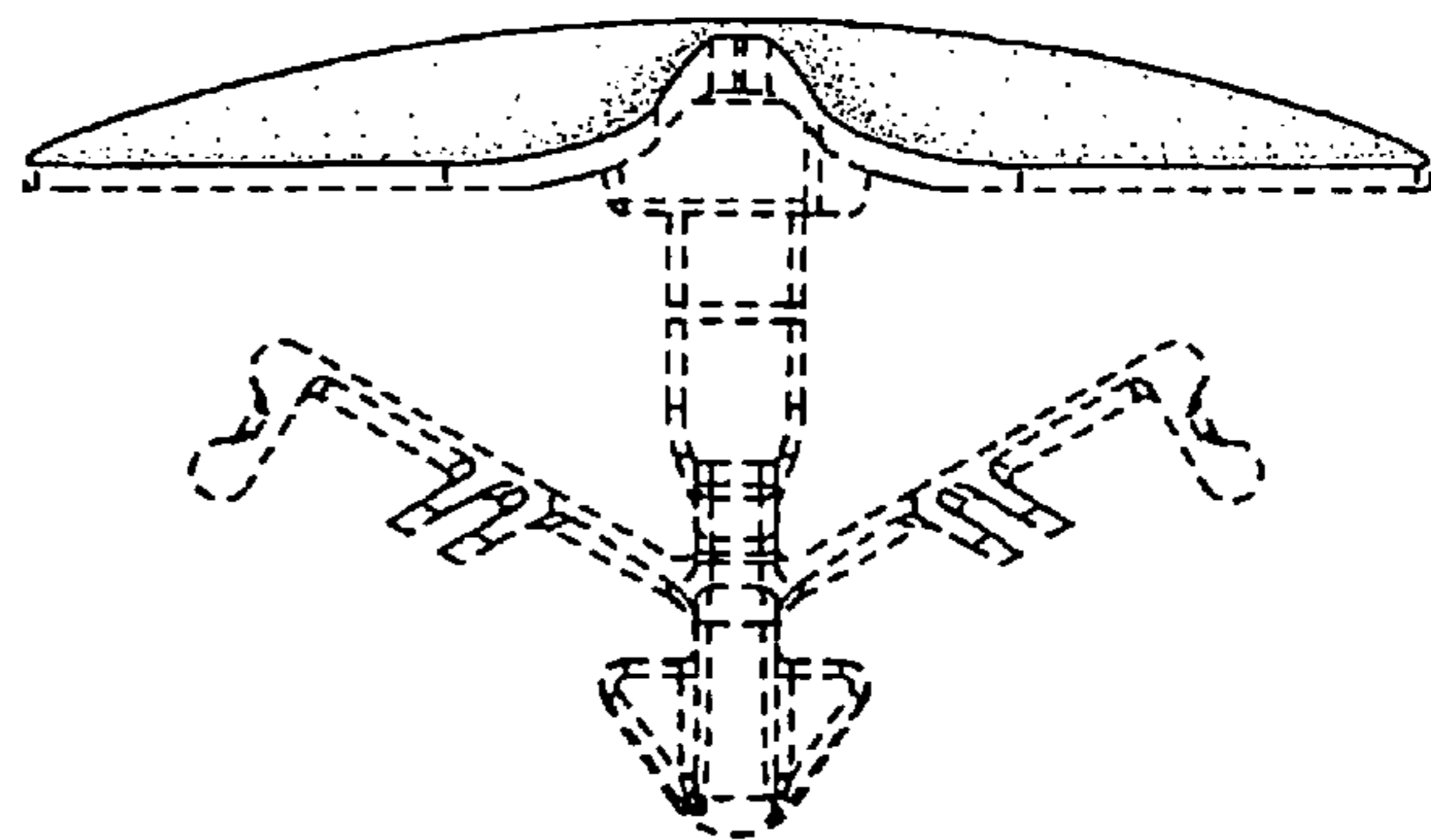
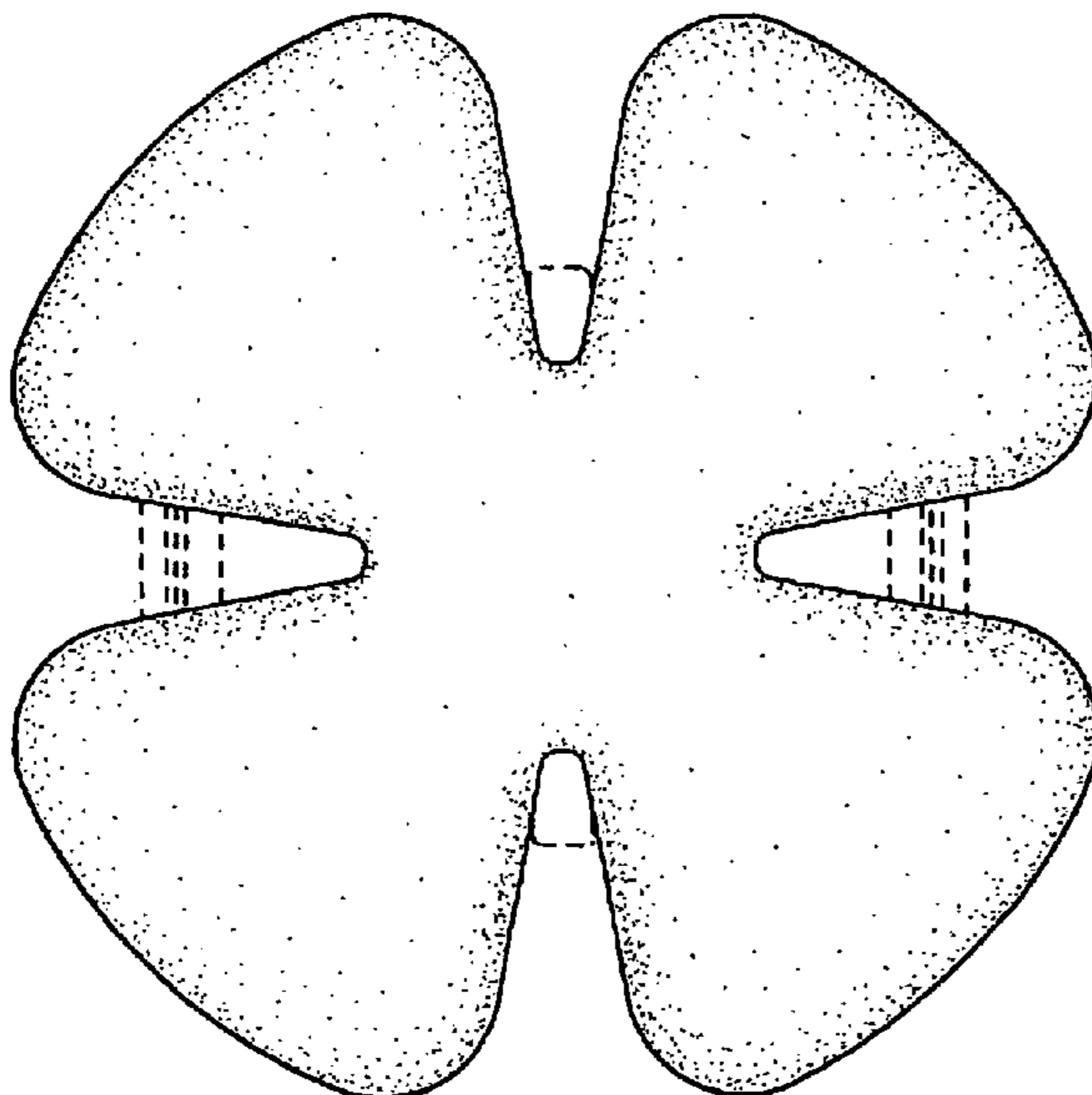

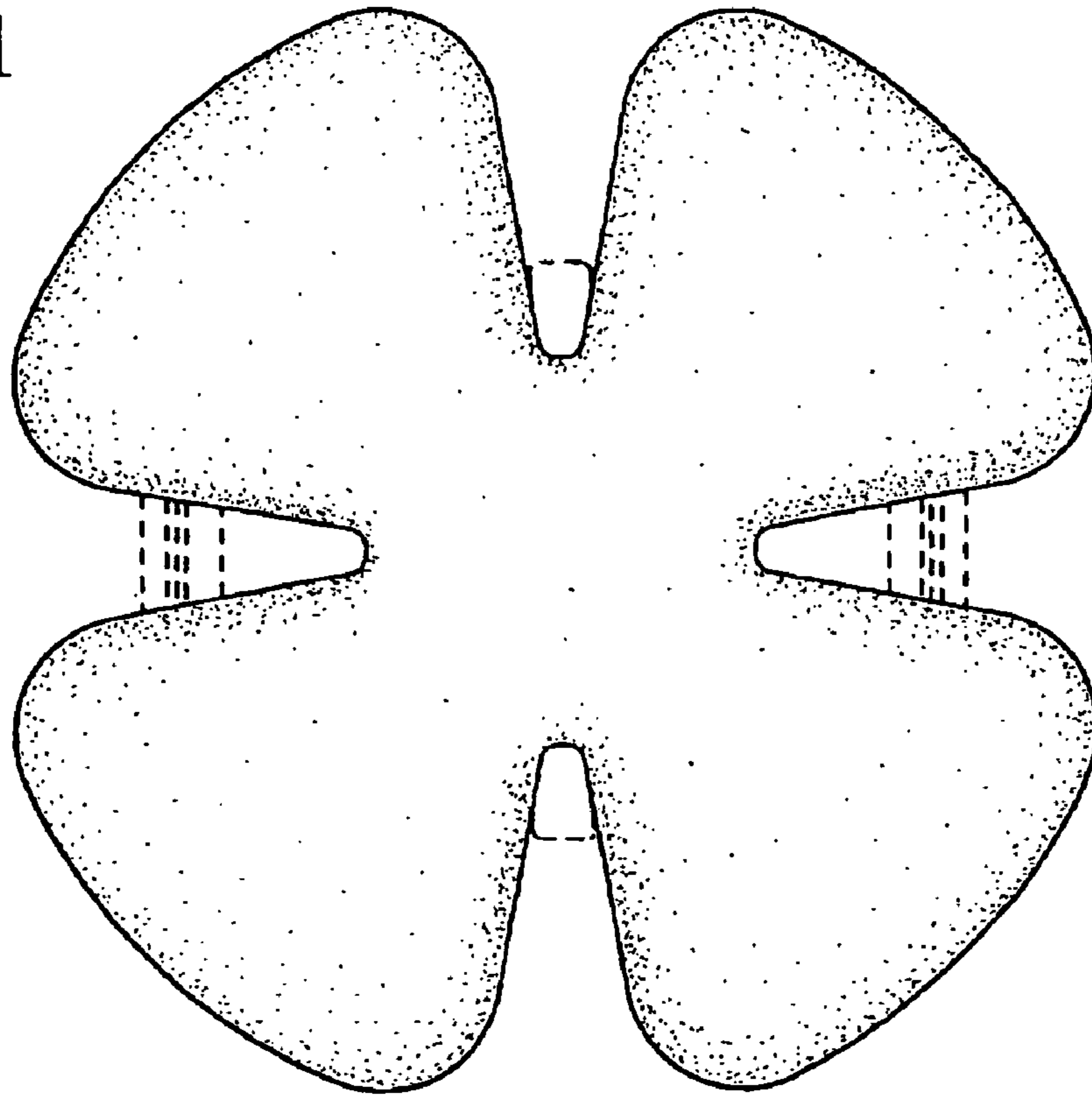

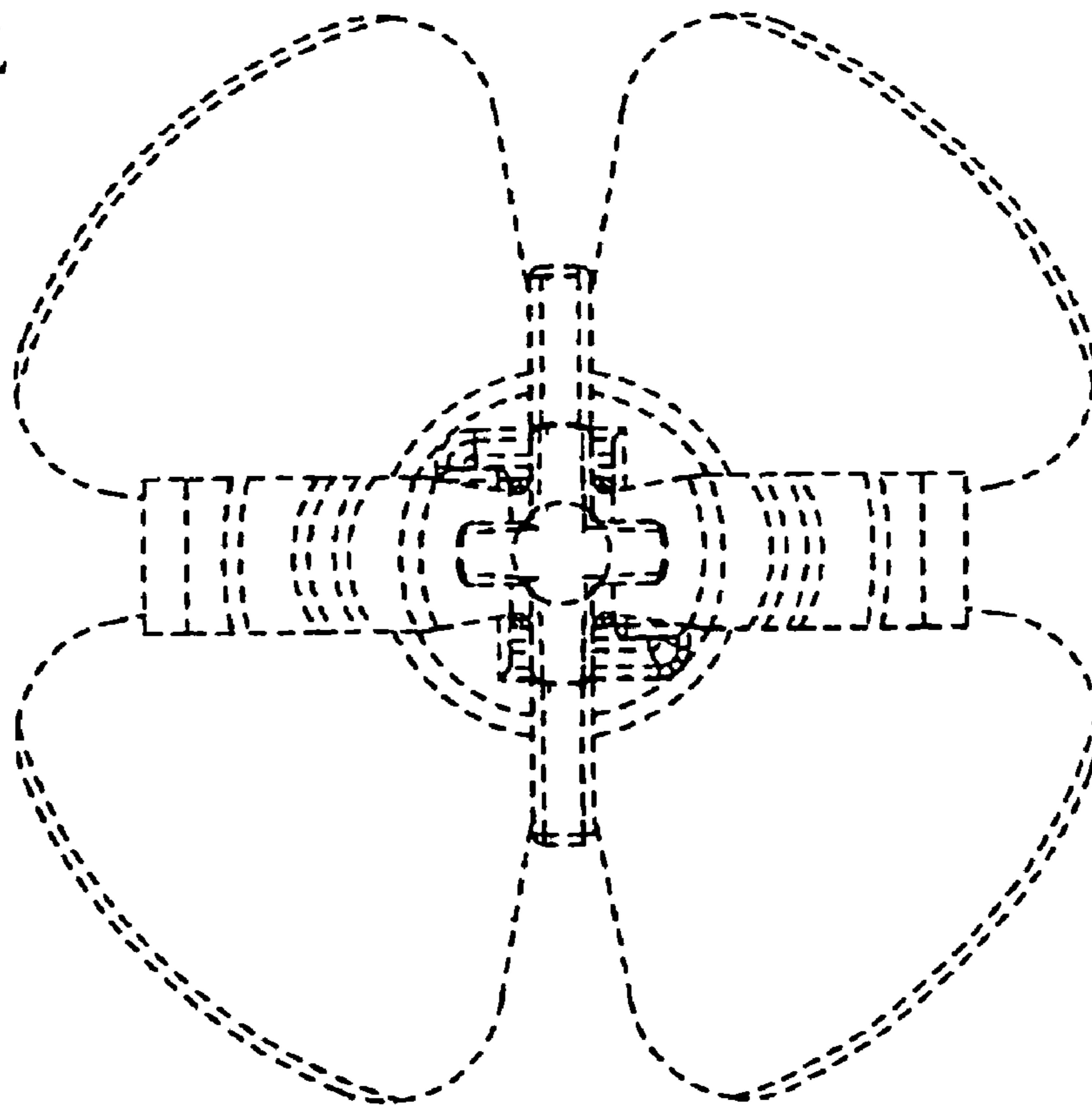

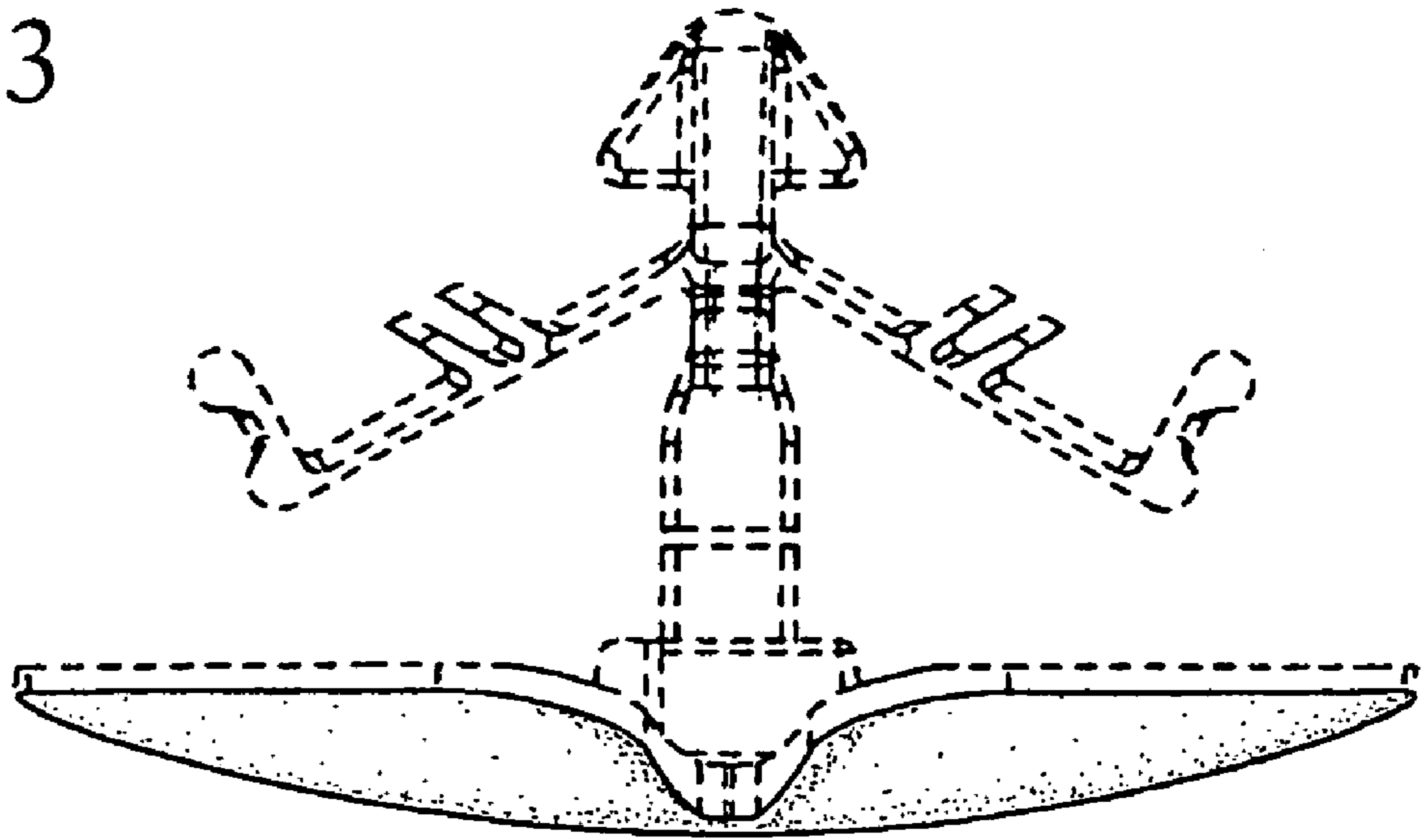

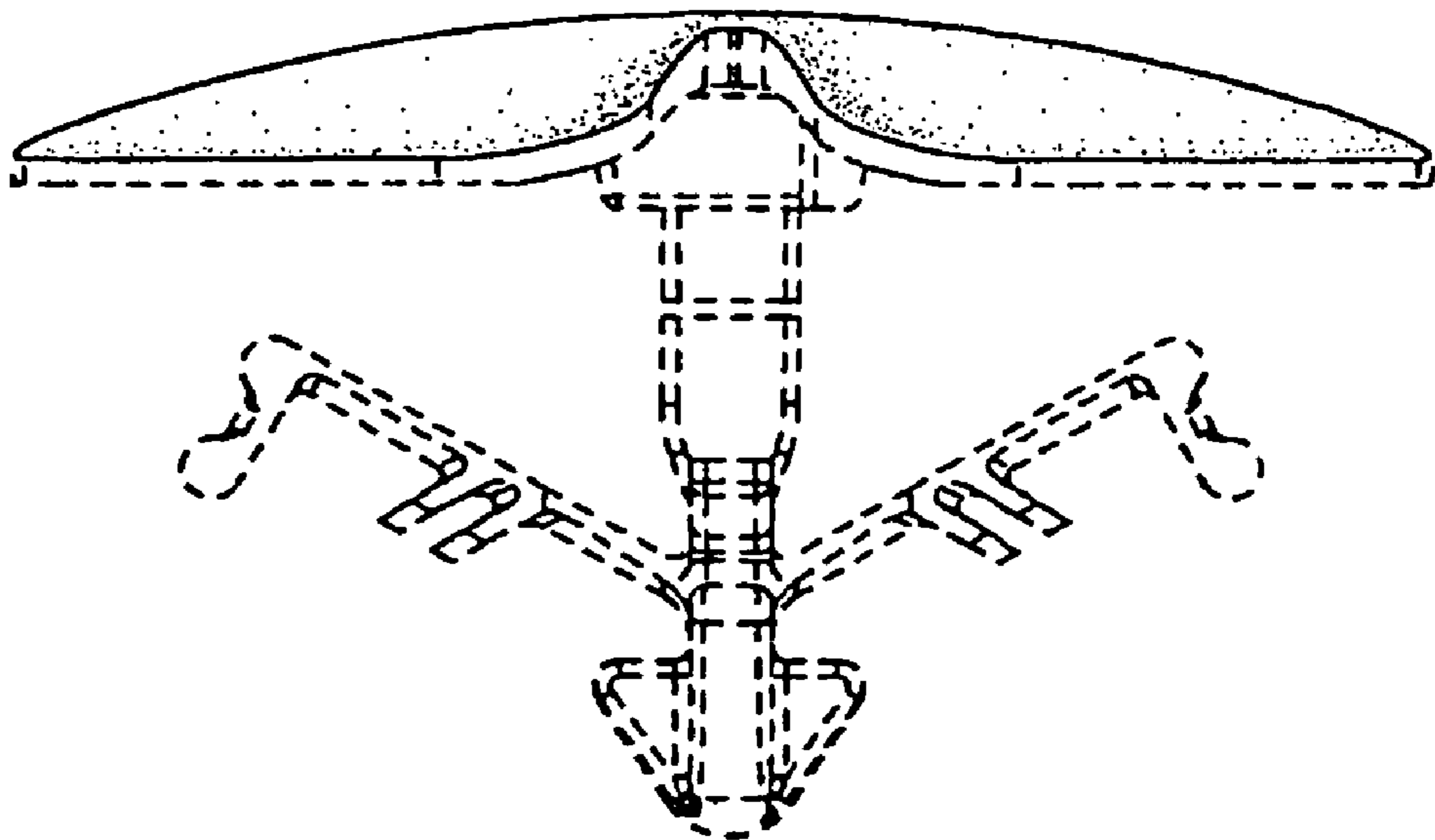

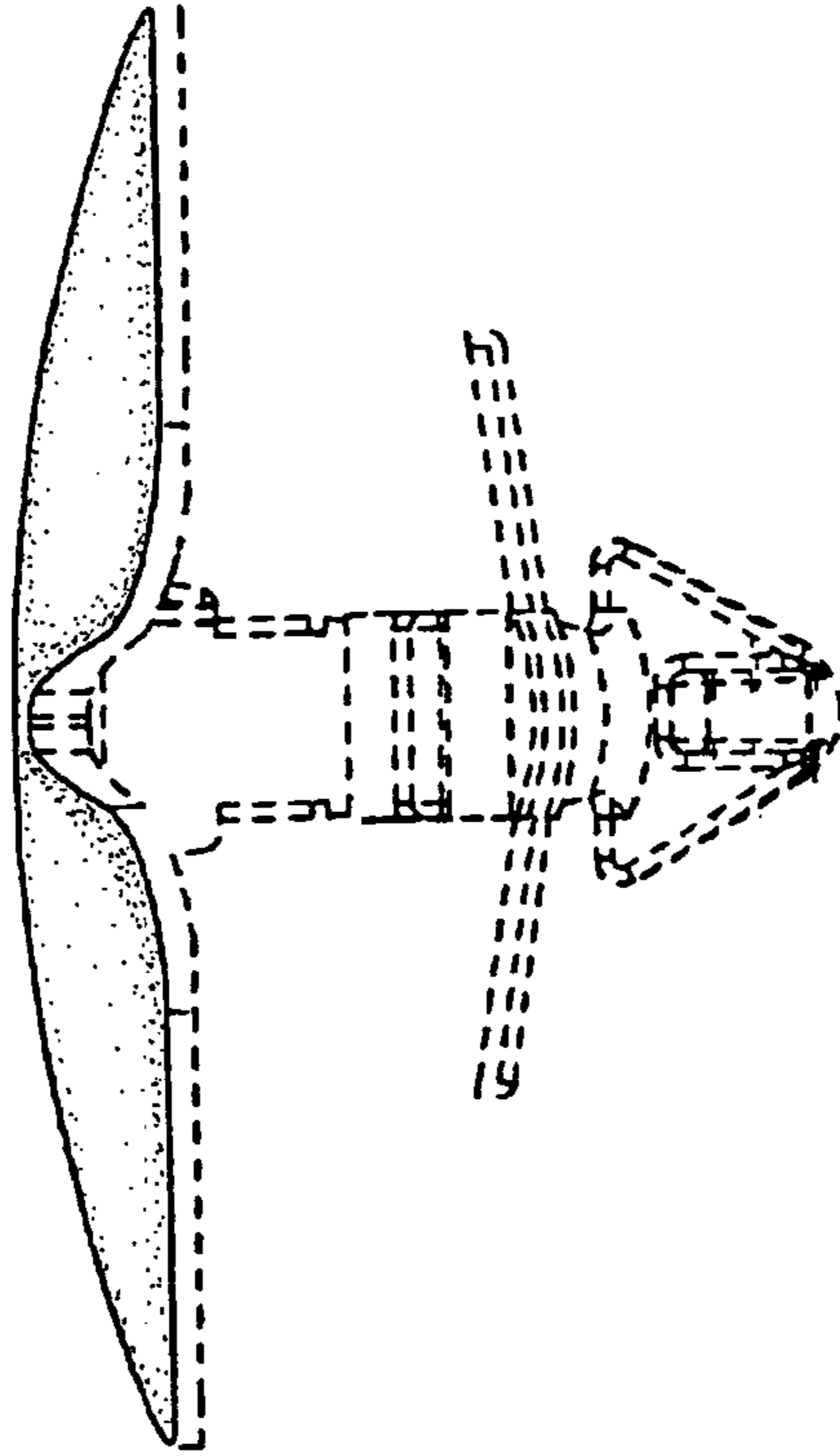
