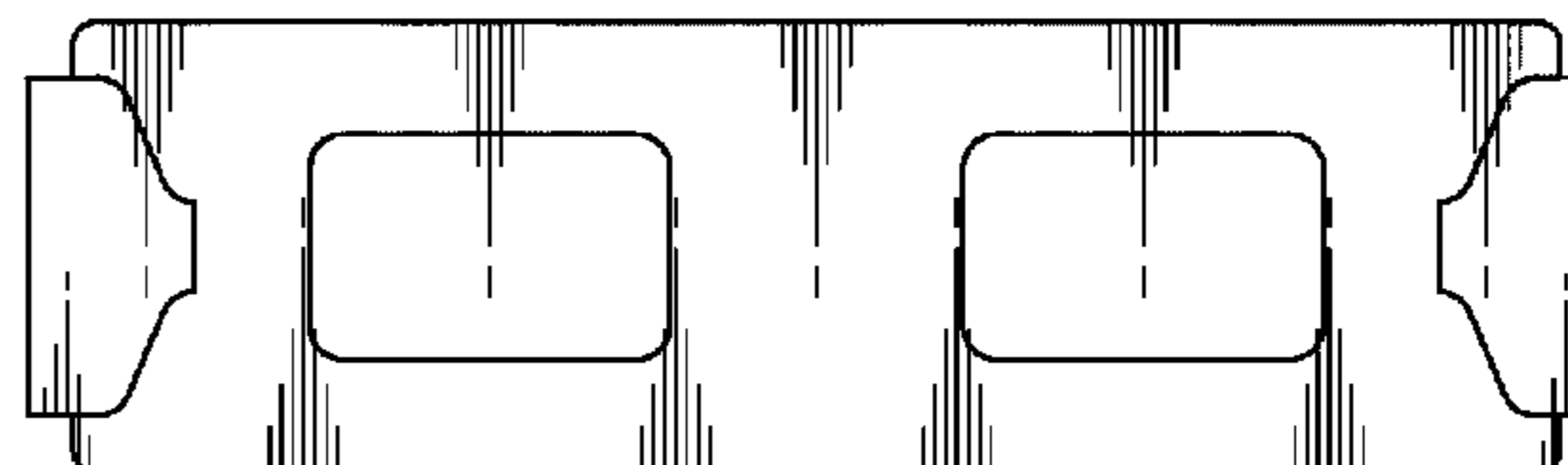
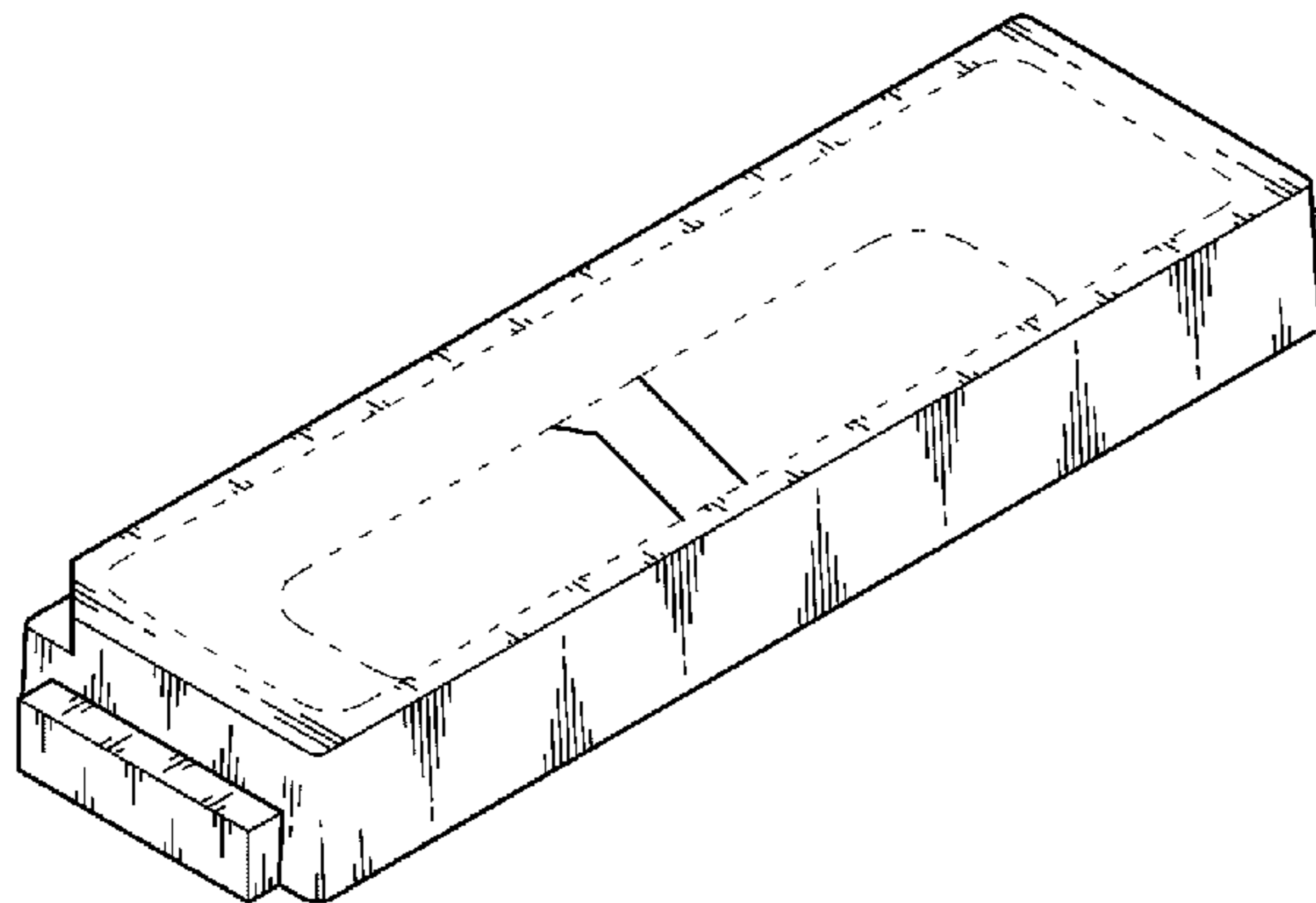
The ornamental design for a “packing structure of light-emitting diode,” as shown and described.

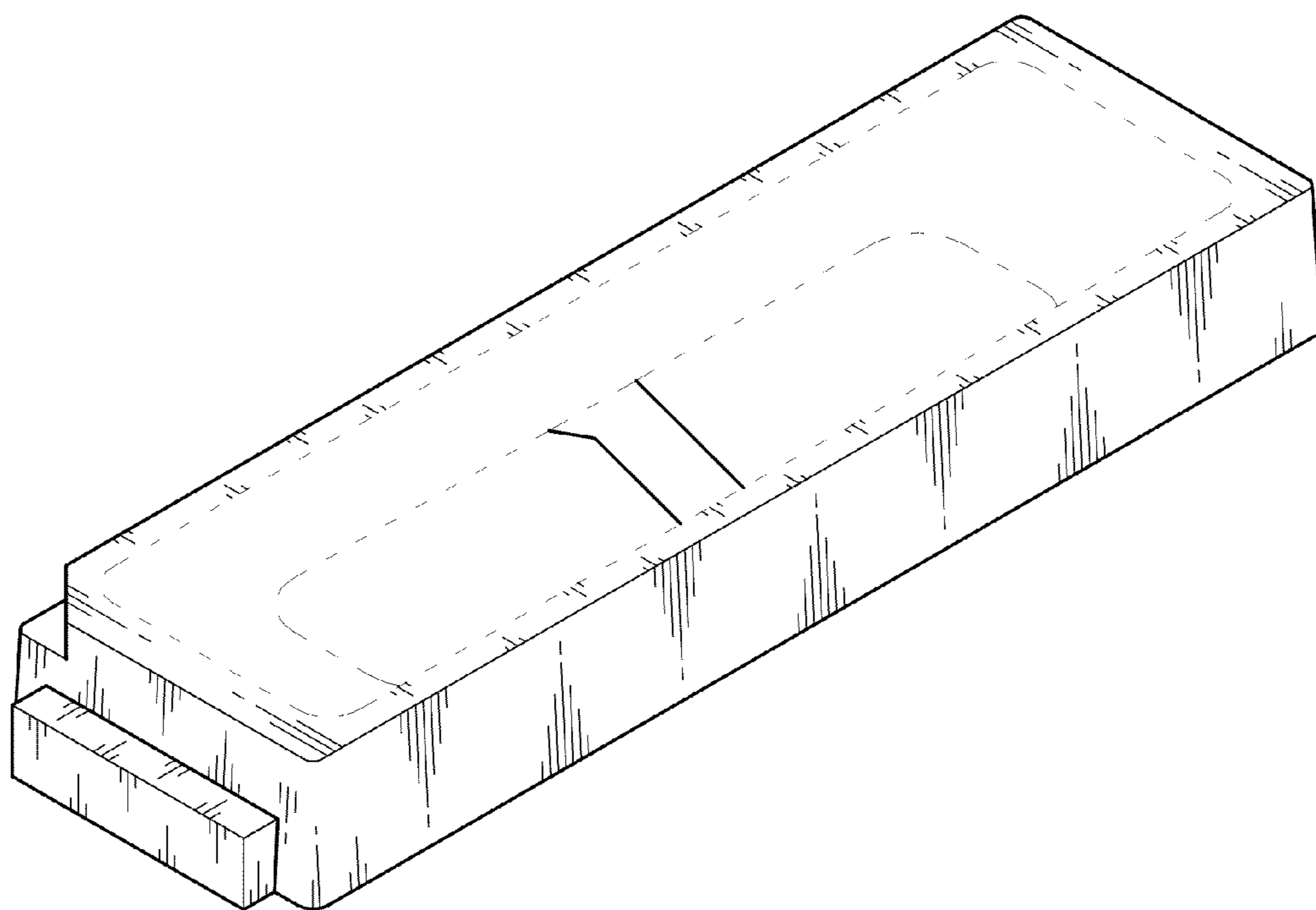

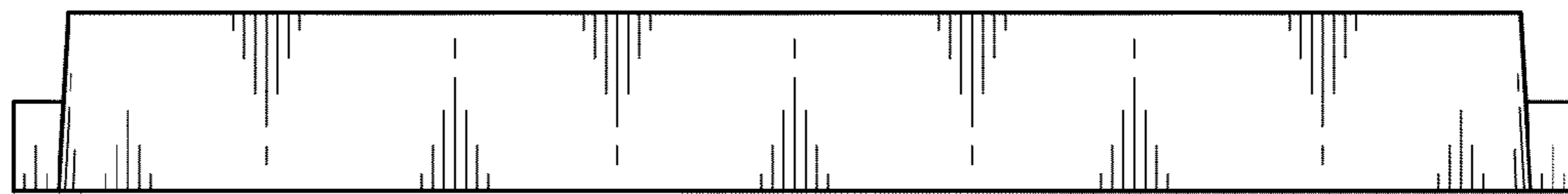

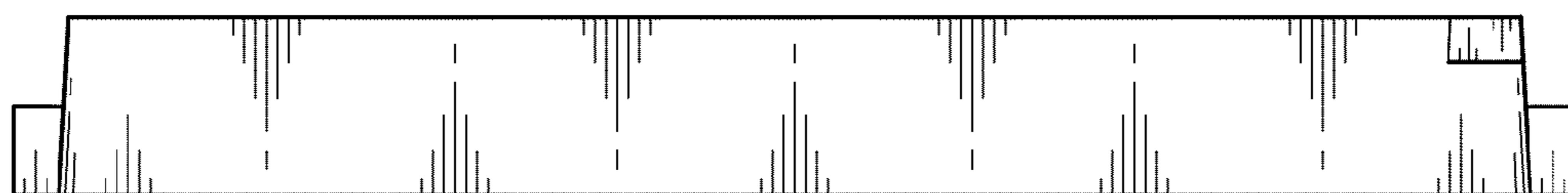

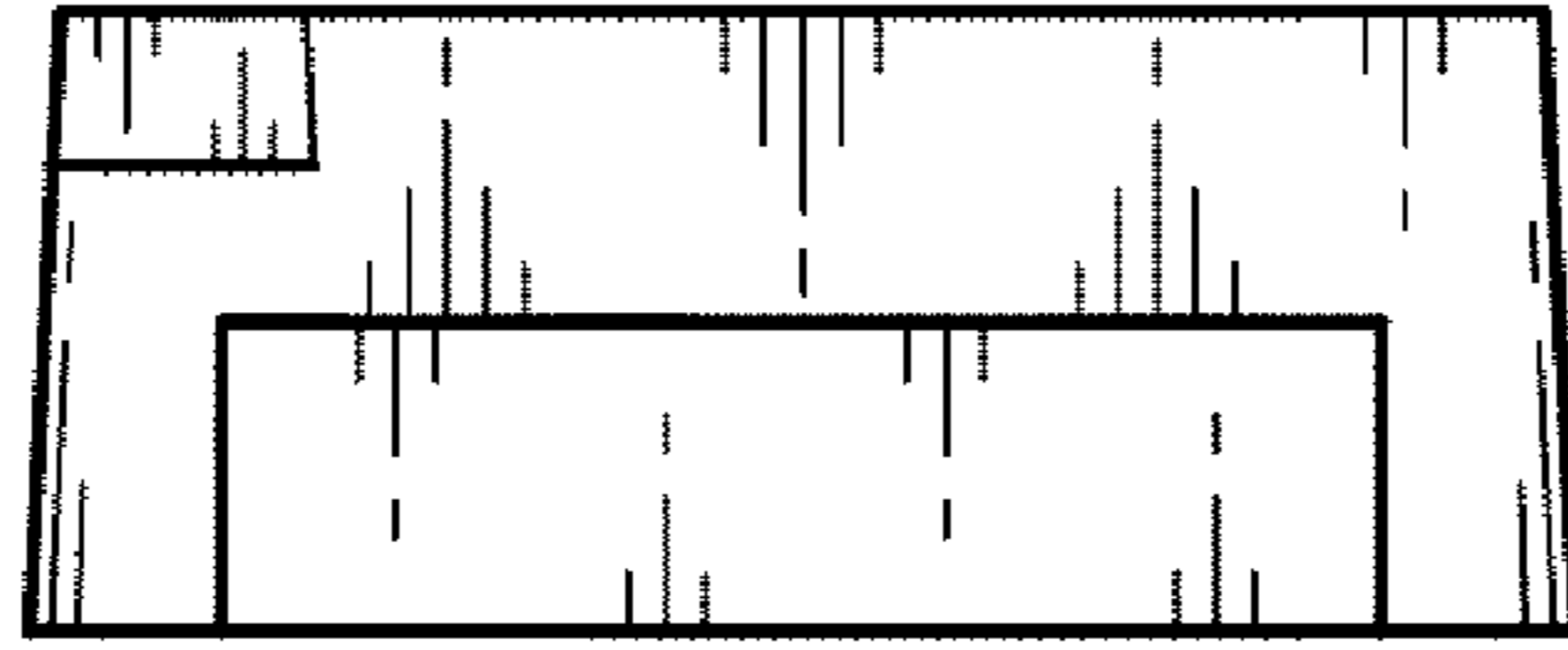

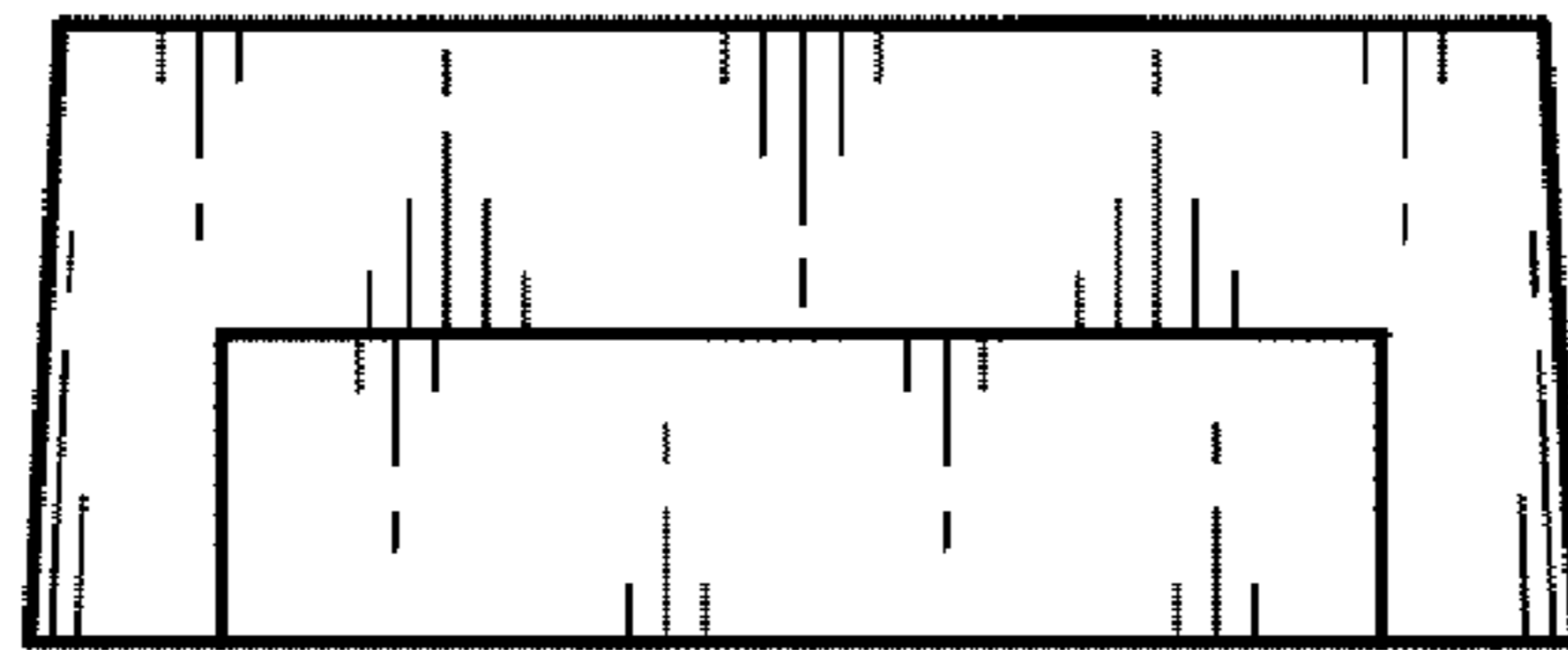

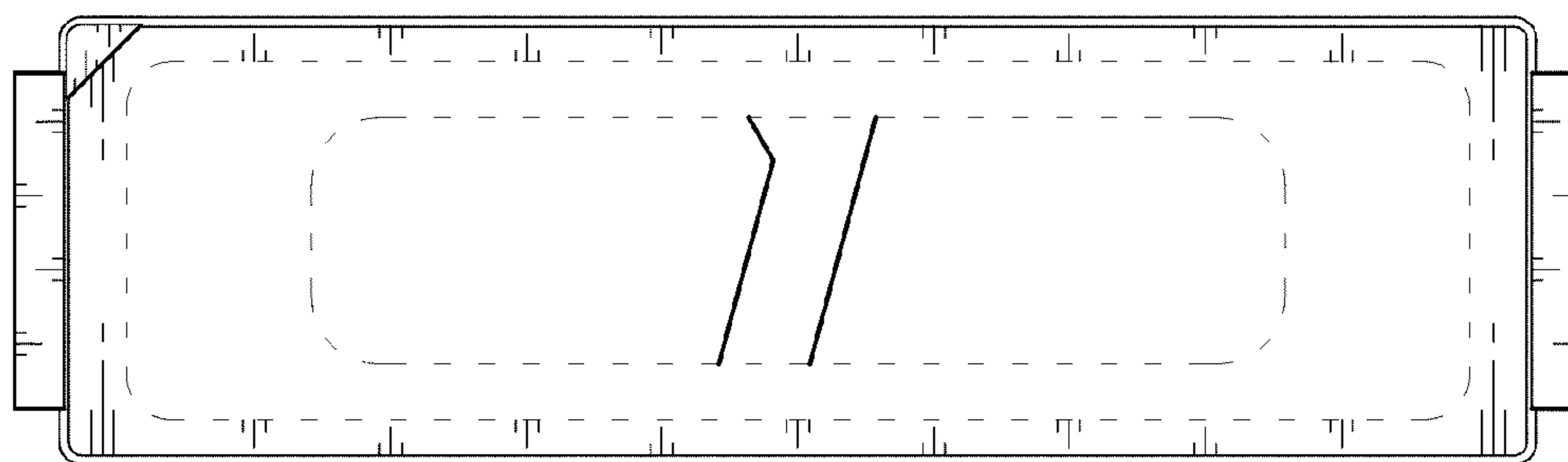

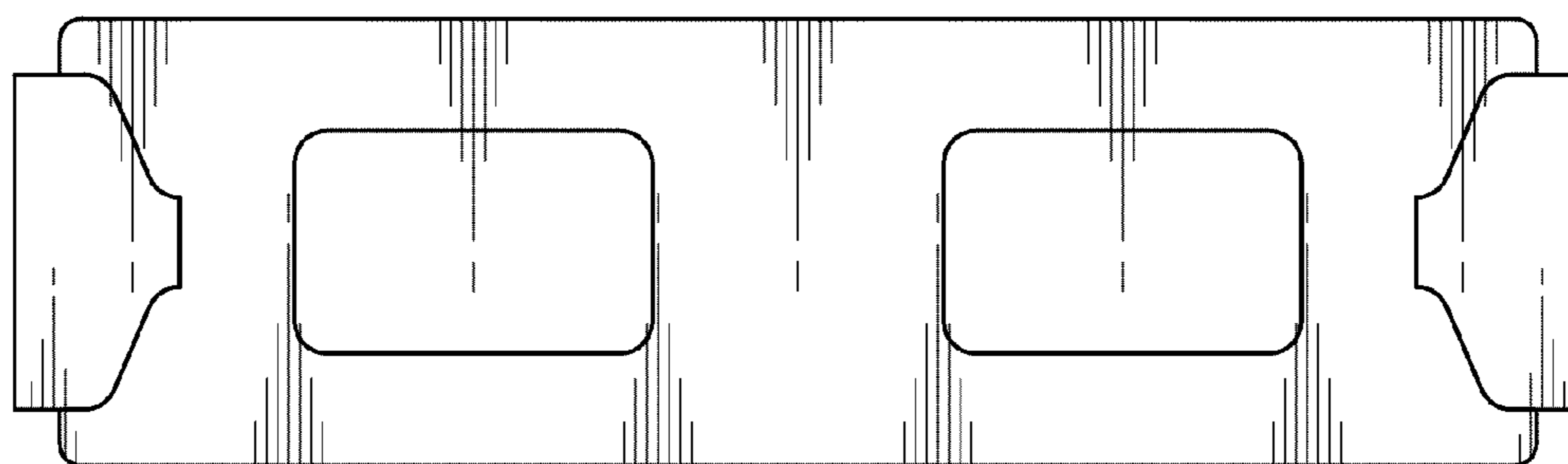
