**DESCRIPTION**

FIG. 11 is a side view of the design of FIG. 8;

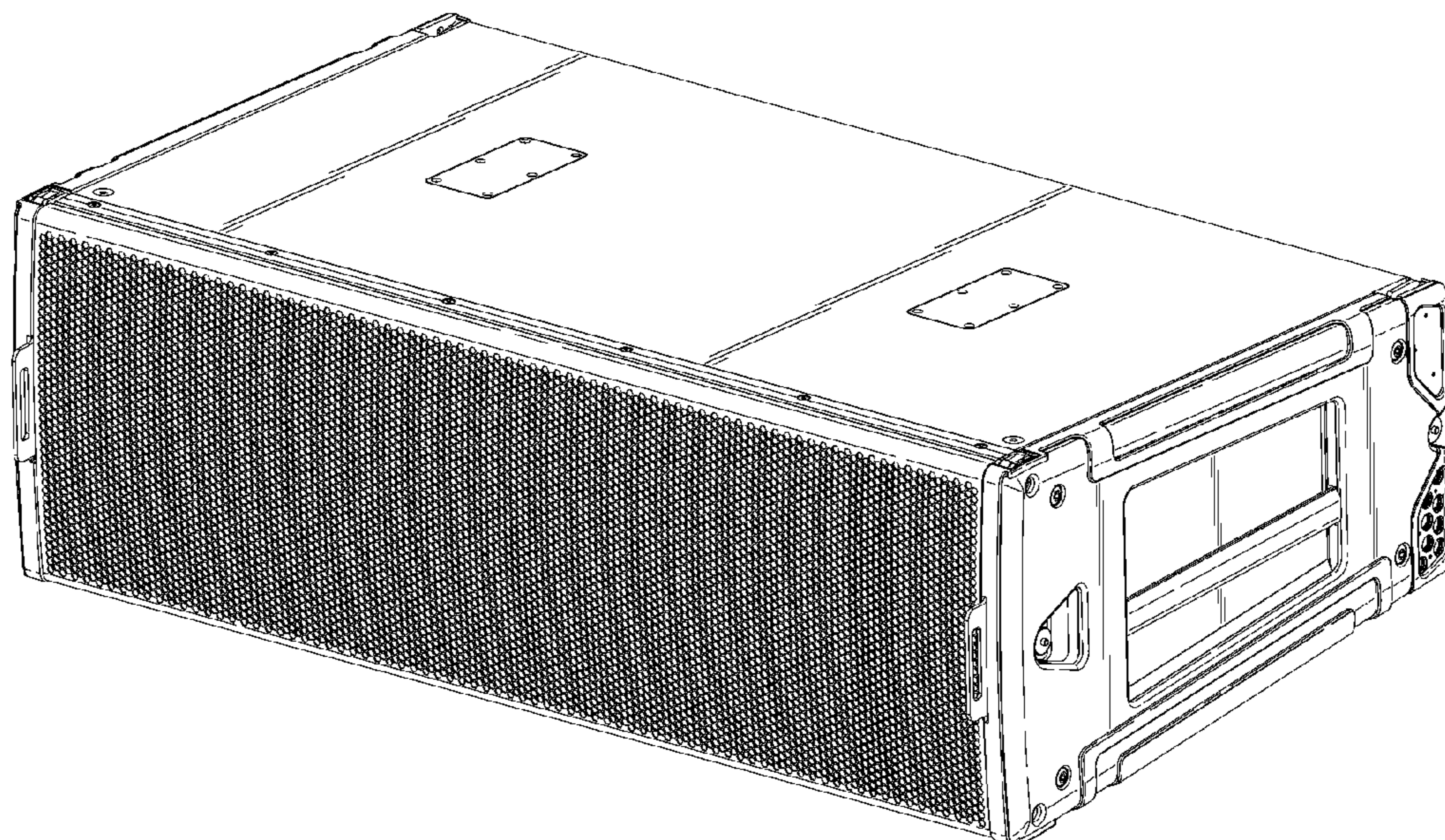
FIG. 12 is an opposite side view of the design of FIG. 8;

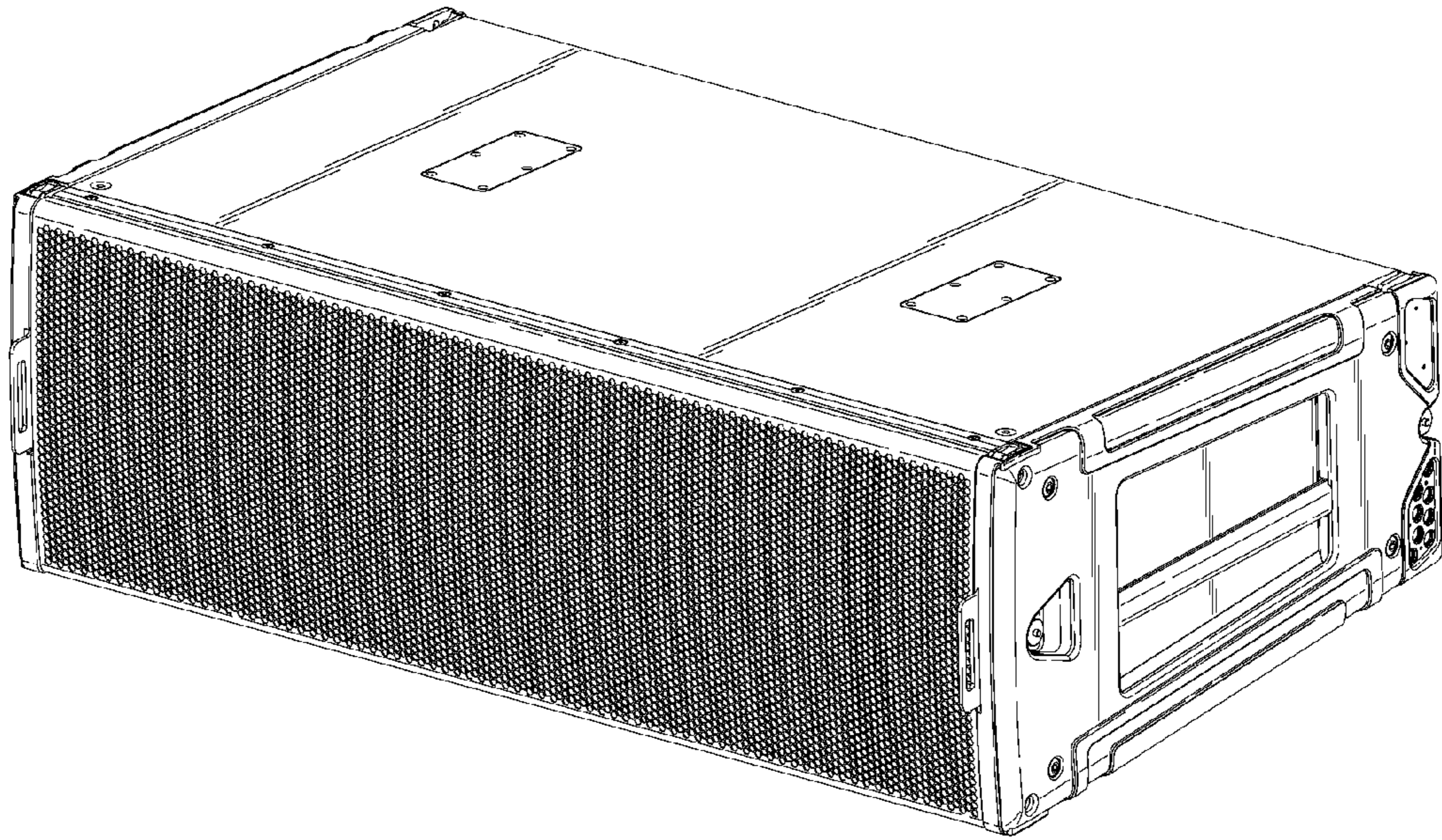

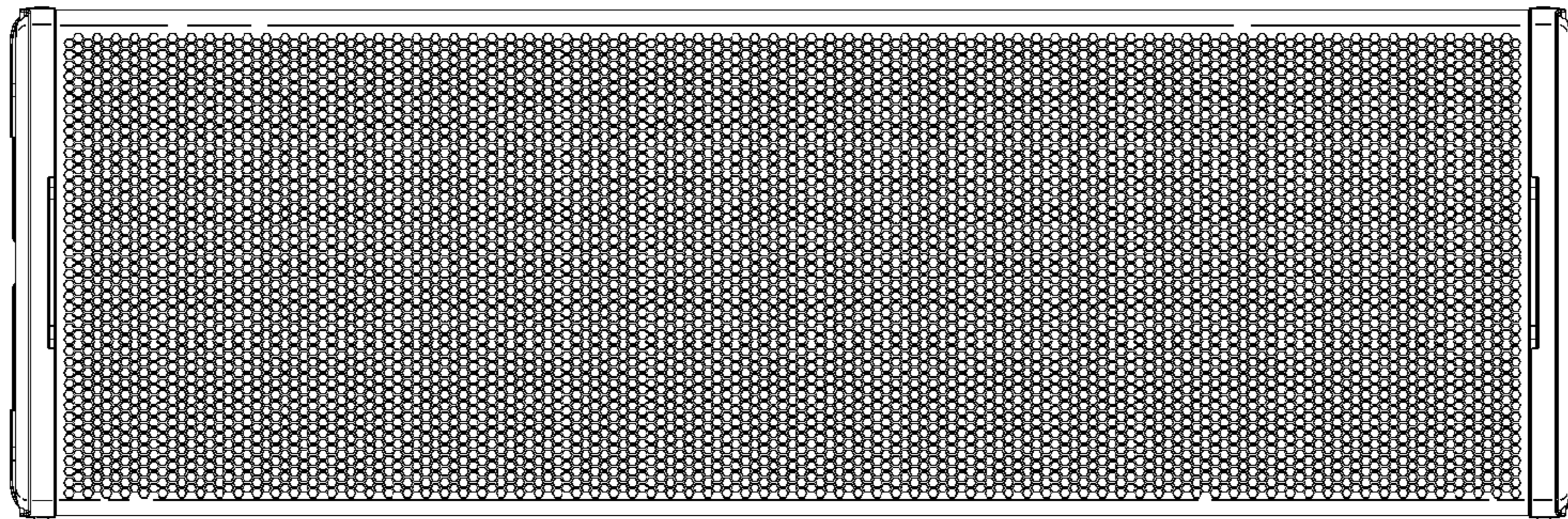

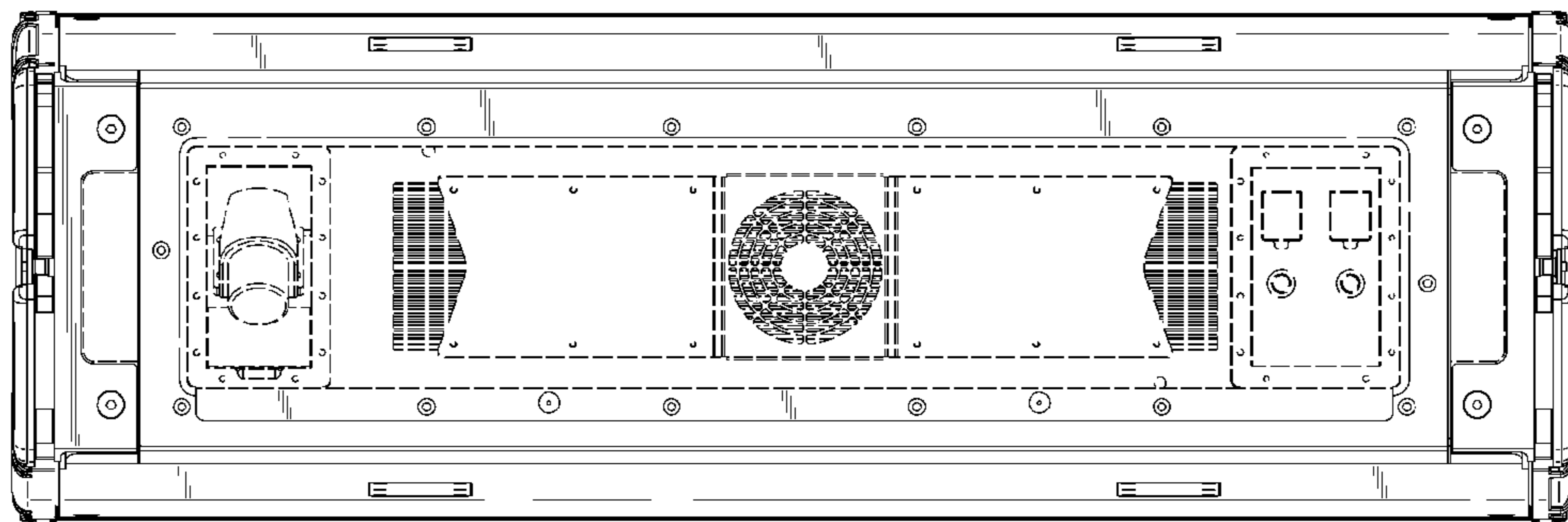

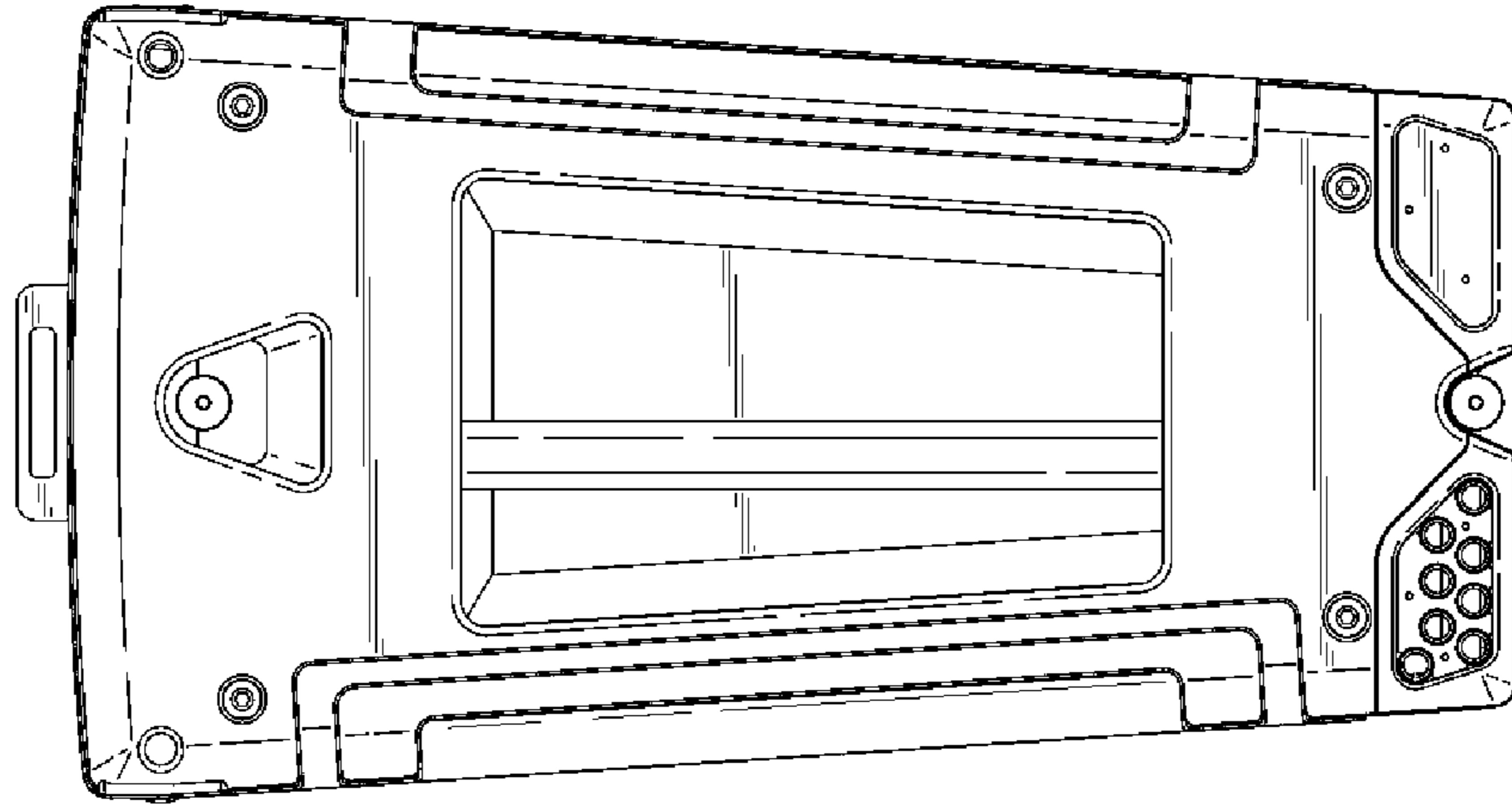

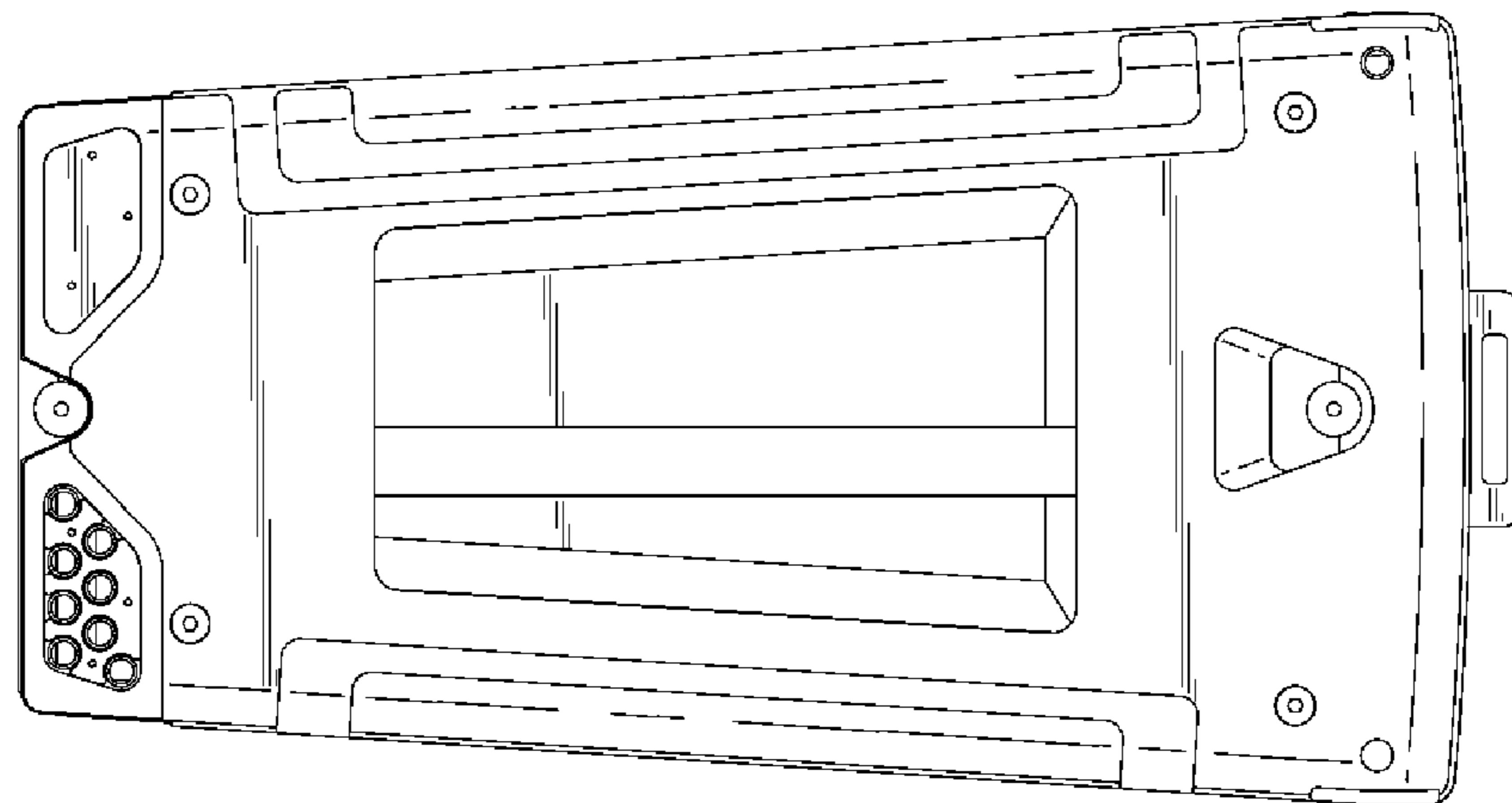

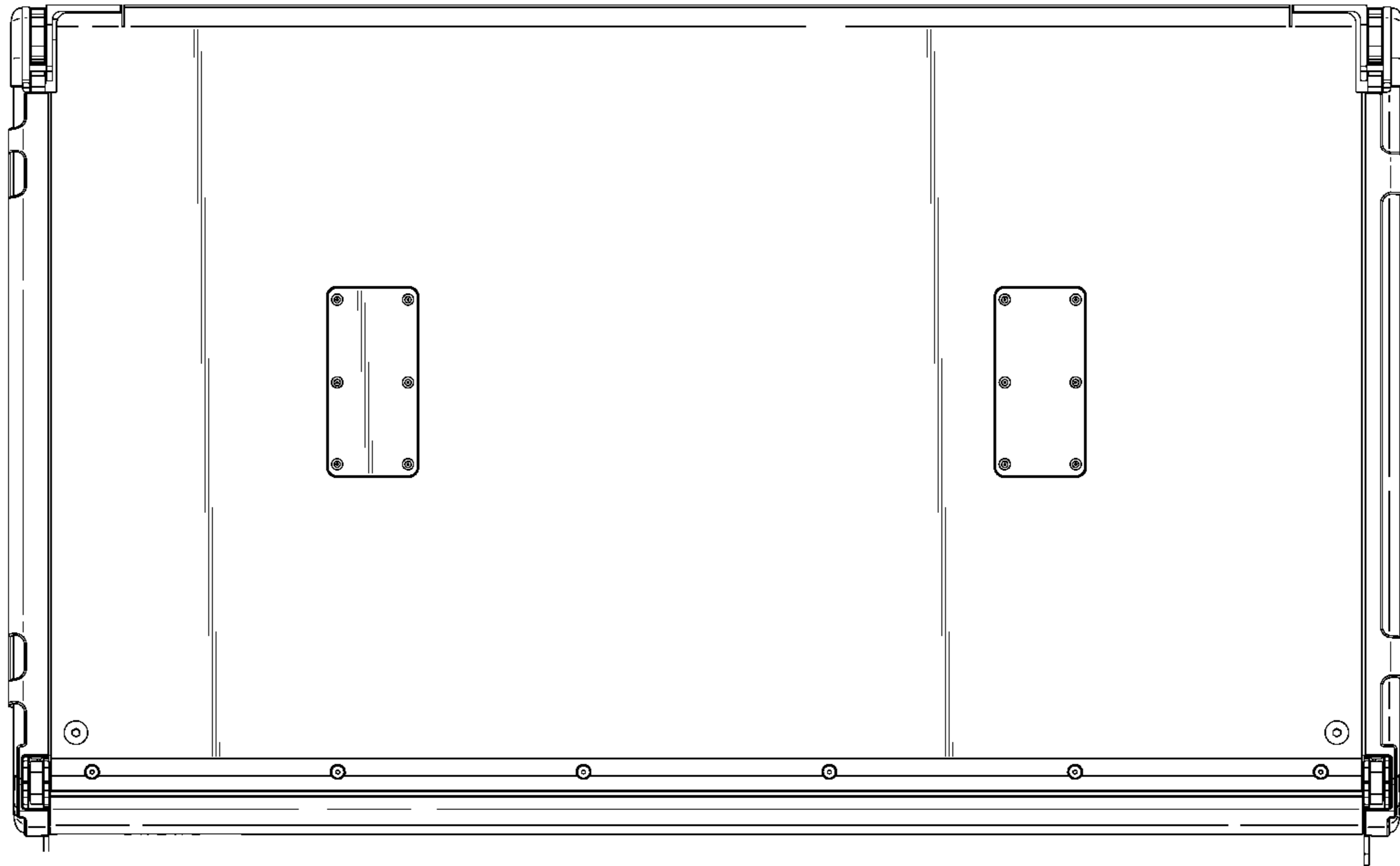

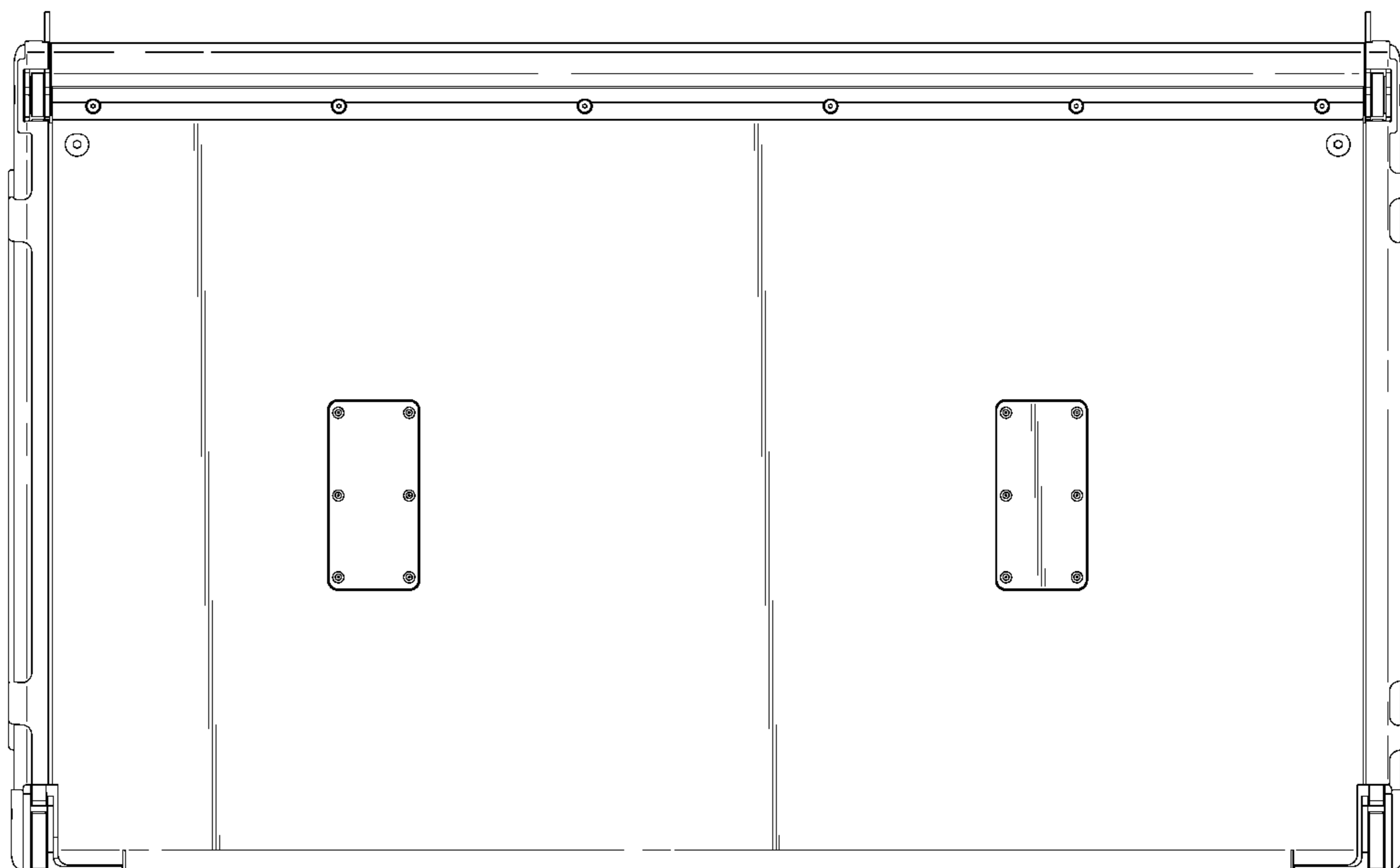

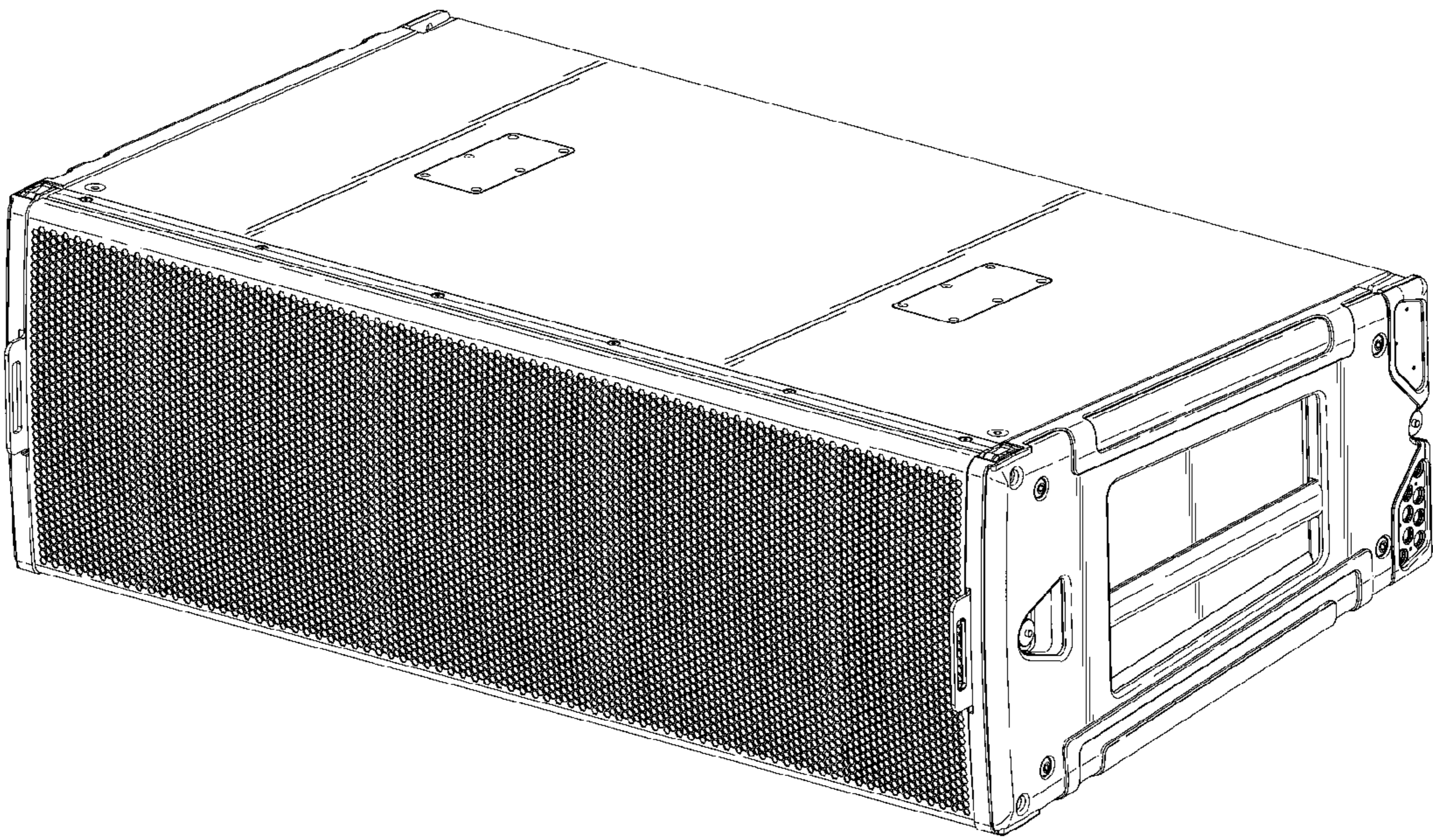

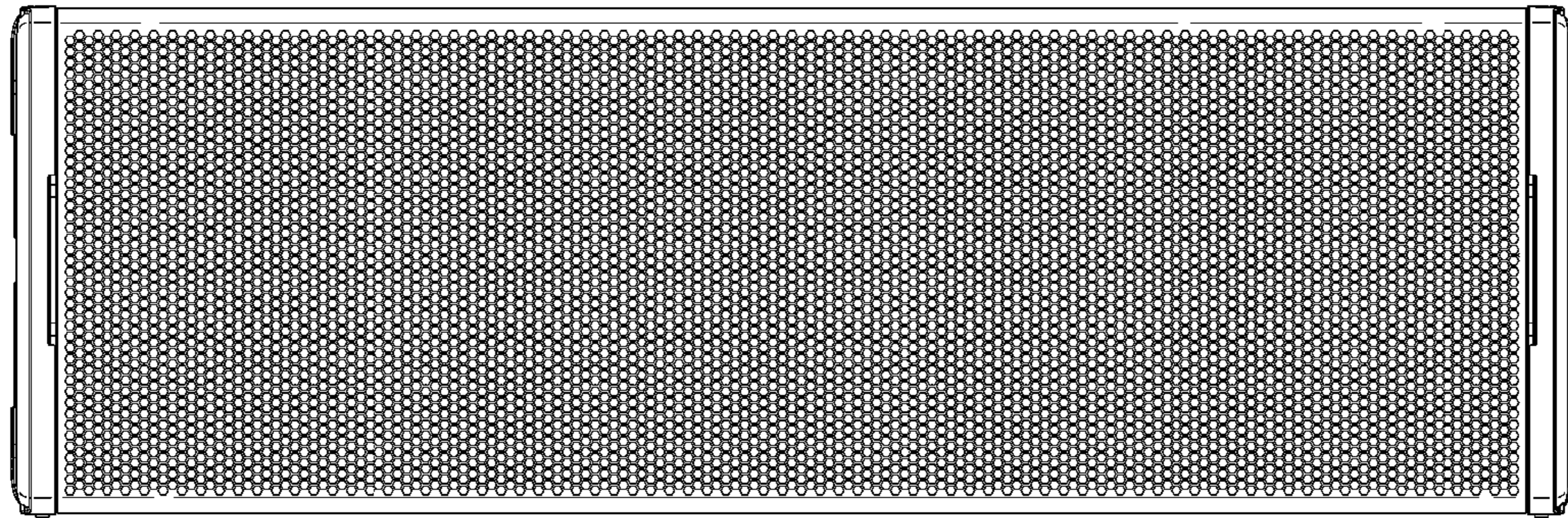

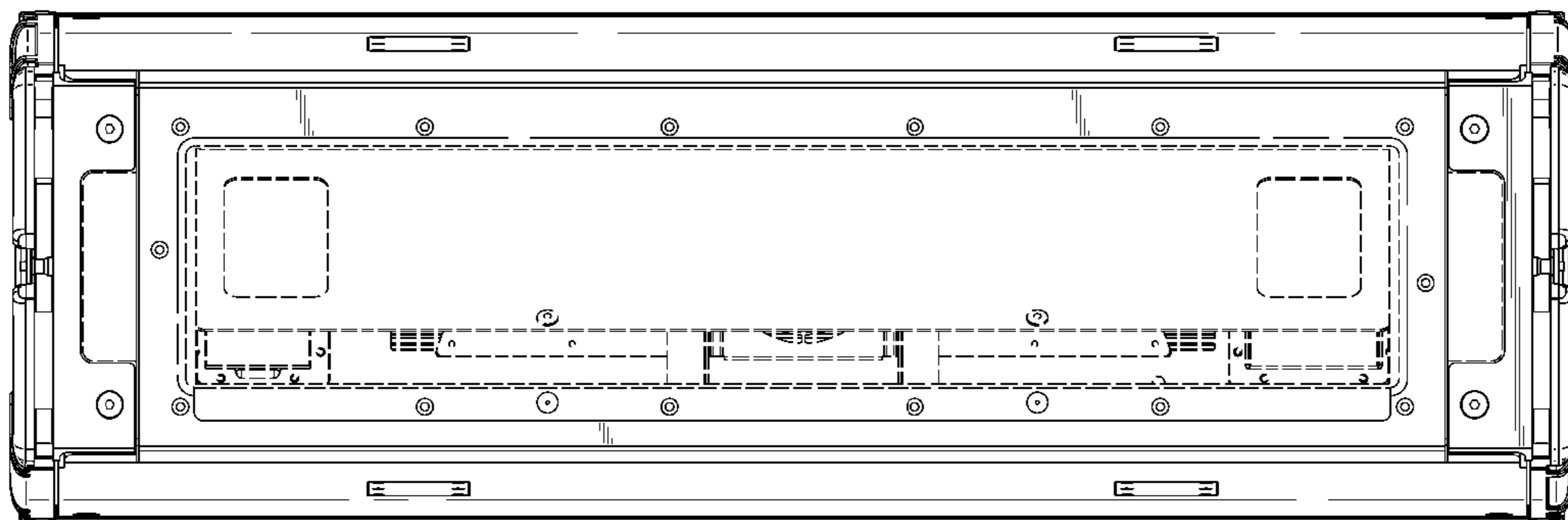

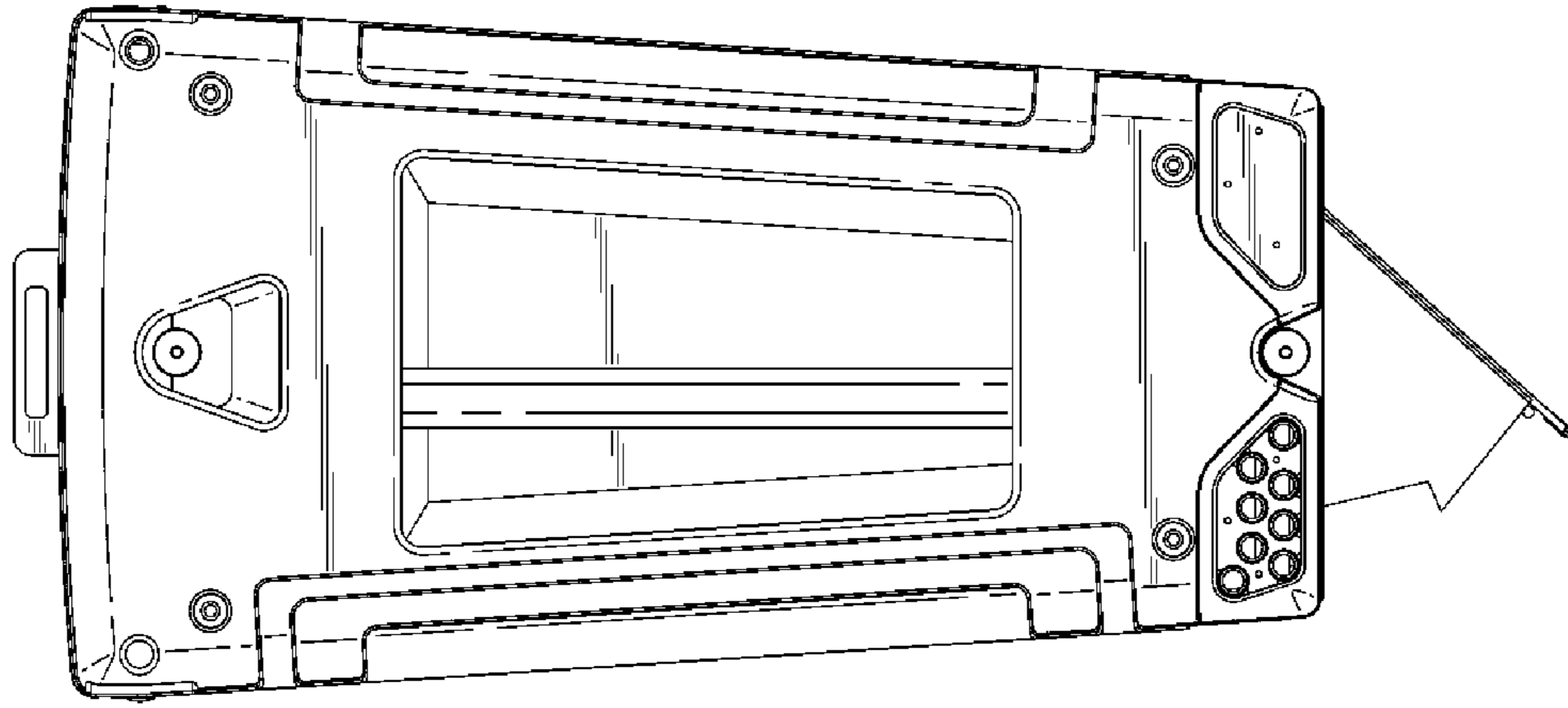

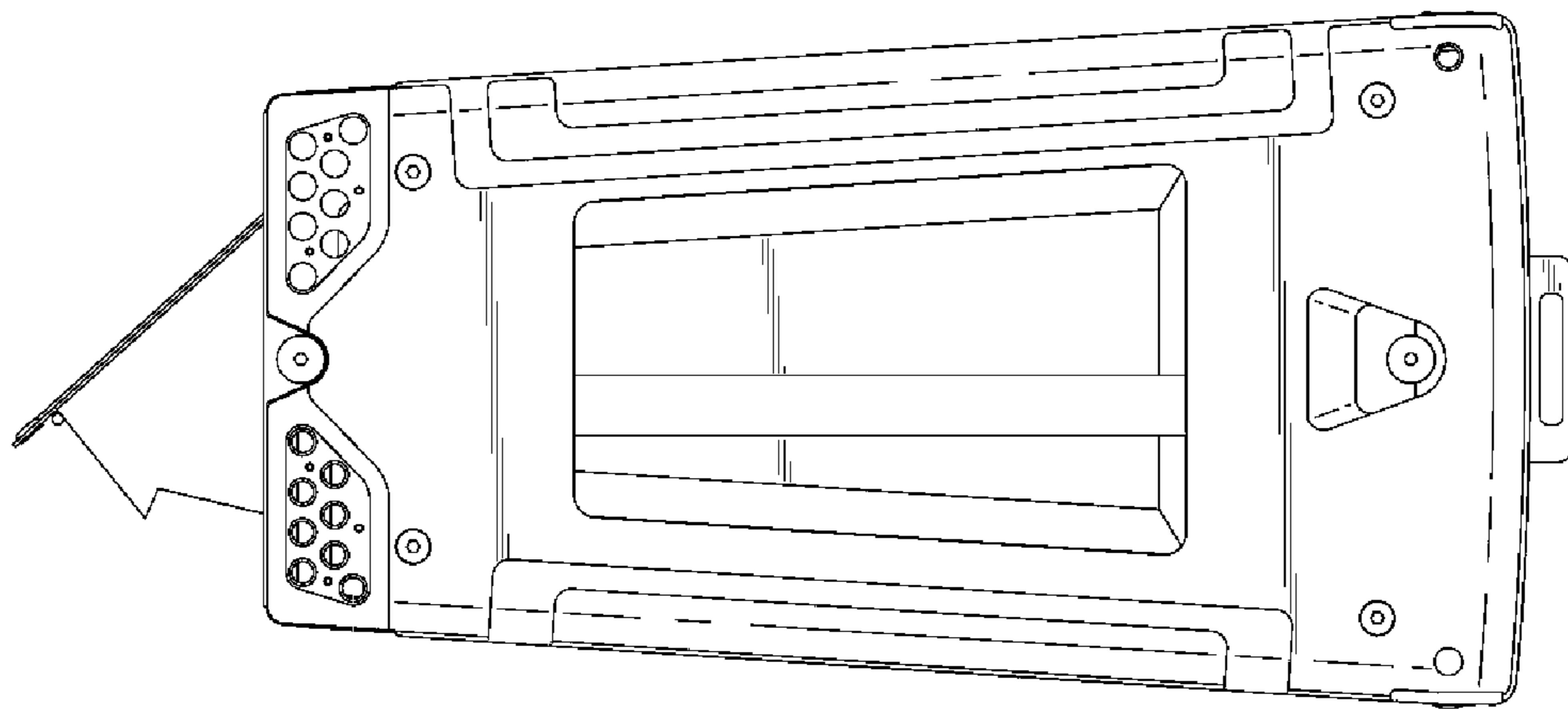

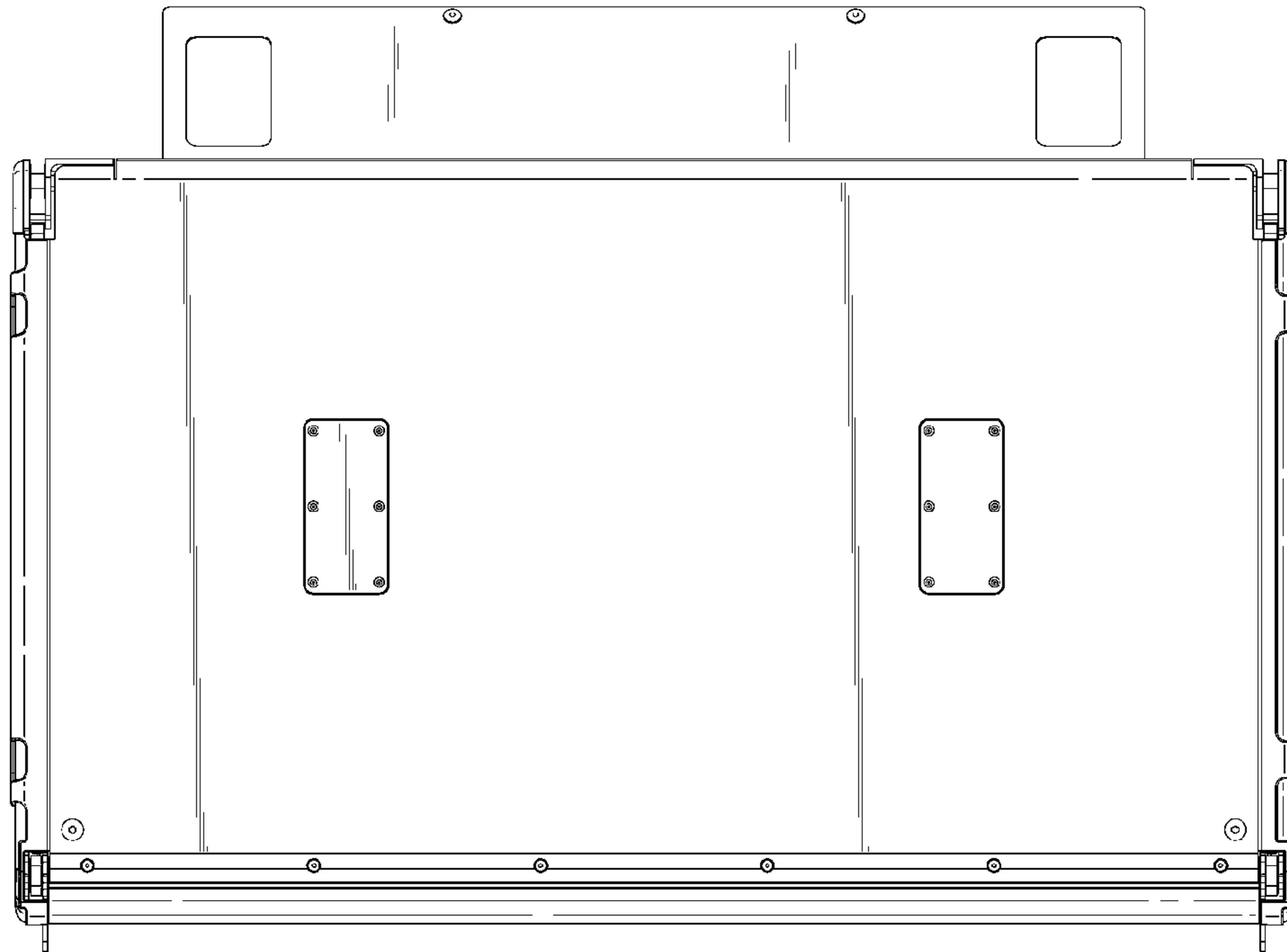

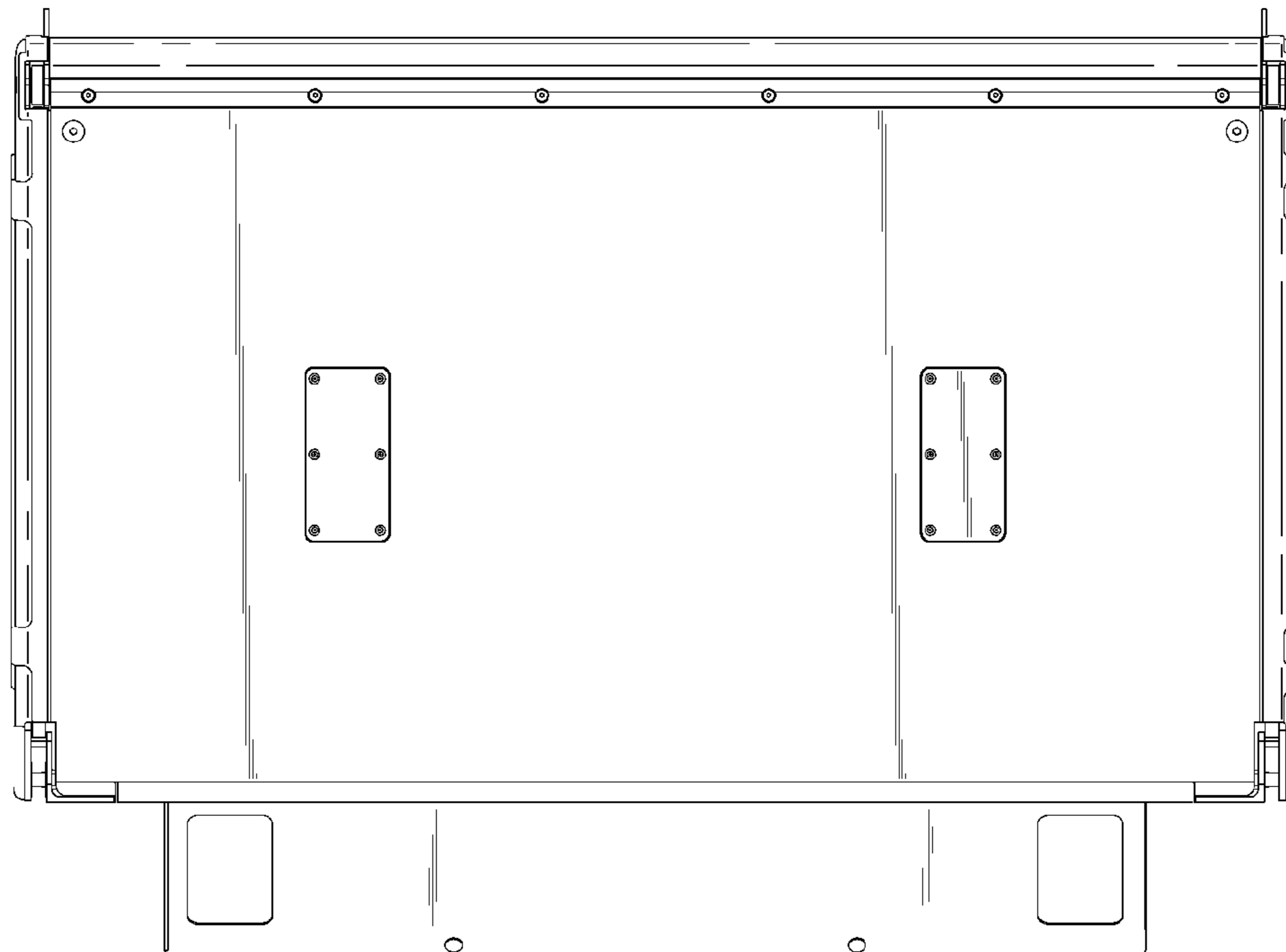
