**DESCRIPTION**

FIG. 9 is a back view of the right side communications earbud;

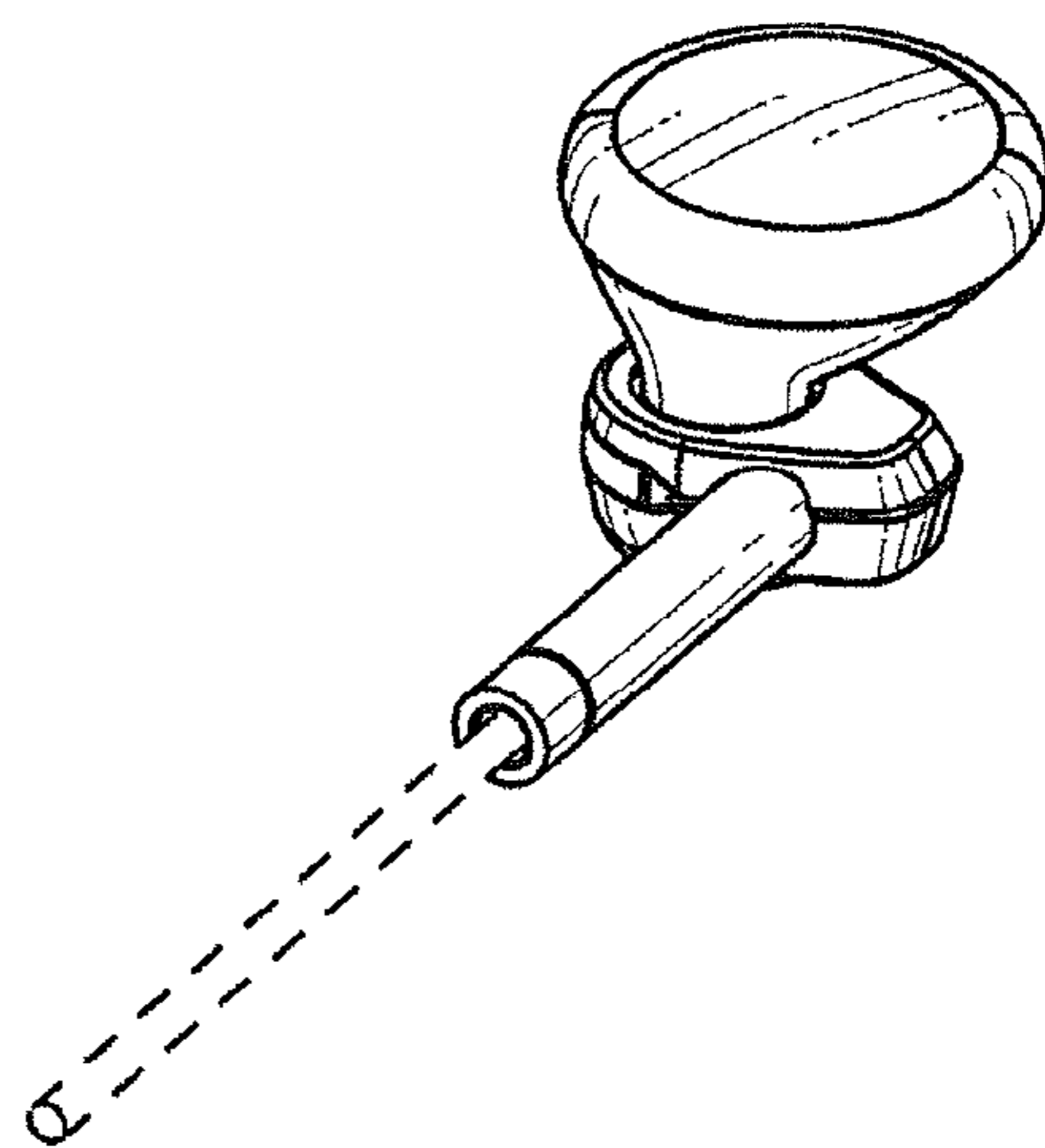
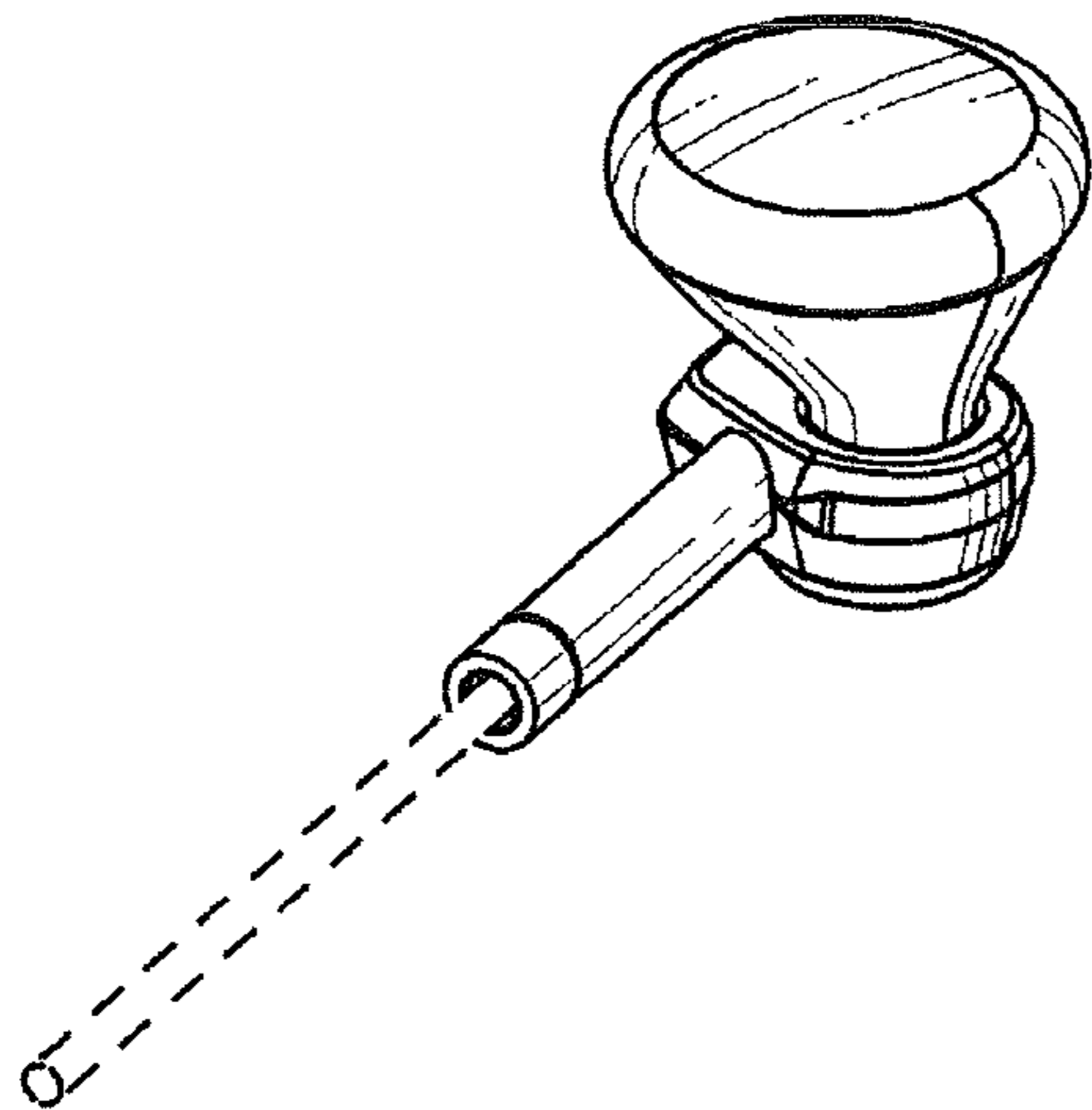
FIG. 10 is back view of the left side communications earbud;

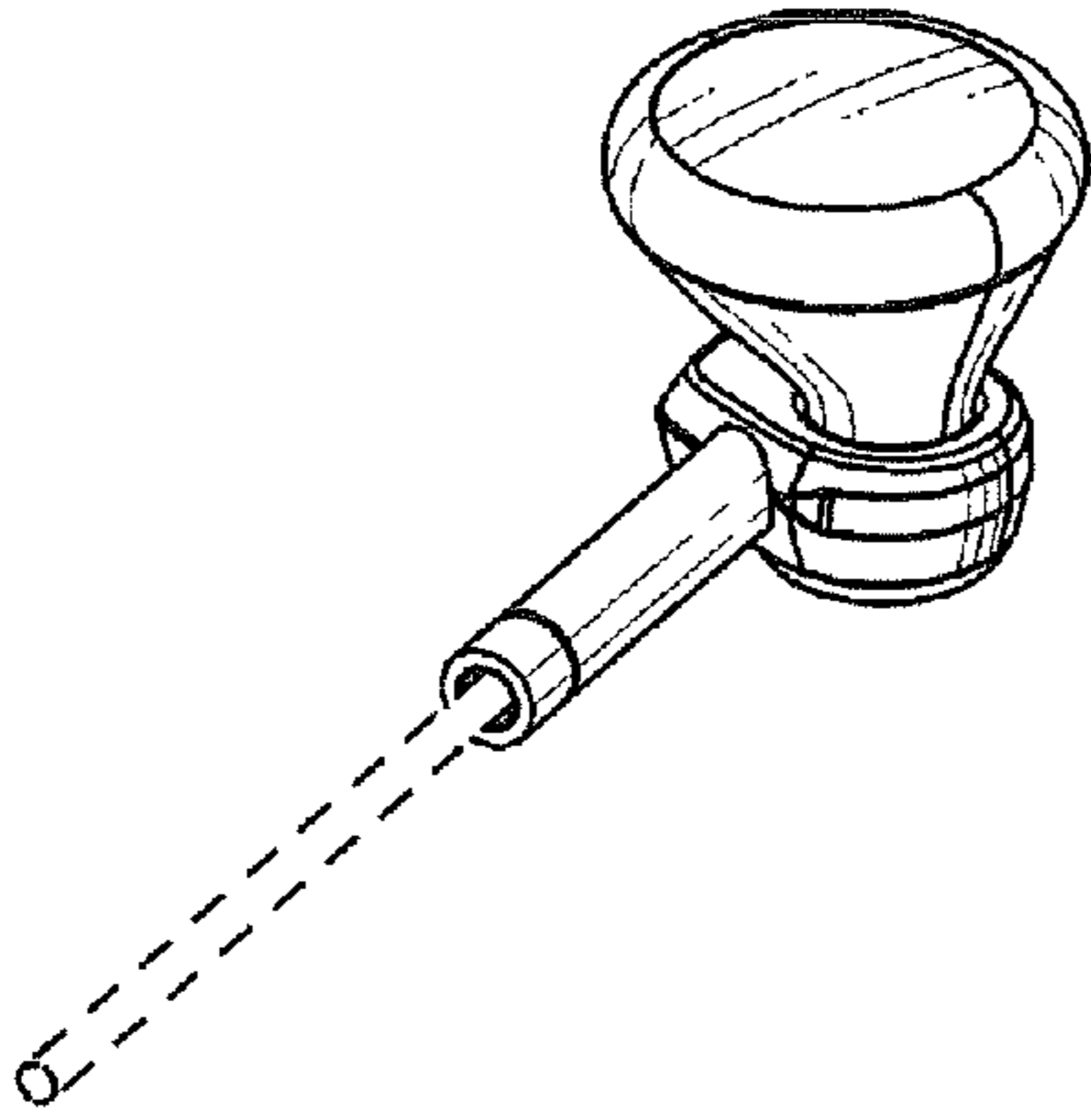
FIG. 11 is a left side view of the left side communications earbud; and,

FIG. 12 is a right side view of the right side communications earbud.

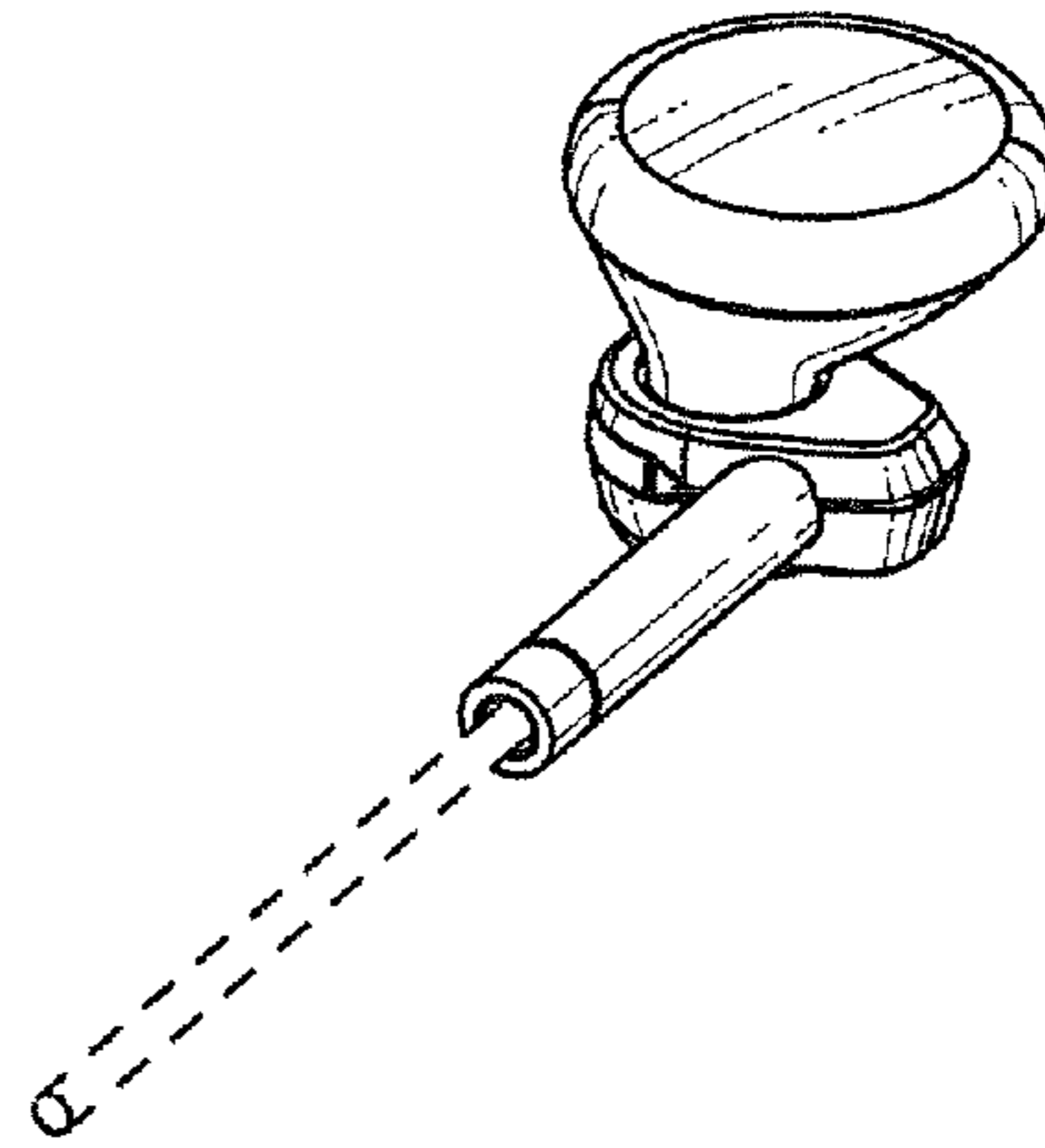

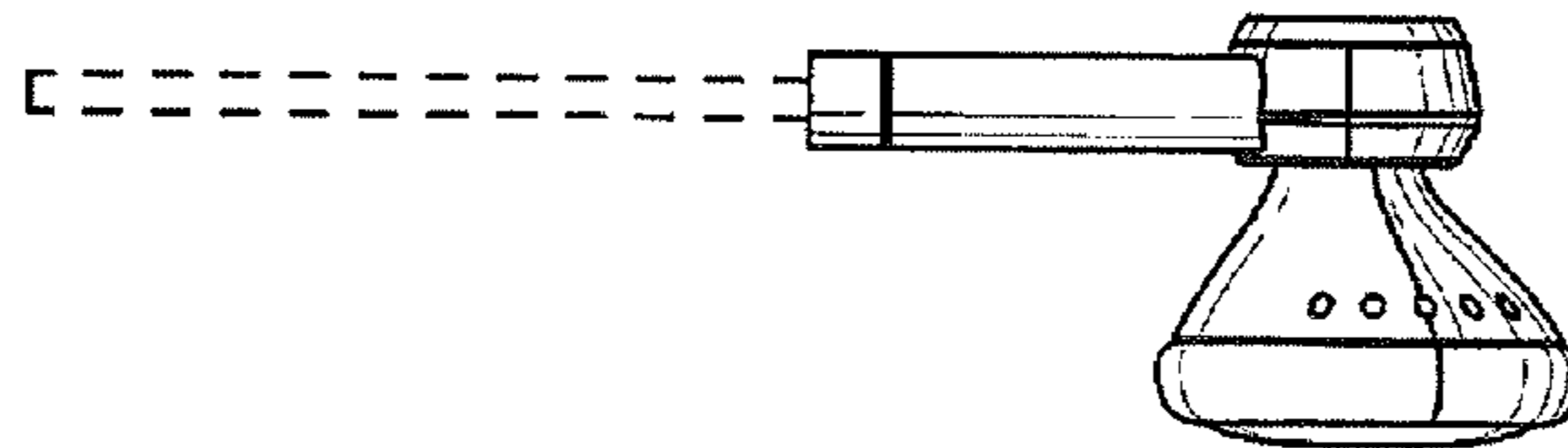

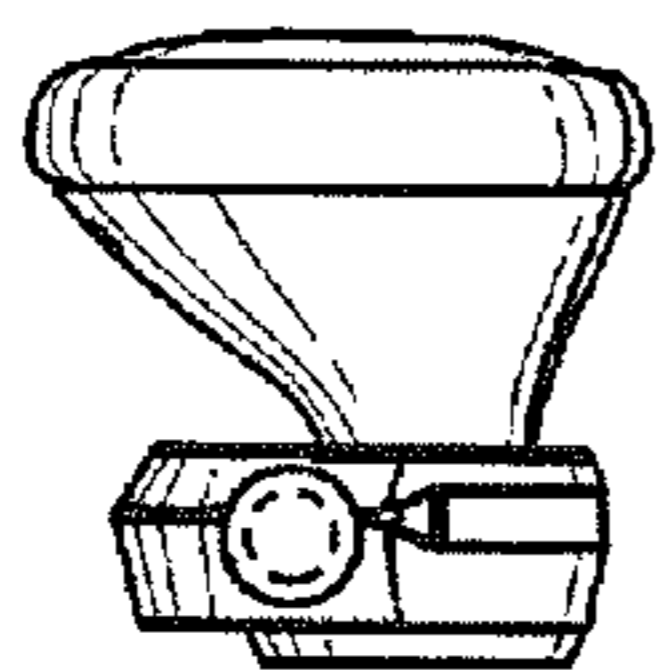

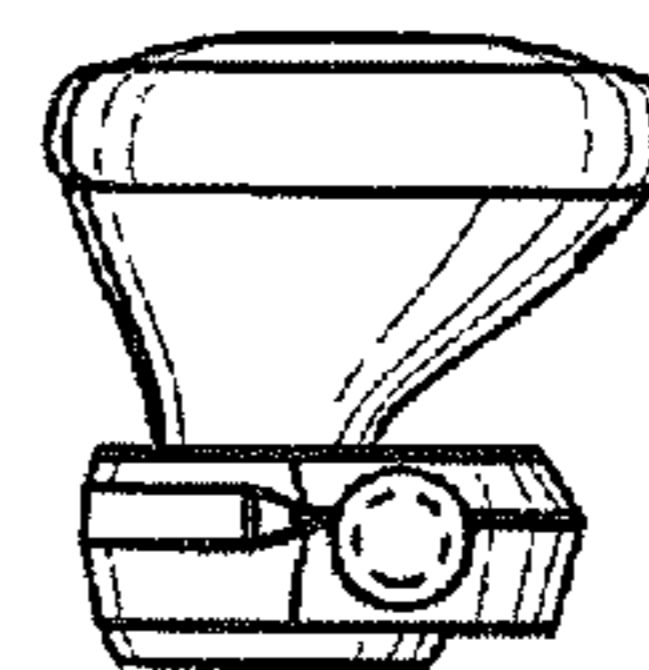

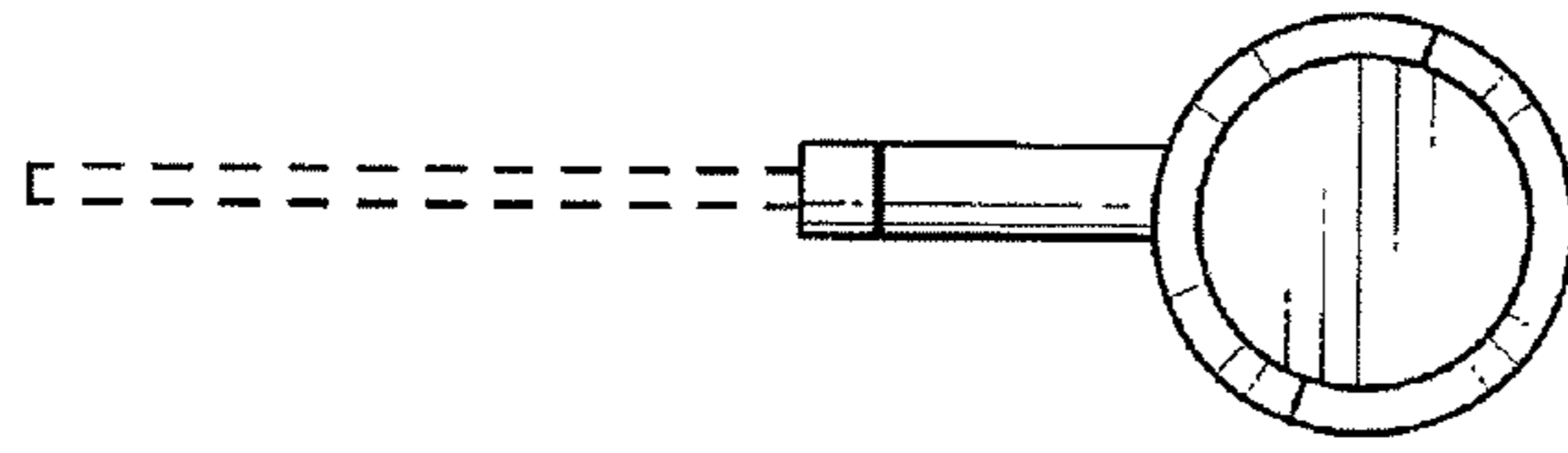

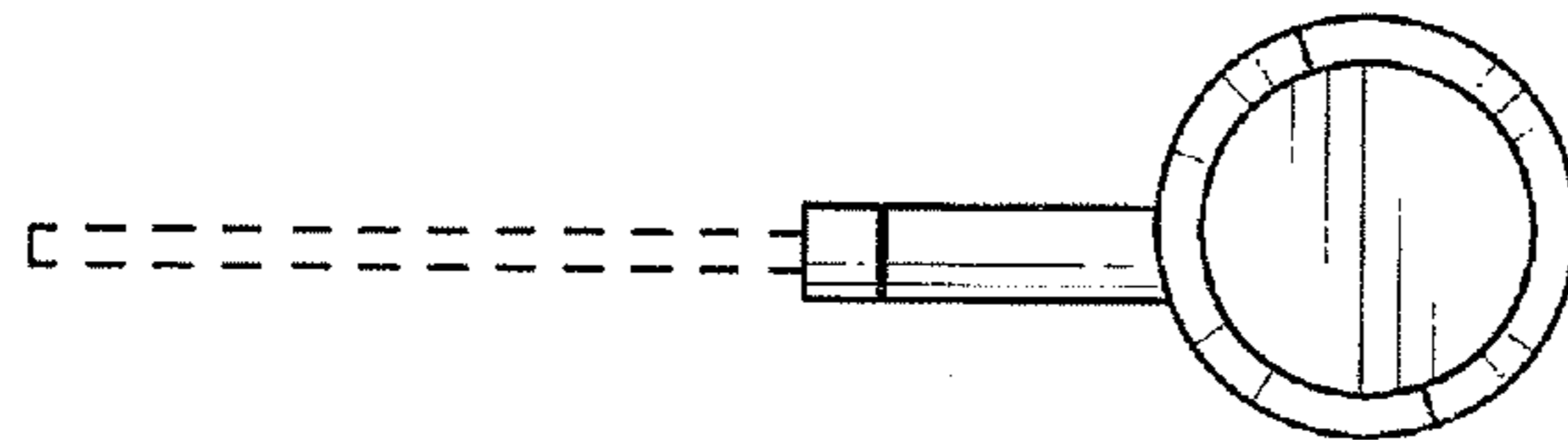

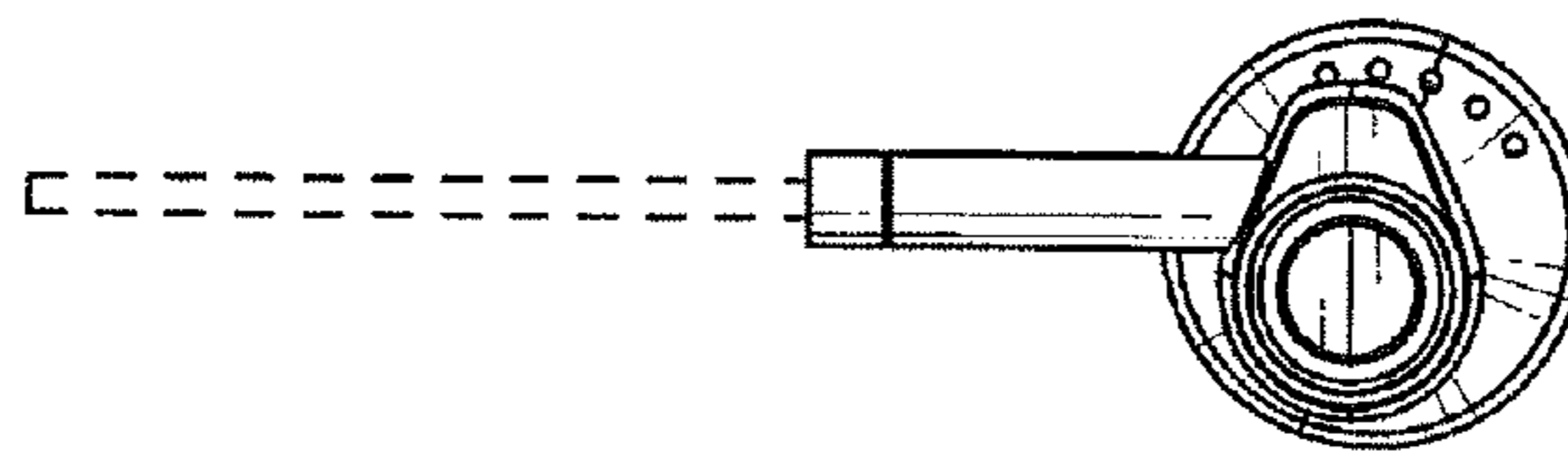

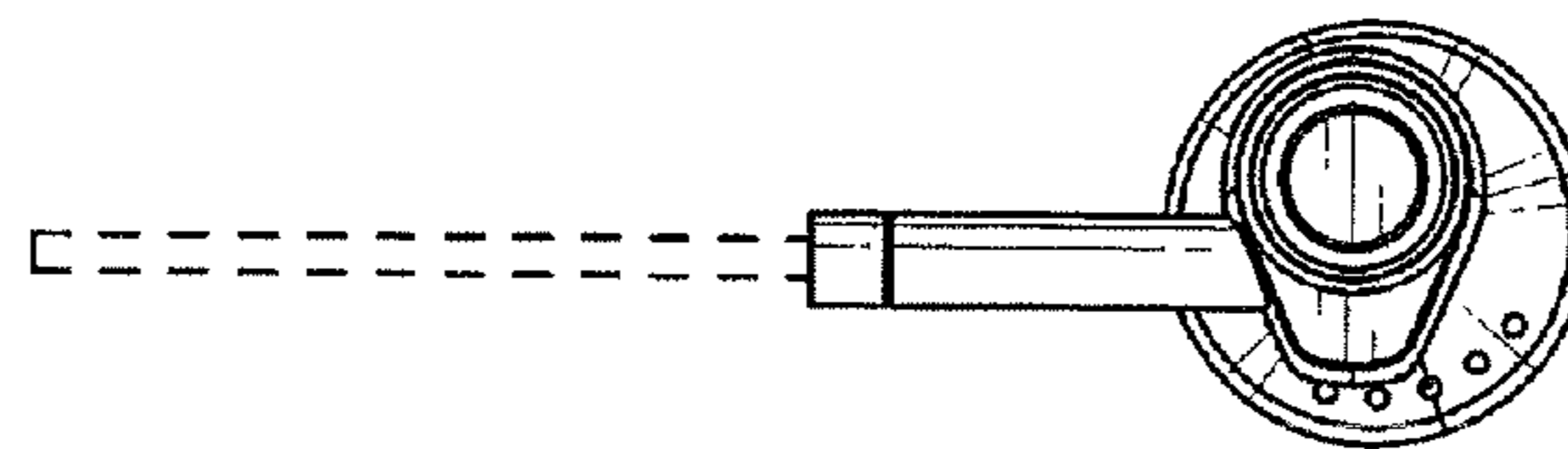

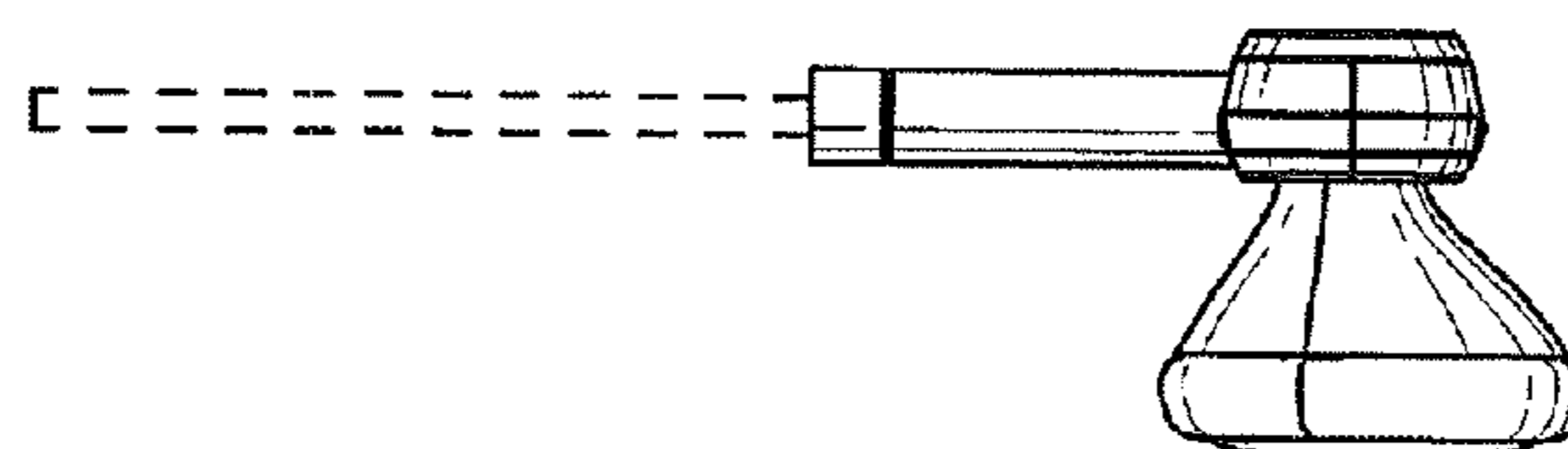

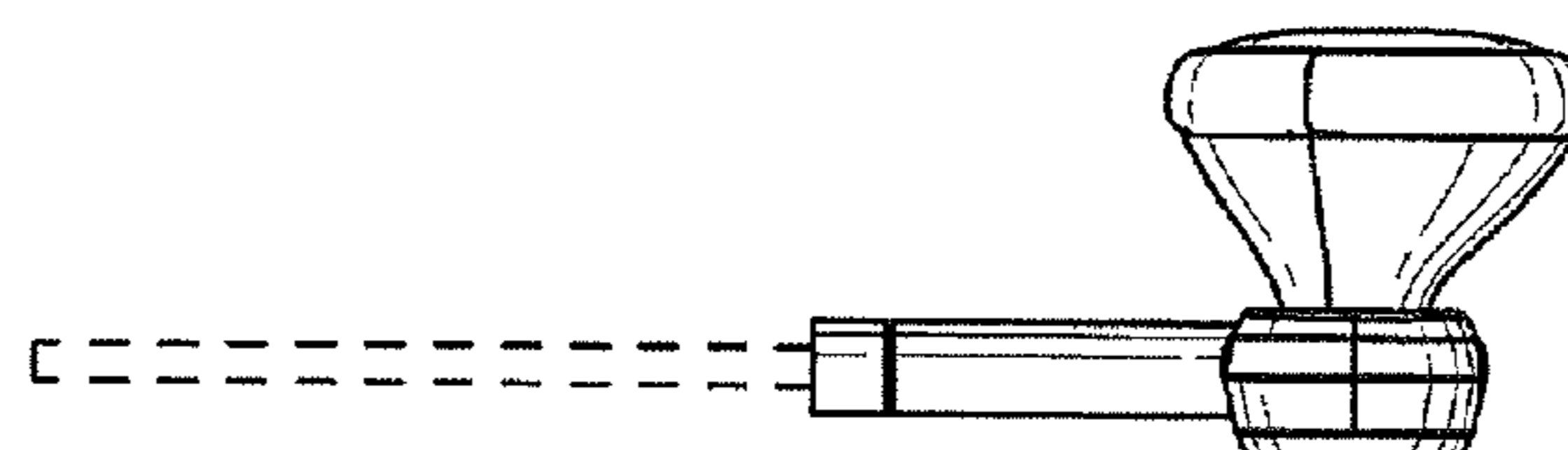
