(57) **CLAIM**

The ornamental design for a lantern, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the lantern, shown with table base as assembly

FIG. 2 is a side elevation view thereof

FIG. 3 is a bottom perspective view thereof

FIG. 4 is a side elevation view of the cover for the lantern, shown separately for completeness of disclosure

FIG. 5 is a top plan view of the connector tube of the lantern, shown separately for the completeness of disclosure

FIG. 6 is a left side elevation view thereof, the right side being a mirror image

FIG. 7 is a front elevation view of the support hanger for the lantern, shown separately for the completeness of disclosure

FIG. 8 is a perspective view of the connector to the table base for the lantern, shown separately for completeness of disclosure

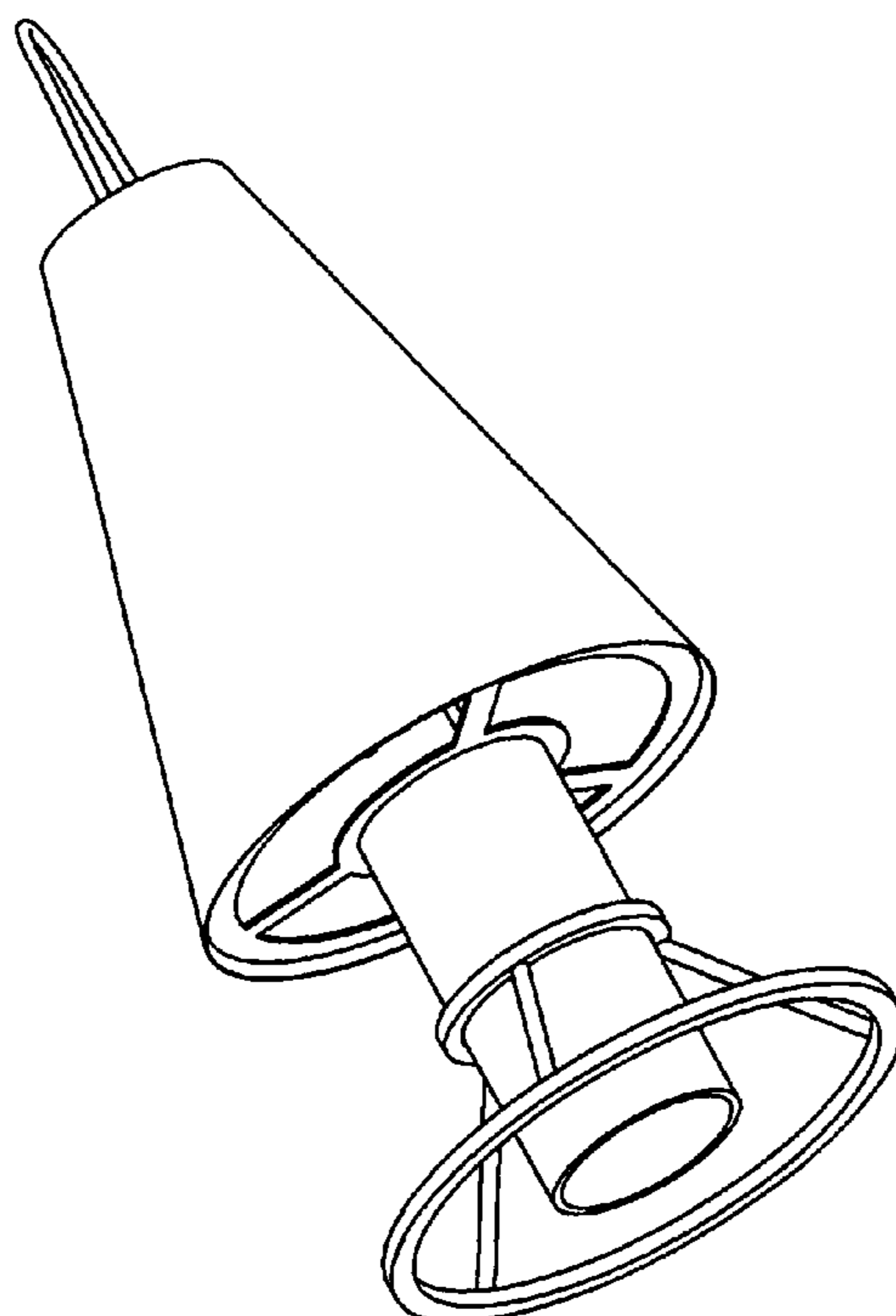
FIG. 9 is a top plan view thereof

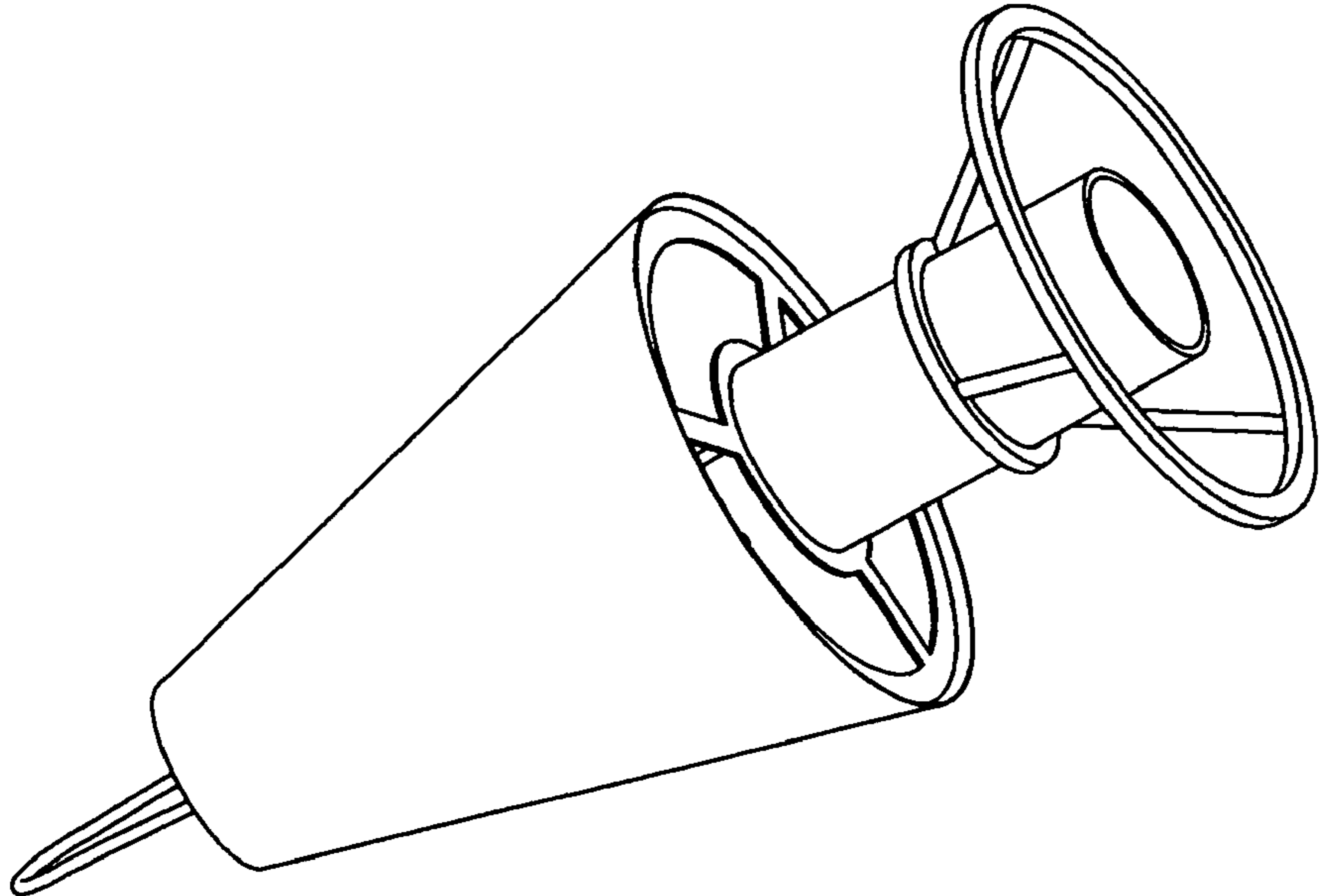

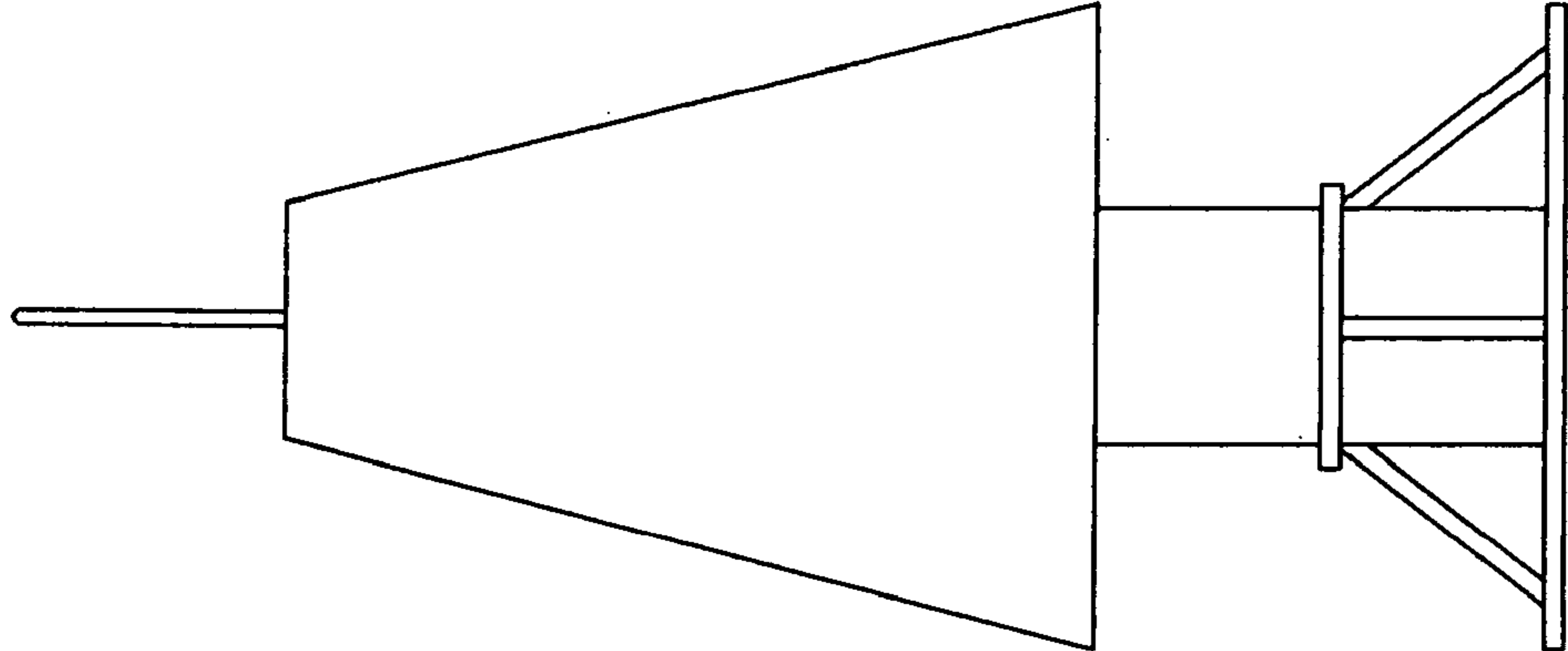

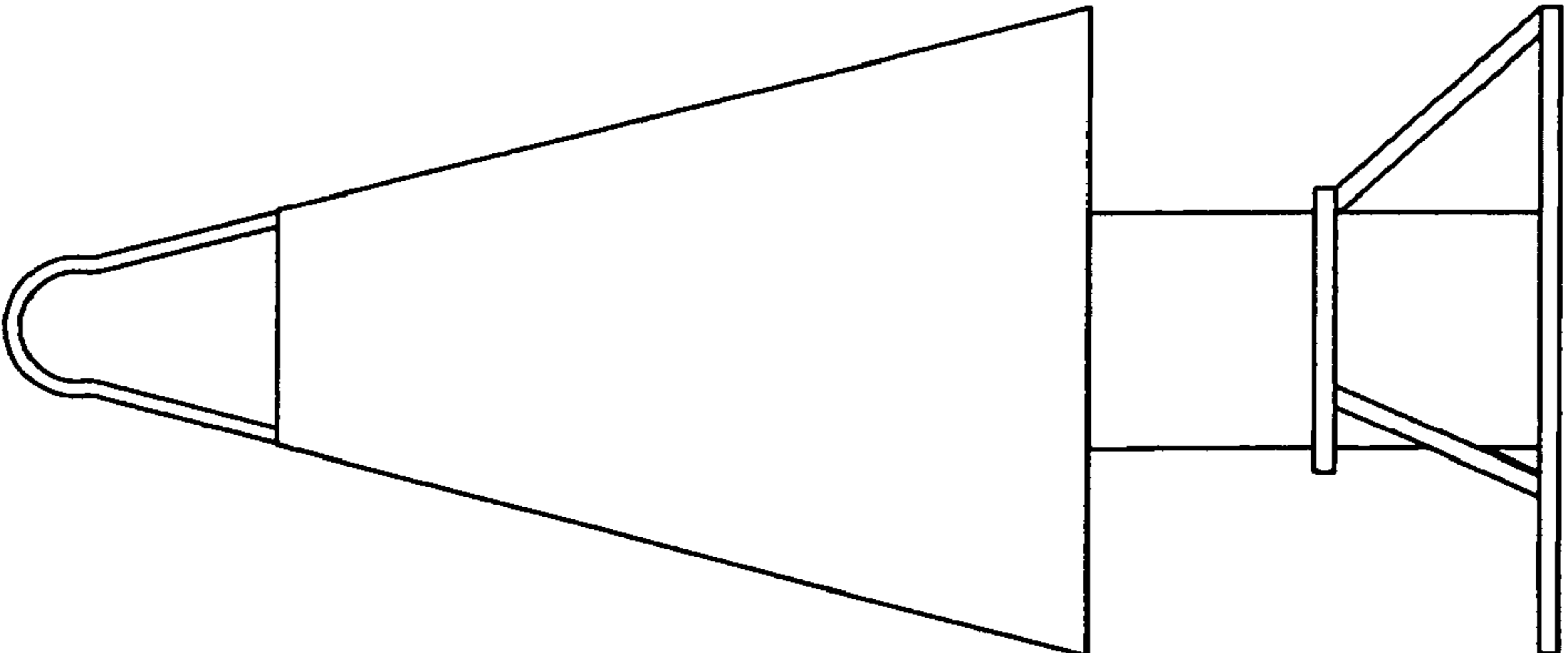

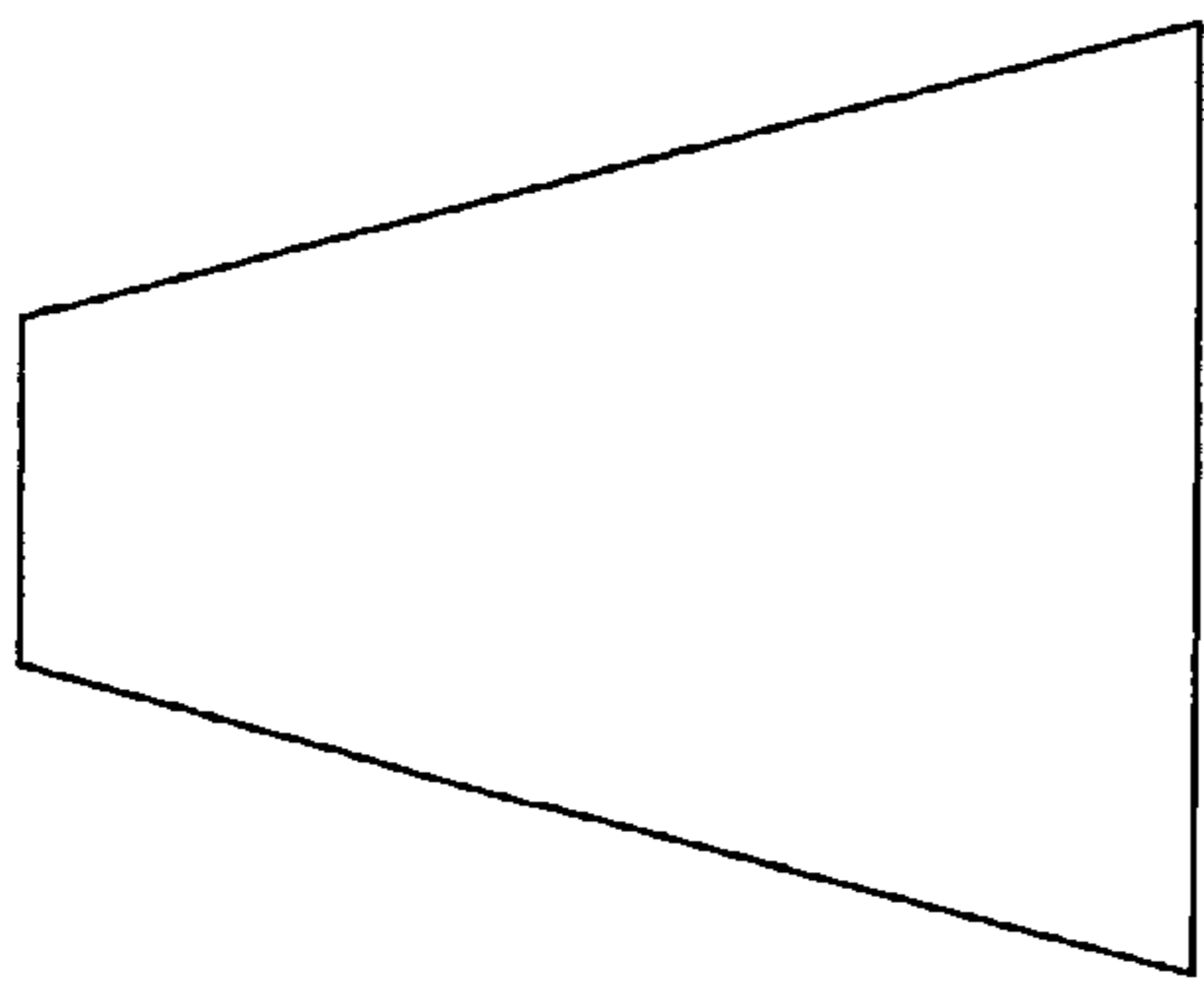

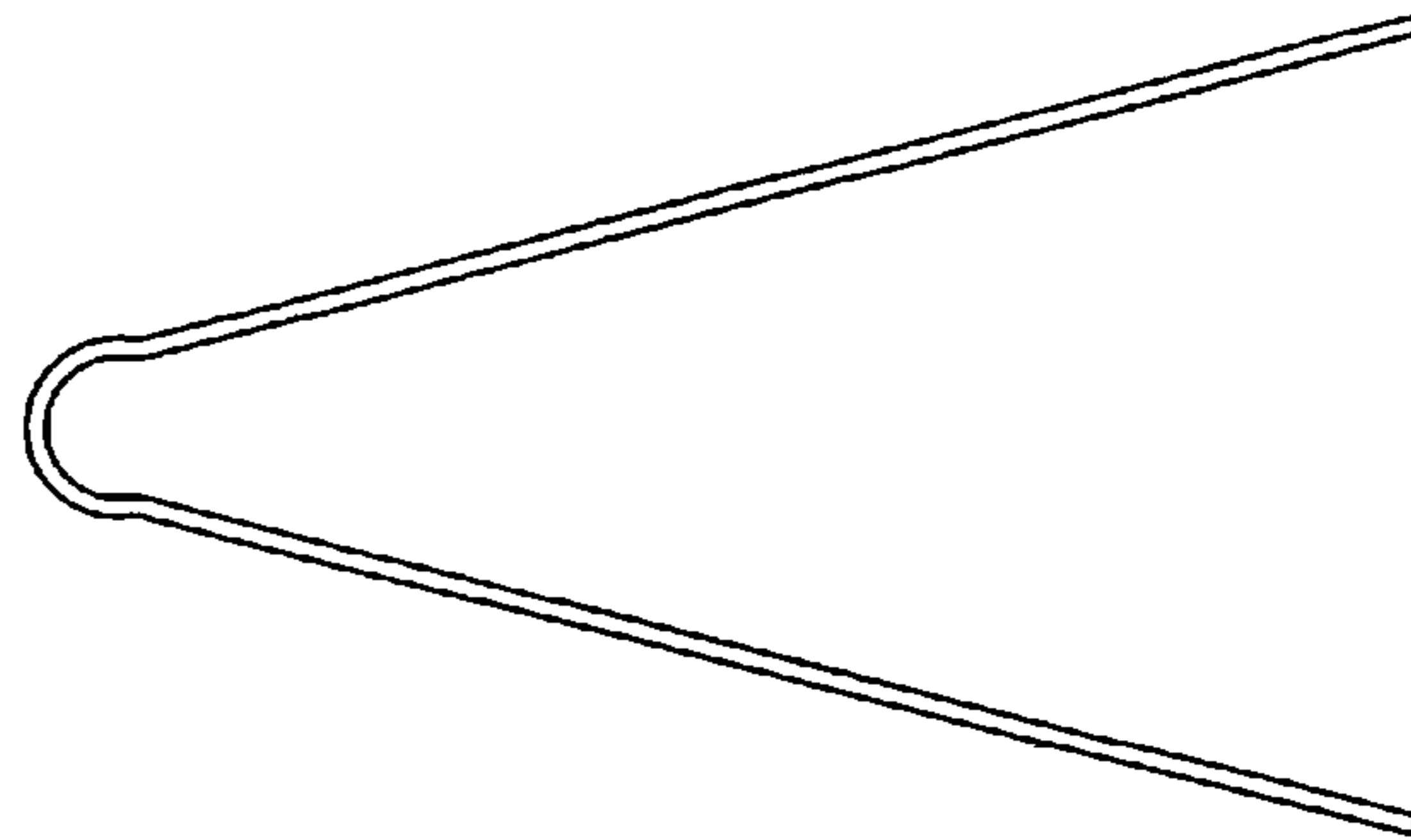

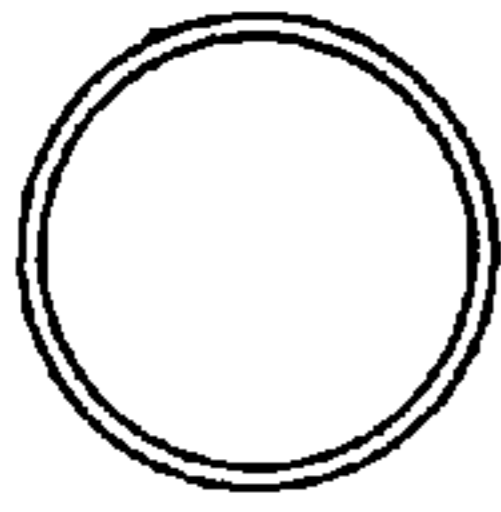

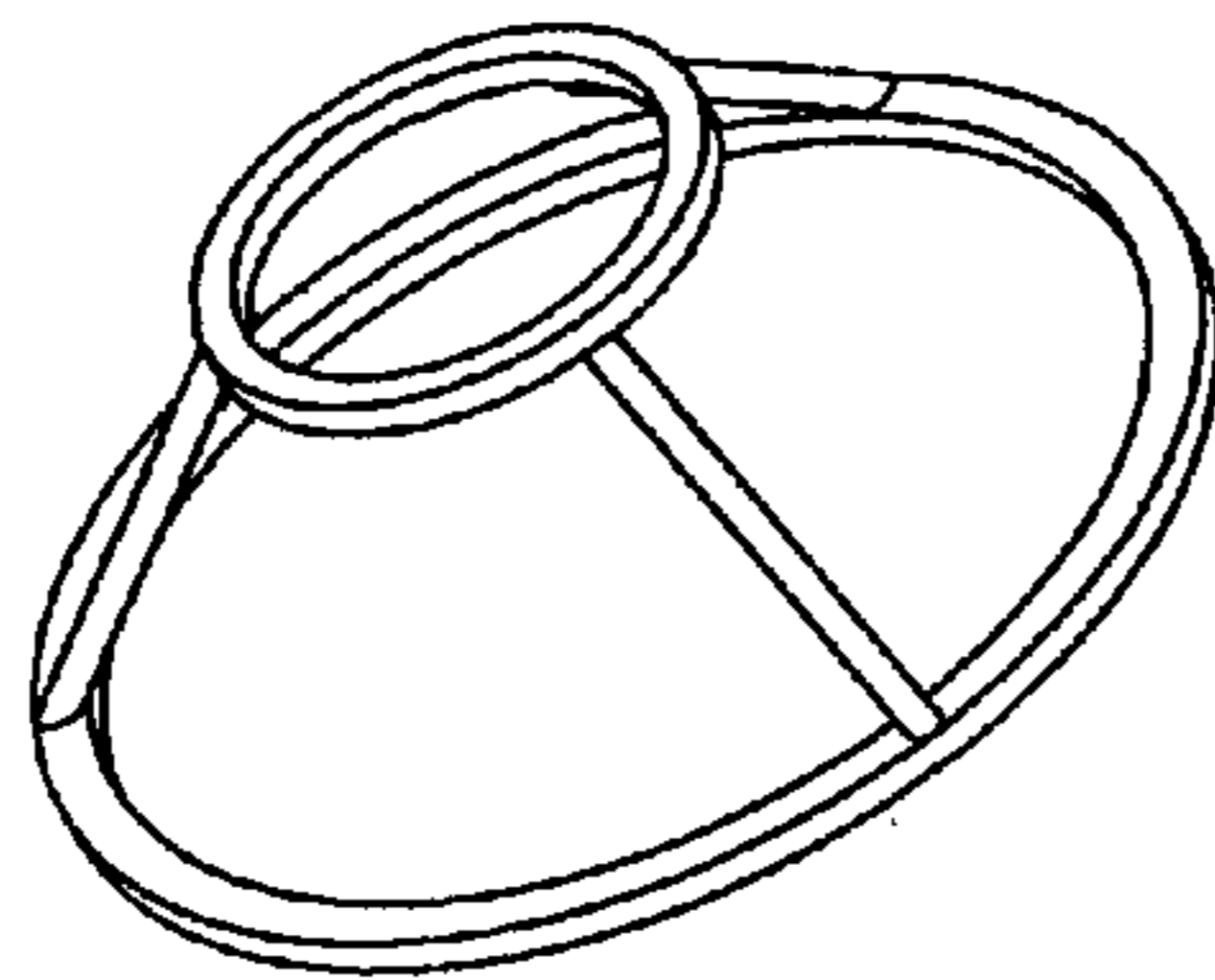

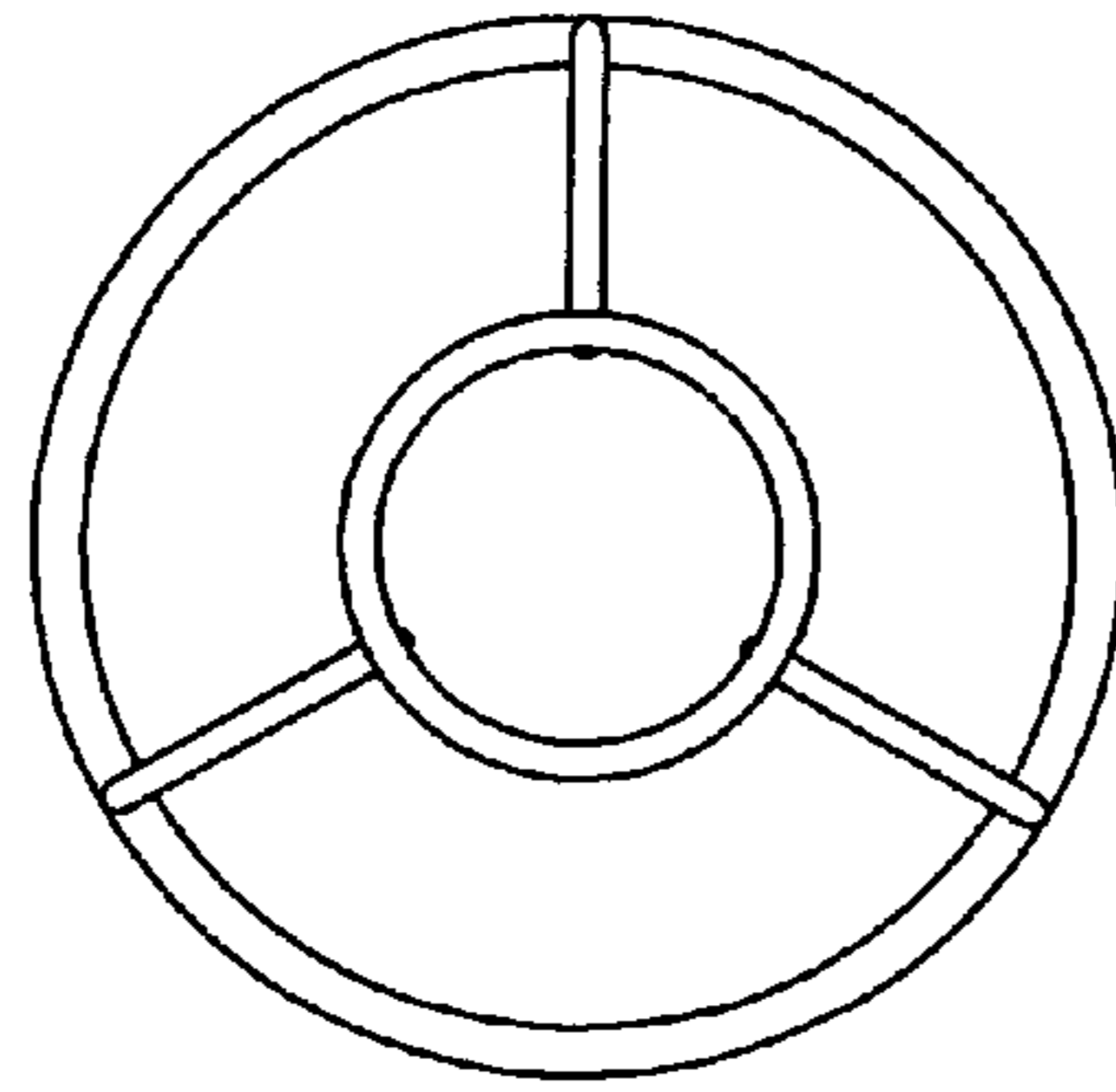

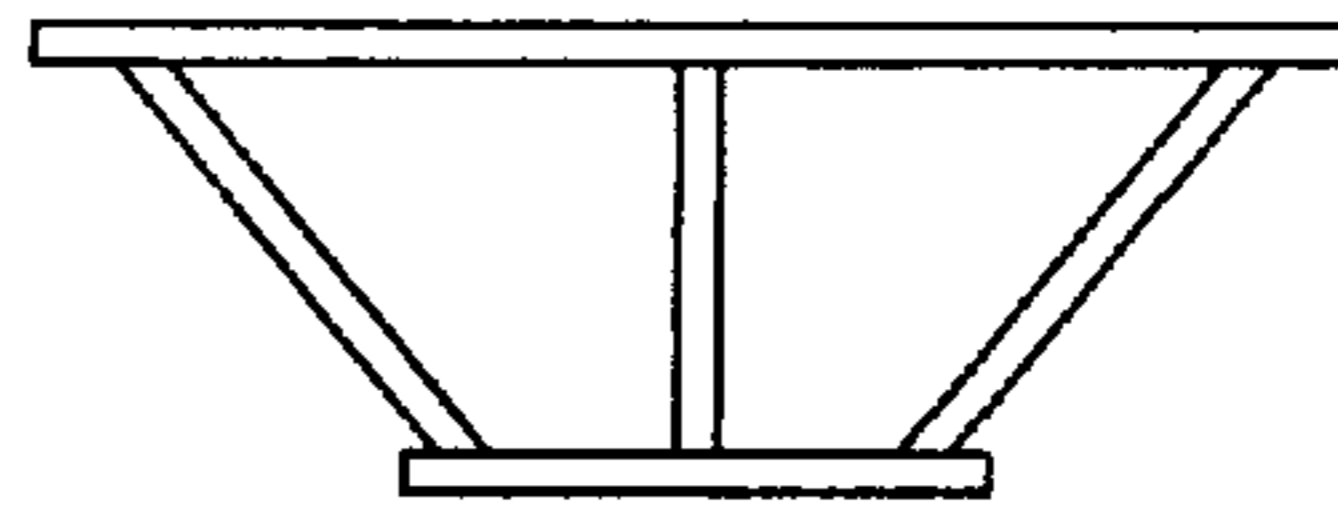

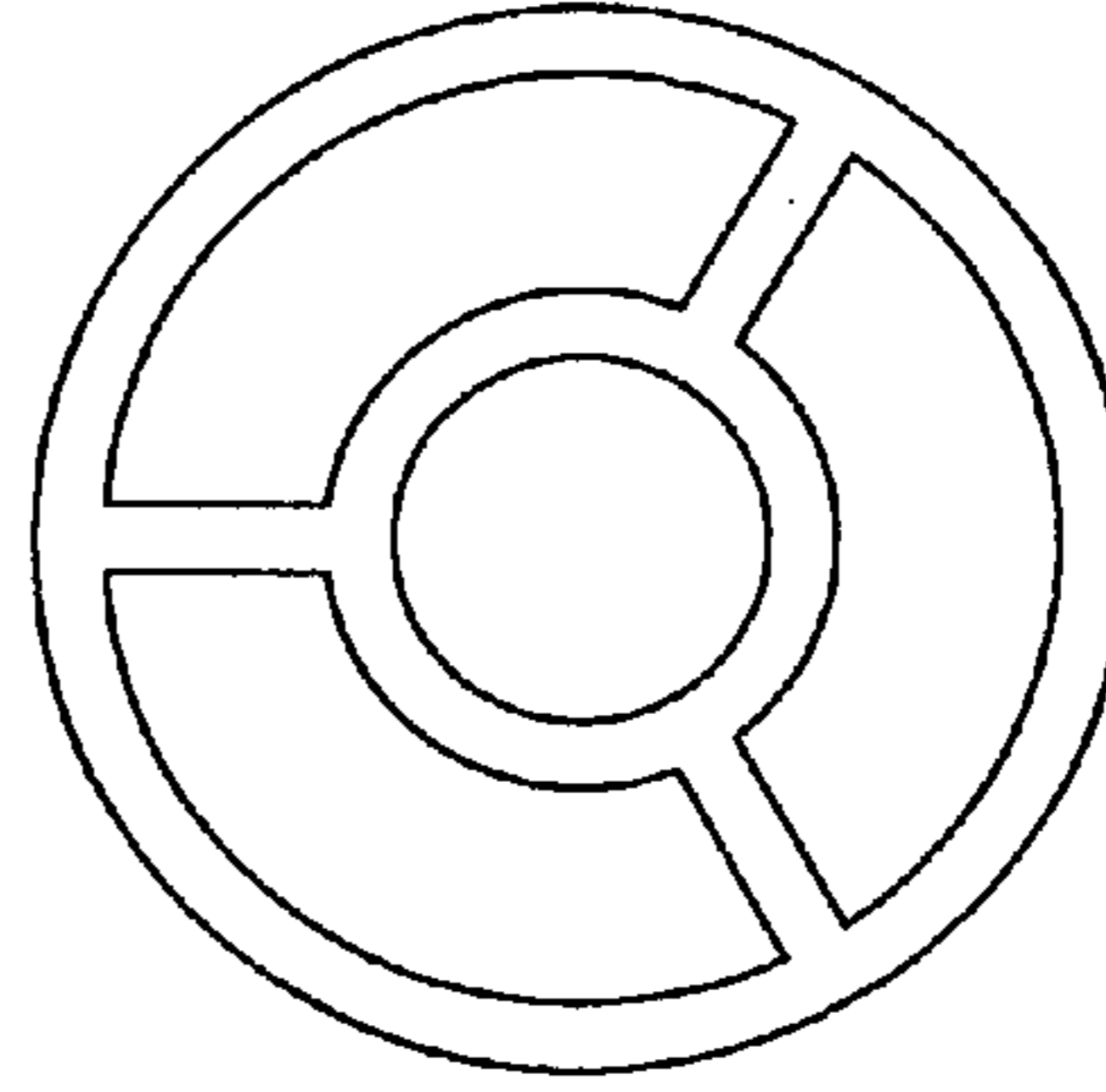
