FIG. 3 is a back, elevation view thereof;

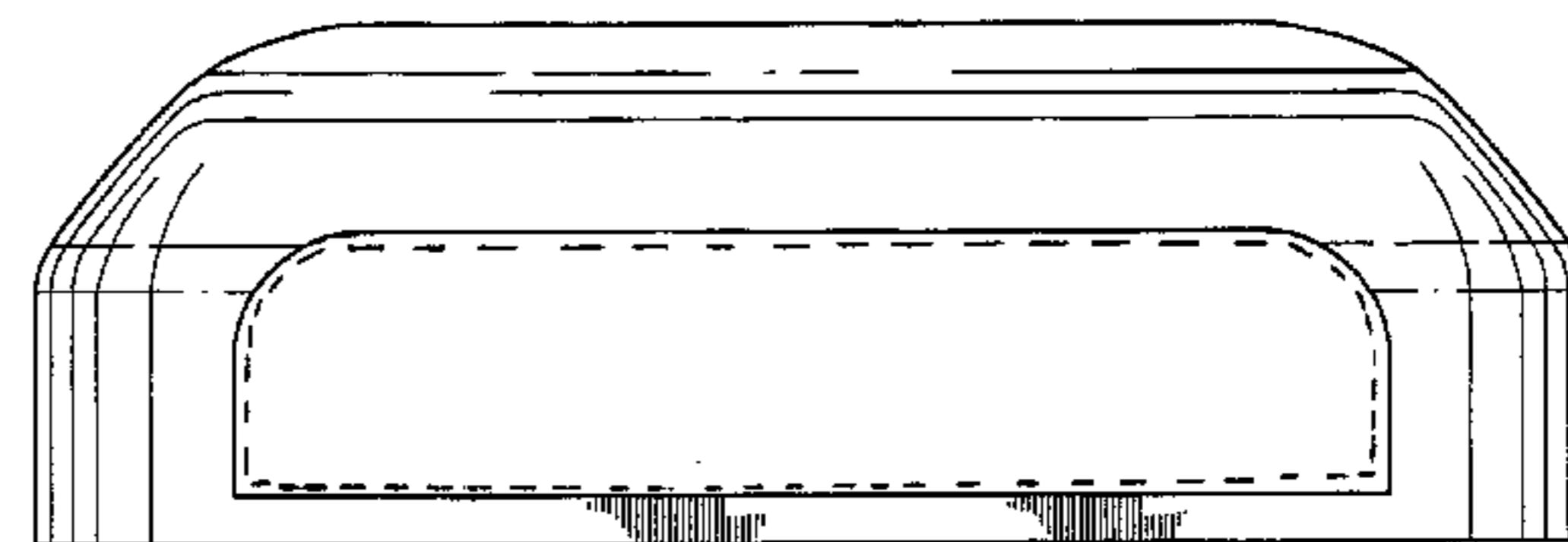
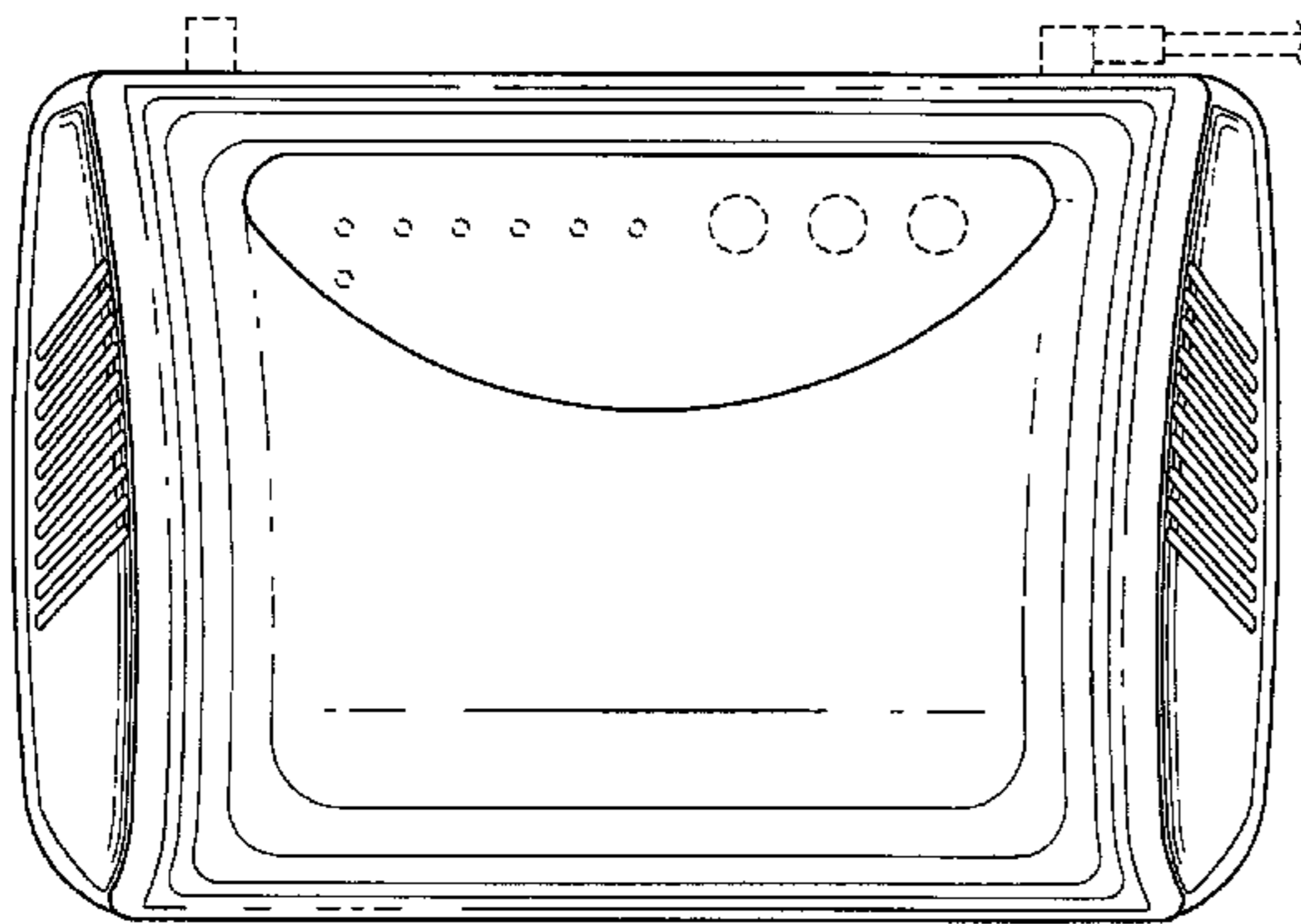
FIG. 4 is a front, elevation view thereof;

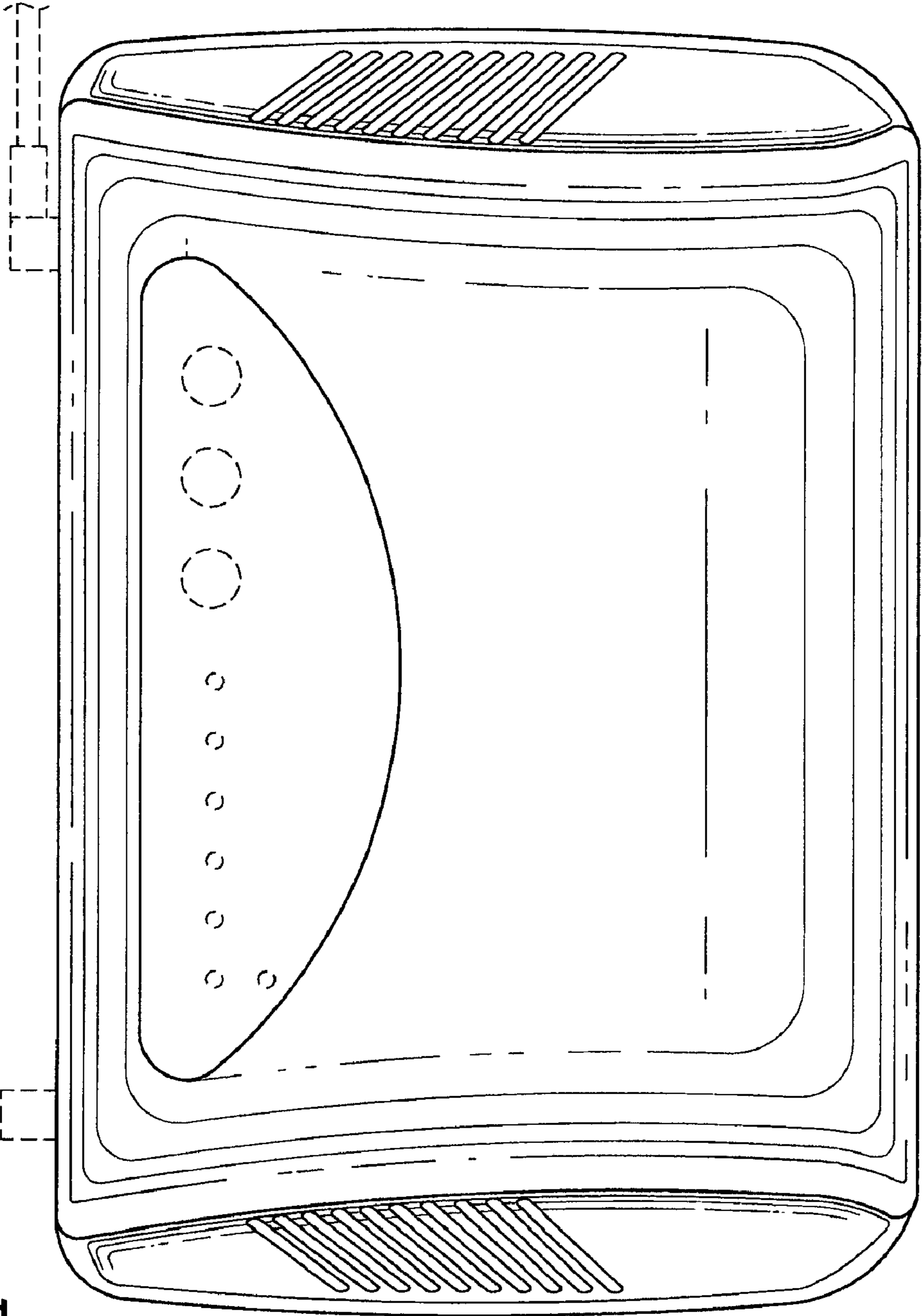

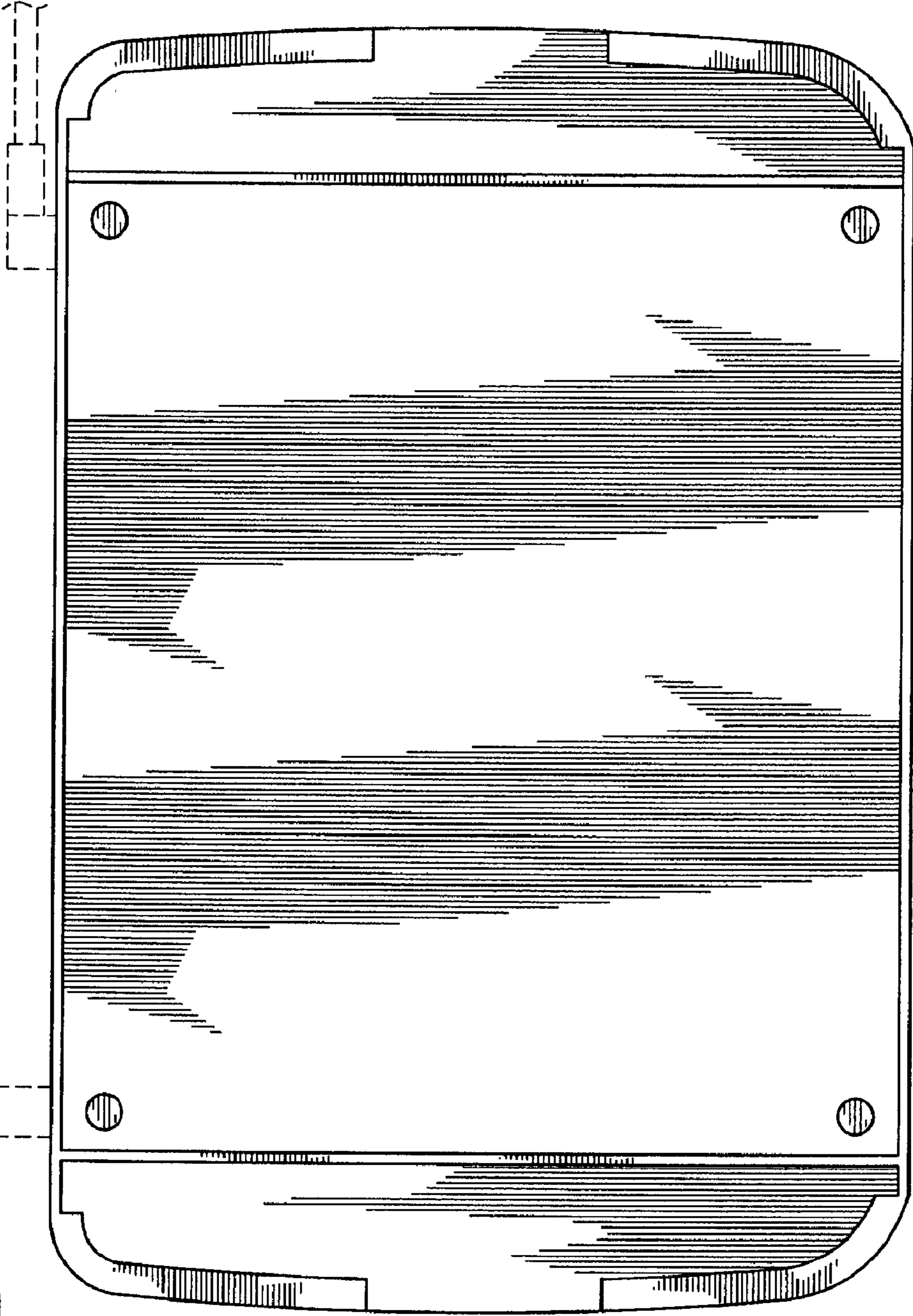

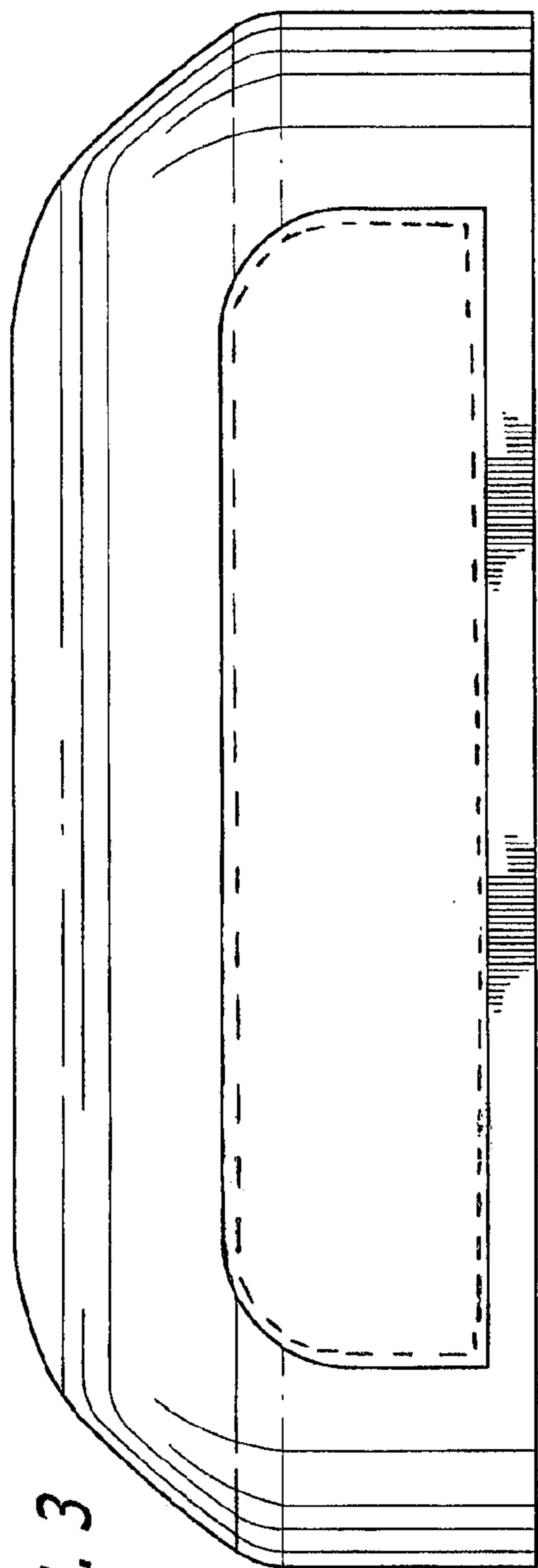

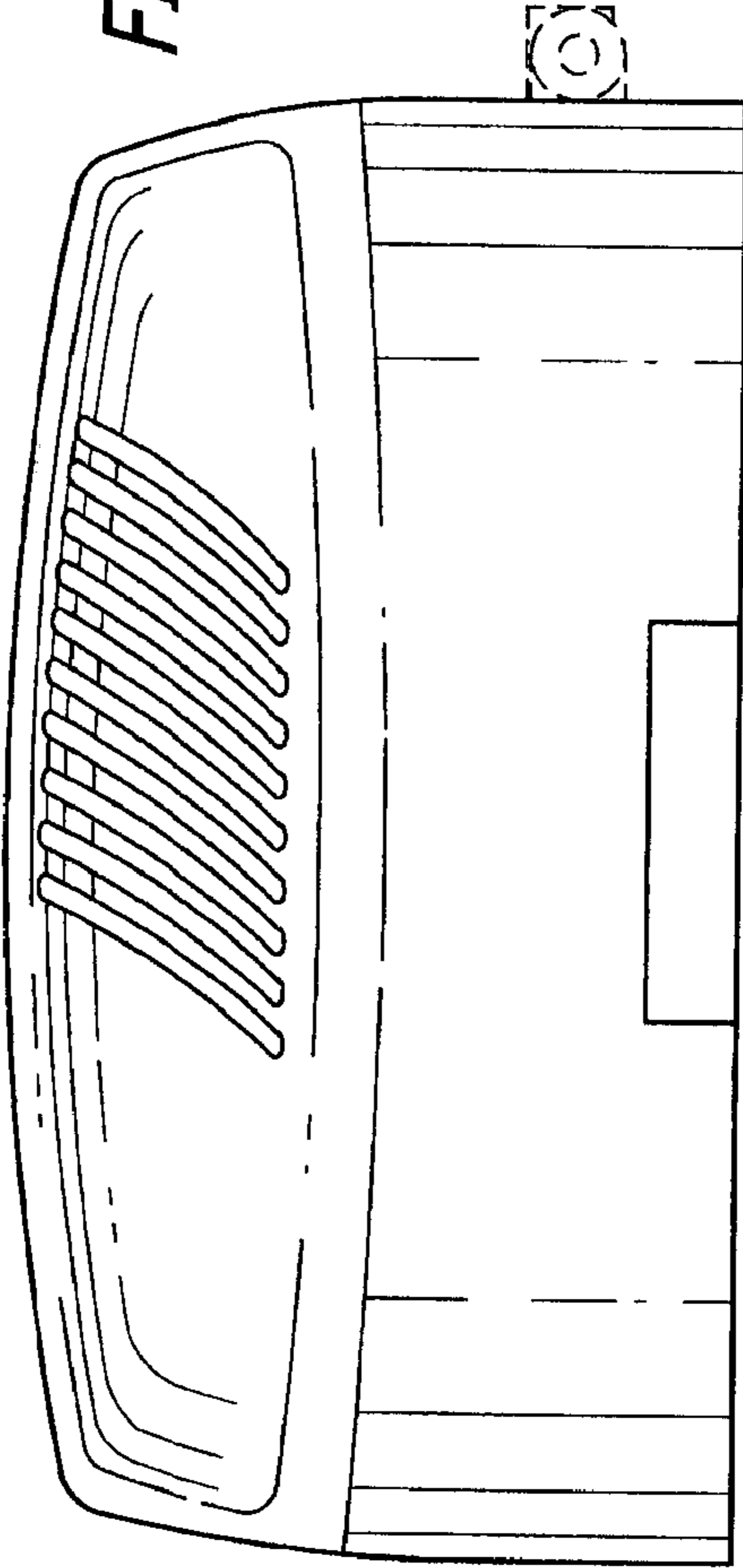
