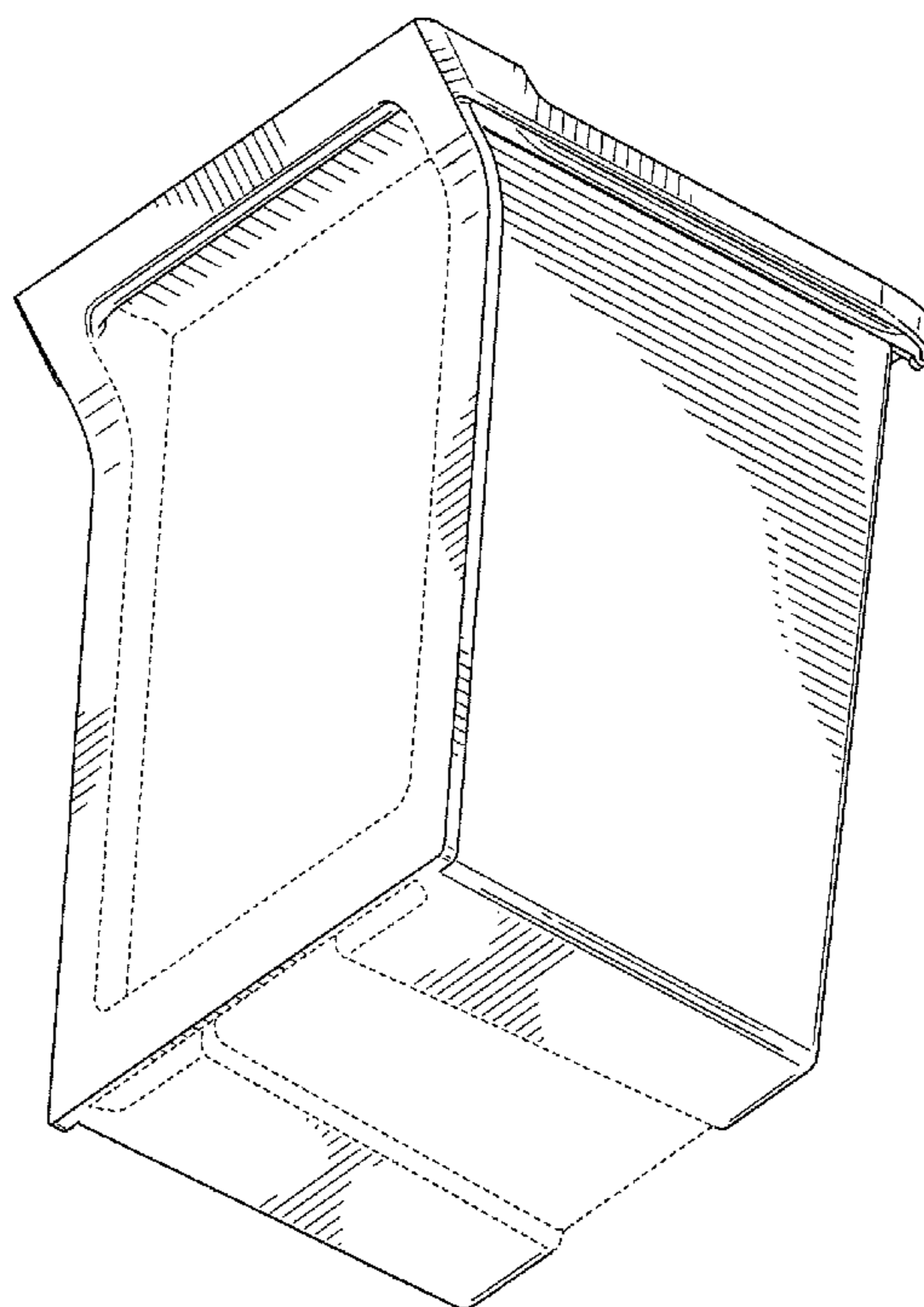
The ornamental design for a receptacle, as shown and described.

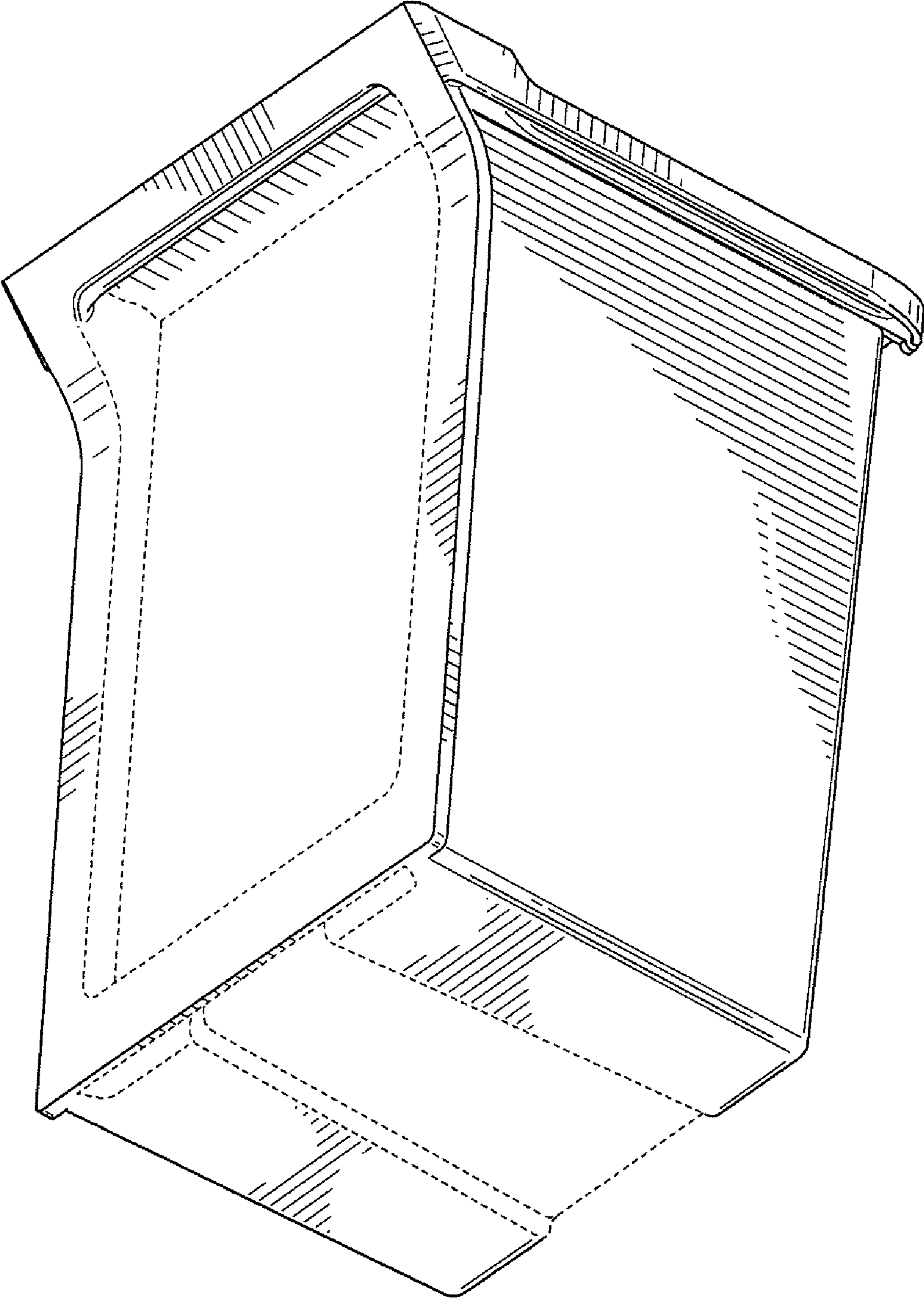
**DESCRIPTION**

FIG. 1 is a perspective view of a receptacle showing our new design;

 FIG. 8 is a left side elevation cross-section view thereof taken along line 8—8 of FIG. 3.

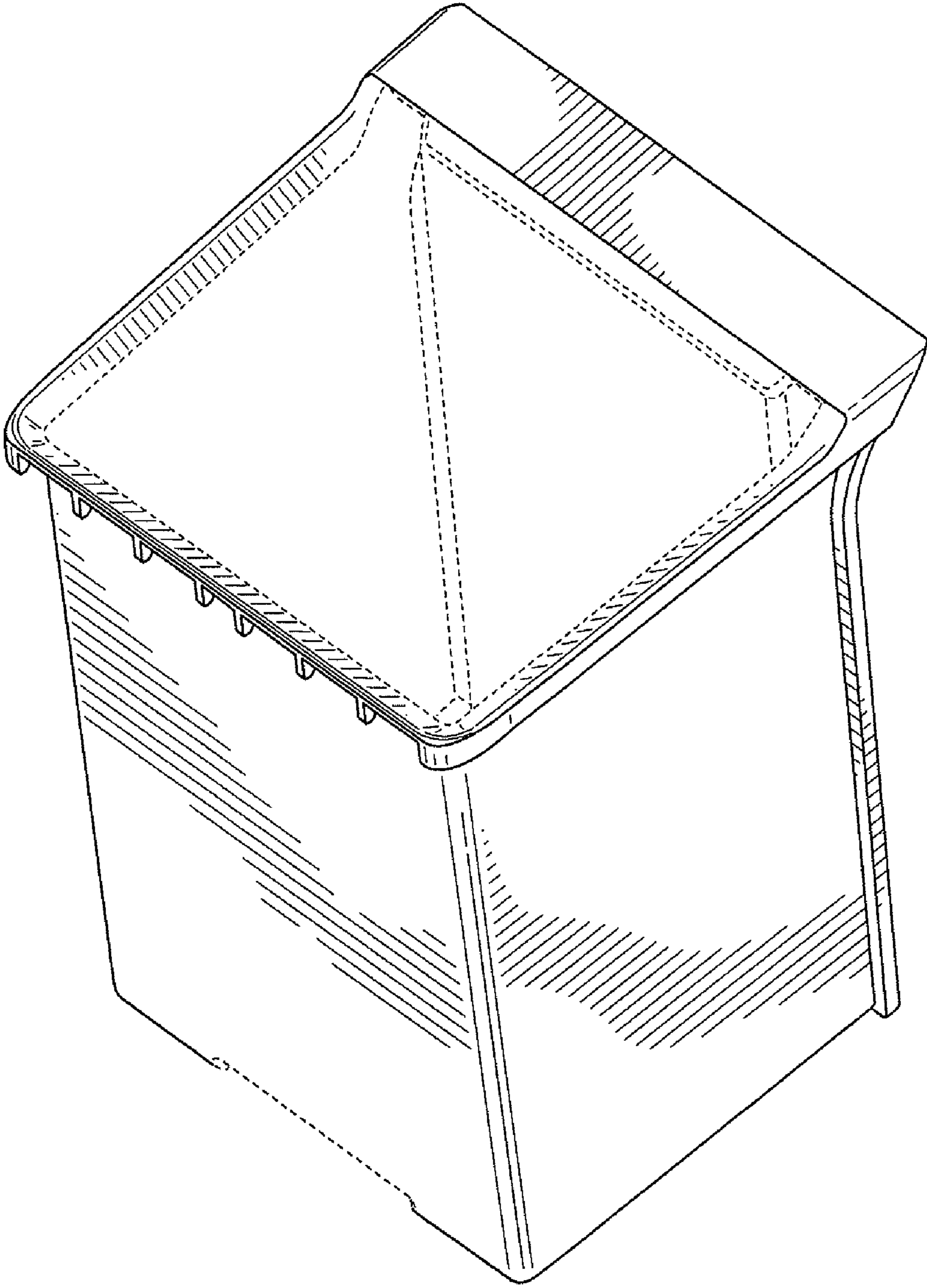

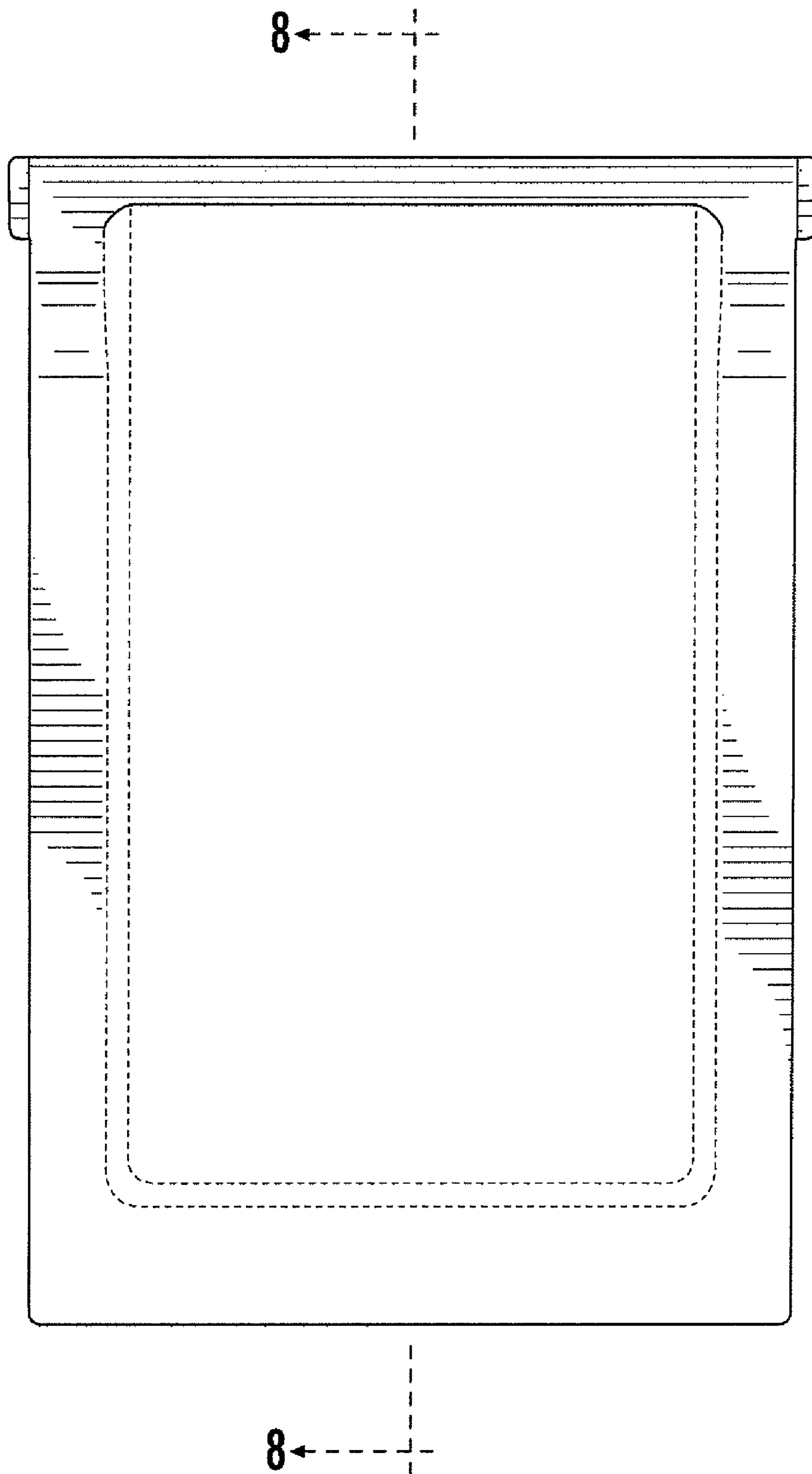
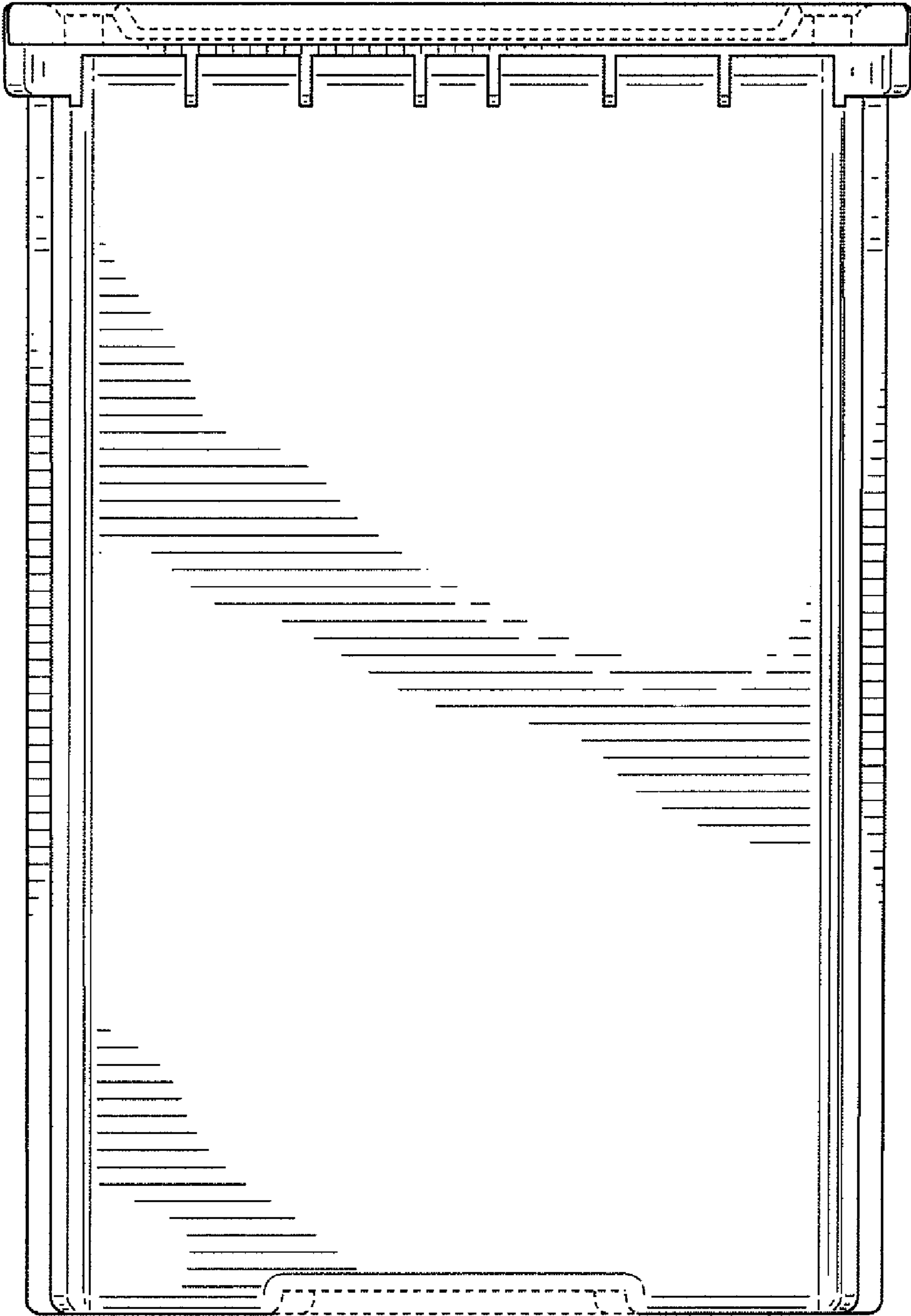
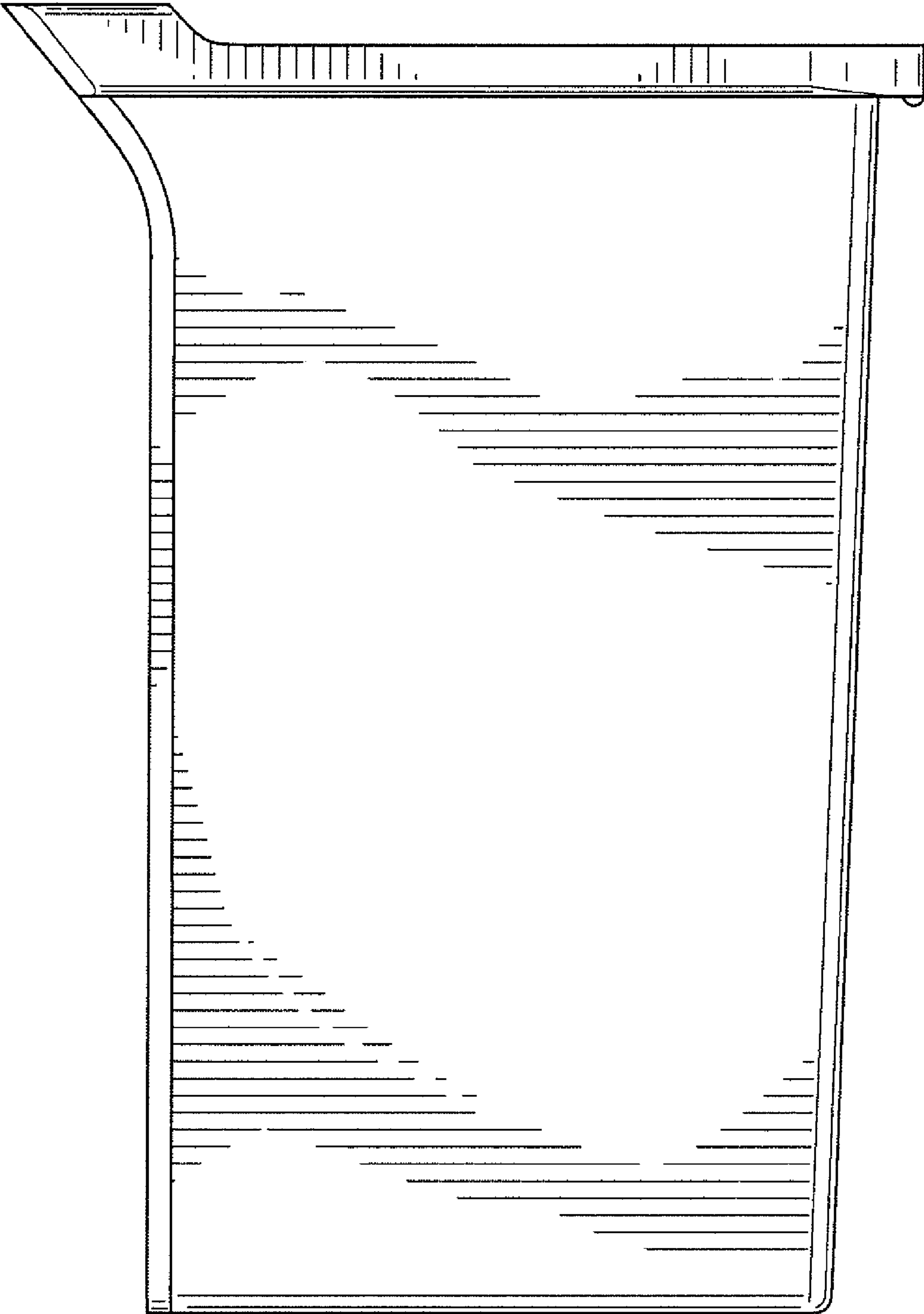


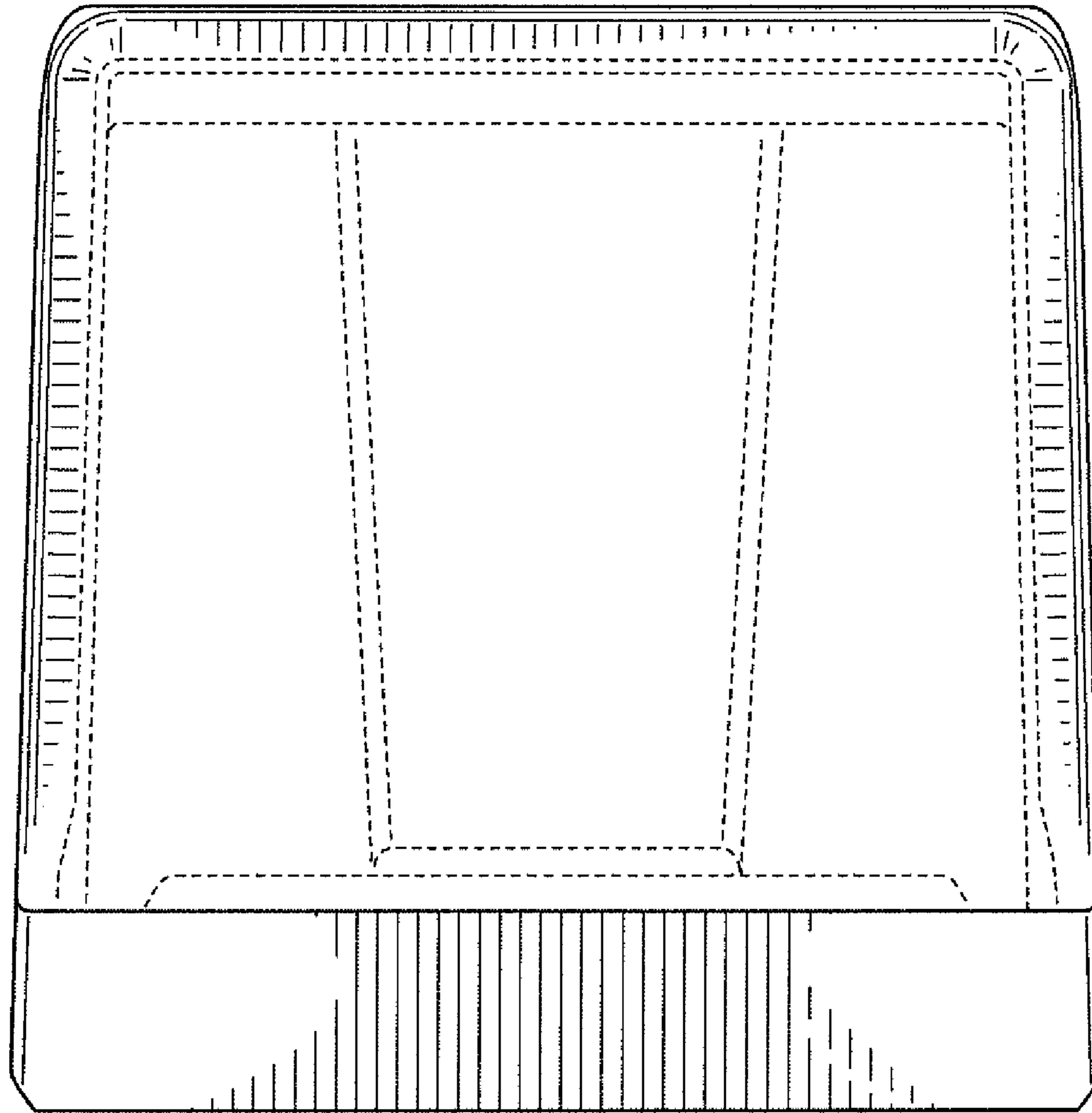

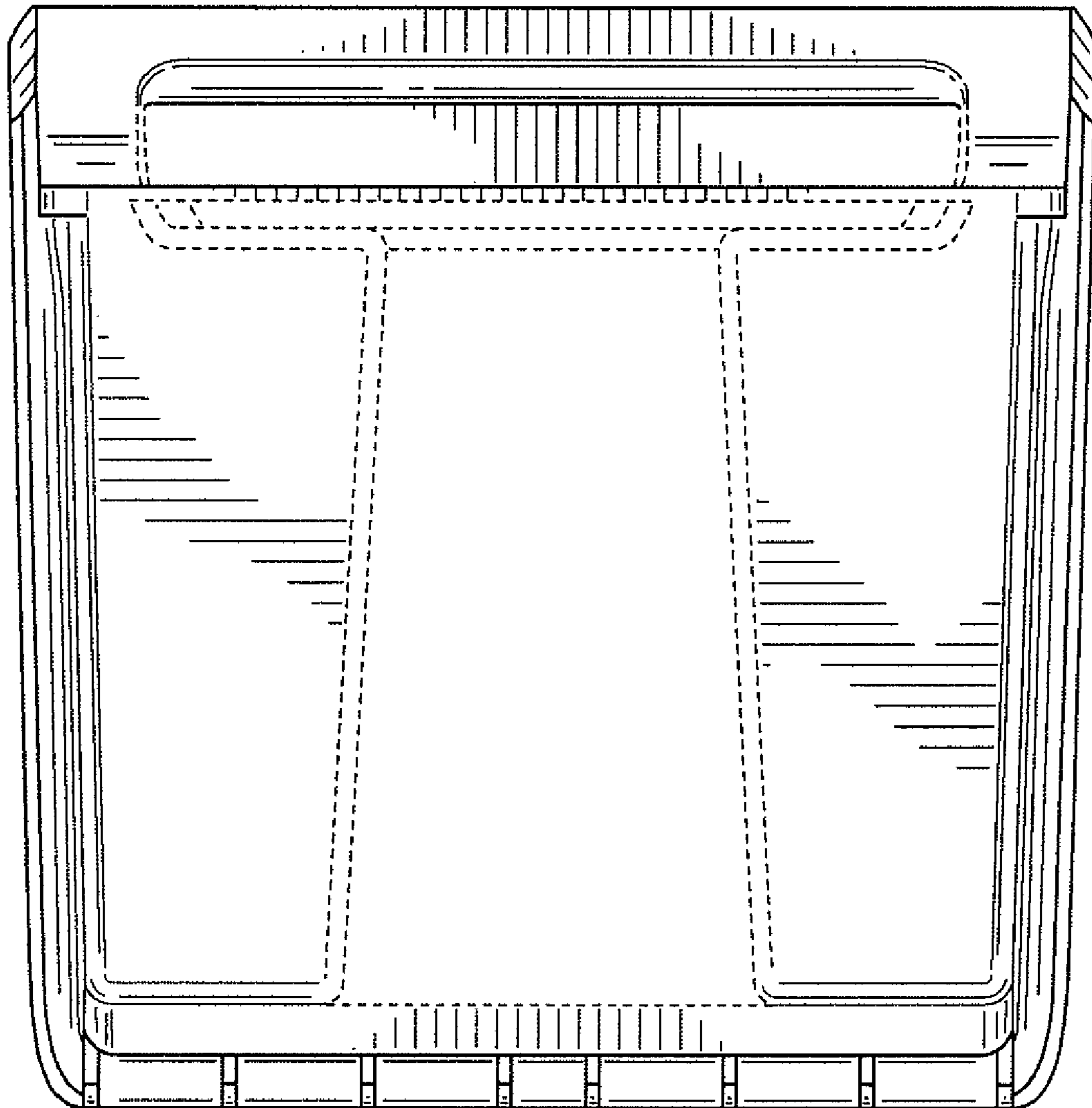

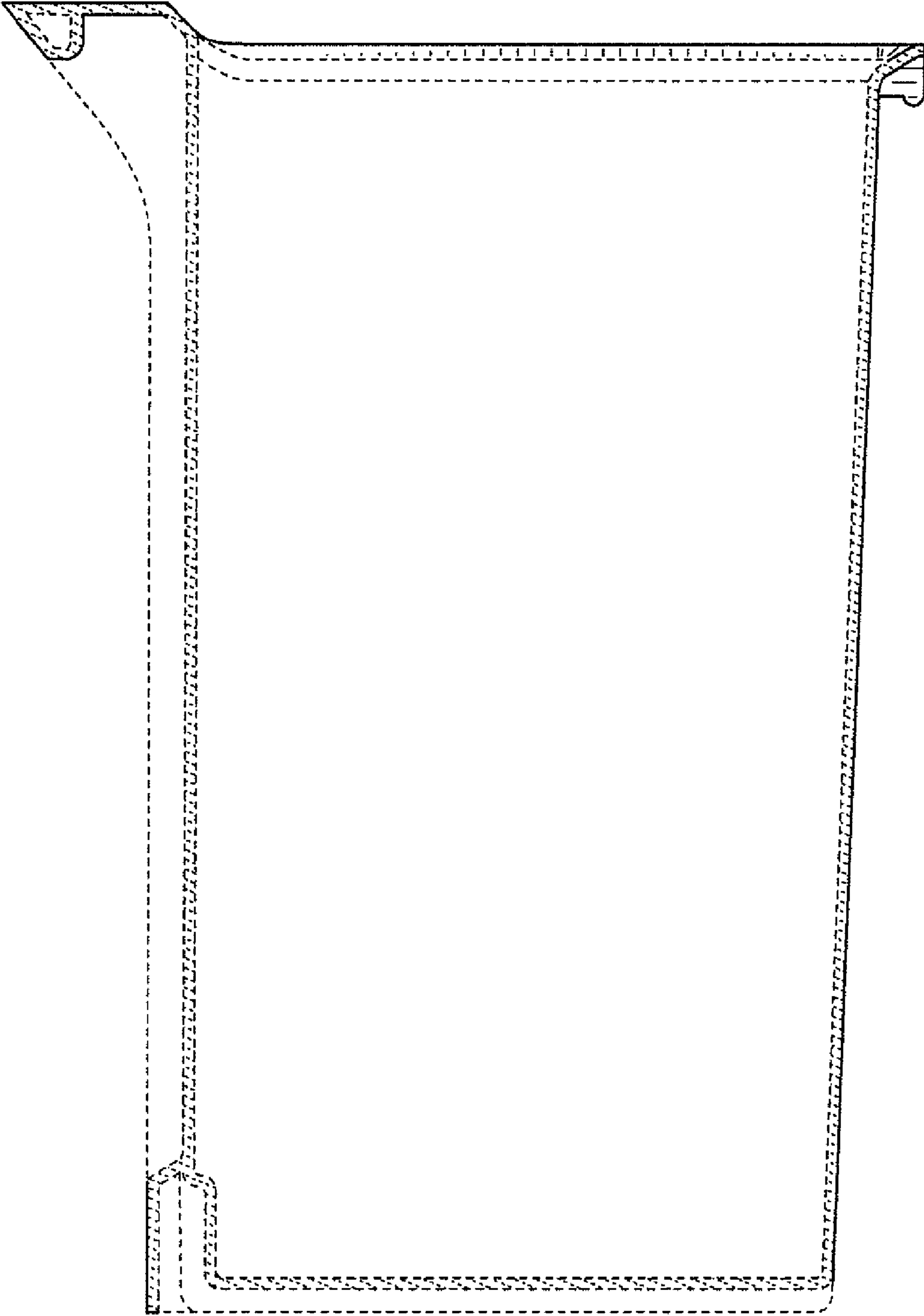
