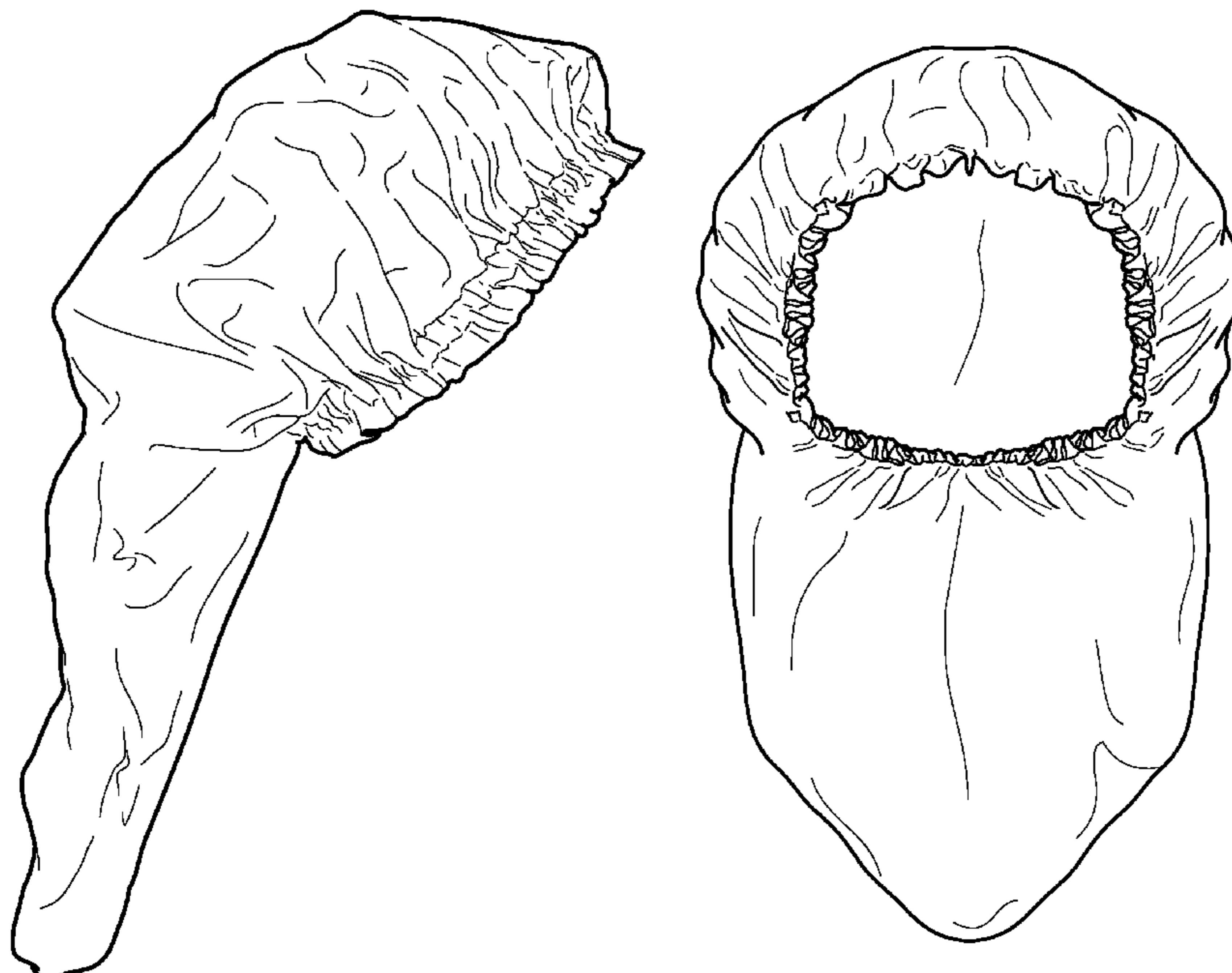
(57) **CLAIM**

The ornamental design for a hair cover, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a hair cover.

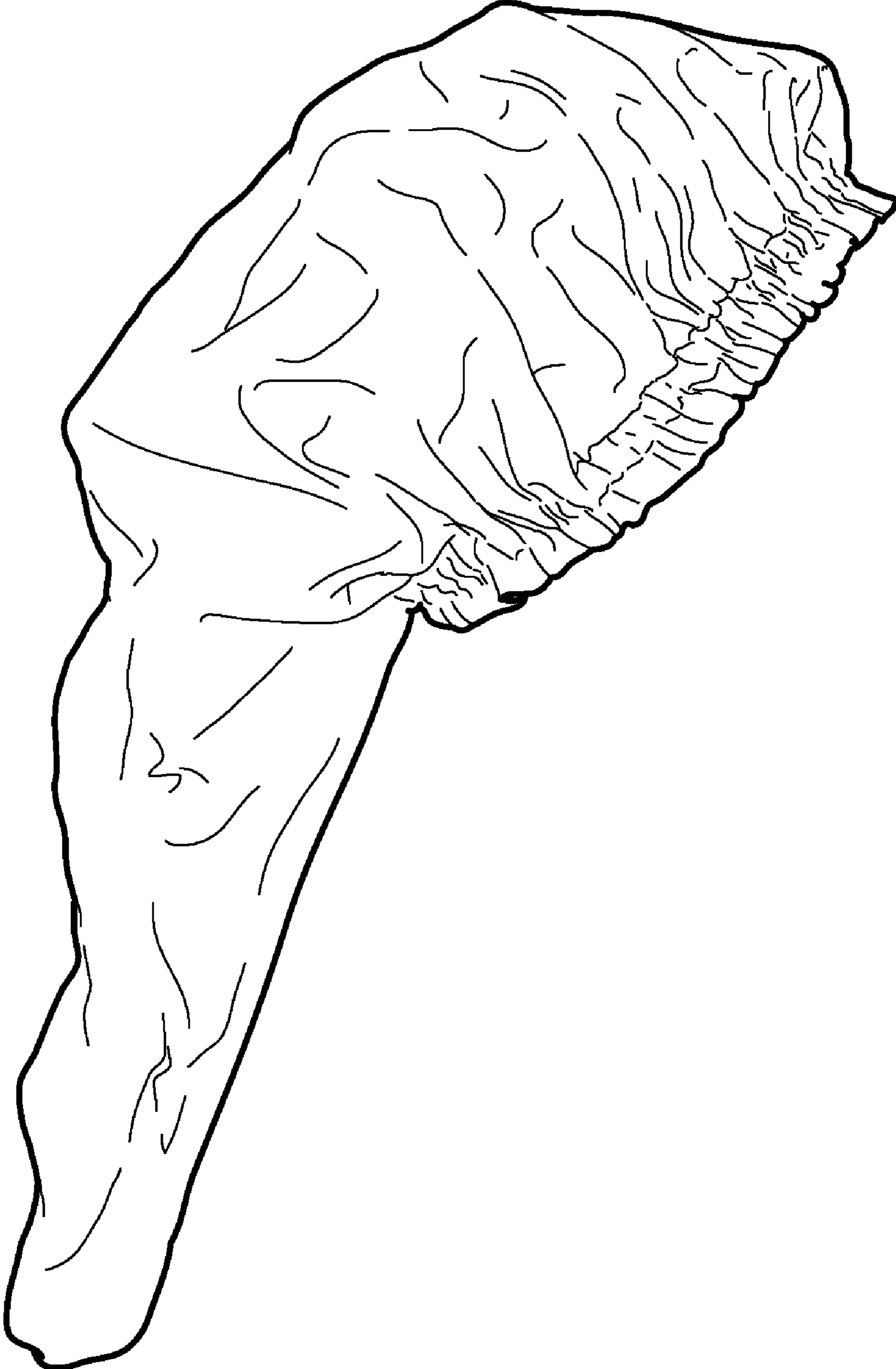

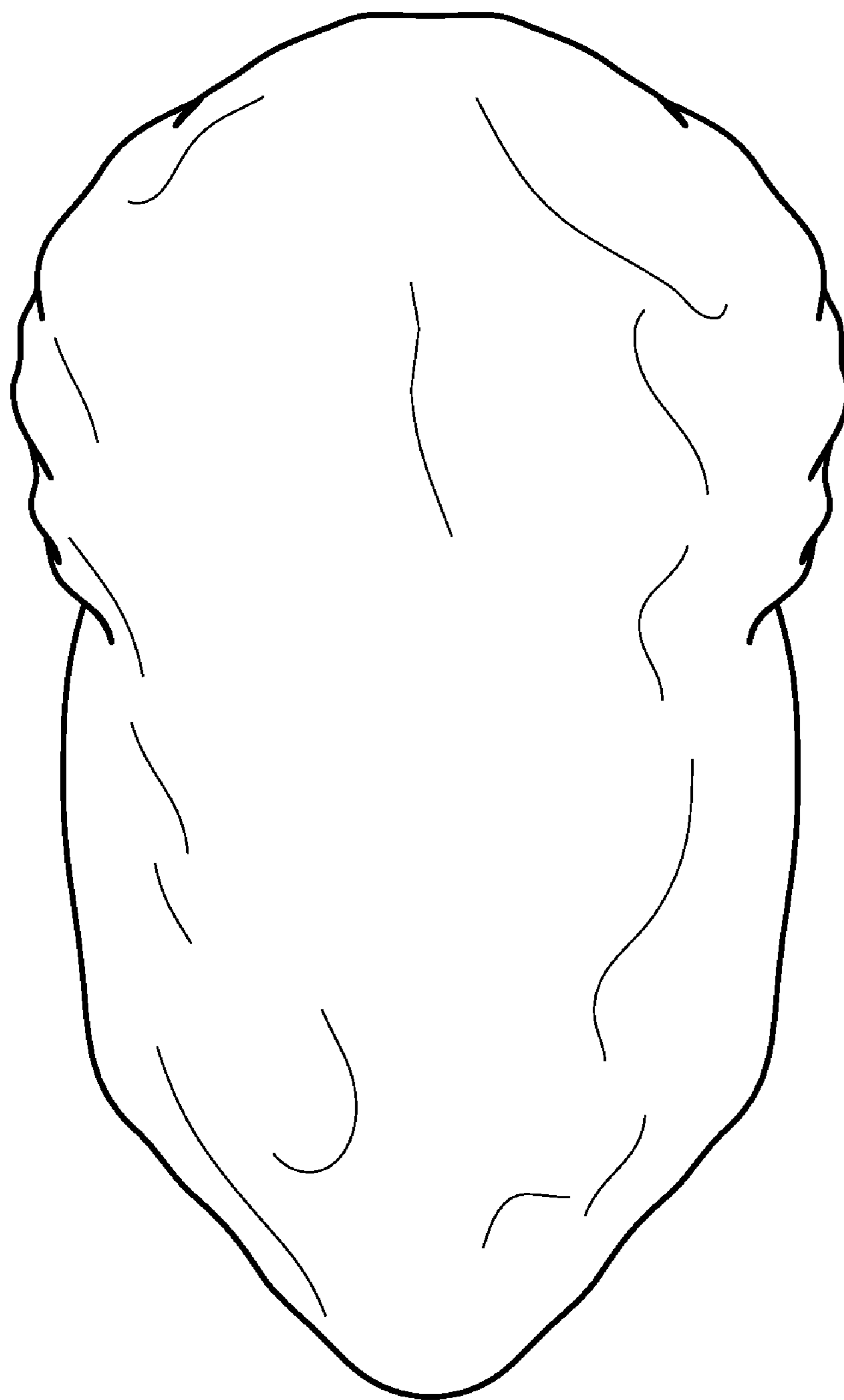
