FIG. 13 is a bottom view thereof;

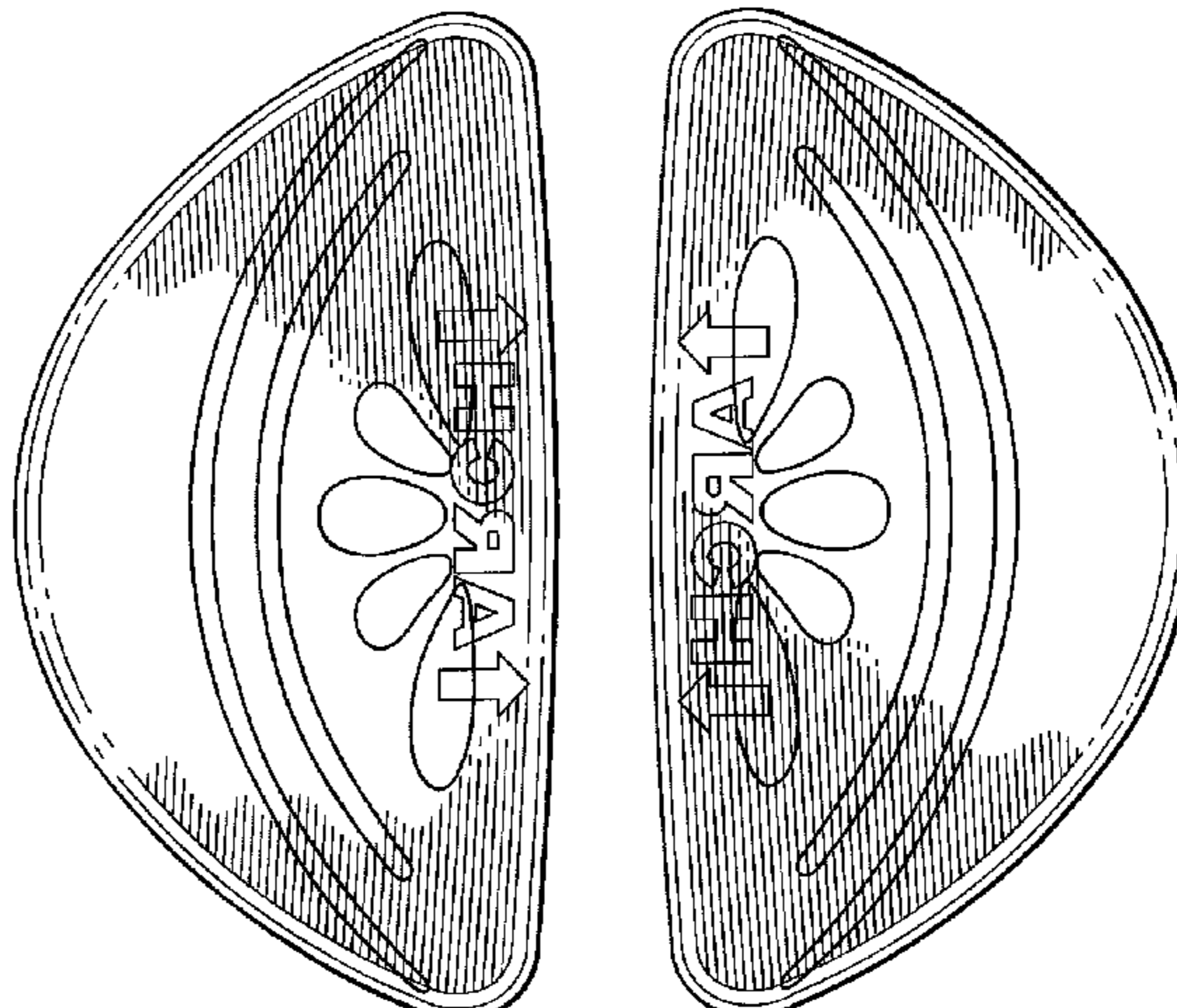
FIG. 14 is a rear view thereof;

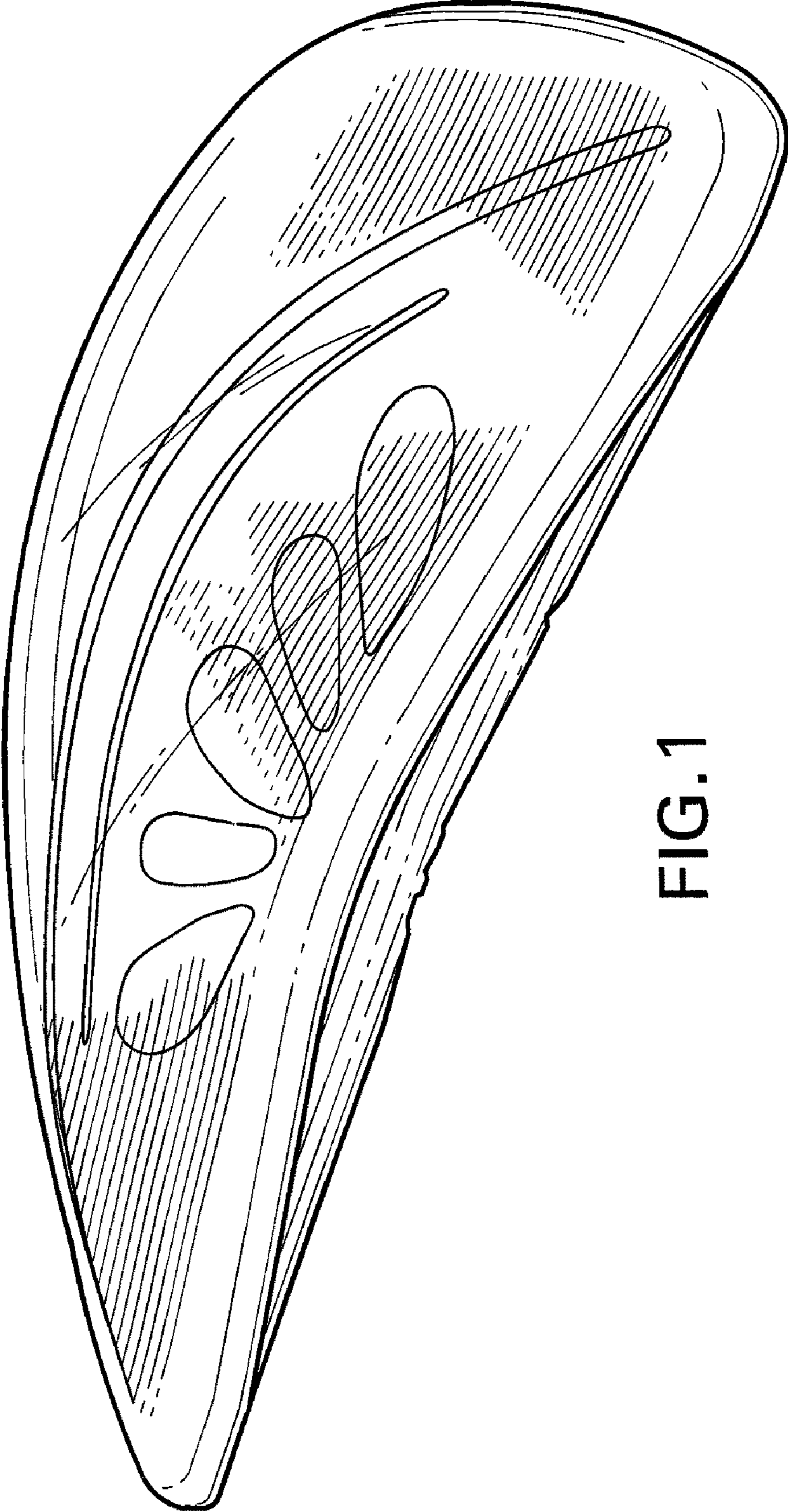

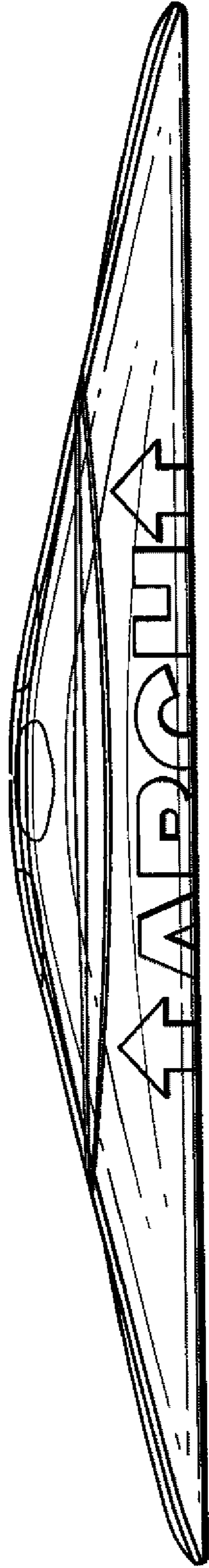

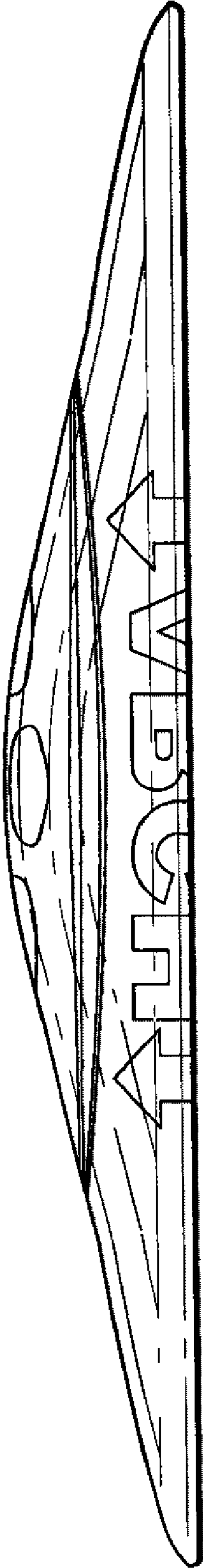

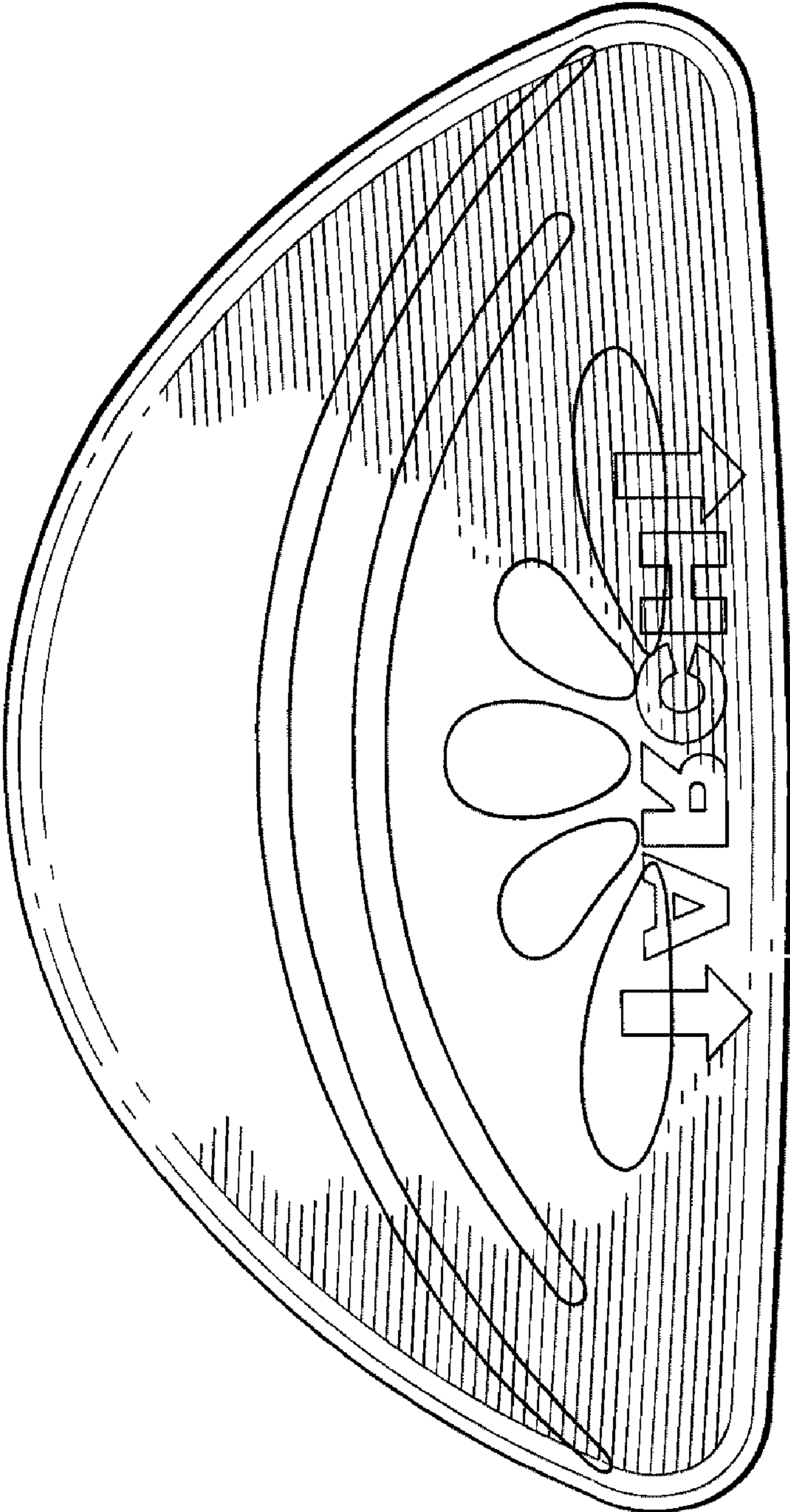

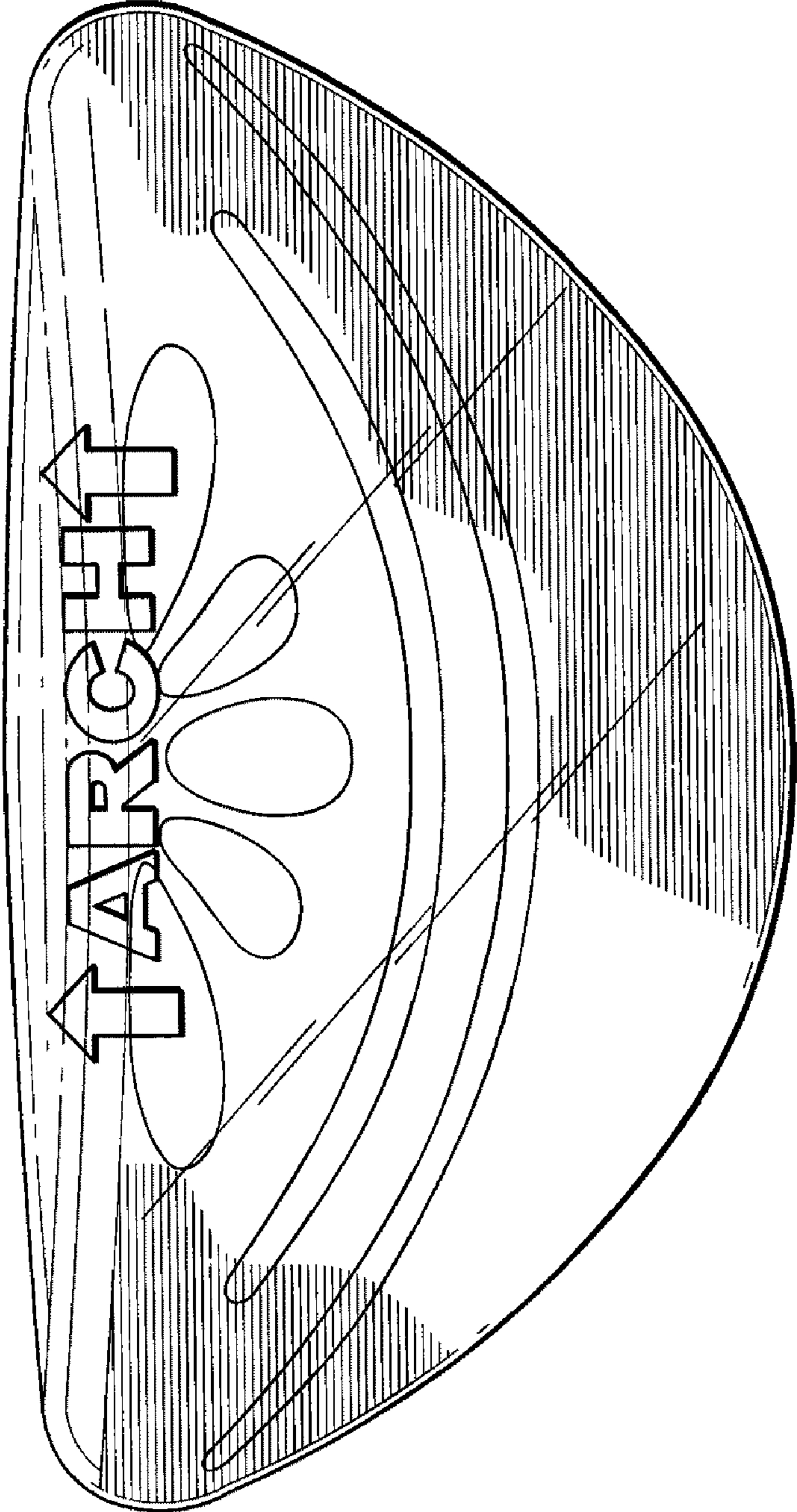

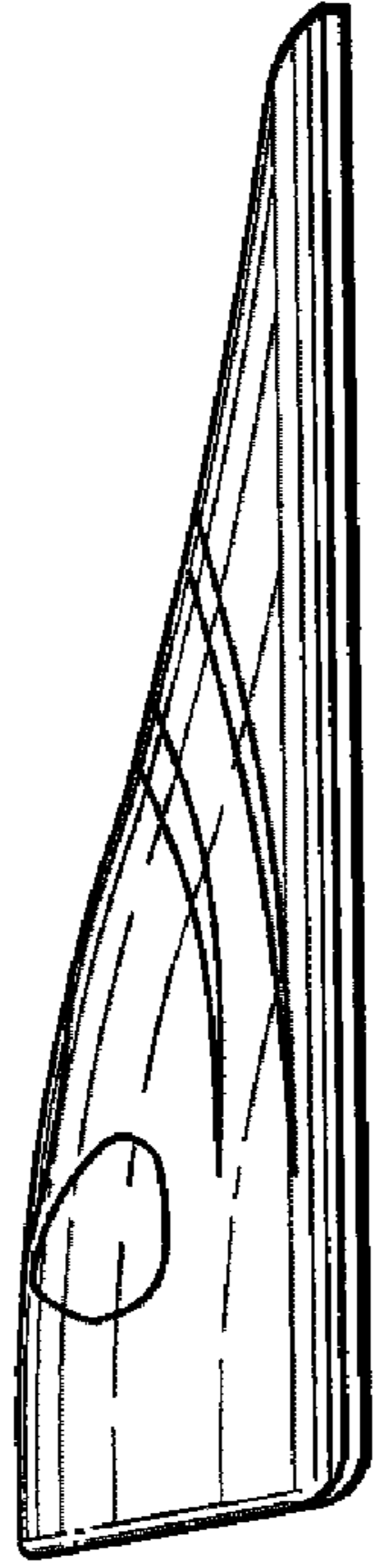

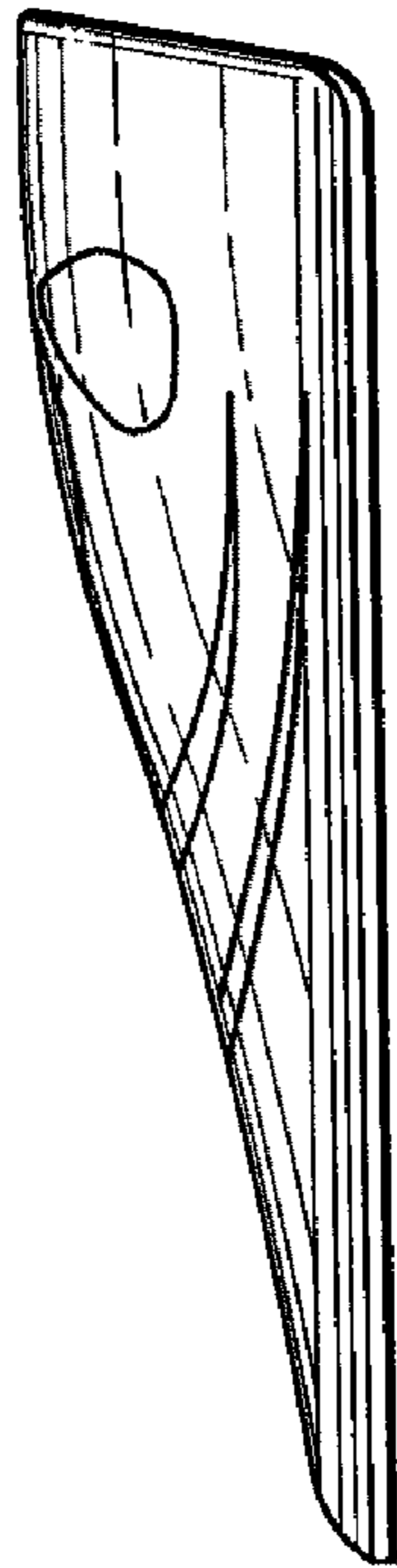

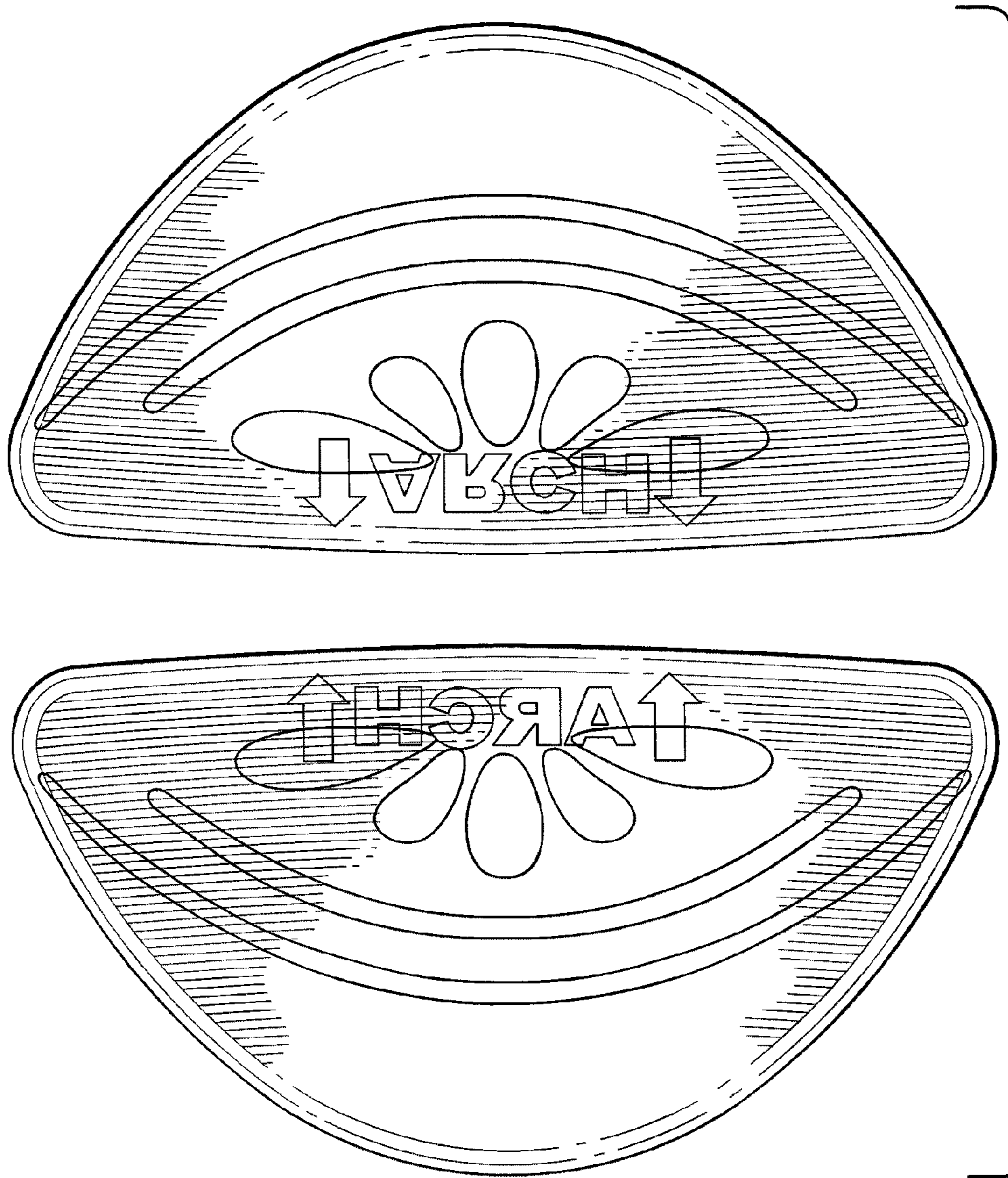

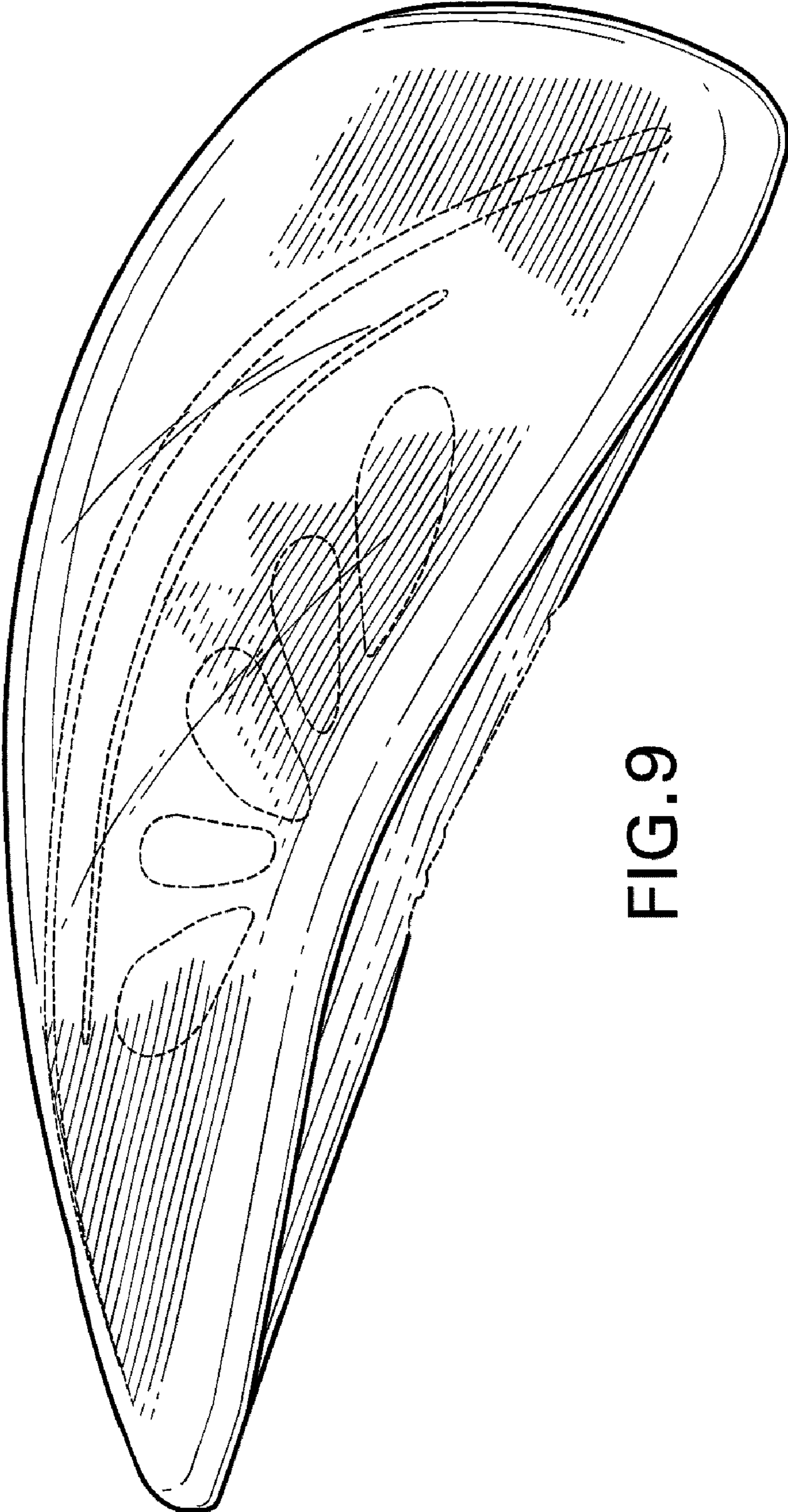

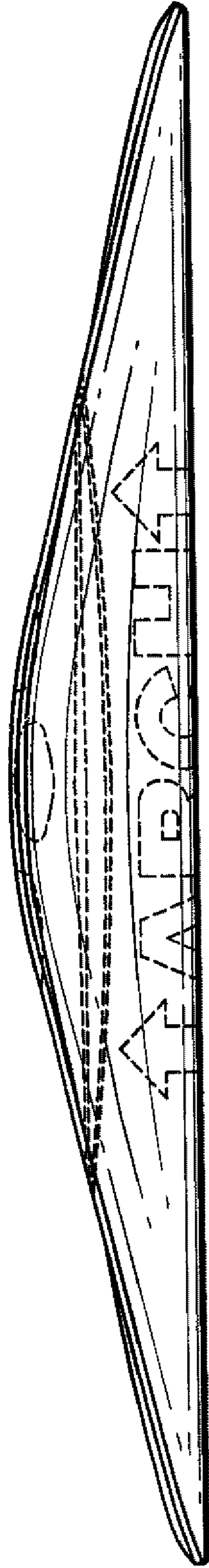

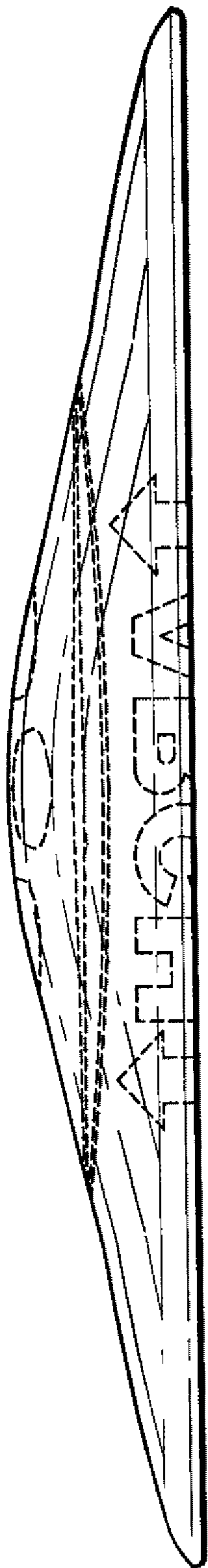

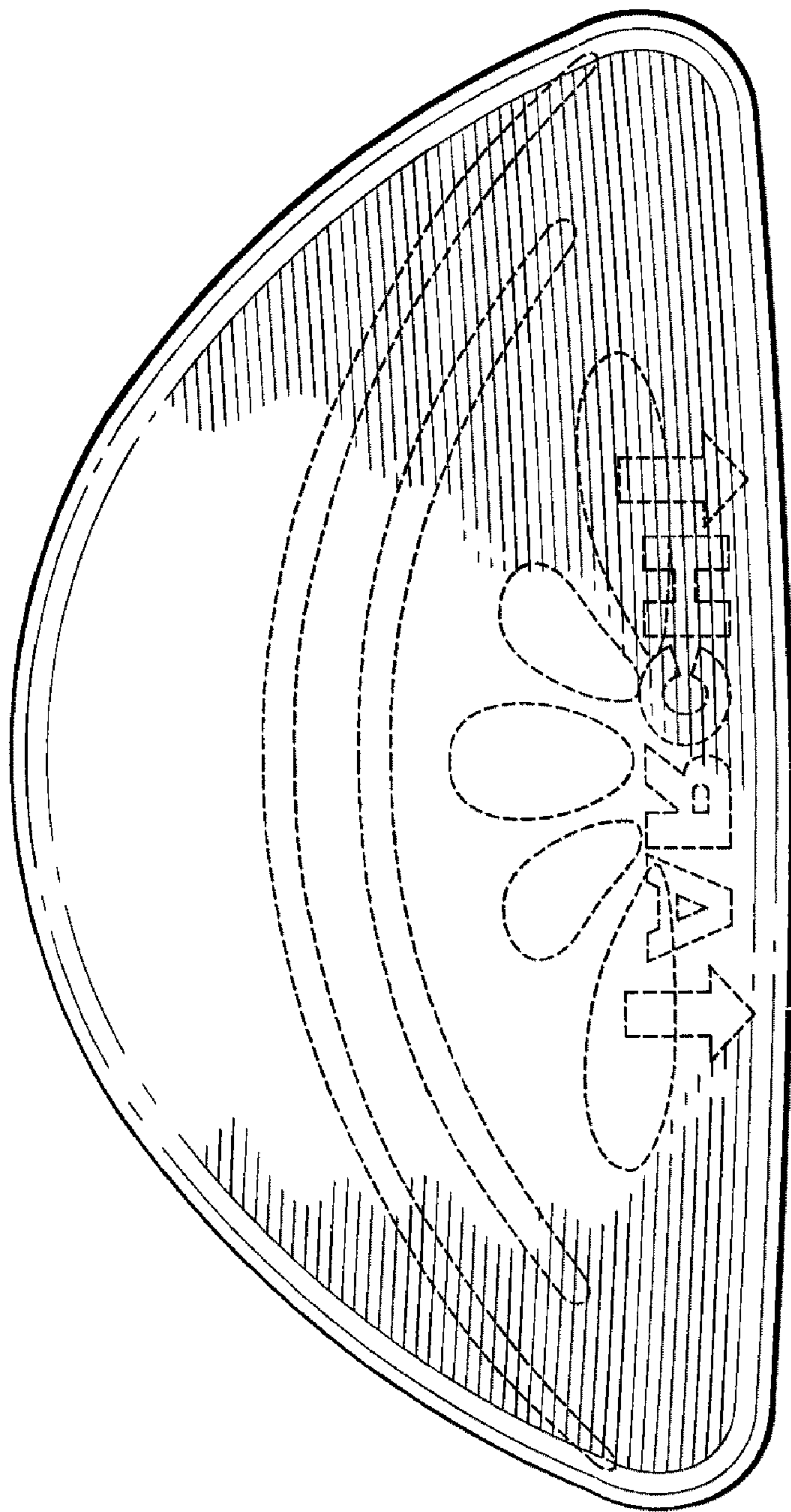

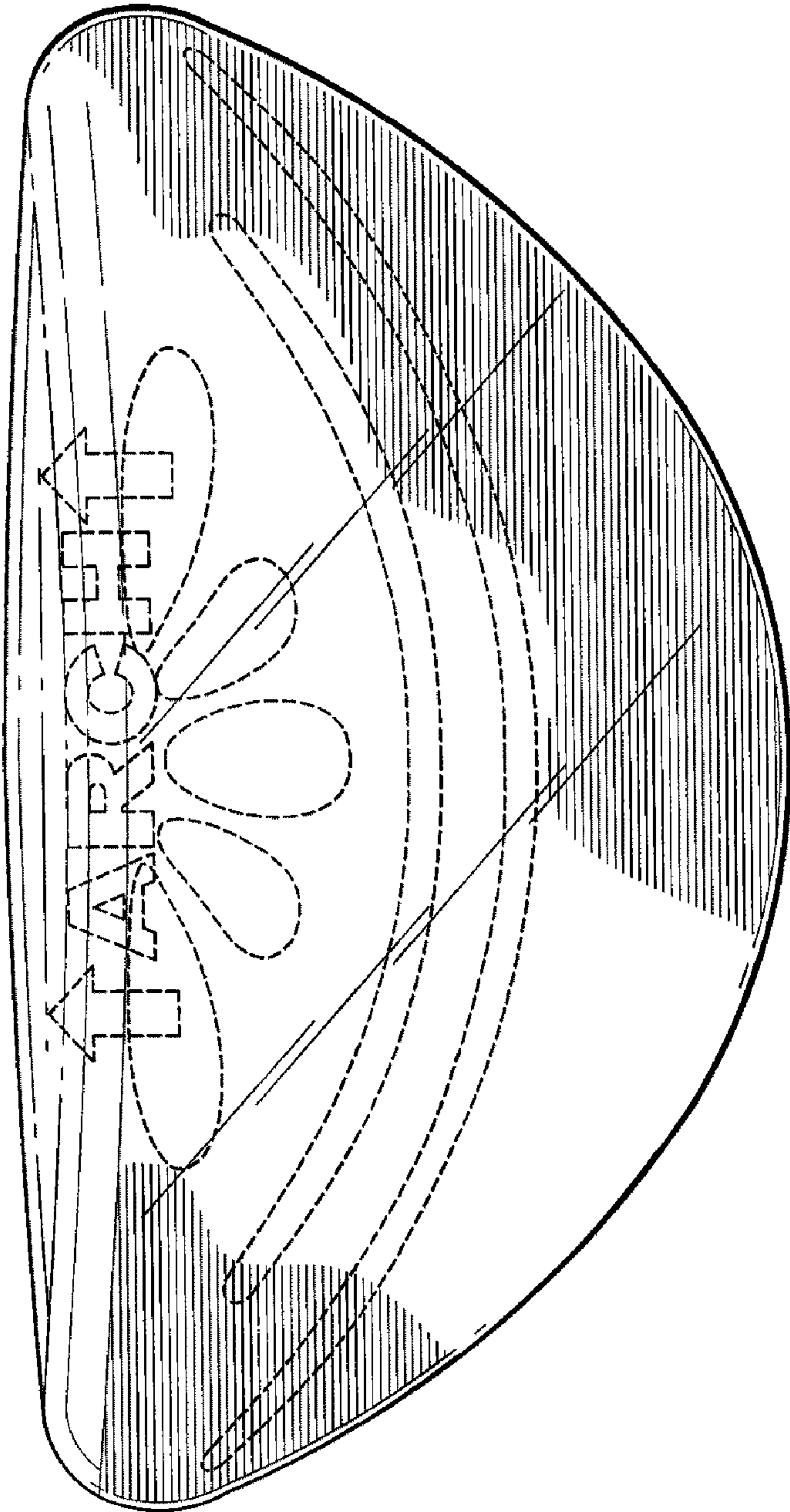

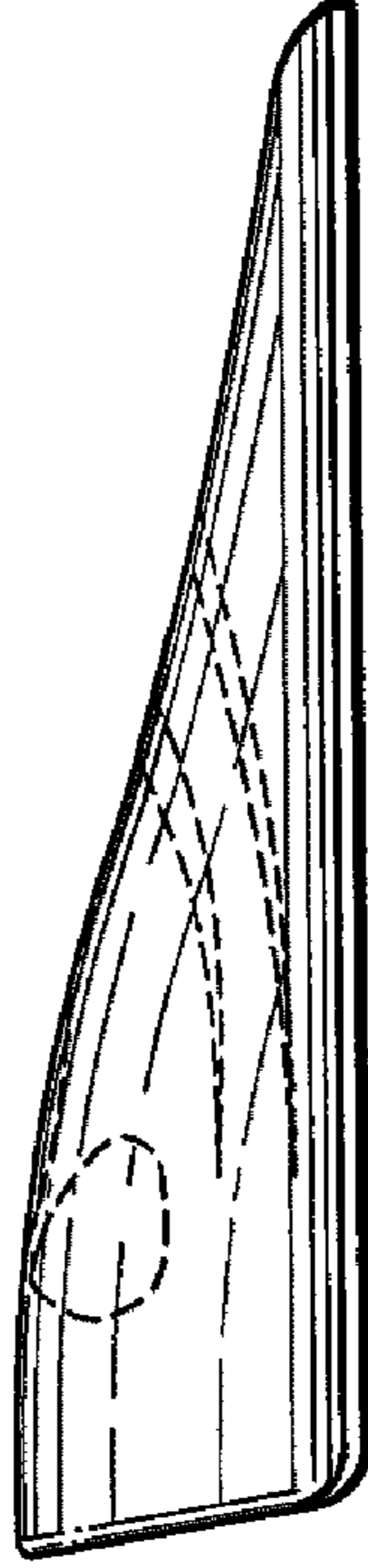

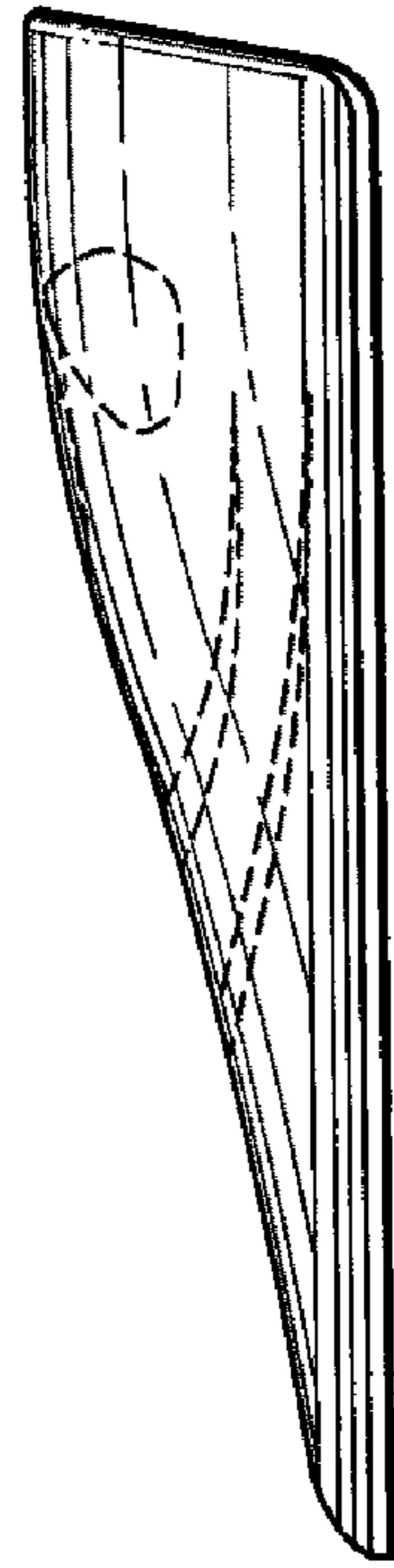

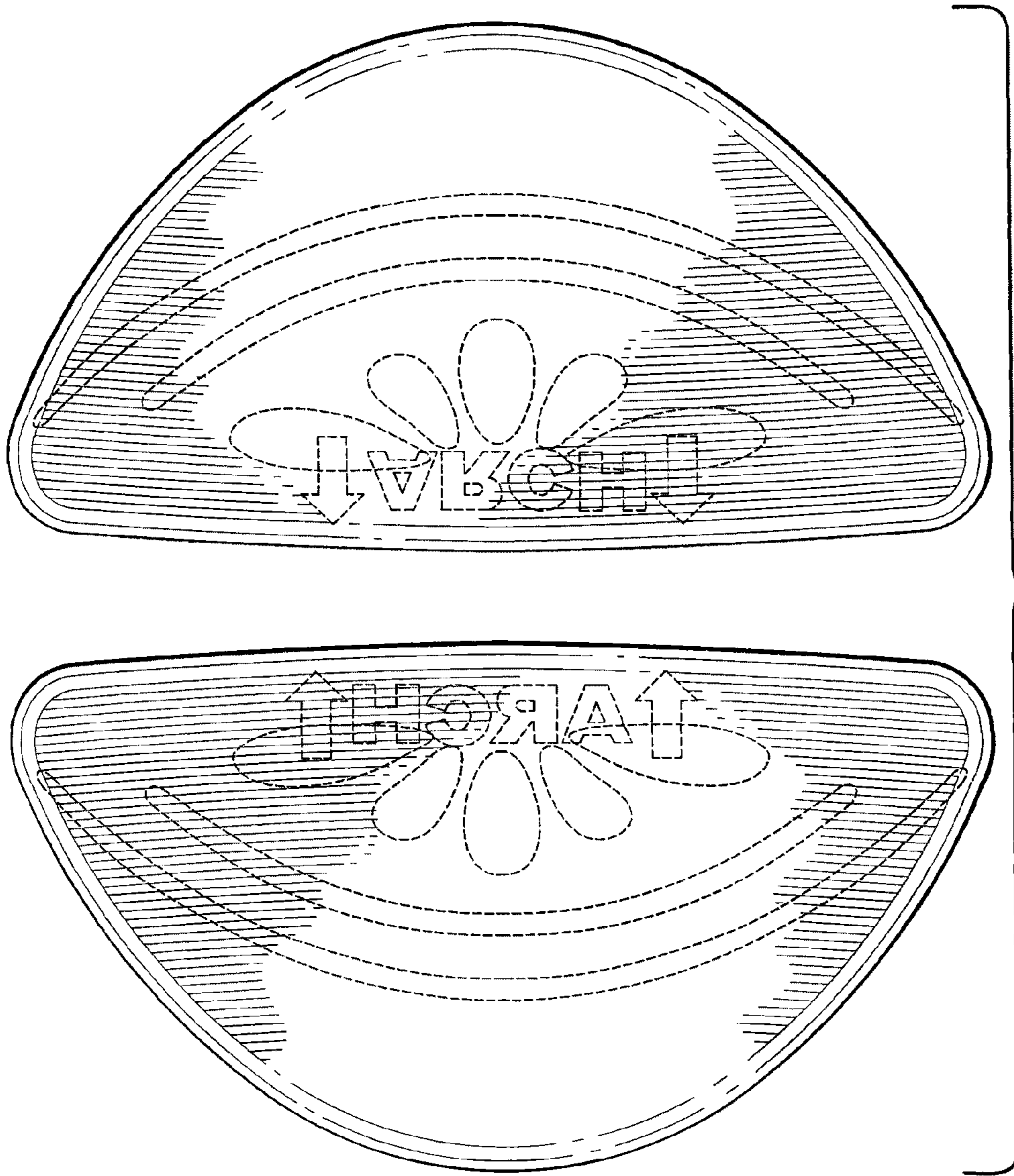
