(57) **CLAIM**

What is claimed is the ornamental design for a pair of socks, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pair of socks, showing the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left-side elevational view of a left sock thereof;

FIG. 6 is a right-side elevational view of the left sock;

FIG. 7 is a right-side elevational view of a right sock thereof;

FIG. 8 is a left-side elevational view of the right sock; and,

FIG. 9 is a bottom plan view of the pair of socks.

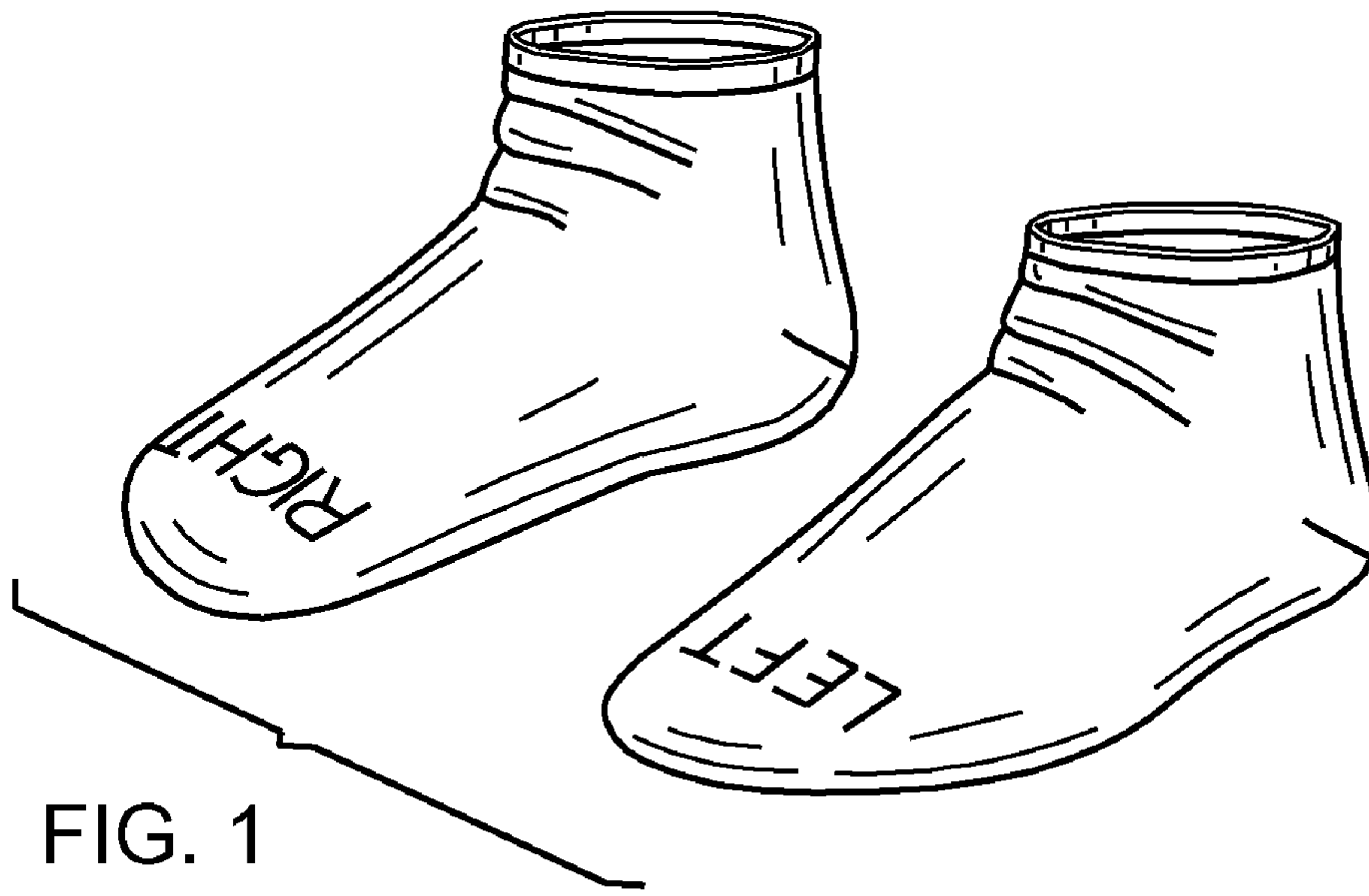

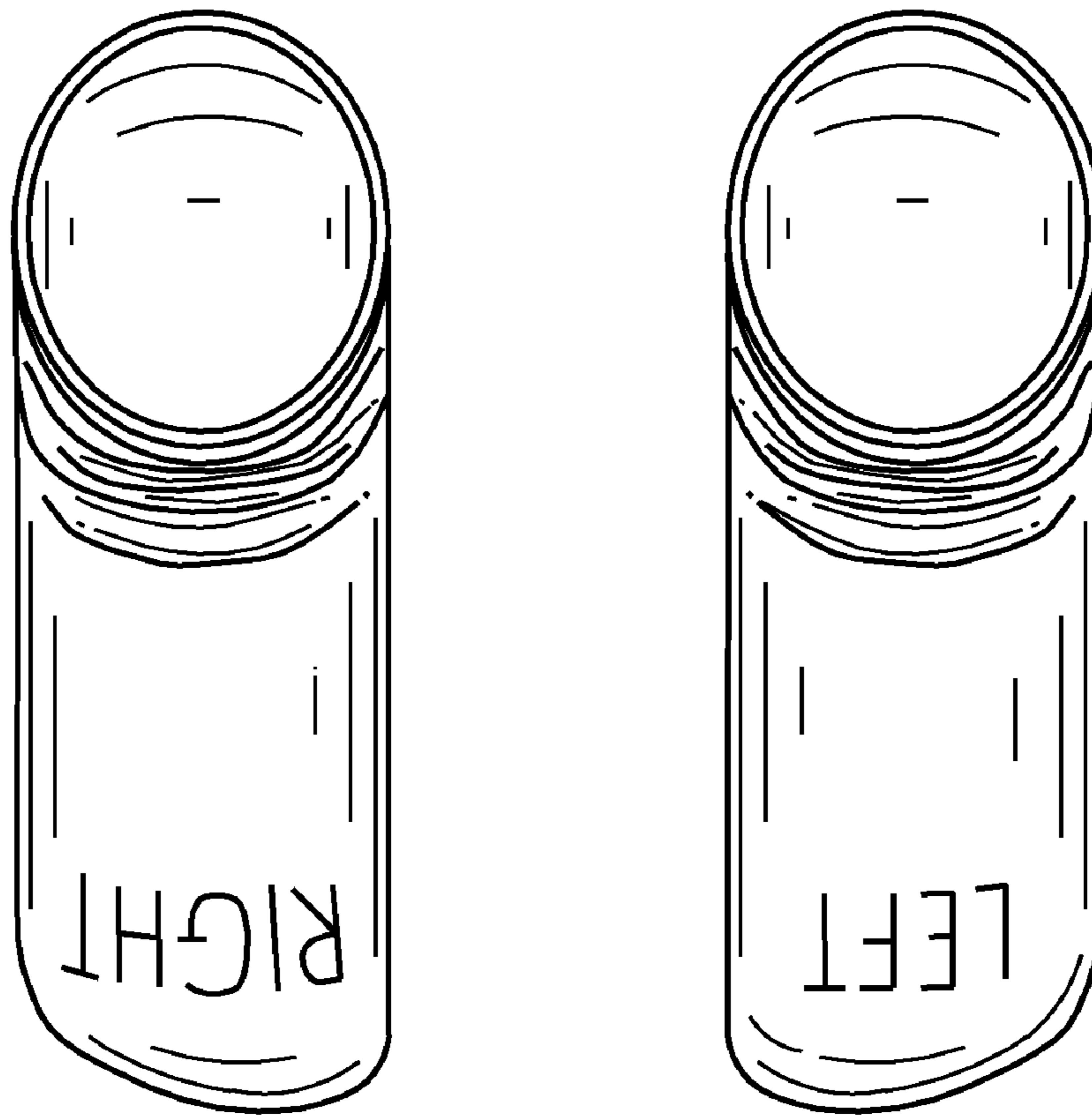

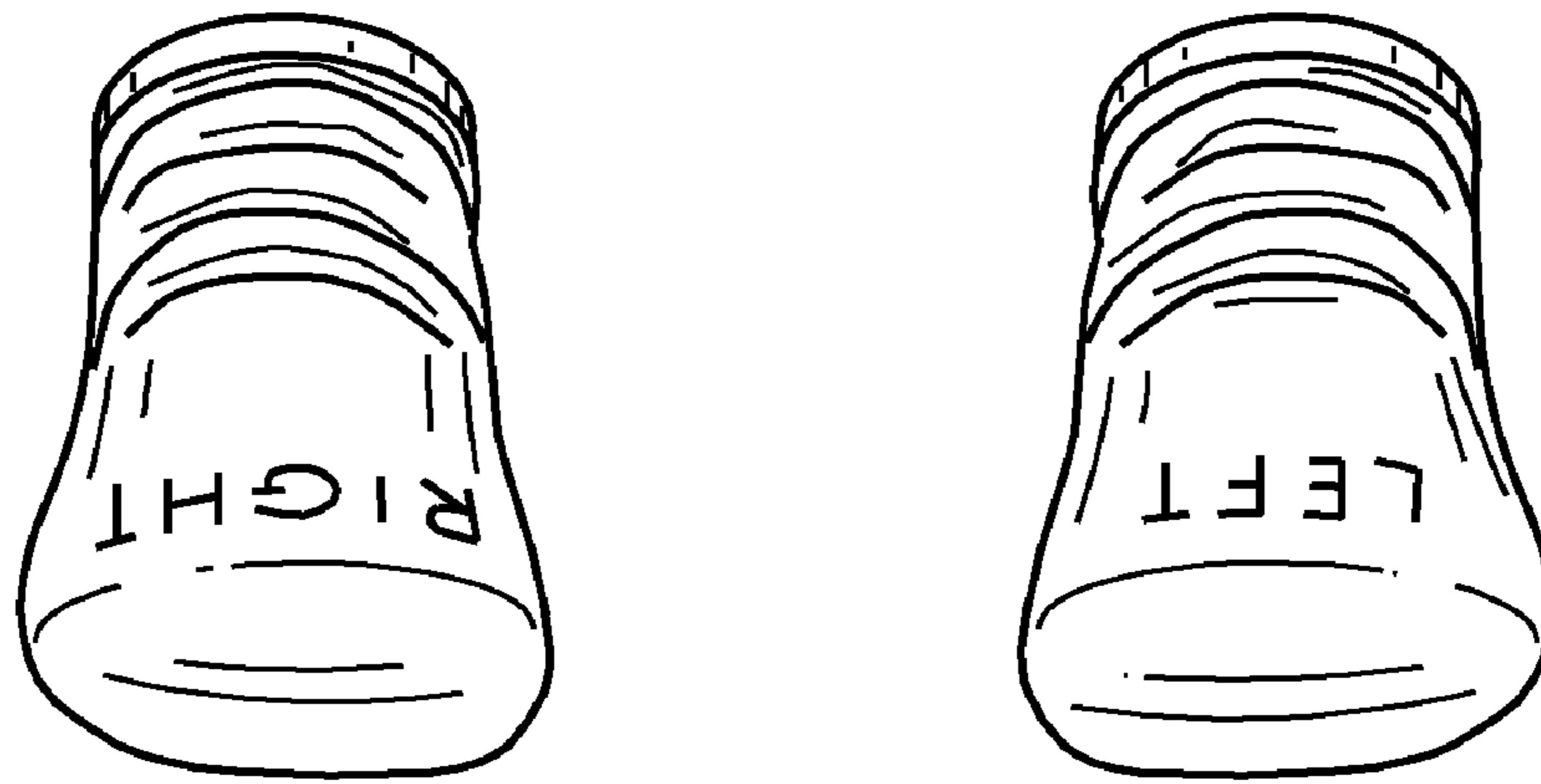

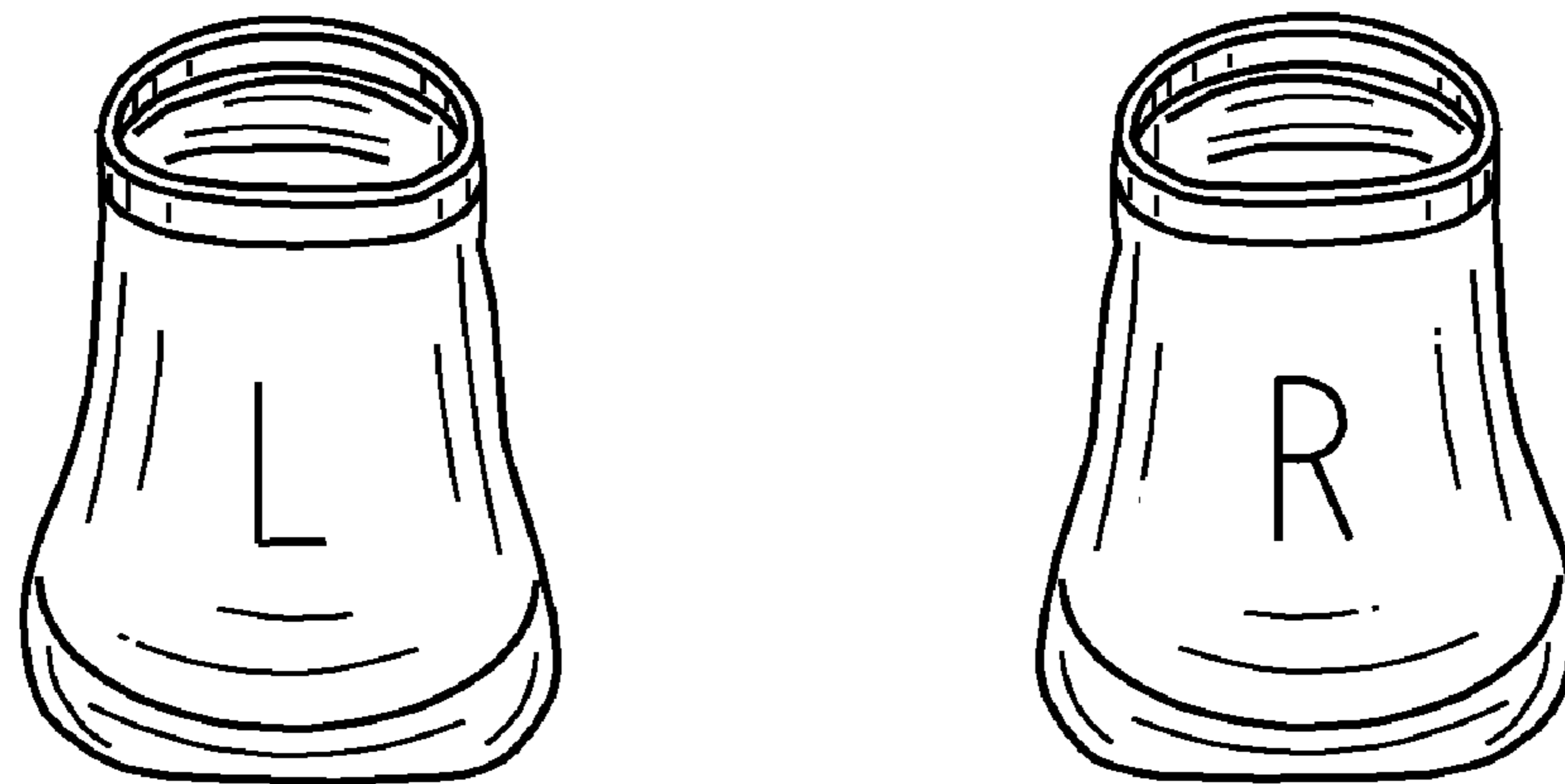

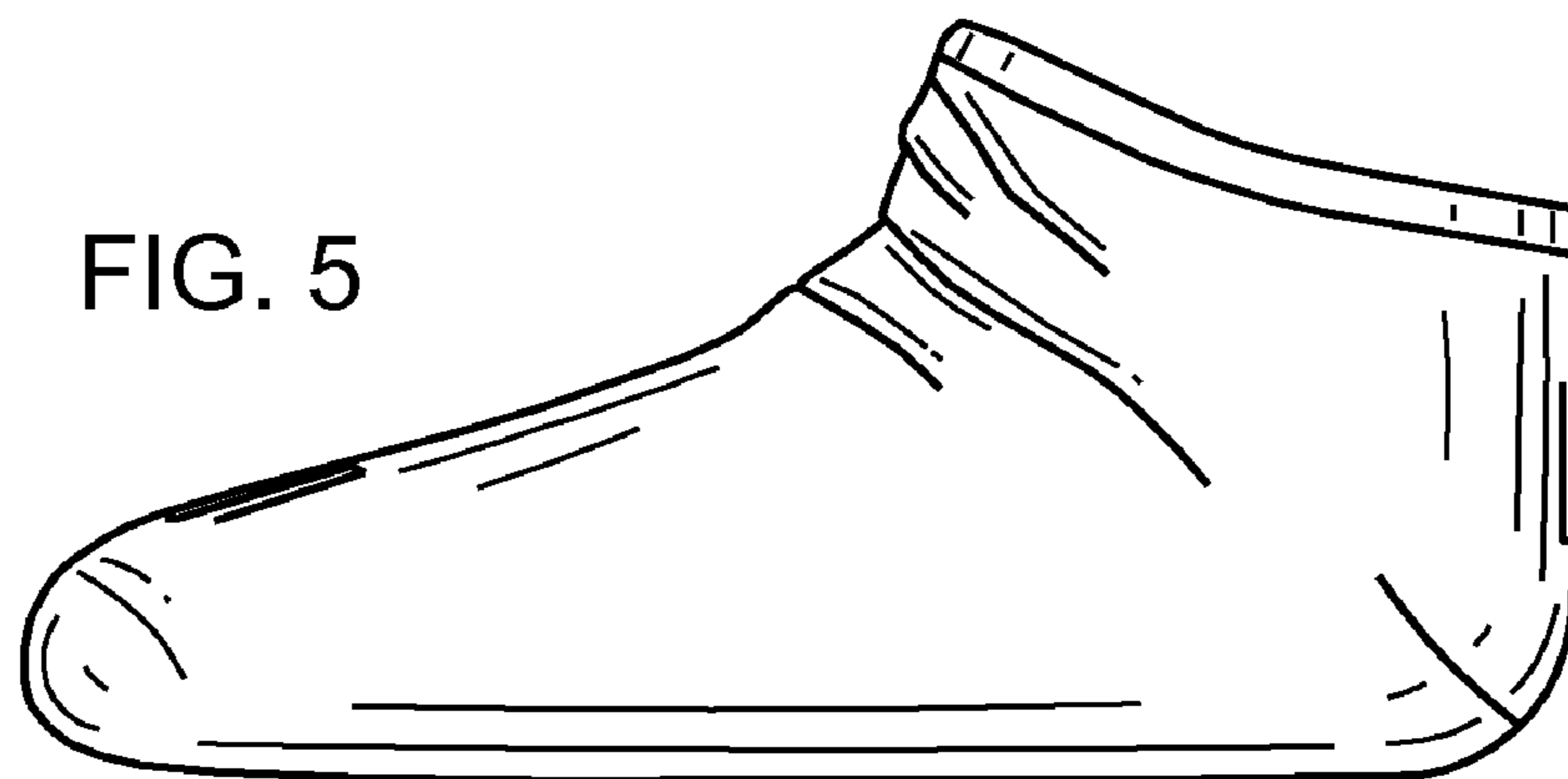

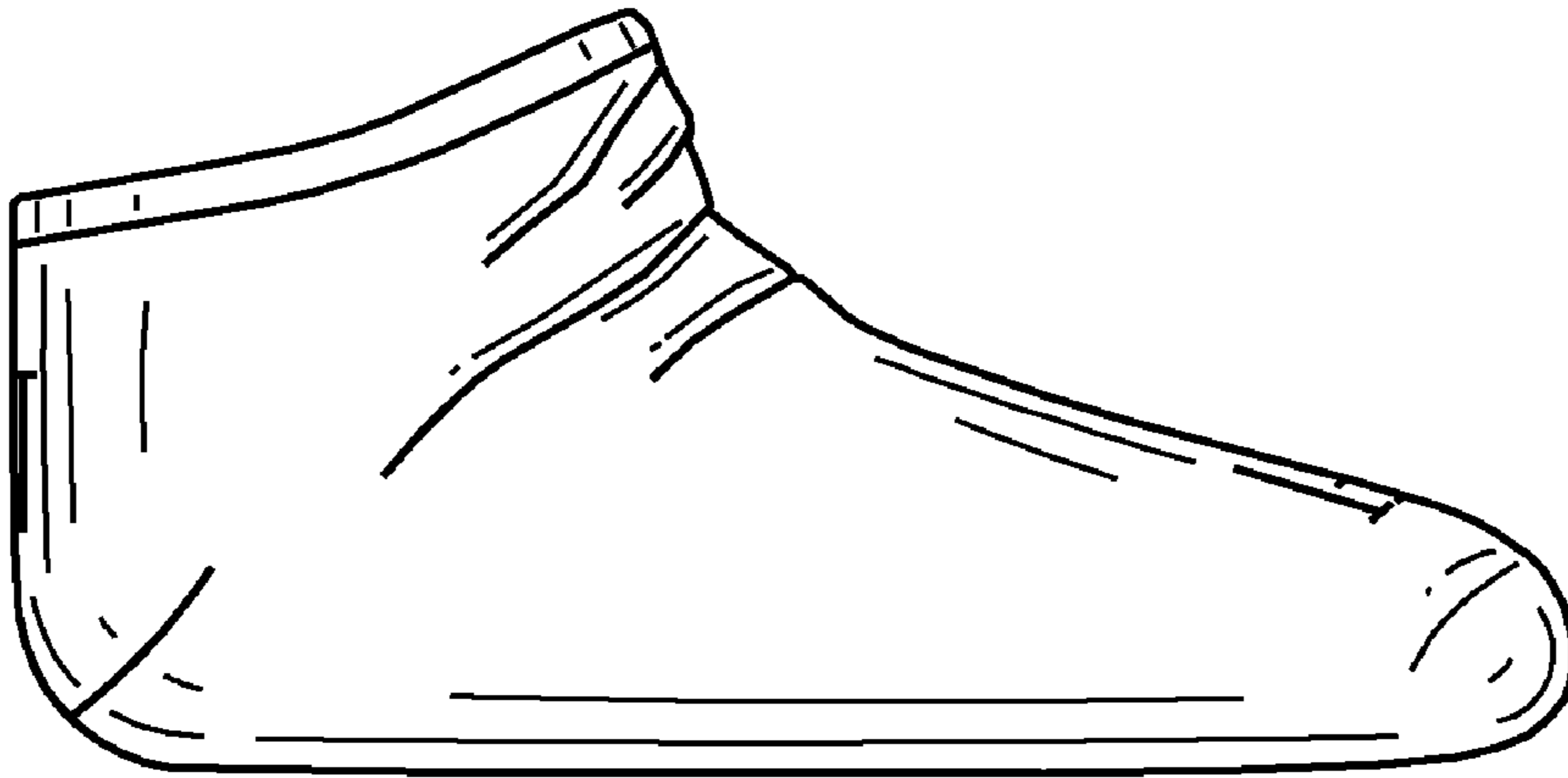

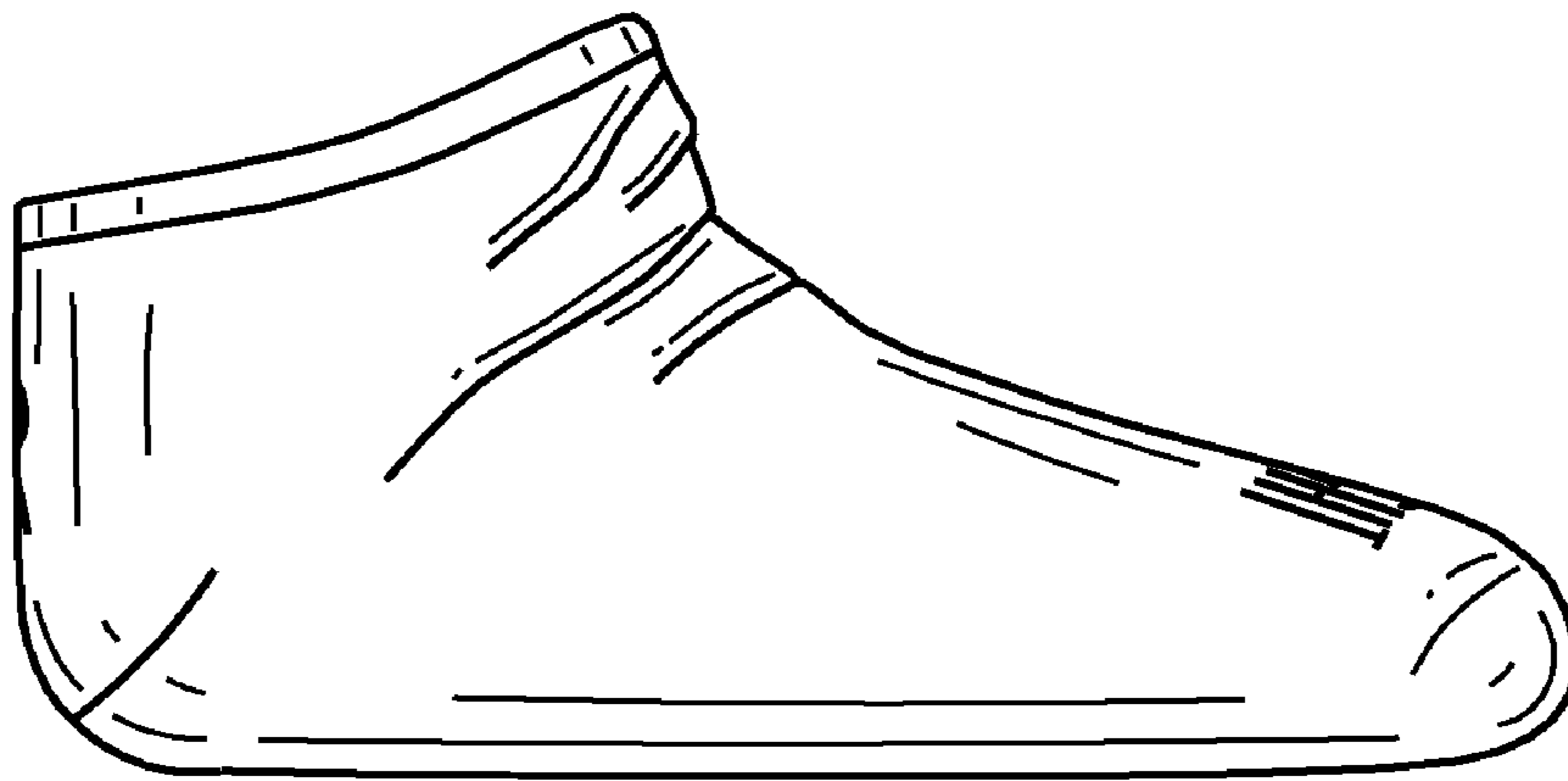

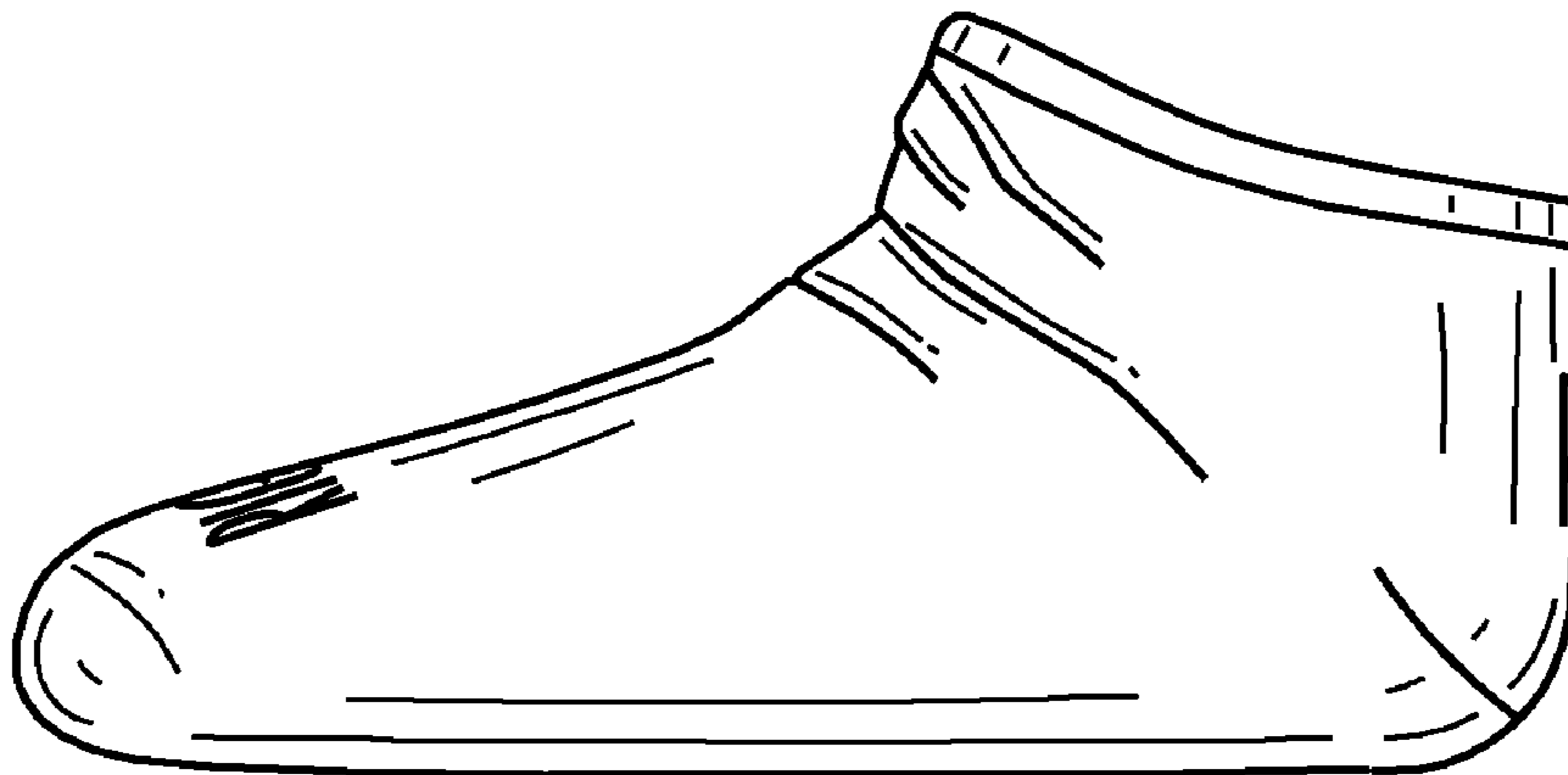

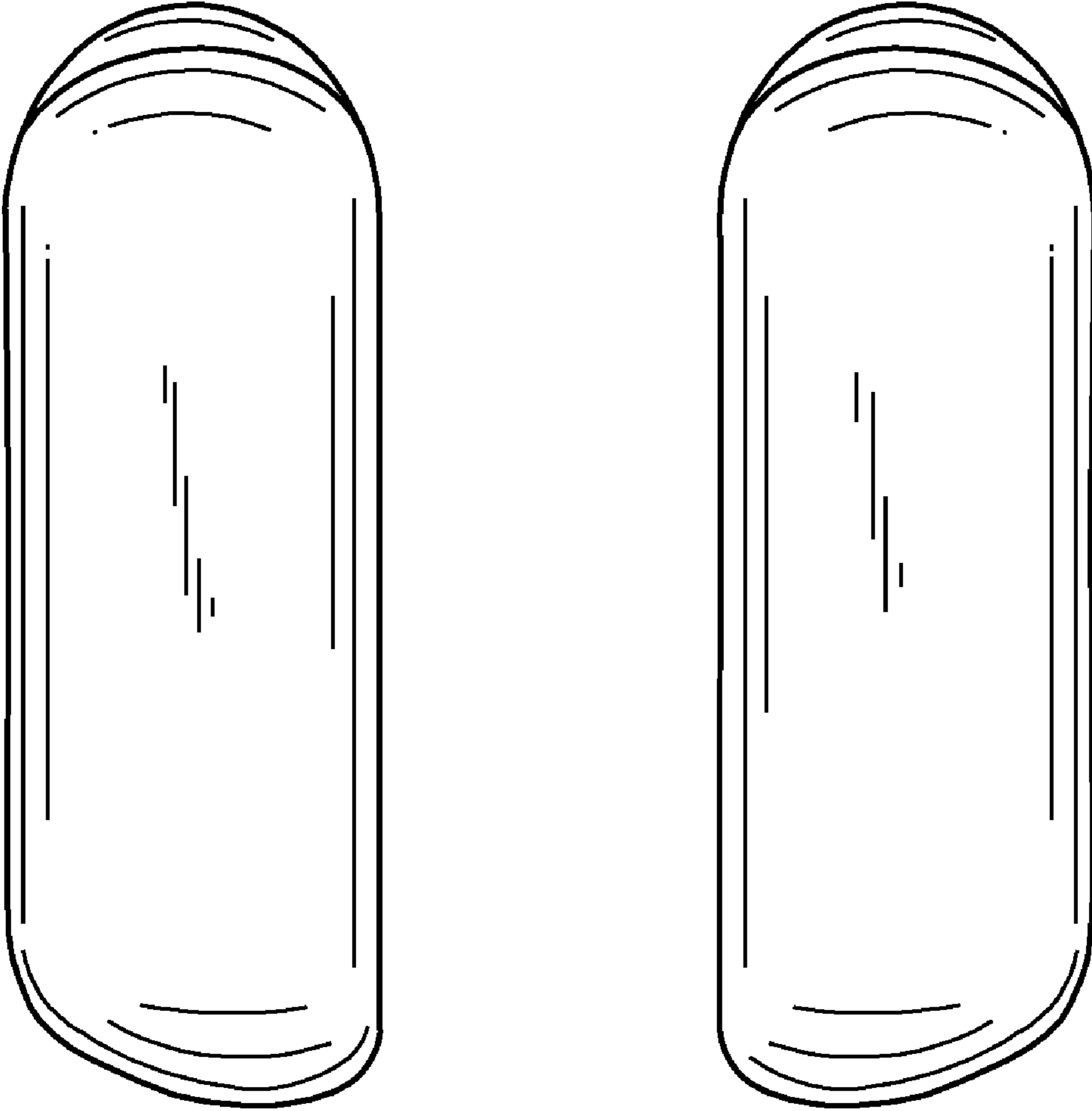
