ture of FIG. 1.

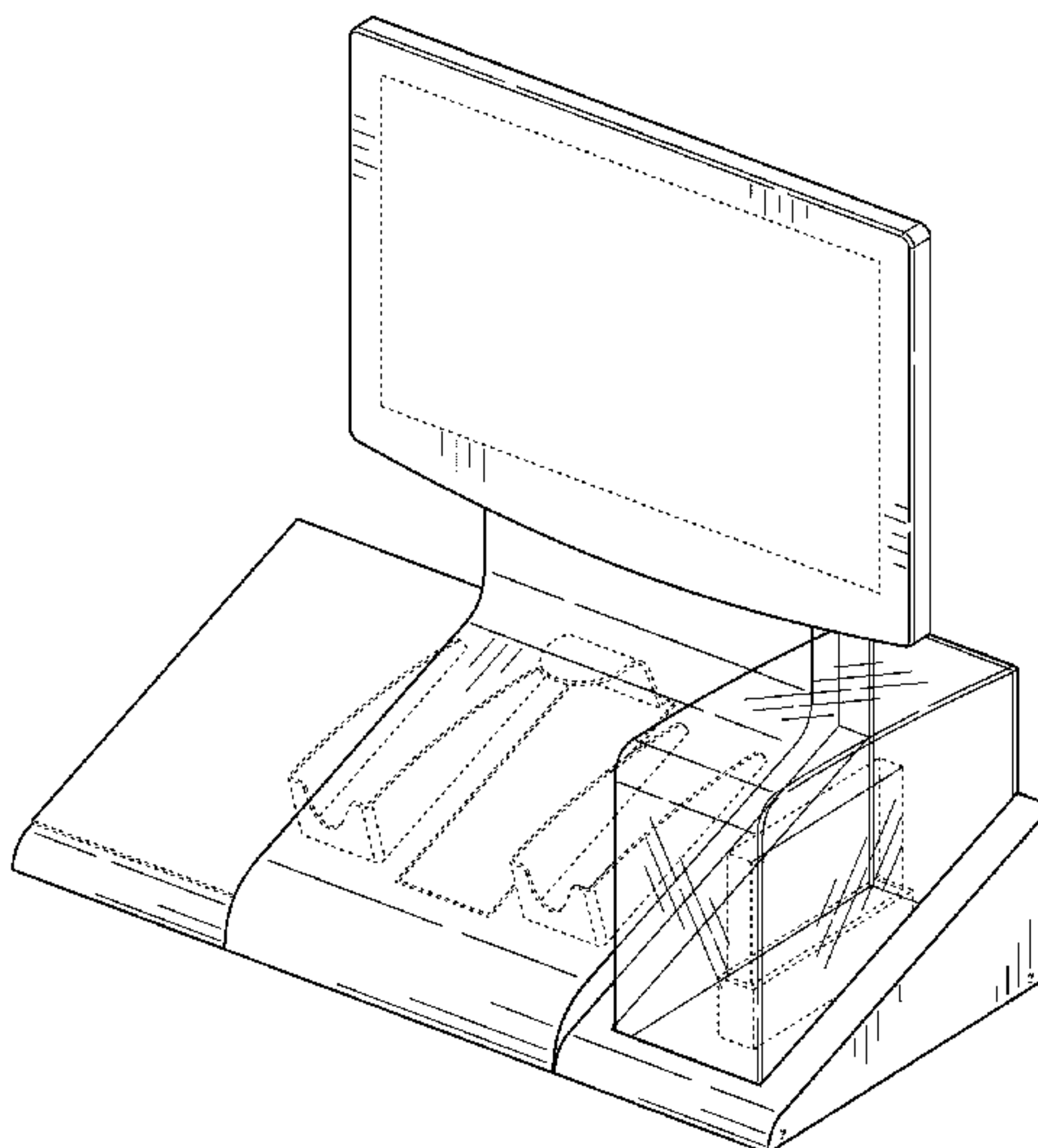

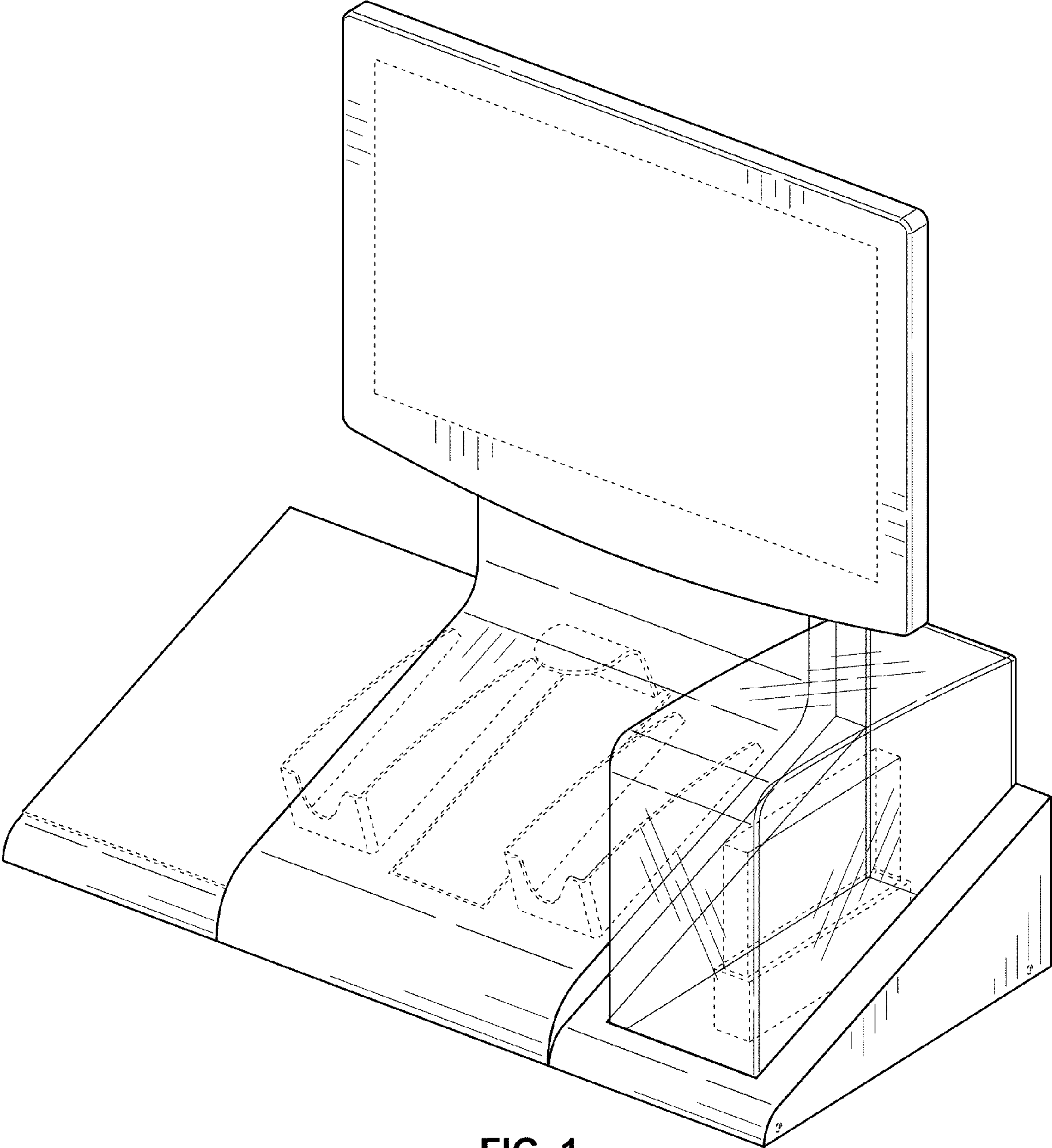

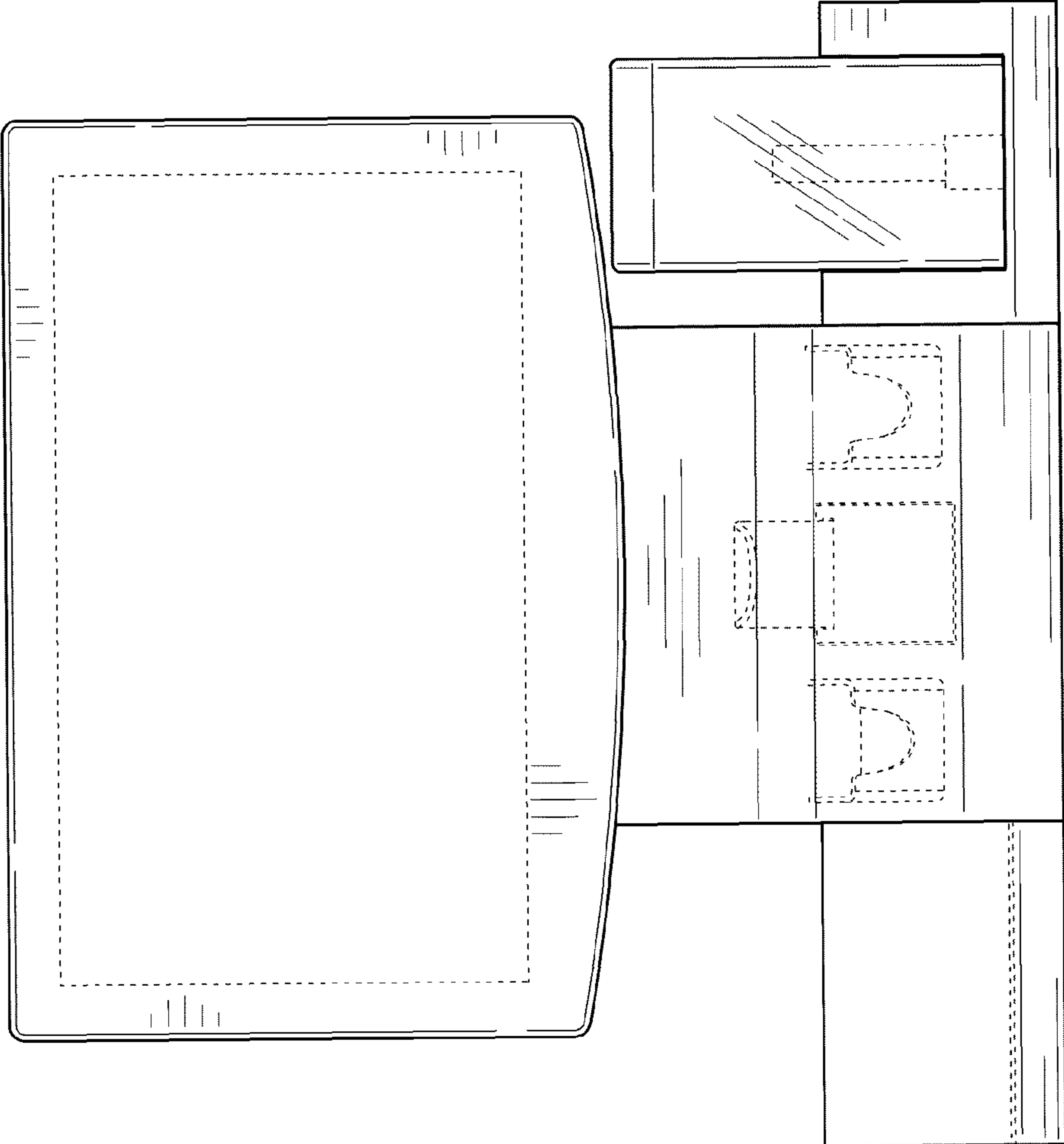

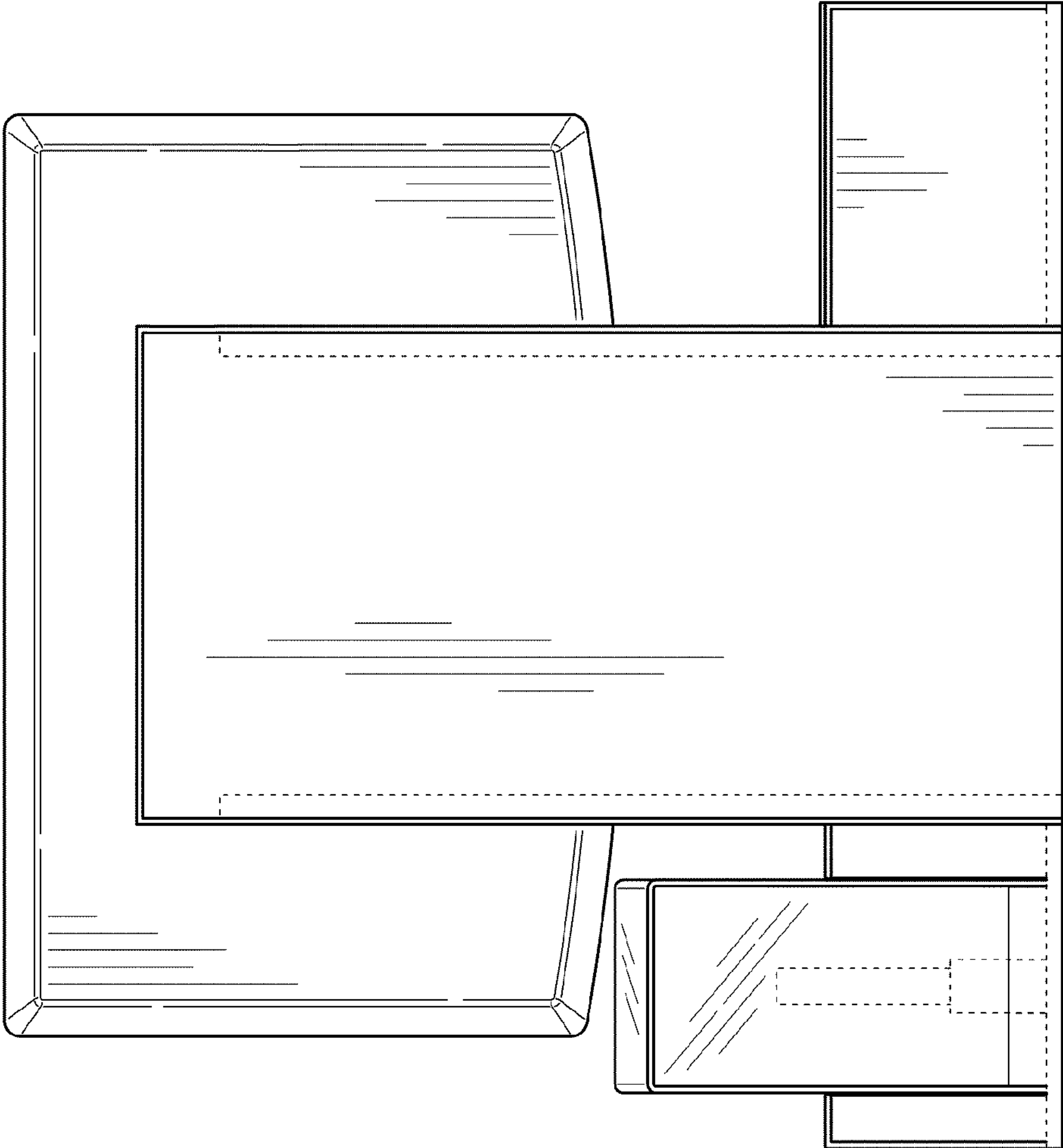

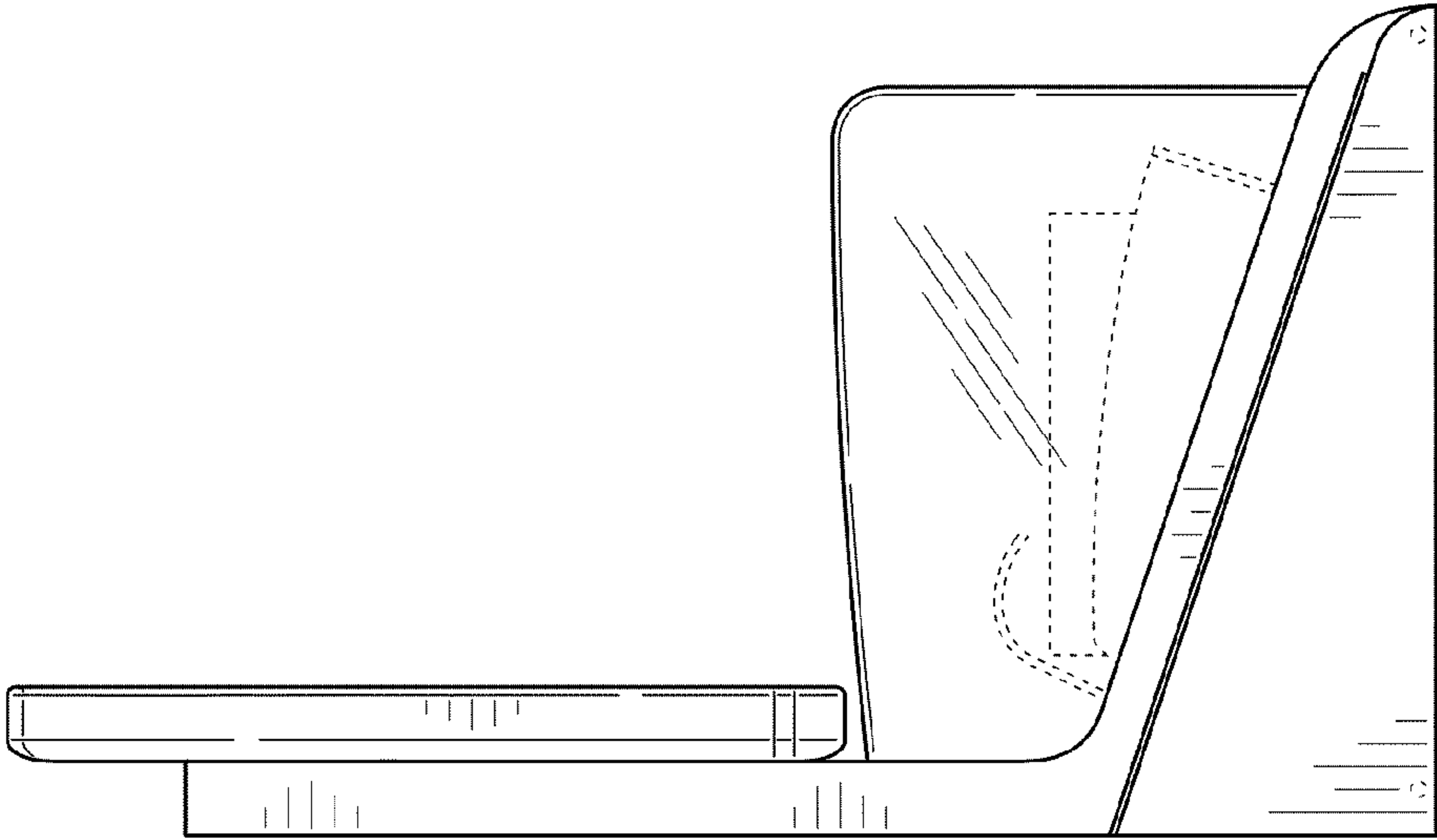

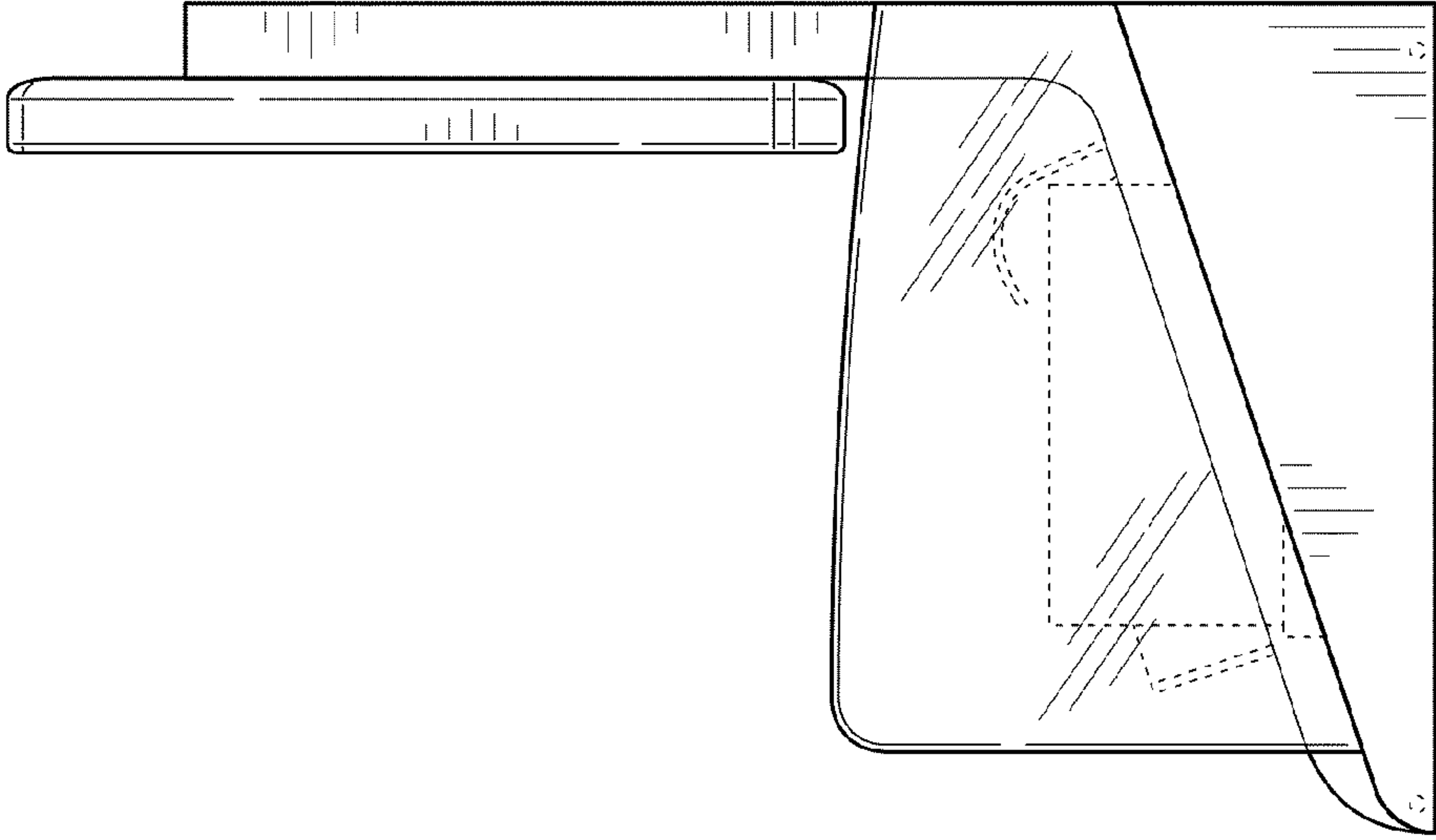

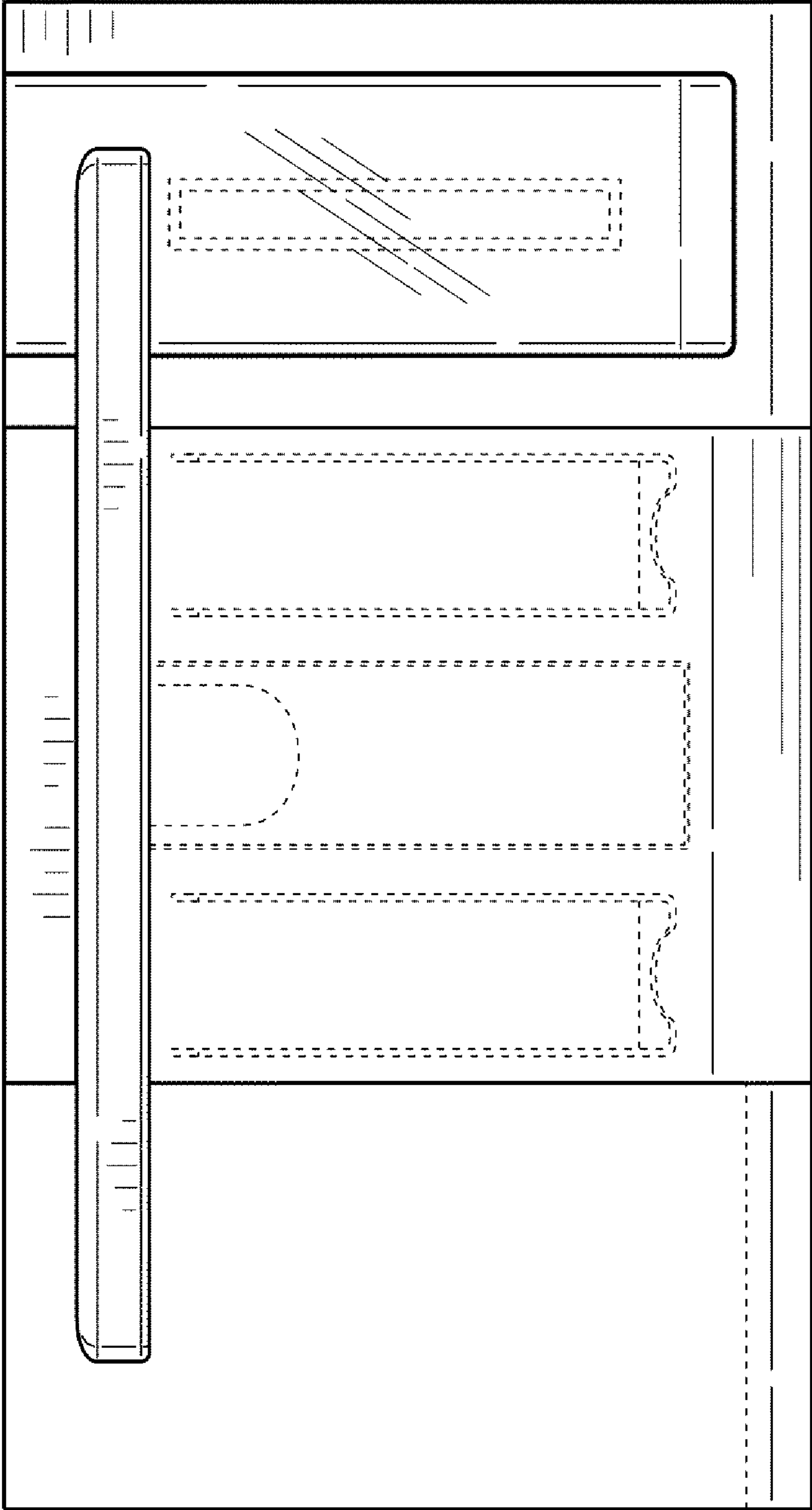

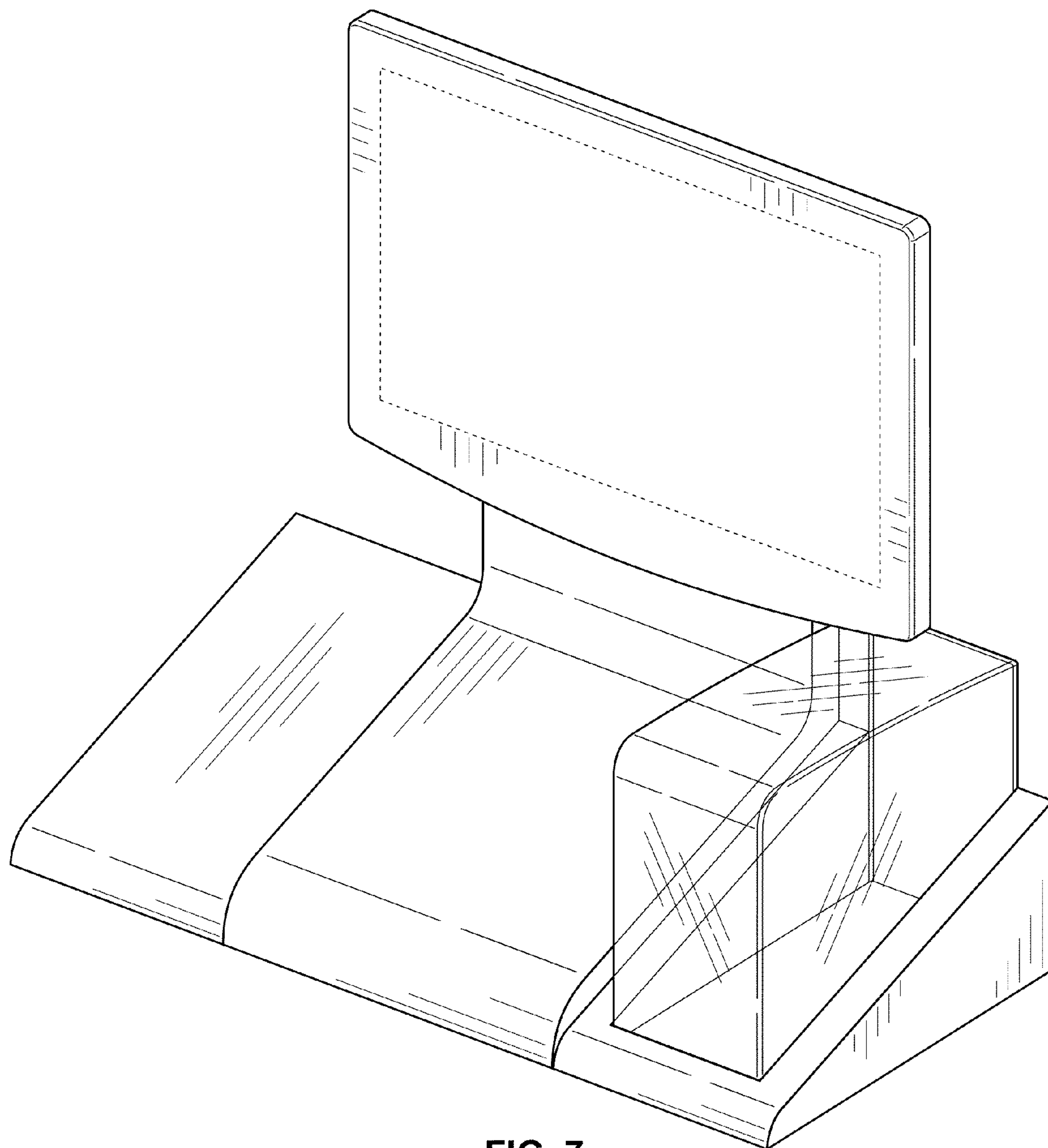
