(57) **CLAIM**

The ornamental design for a multi-steamer assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a preferred embodiment of the multi-steamer assembly in an assembled form;

FIG. 2 is a top view of the multi-steamer assembly shown in FIG. 1;

FIG. 3 is a cross-sectional view of the multi-steamer assembly taken through line 3—3 of shown in FIG. 2, in which no claim is made to the ornamental details shown under the handle and the bottom indicated in broken lines in FIG. 3;

FIG. 4 is an exploded perspective view of the multi-steamer assembly of FIG. 1 showing the top lid, the steamer plate, the steamer bowl and the bottom bowl;

FIG. 5 is a perspective view of the top lid of the multi-steamer assembly of FIG. 4, shown separately for completeness of illustration;

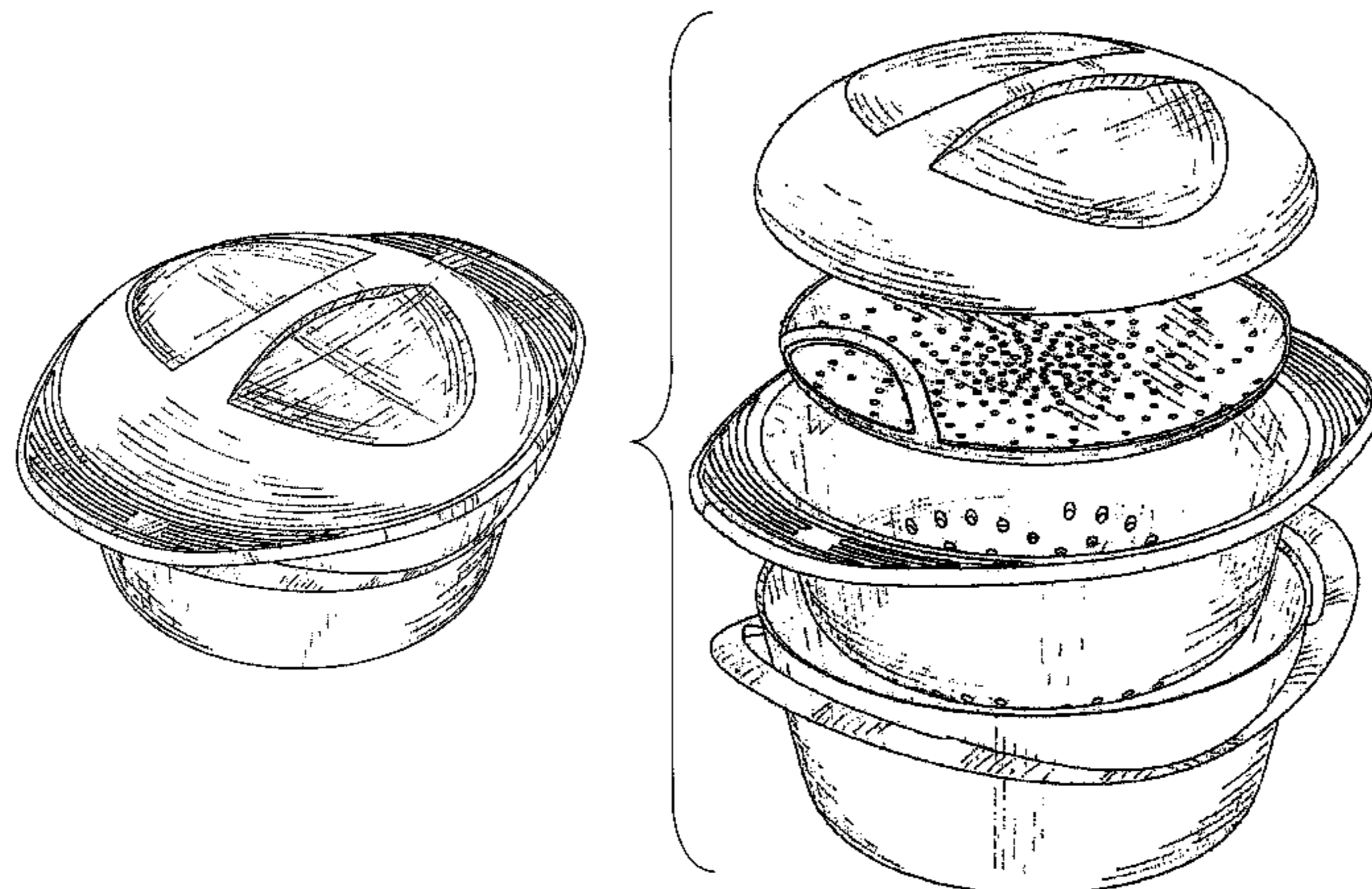
FIG. 6 is a perspective view of the steamer plate of the multi-steamer assembly of FIG. 4, shown separately for completeness of illustration;

FIG. 7 is a perspective view of the steamer bowl for the multi-steamer assembly of FIG. 4, shown separately for completeness of illustration; and,

FIG. 8 is a perspective view of the bottom bowl for the multi-steamer assembly of FIG. 4, shown separately for completeness of illustration.

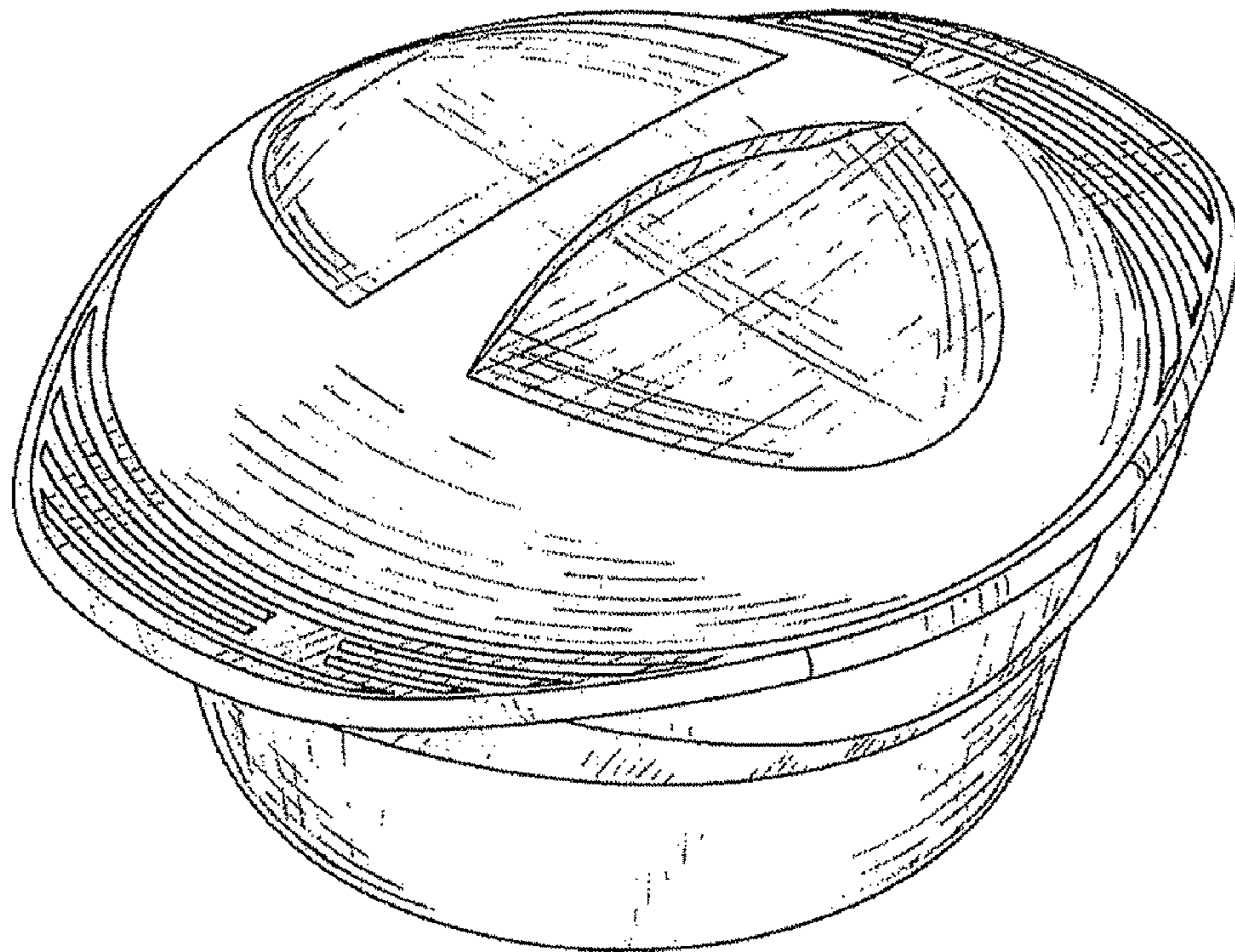

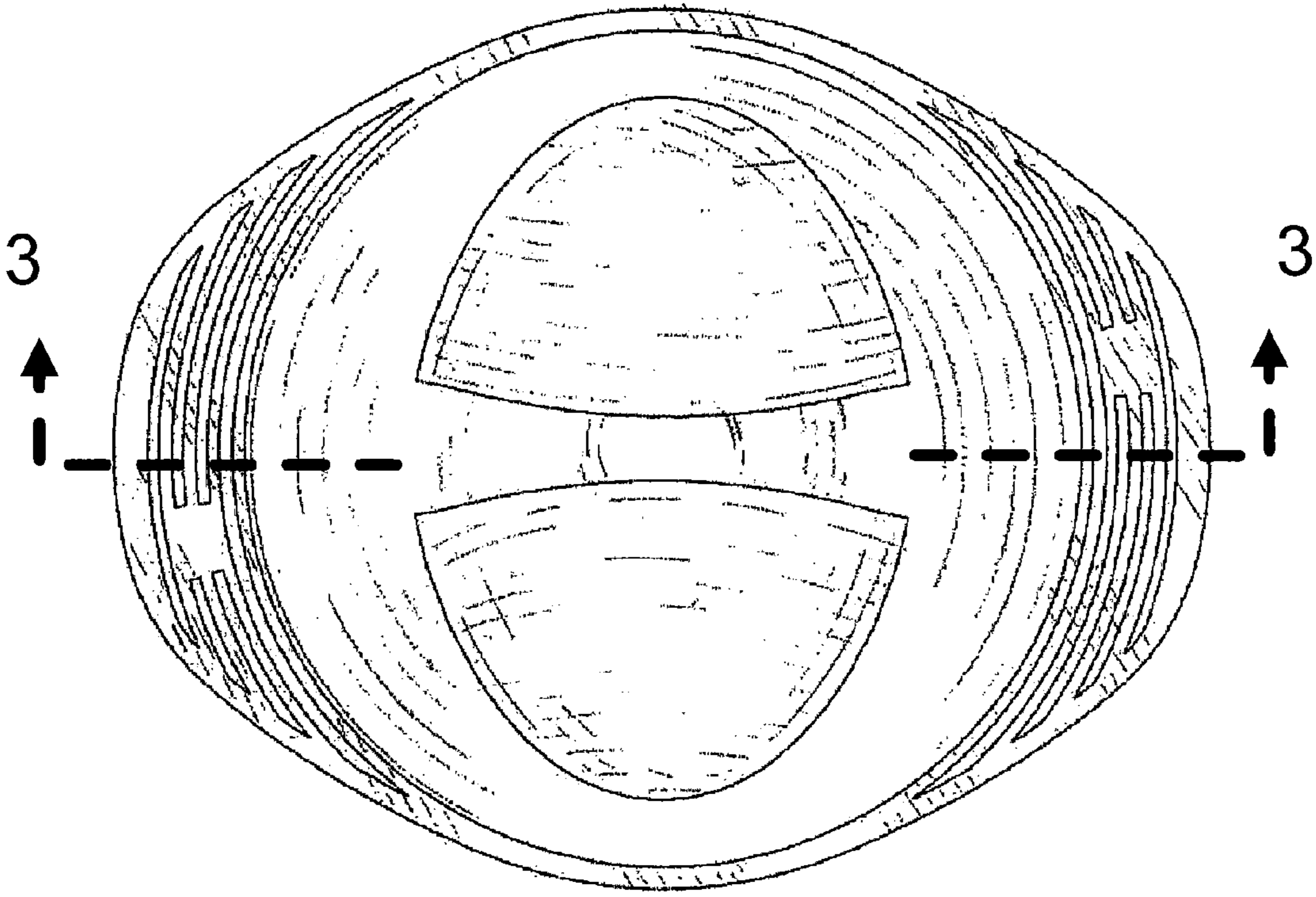

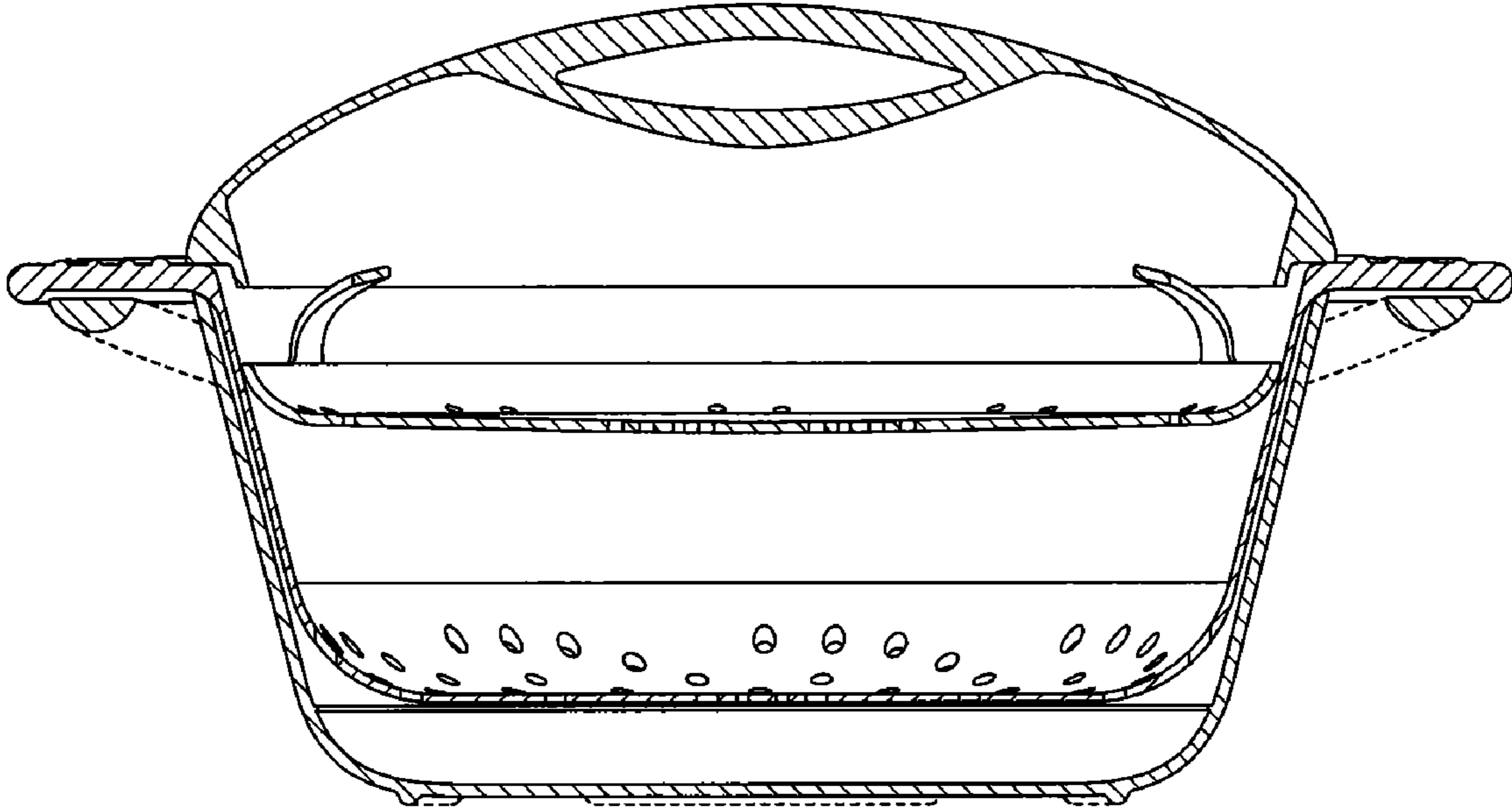

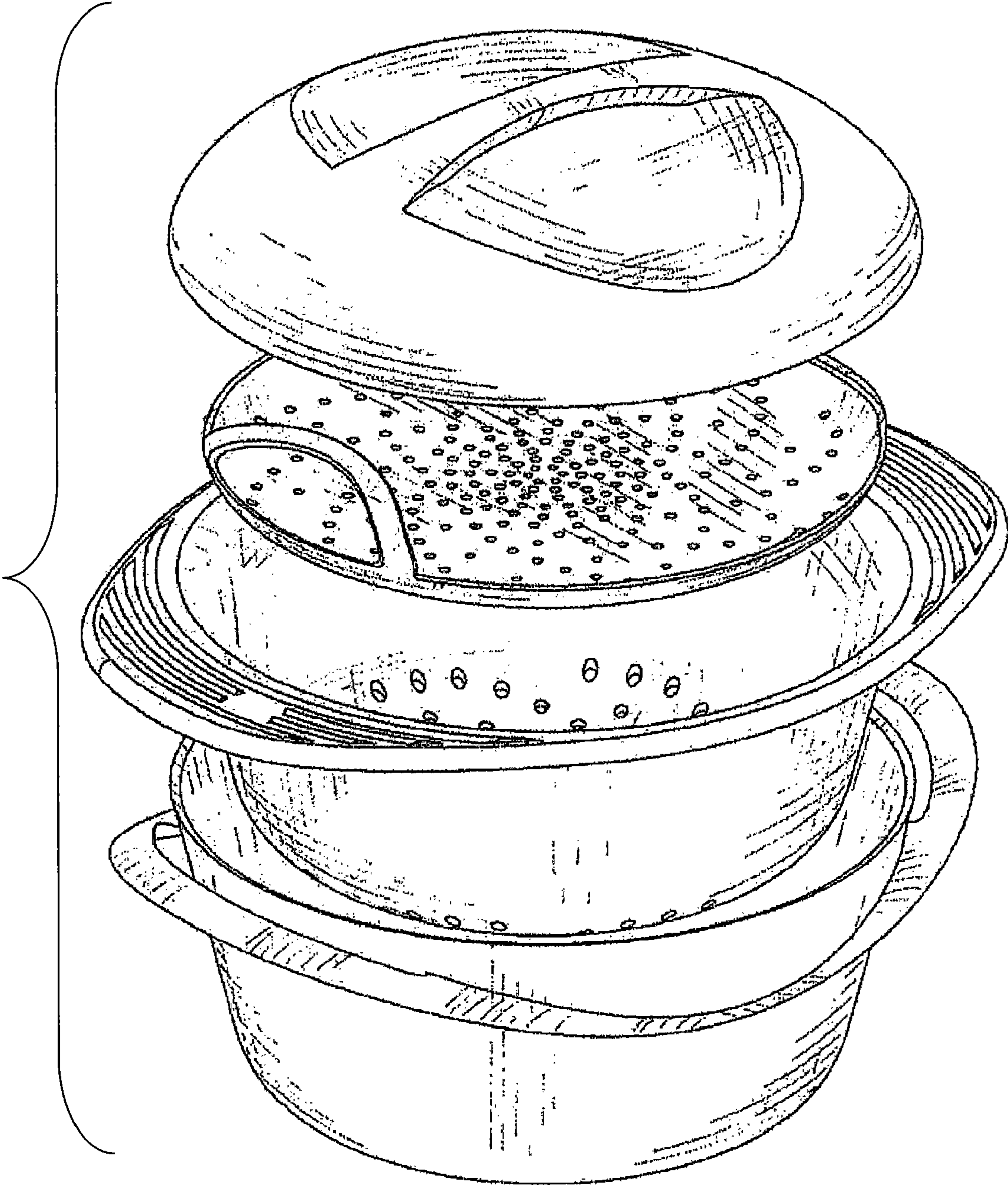

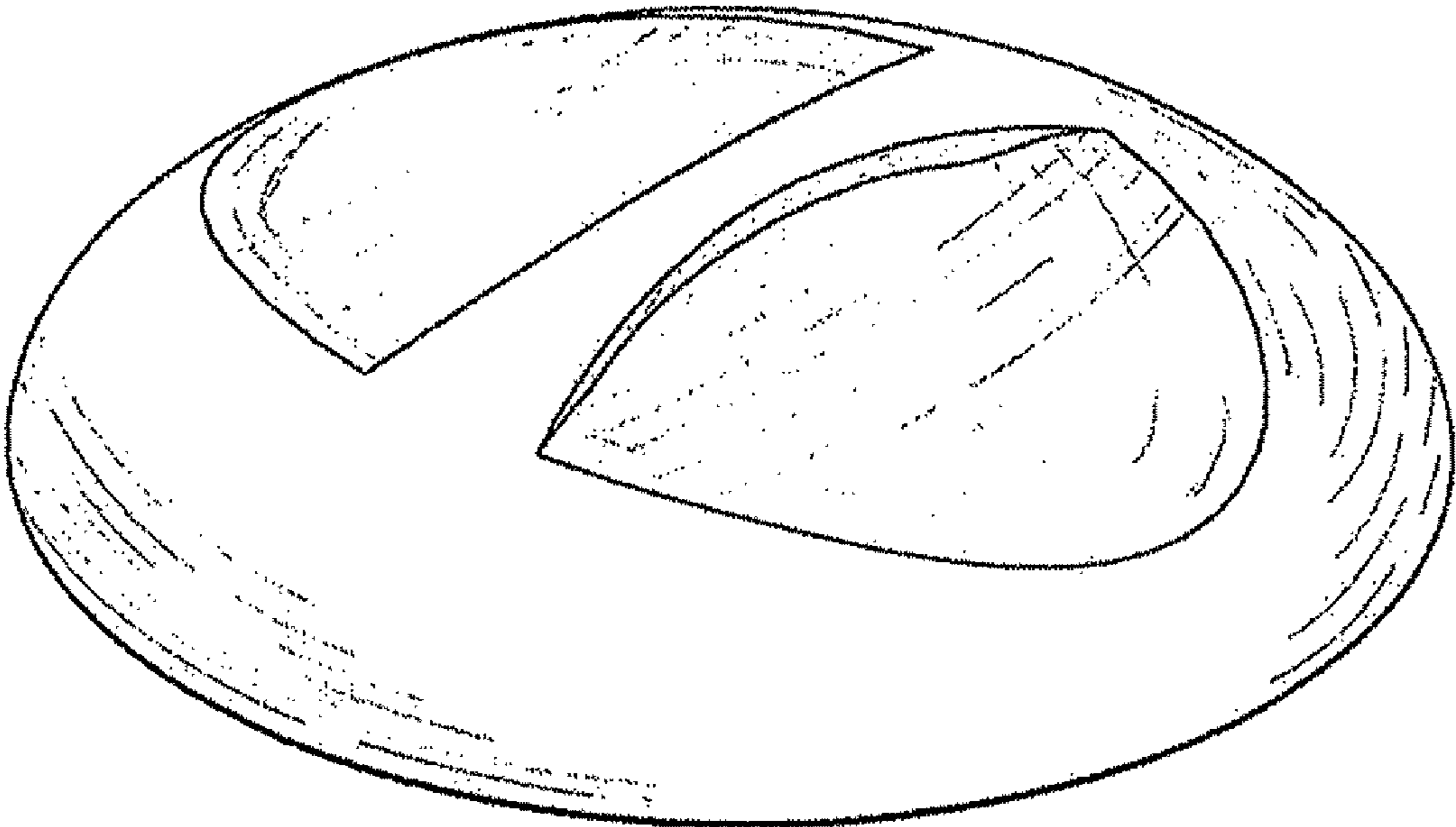

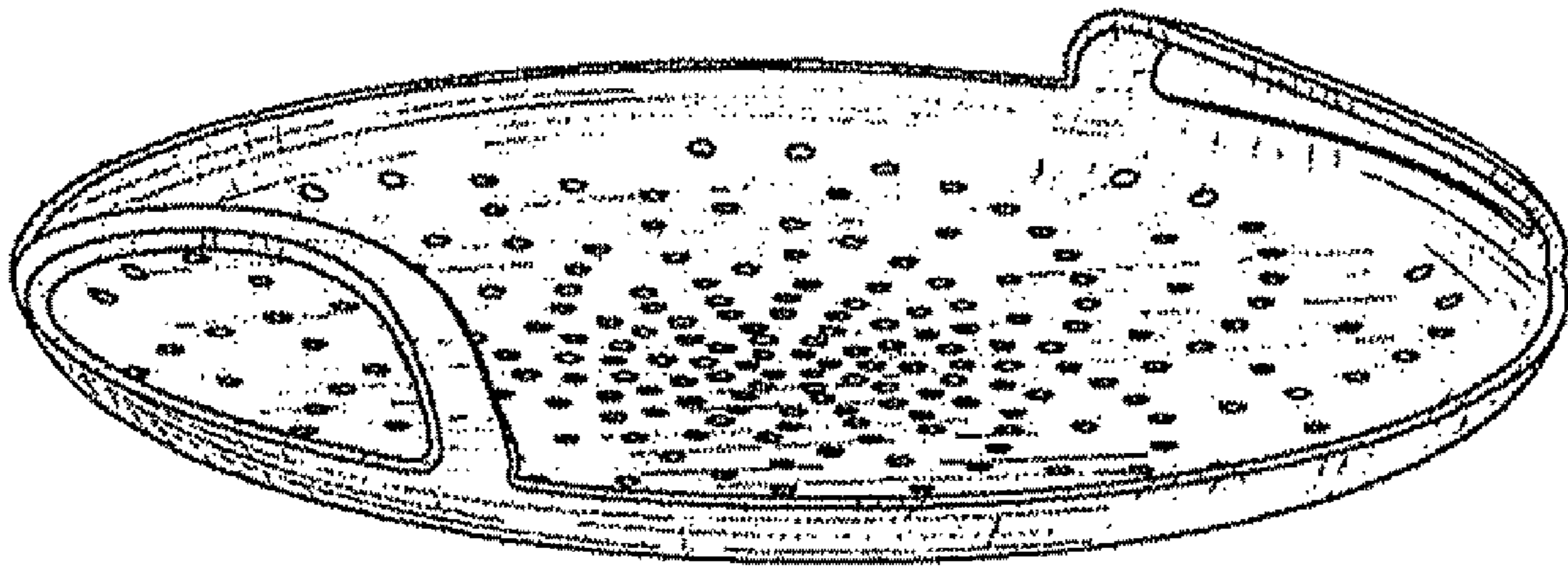

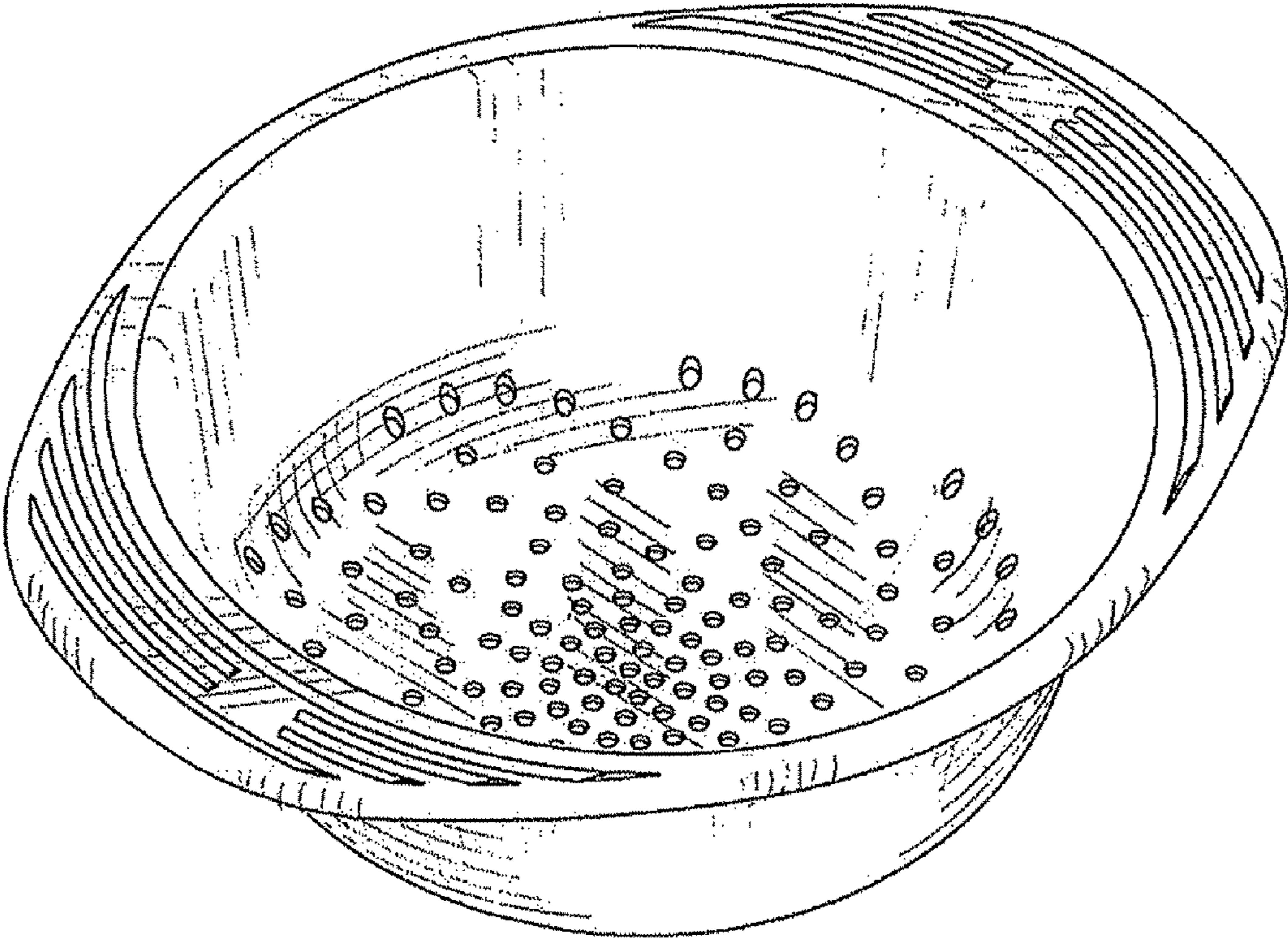

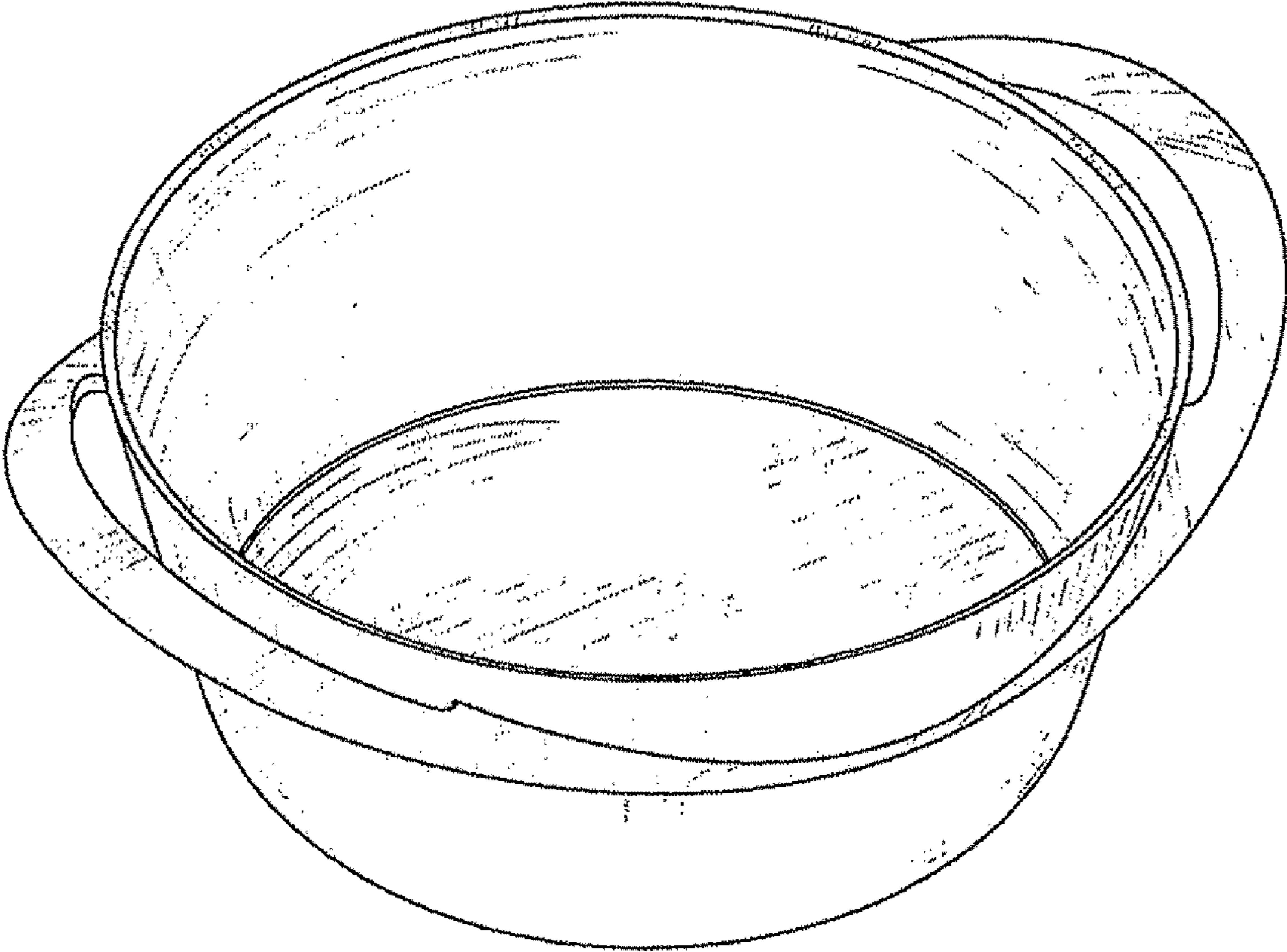
