FIG. 10 is a front elevation view, the rear elevation being identical thereto;

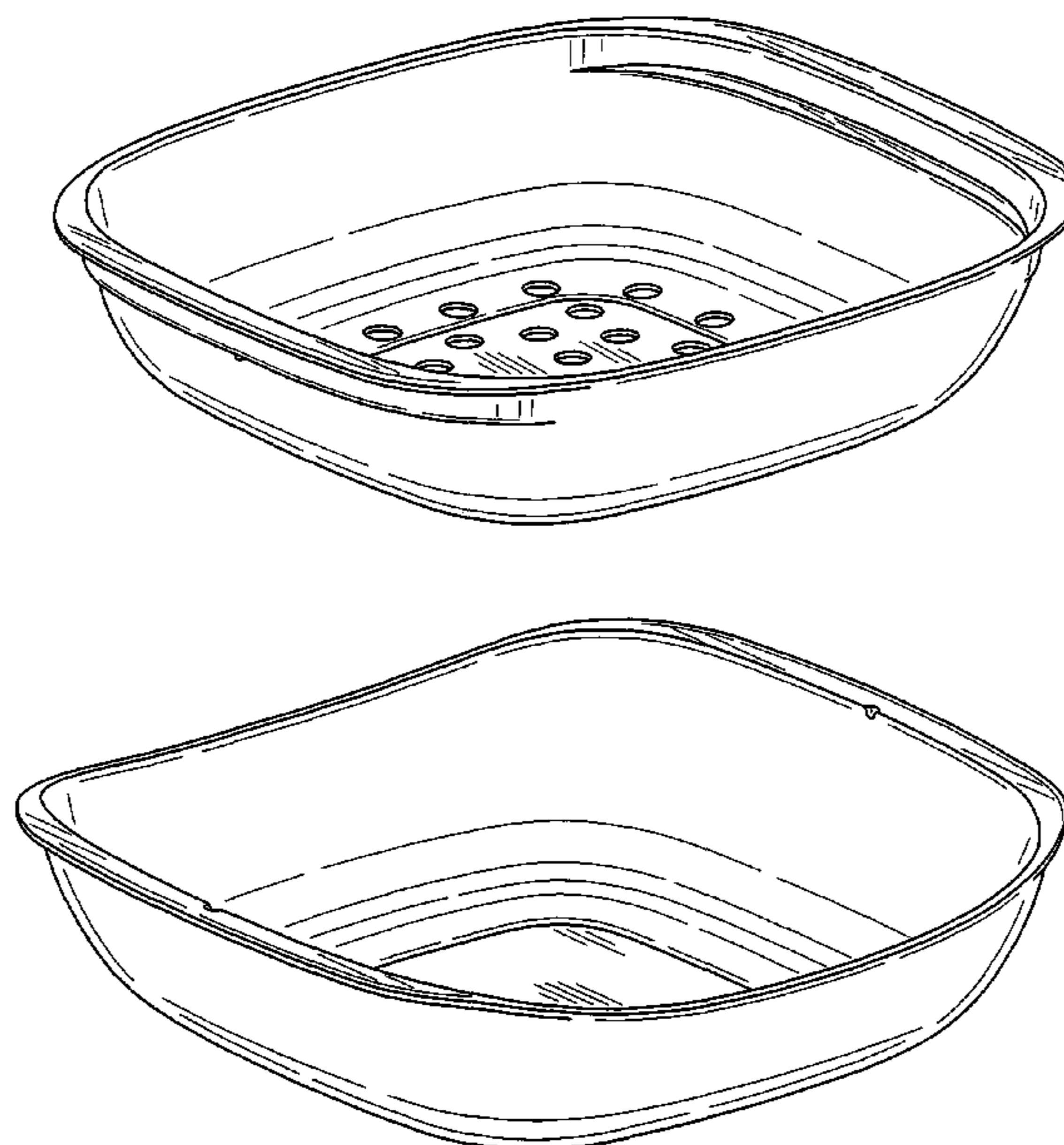
FIG. 11 is a right side elevation view, the left side elevation being identical thereto;

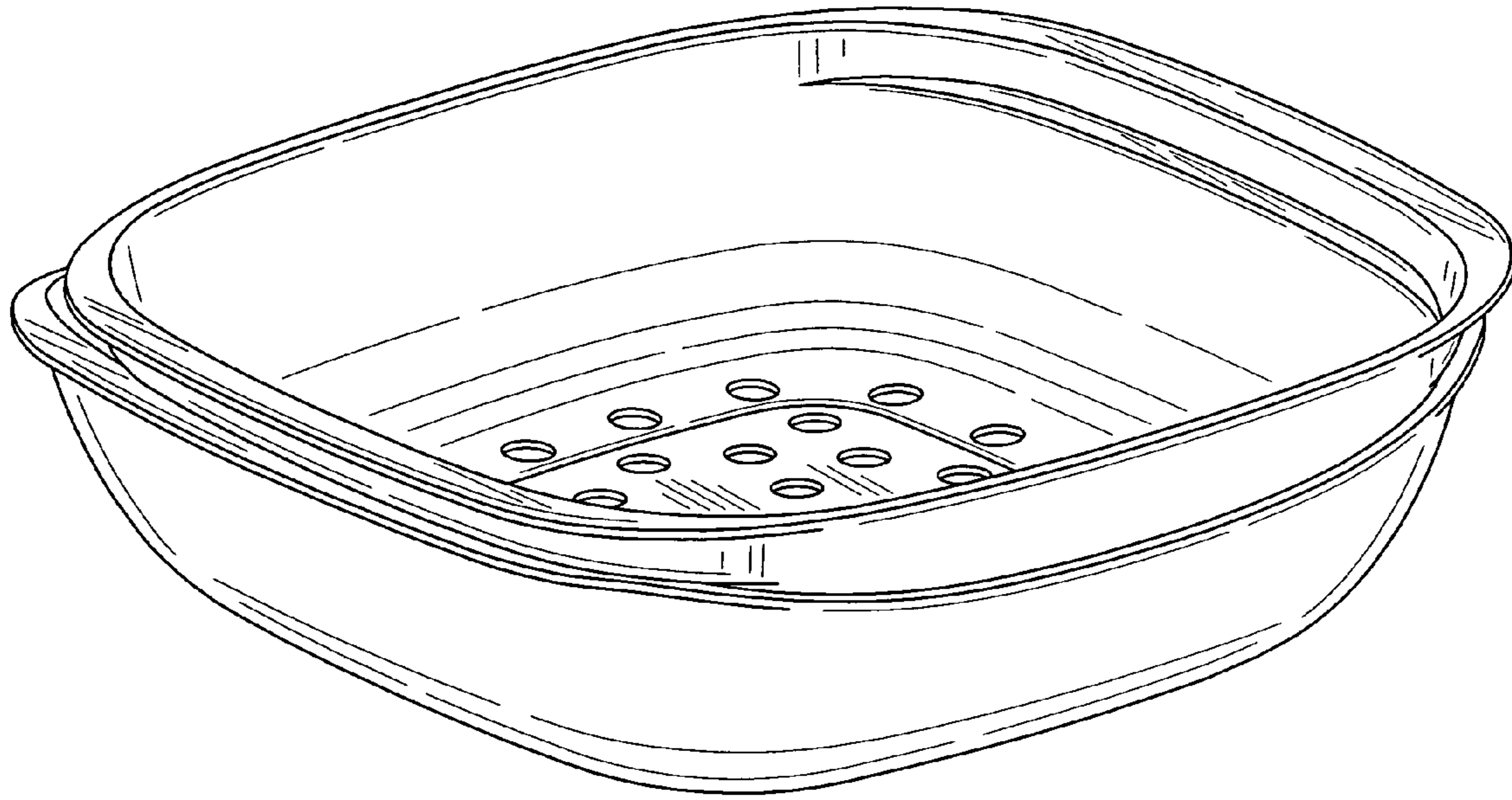

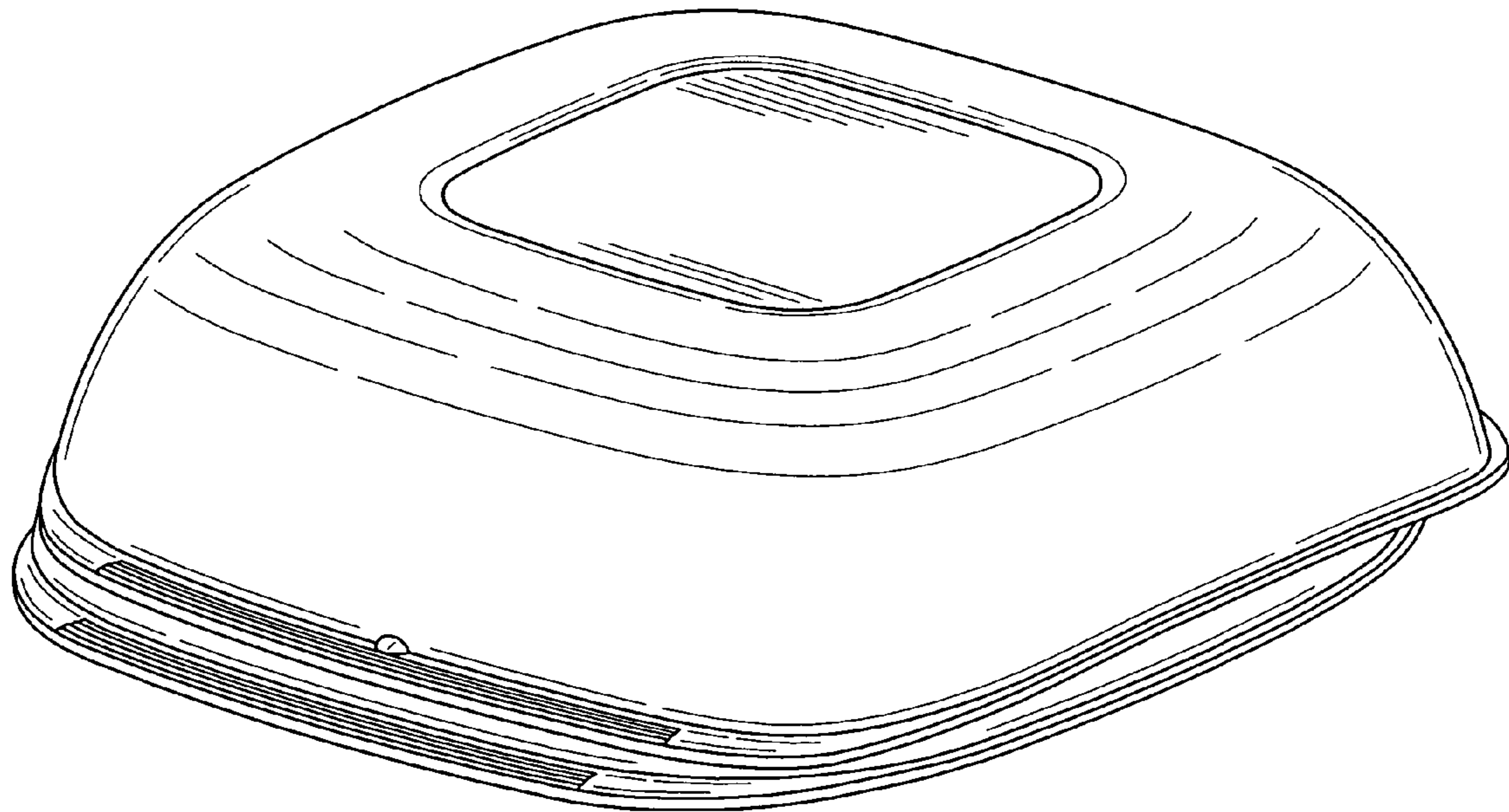

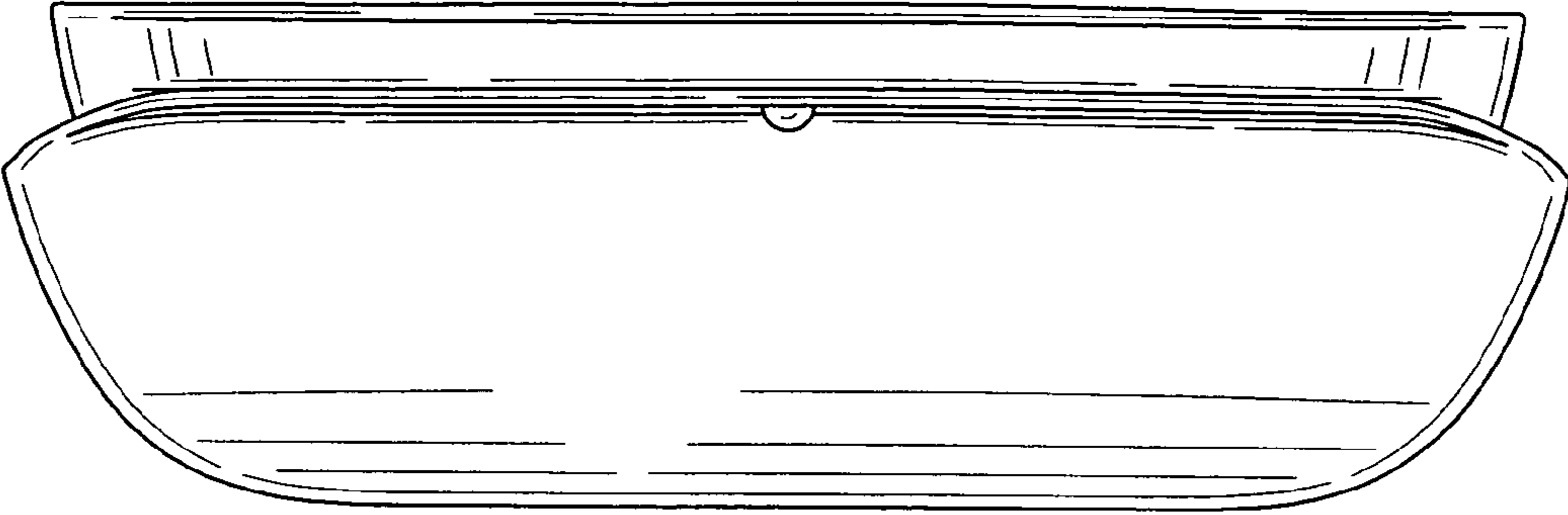

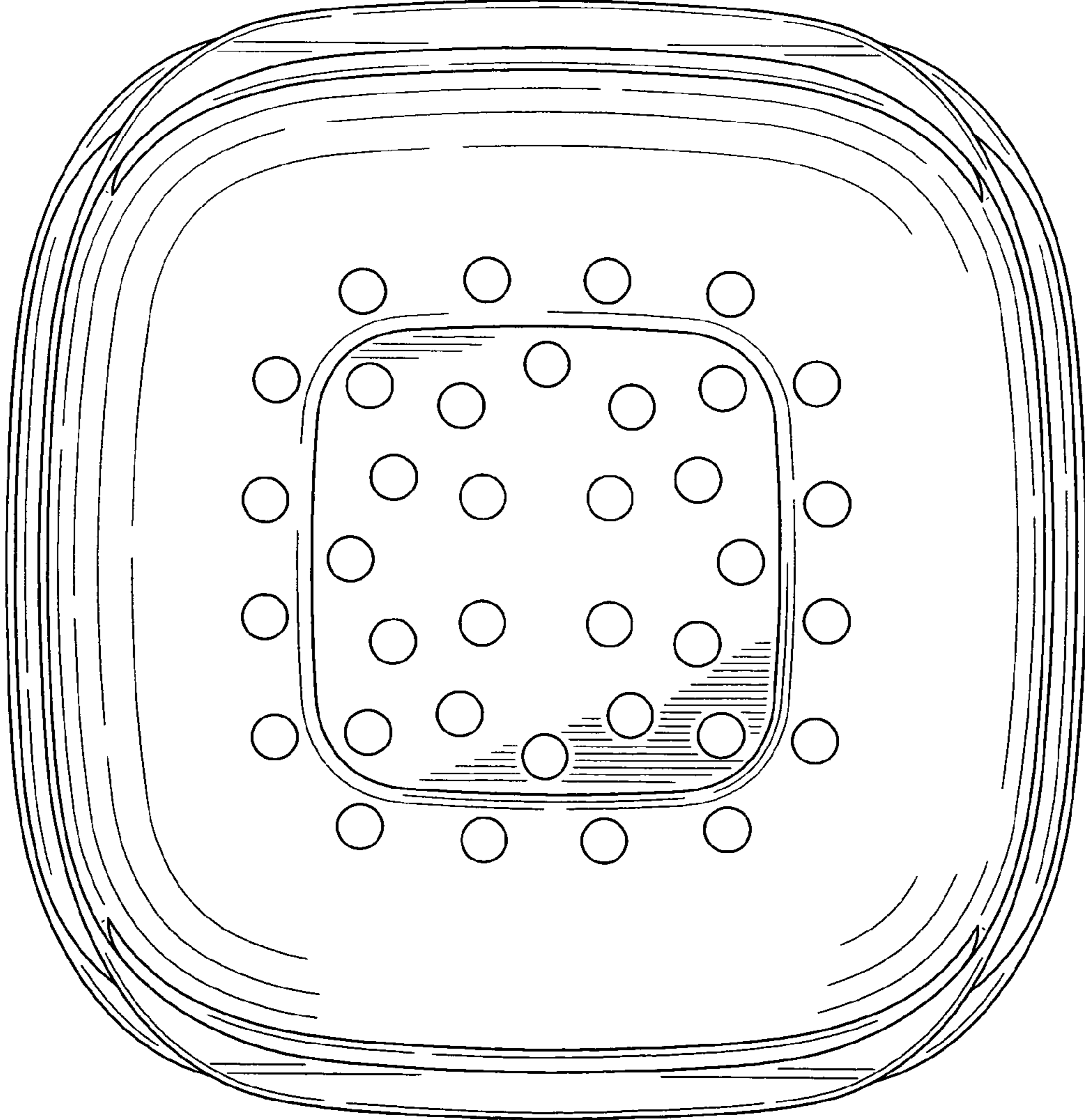

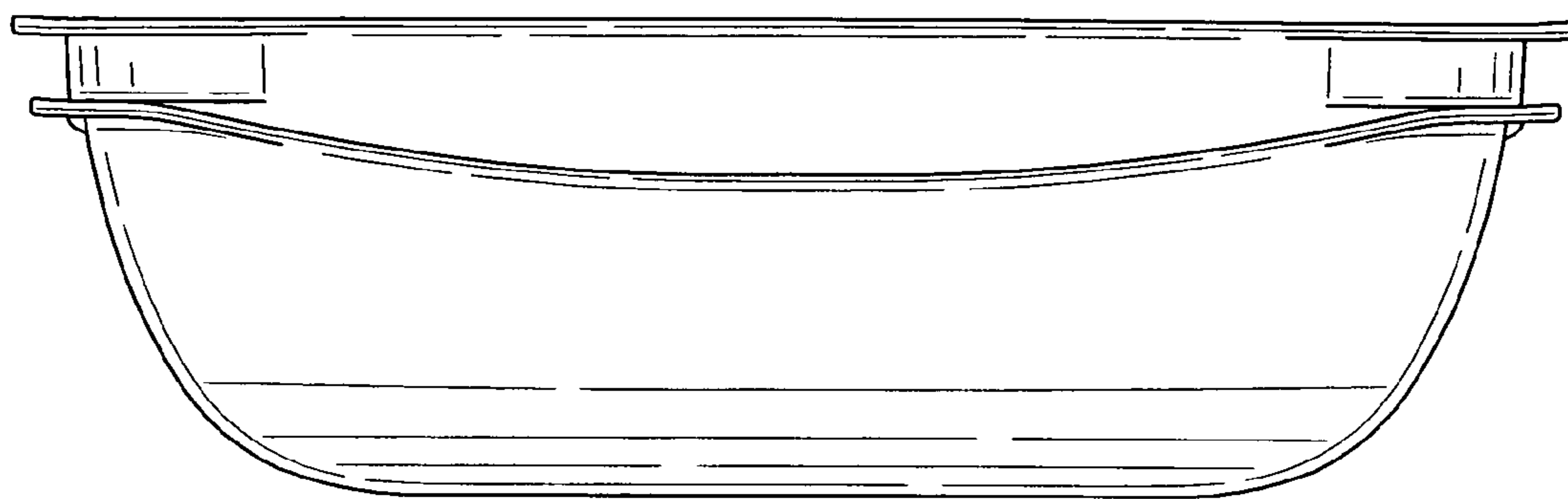

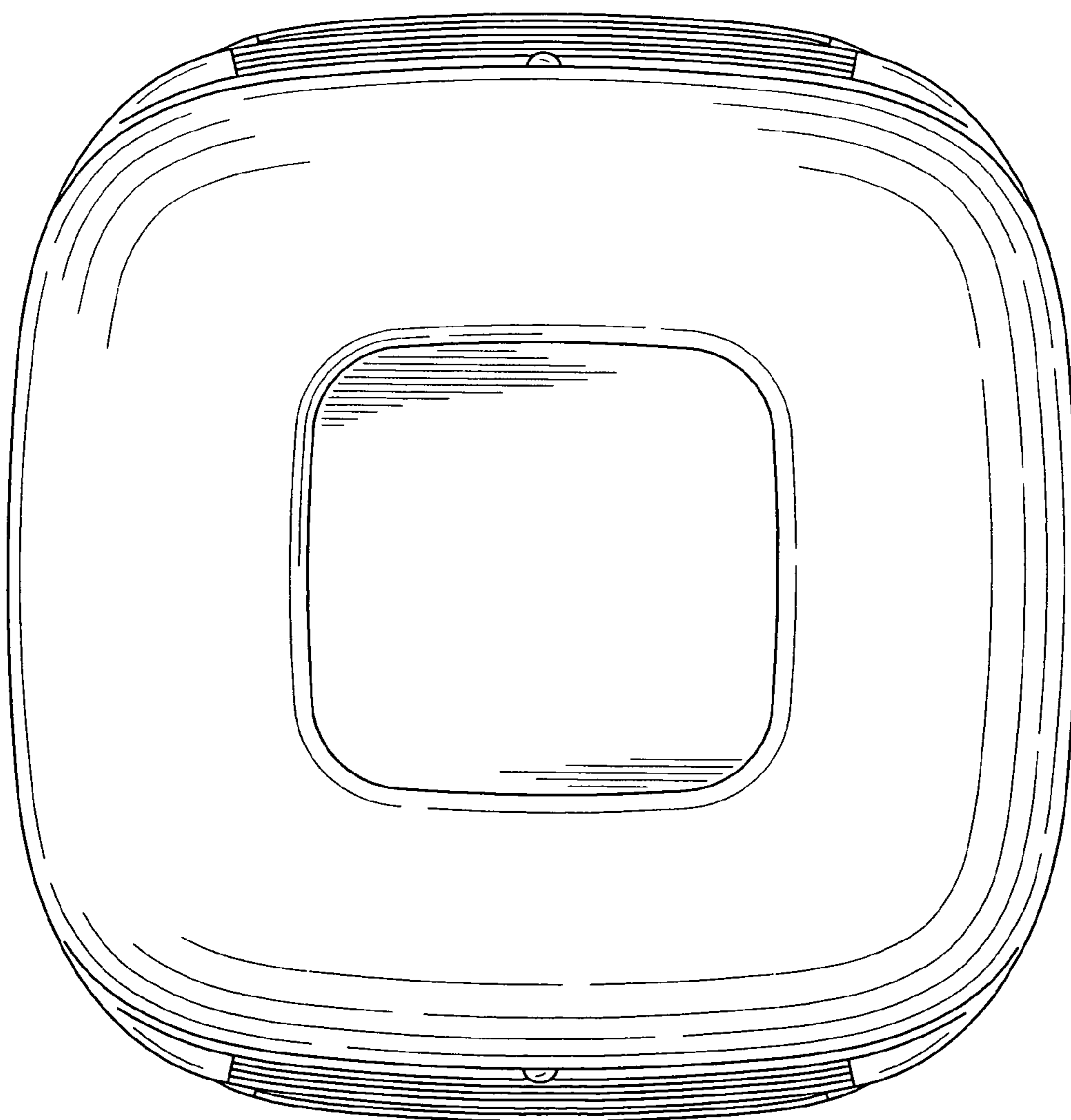

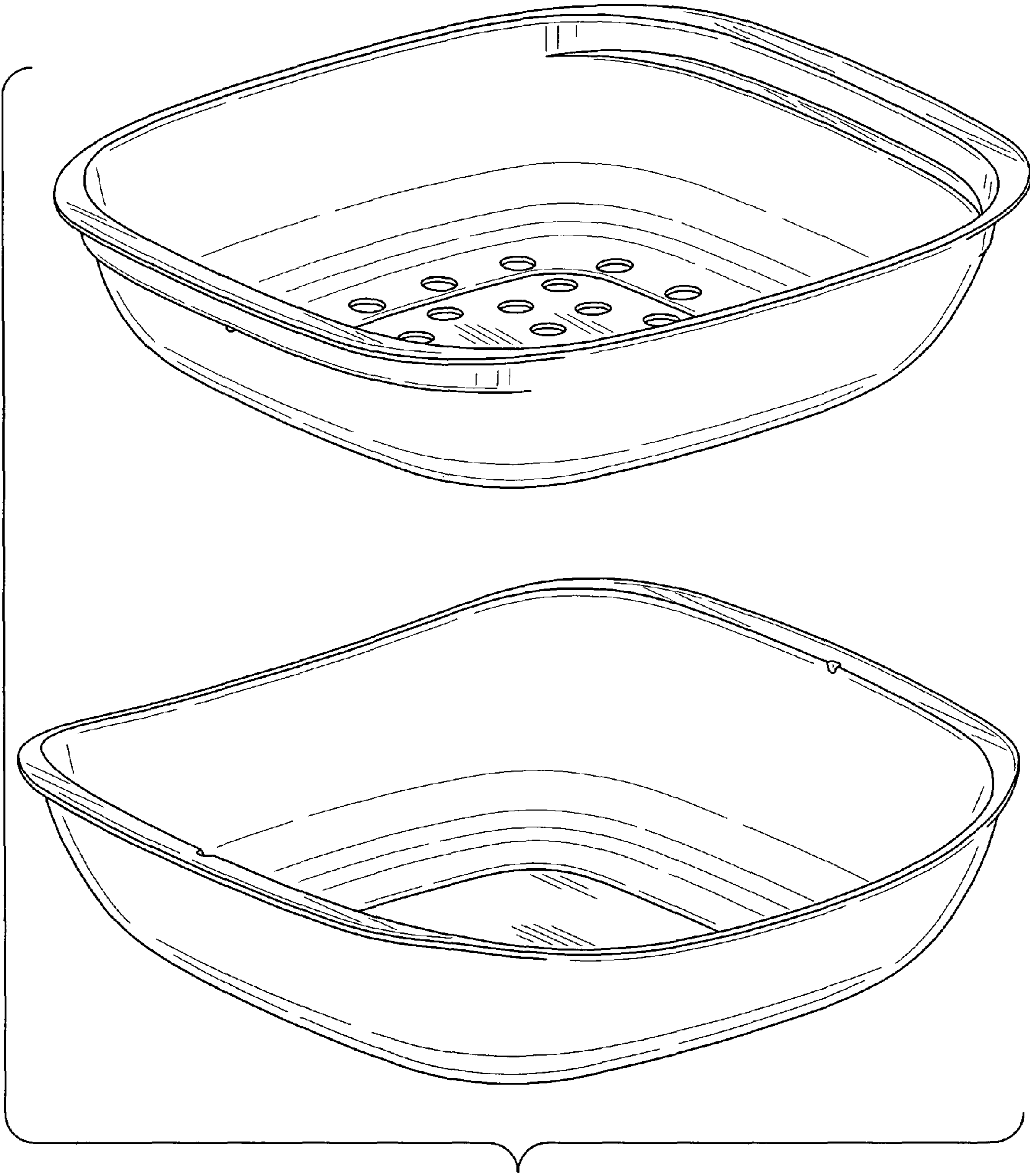

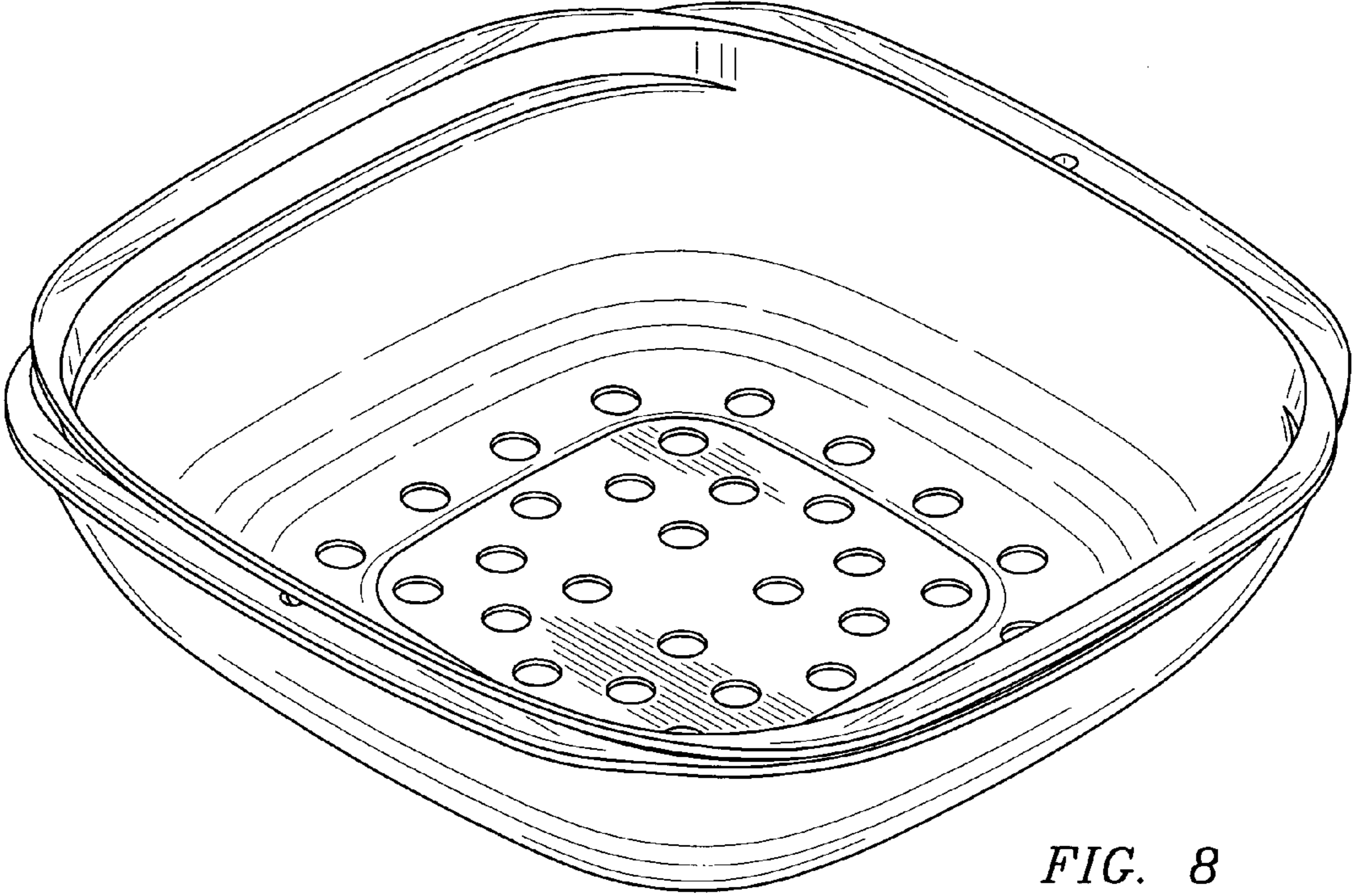

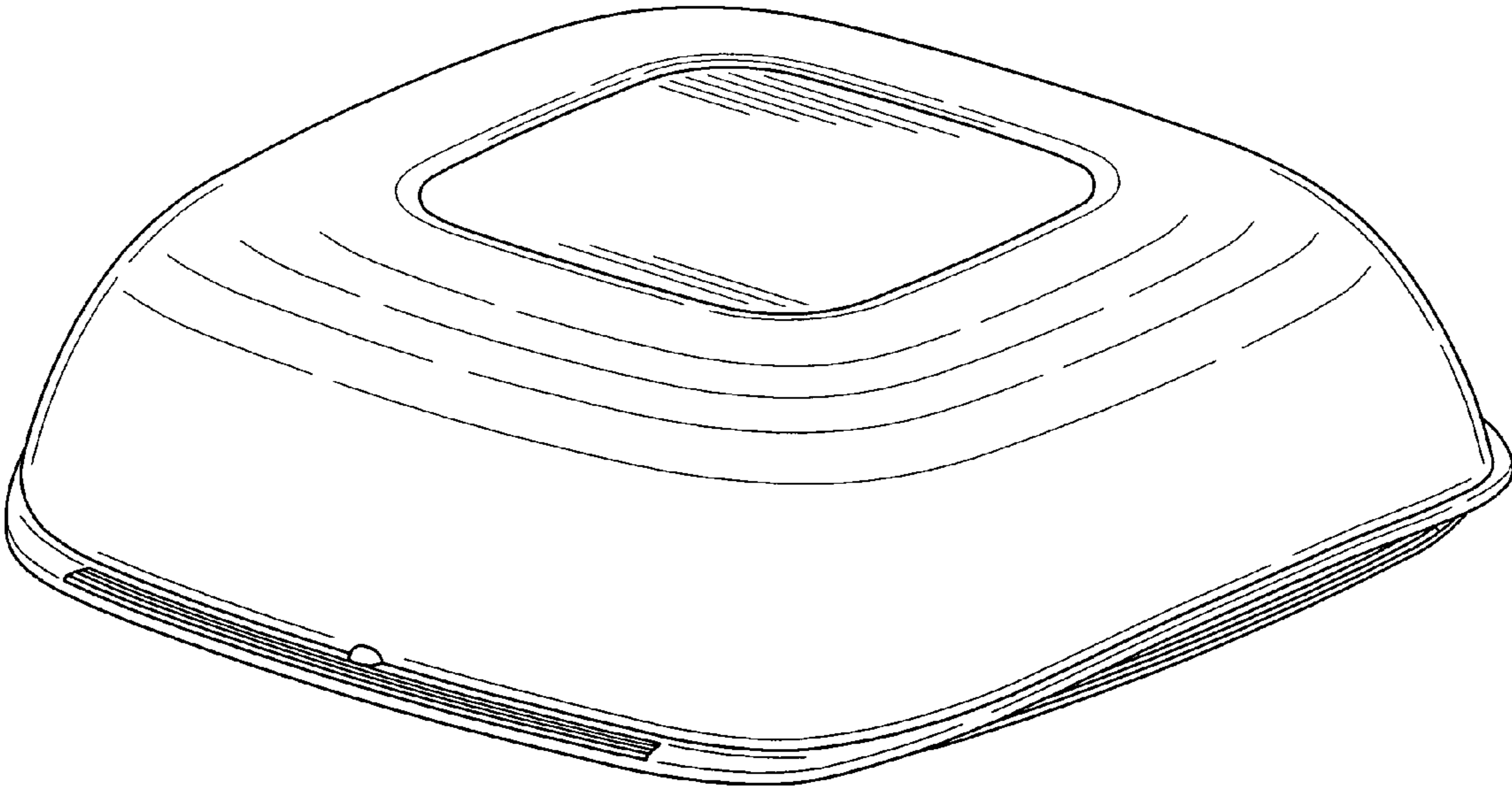

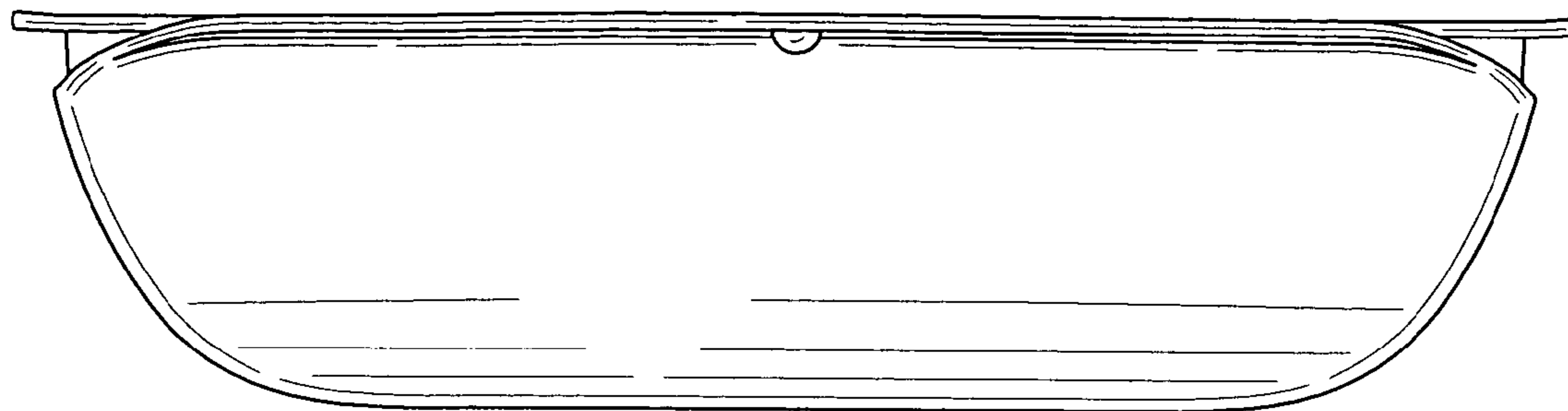

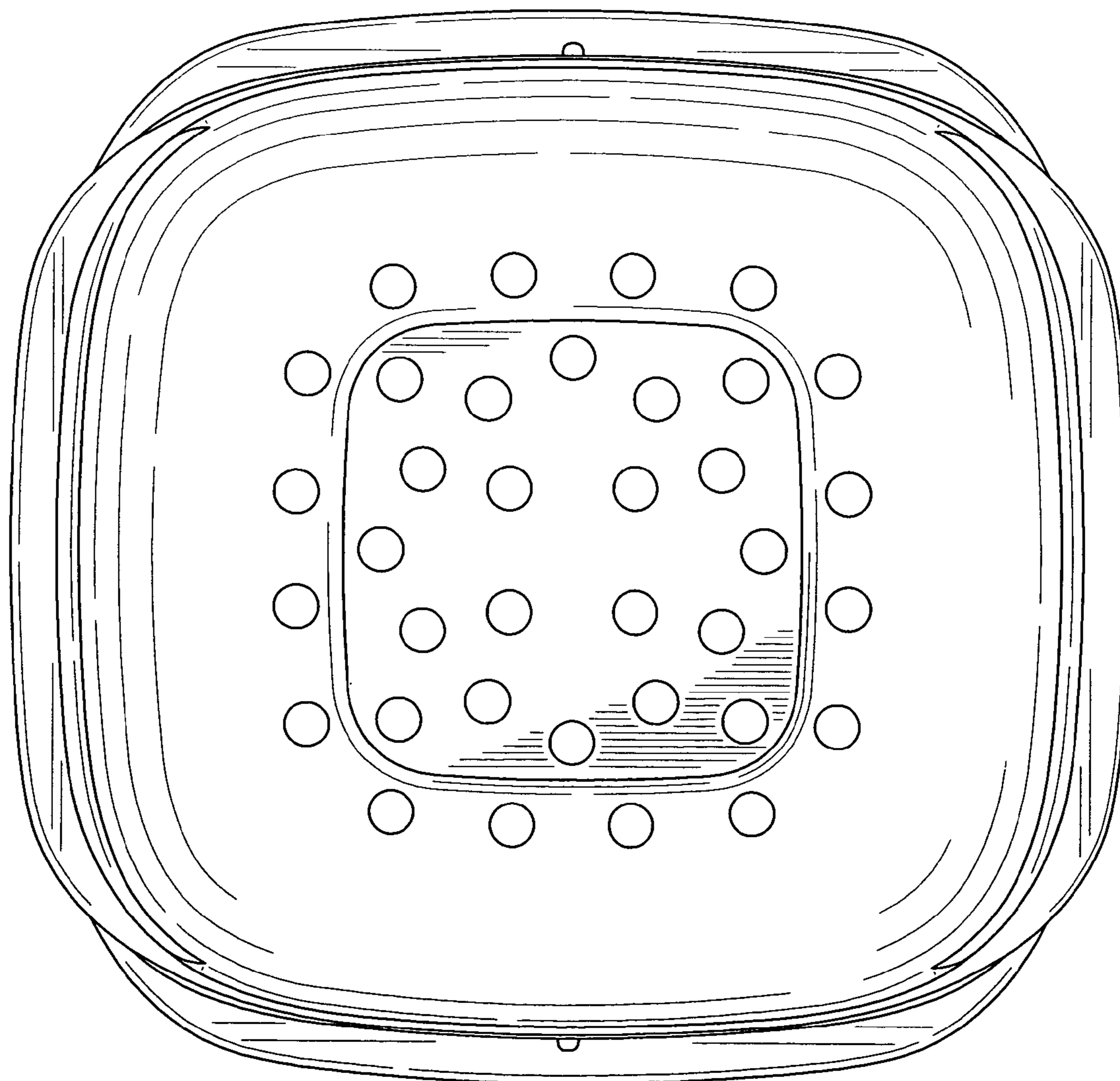

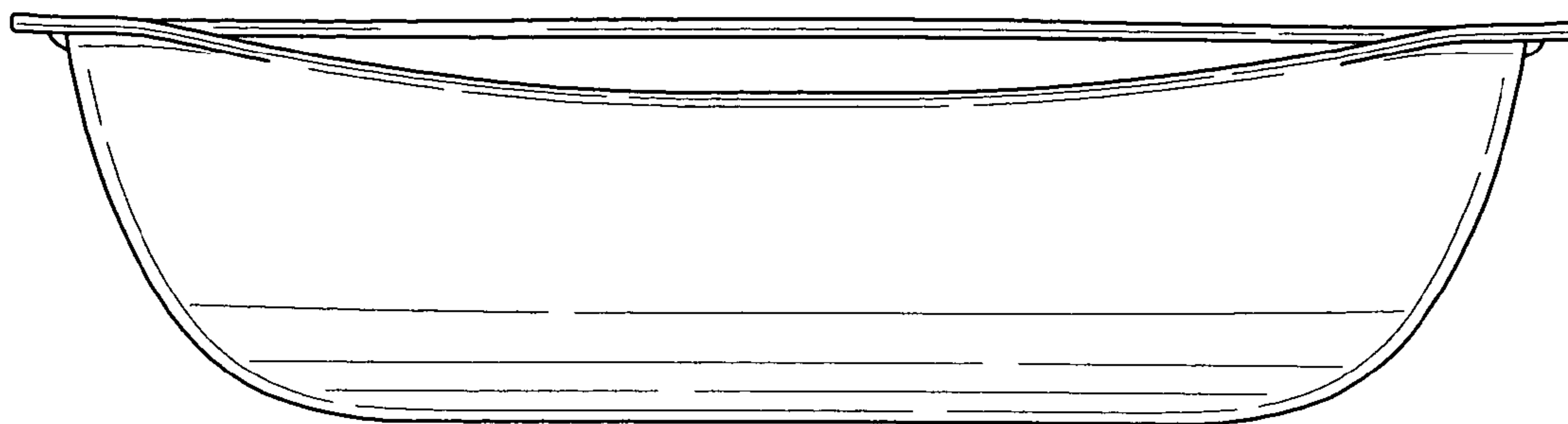

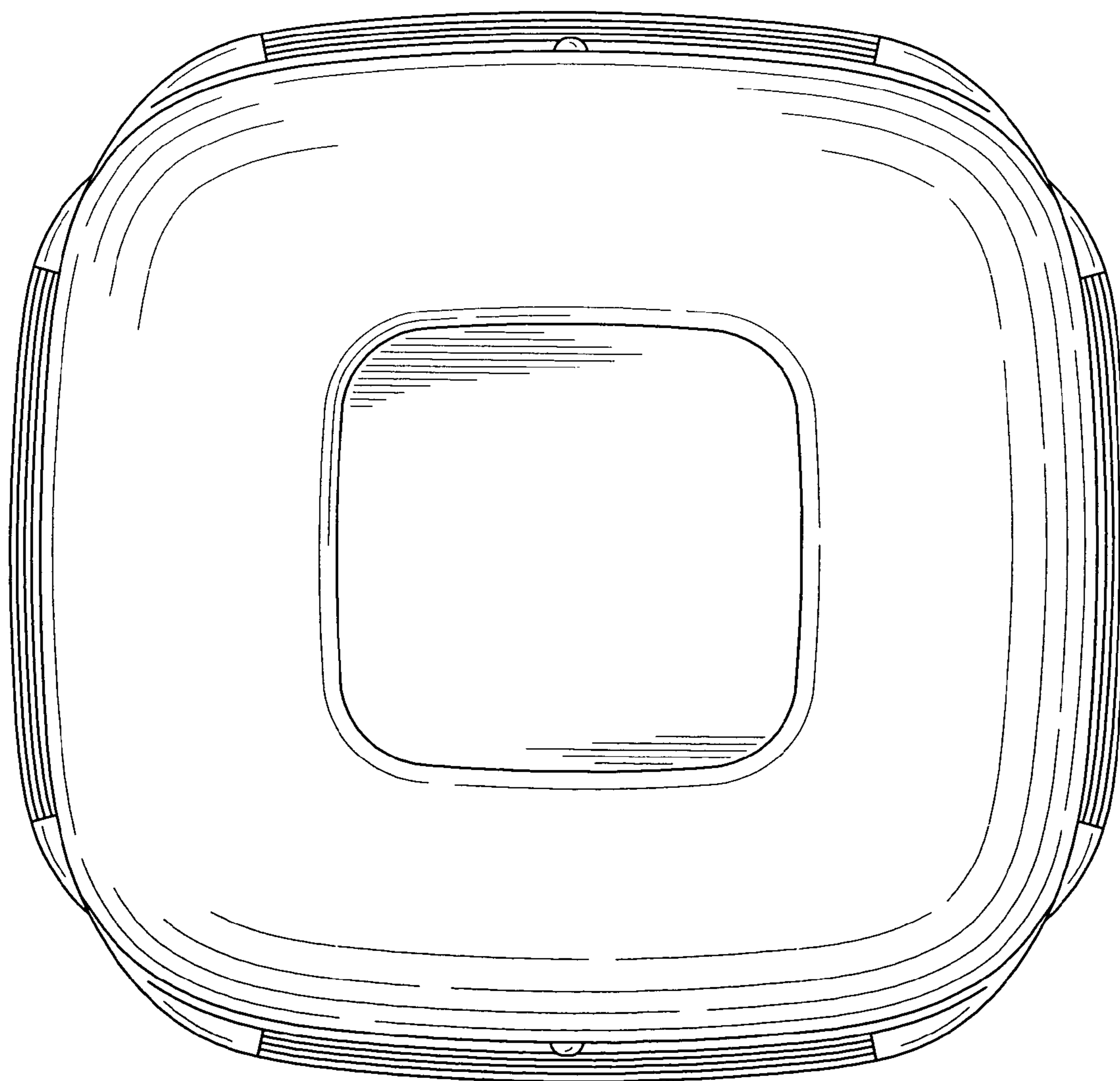

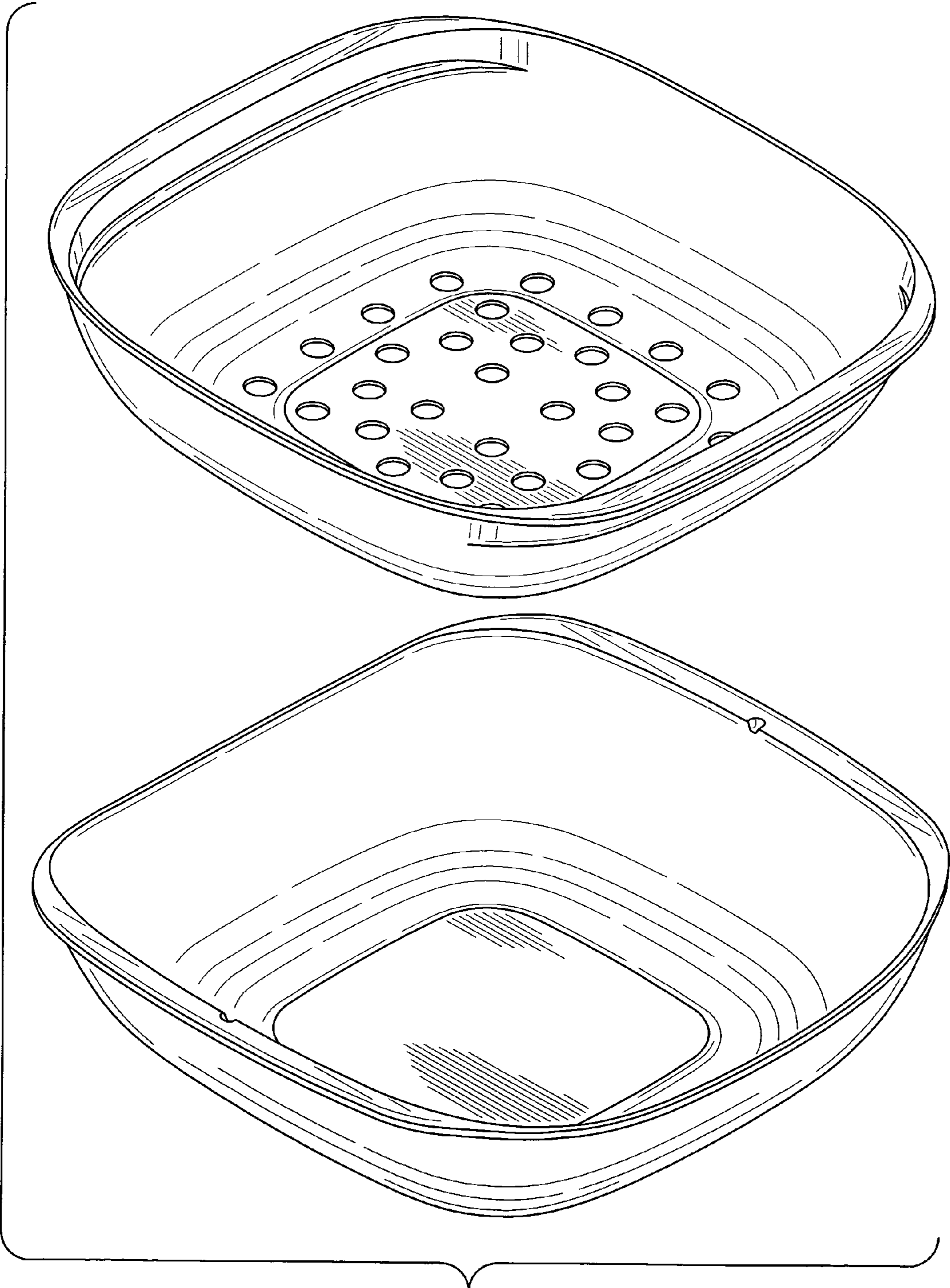
