**DESCRIPTION**

FIG. 1 is a front, right and top perspective view of the pizza bag showing my new design;  
FIG. 2 is a top view thereof;

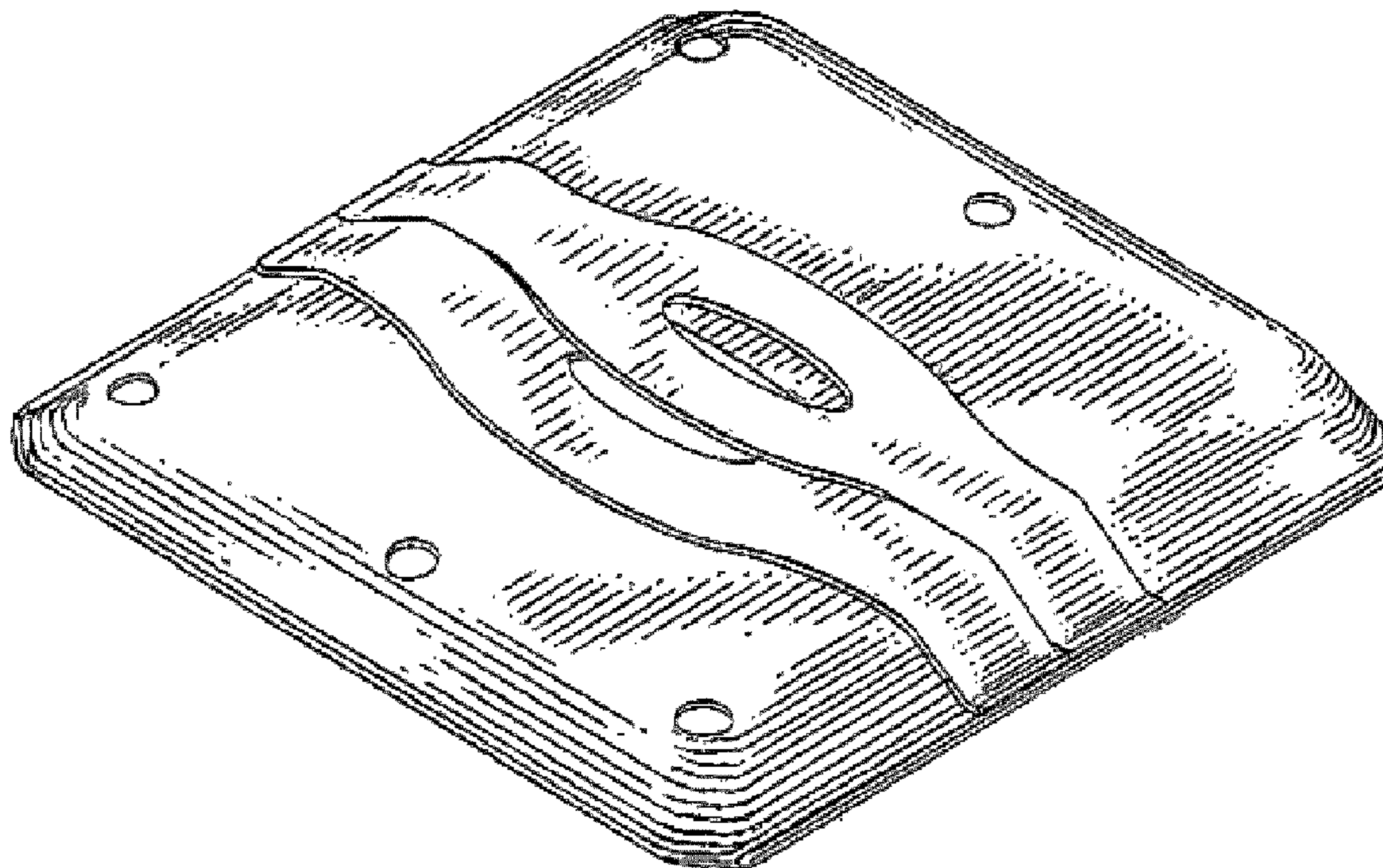

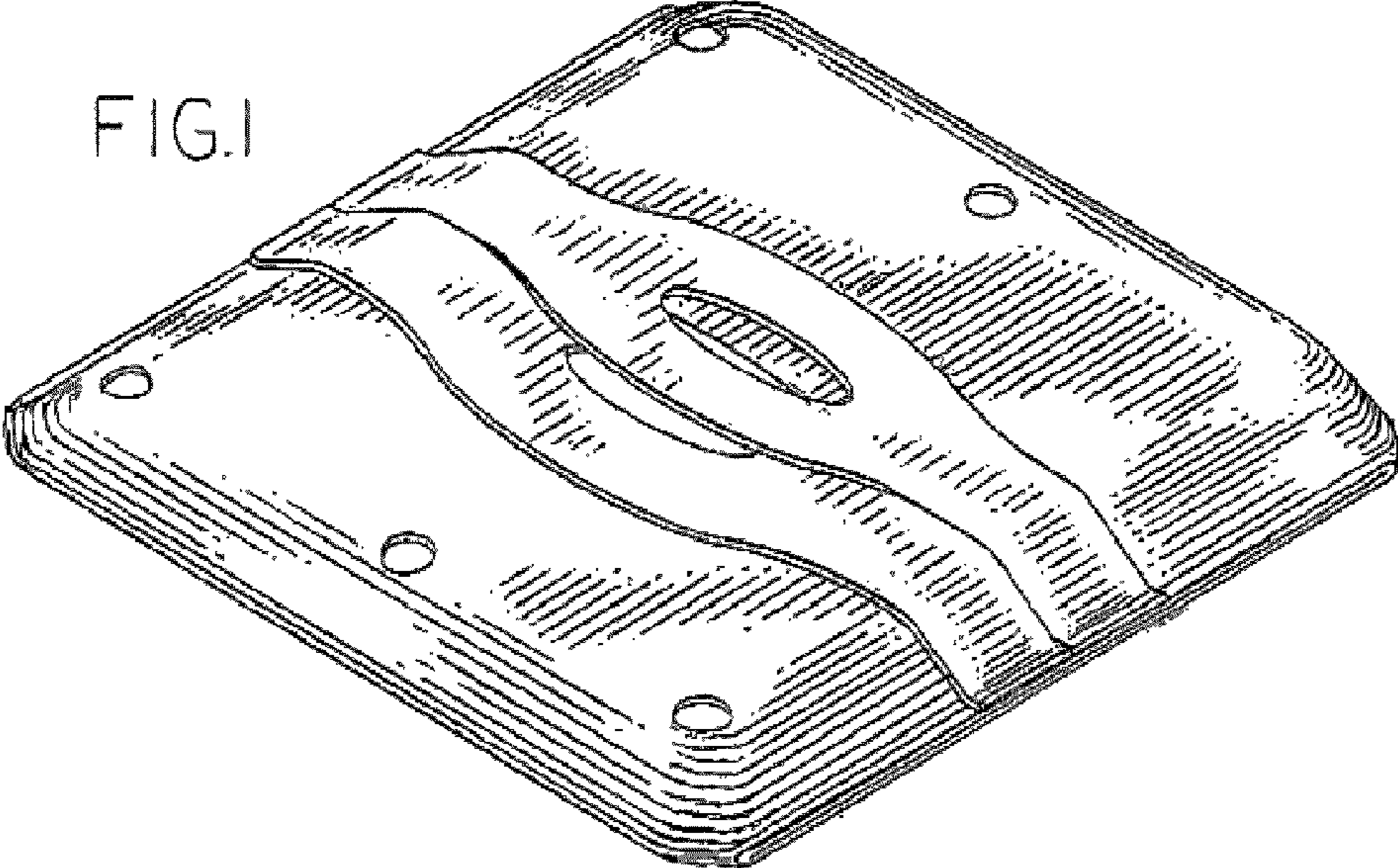

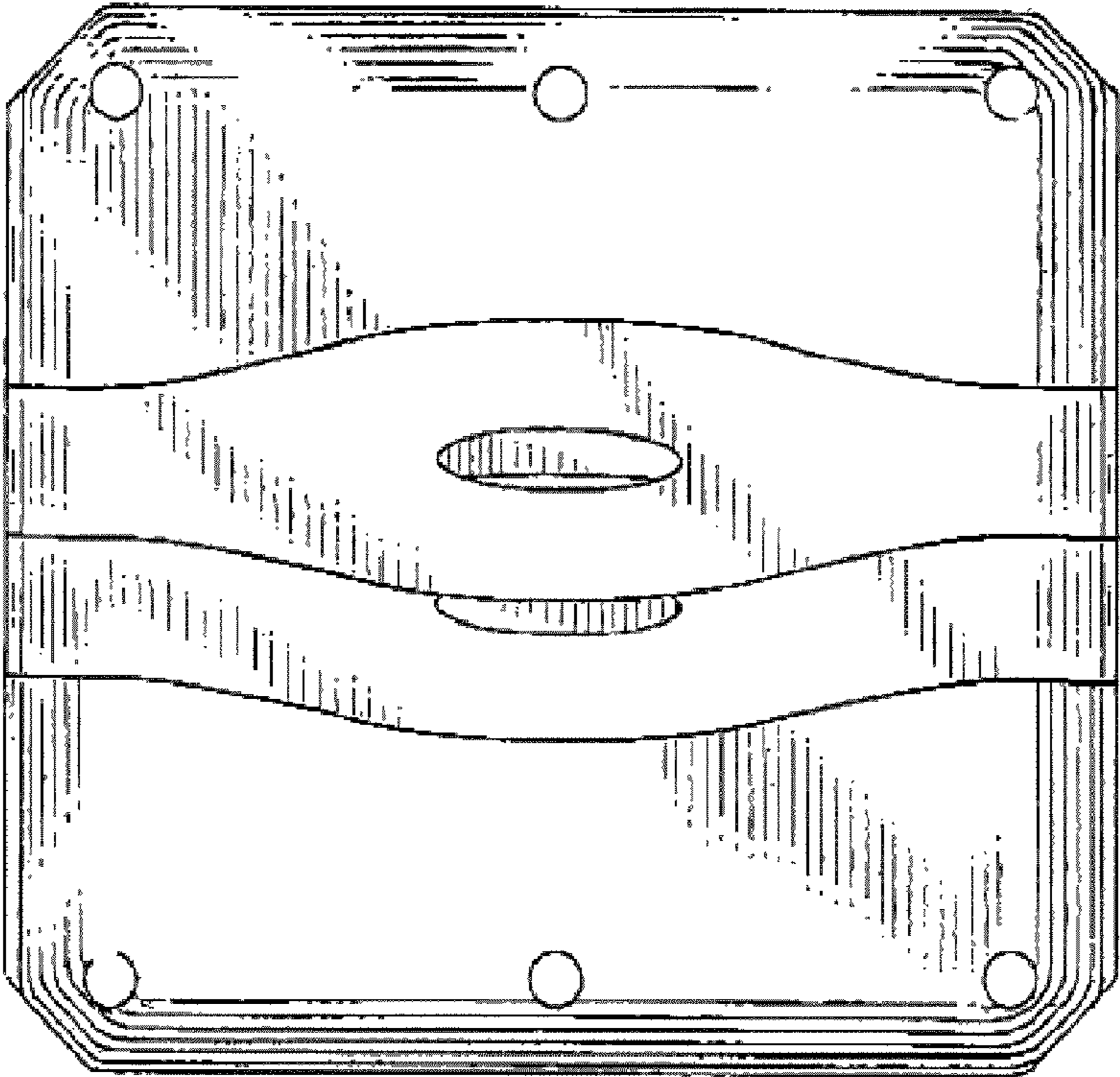
