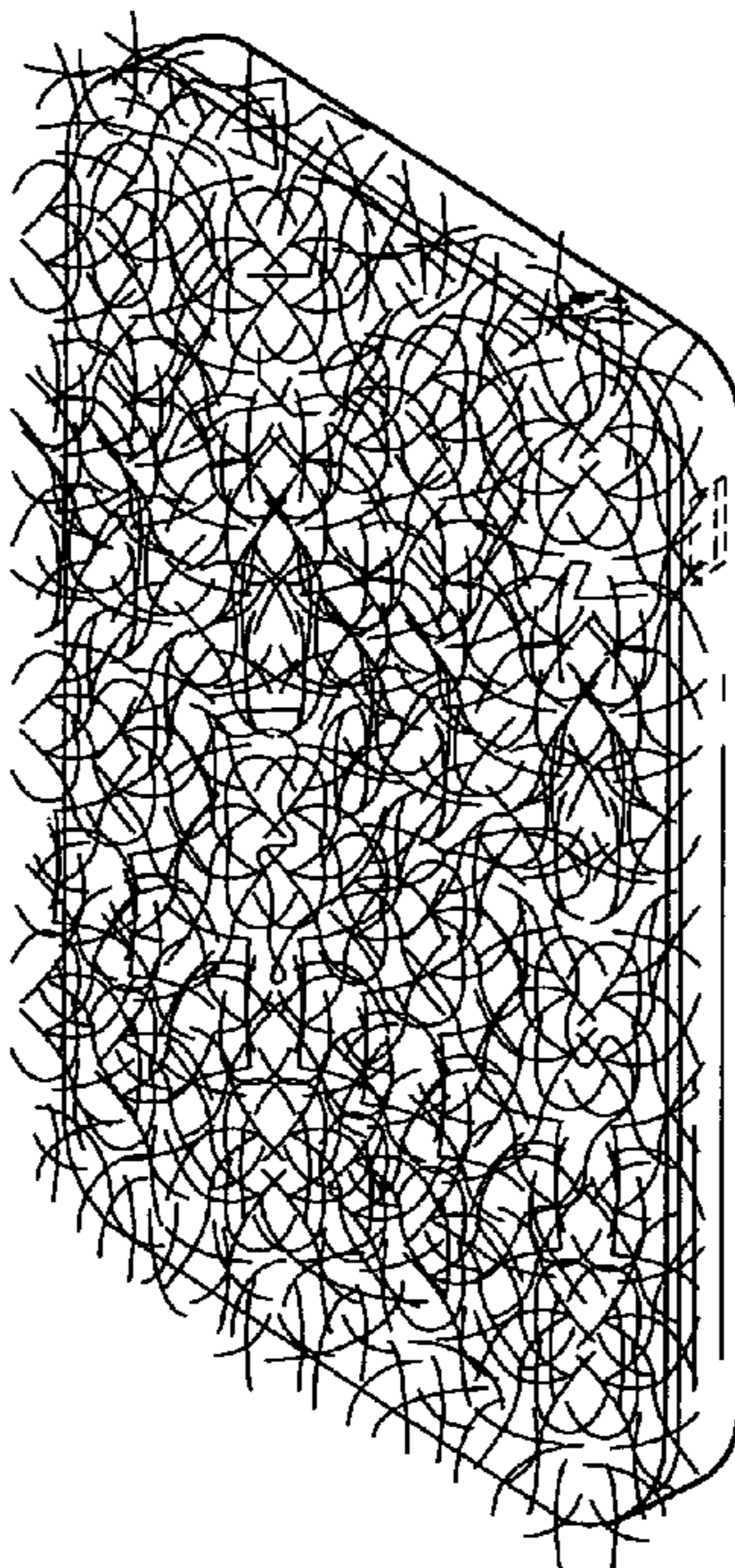
(57) **CLAIM**

The ornamental design for a handheld electronic device cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handheld electronic device cover, showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a rear elevational view thereof;

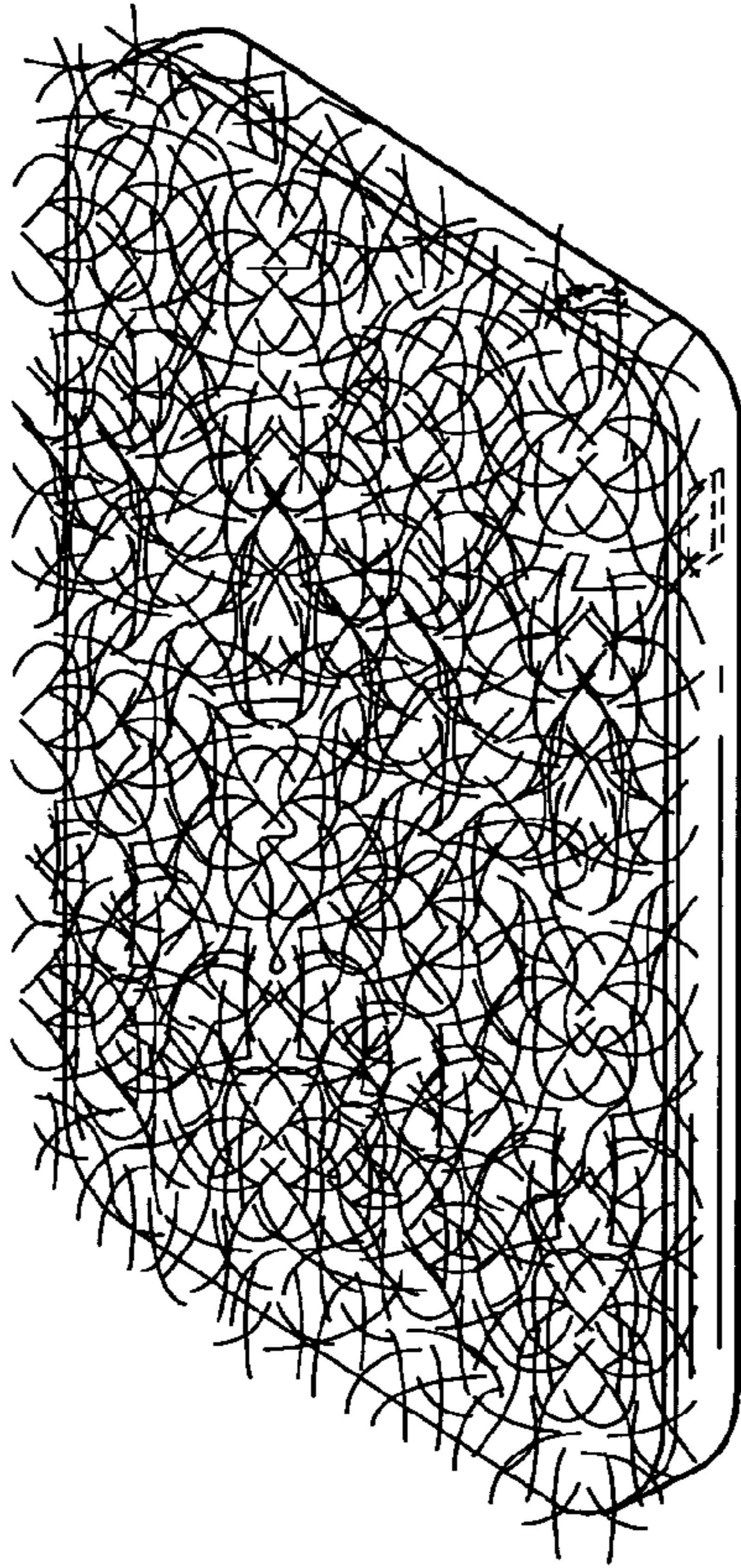

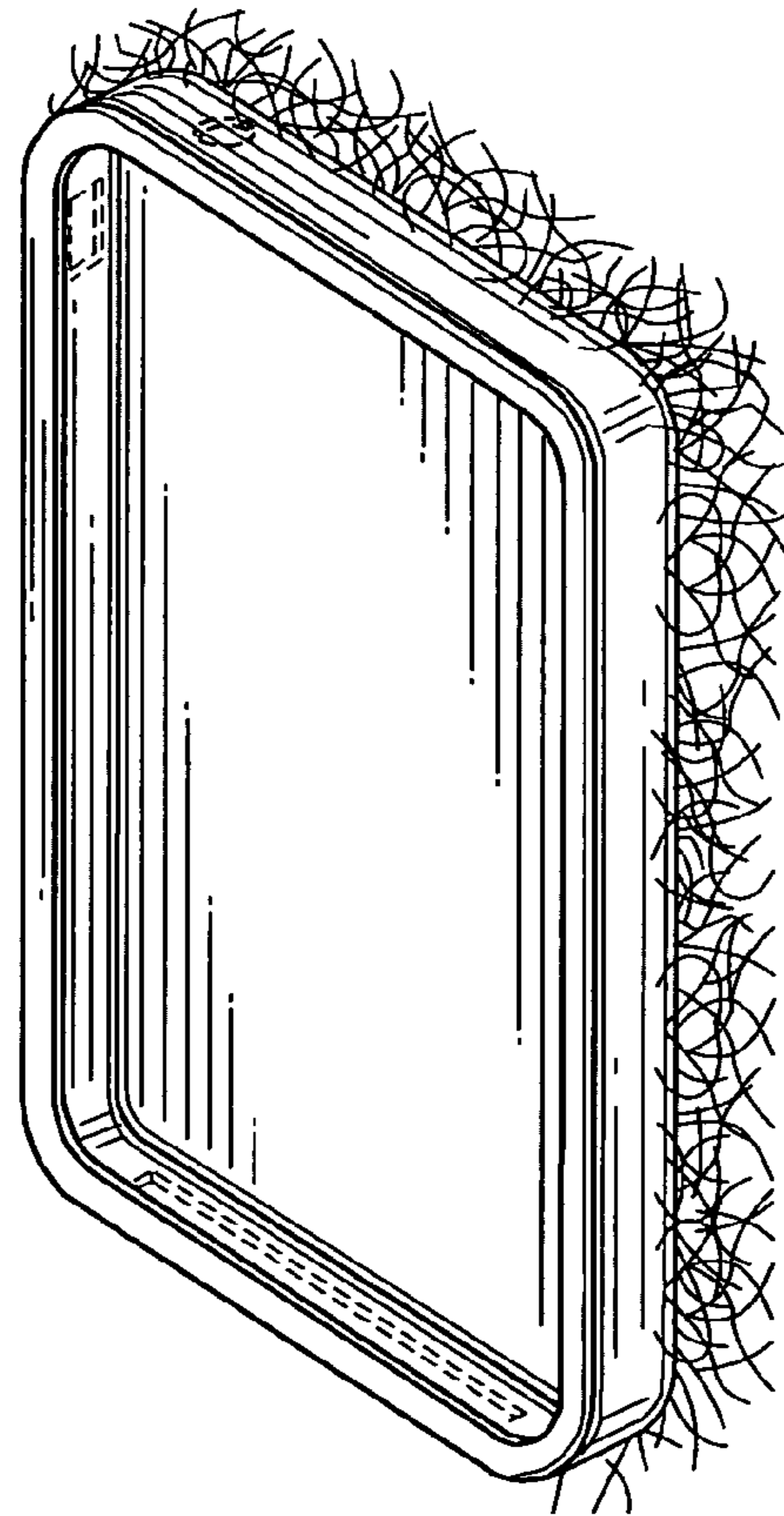

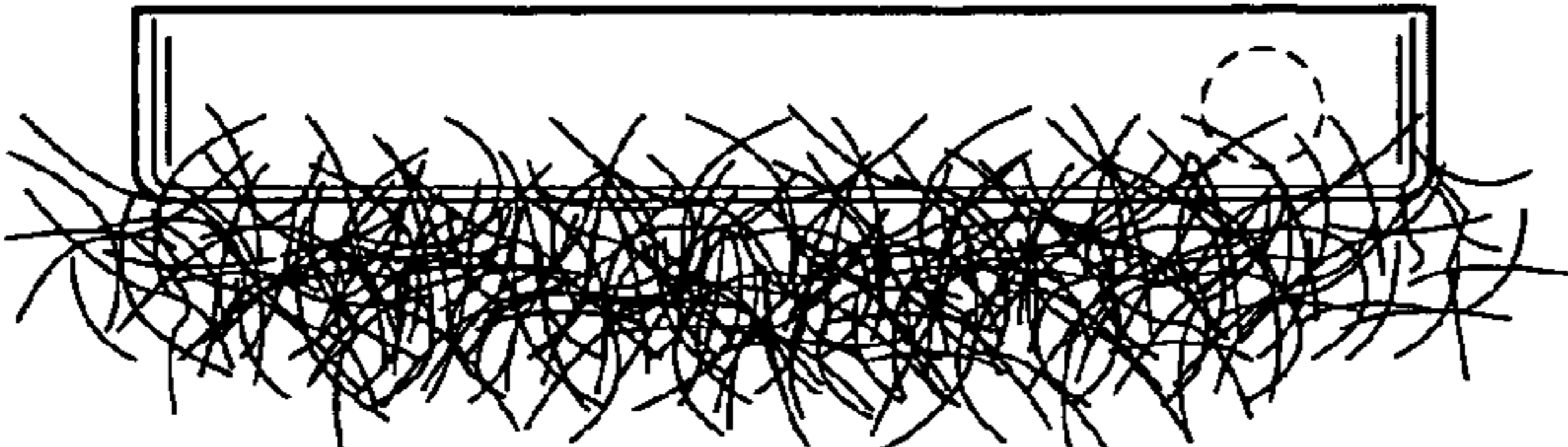

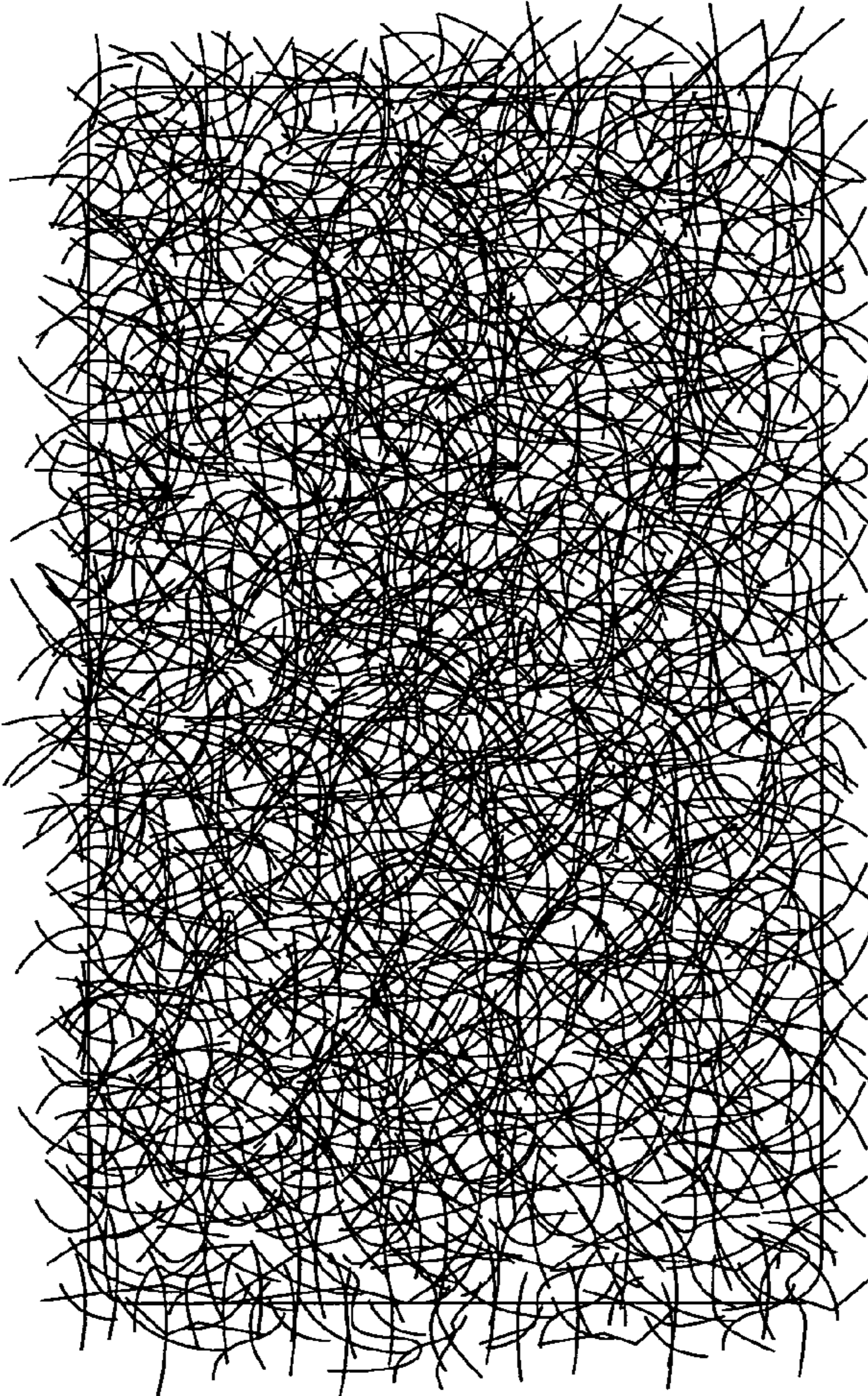

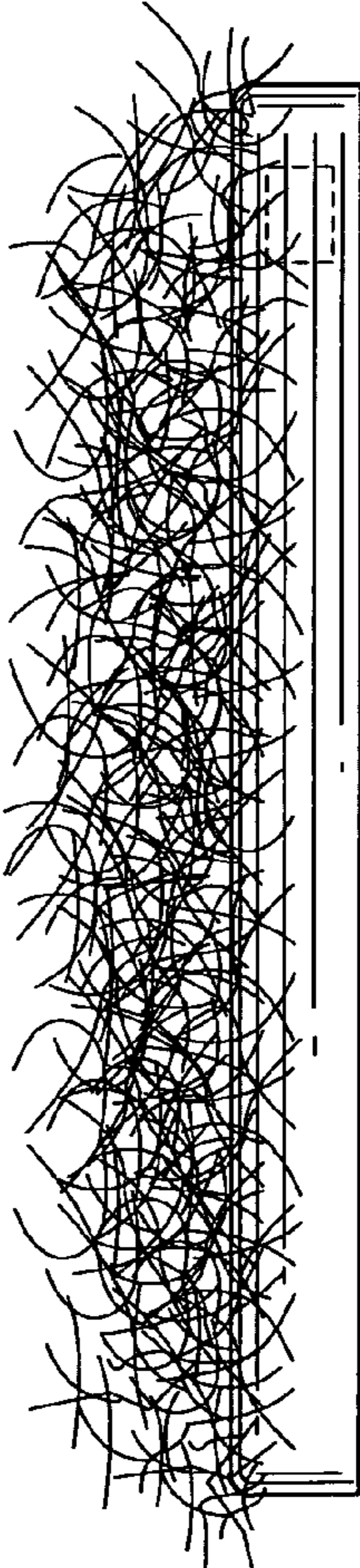

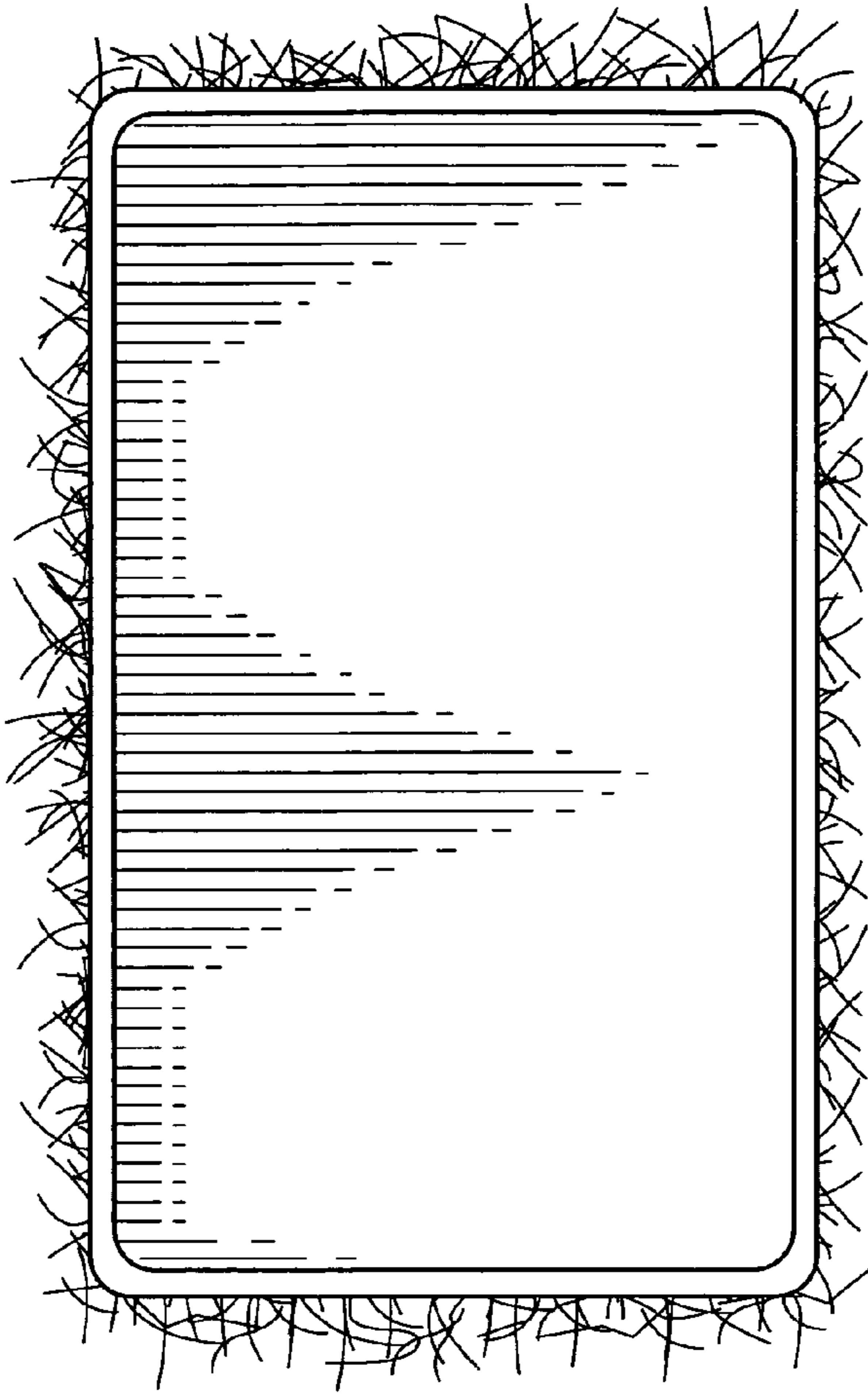

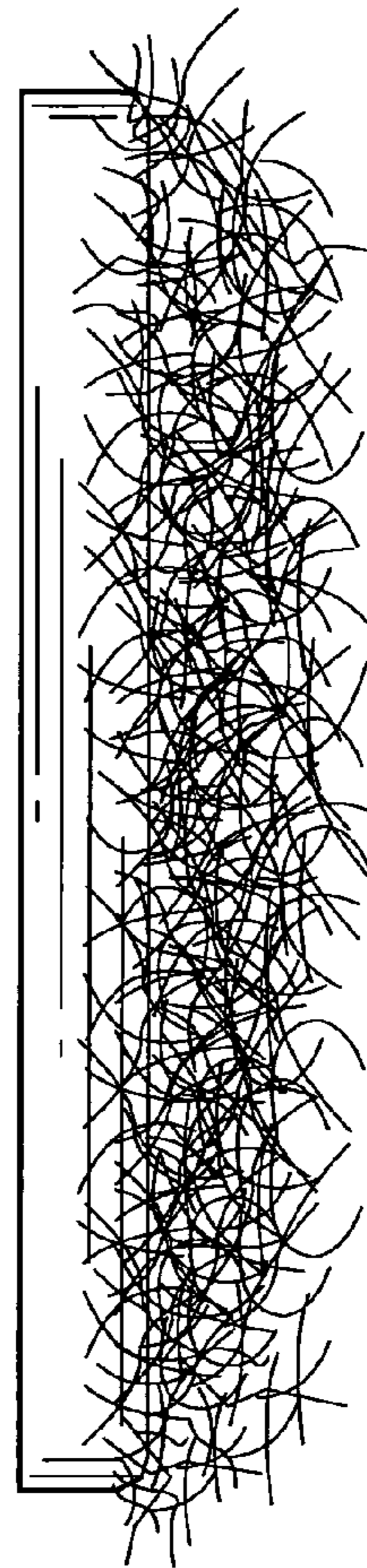

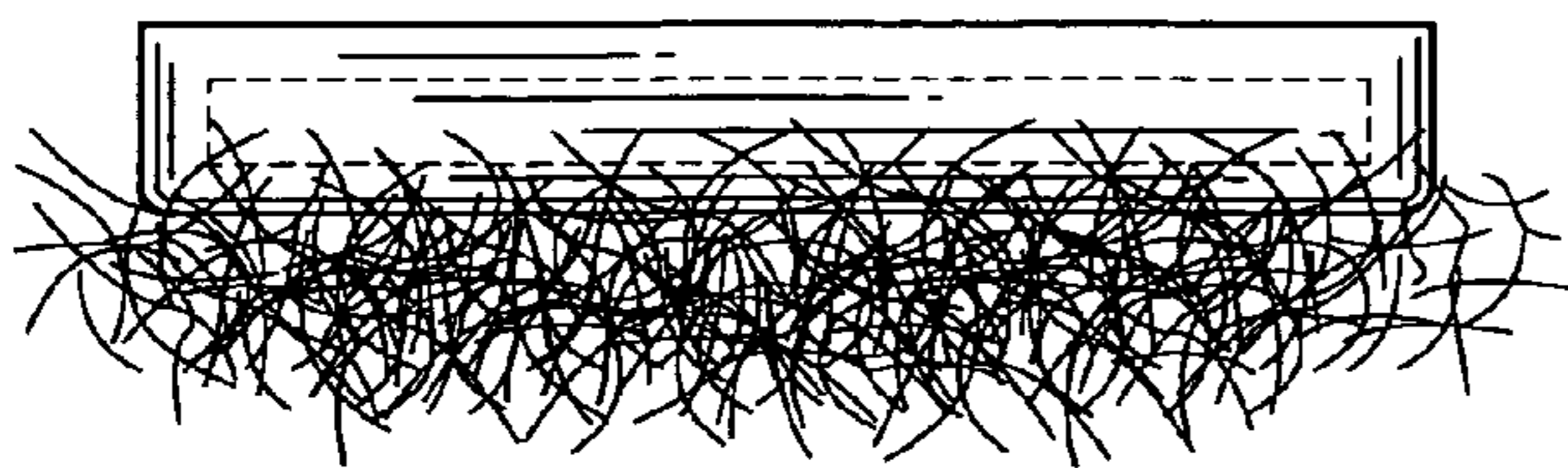
