(57) **CLAIM**

The ornamental design for a pendant, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a pendant showing our new design with a handheld mobile electronic device and a neck strap in broken lines;

FIG. 2 is an enlarged isometric view of the pendant of FIG. 1 with a portion of the neck strap in broken lines;

FIG. 3 is a front view thereof with a handheld mobile electronic device and a portion of a neck strap in broken lines;

FIG. 4 is a right side view thereof with a handheld mobile electronic device in broken lines;

FIG. 5 is a left side view thereof;

FIG. 6 is a back view thereof with a portion of a neck strap in broken lines;

FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

The broken lines in the drawing are for illustrative purposes only and form no part of the claimed design. Specifically, the broken lines are provided to illustrate the environment in which the pendant may be used.

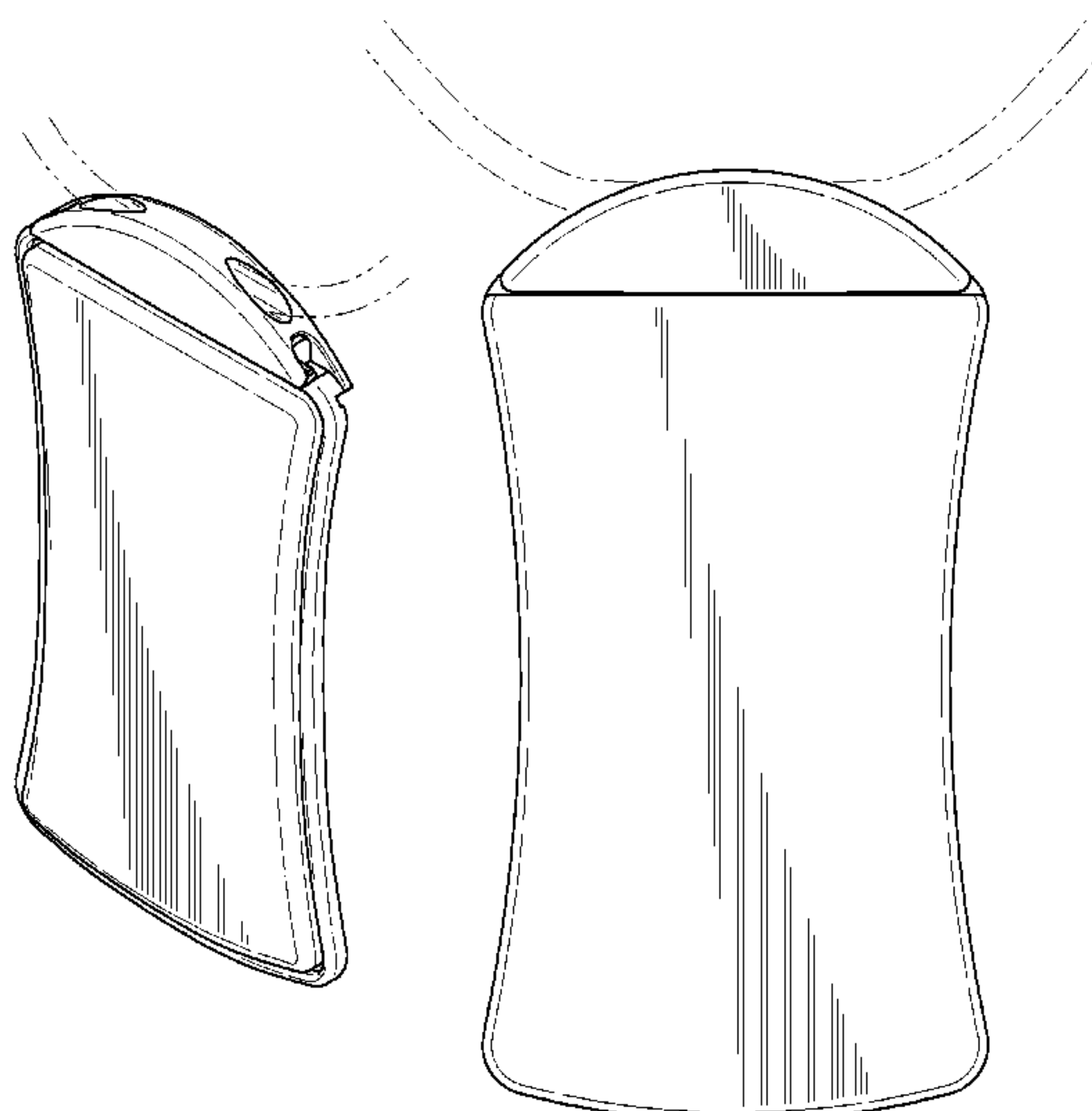

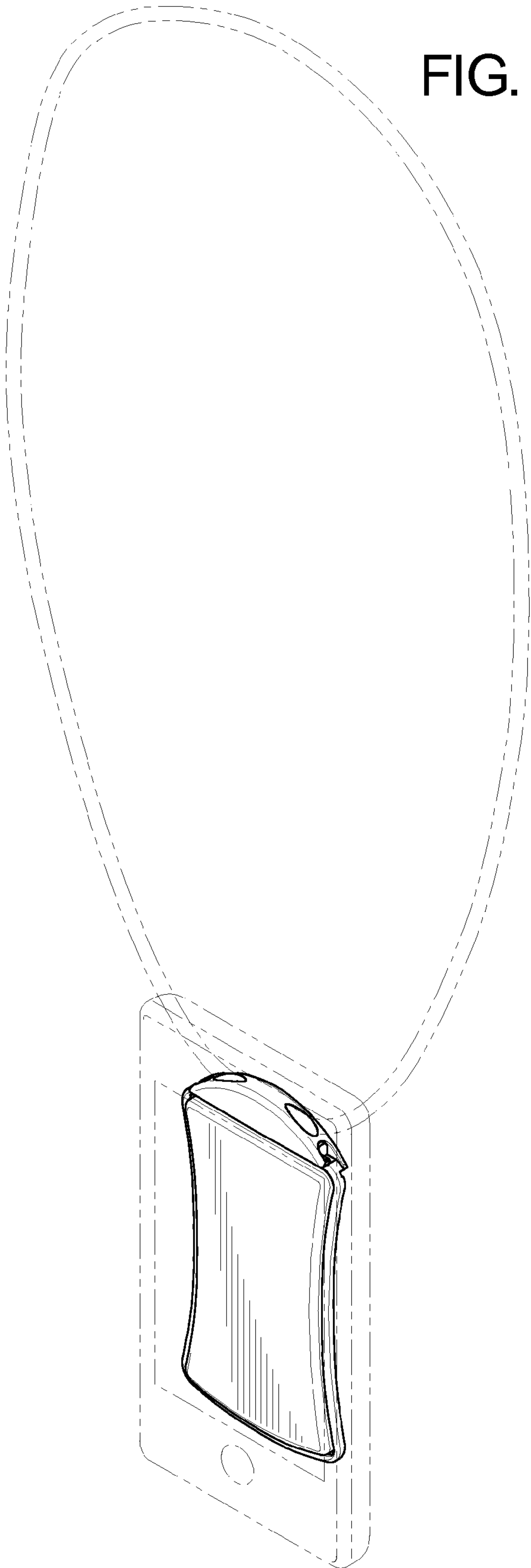

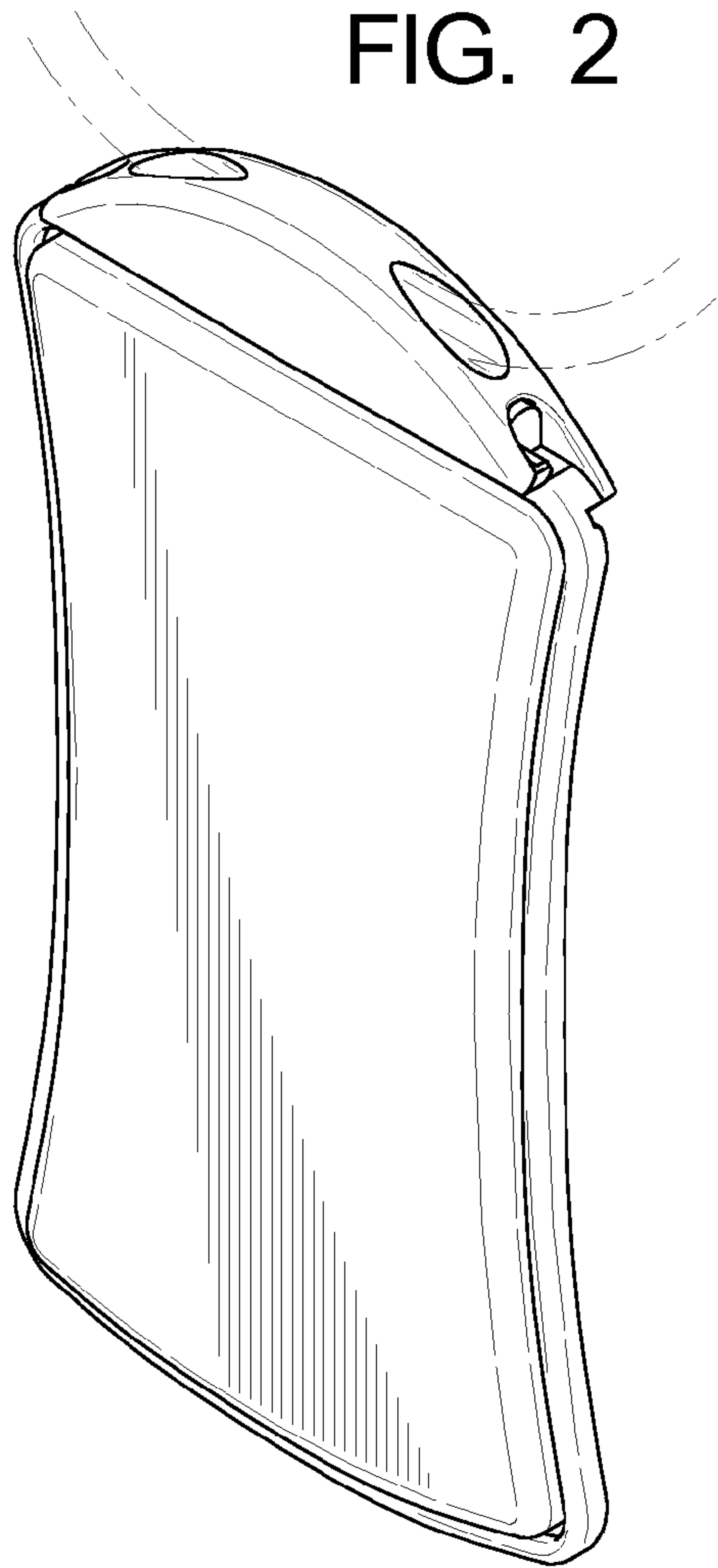

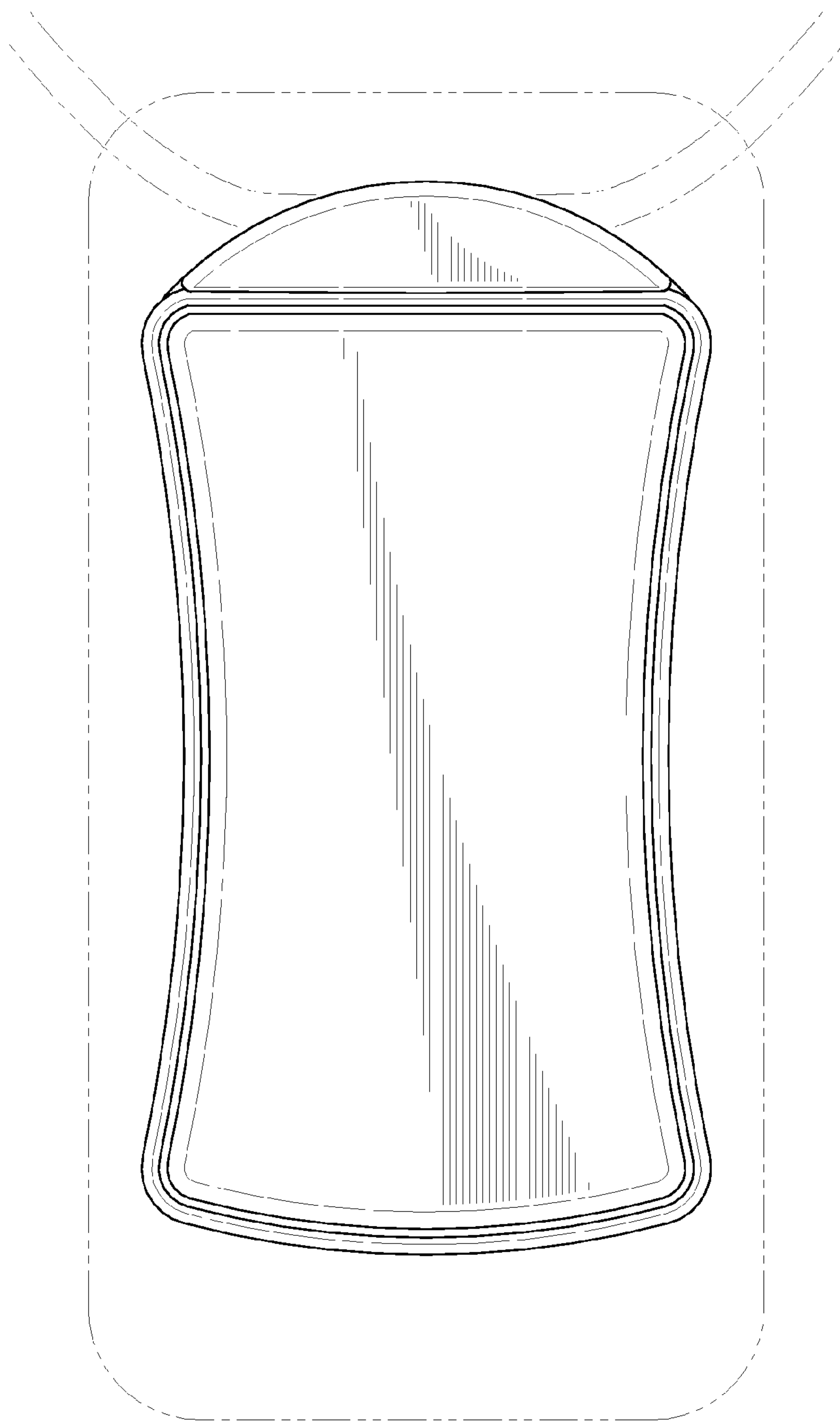

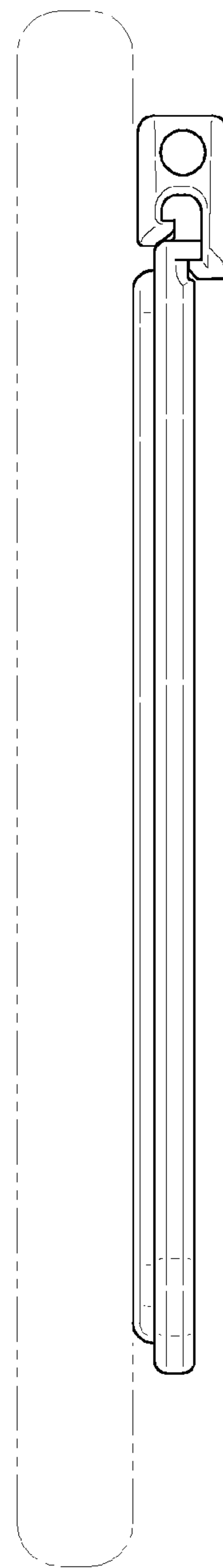

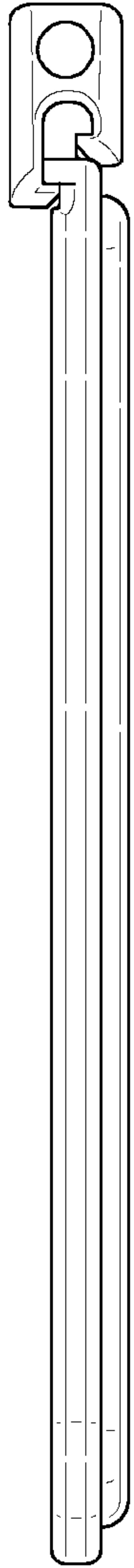

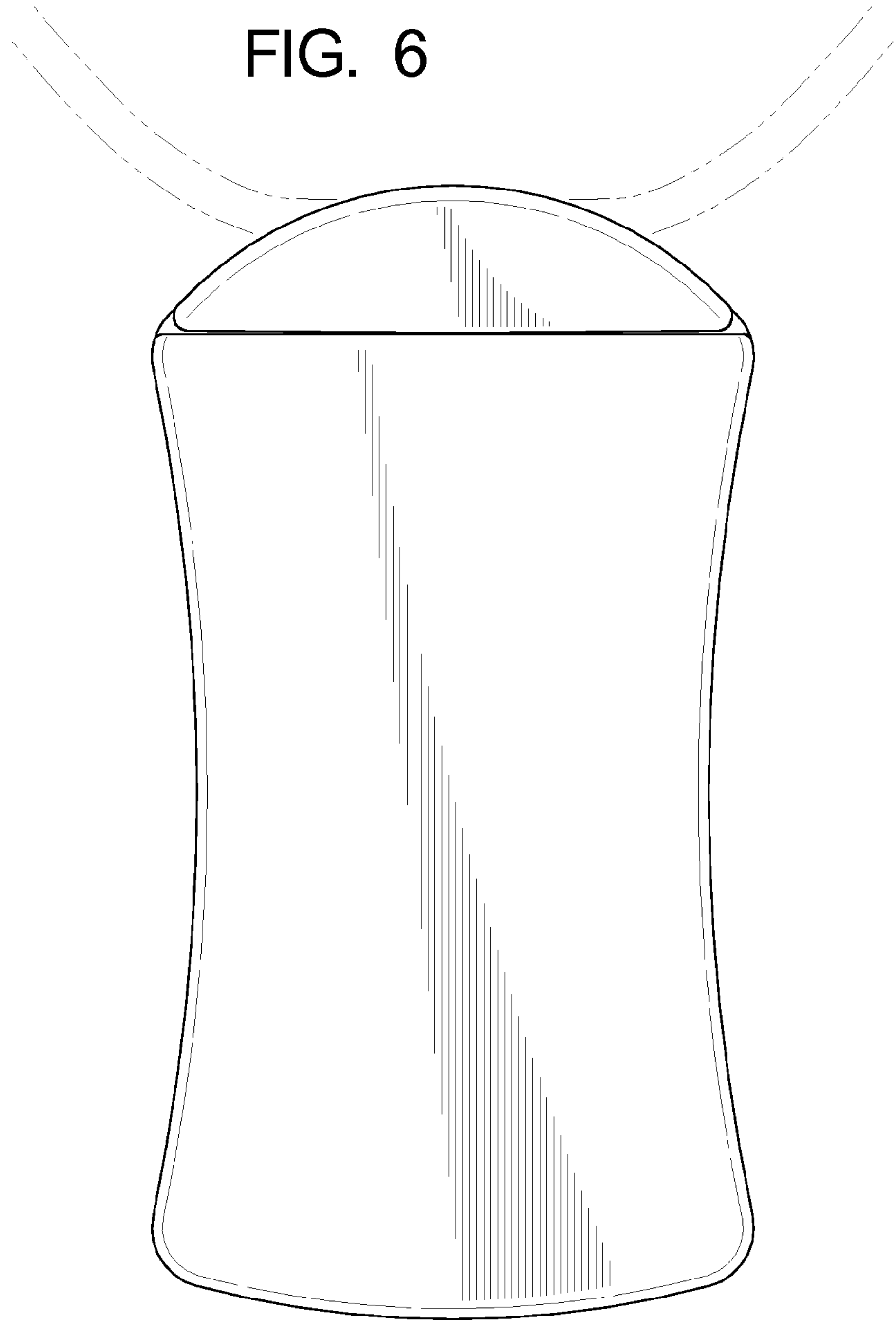

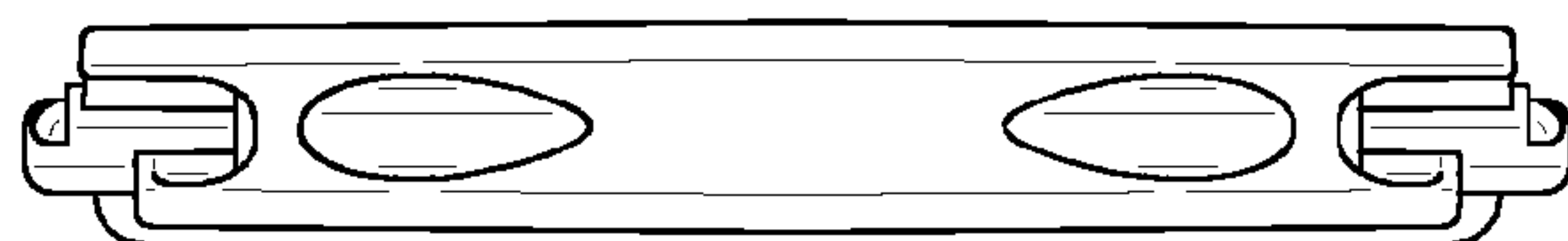
