DESCRIPTION

FIG. 1 is an upper right front perspective view of the pencil
sharpener that shows my design;

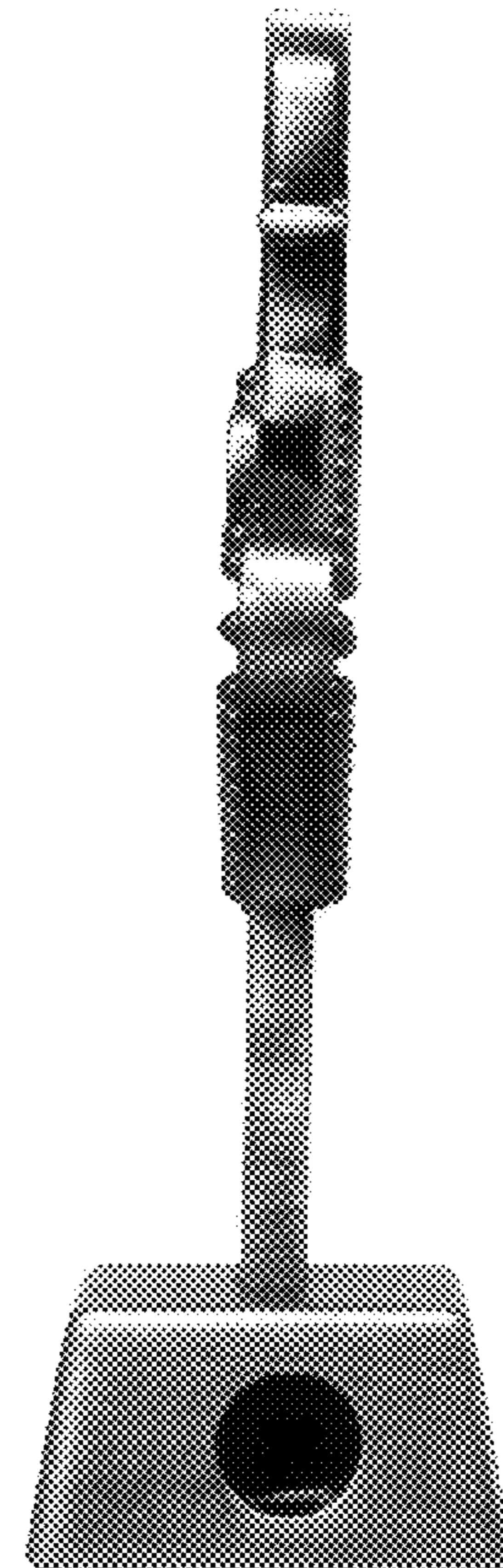

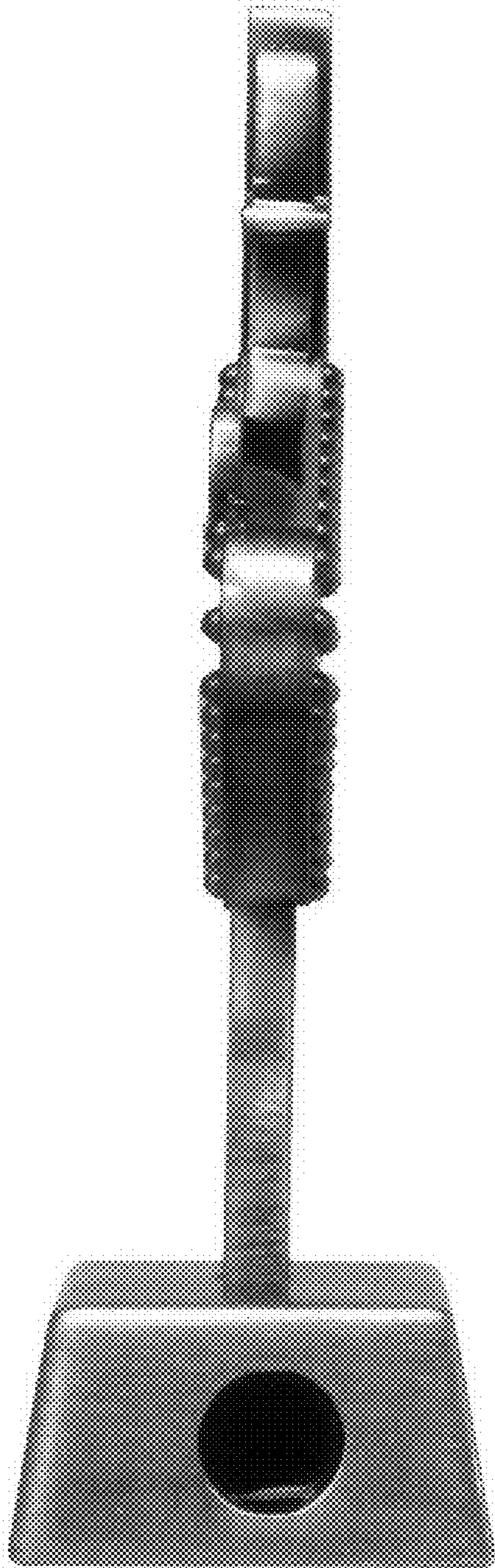

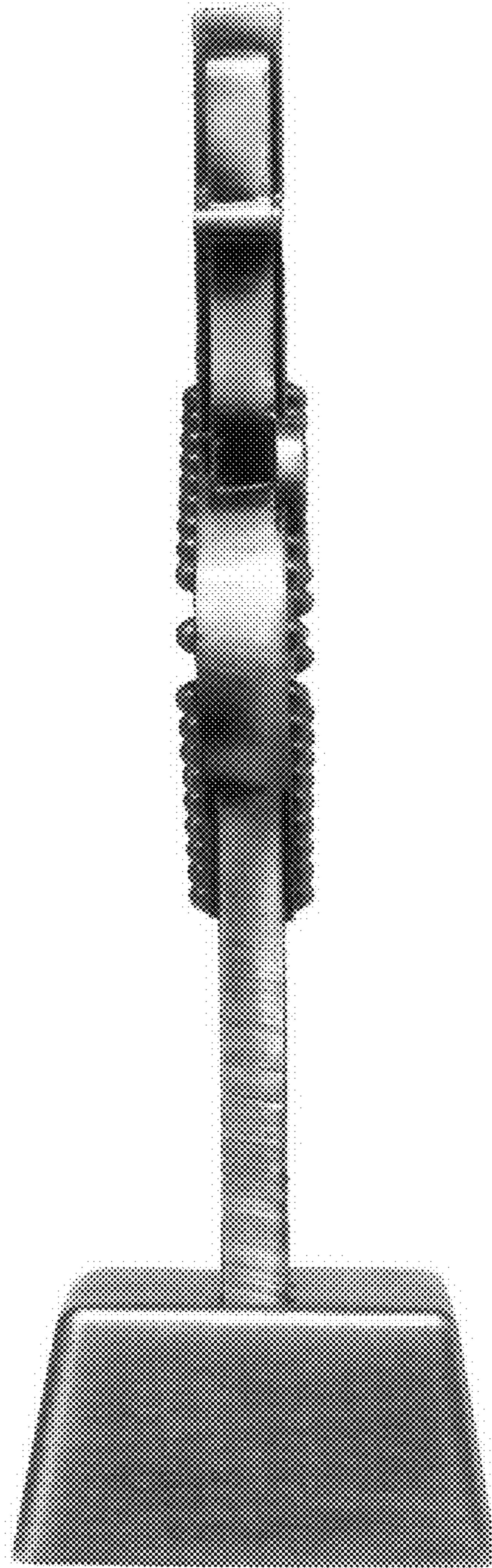

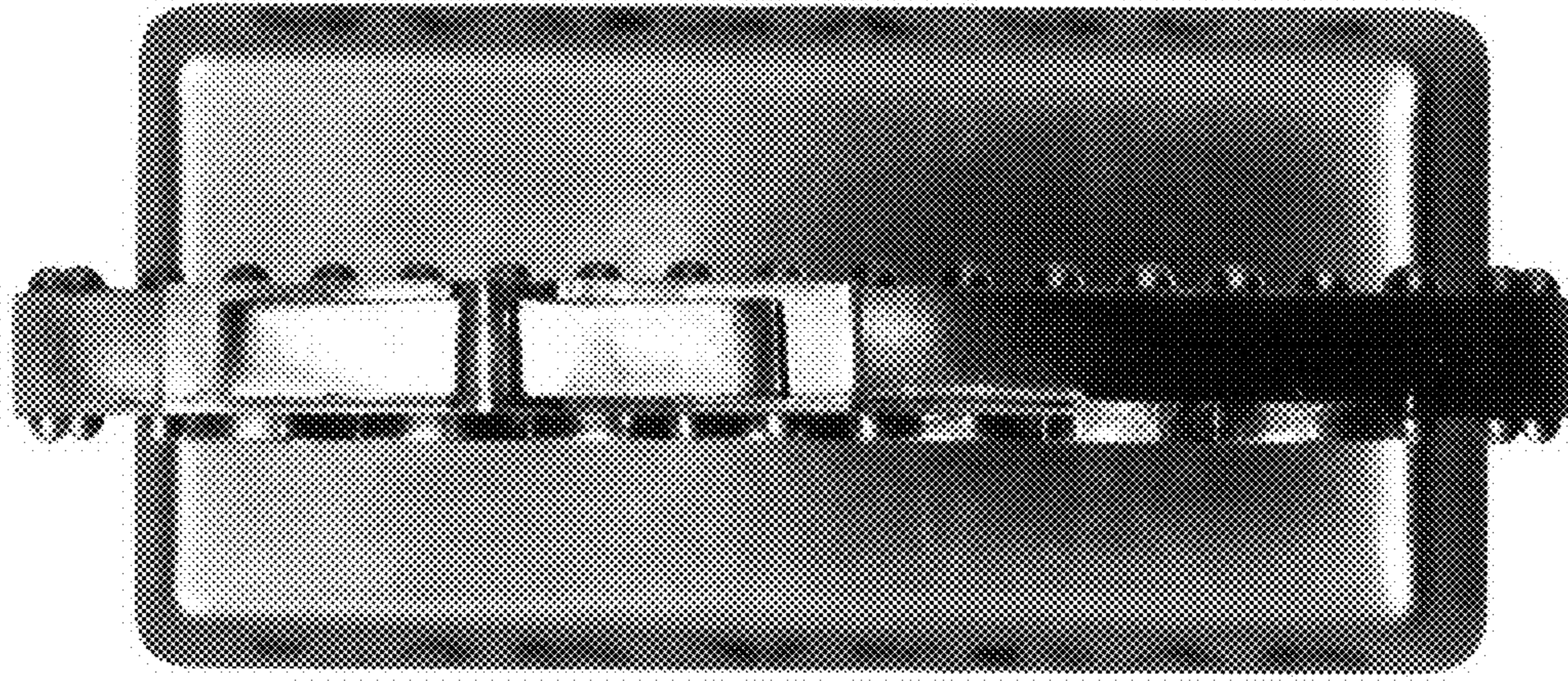

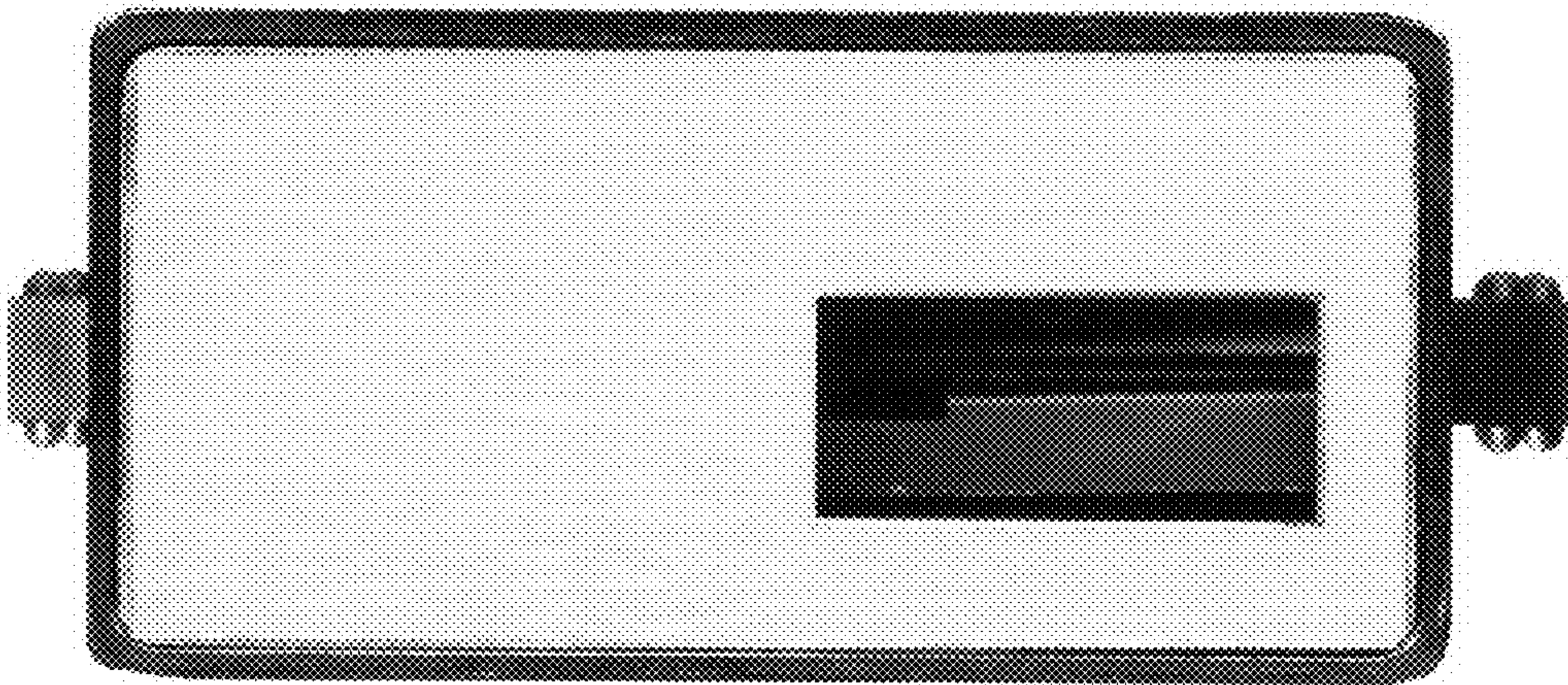
