FIG. 4;

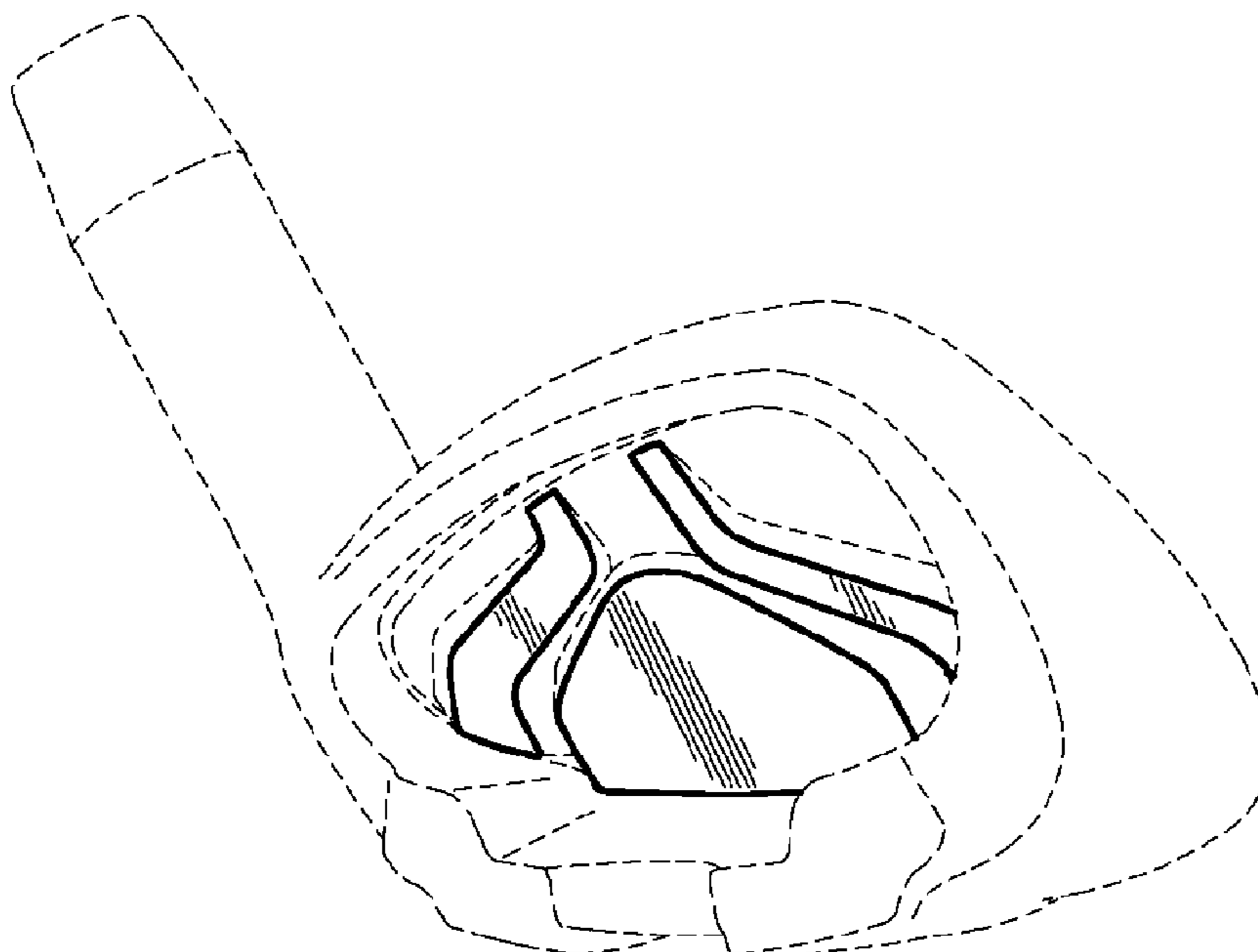
FIG. 7 is a first perspective view of a third embodiment of a

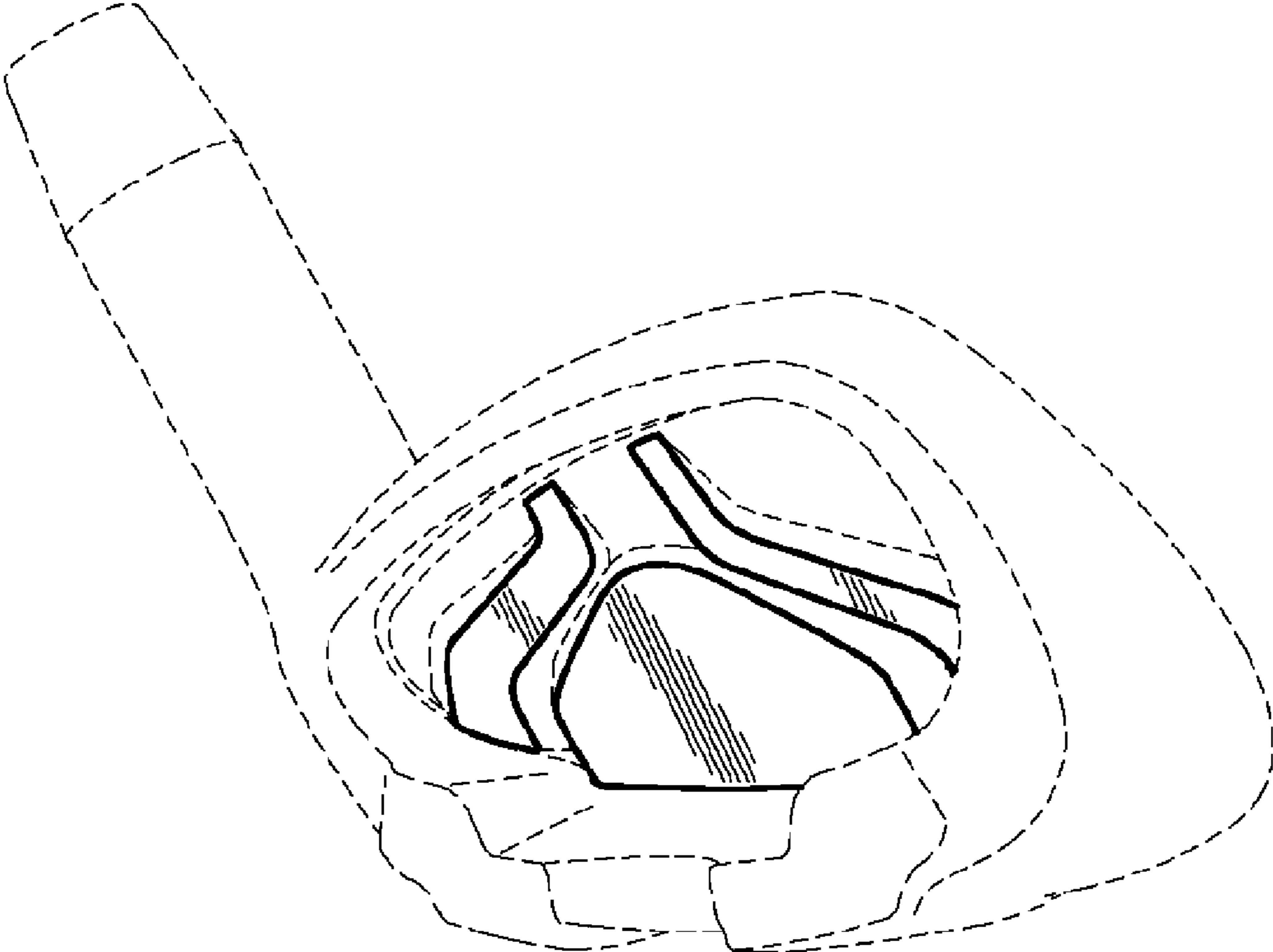

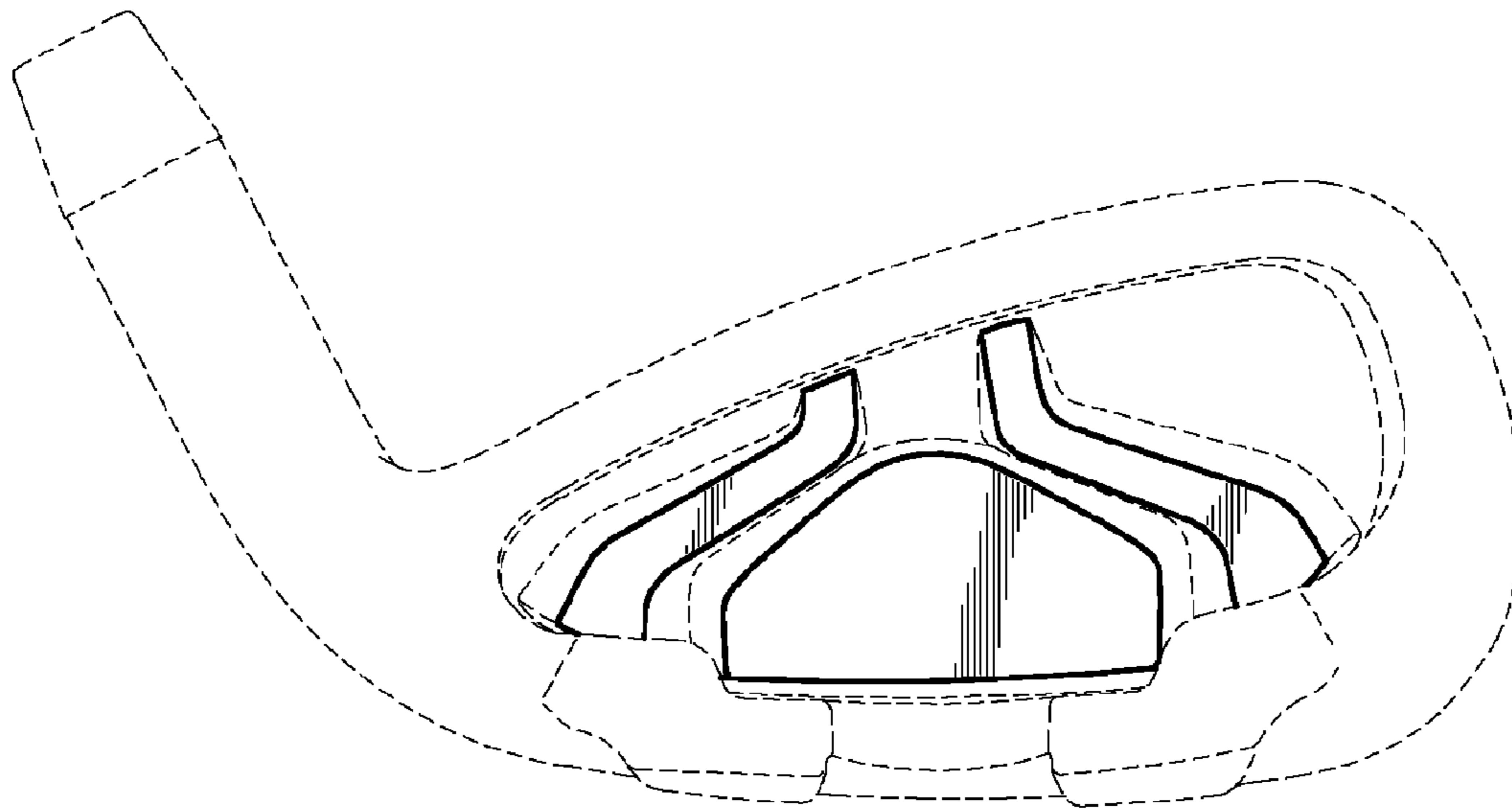

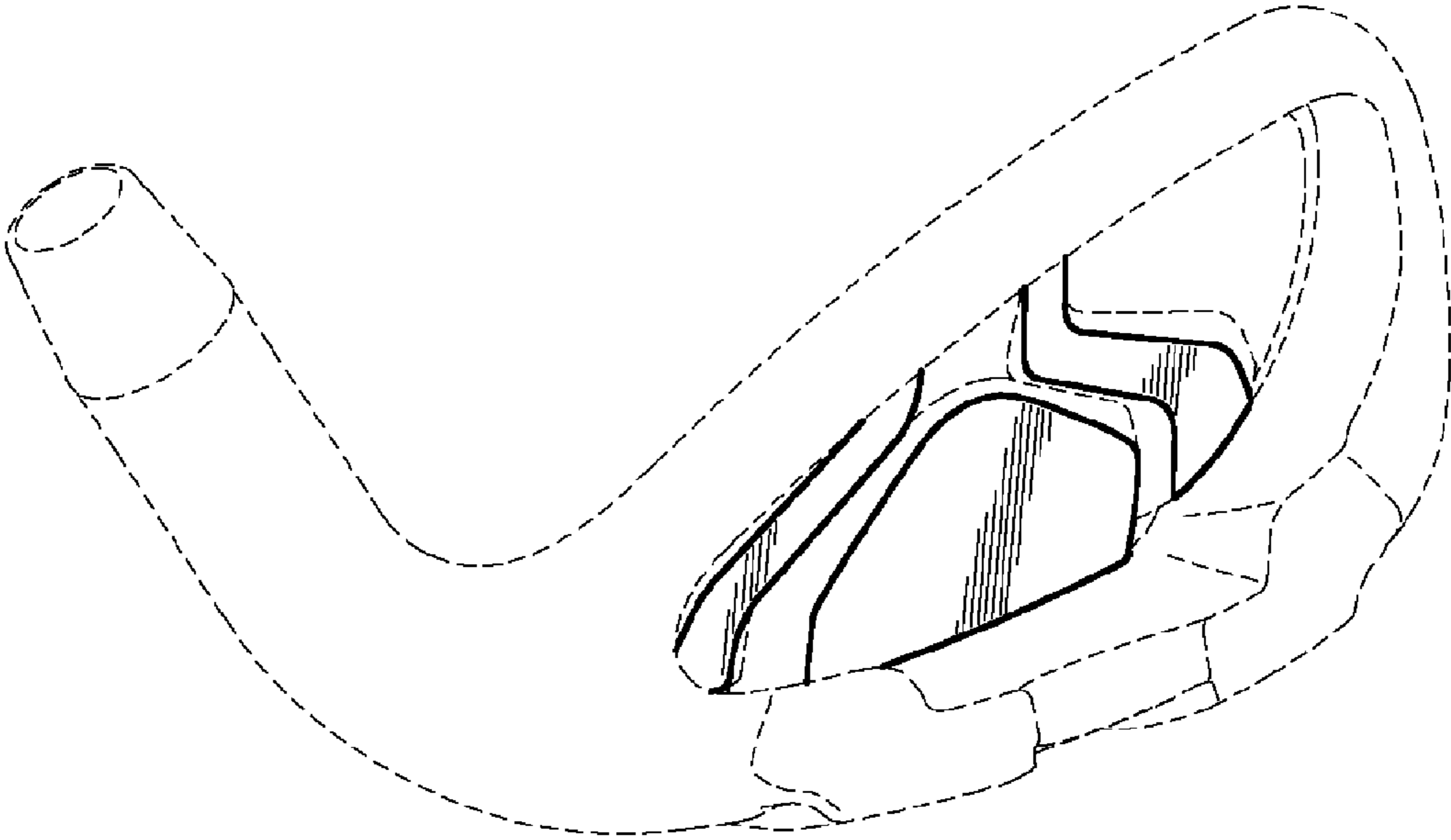

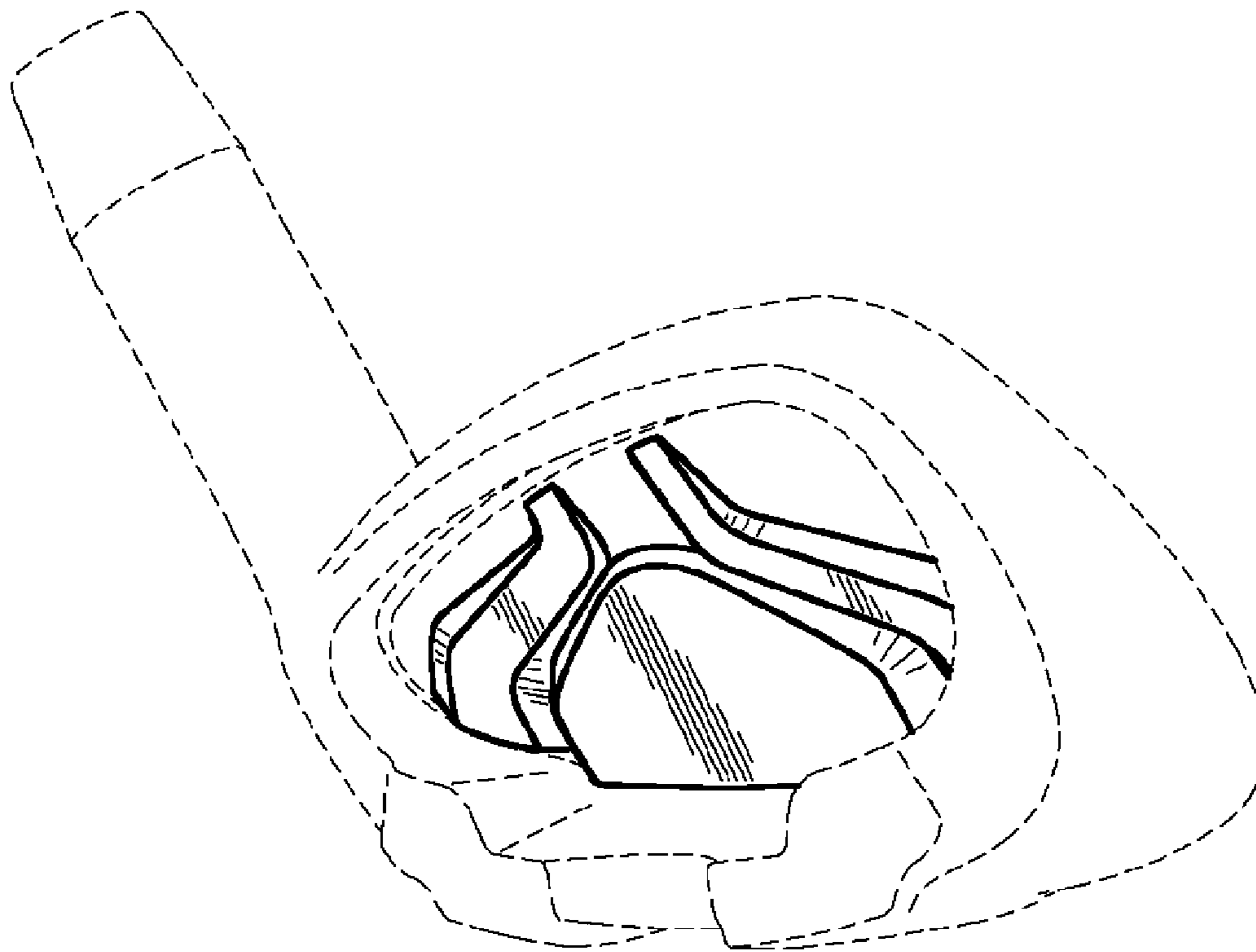

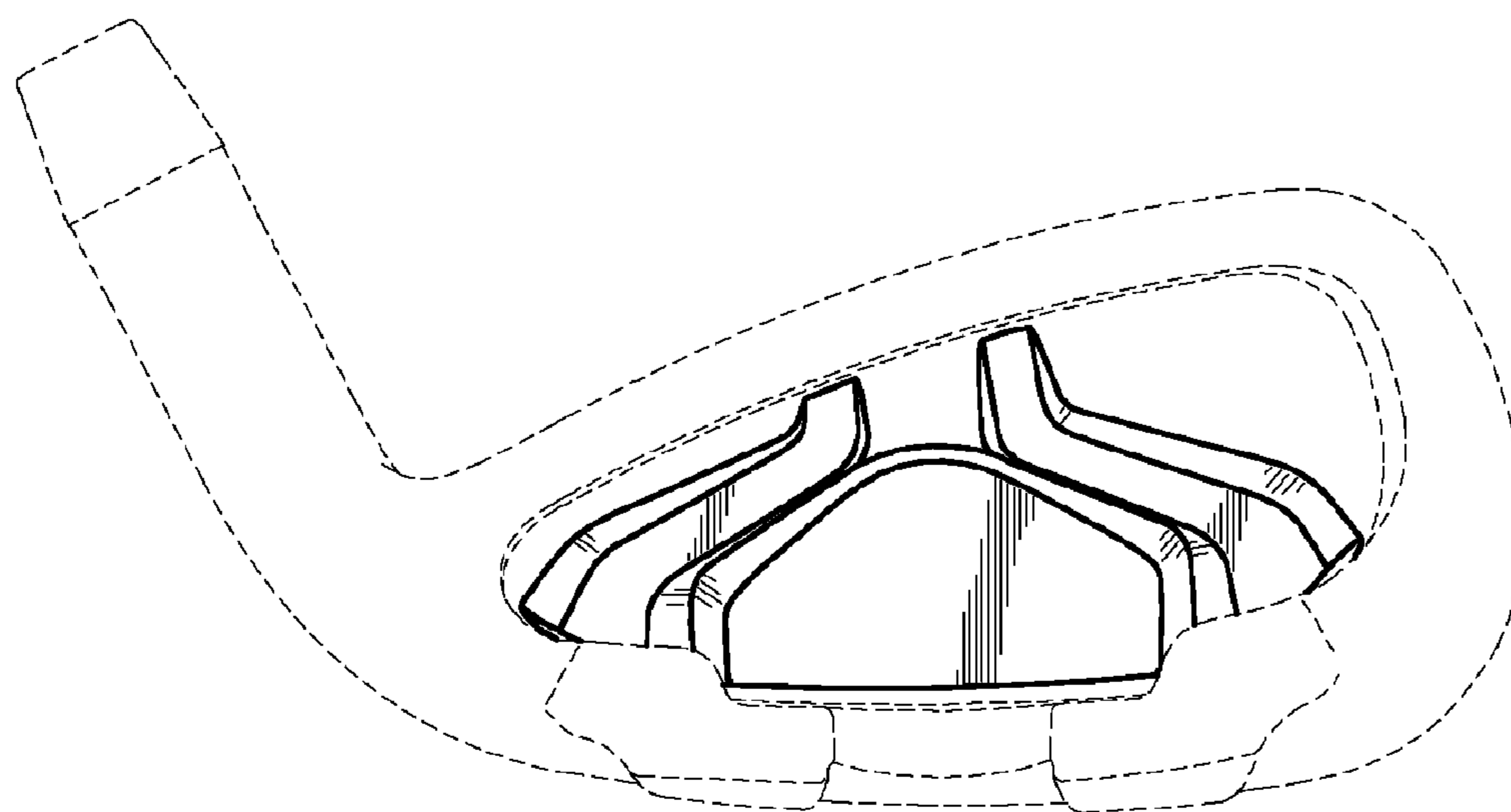

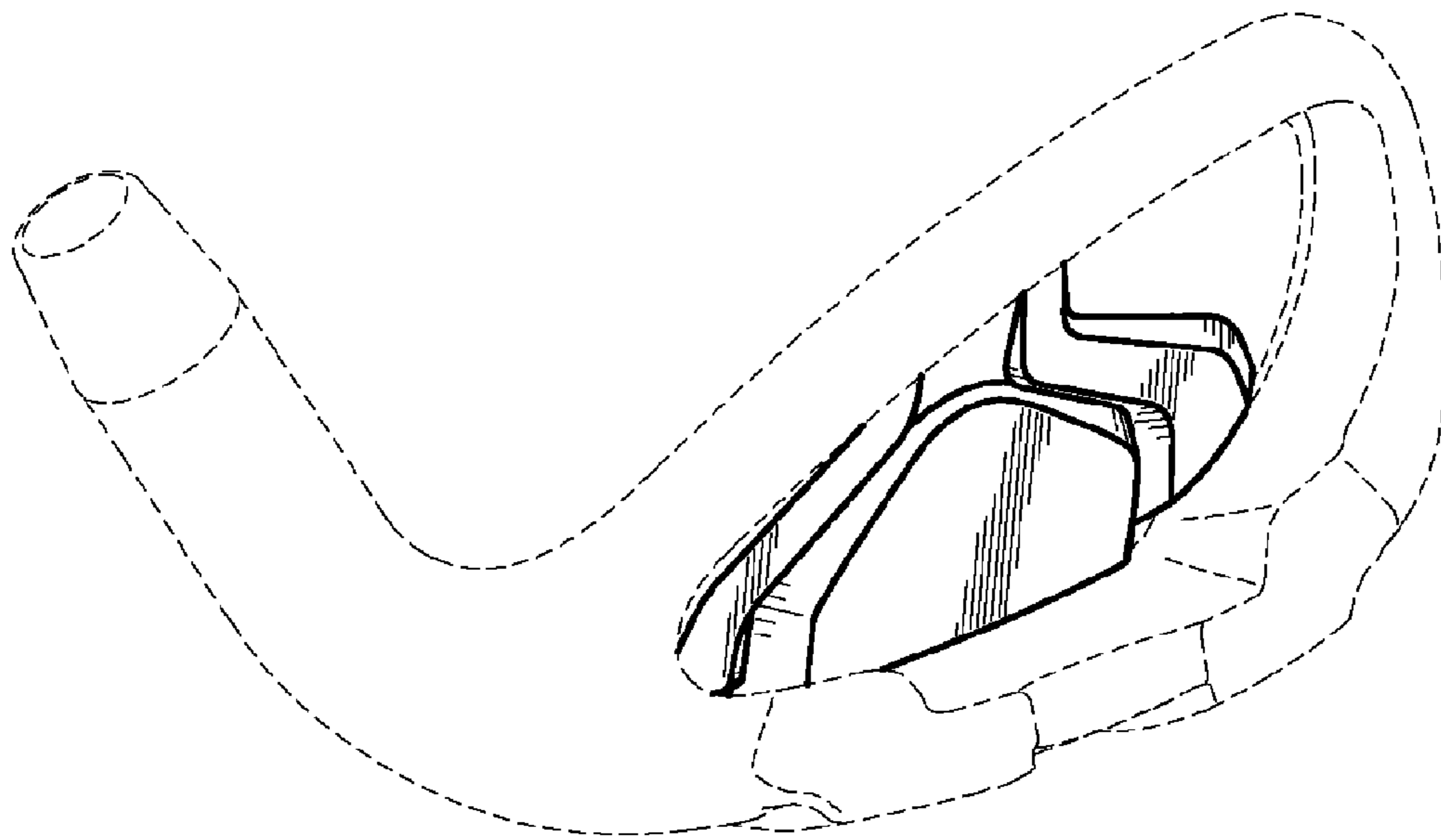

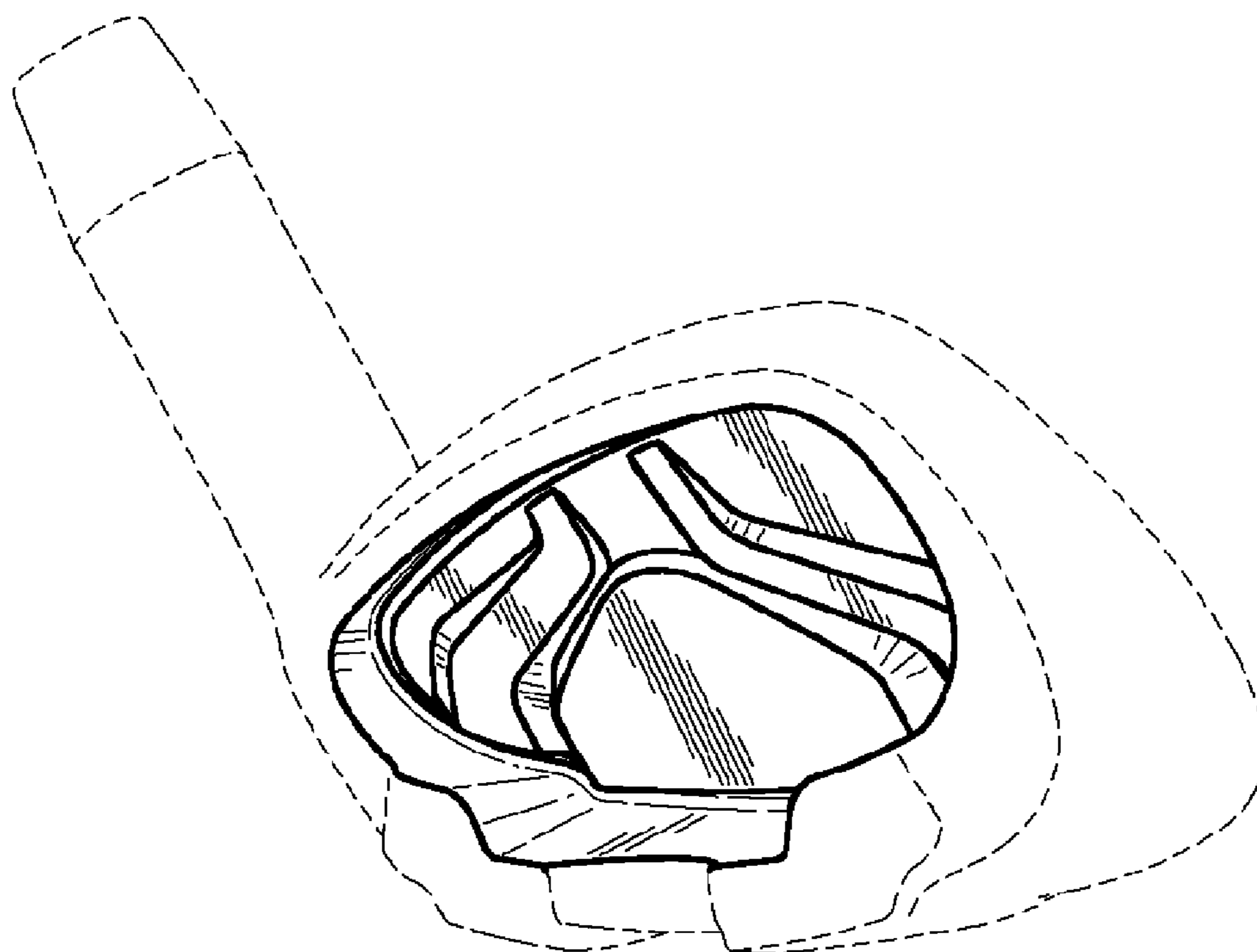

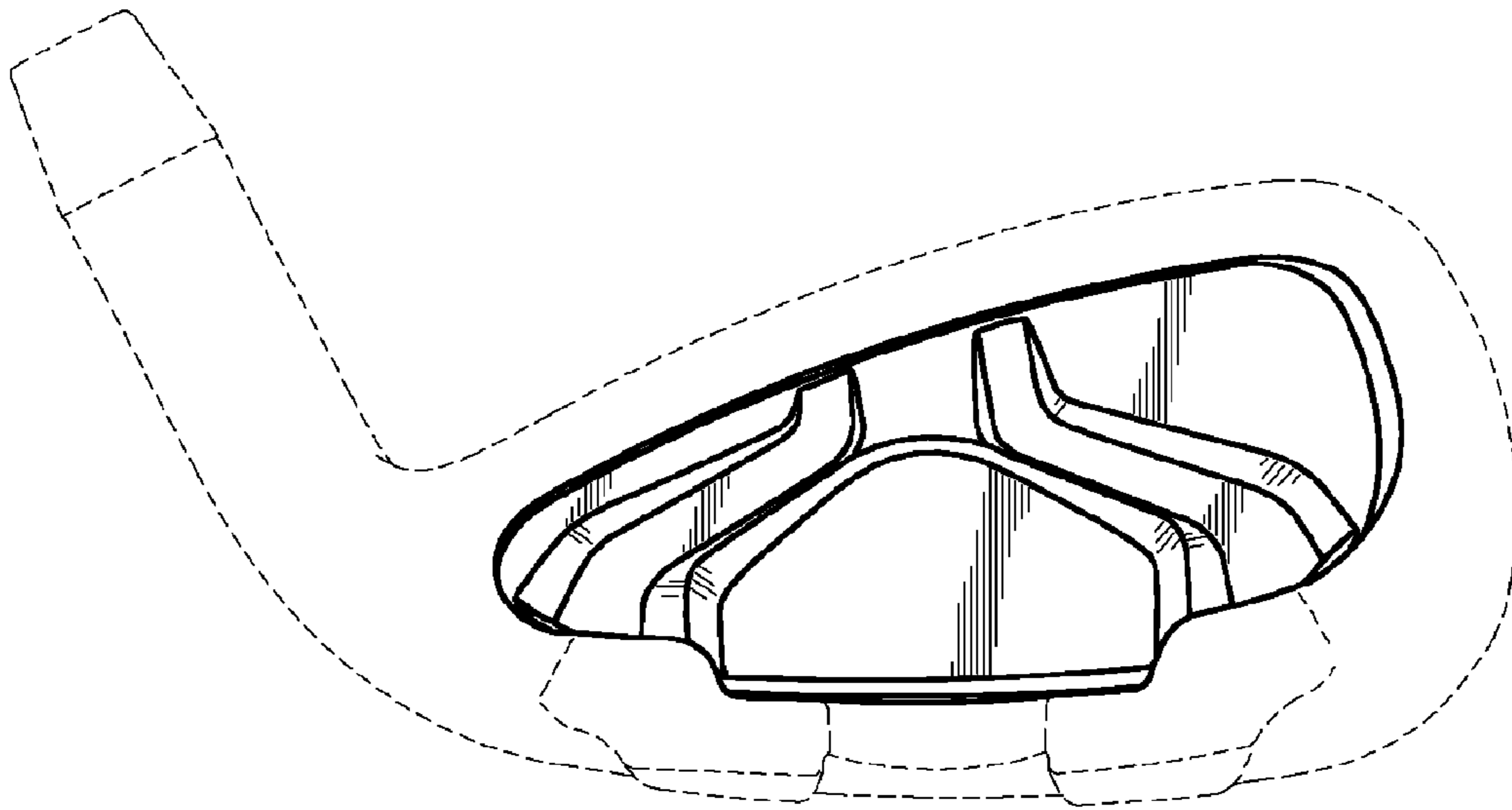

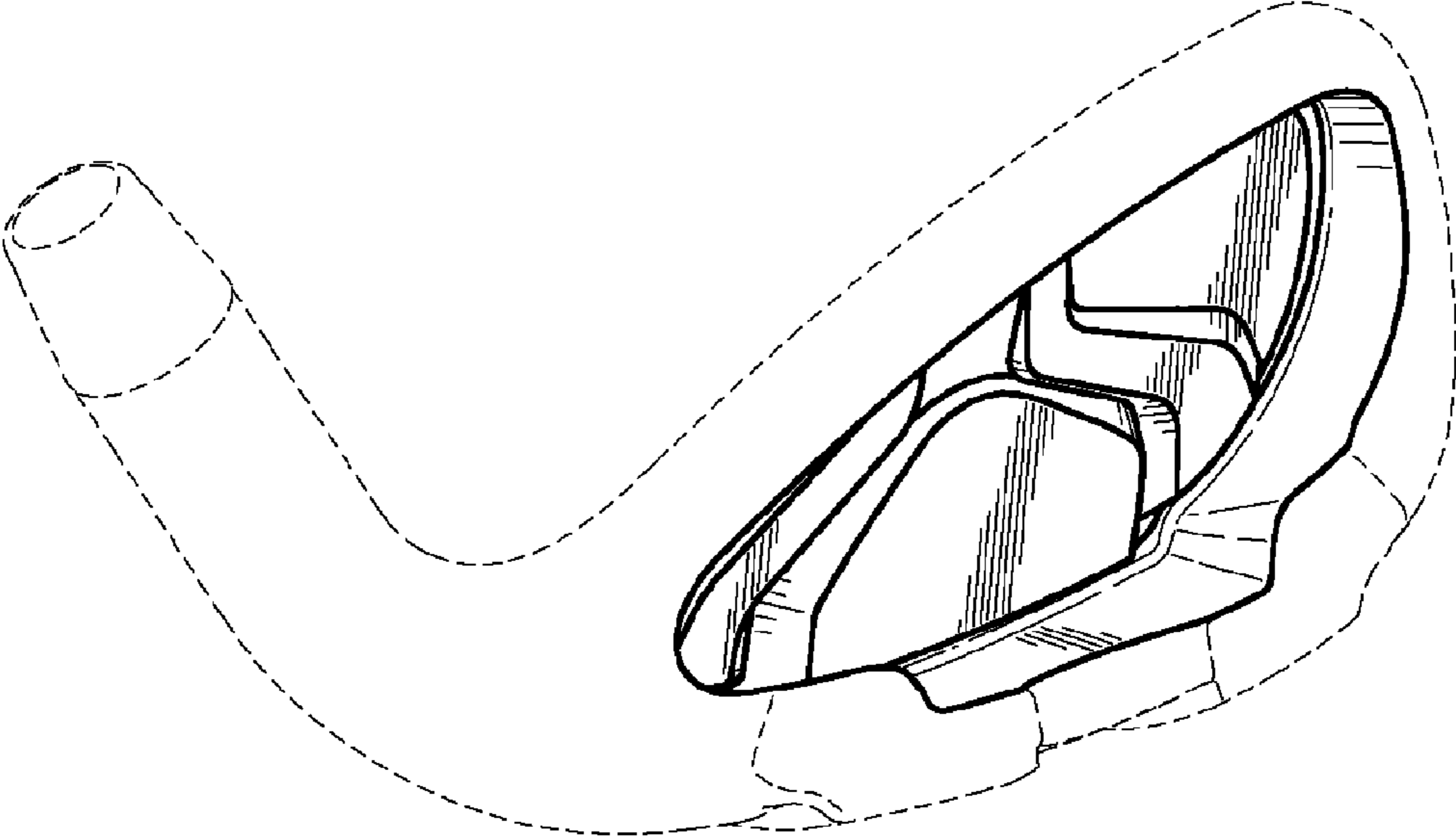
