(57) **CLAIM**

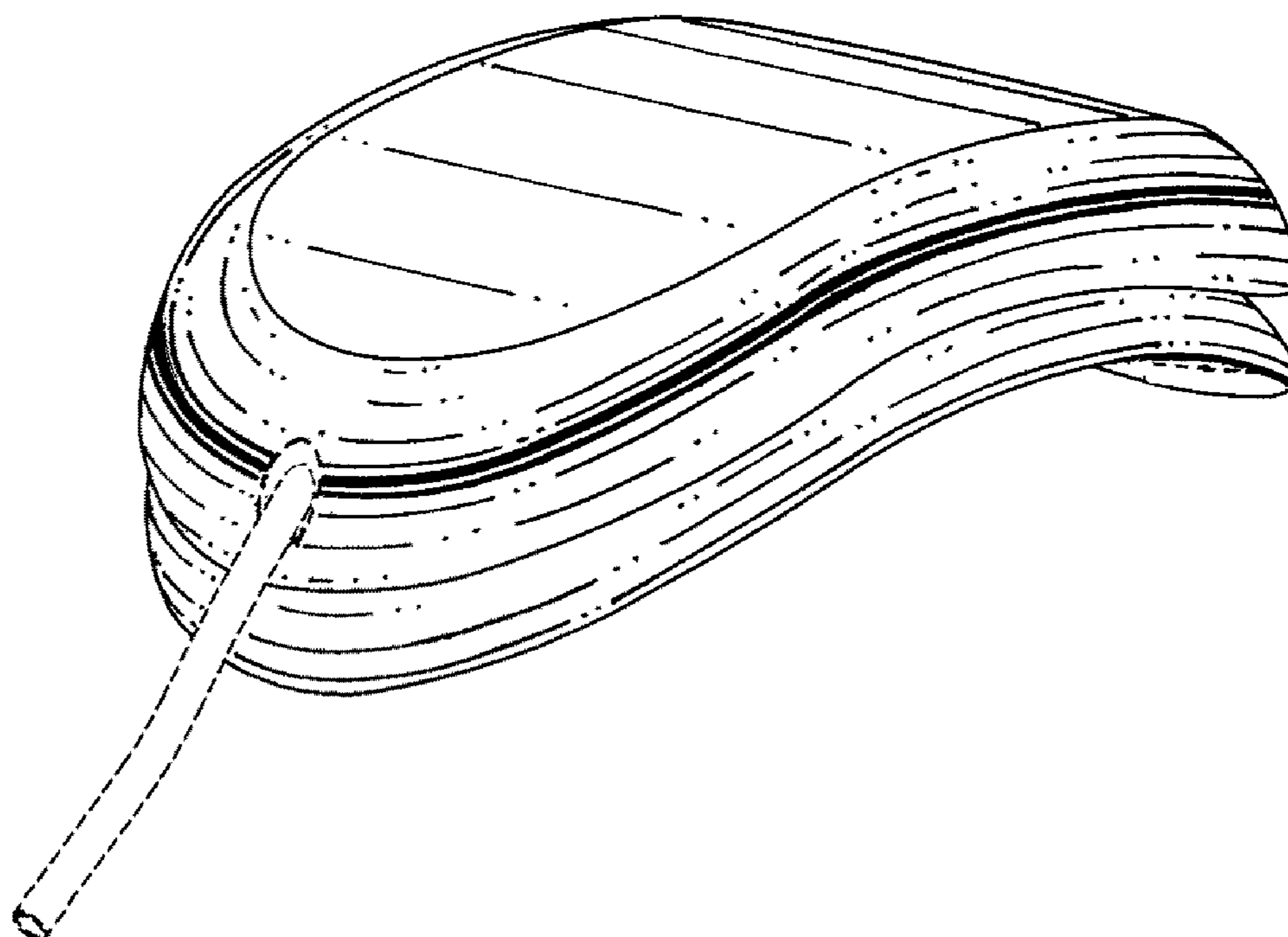
The ornamental design for a skin treatment apparatus, as shown and described.

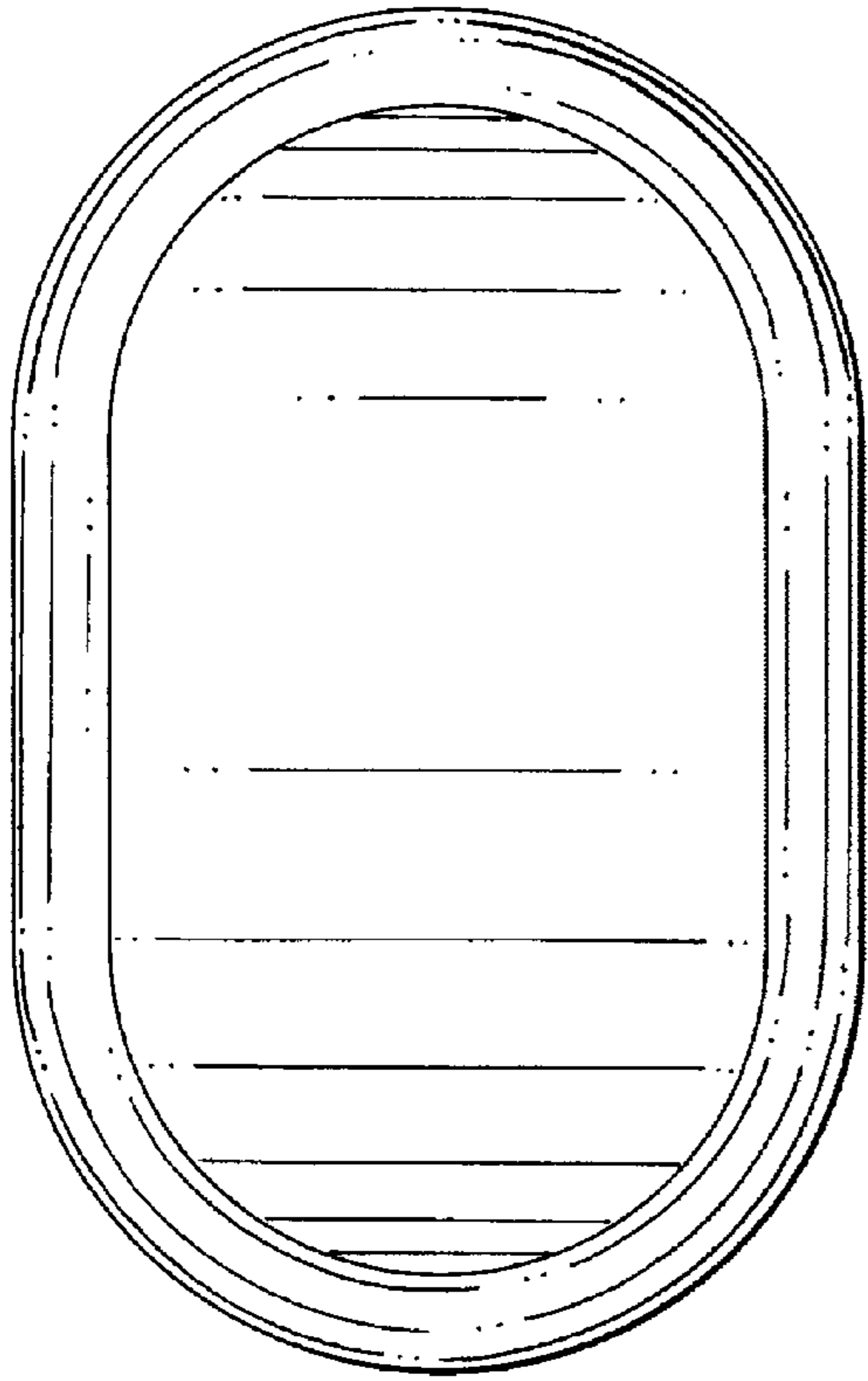

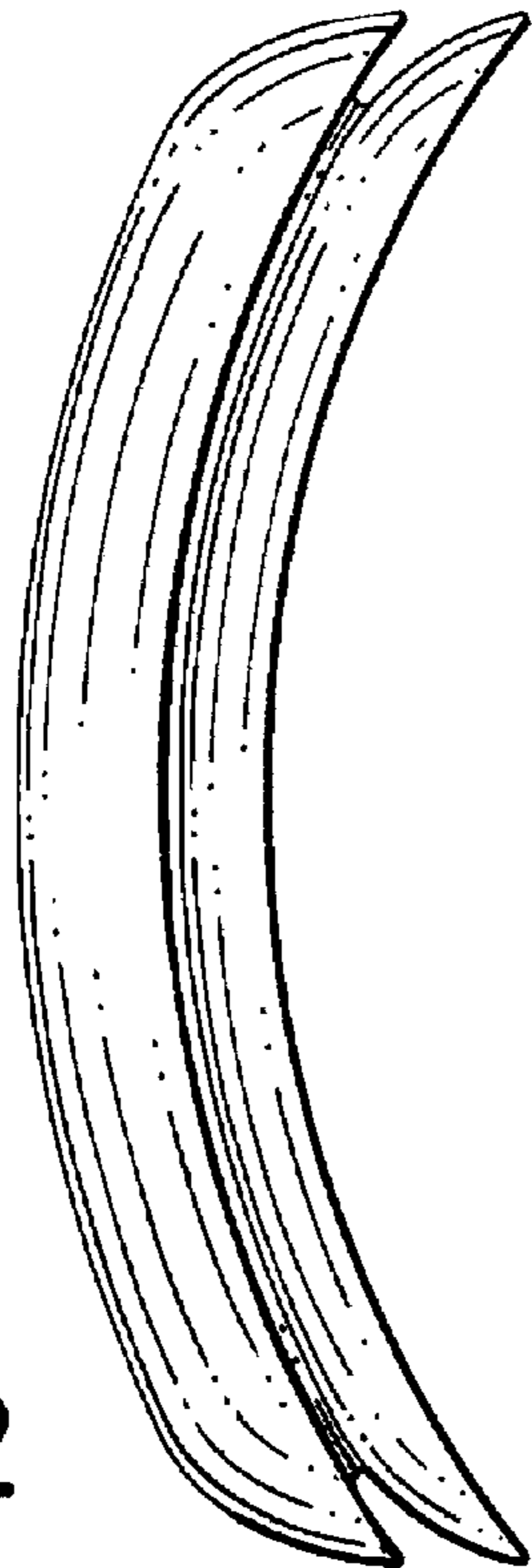

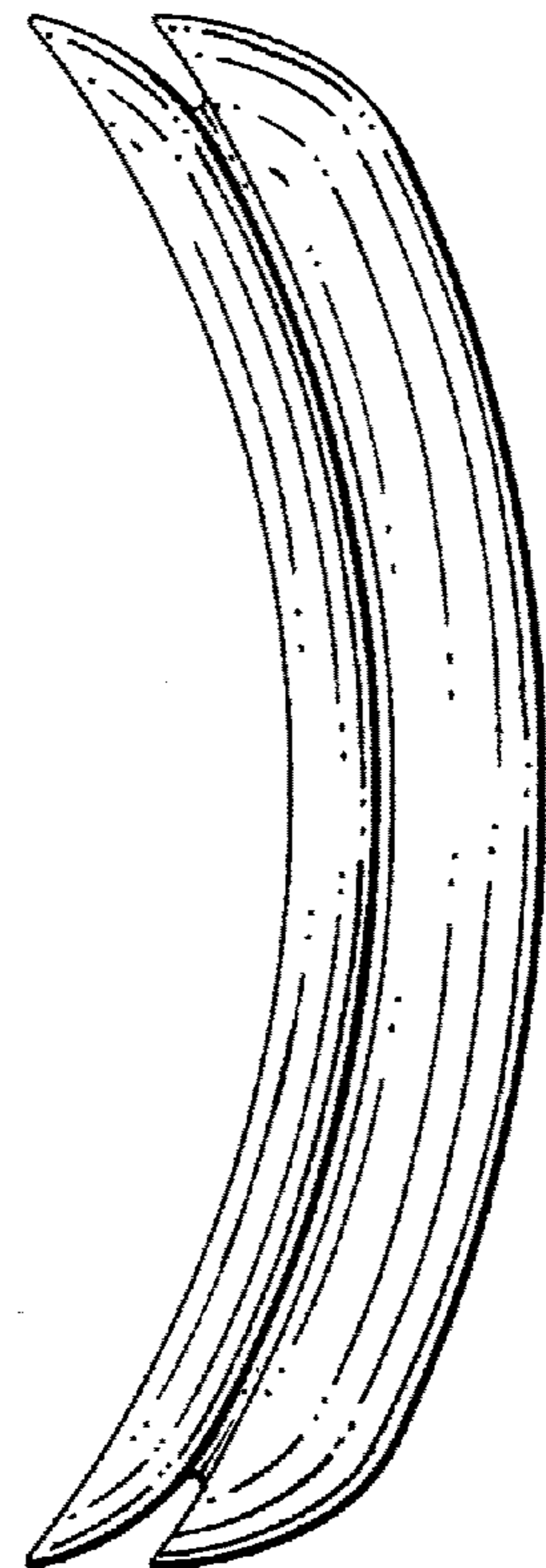

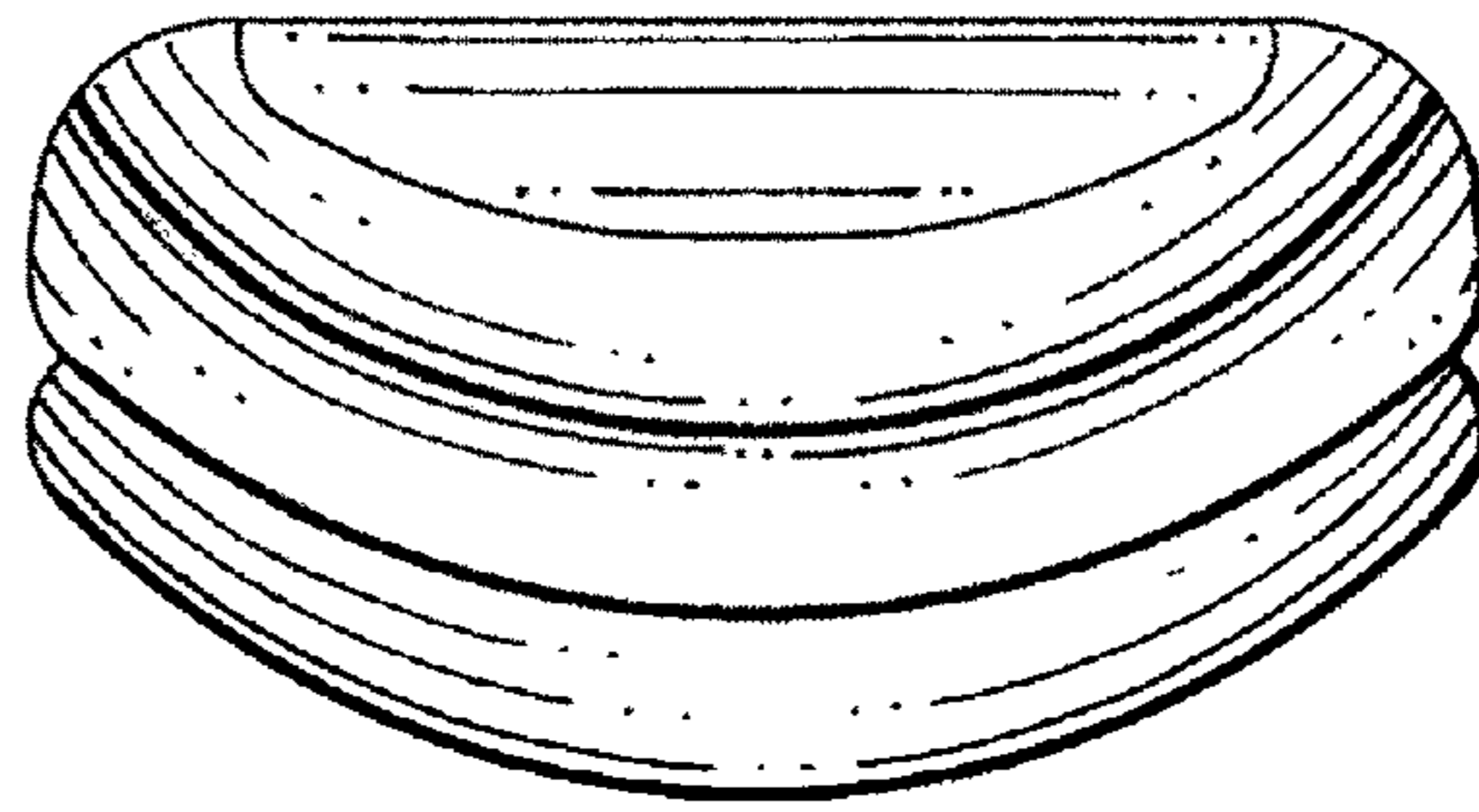

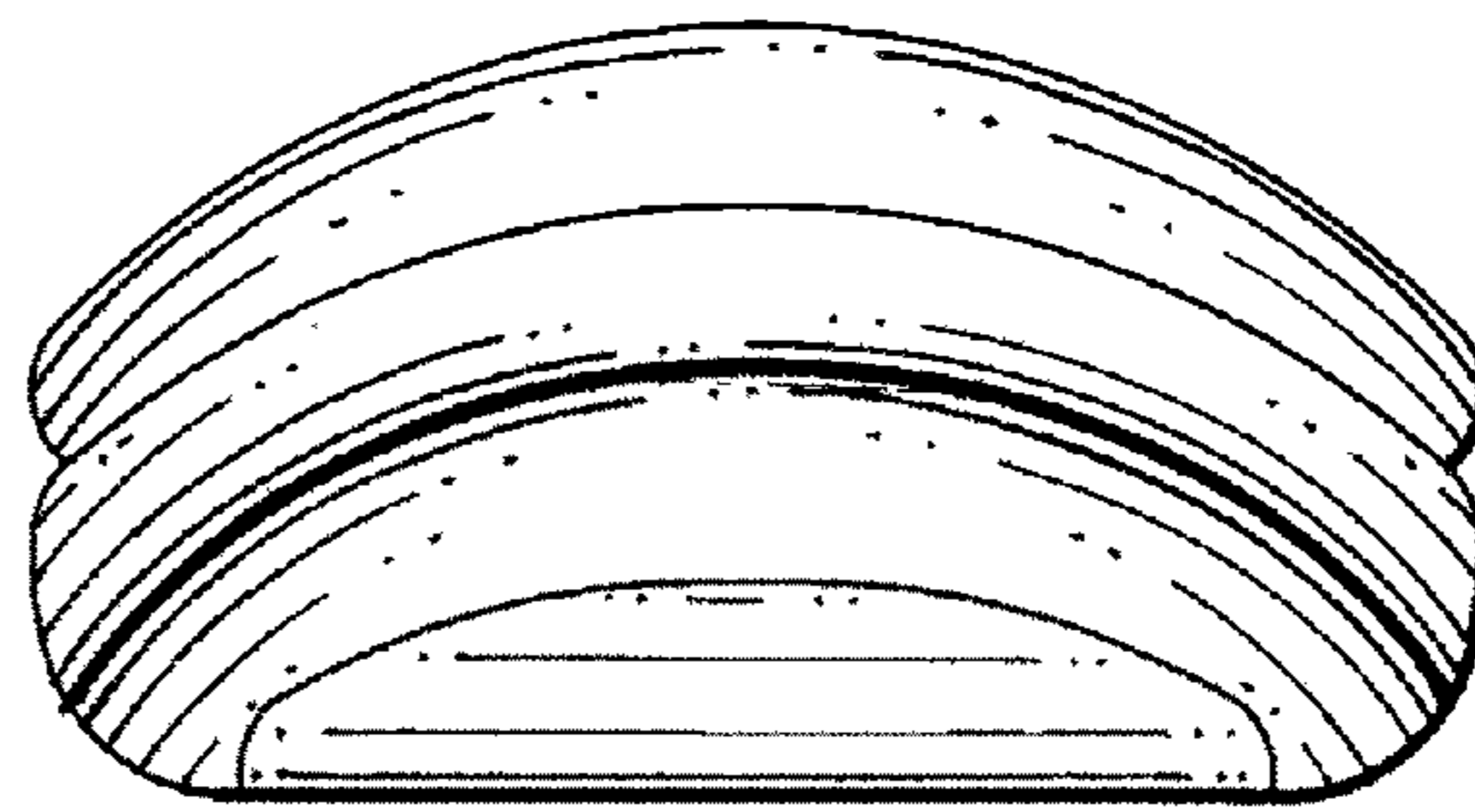

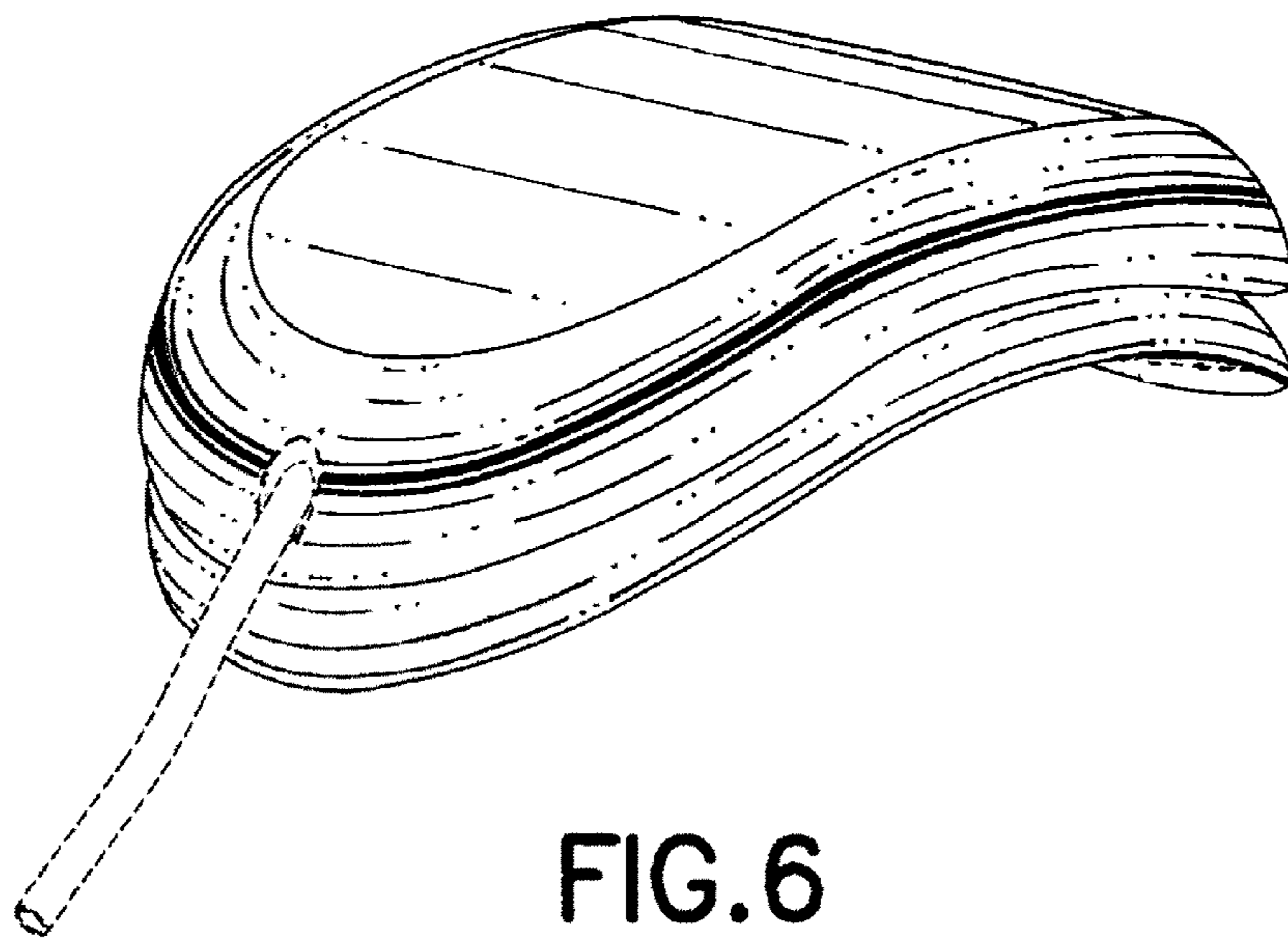
