The ornamental design for a frozen confection, as shown and described.

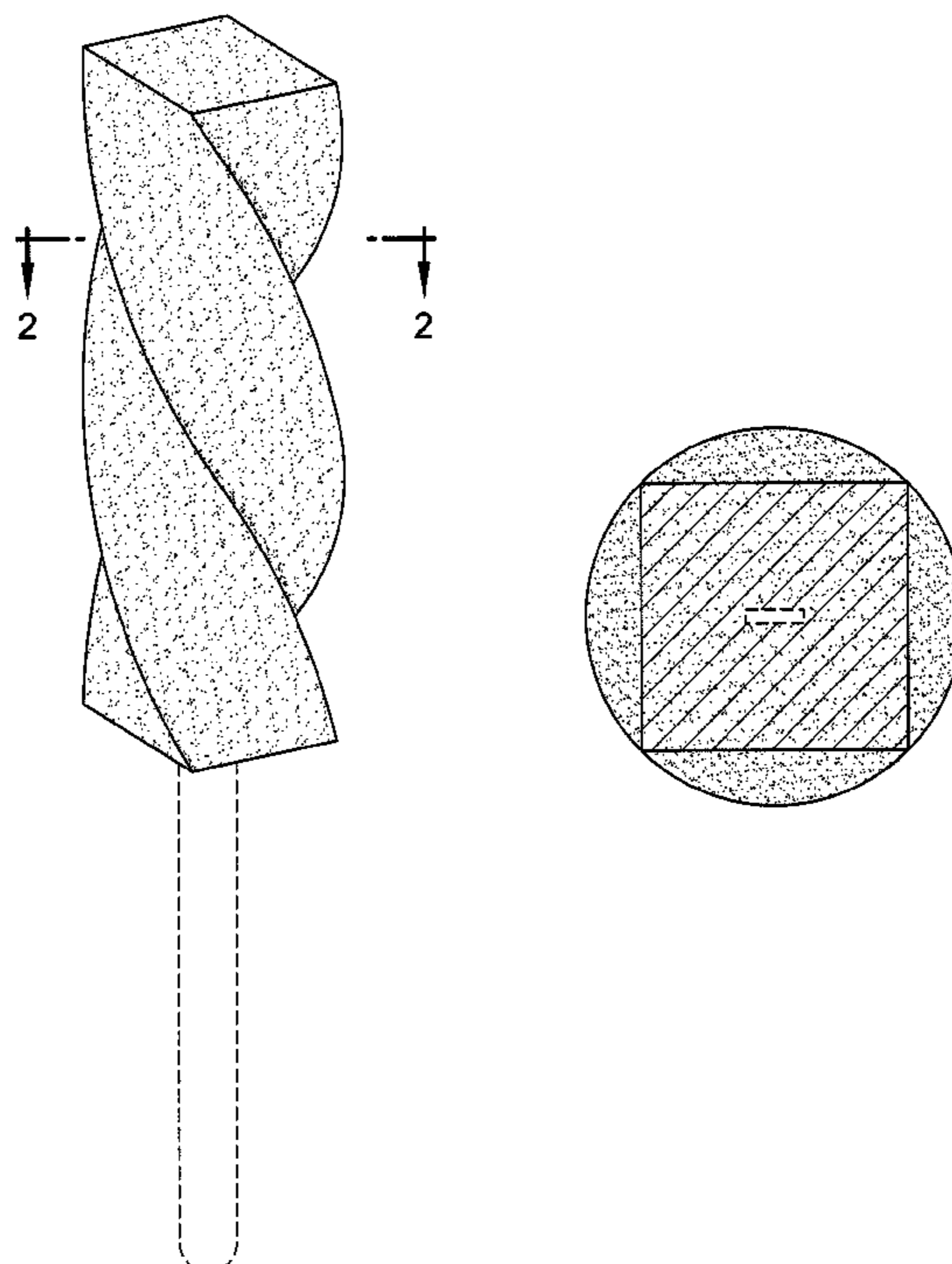
DESCRIPTION

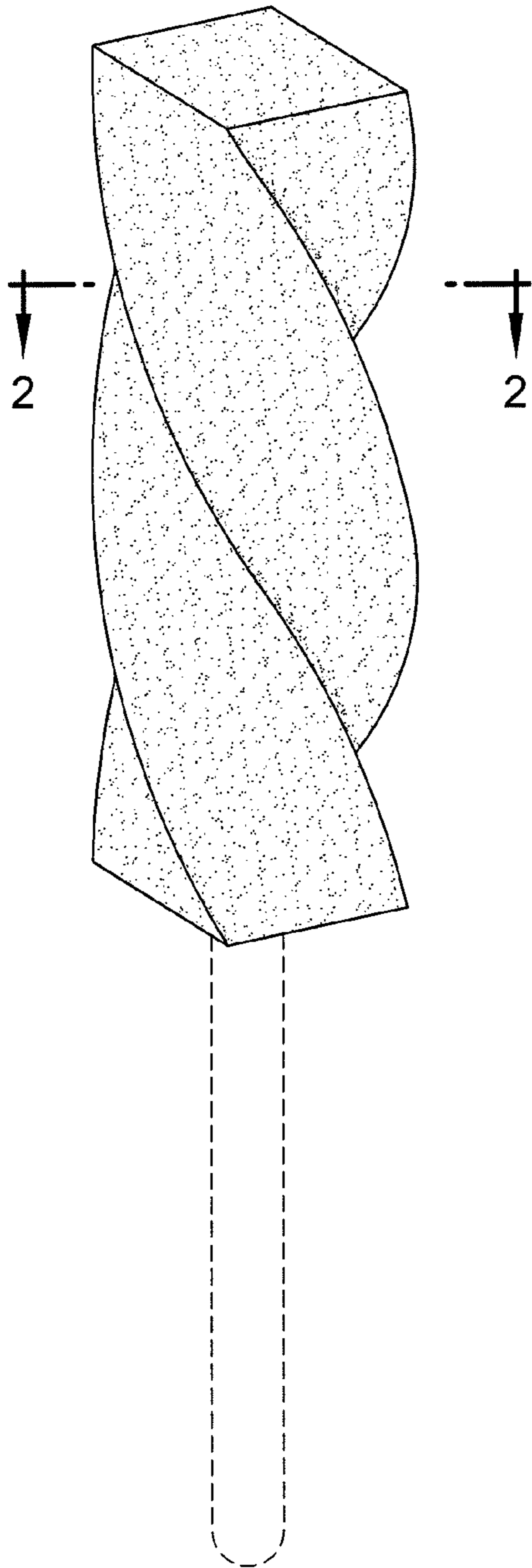

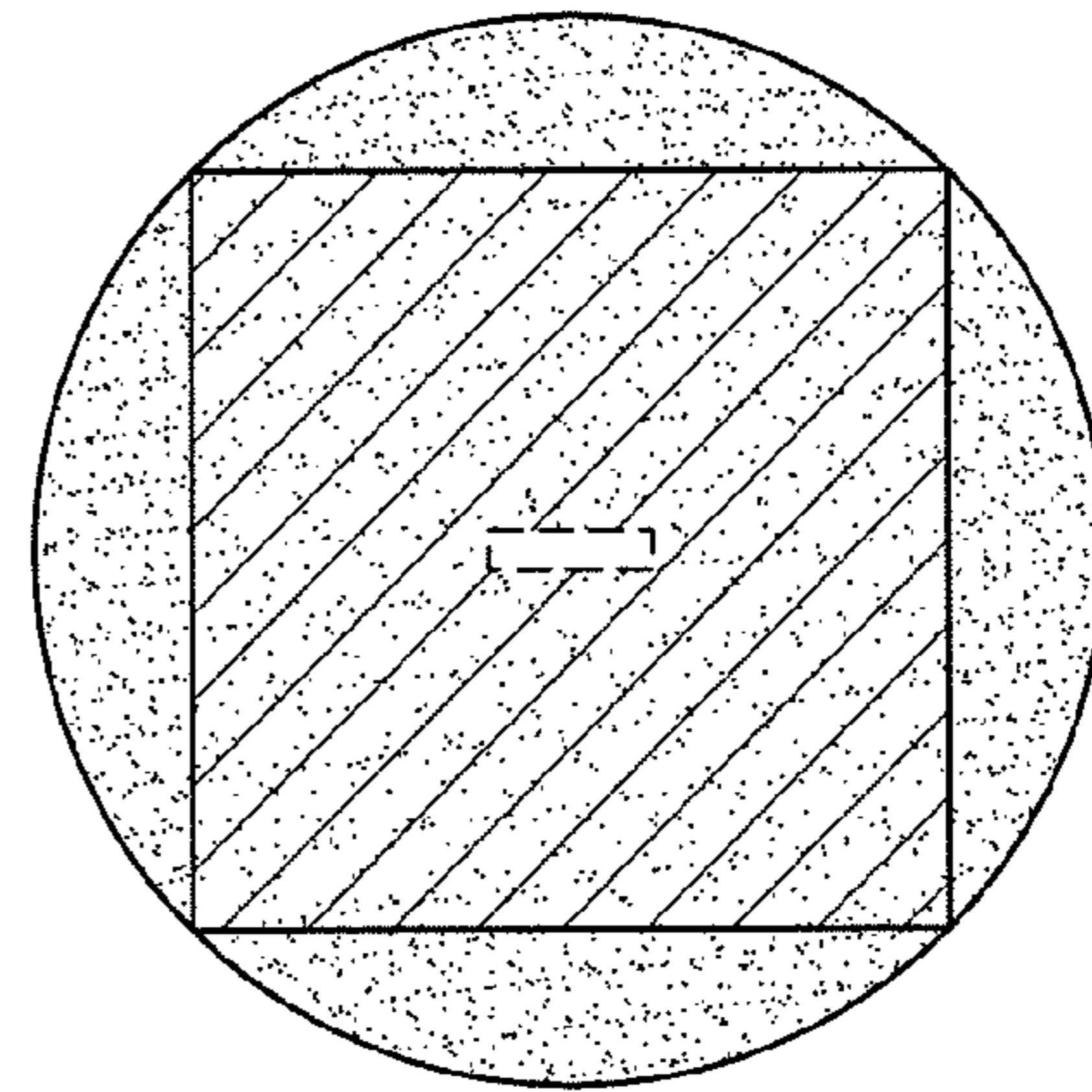
