The ornamental design for a ladies wrap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the ladies wrap showing my new design.

FIG. 2 is a top view thereof.

FIG. 3 is a side view thereof.

FIG. 4 is a bottom view thereof.

FIG. 5 is a front view of the ladies wrap of the second embodiment, having a more uniform width.

FIG. 6 is a top view thereof.

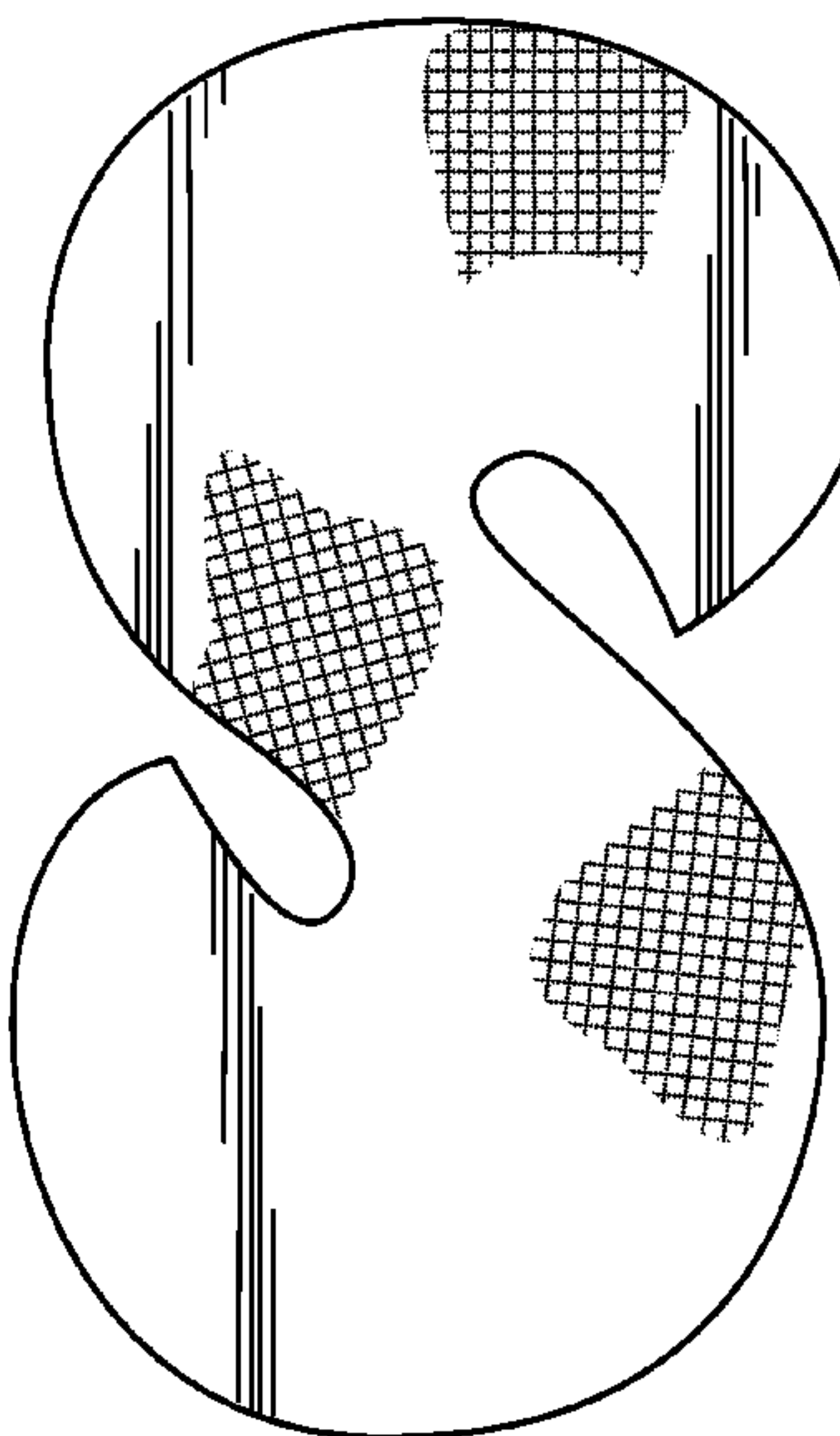
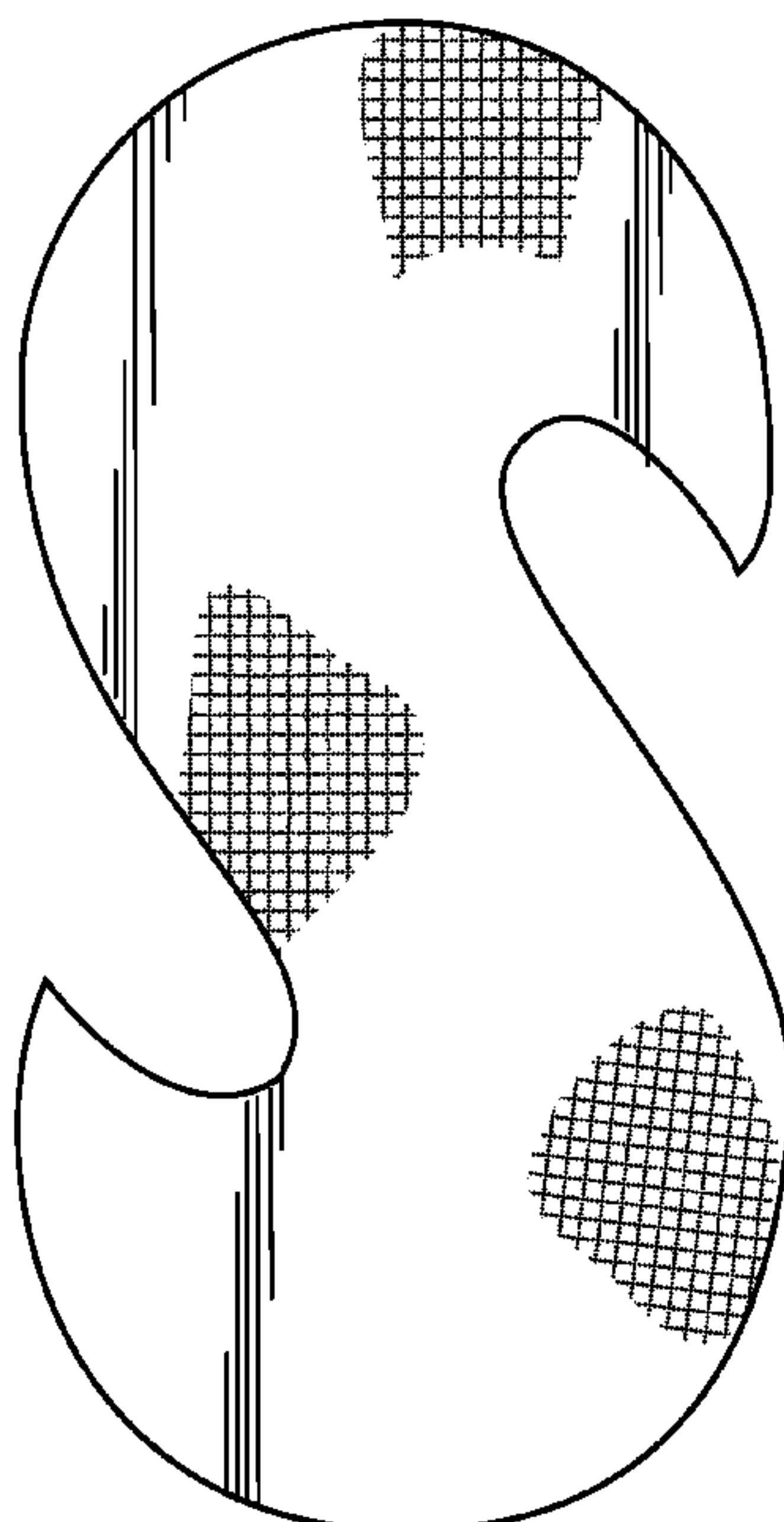

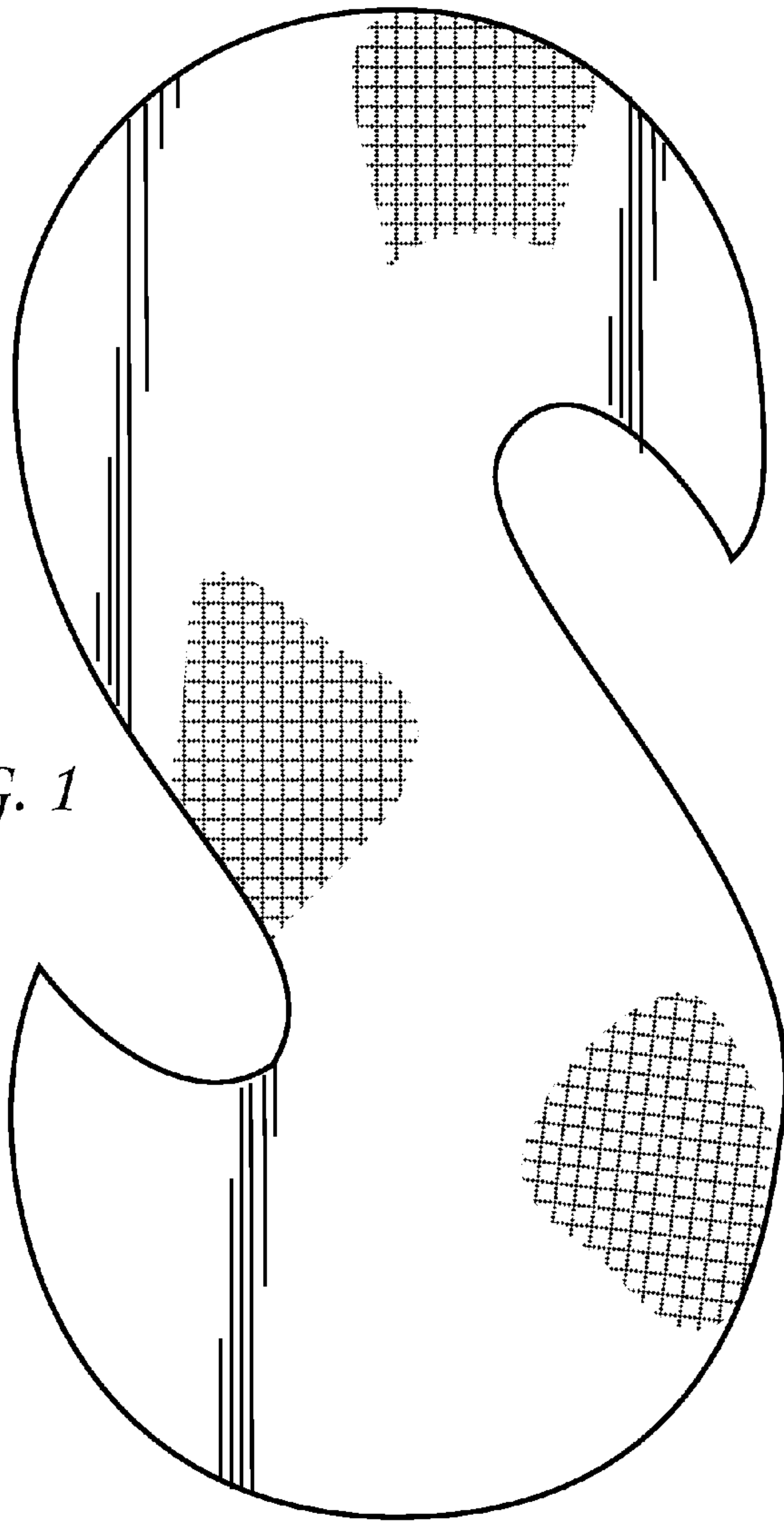

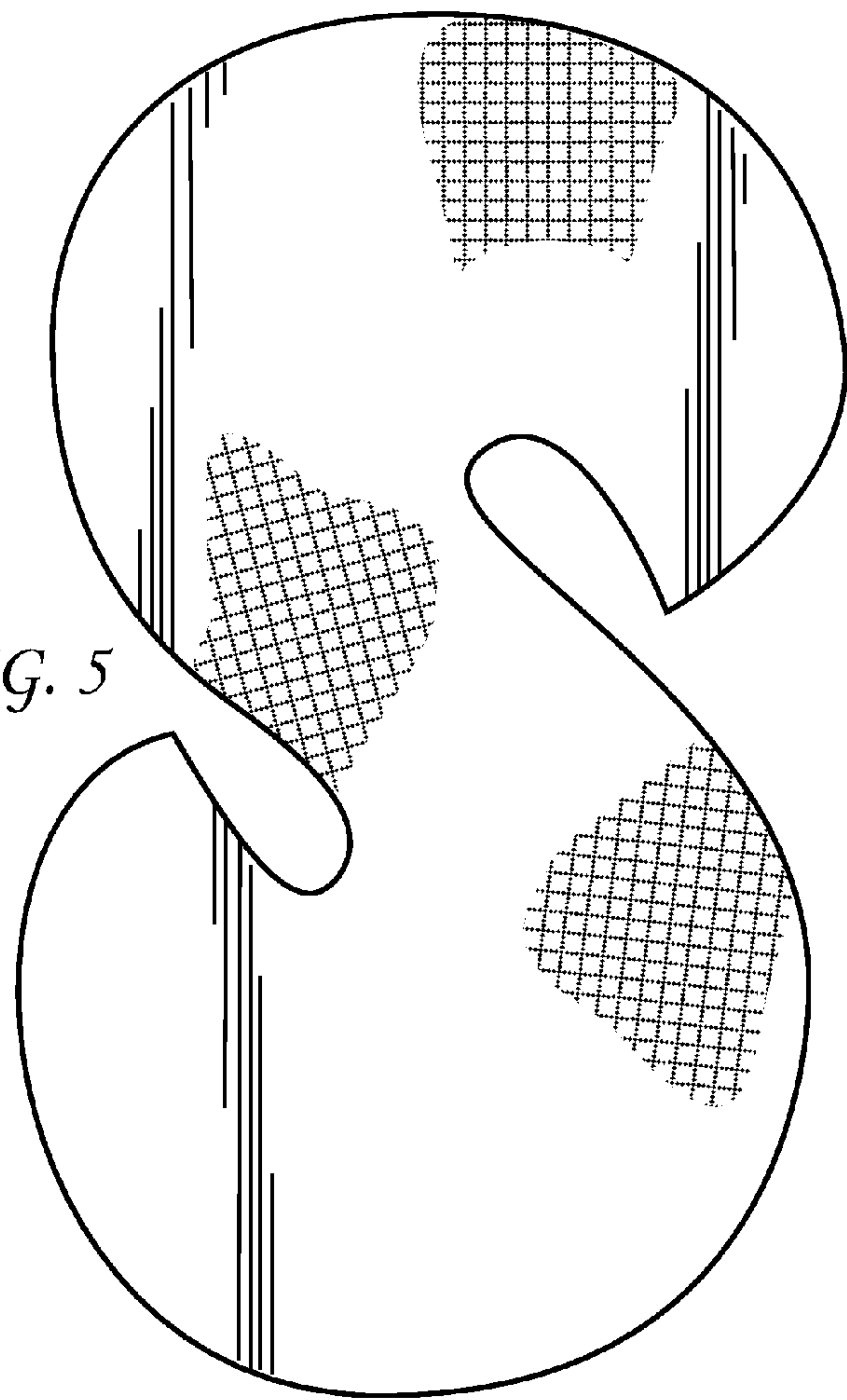
