FIG. 6 is a left side view thereof.

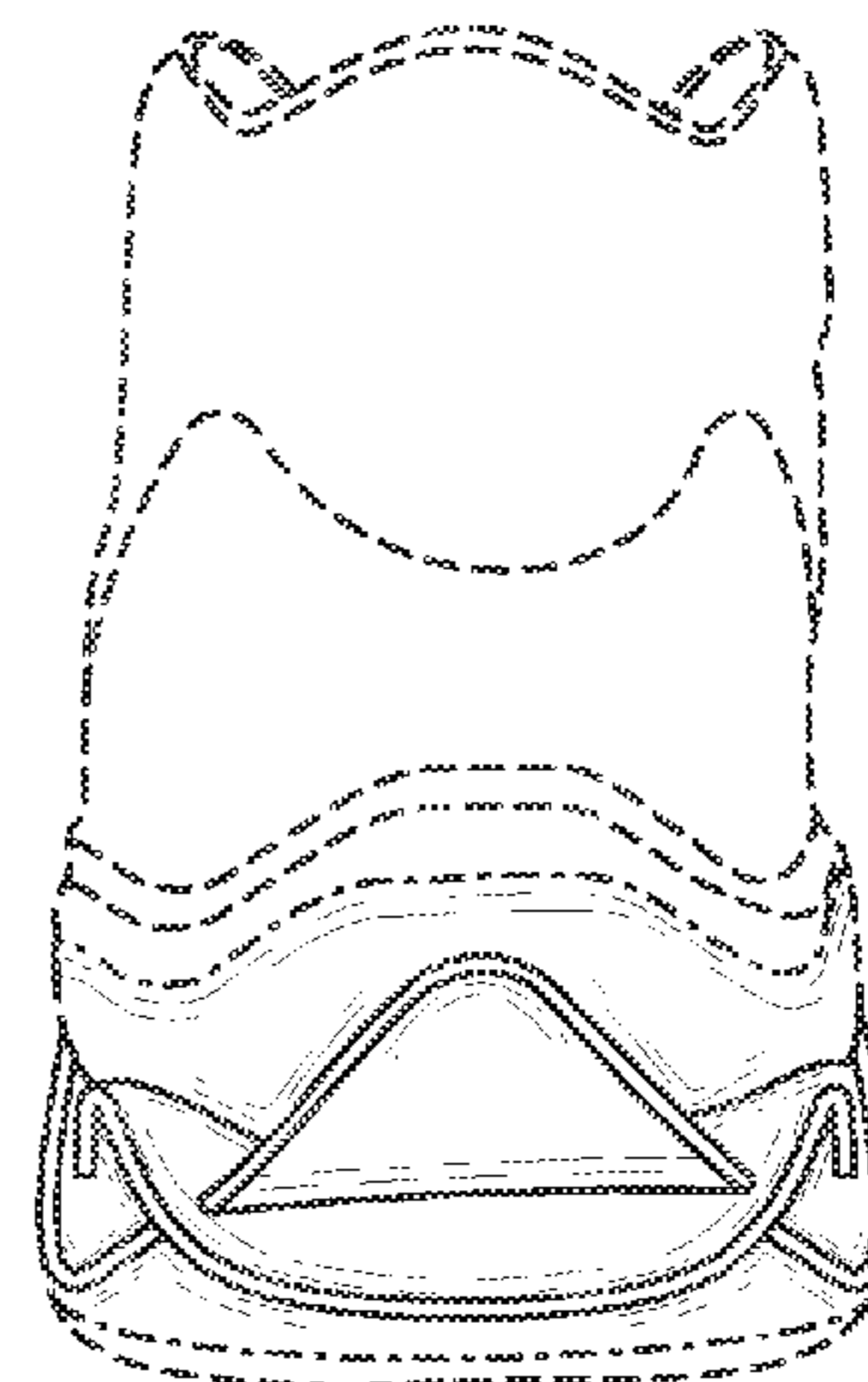
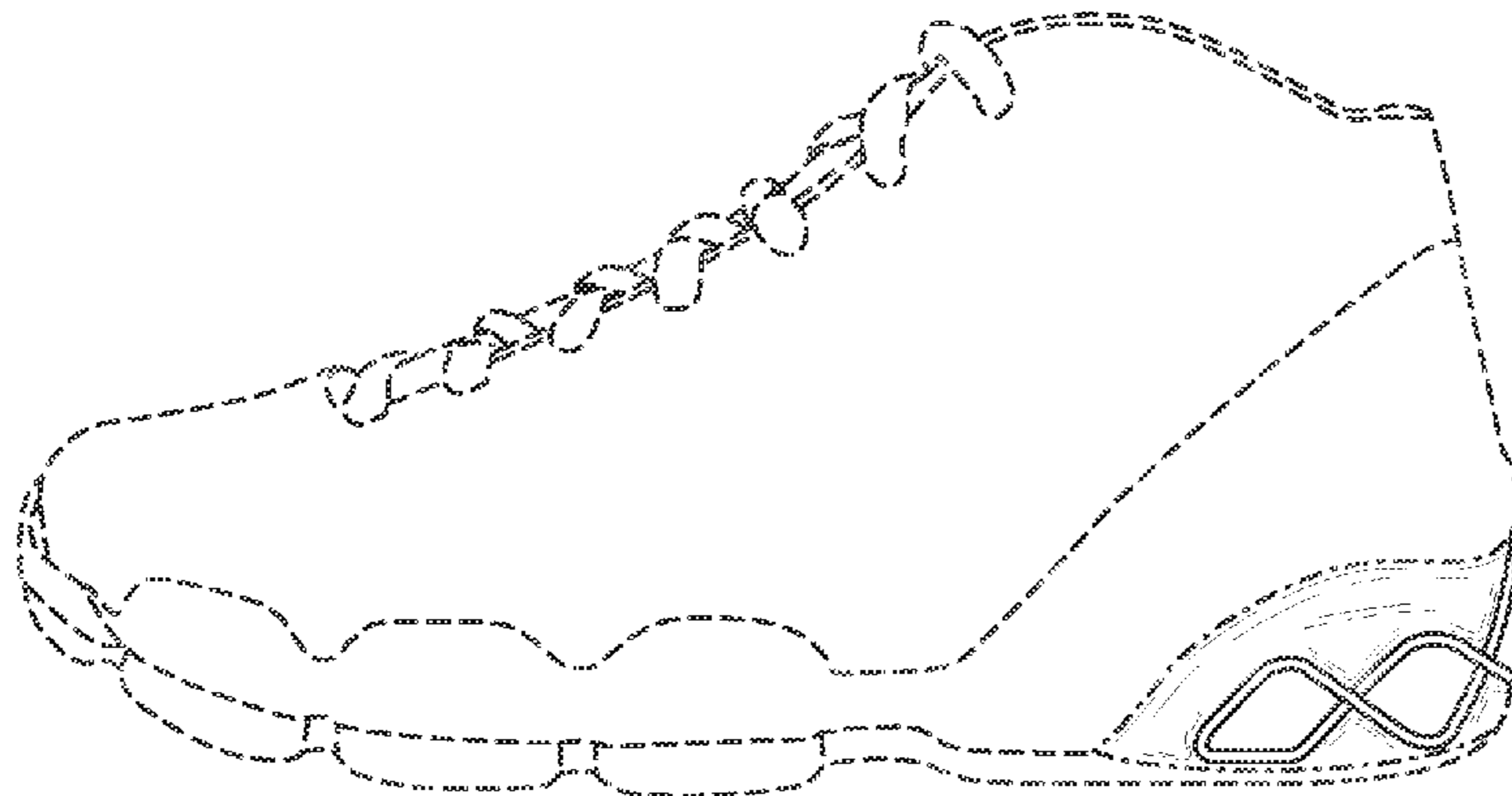
The dot-dash broken line immediately adjacent the shaded

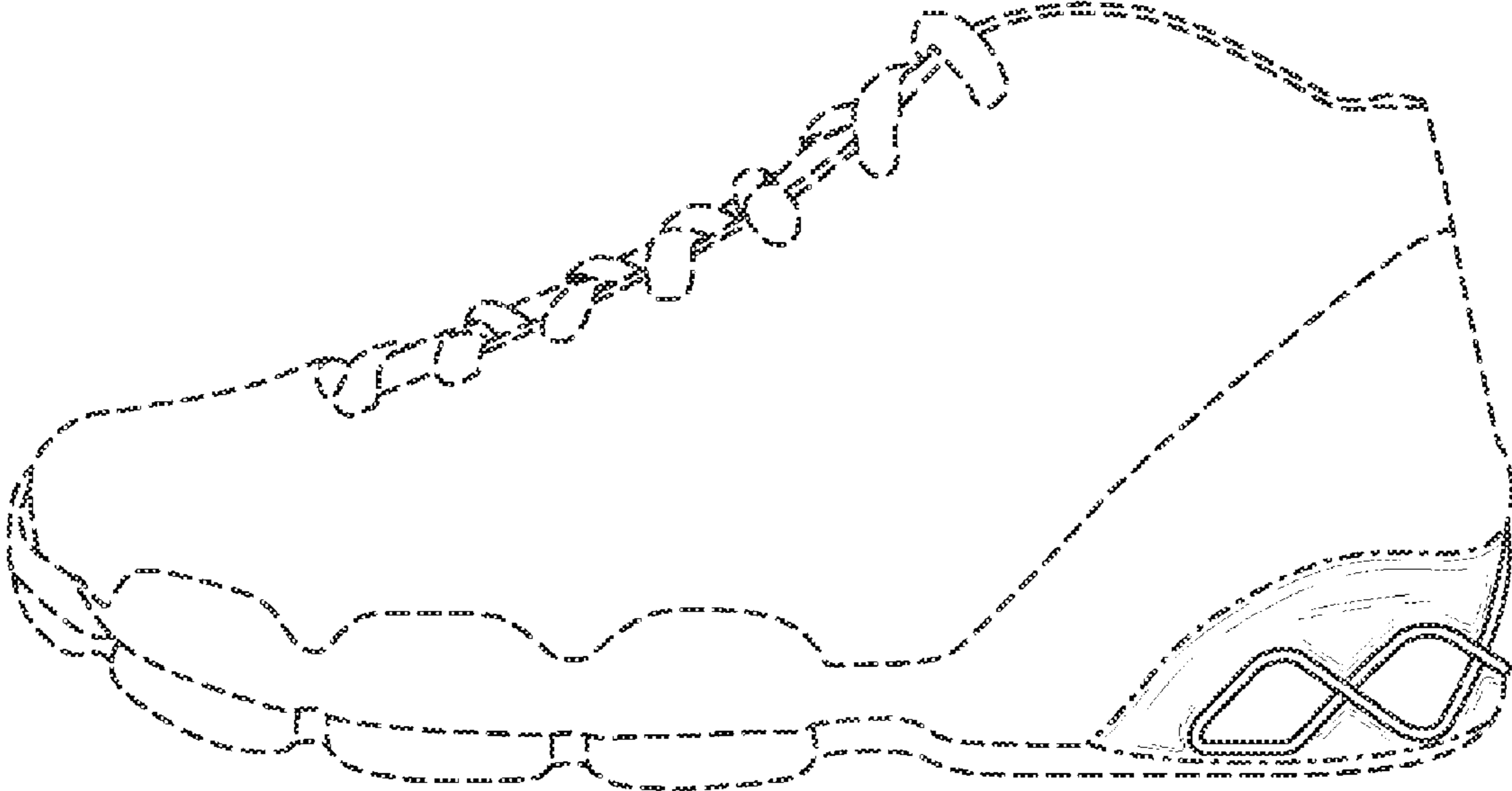

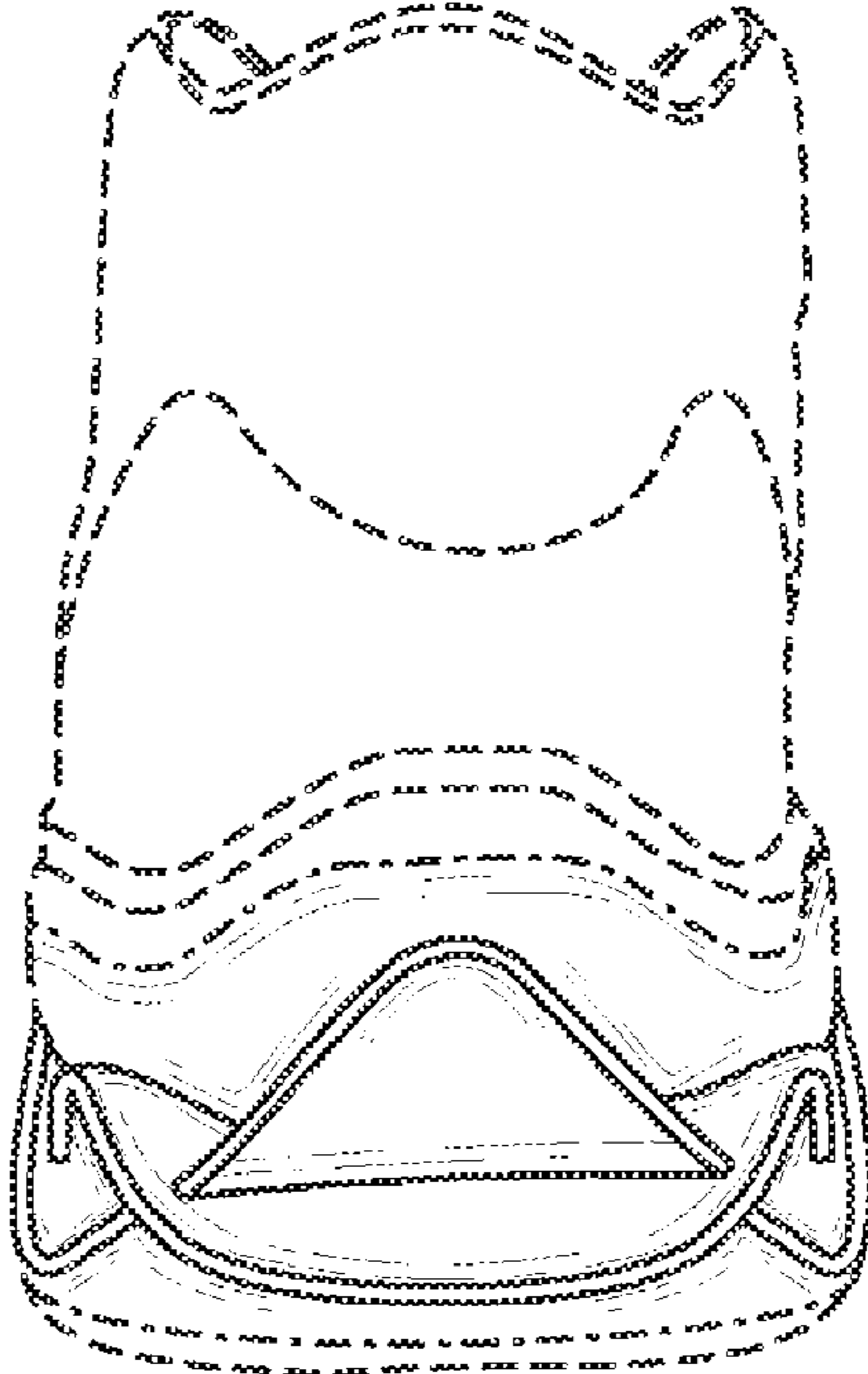

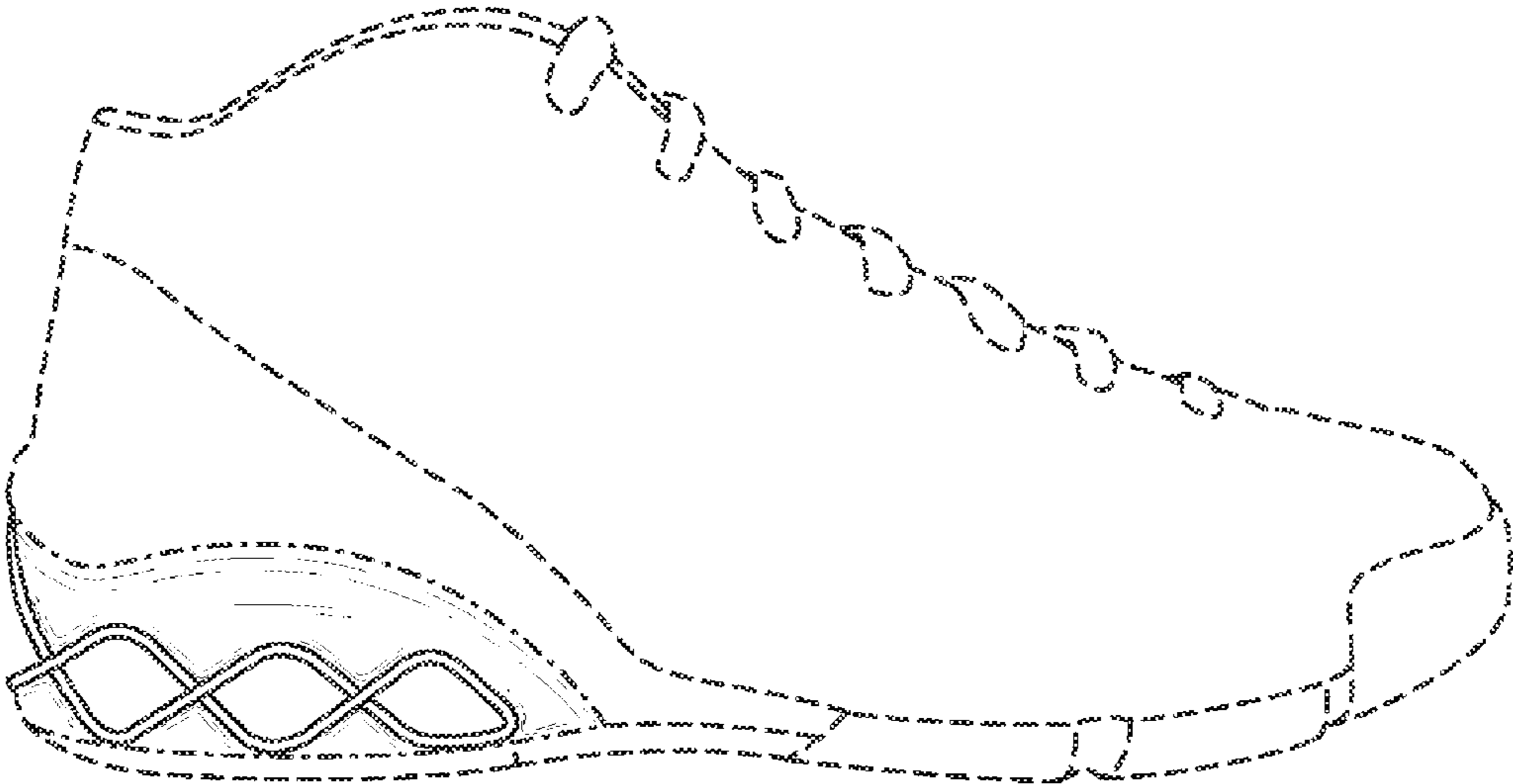

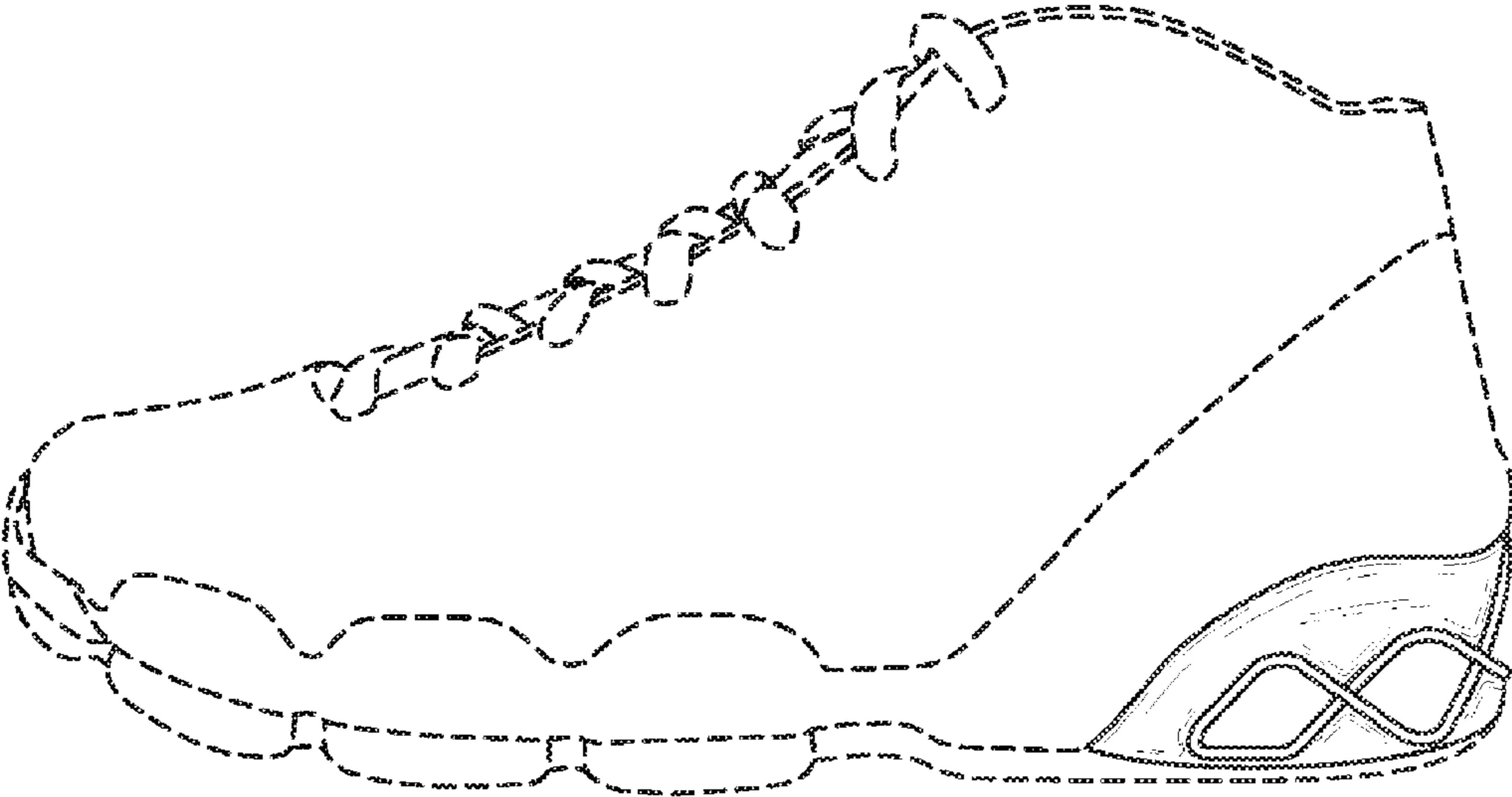

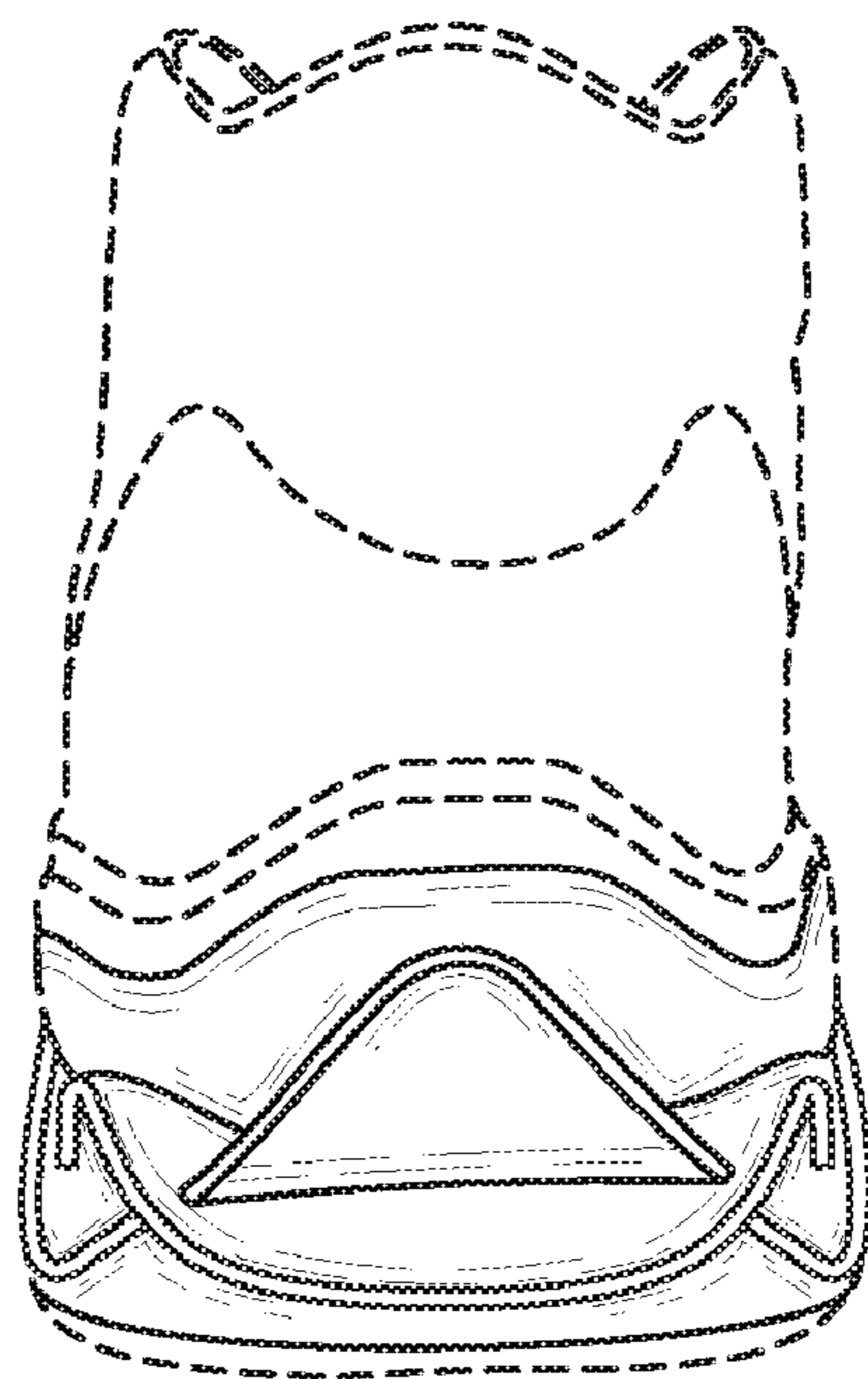

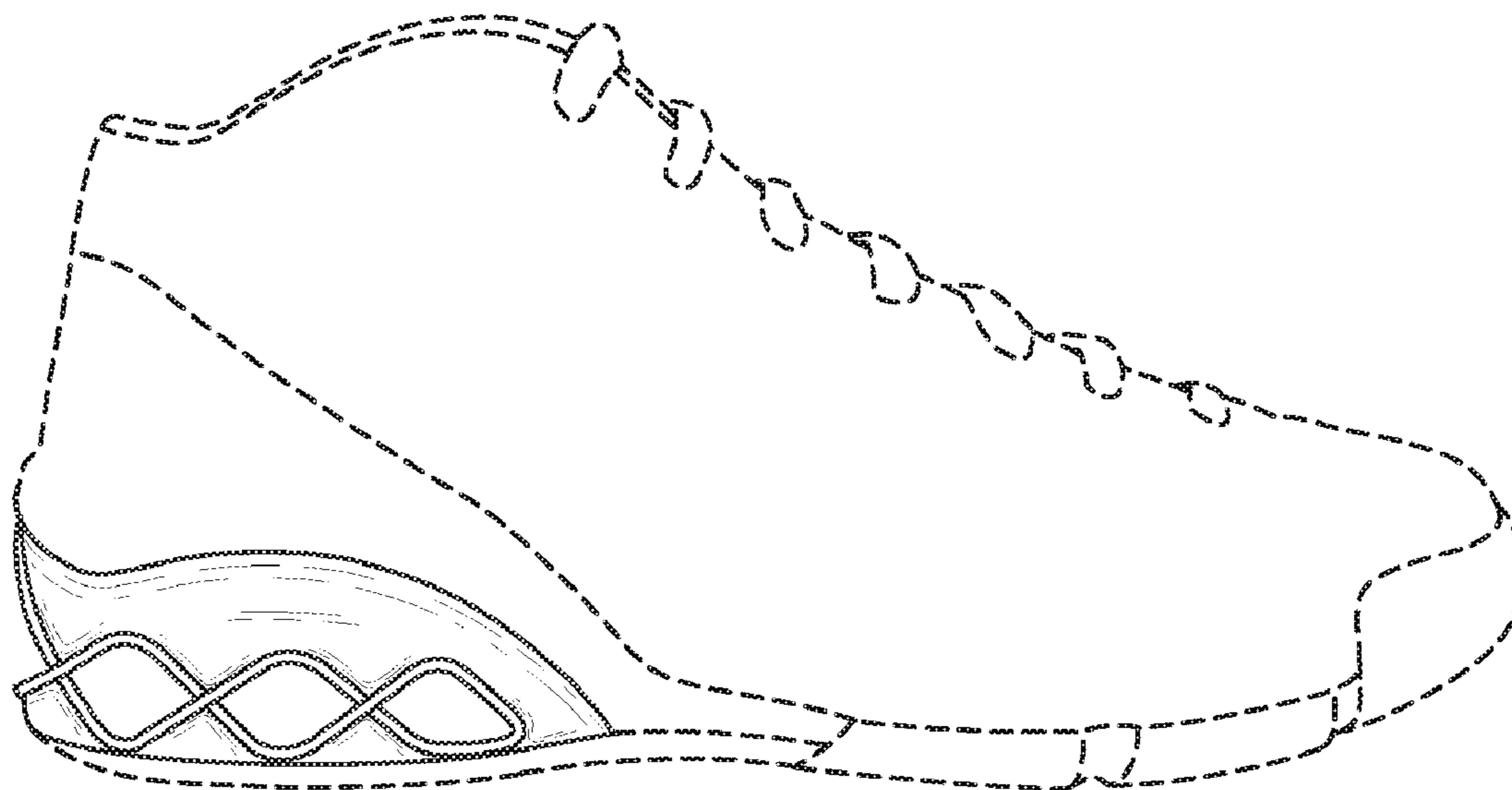
