(57) **CLAIM**

The ornamental design for a plant support, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a plant support, showing the new design with a basket portion separated from a base portion;

FIG. 2 is a perspective view thereof;

FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;

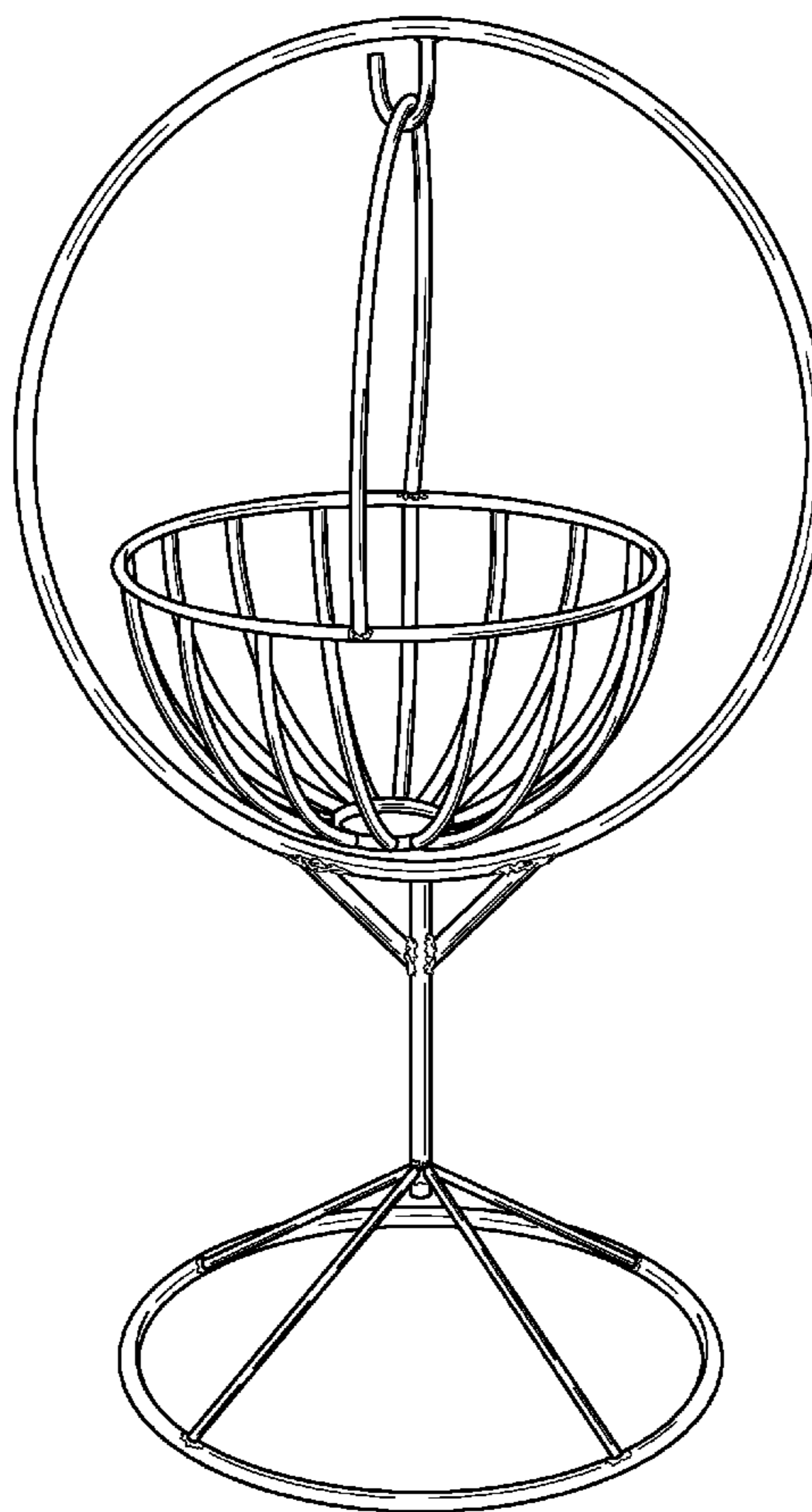
FIG. 4 is a front elevational view thereof;

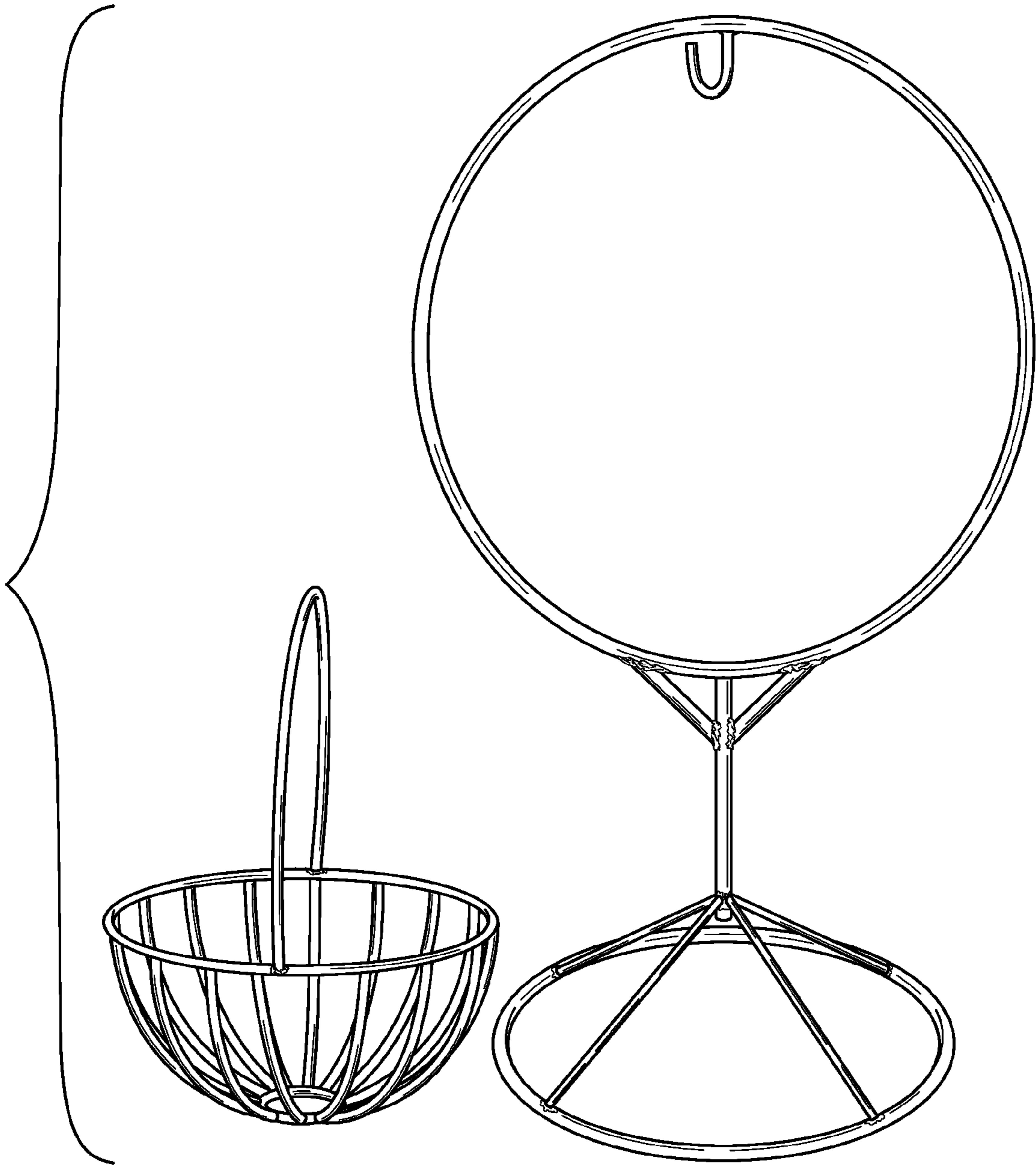

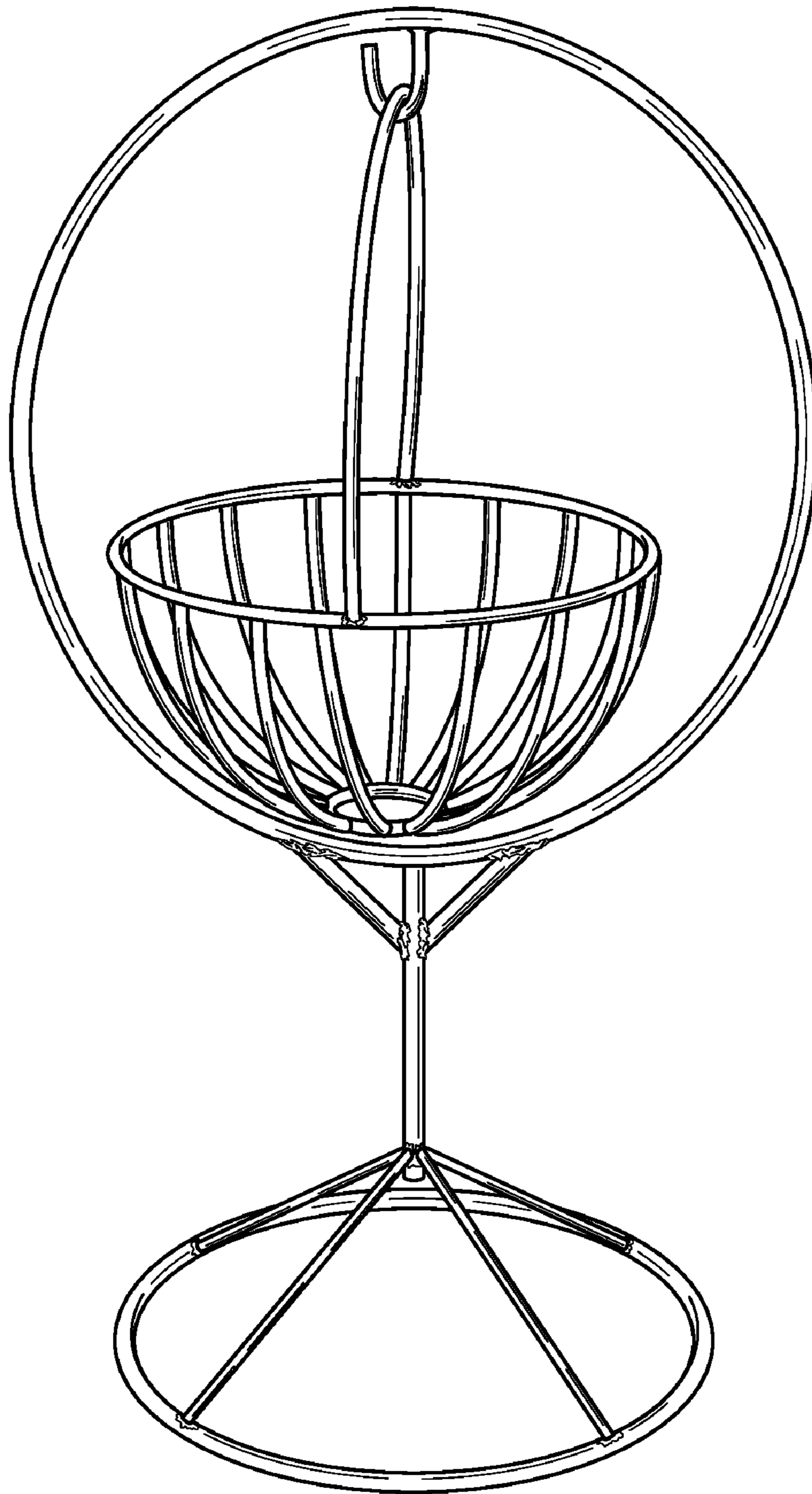

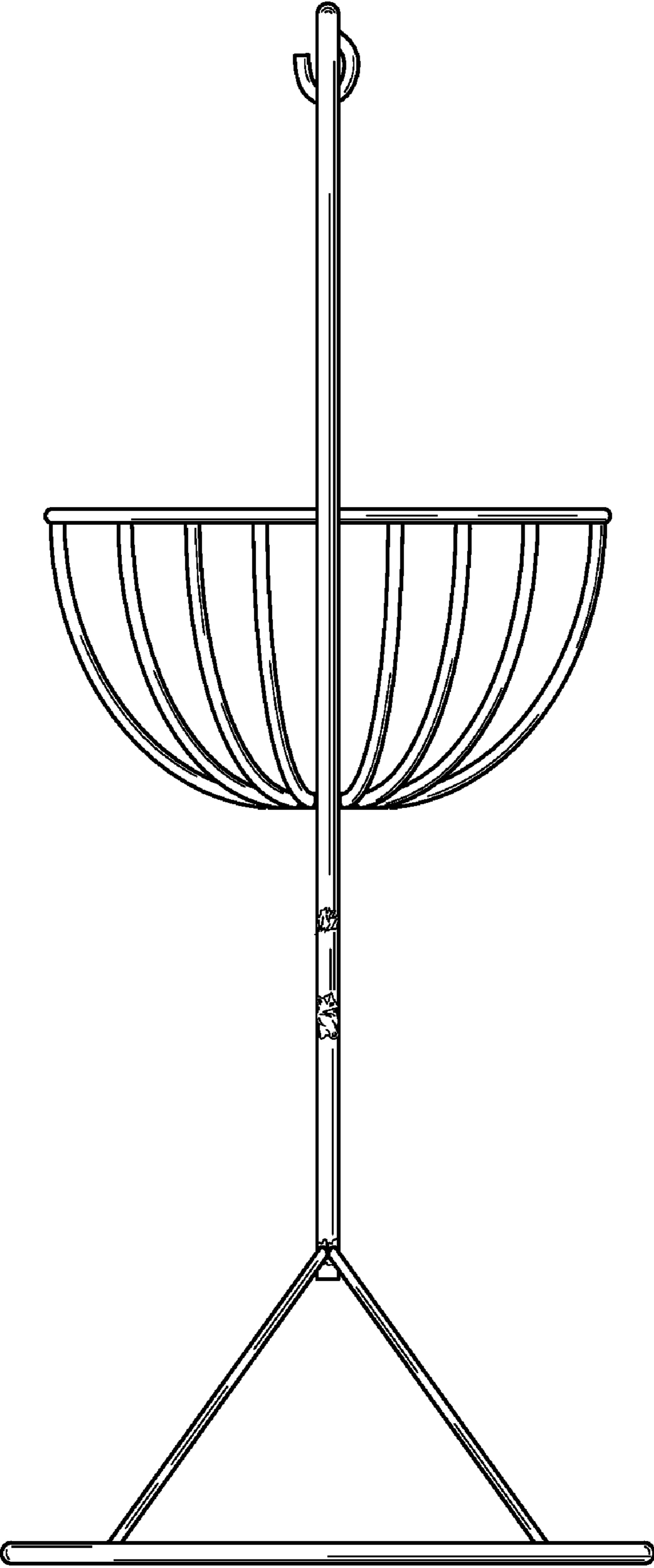

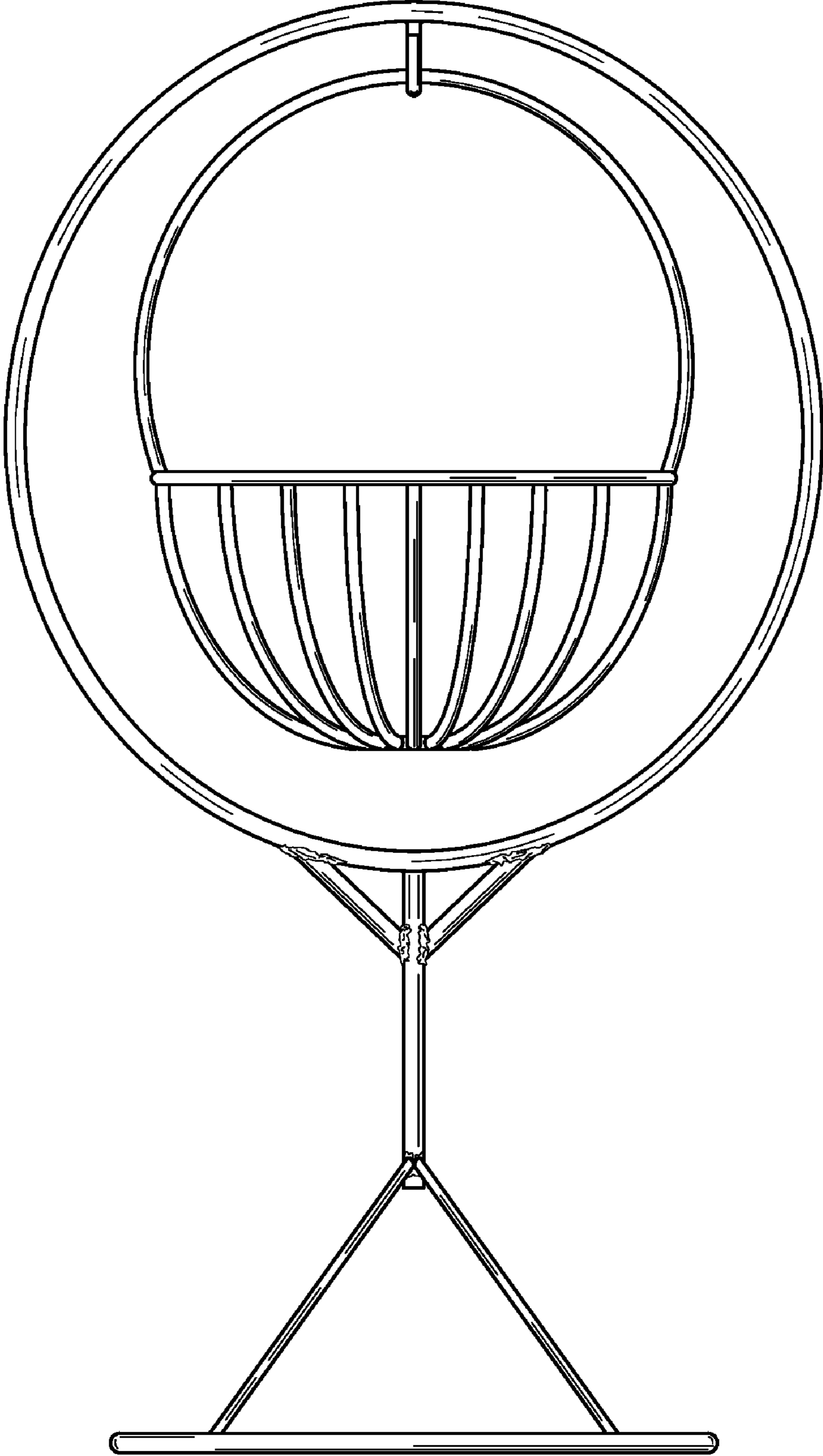

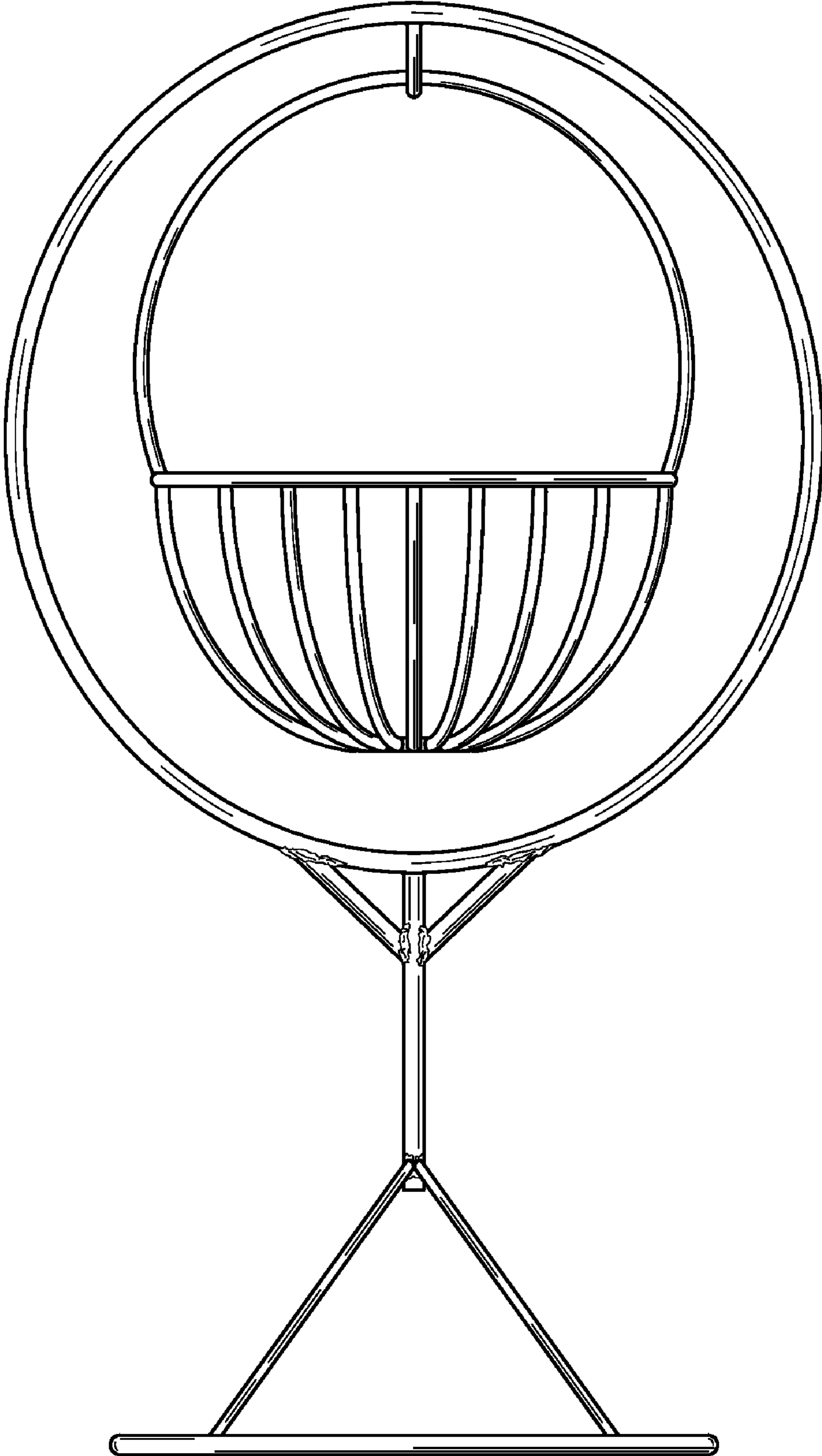

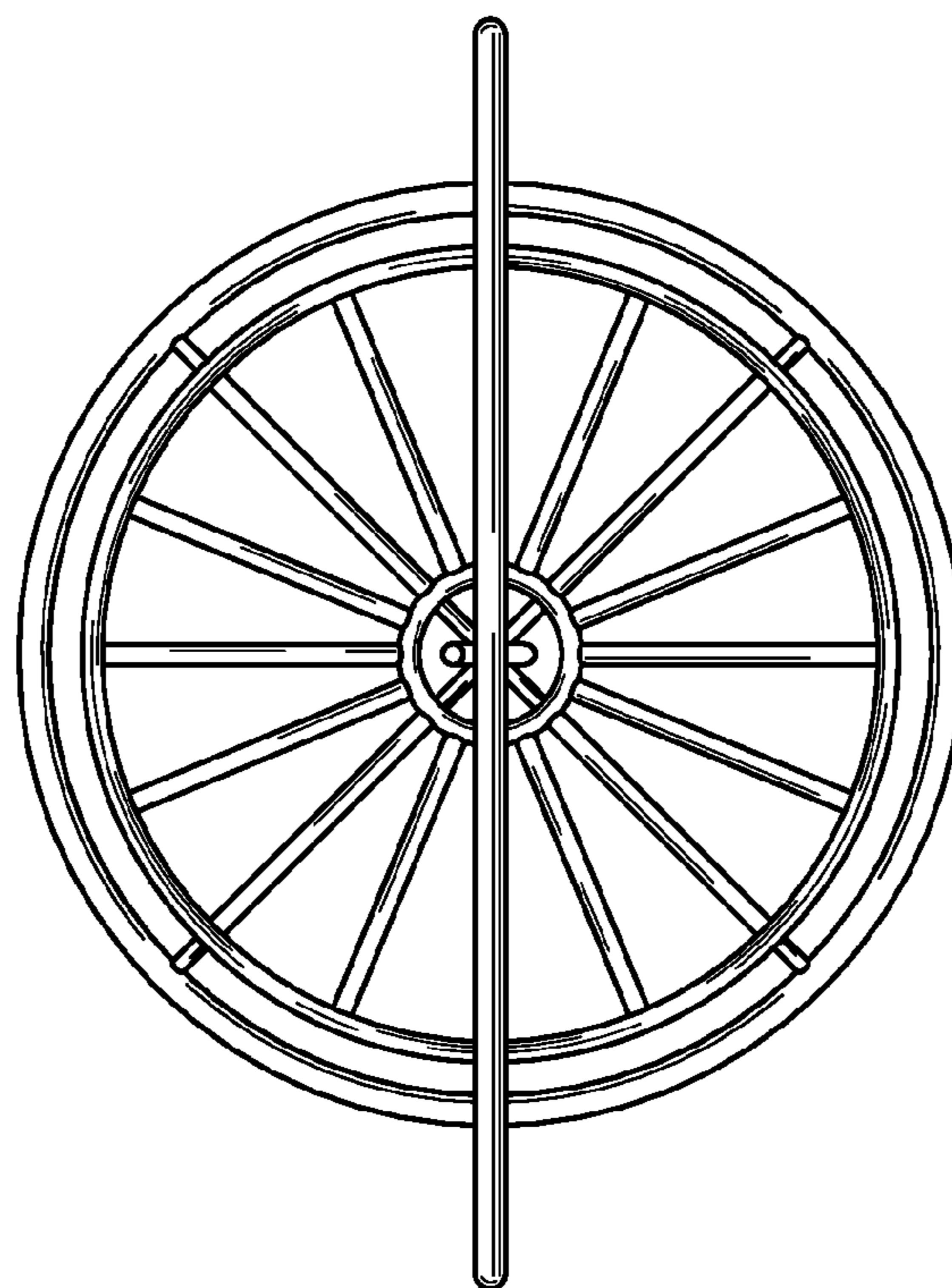

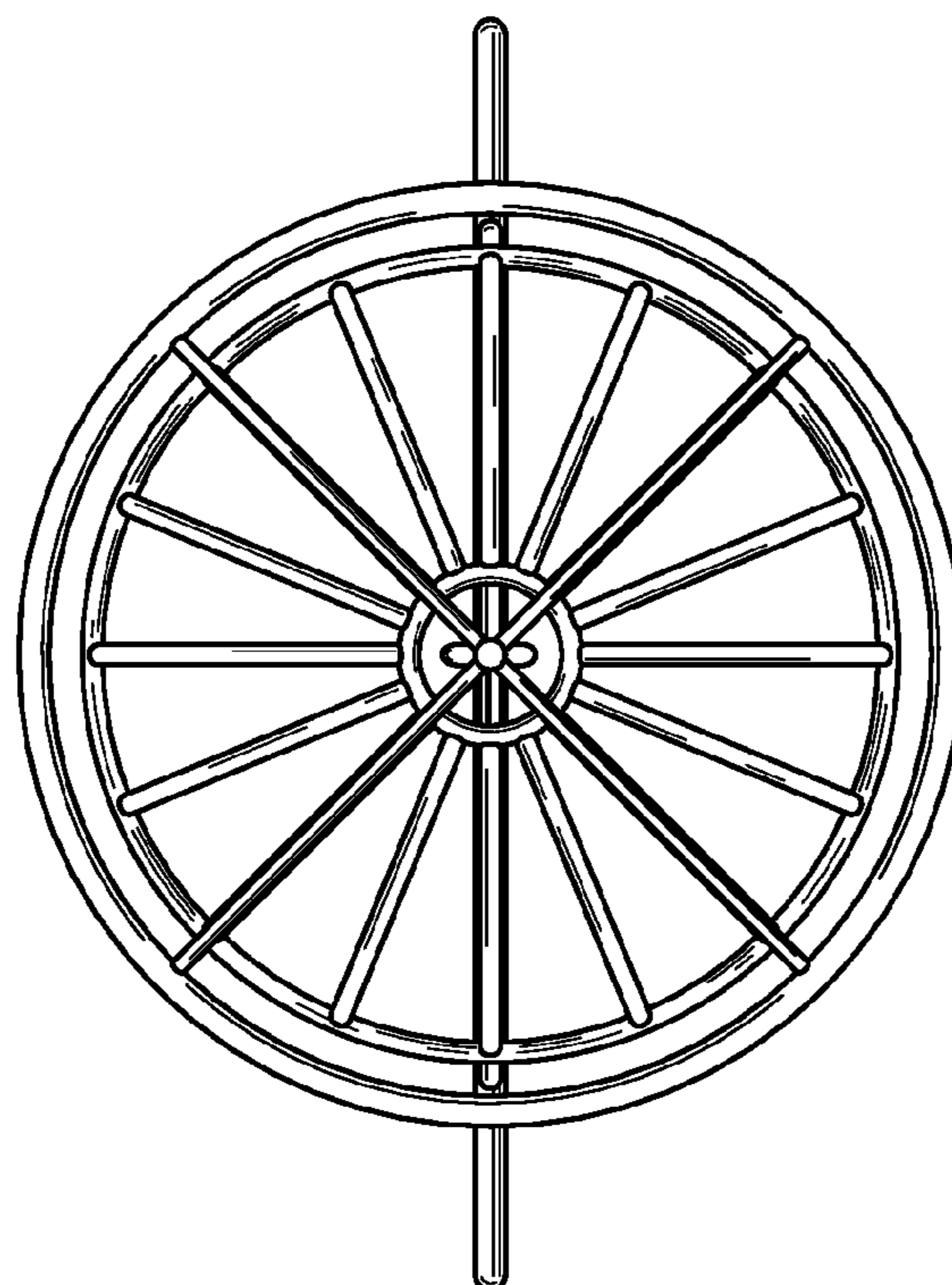
