(57) **CLAIM**

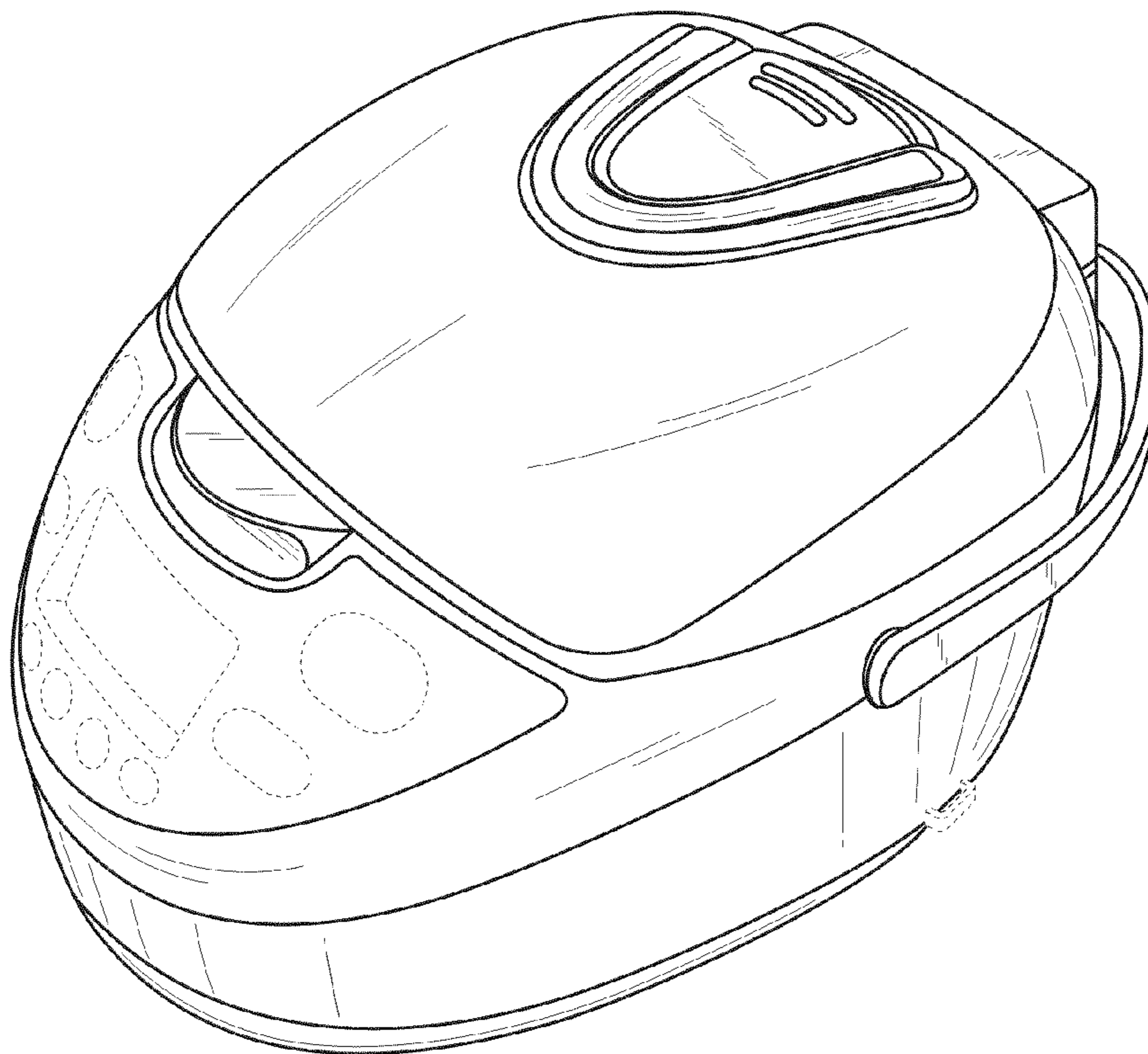
The ornamental design of a electric kitchen appliance, as shown and described.

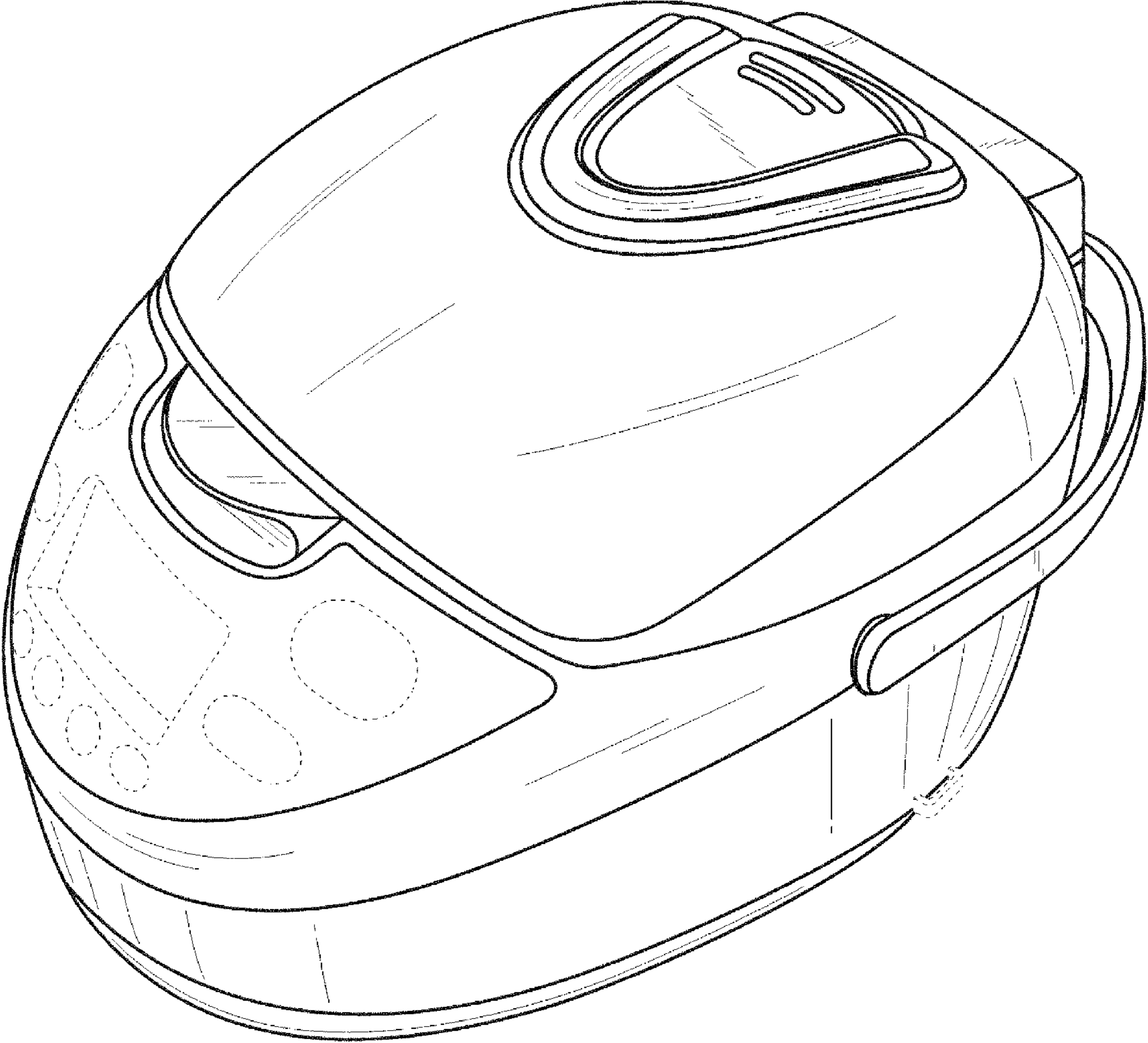

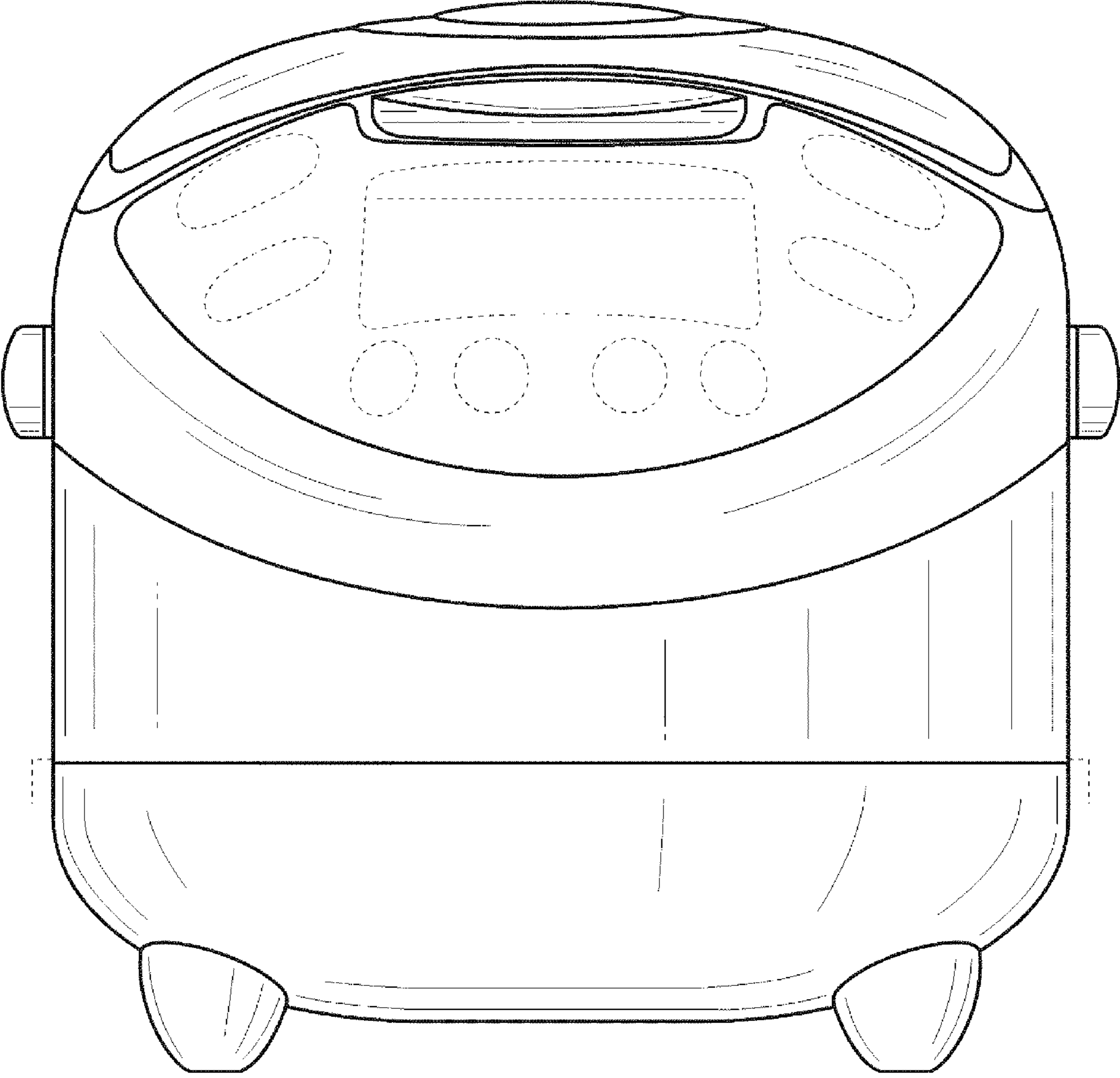

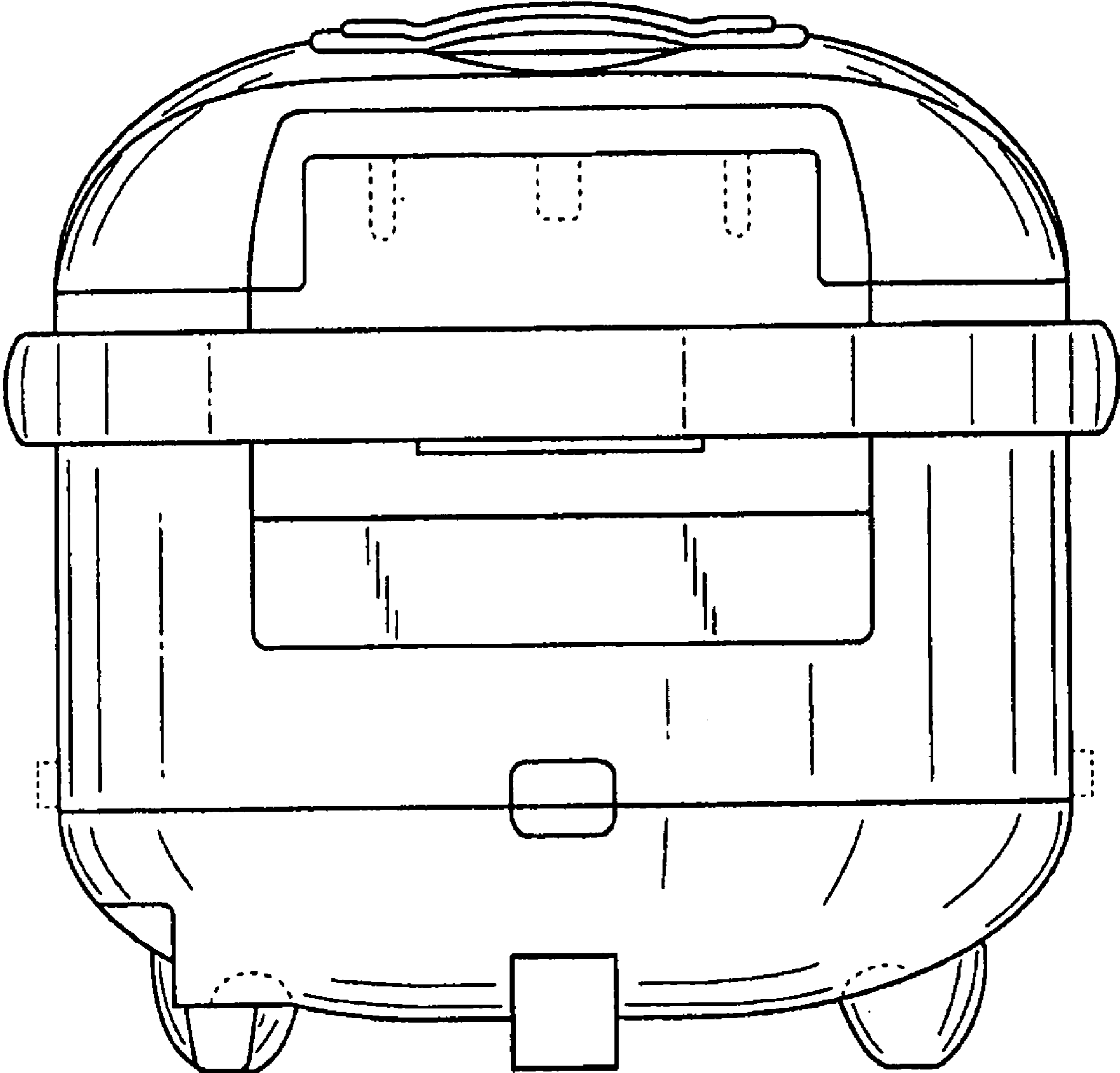

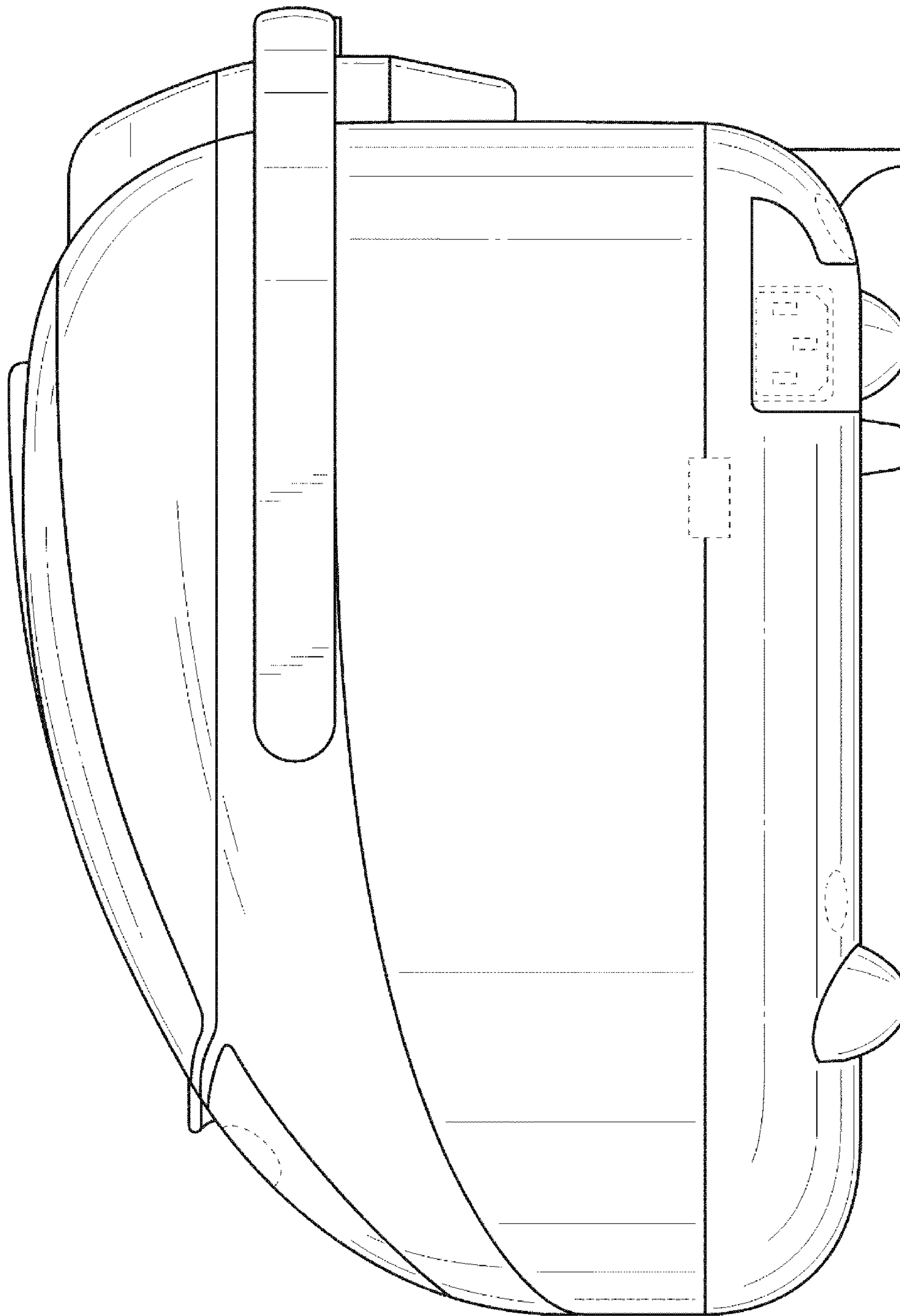

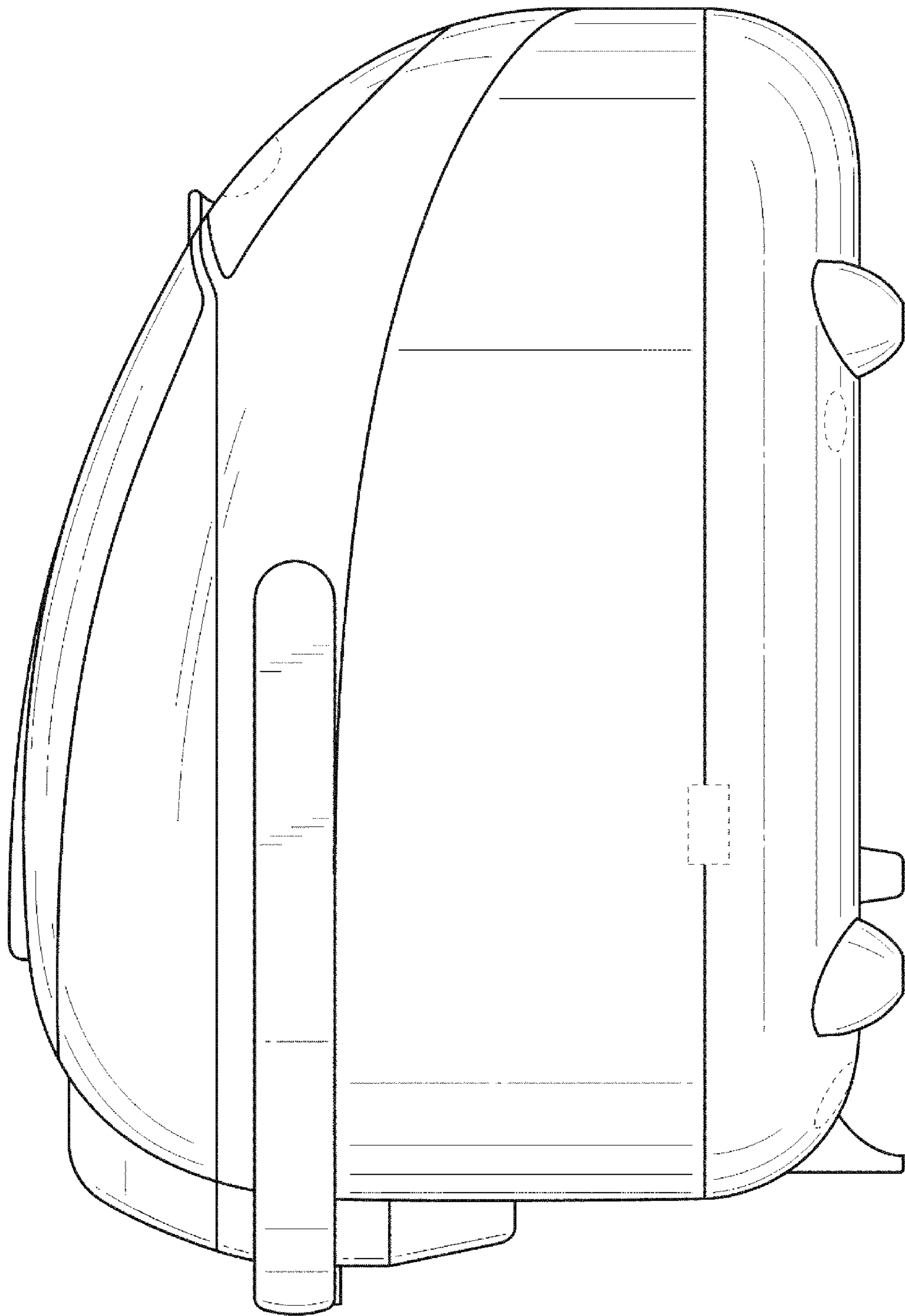

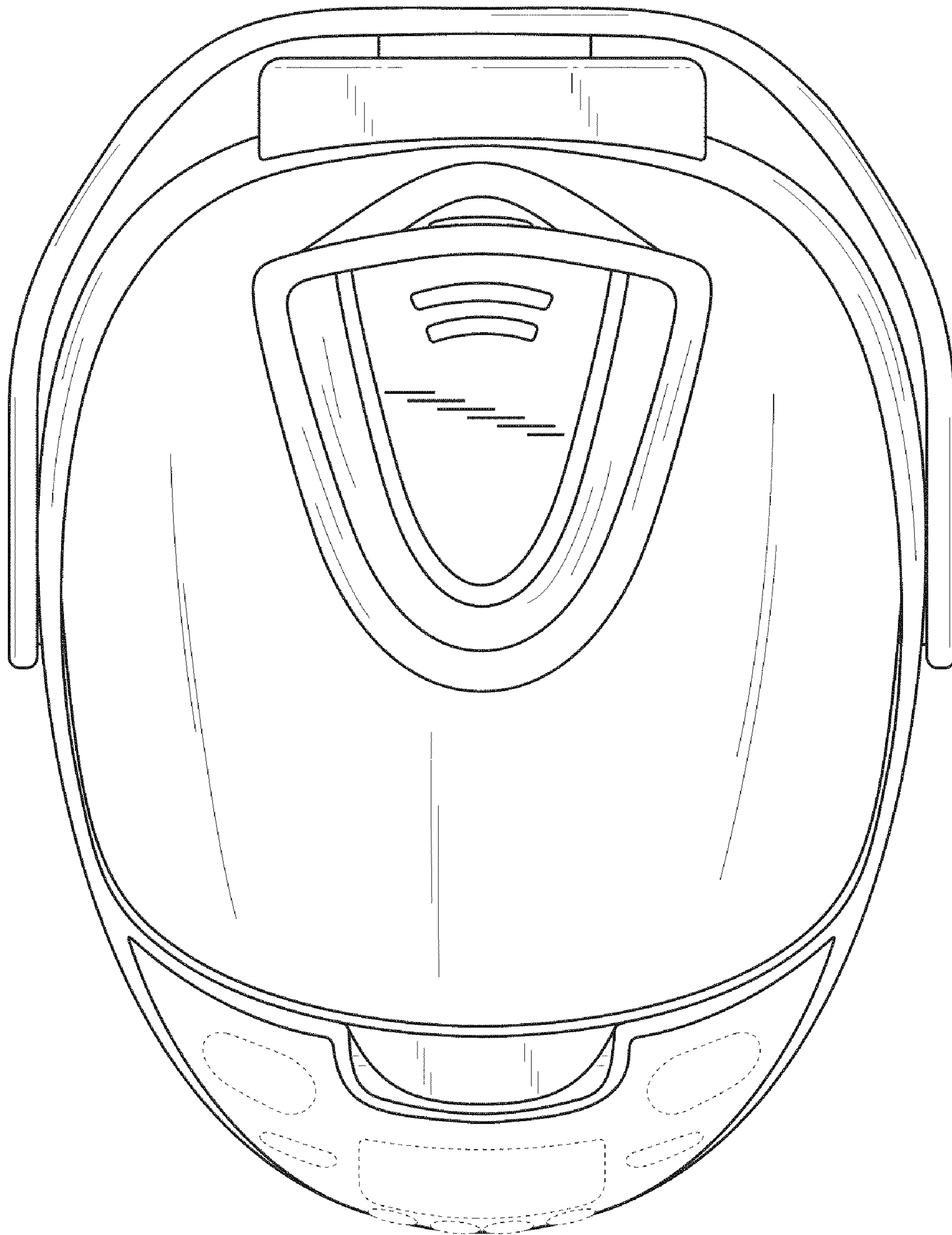

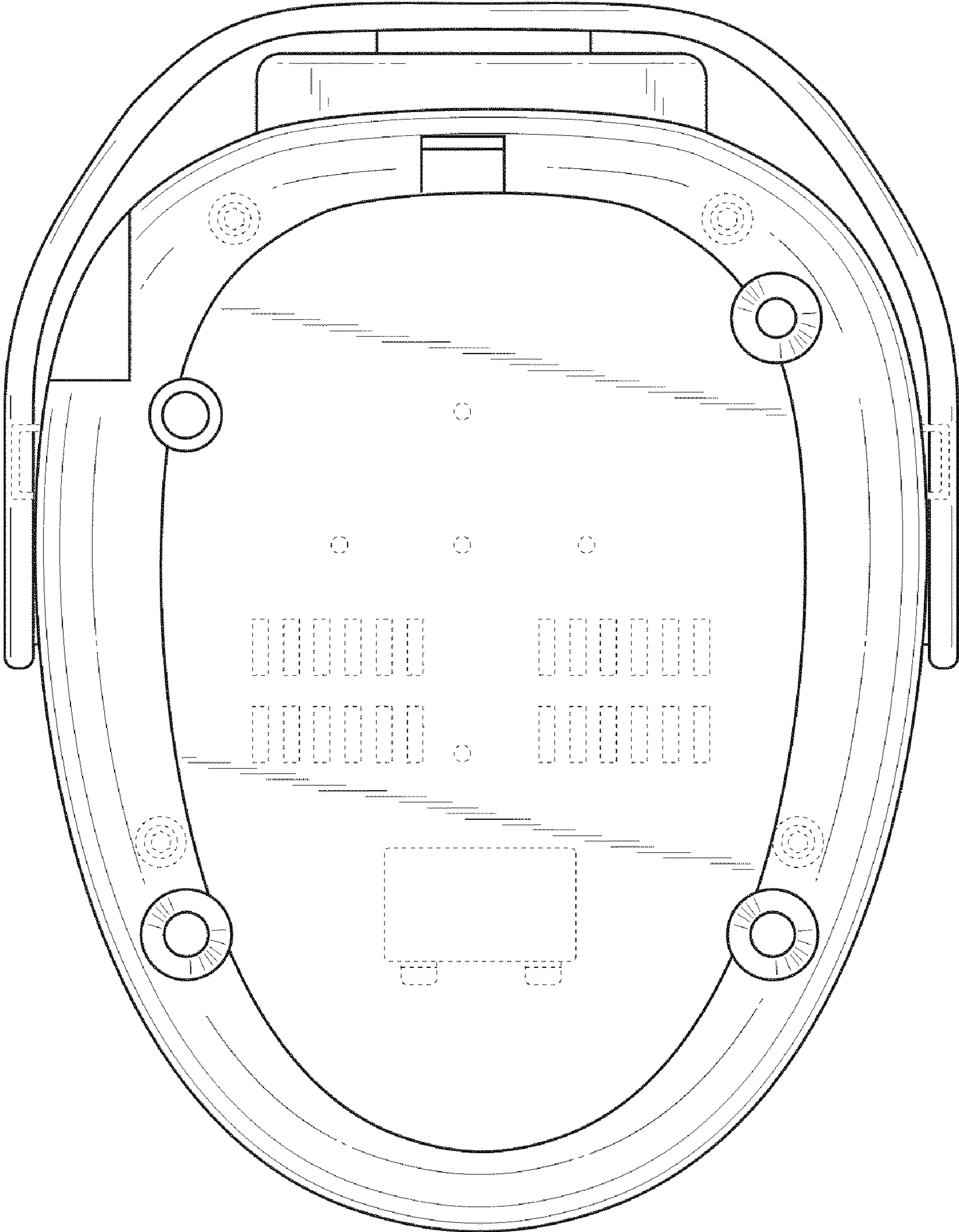
