FIG. 5 is a top view of the caster shown in FIG. 1; and,

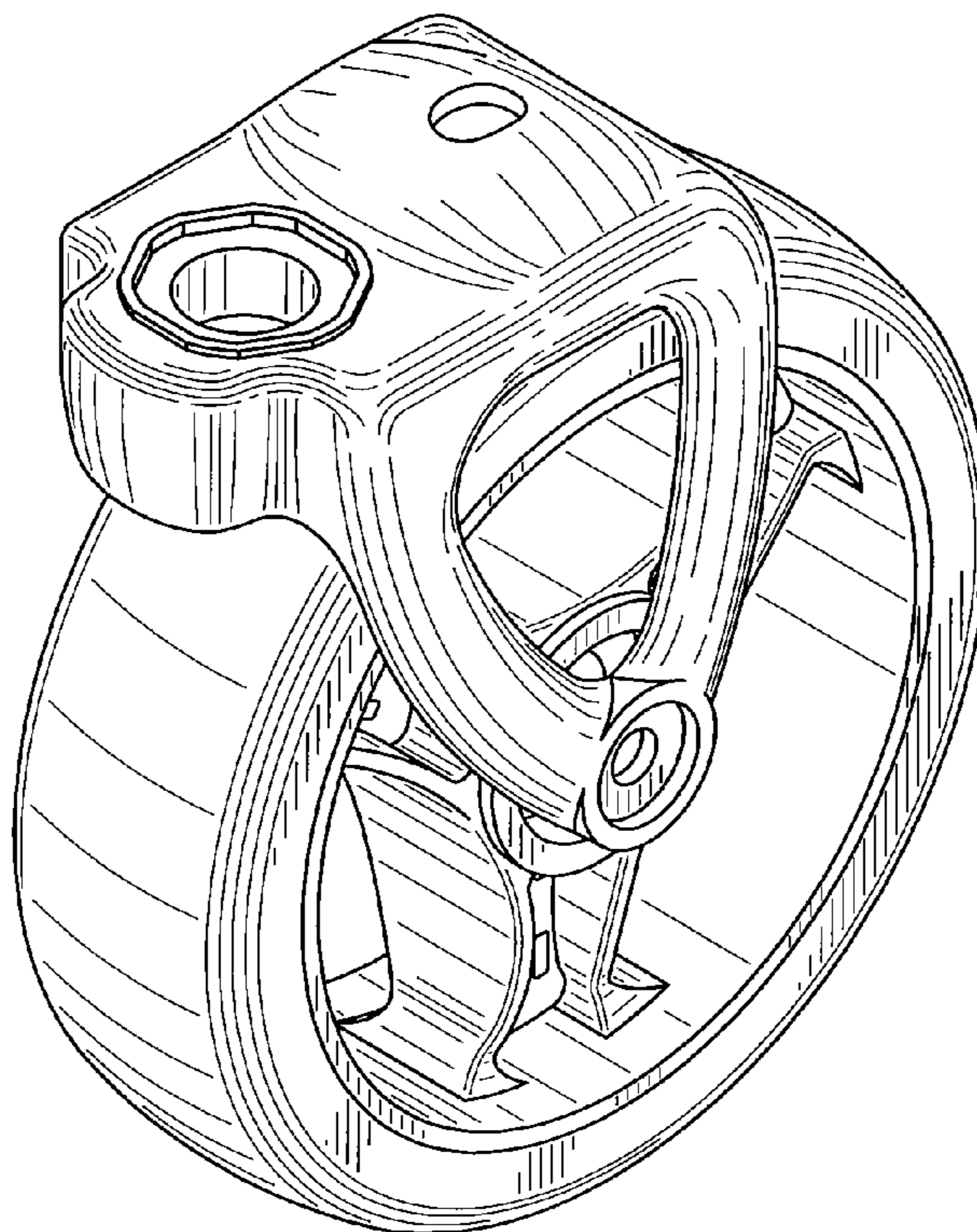
FIG. 6 is a bottom view of the caster shown in FIG. 1.

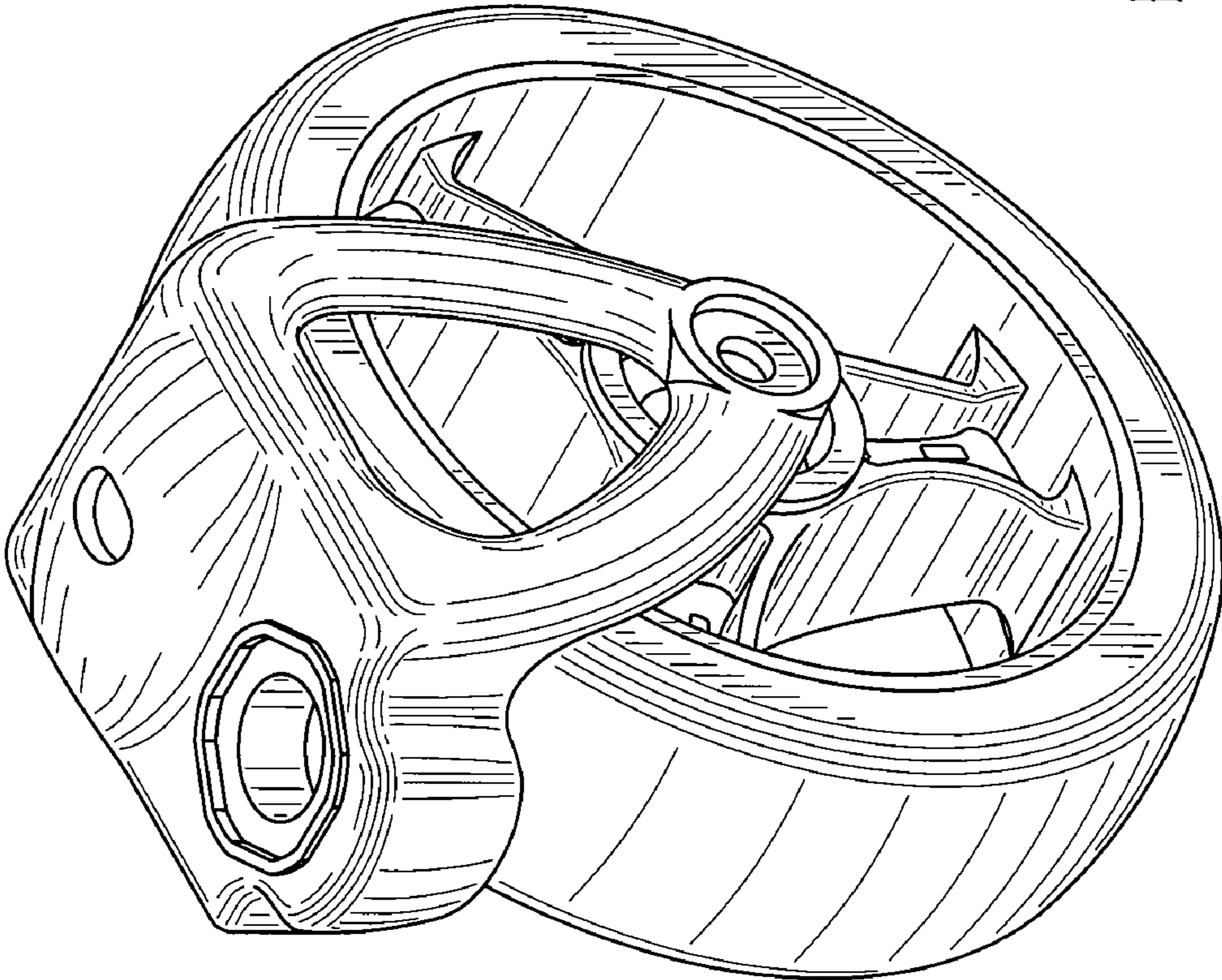

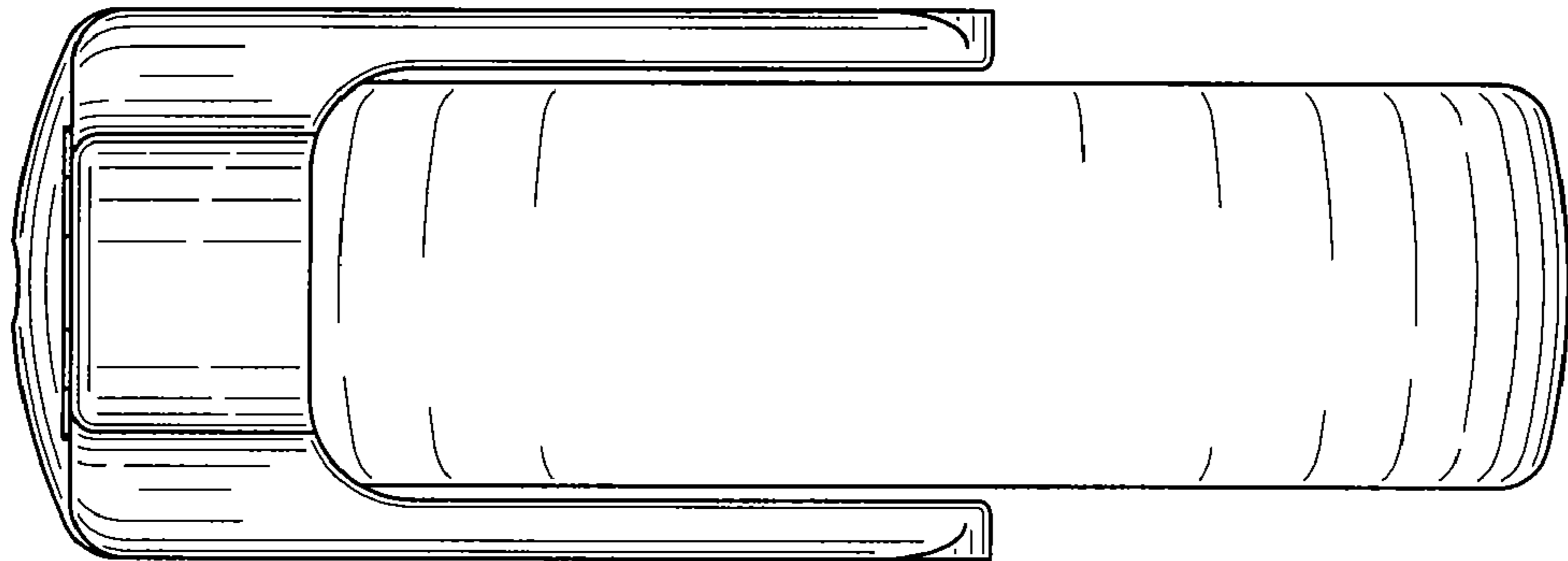

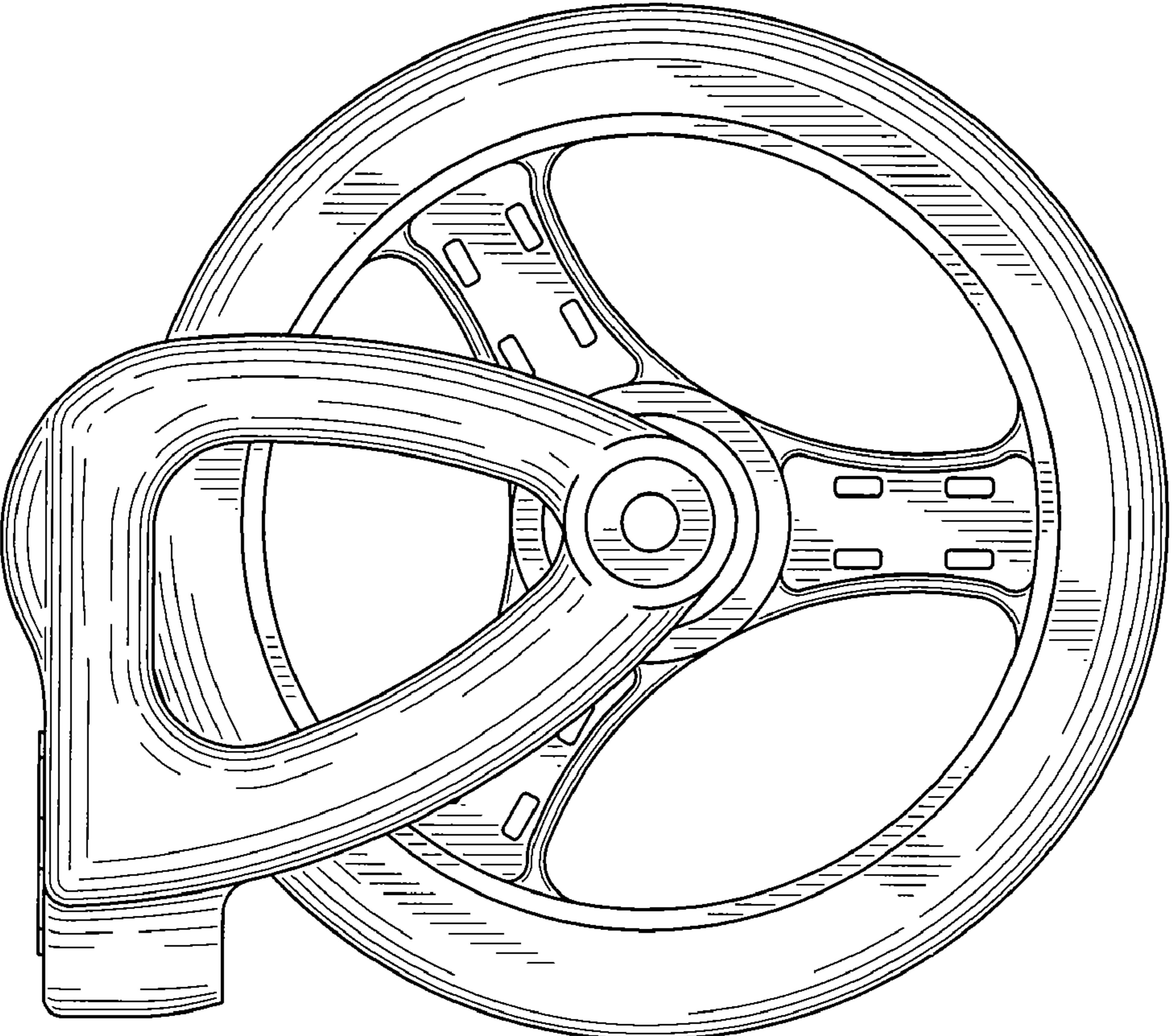

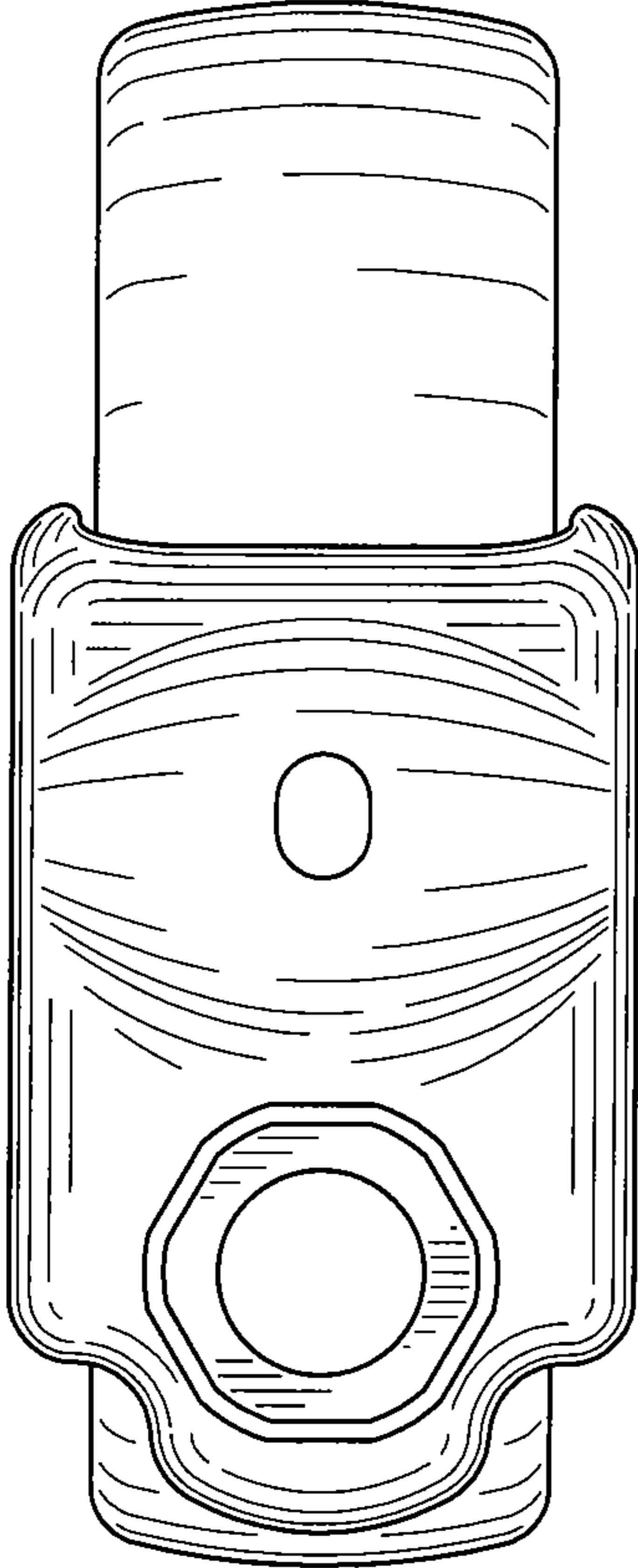

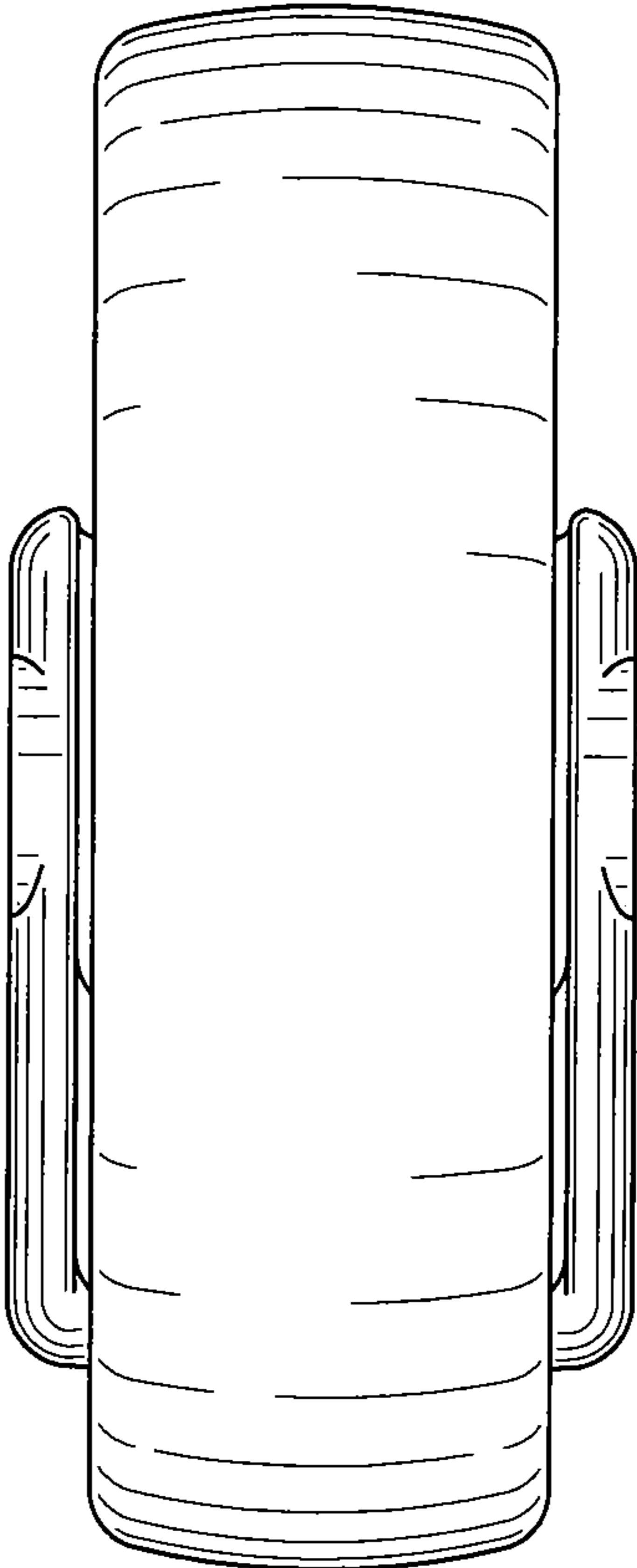

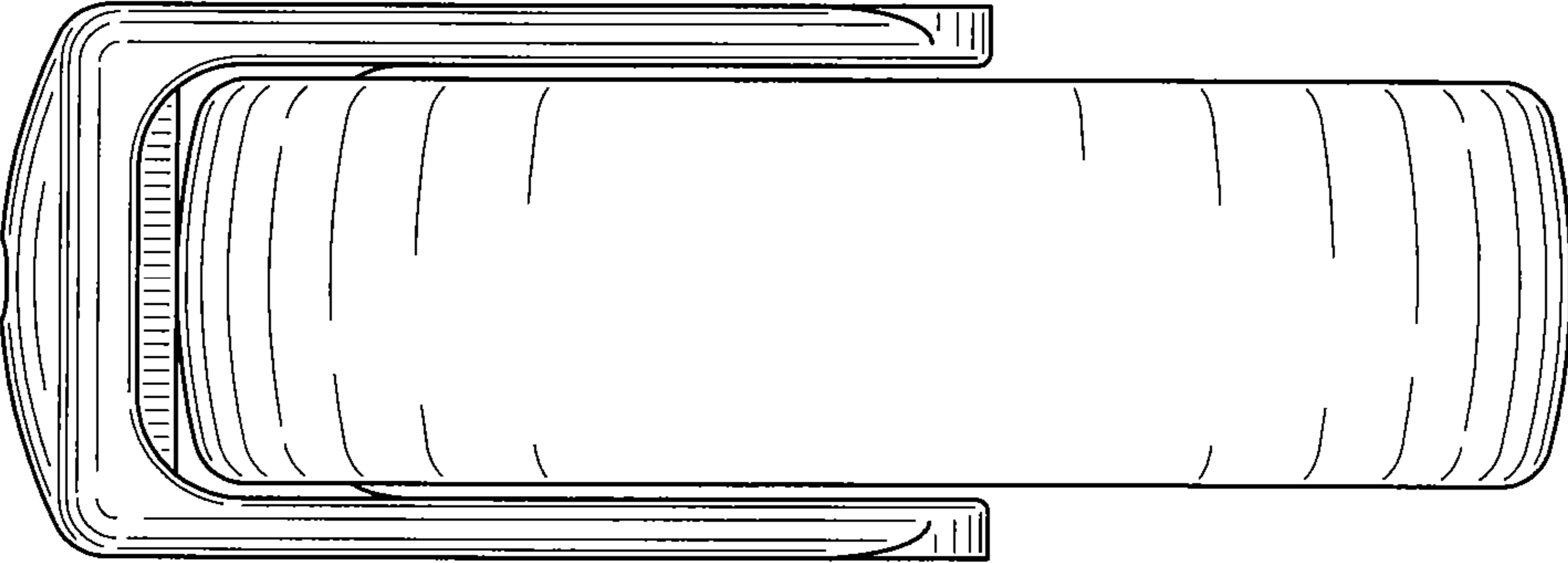
