**DESCRIPTION**

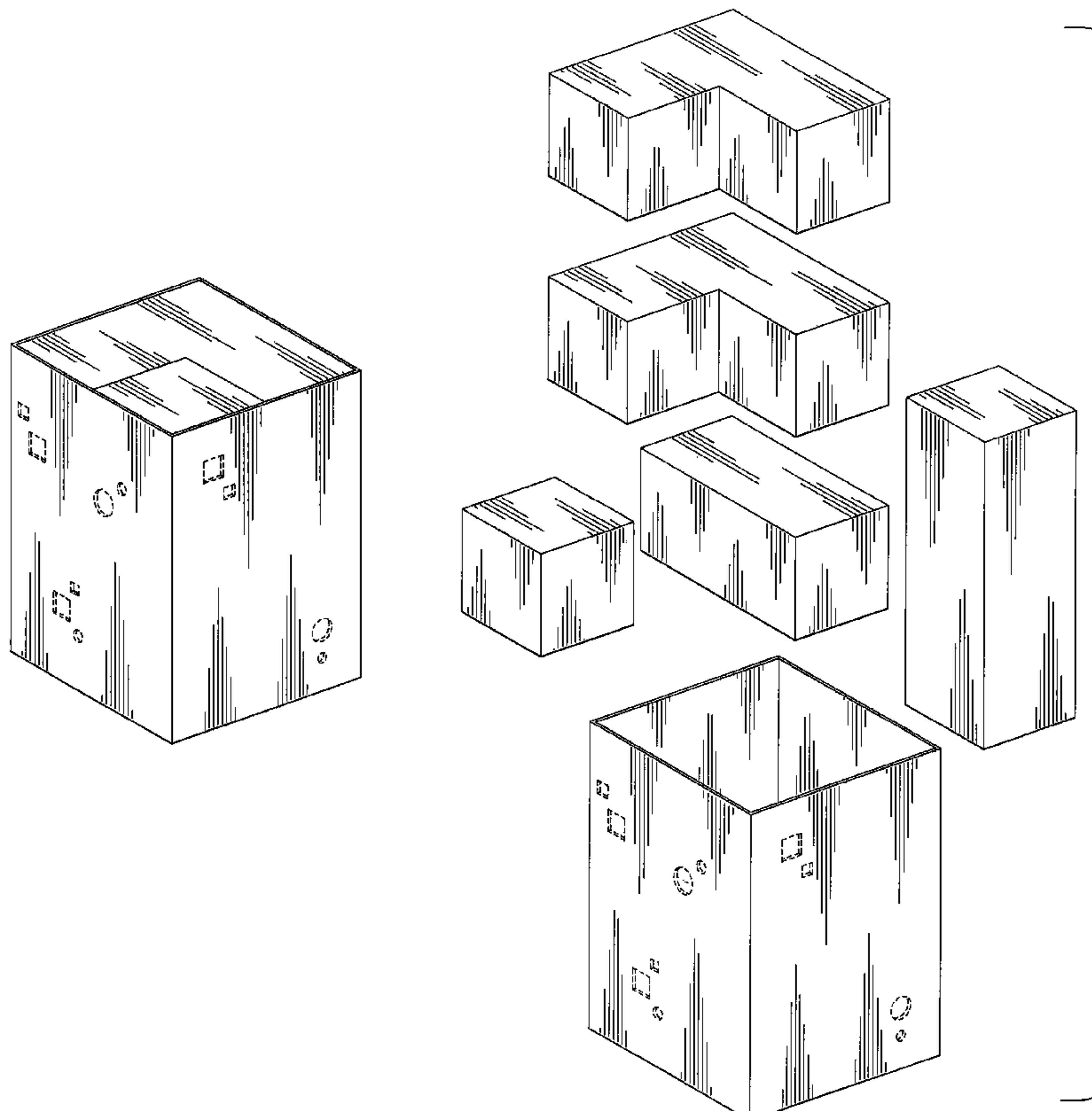
FIG. 1 illustrates a front right perspective view of the box assembly showing my new design;

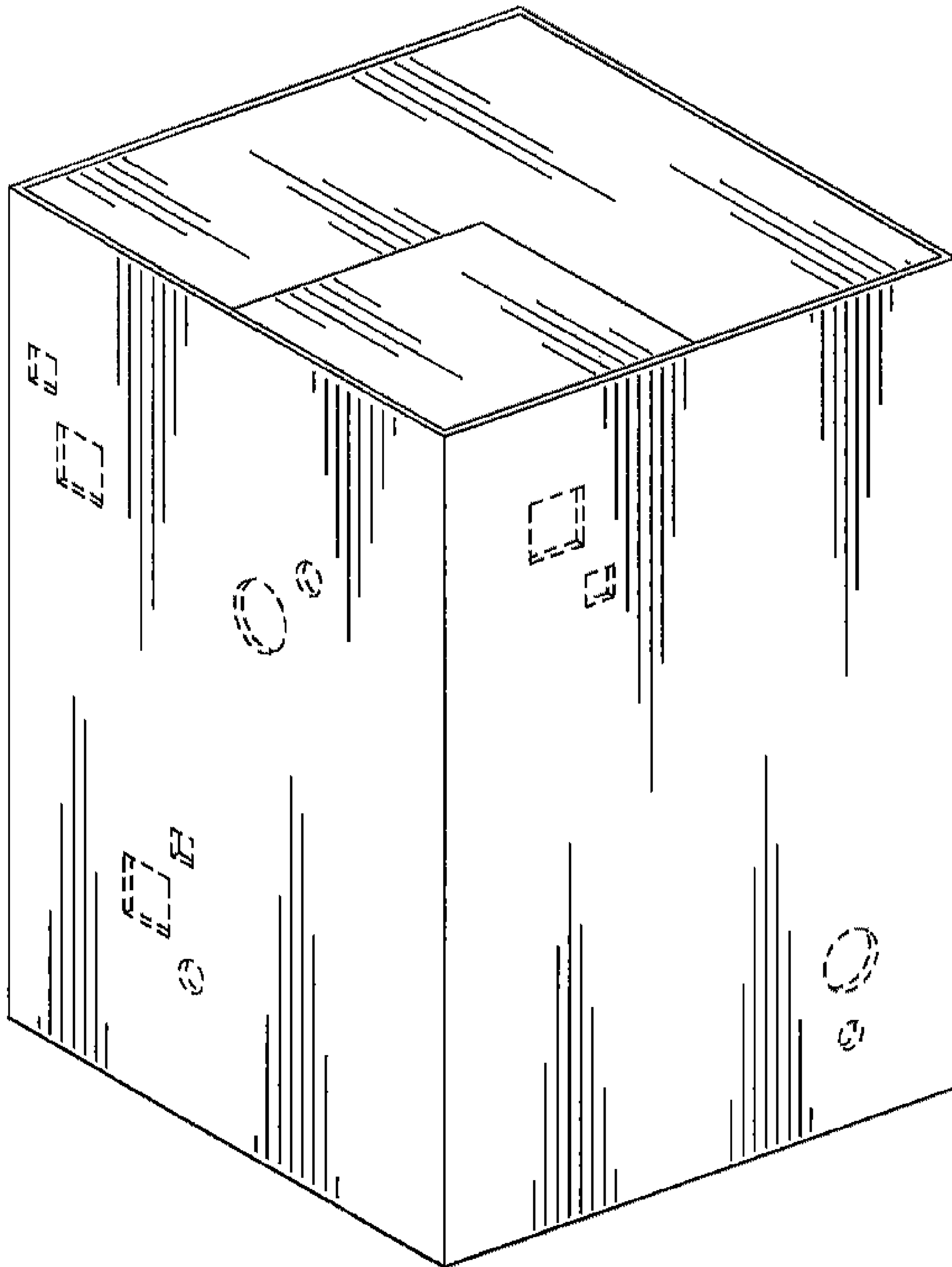

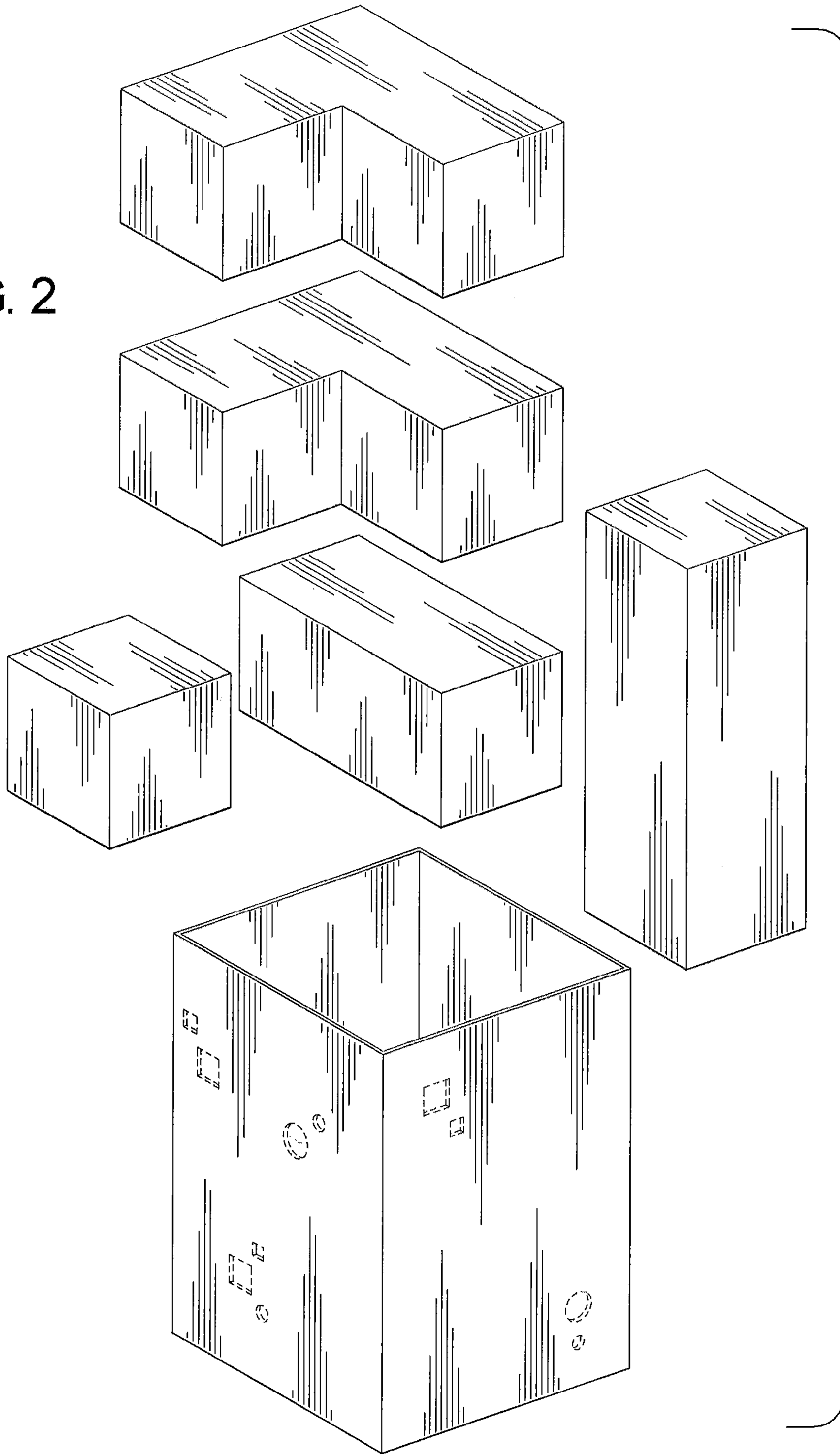
