FIG. 7 is a left elevation view of the design illustrated in FIG. 1.

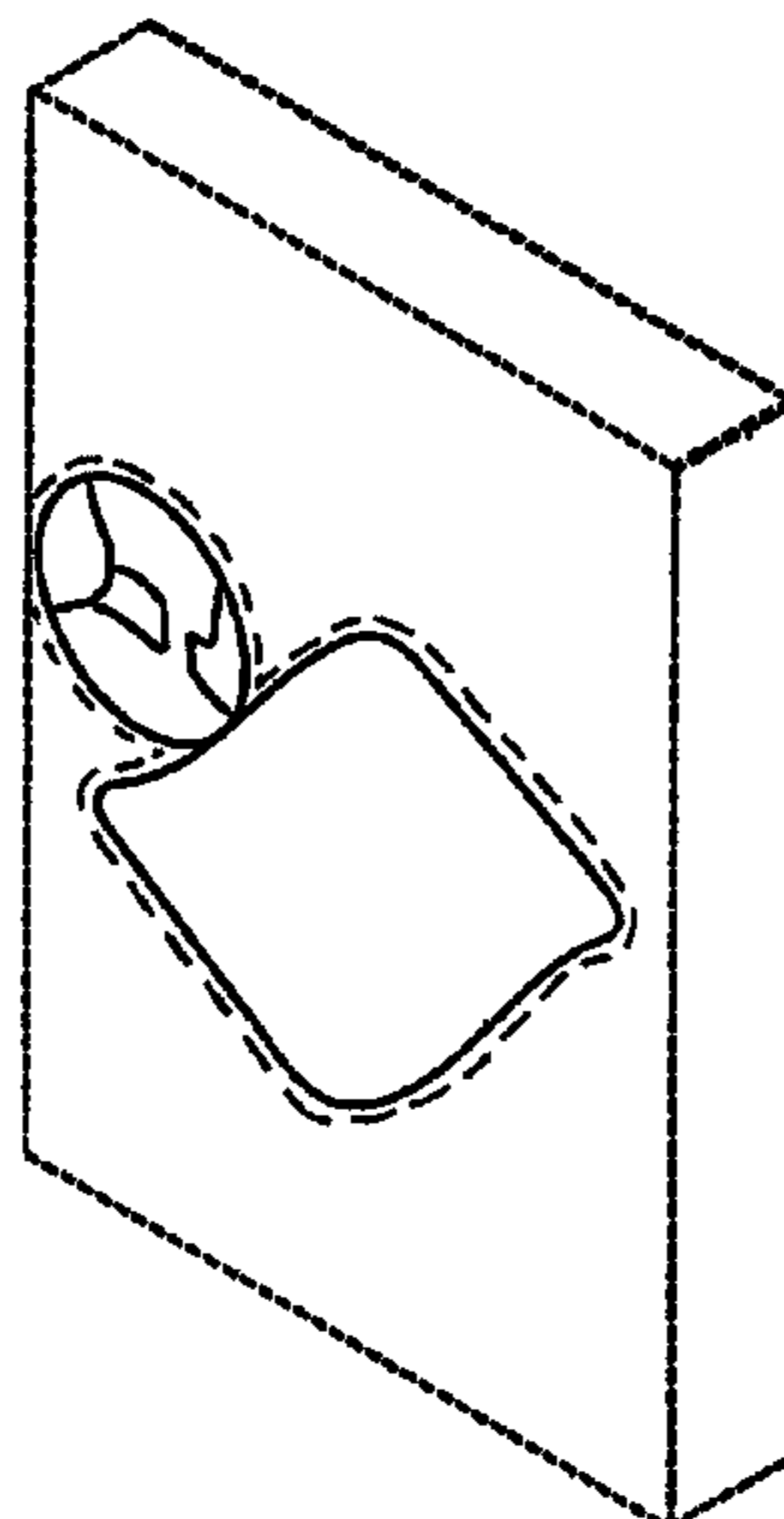

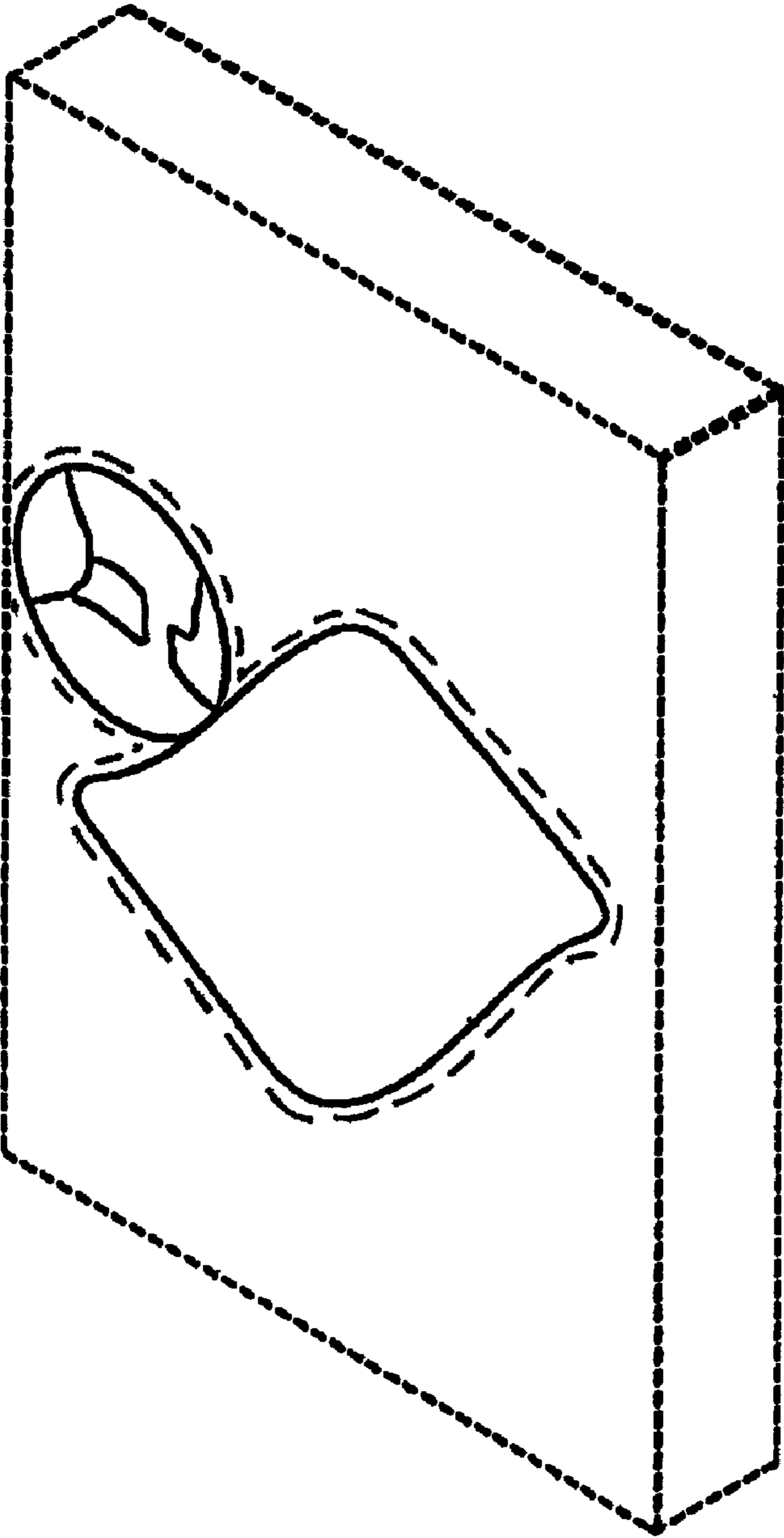

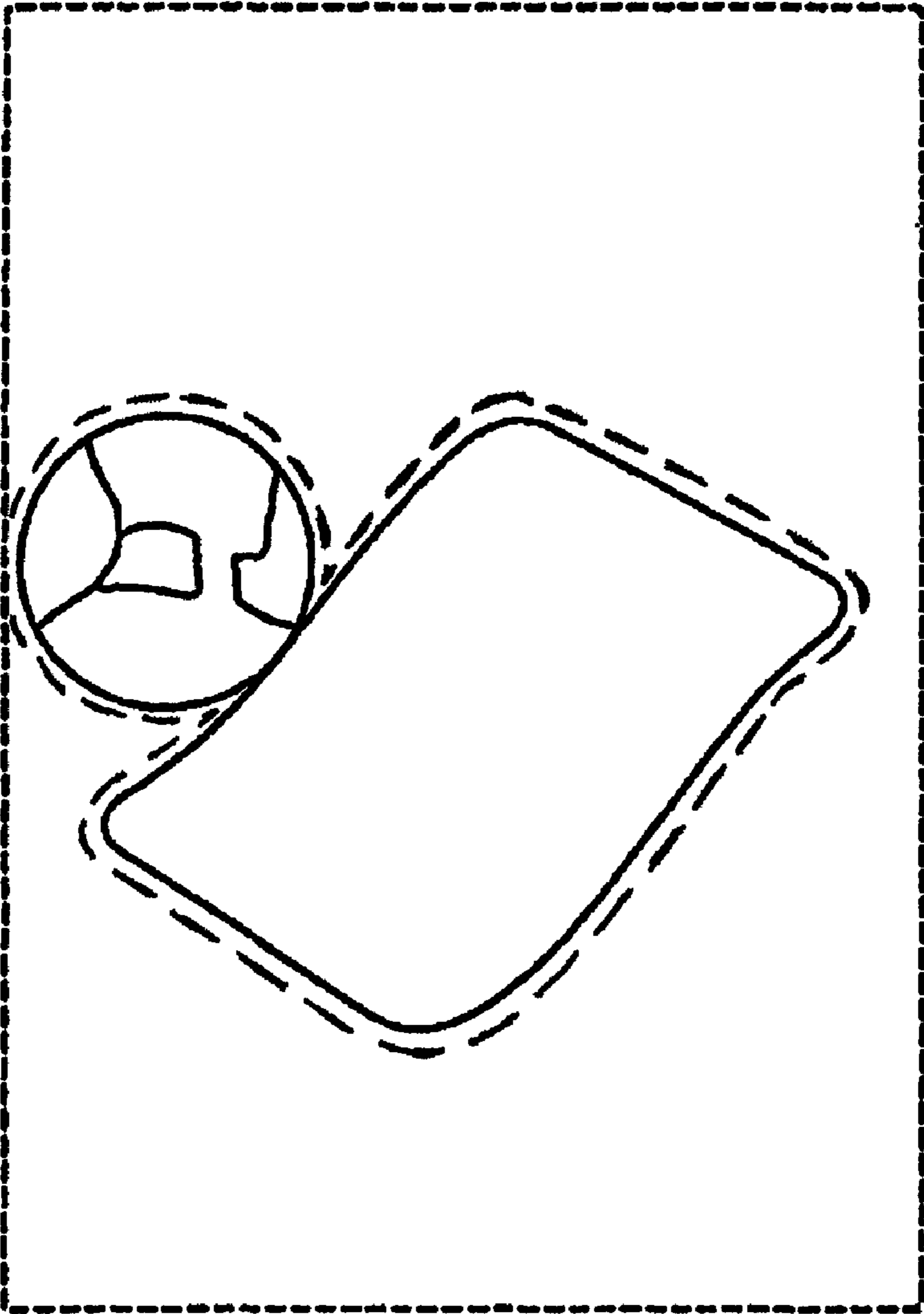

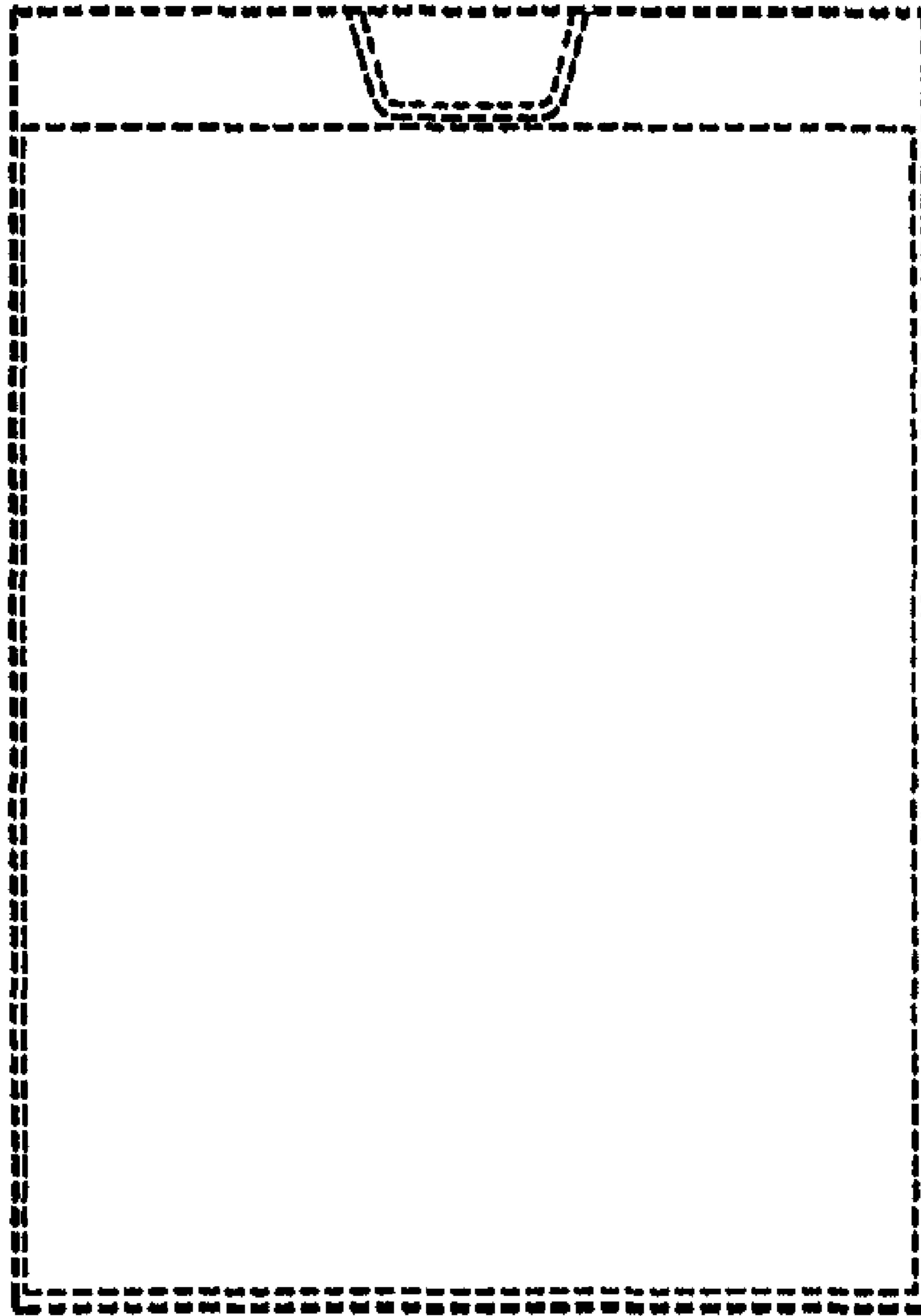

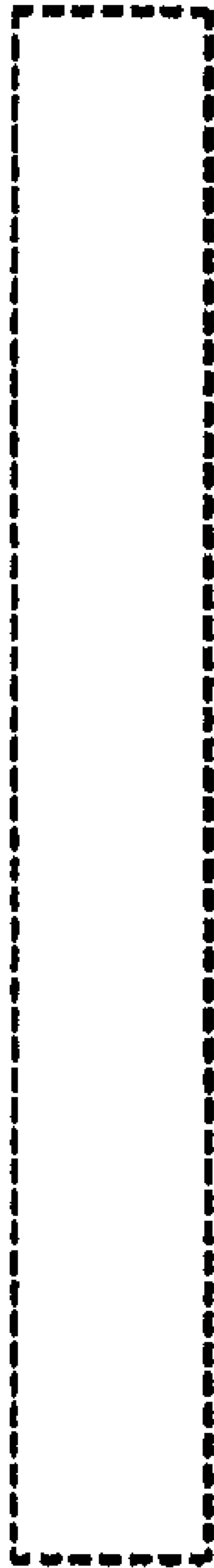

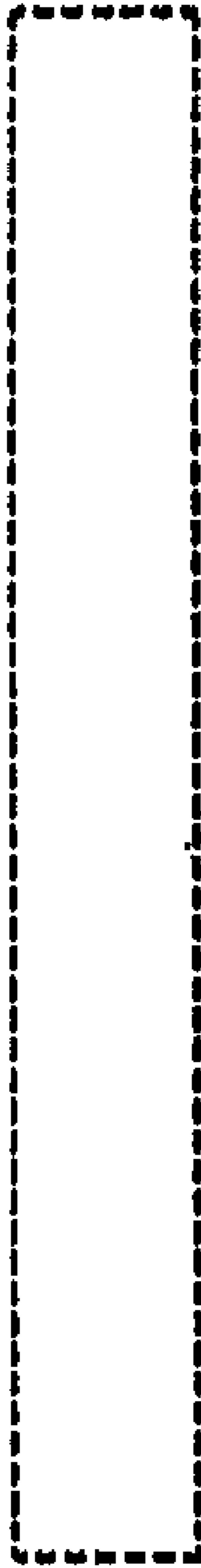
