(57) **CLAIM**

The ornamental design for a cosmetic bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the cosmetic bottle showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear side elevational view thereof;

FIG. 5 is a front side elevational view thereof; and,

FIG. 6 is a top plan view thereof.

The broken lines are included for the purpose of illustrating portions of the cosmetic bottle that form no part of the claimed design.

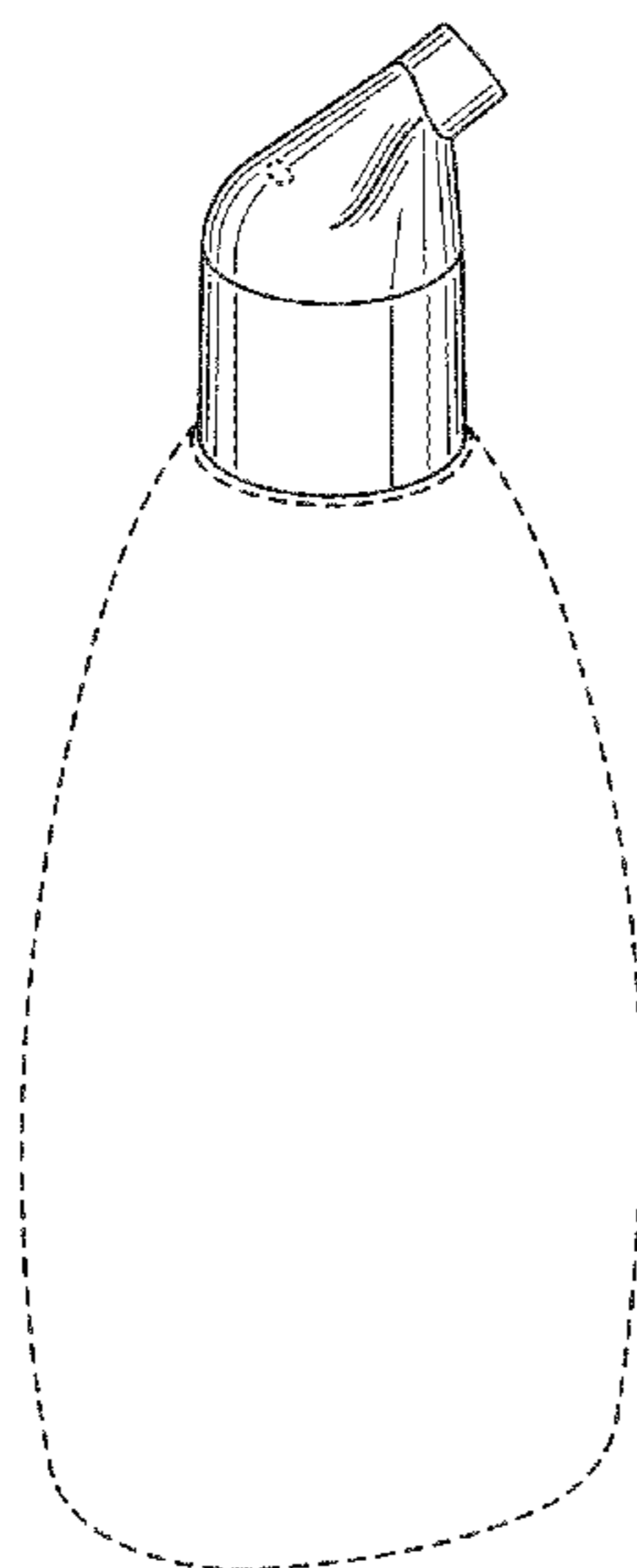

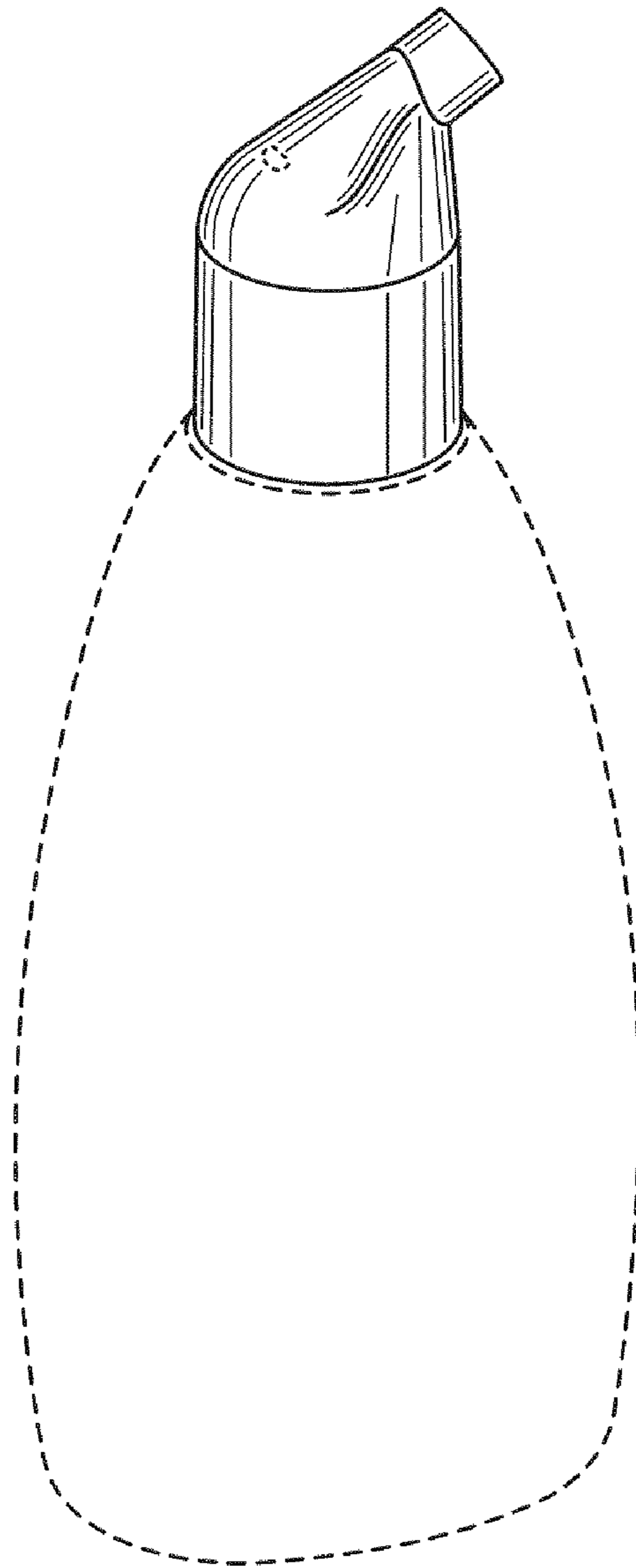

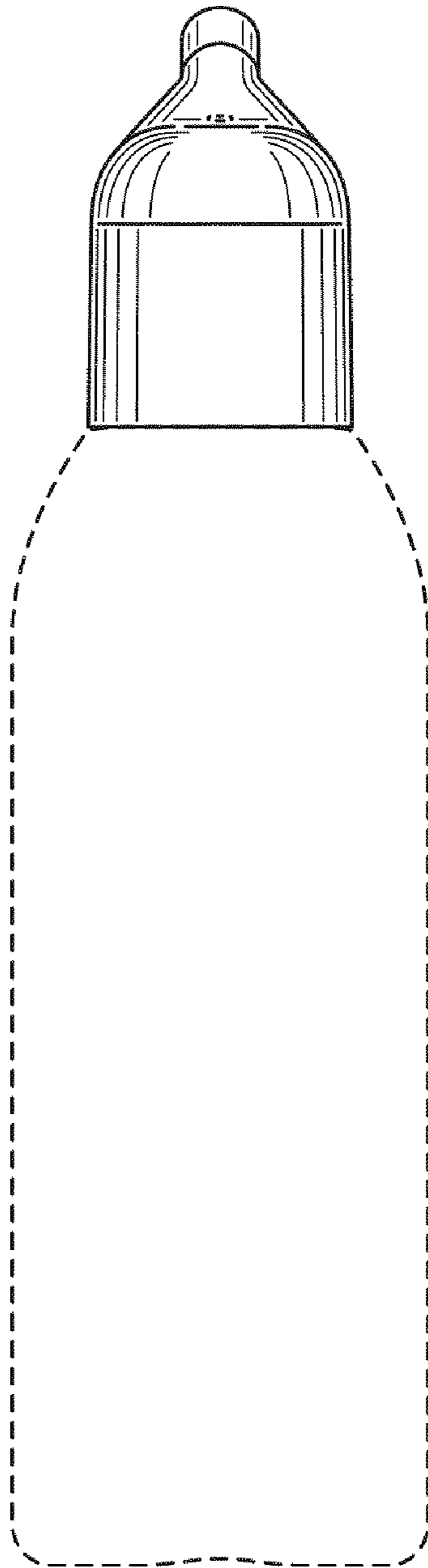

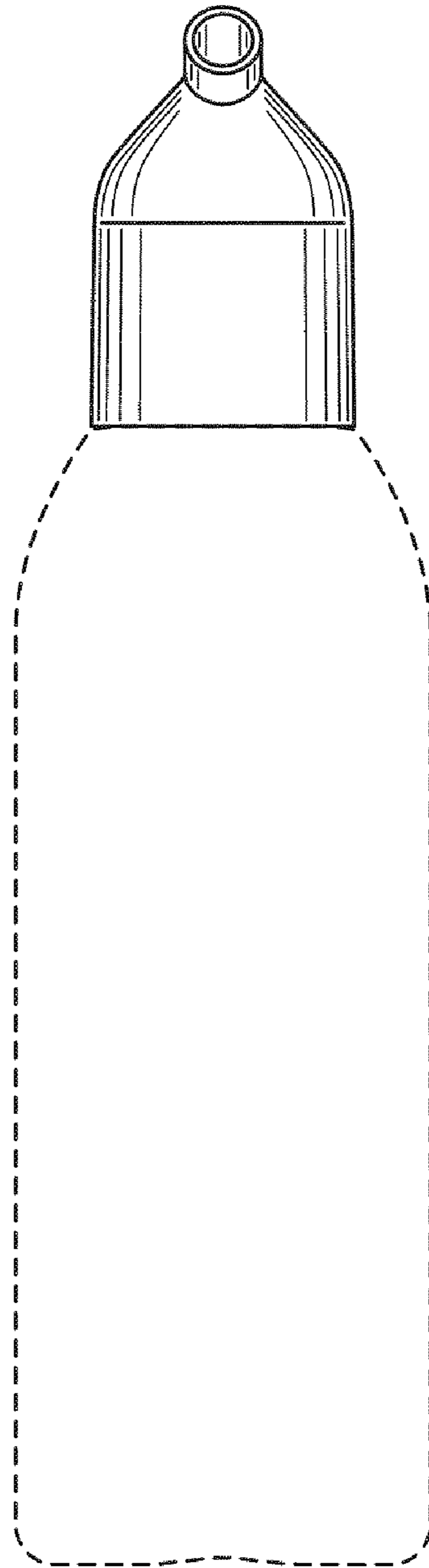

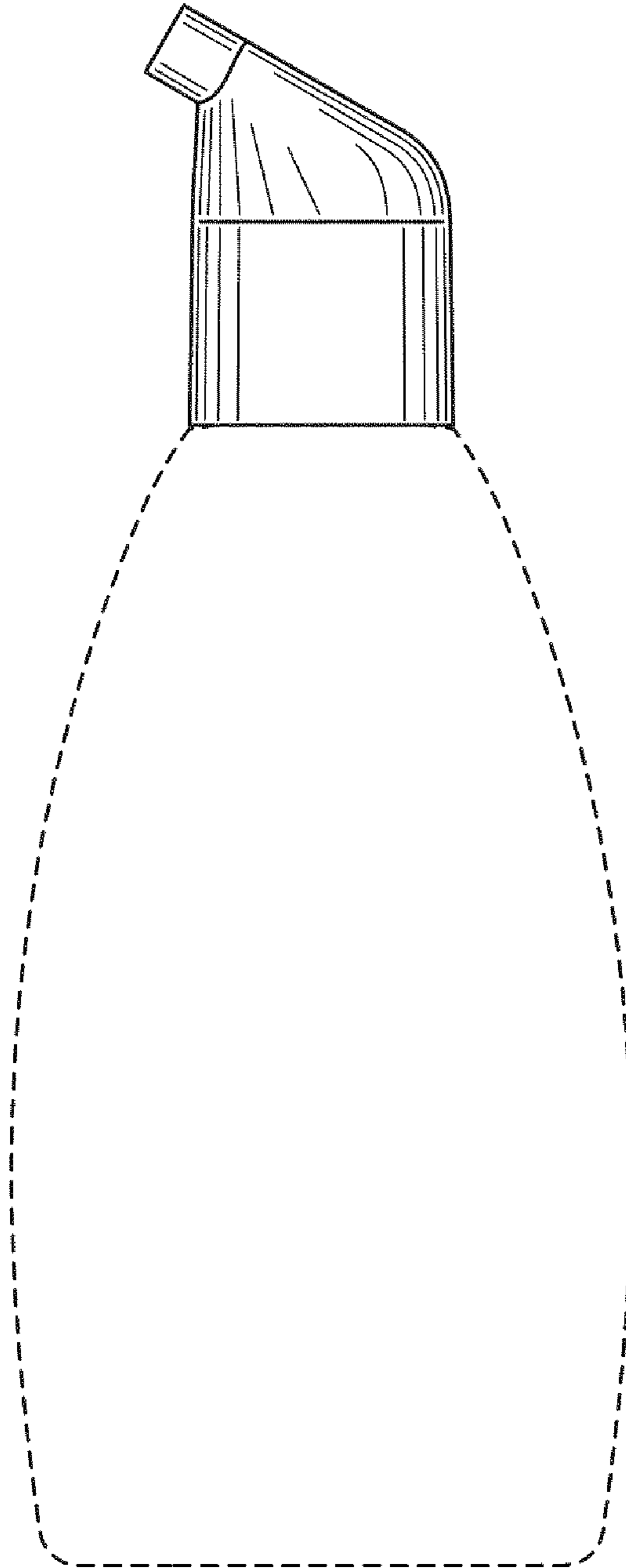

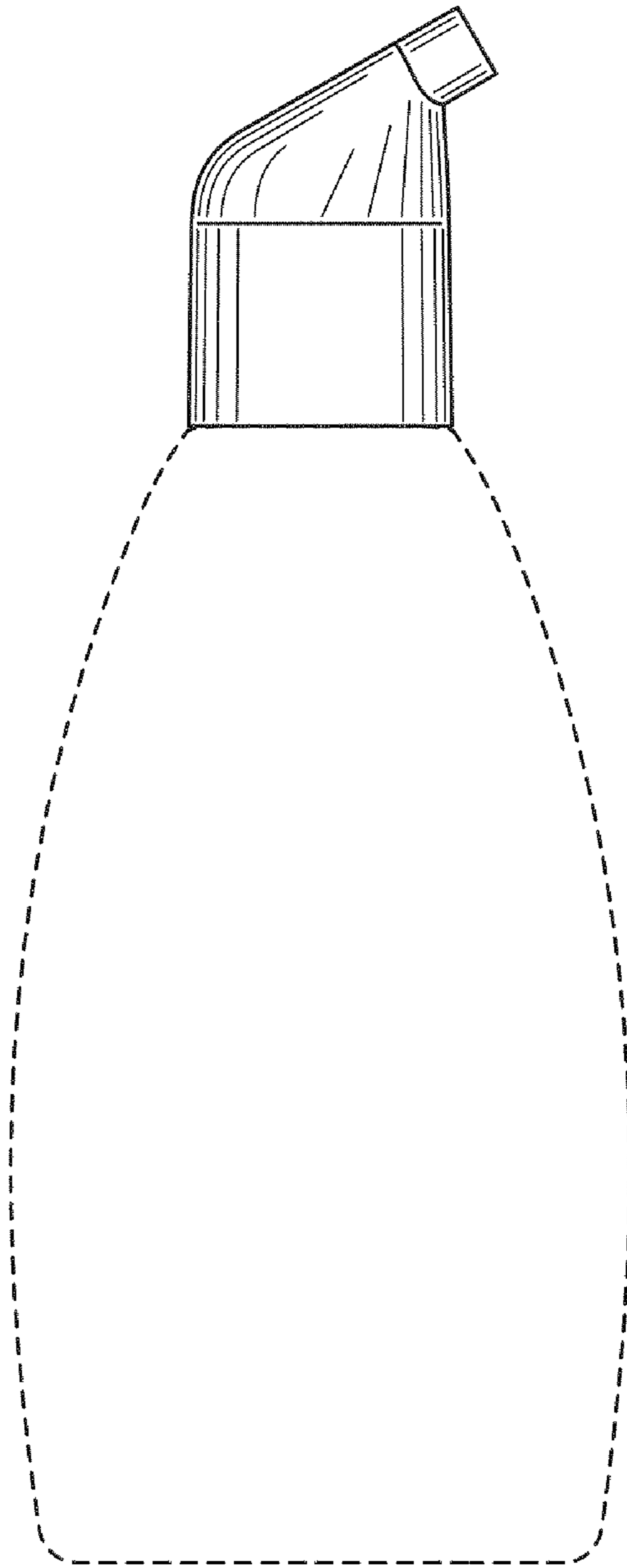
