The ornamental design for a bottle, as shown and described.

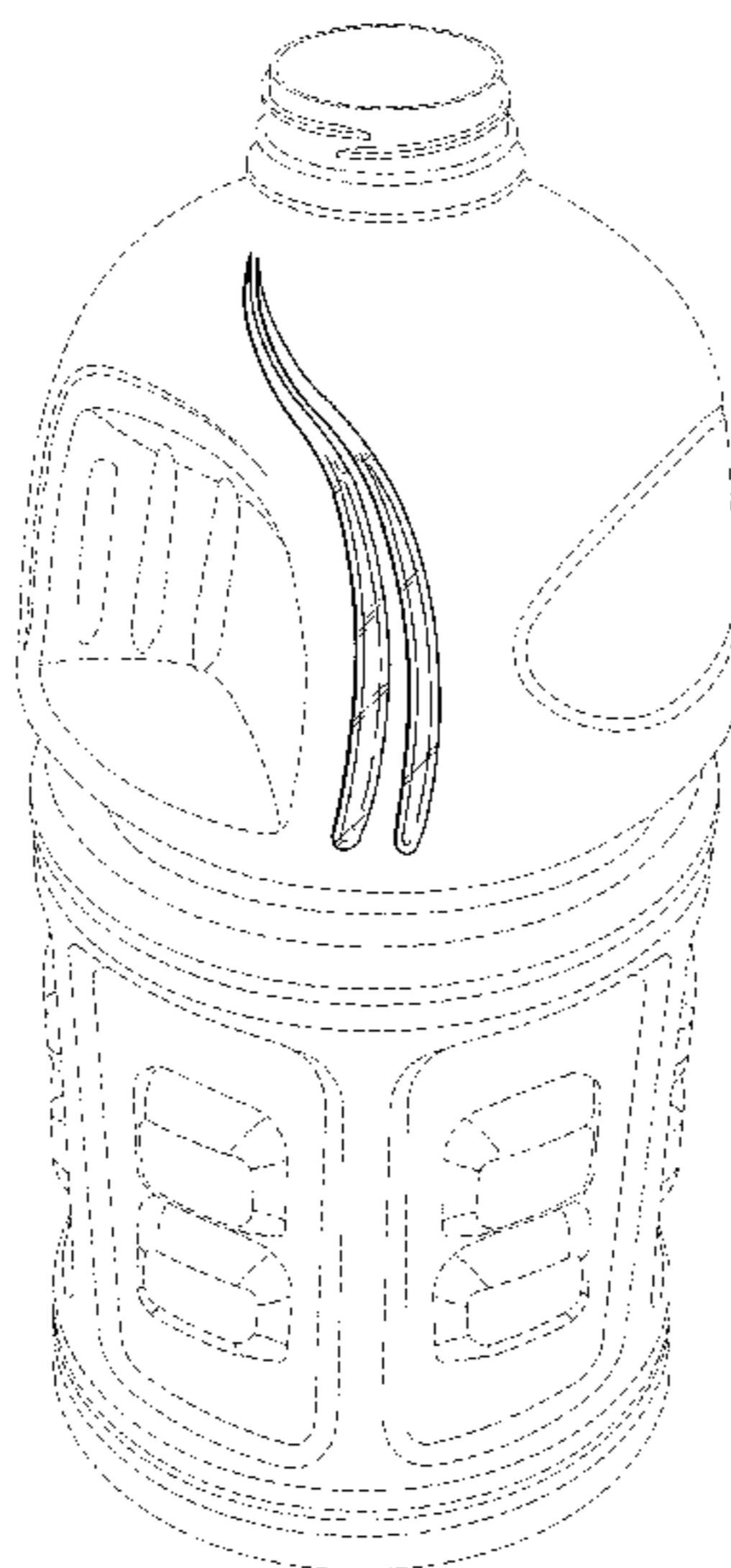
DESCRIPTION

FIG. 1 is a rear, left side perspective view of a bottle showing our new design;
 FIG. 2 is a reverse perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a left side view thereof, with the right side view thereof being a mirror image thereof (with the exception of the phantom-line threaded portion on the neck); and,
 FIG. 6 is an enlarged sectional view taken along lines 6—6 of FIG. 3.

The broken lines showing environment or structure of the bottle are for illustrative purposes only and form no part of the claimed design.

In the drawings, the broken lines in FIGS. 1-6 depict portions of the design that form no part of the claim.

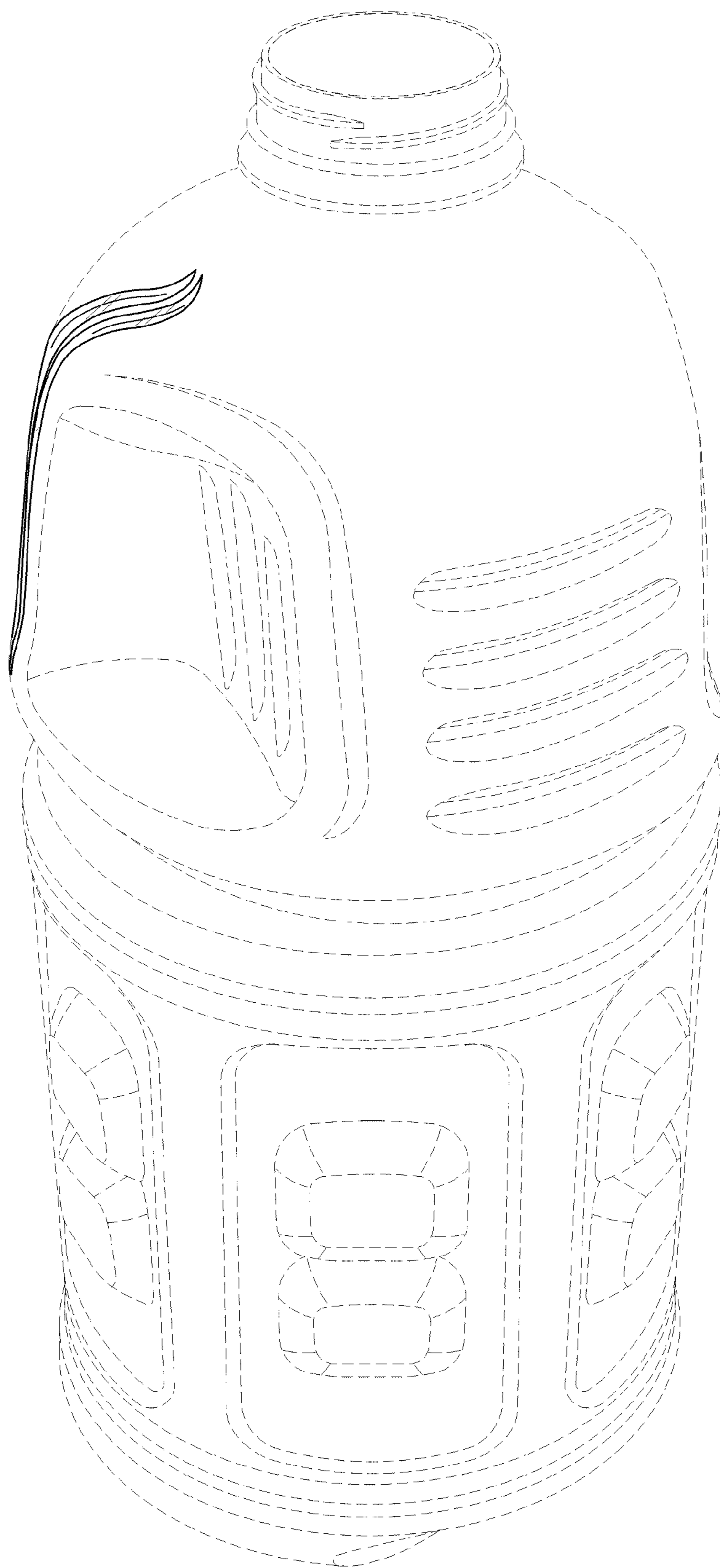

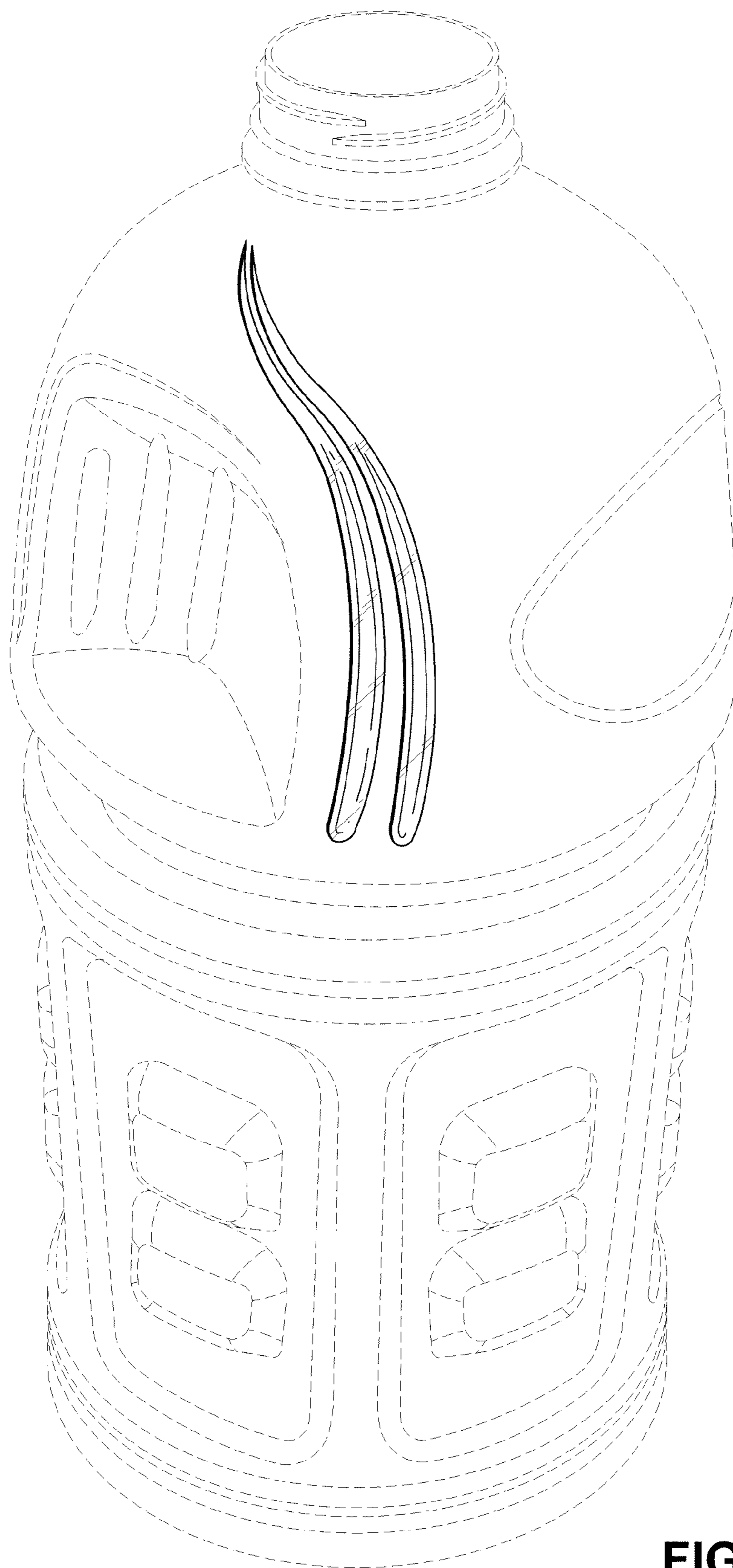

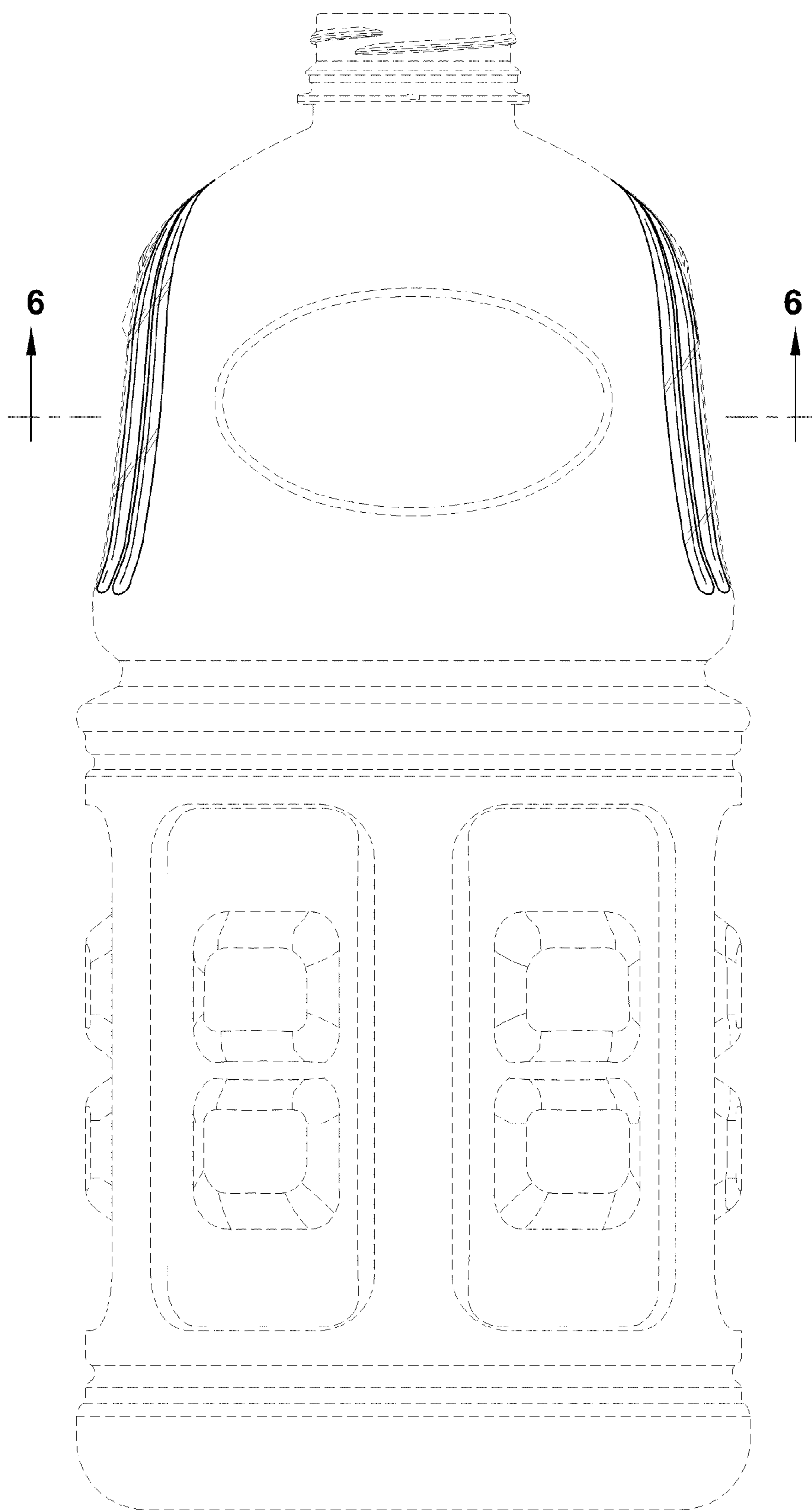

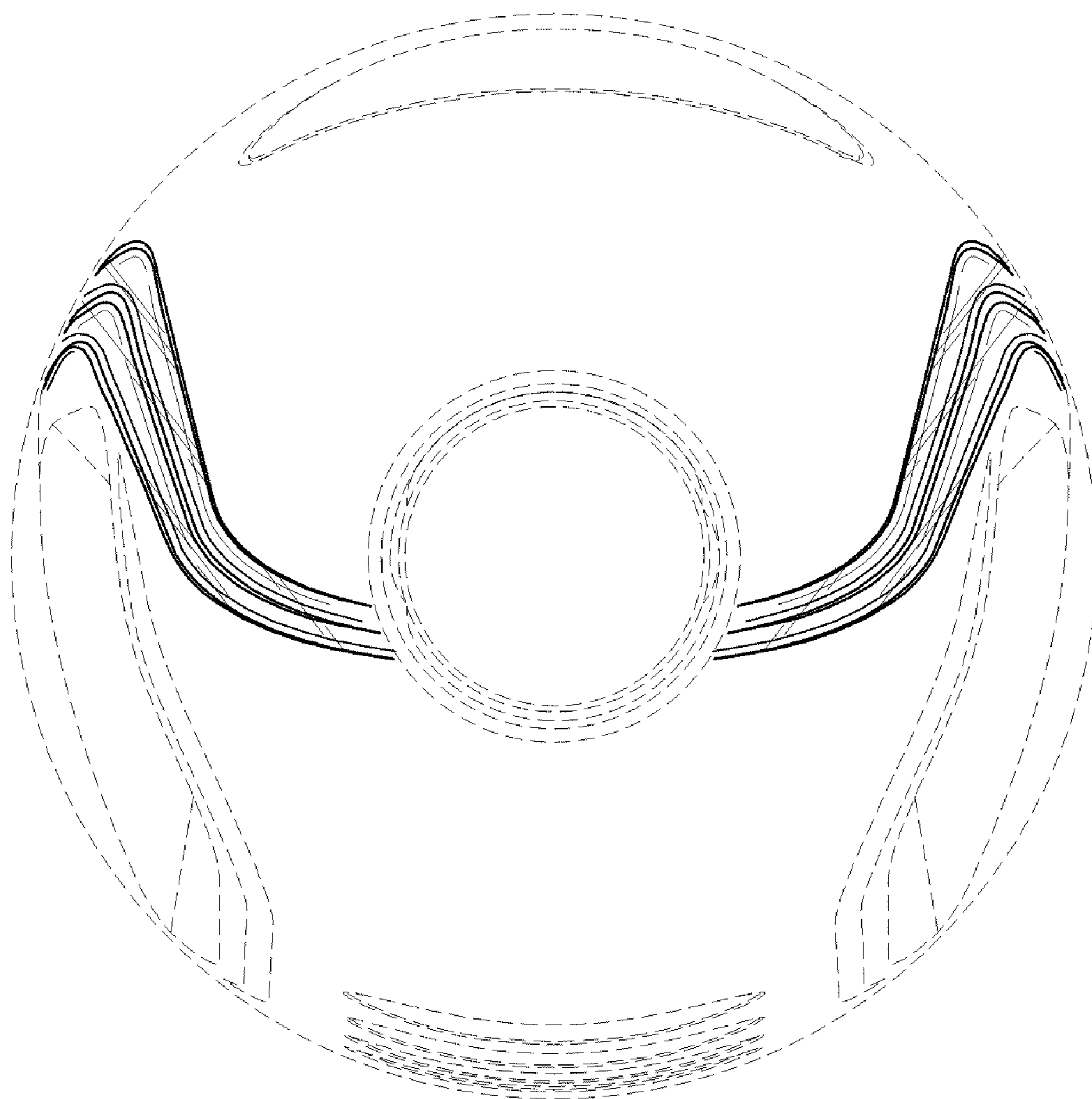

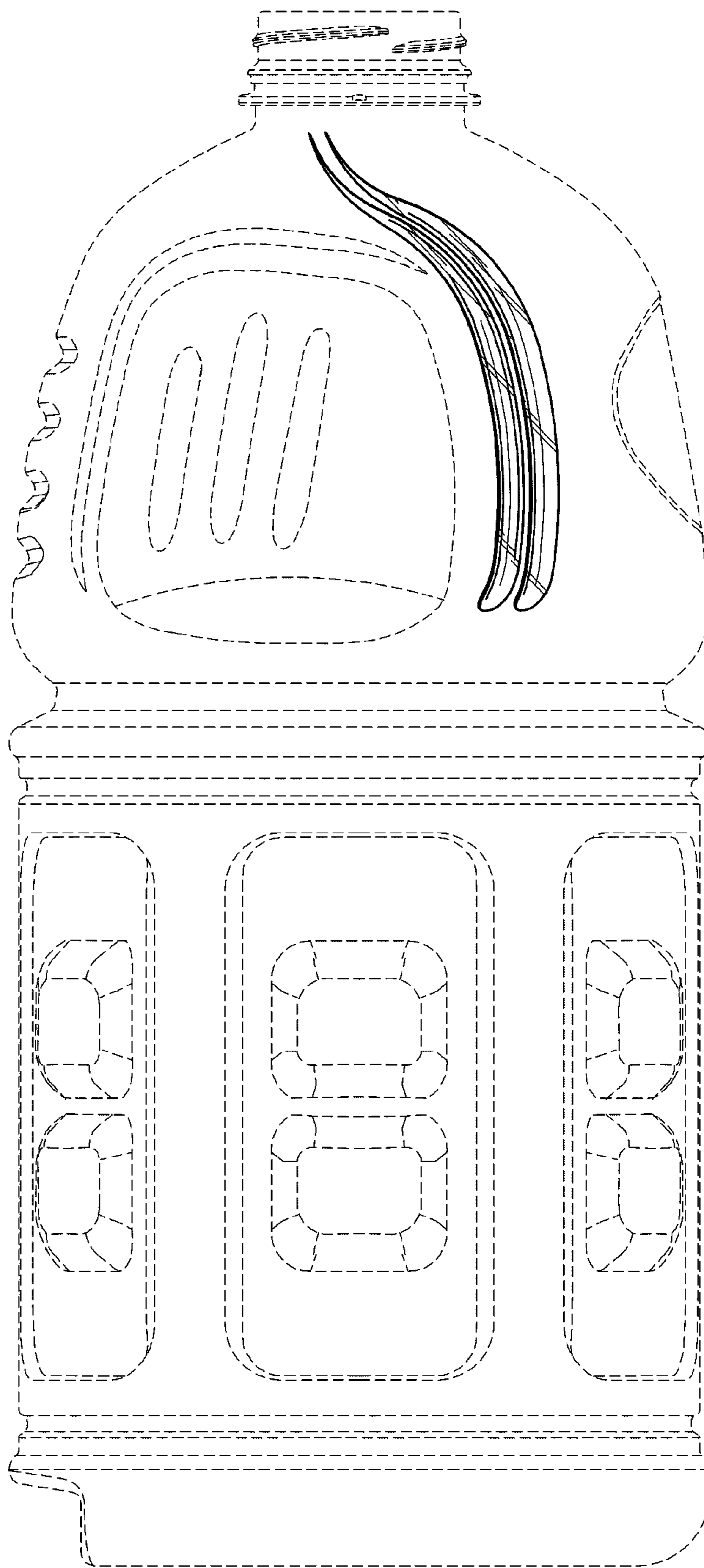

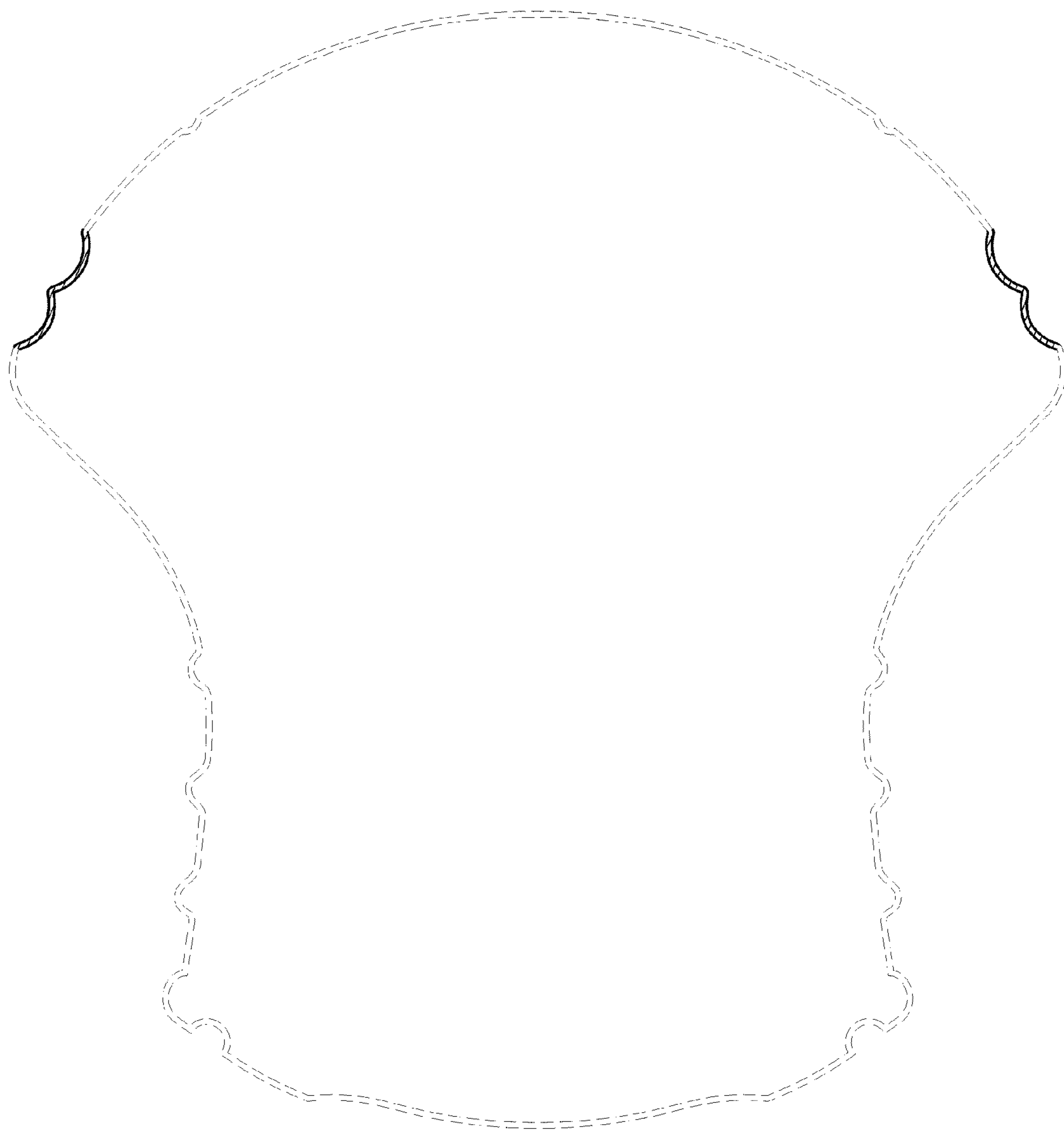
