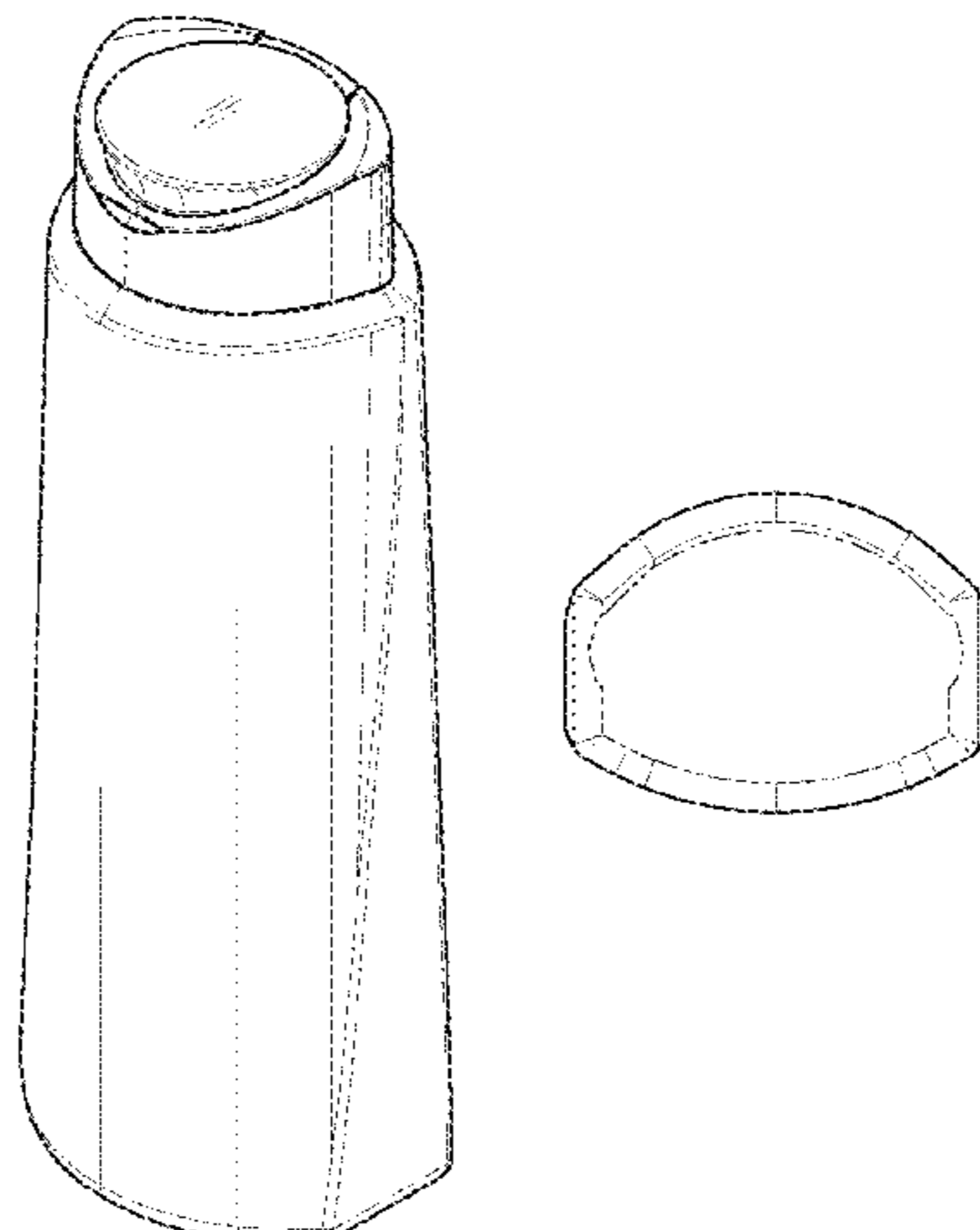

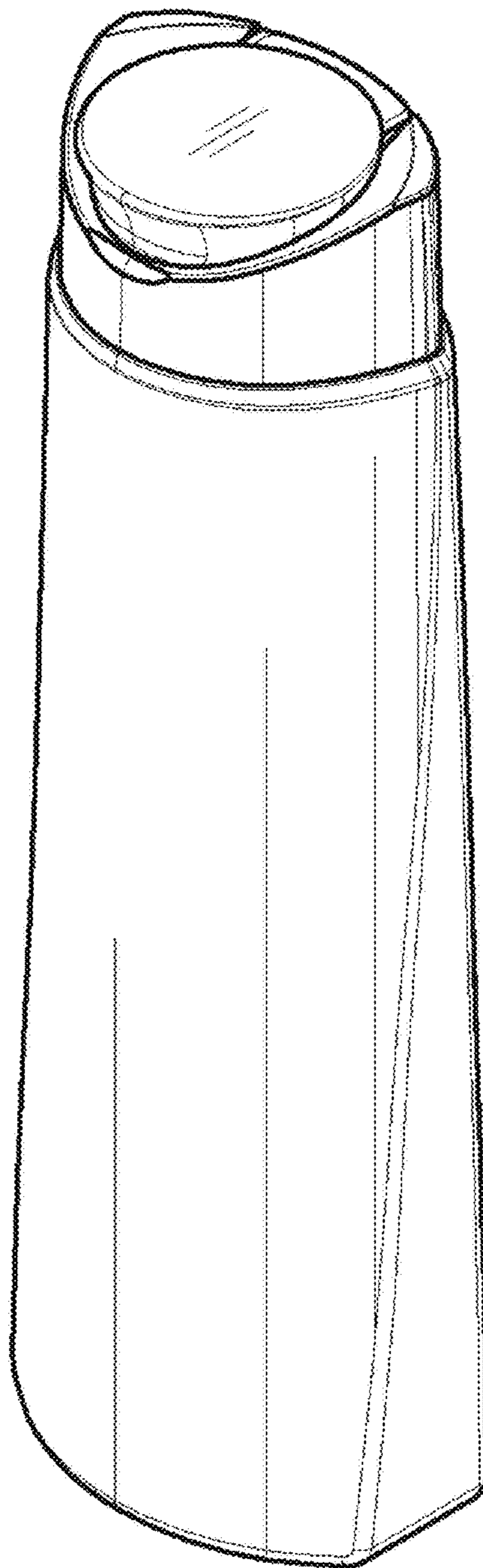
The ornamental design for a container for hair care composition, as shown and described.

**DESCRIPTION**

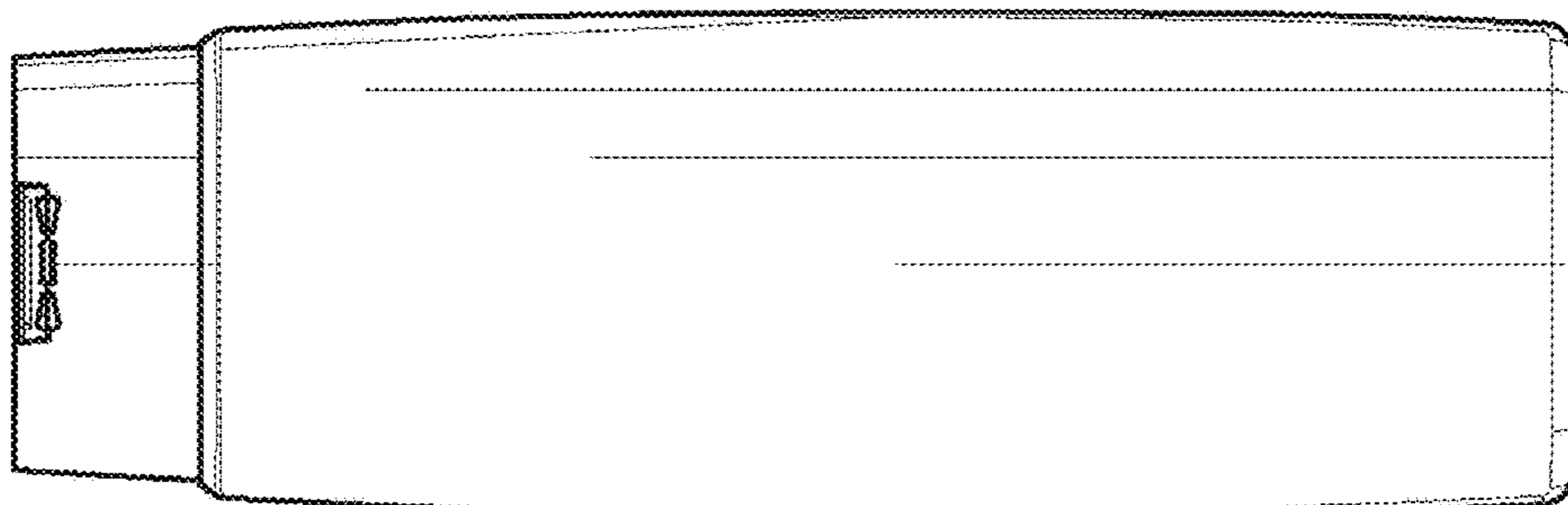

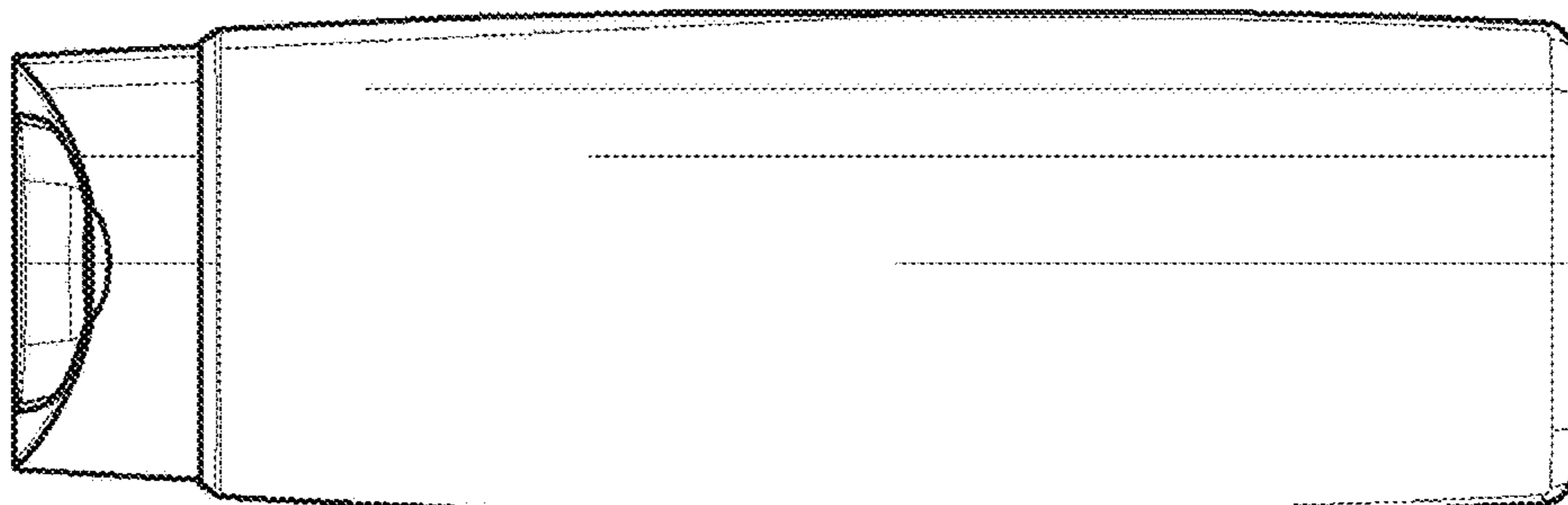




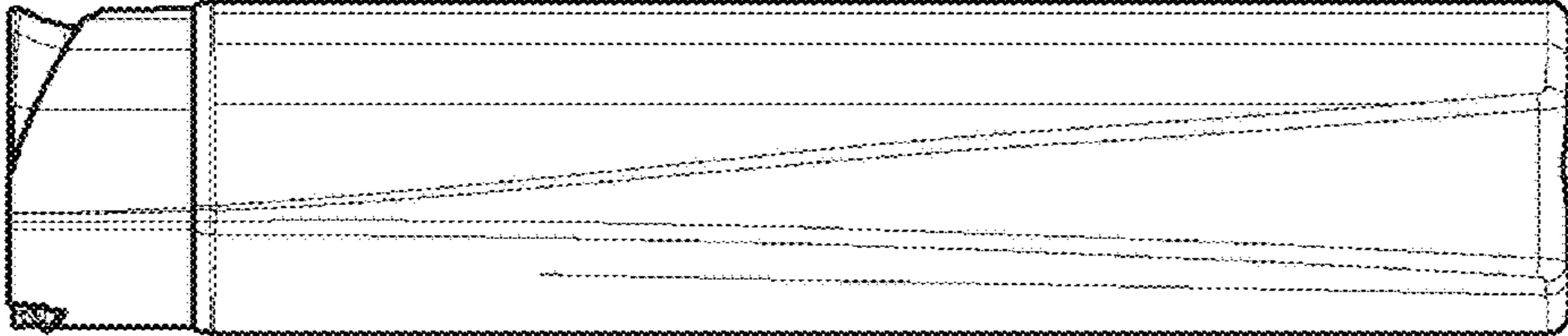

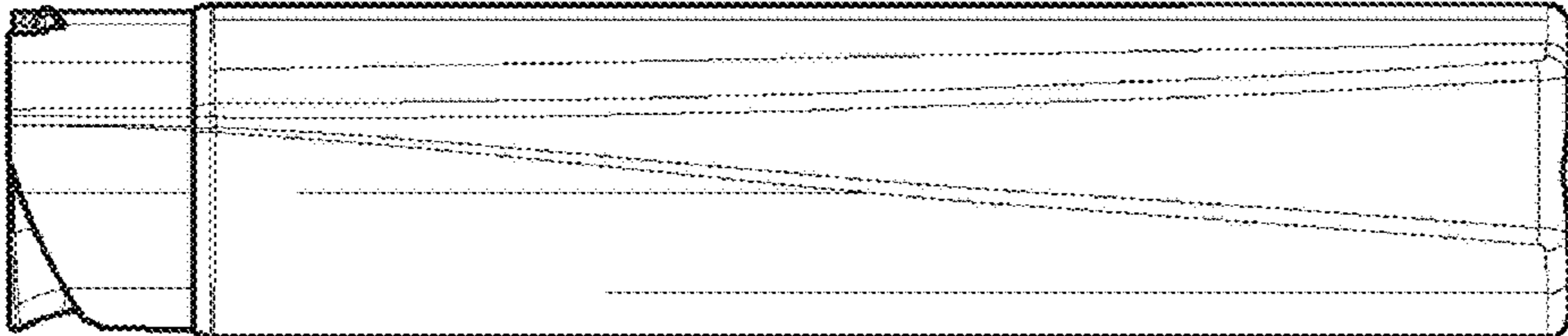

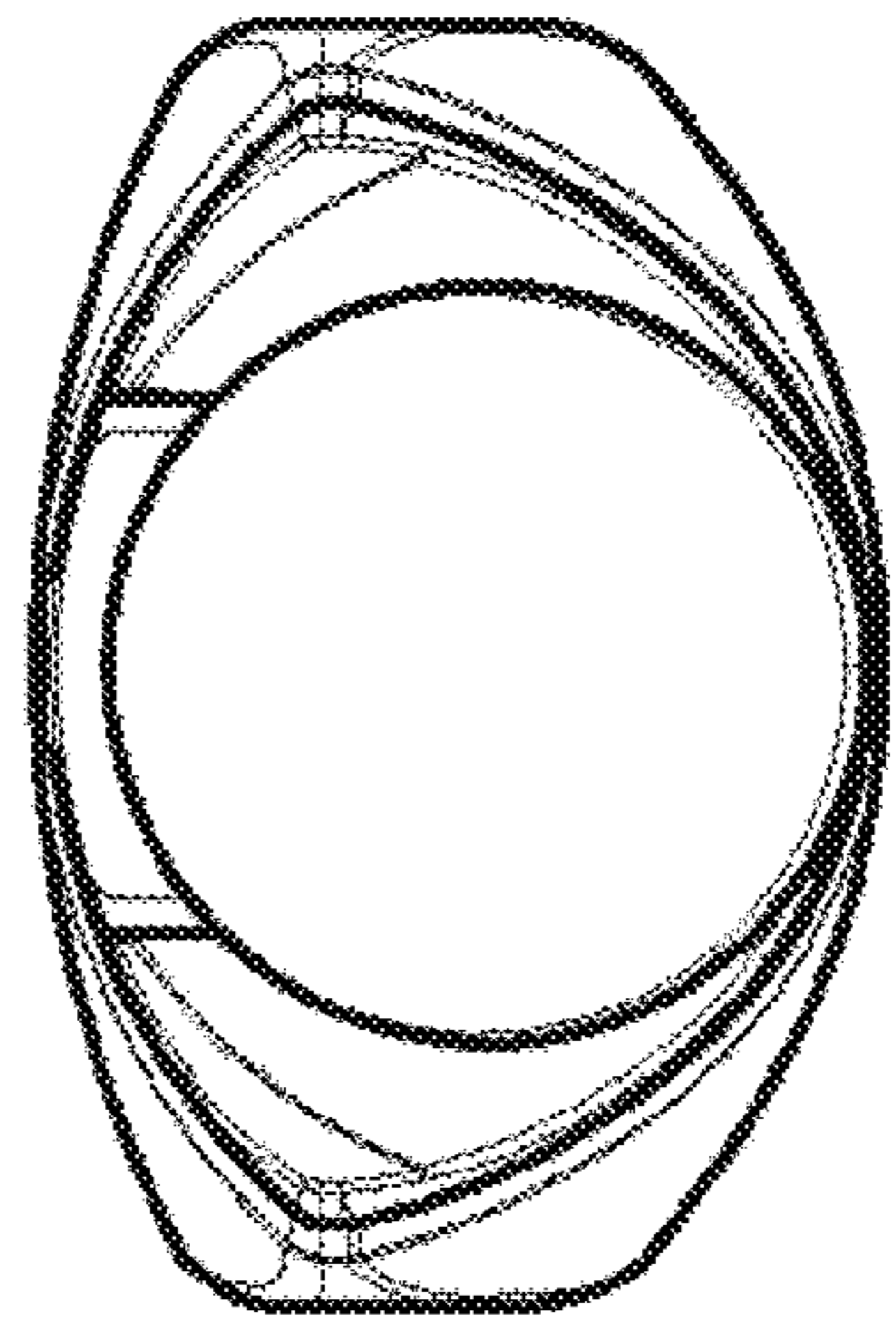

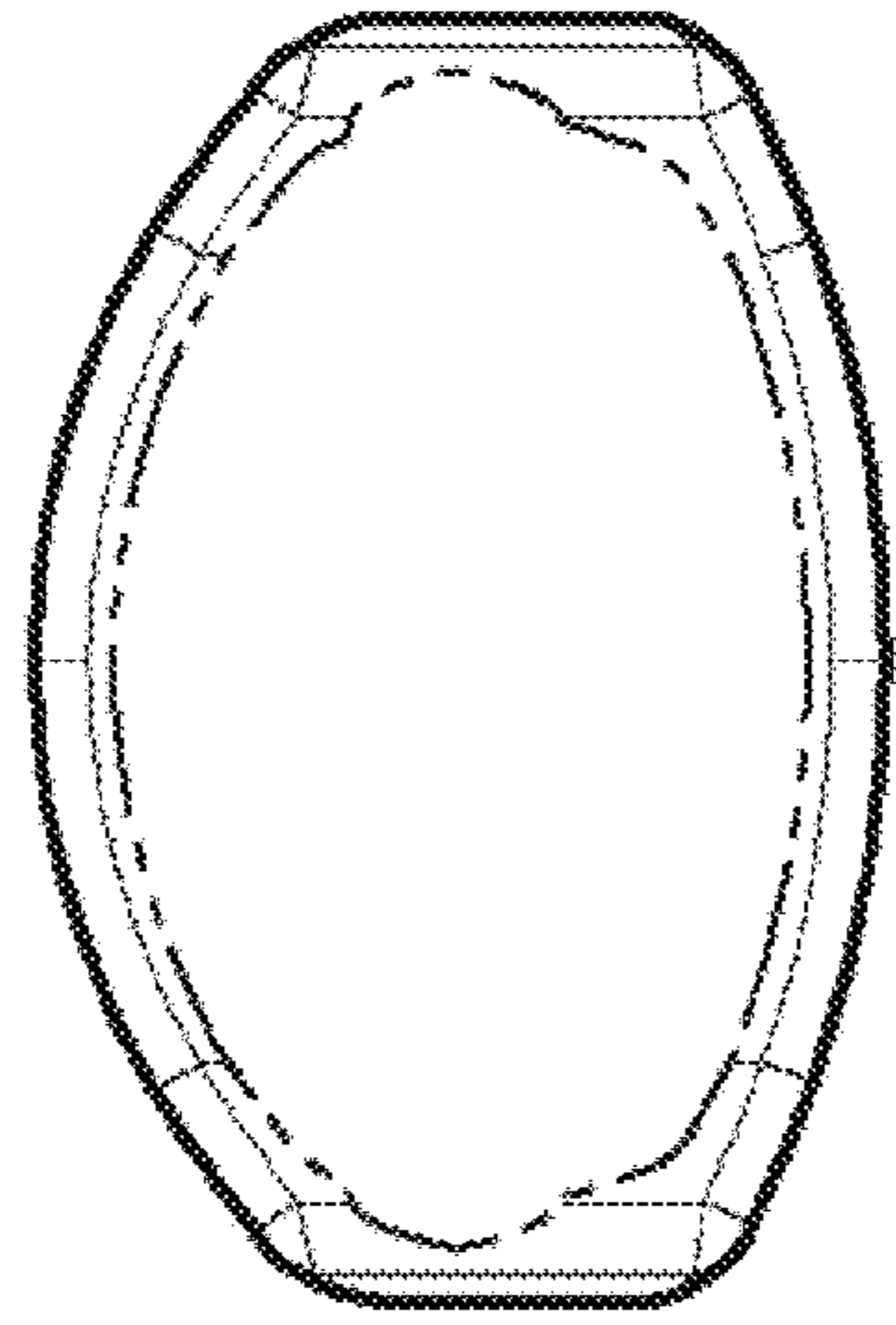

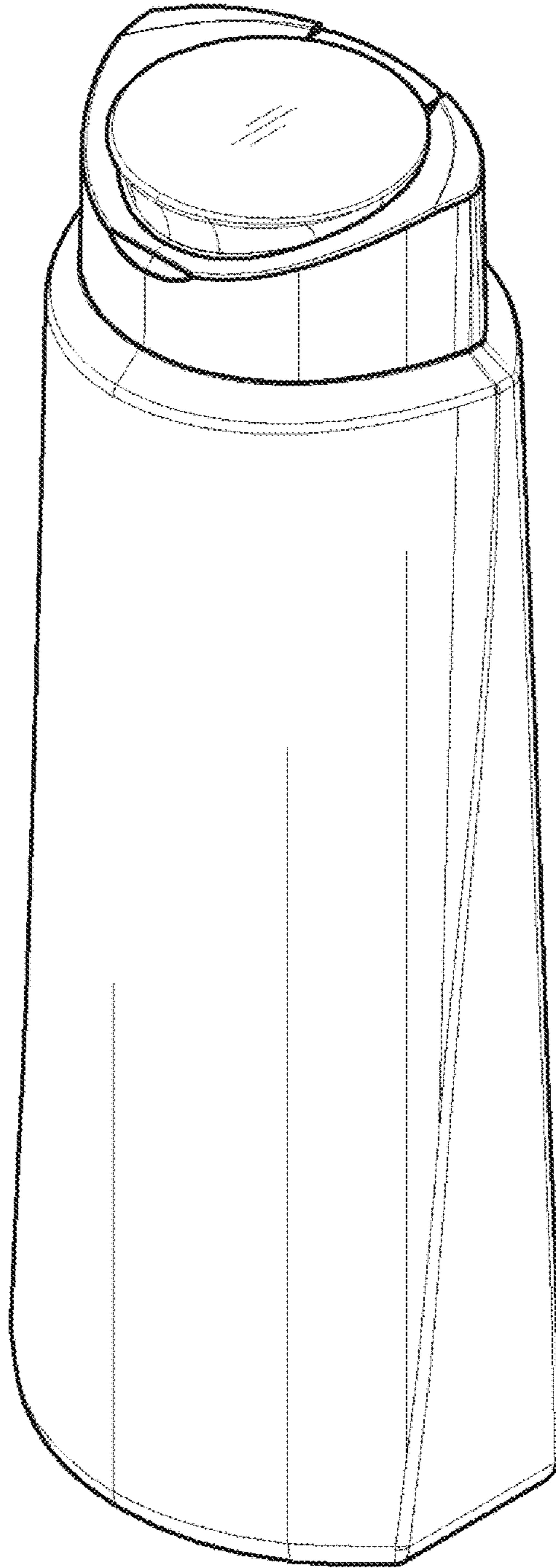

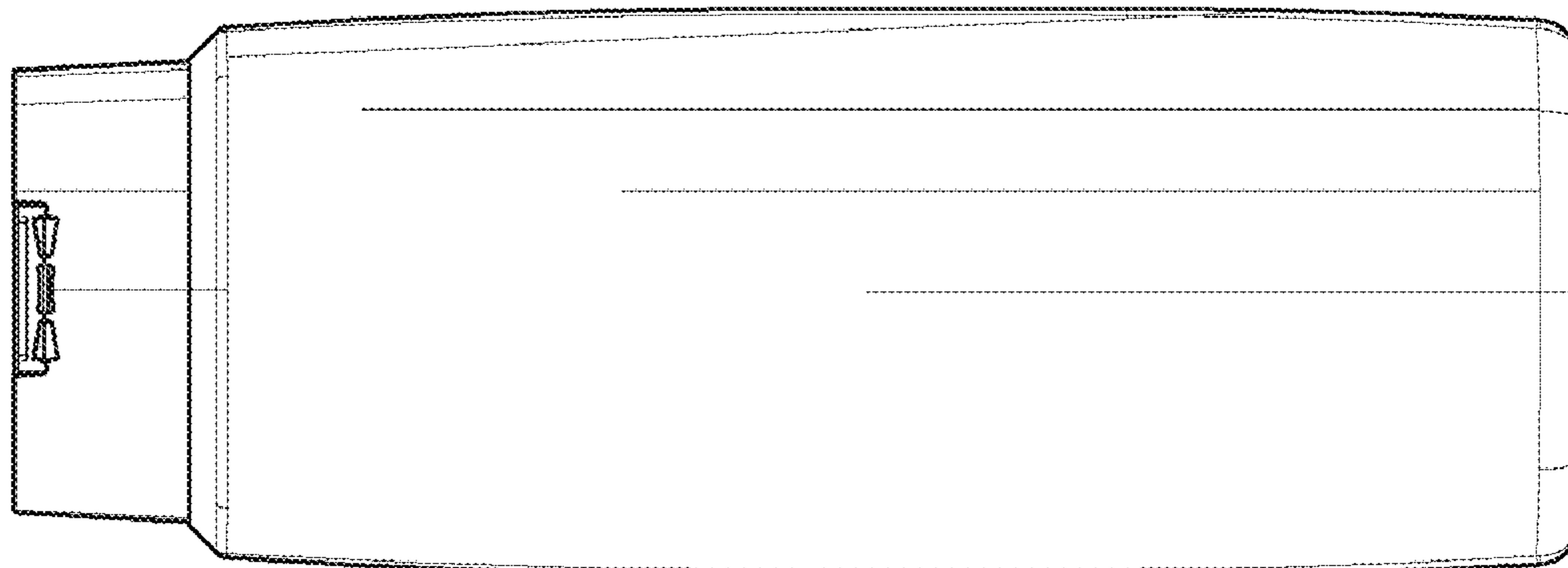

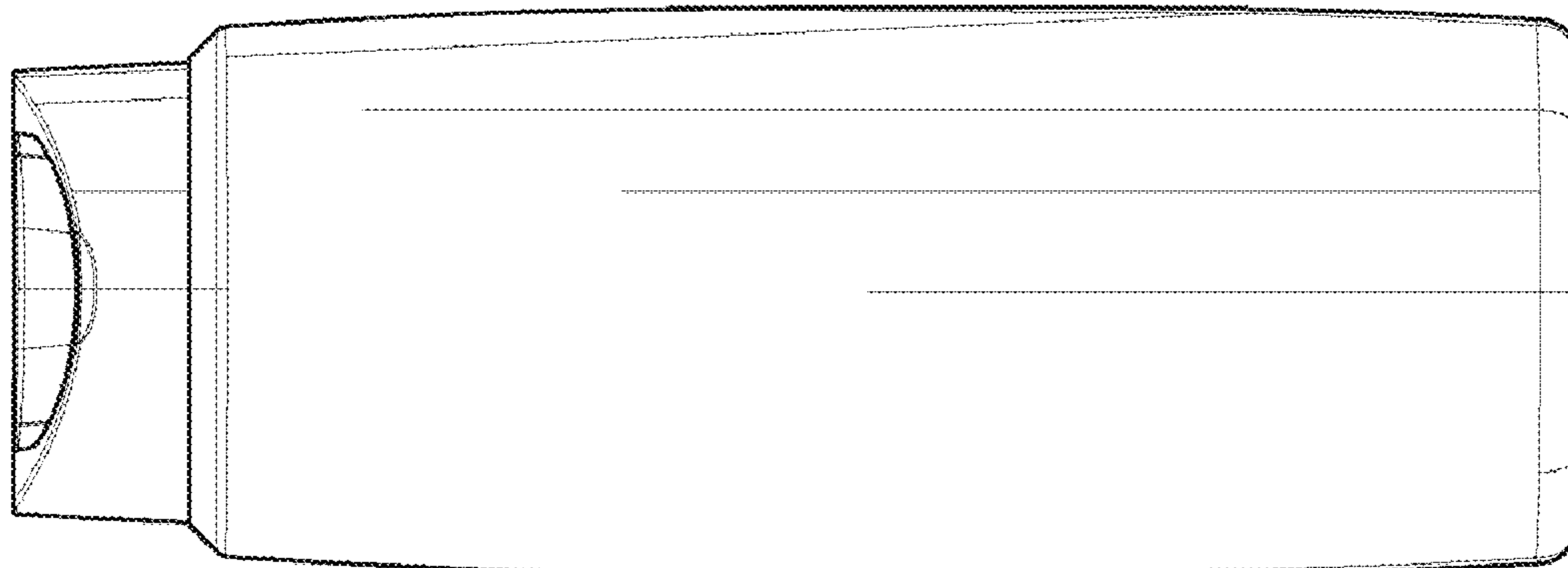

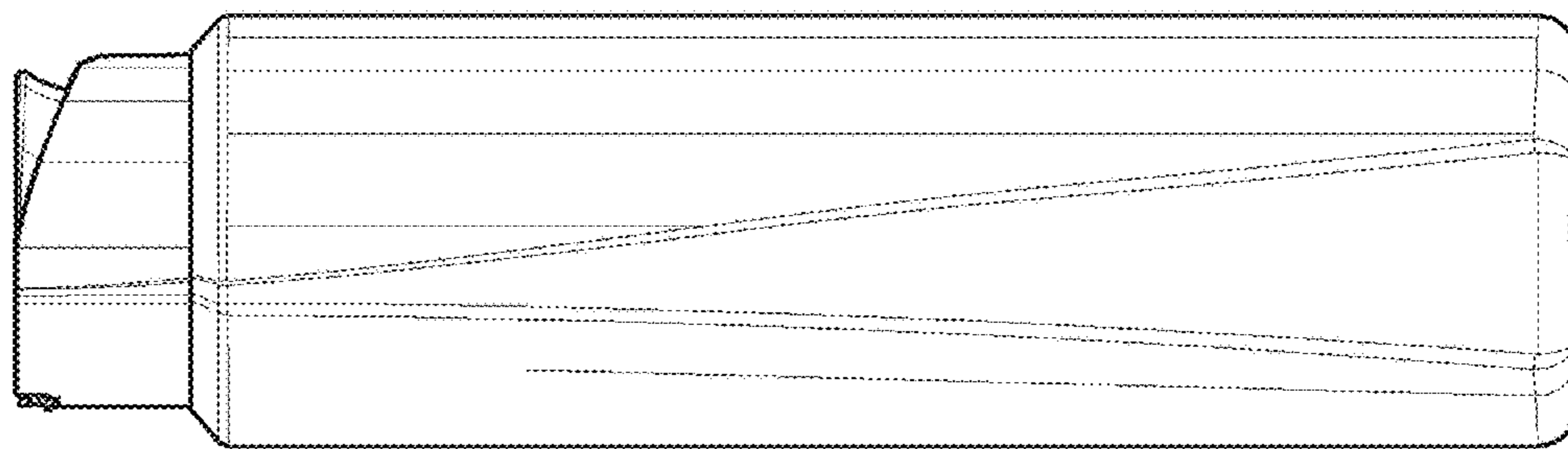

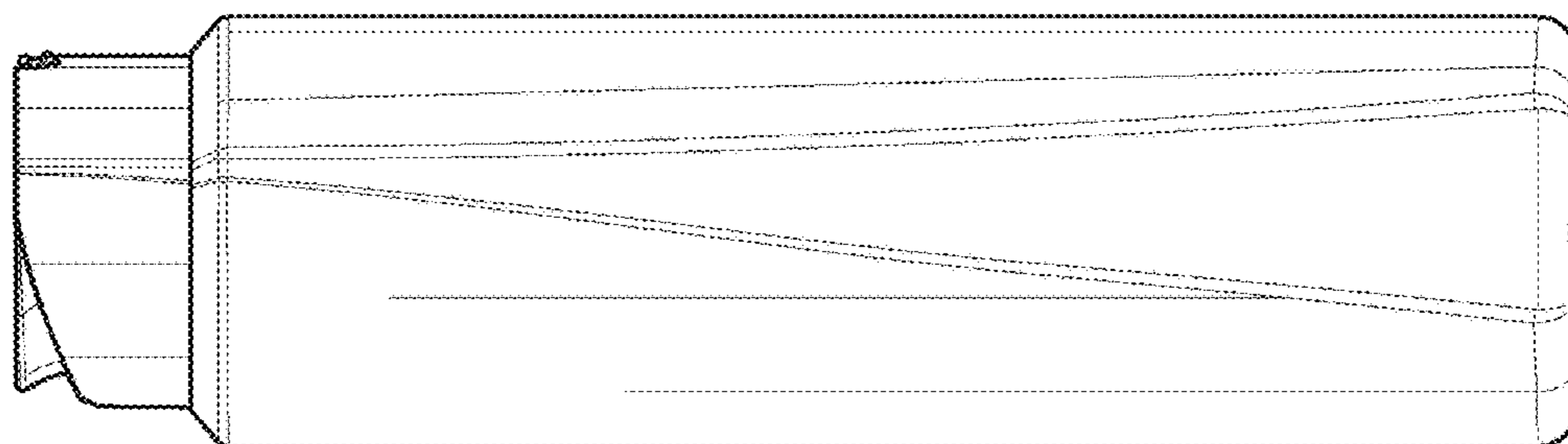

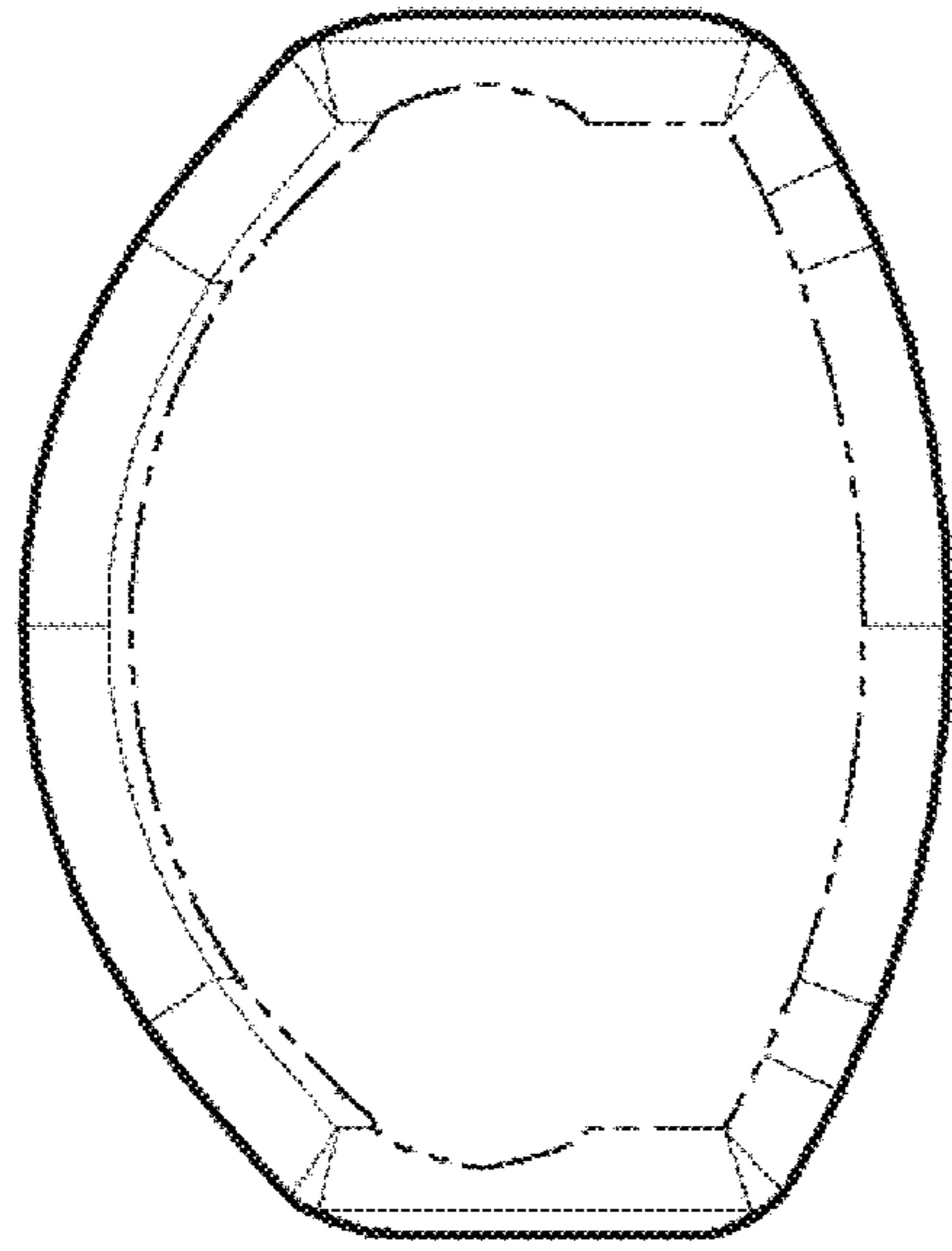

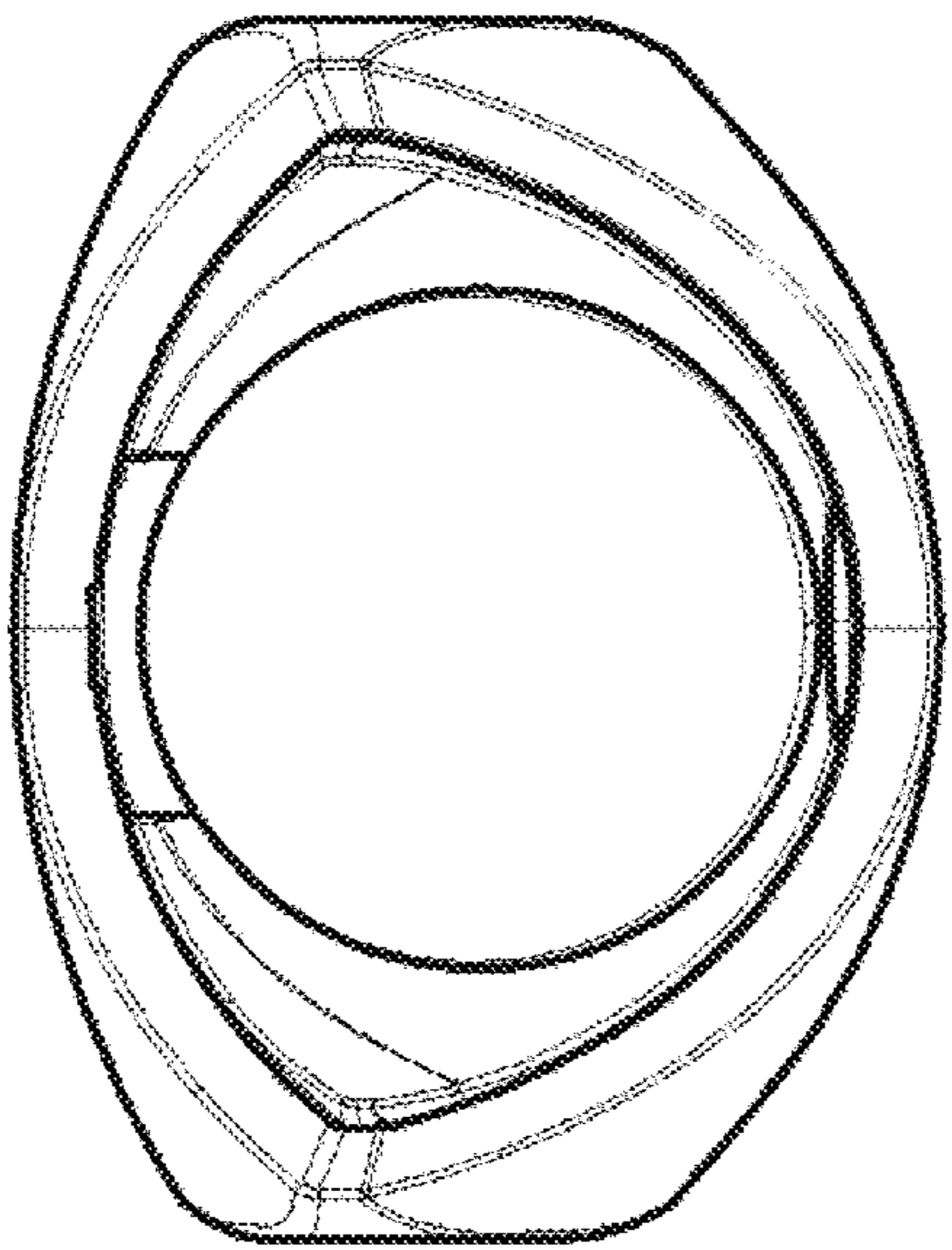
