(57) **CLAIM**

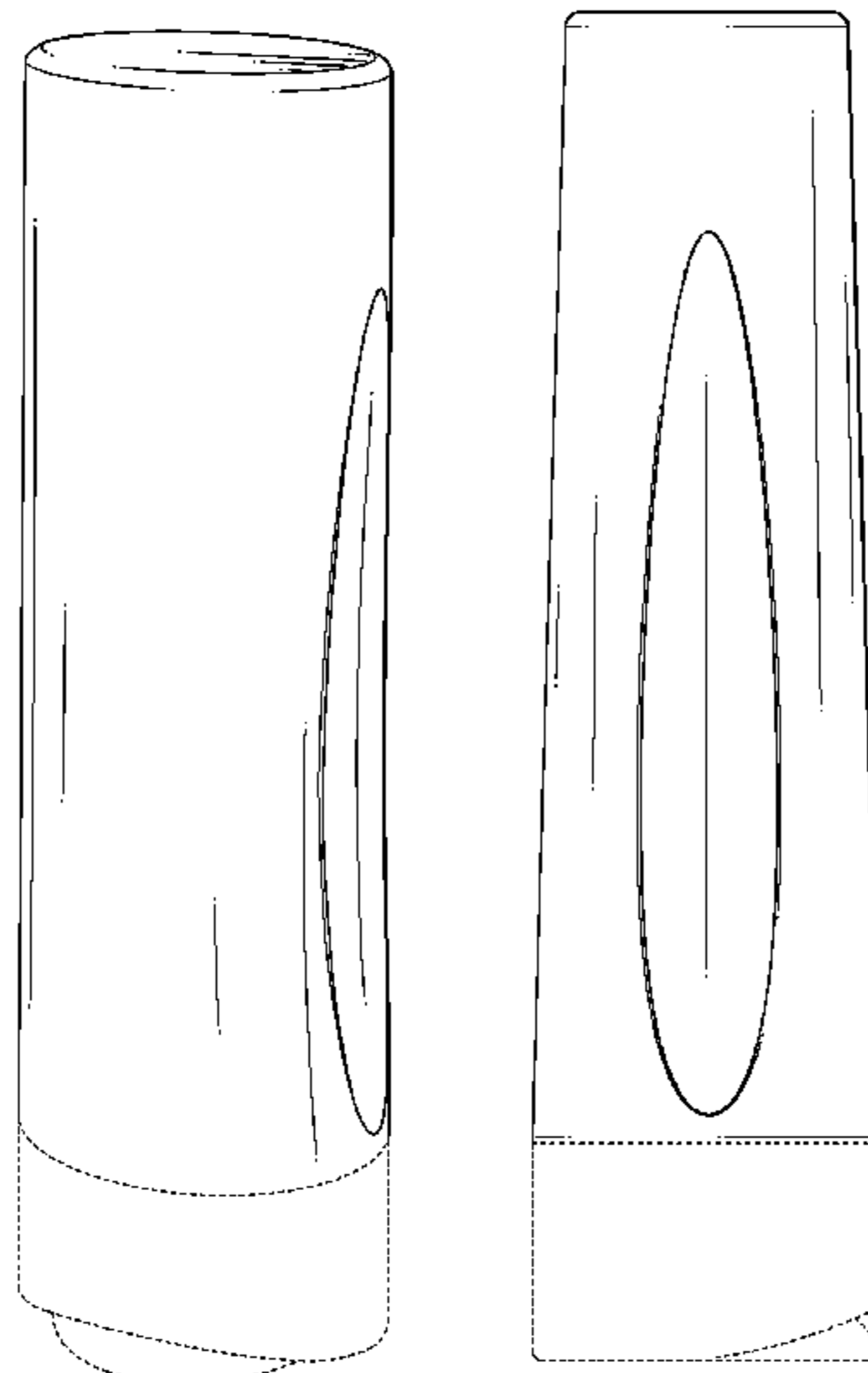
The ornamental design for a container for hair care composition, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container for hair care composition showing our new design; FIG. 2 is a front side view of the container for hair care composition as shown in FIG. 1; FIG. 3 is a left side view of the container for hair care composition as shown in FIG. 1; FIG. 4 is a back side view of the container for hair care composition as shown in FIG. 1; FIG. 5 is a right side view of the container for hair care composition as shown in FIG. 1; FIG. 6 is a top view of the container for hair care composition as shown in FIG. 1; and, FIG. 7 is a bottom view of the container for hair care composition as shown in FIG. 1.

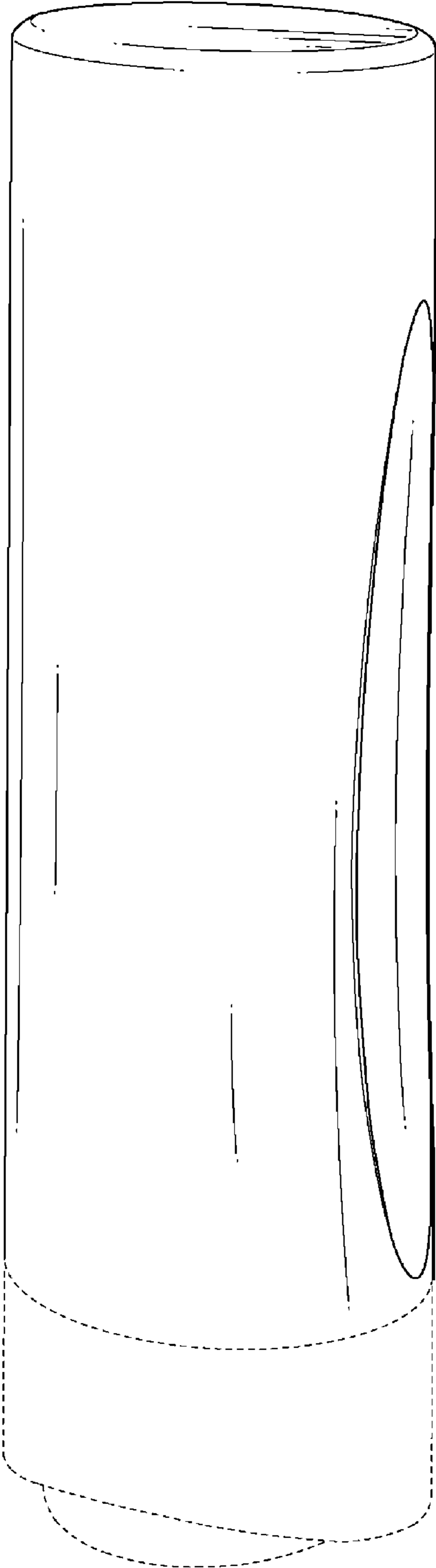

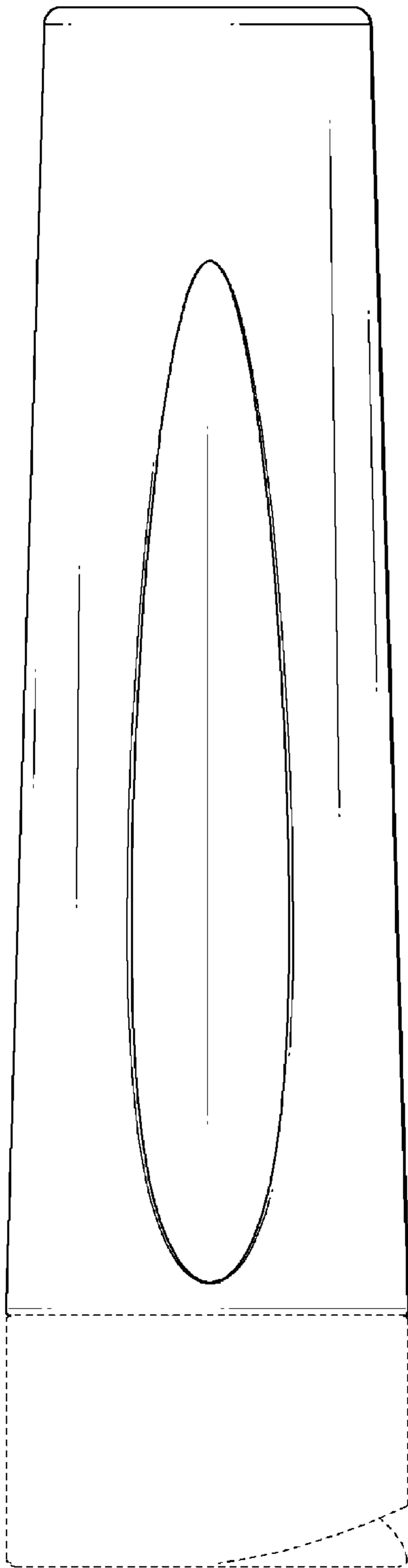

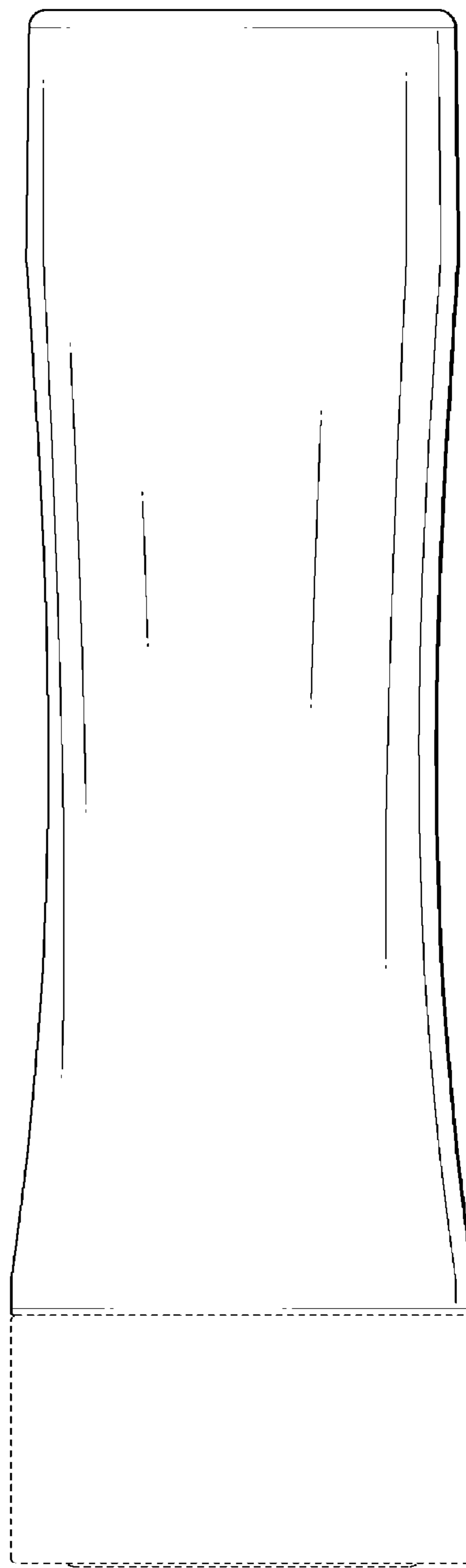

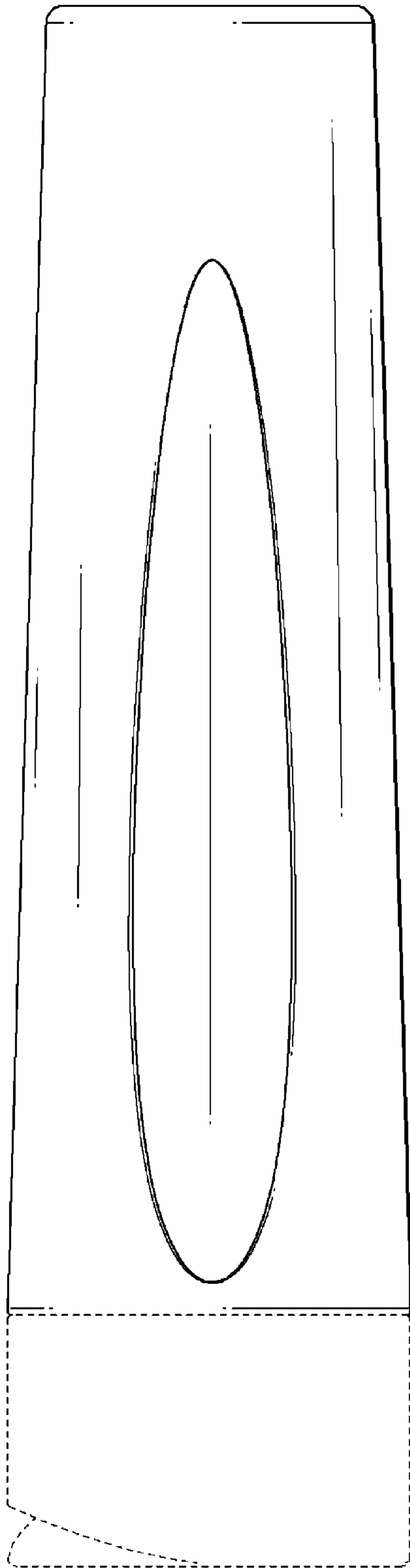

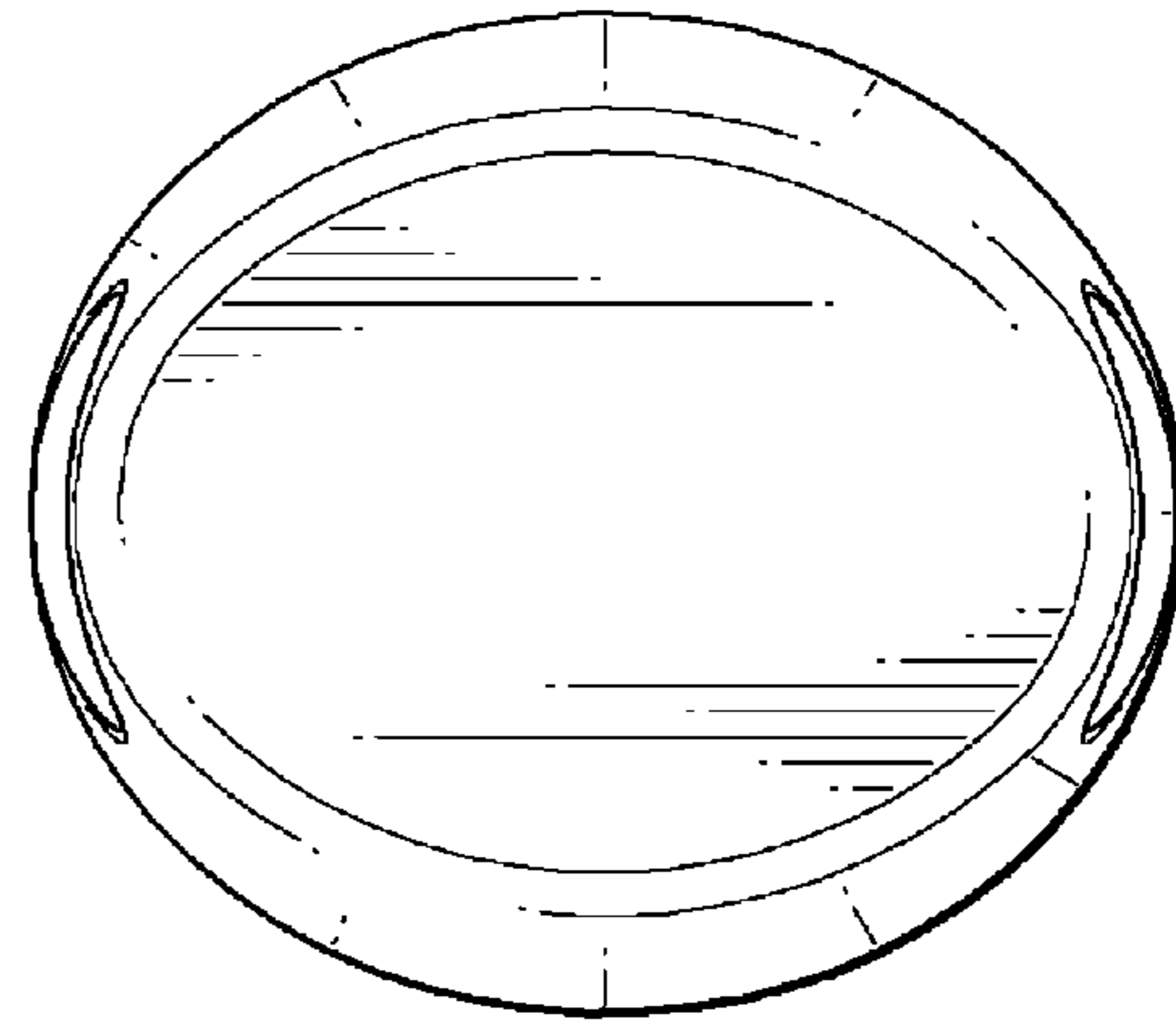

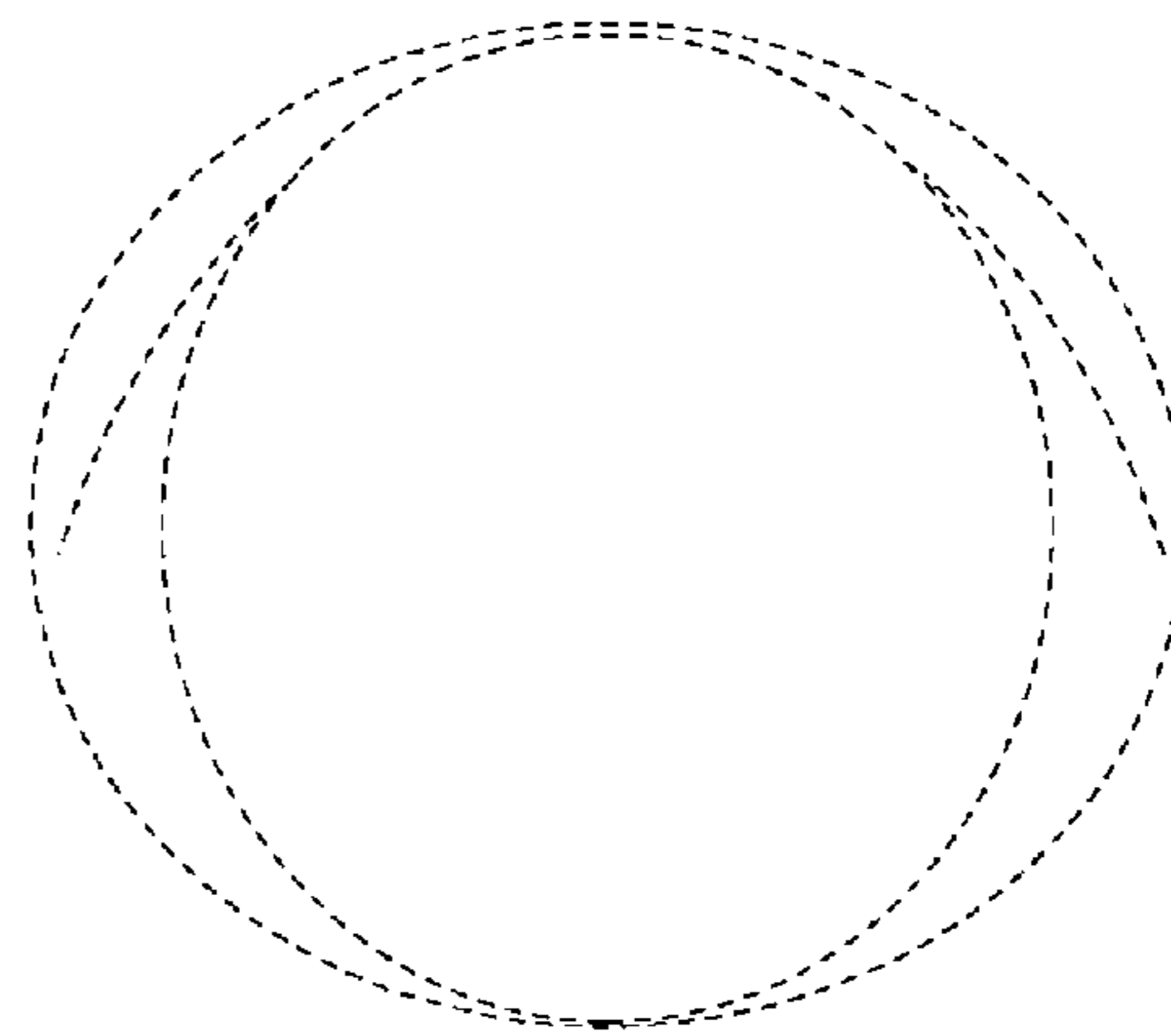
