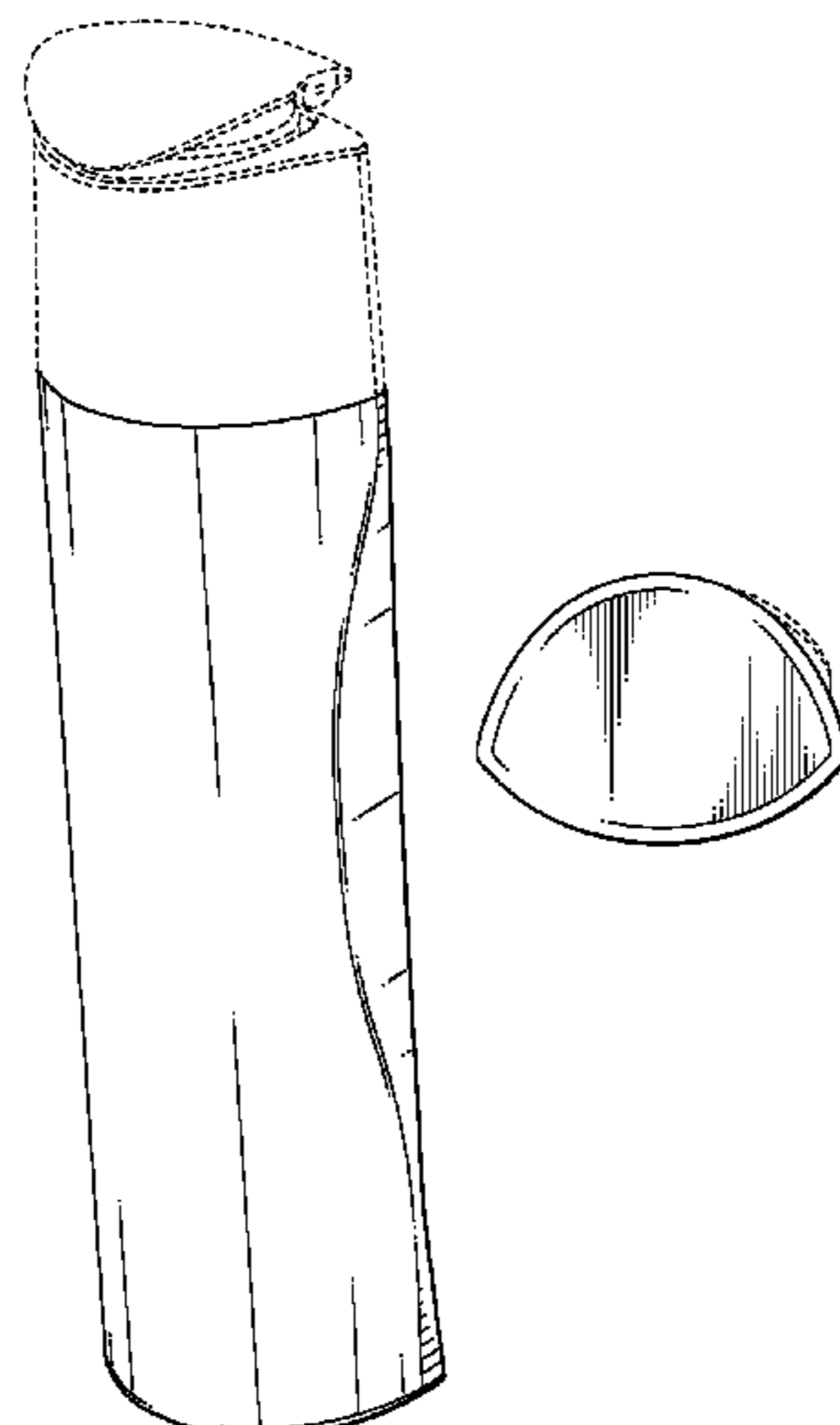
(57) **CLAIM**

The ornamental design for a container for hair care composition, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for hair care composition showing our new design; FIG. 2 is a front side view of the container for hair care composition as shown in FIG. 1; FIG. 3 is a right side view of the container for hair care composition as shown in FIG. 1; FIG. 4 is a back side view of the container for hair care composition as shown in FIG. 1; FIG. 5 is a left side view of the container for hair care composition as shown in FIG. 1; FIG. 6 is a top view of the container for hair care composition as shown in FIG. 1; FIG. 7 is a bottom view of the container for hair care composition as shown in FIG. 1; FIG. 8 is a perspective view of the container for hair care composition of FIG. 1, shown with an alternate unclaimed closure; FIG. 9 is a front side view of the container for hair care composition as shown in FIG. 8; FIG. 10 is a right side view of the container for hair care composition as shown in FIG. 8; FIG. 11 is a back side view of the container for hair care composition as shown in FIG. 8; FIG. 12 is a left side view of the container for hair care composition as shown in FIG. 8; FIG. 13 is a top view of the container for hair care composition as shown in FIG. 8; and, FIG. 14 is a bottom view of the container for hair care composition as shown in FIG. 8. The broken lines showing a closure in FIGS. 1-7 and showing an alternate closure in FIGS. 8-14, are included for the purpose of illustrating environmental structure that forms no part of the claimed design.

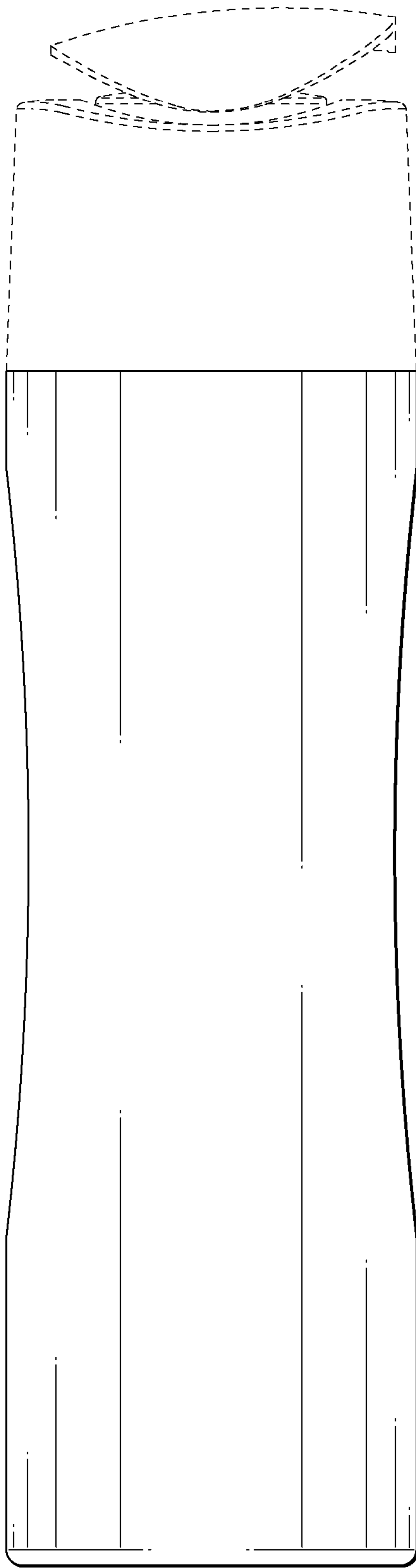

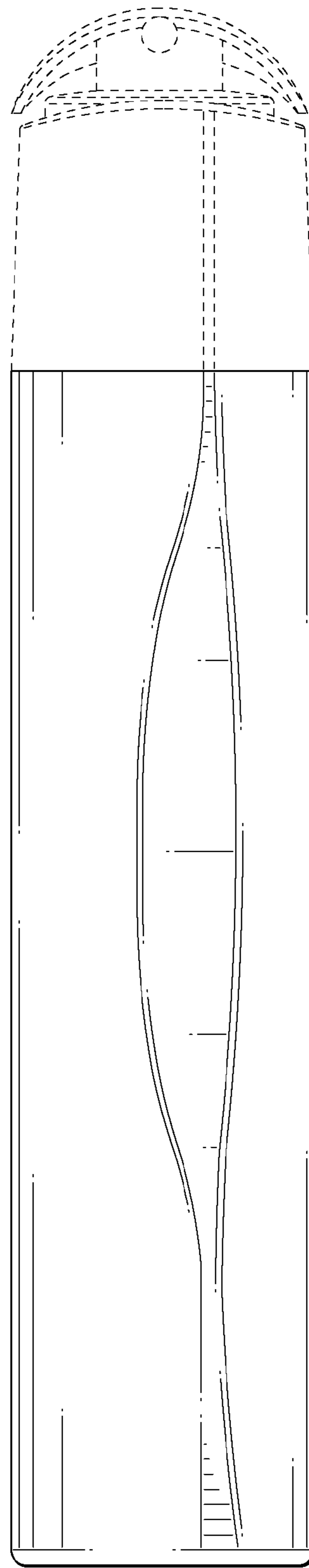

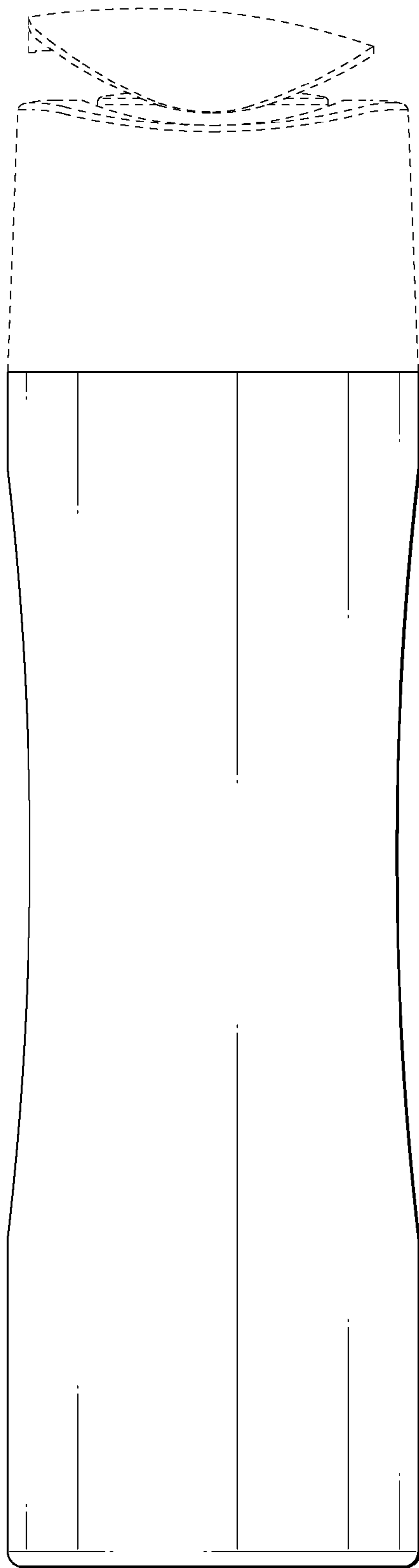

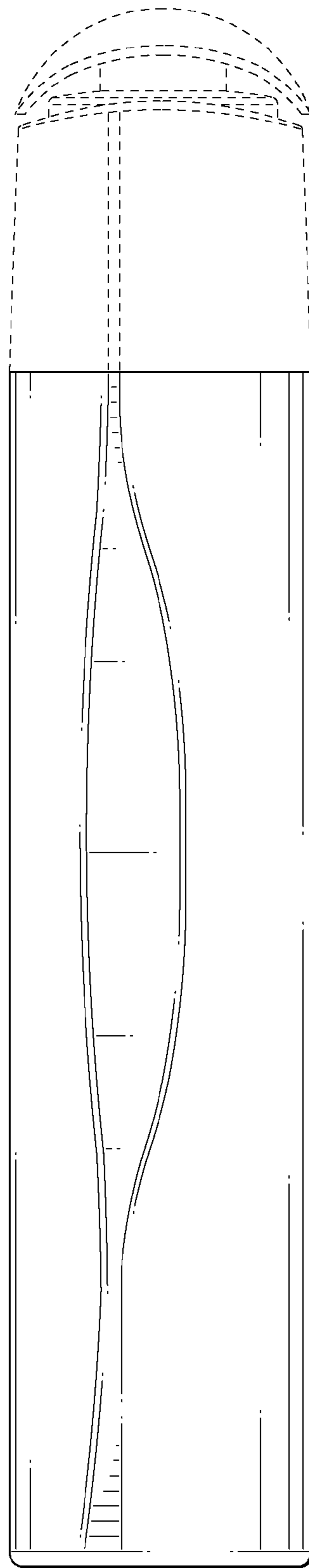

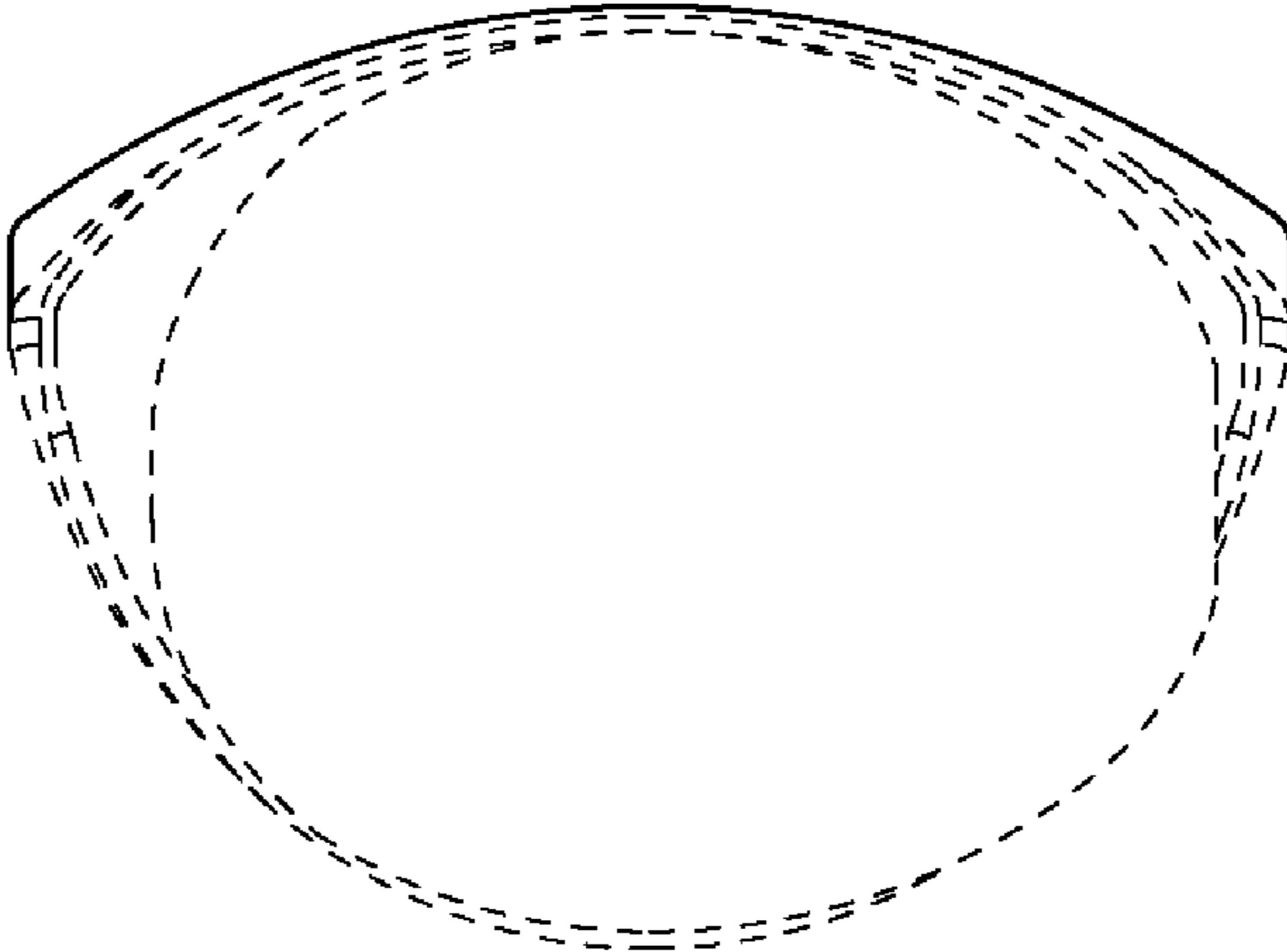

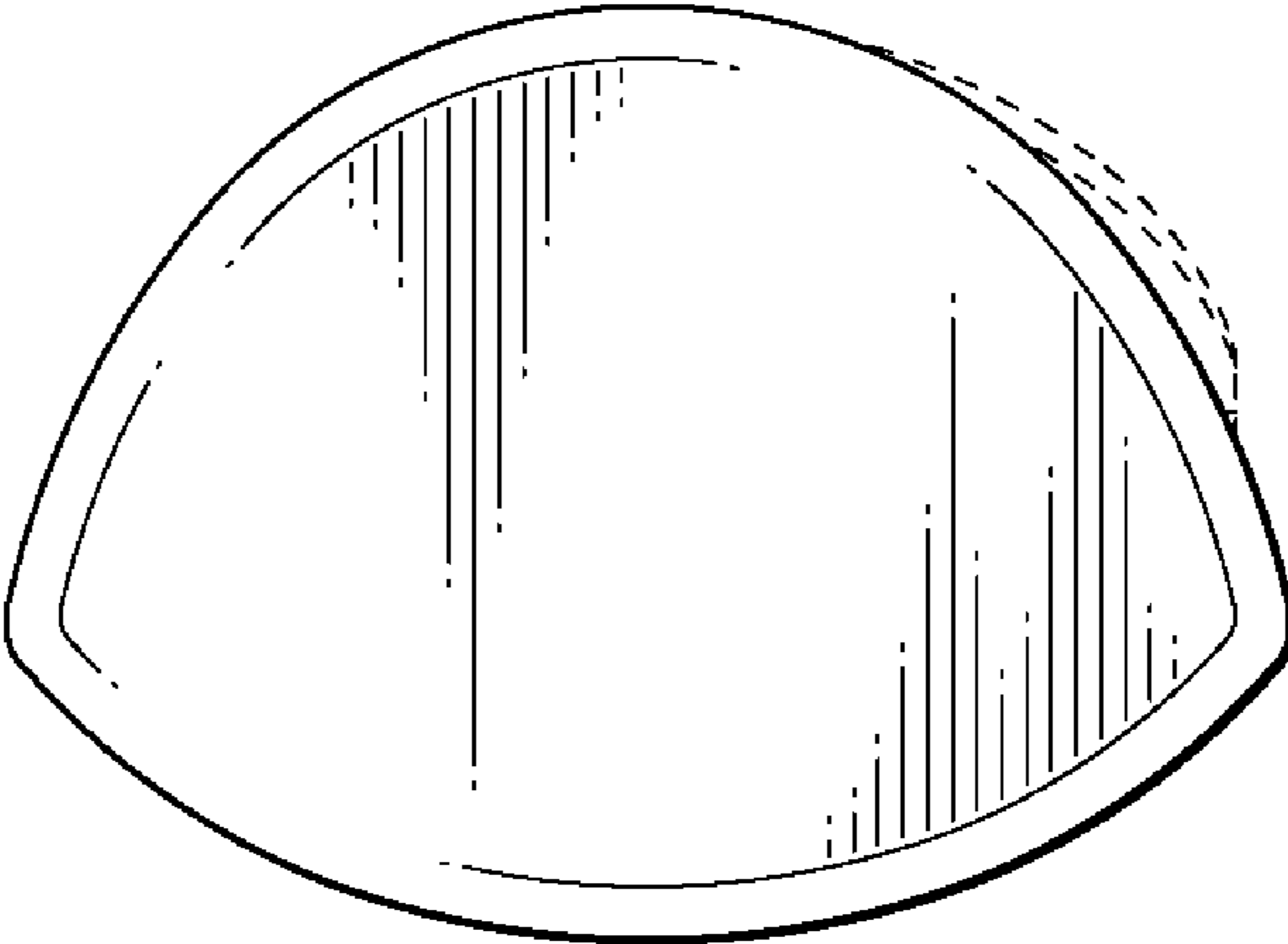

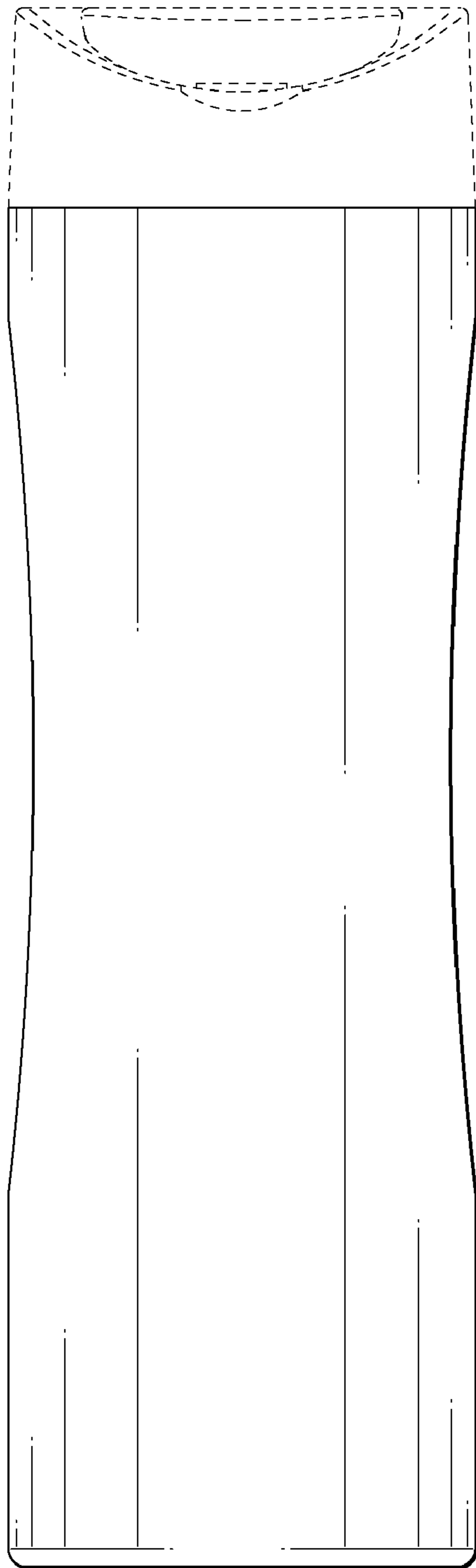

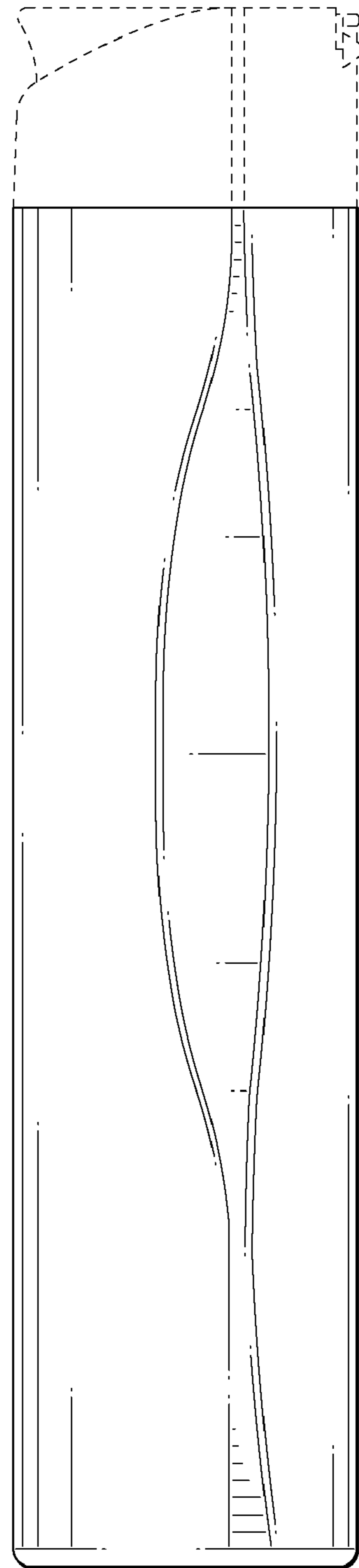

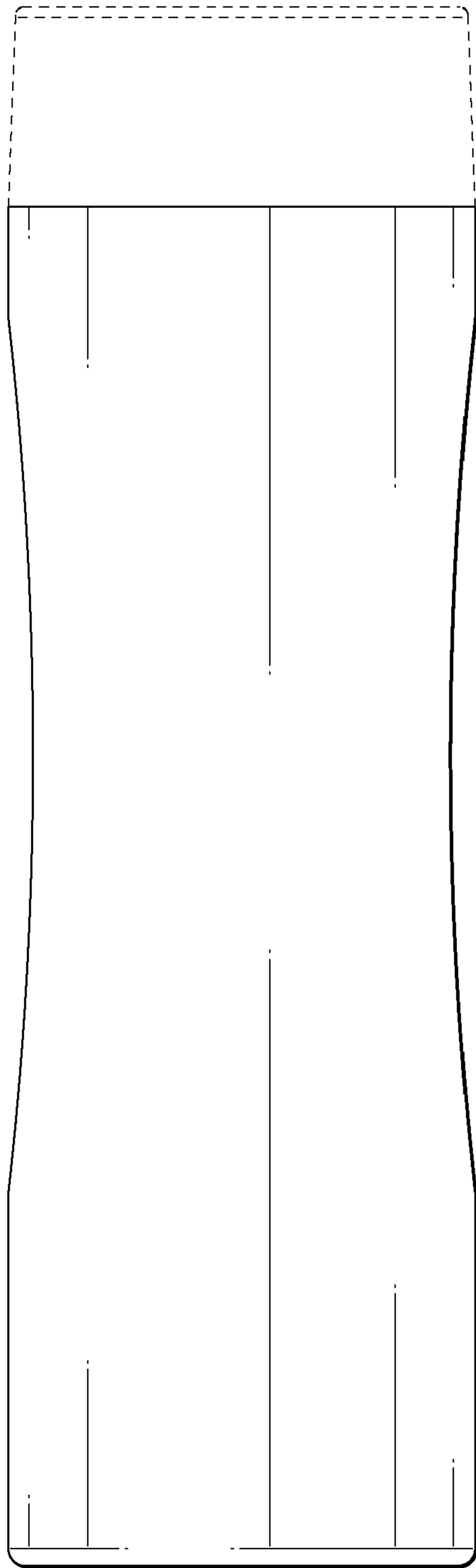

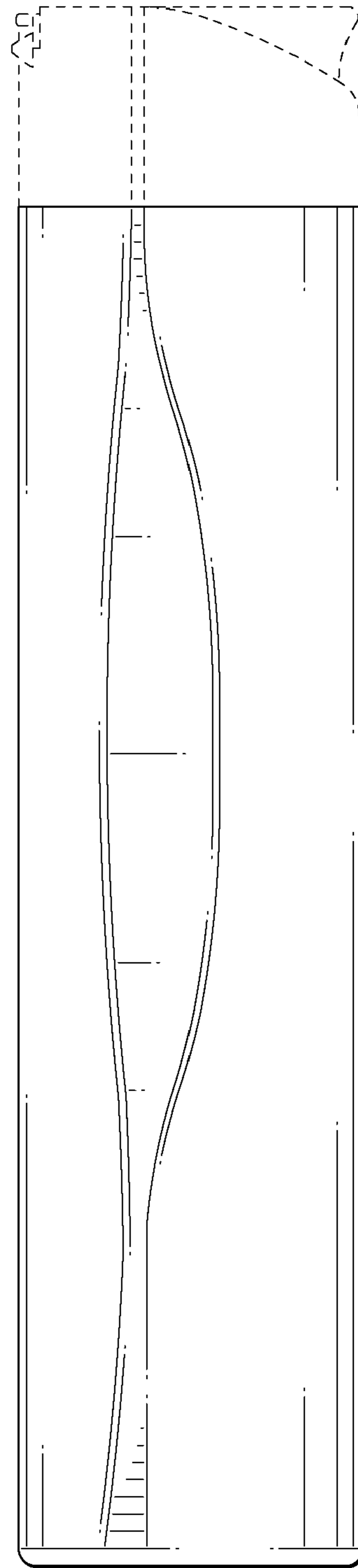

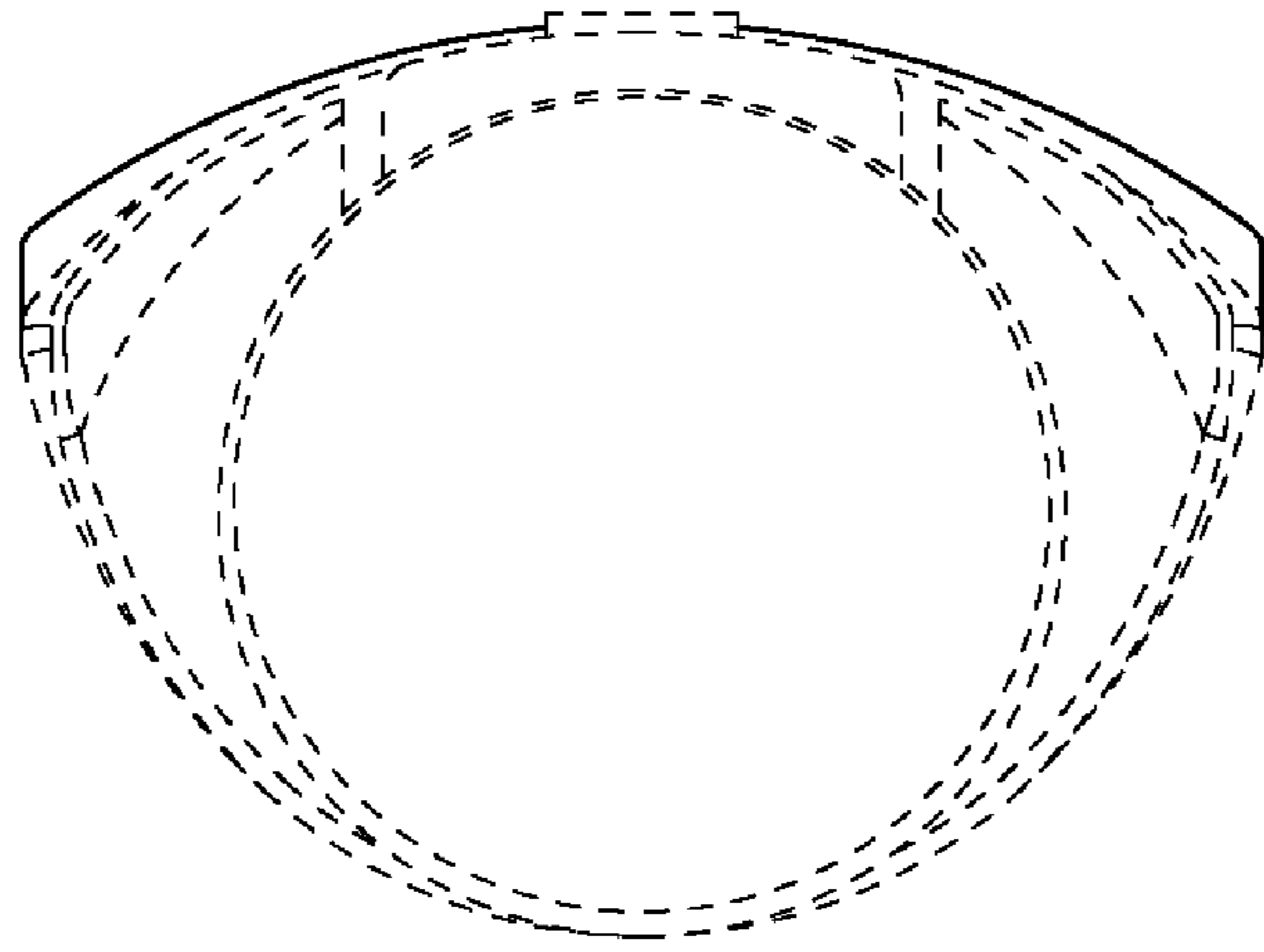

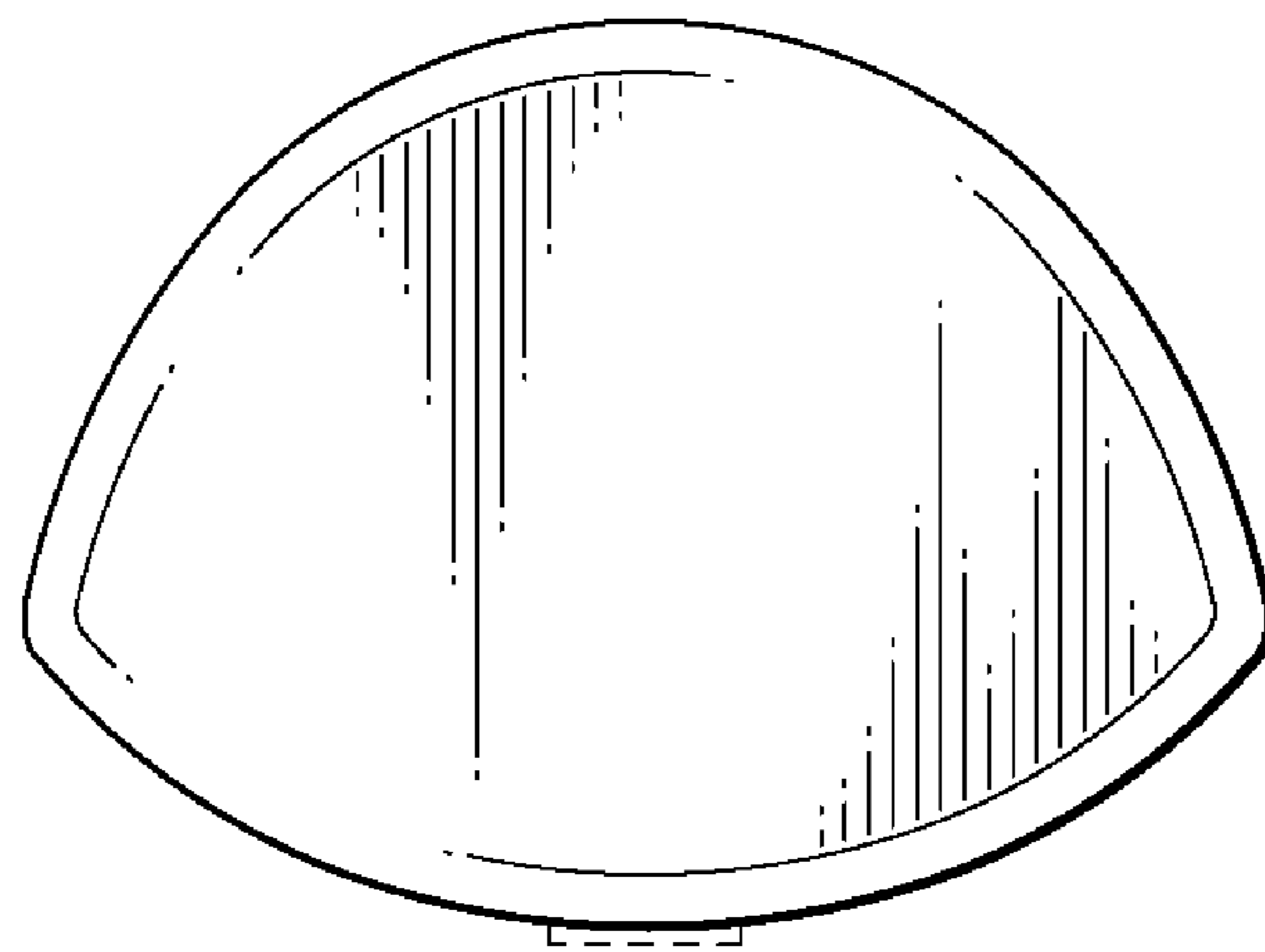
