**DESCRIPTION**

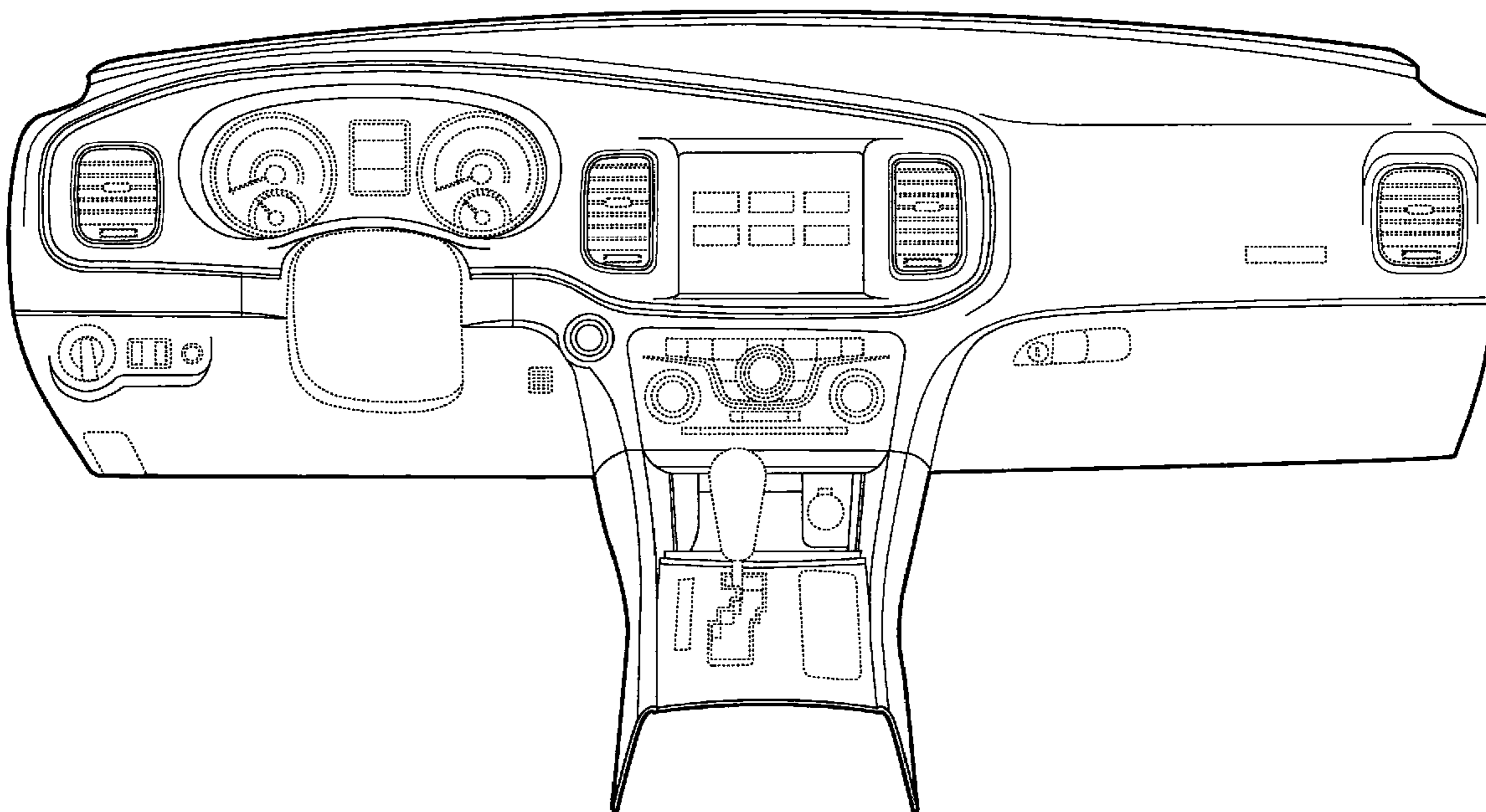
FIG. 1 is a right perspective view of an automobile interior showing our new design;

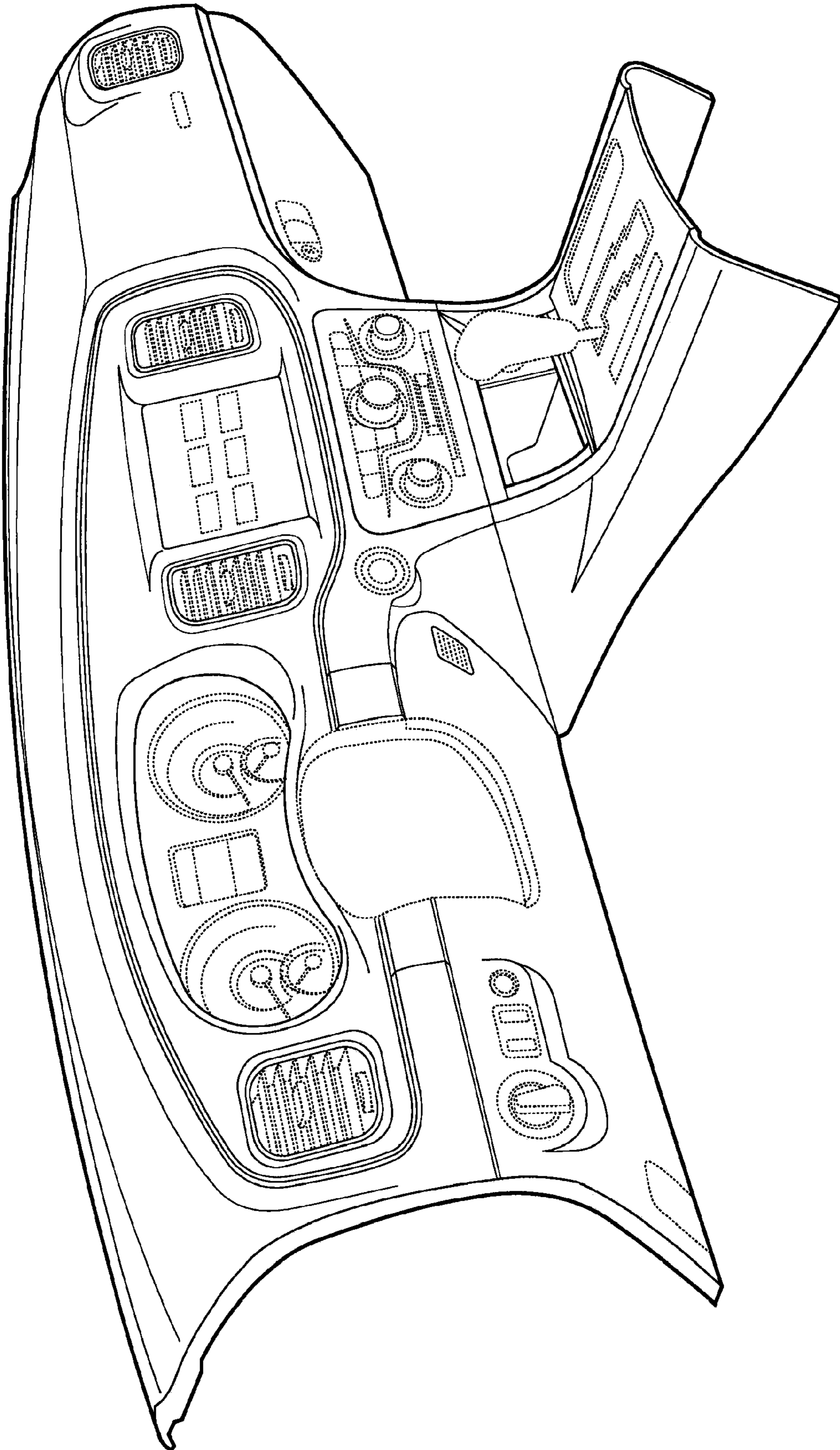

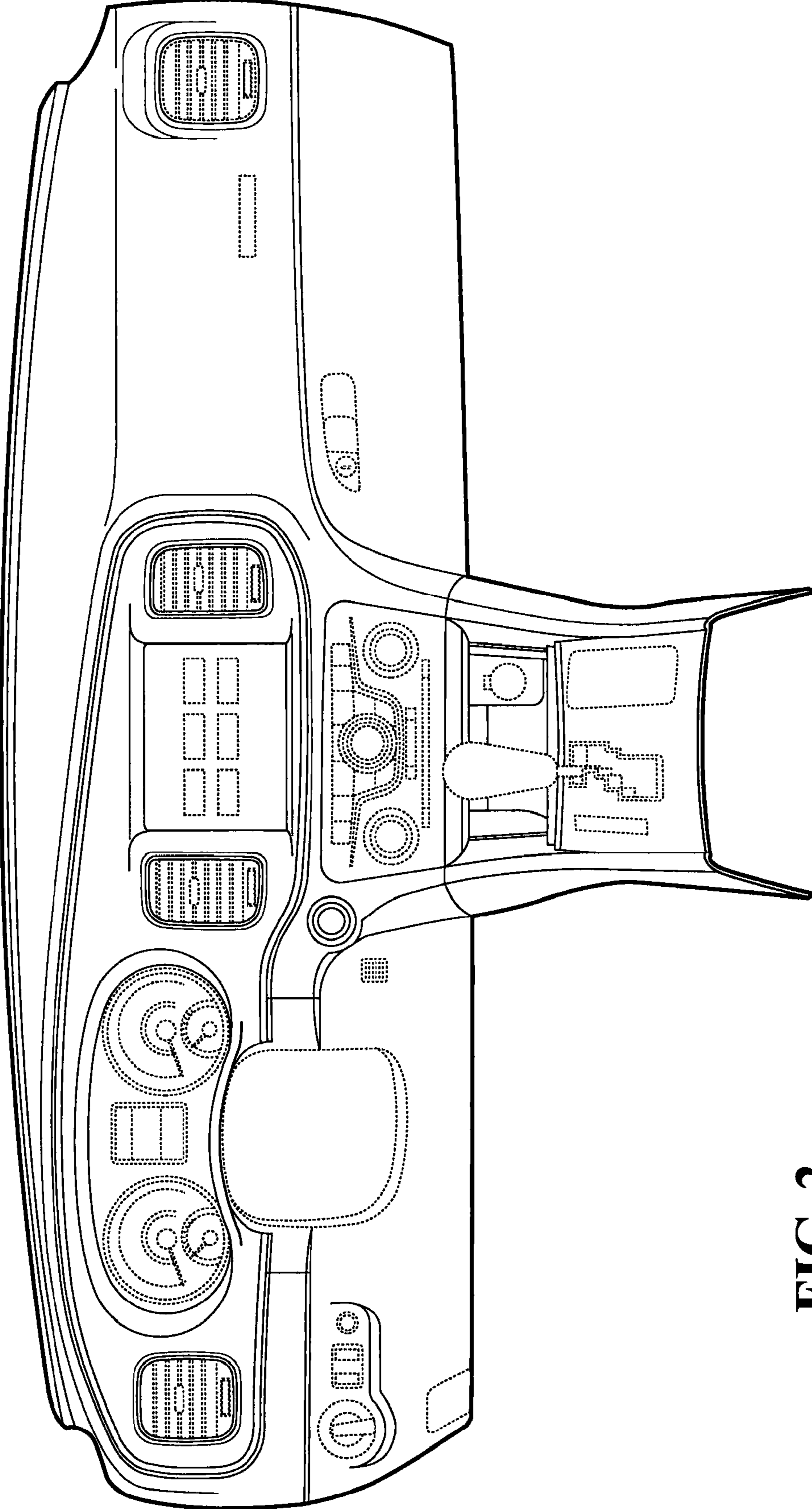

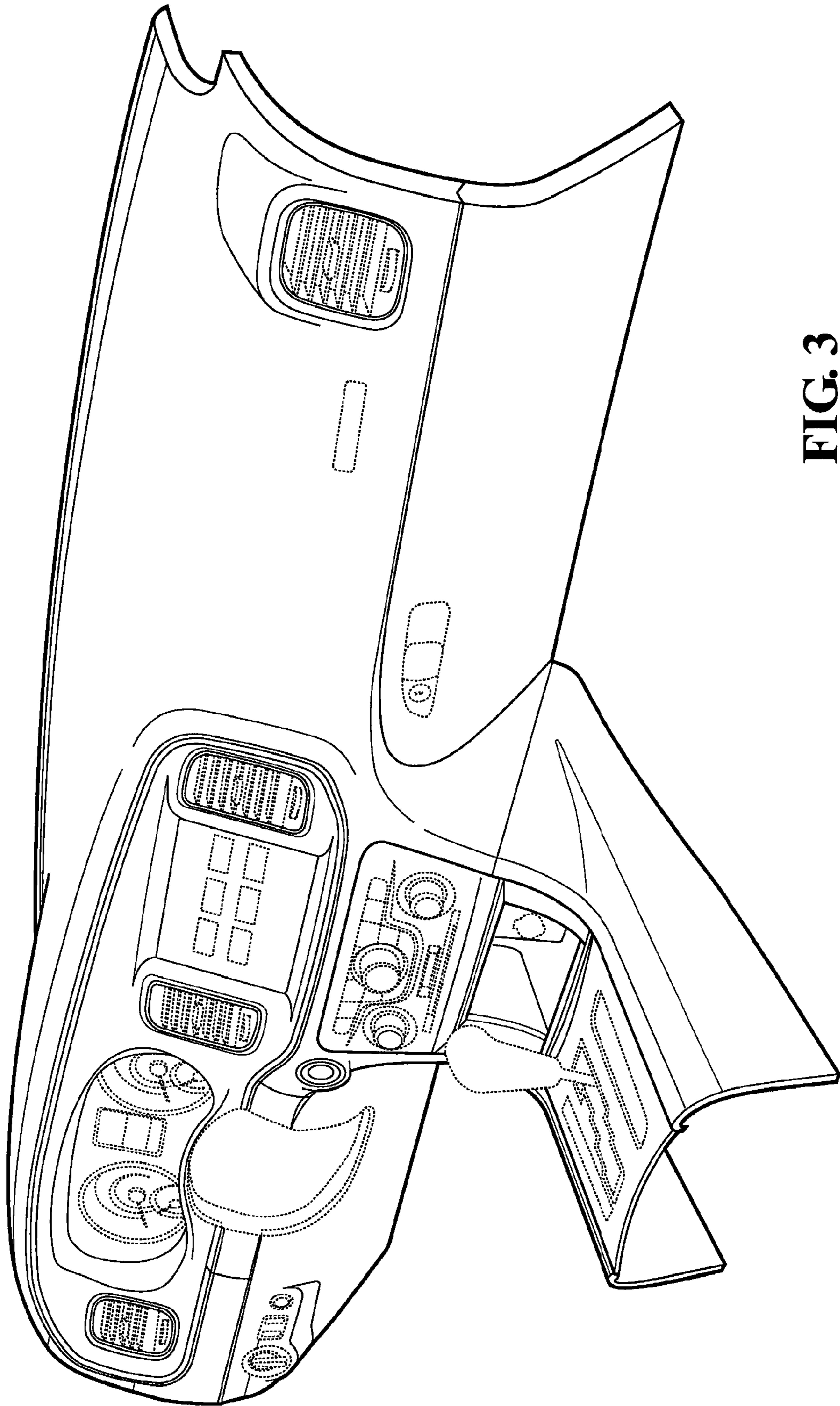
