(57) **CLAIM**

The ornamental design for a decorative pull apart greeting card, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the decorative pull apart greeting card in a closed position showing our new design; FIG. 2 is a front view of the decorative pull apart greeting card of FIG. 1.

FIG. 3 is a back view of the decorative pull apart greeting card of FIG. 1.

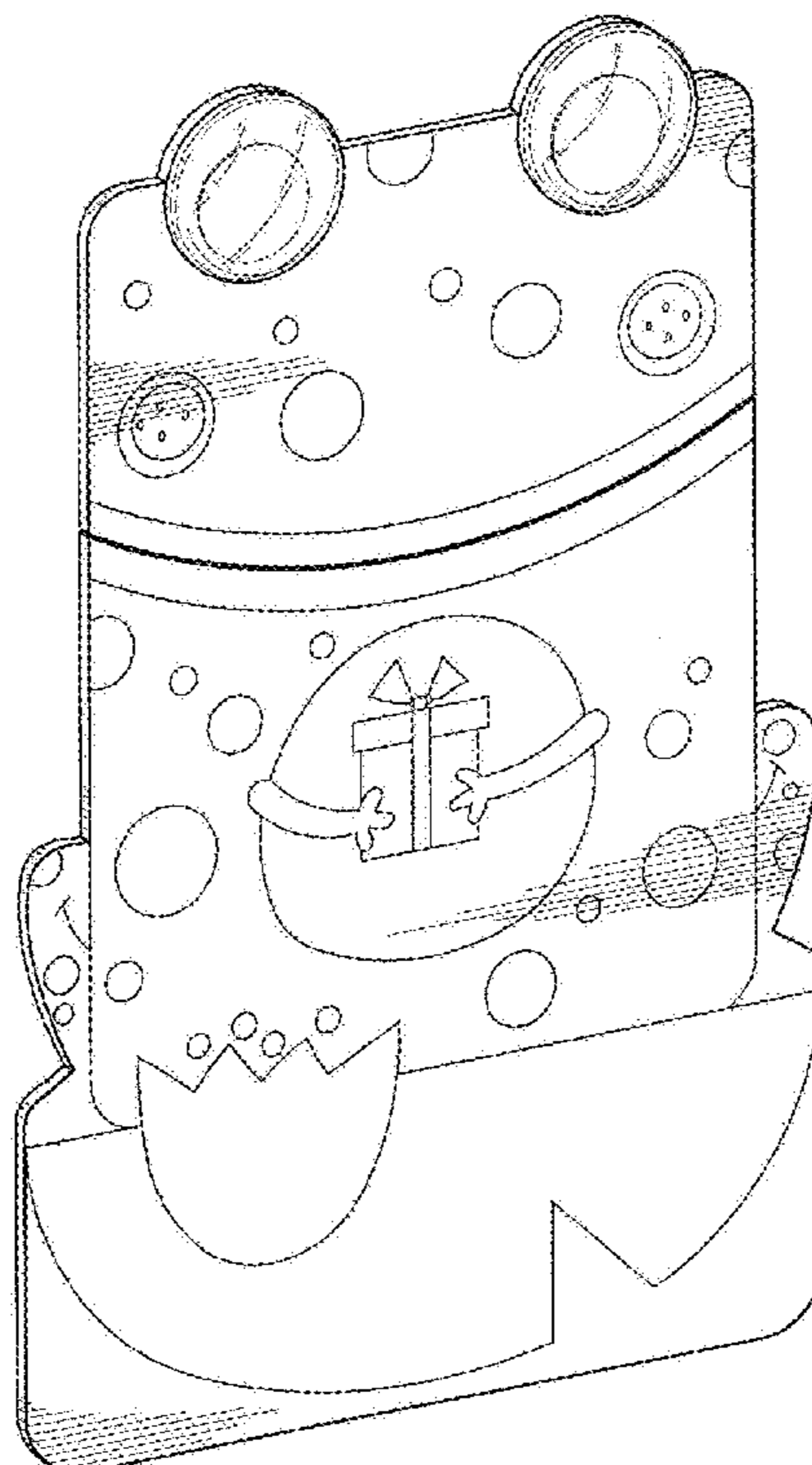
FIG. 4 is a side view of the decorative pull apart greeting card of FIG. 1, identical to the opposite side view thereof.

FIG. 5 is a top view of the decorative pull apart greeting card of FIG. 1.

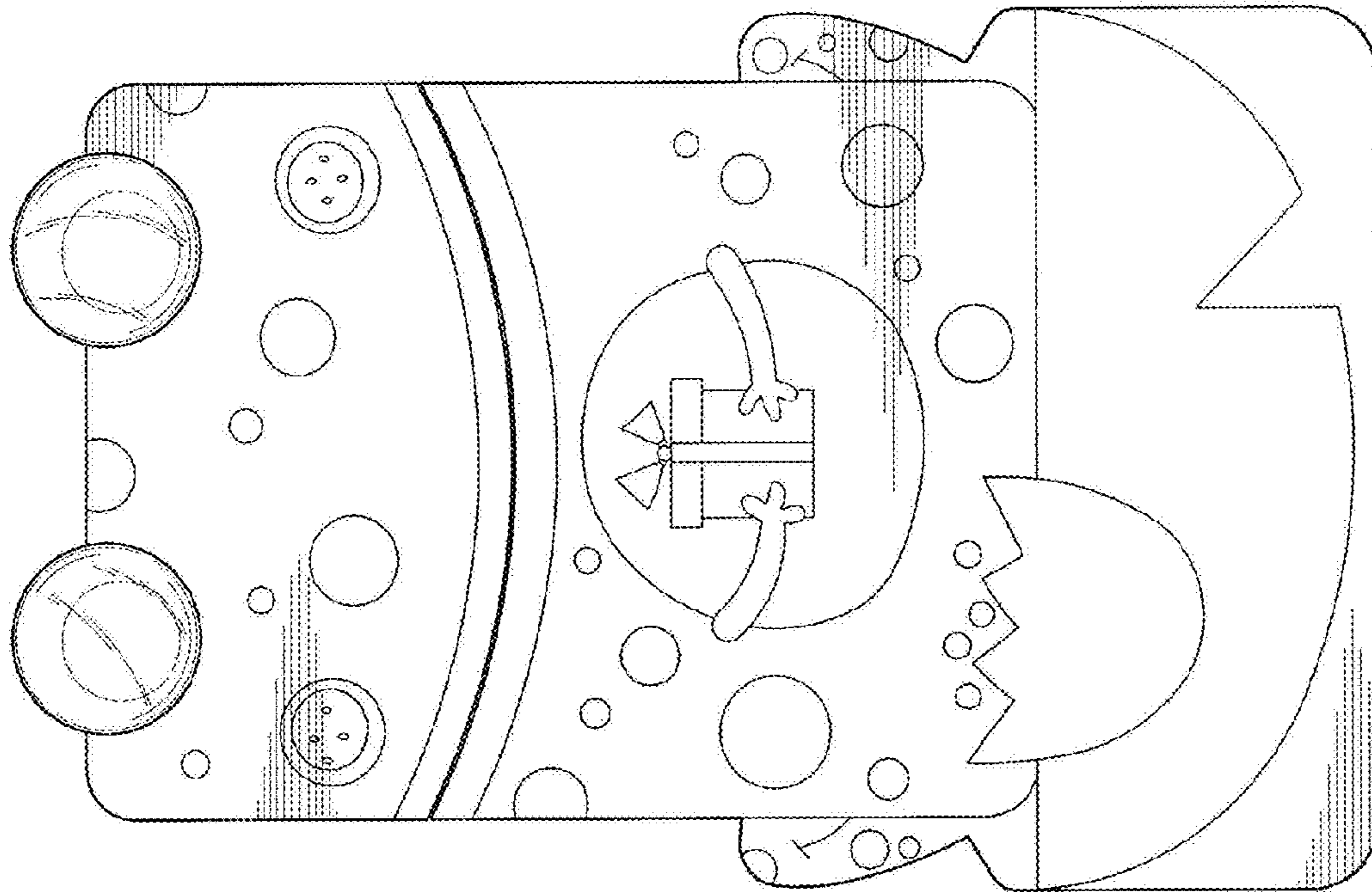

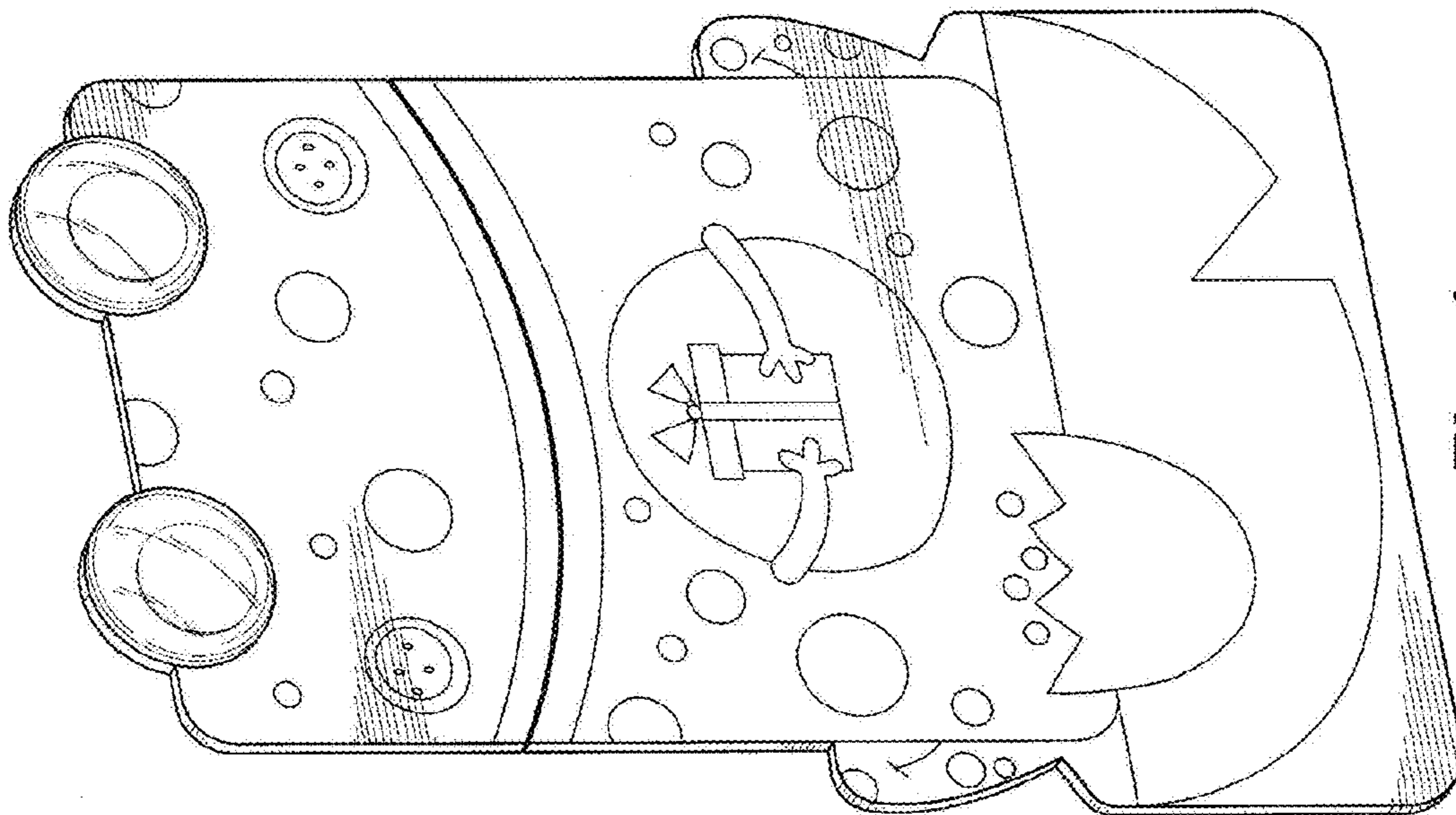

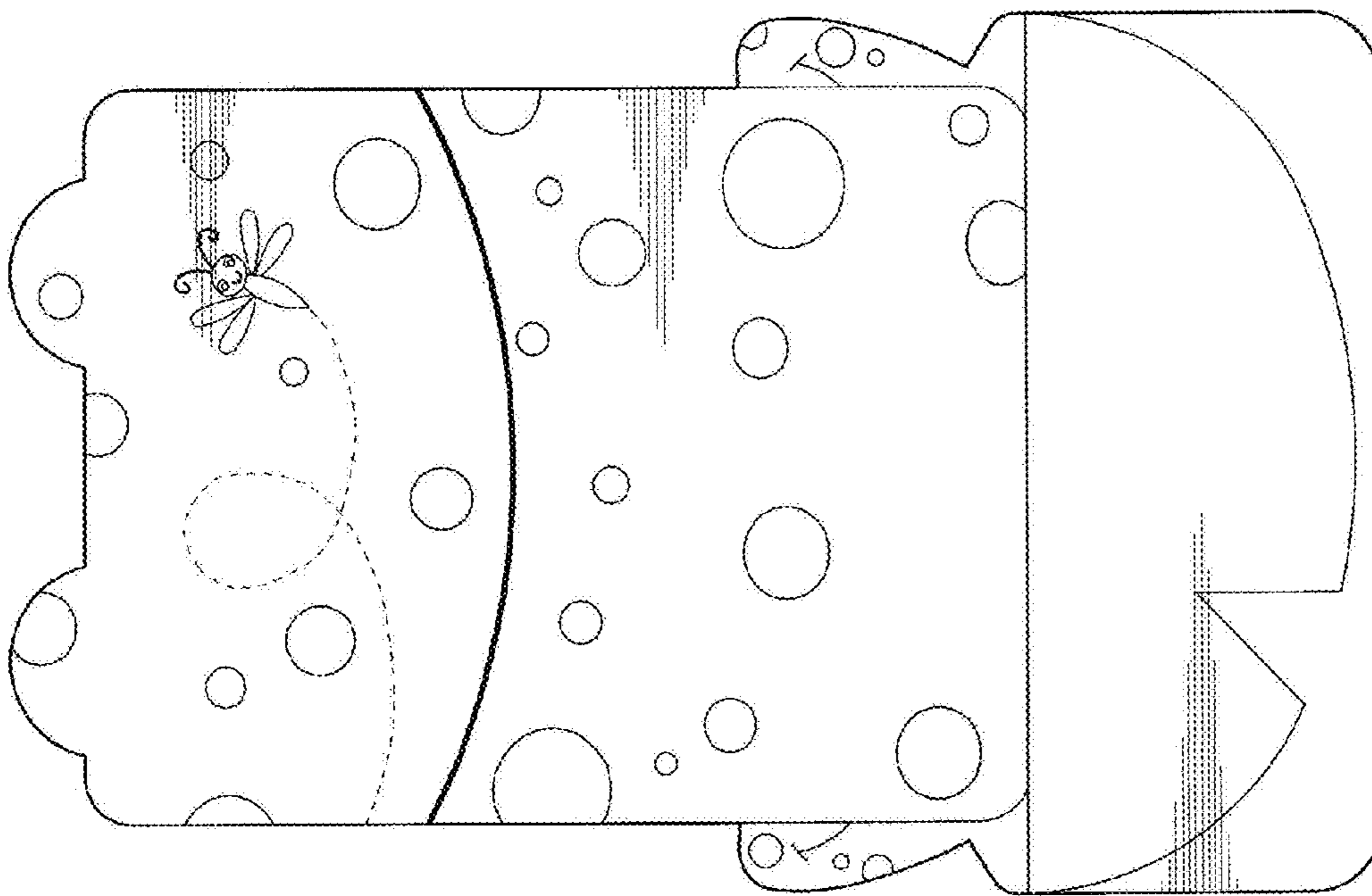

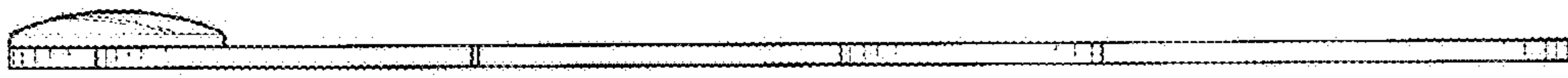

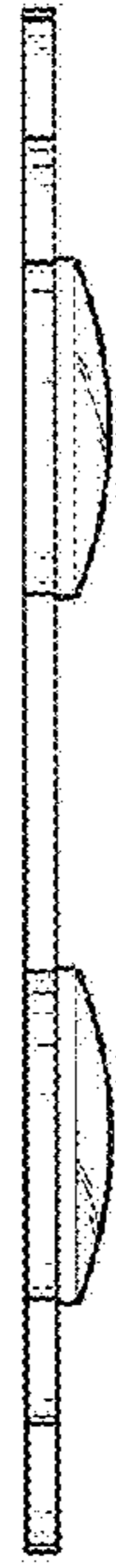

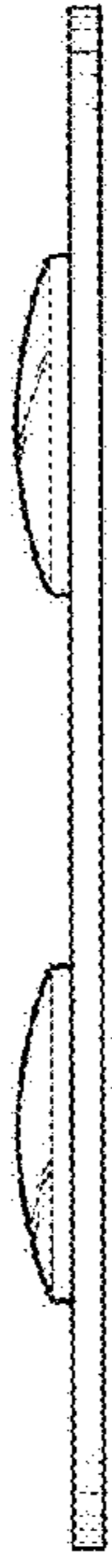

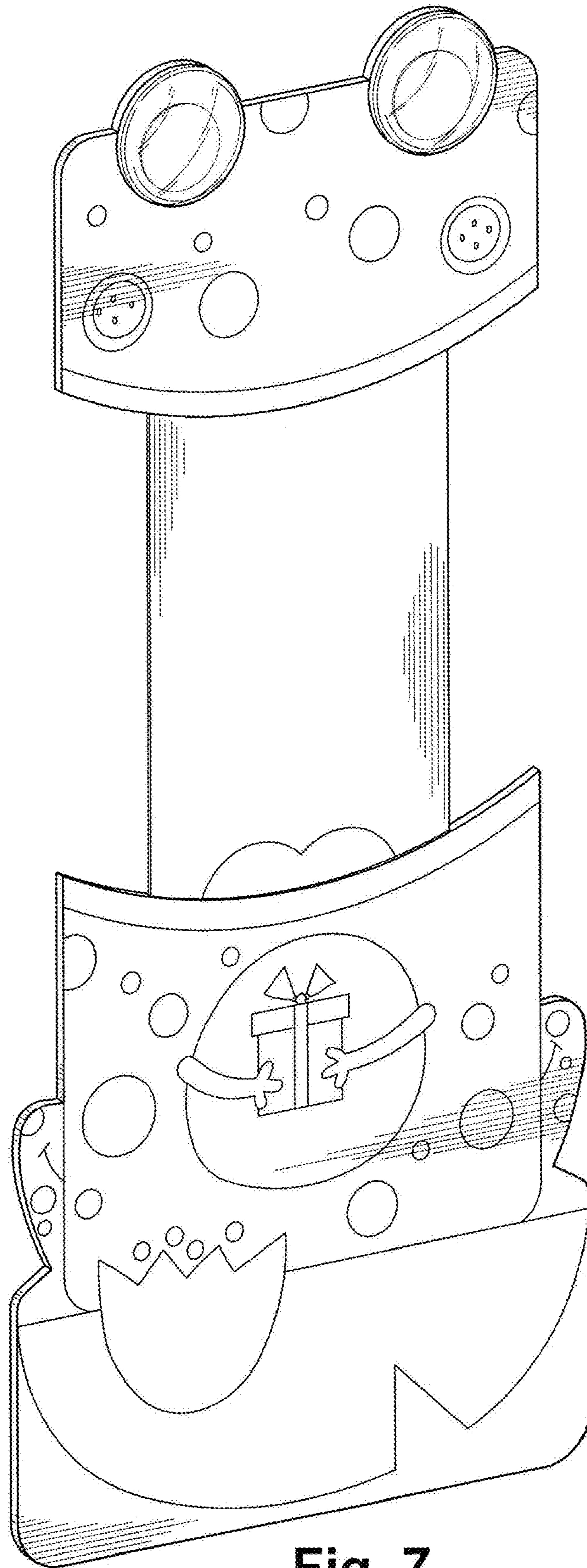
