FIG. 3 is back elevation view thereof;

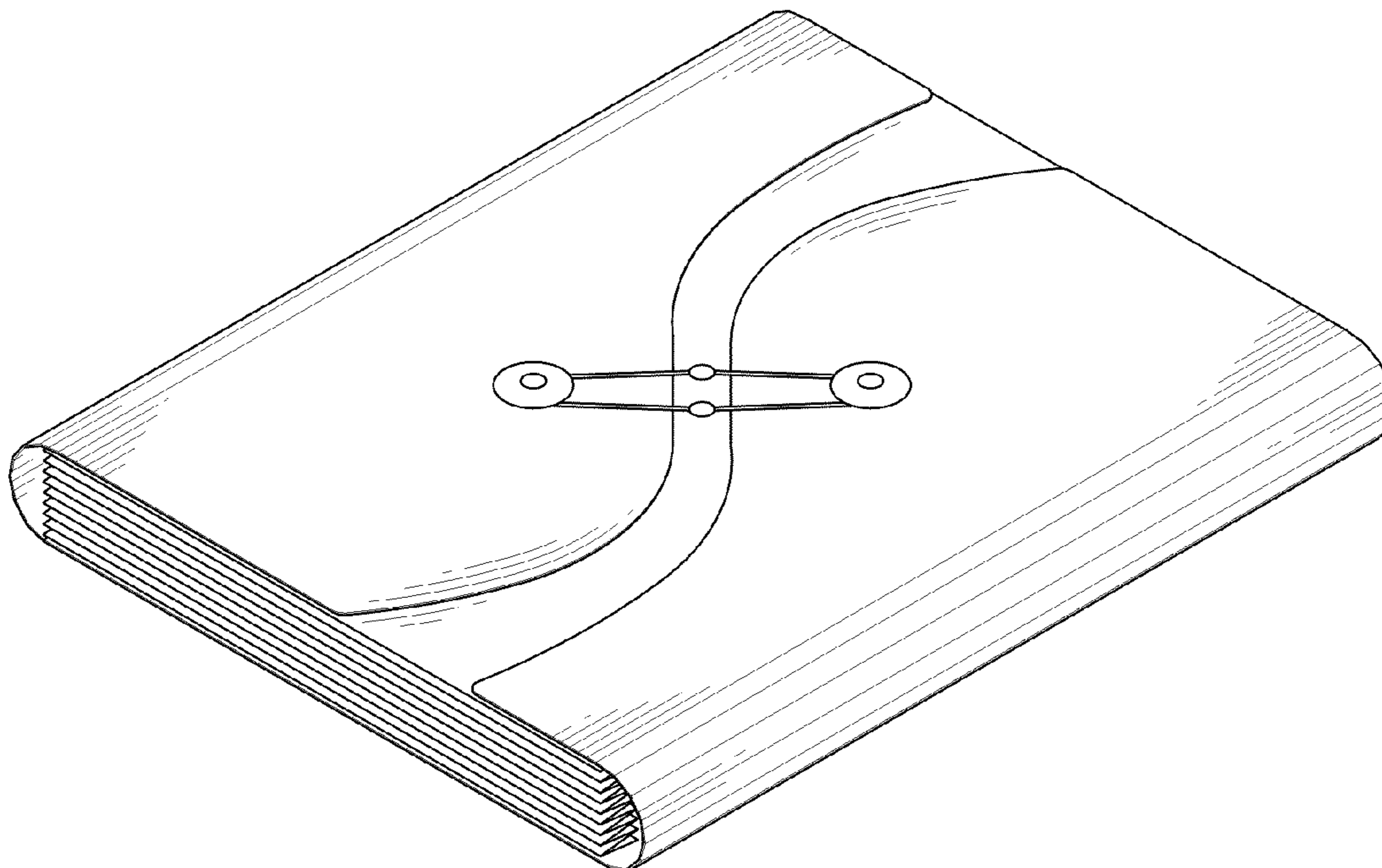
FIG. 4 is a side elevation view thereof;

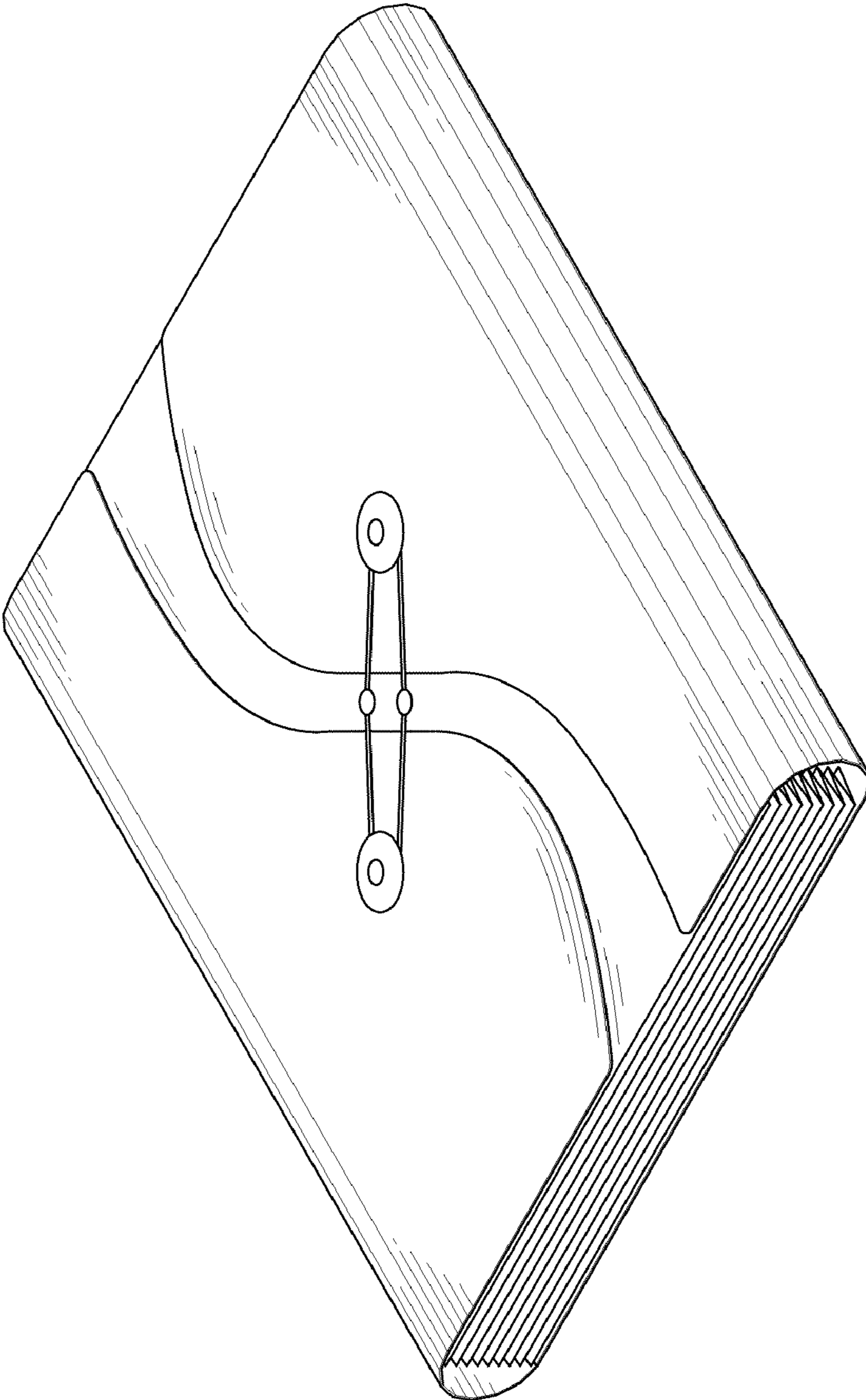

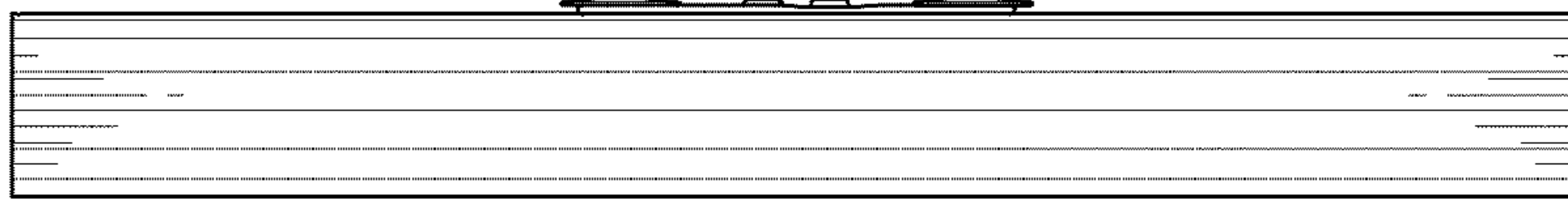

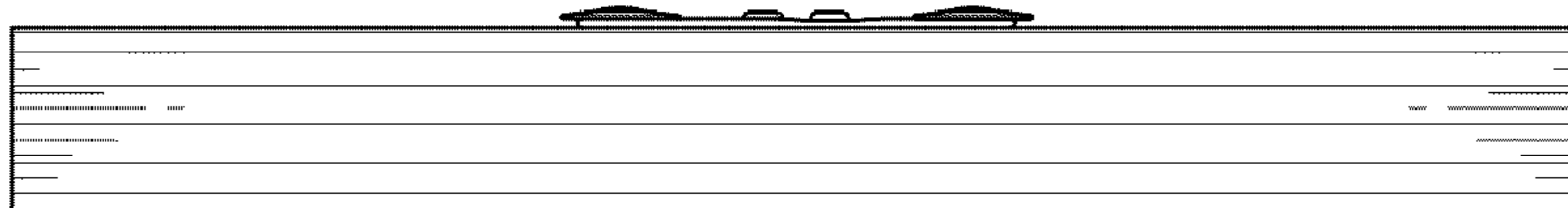

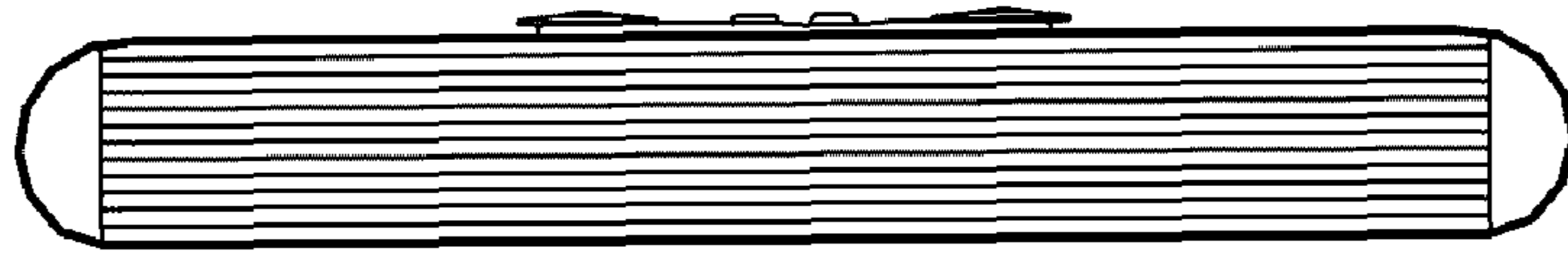

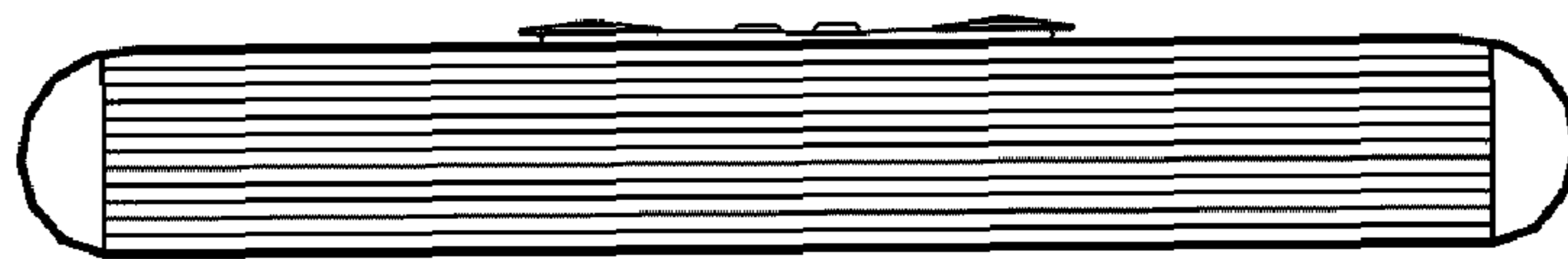

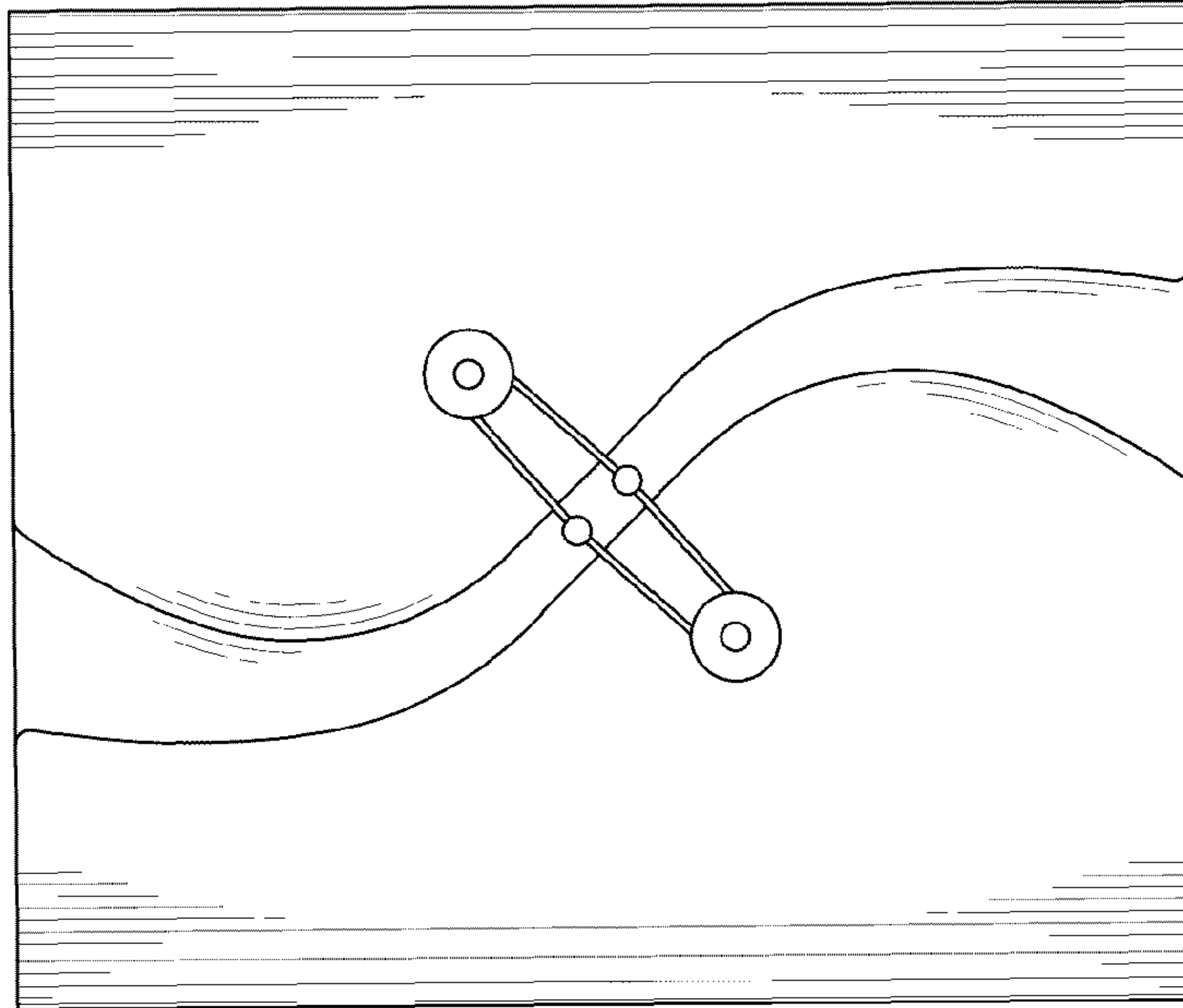

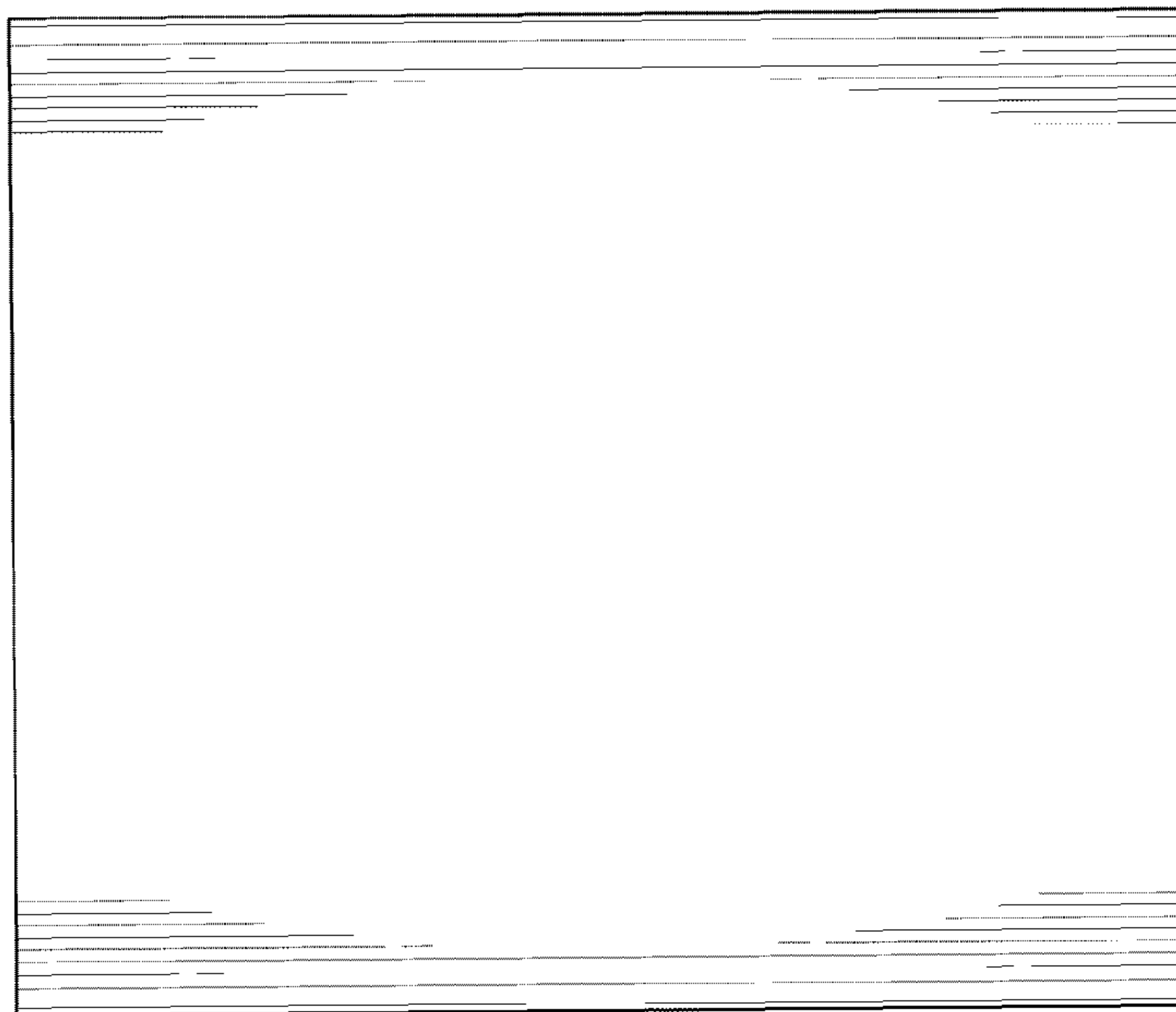
