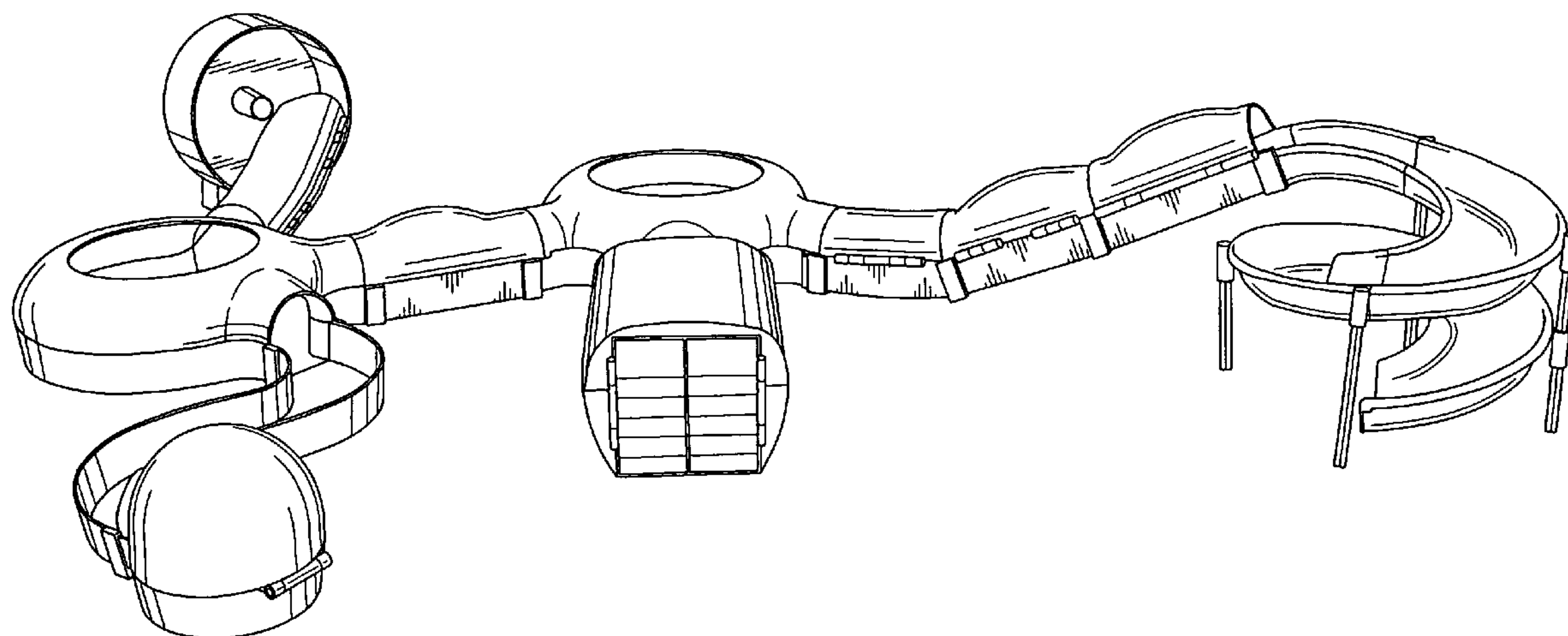
(57) **CLAIM**

The ornamental design for a toy play set, as shown and described.

DESCRIPTION

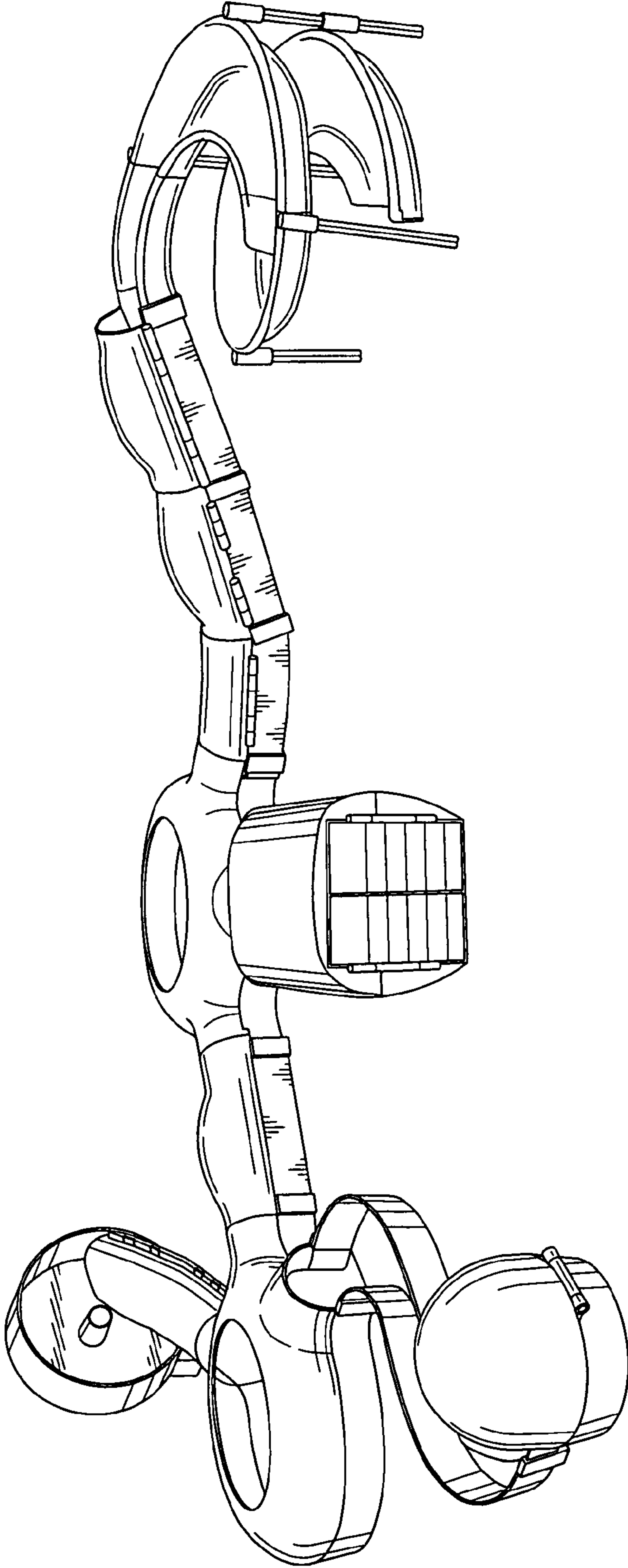

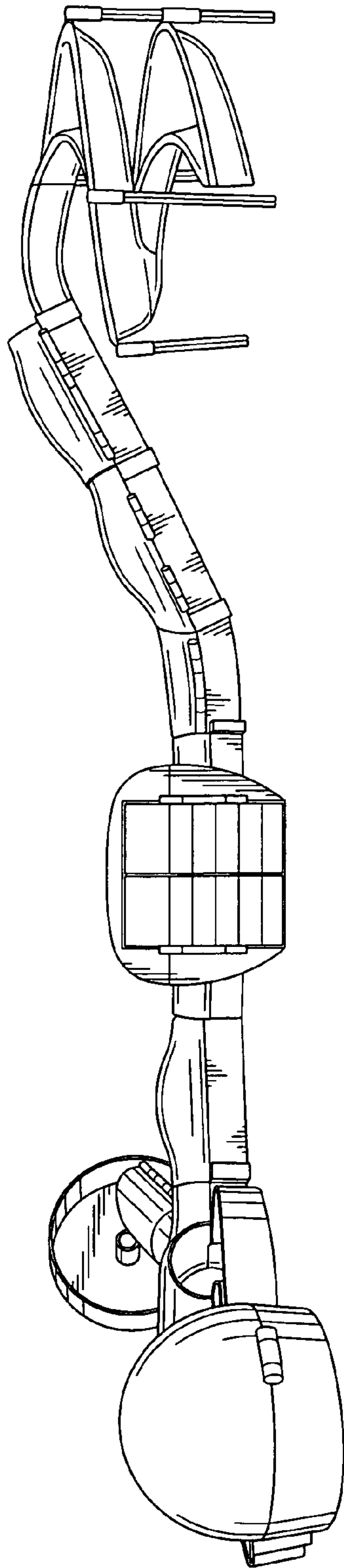

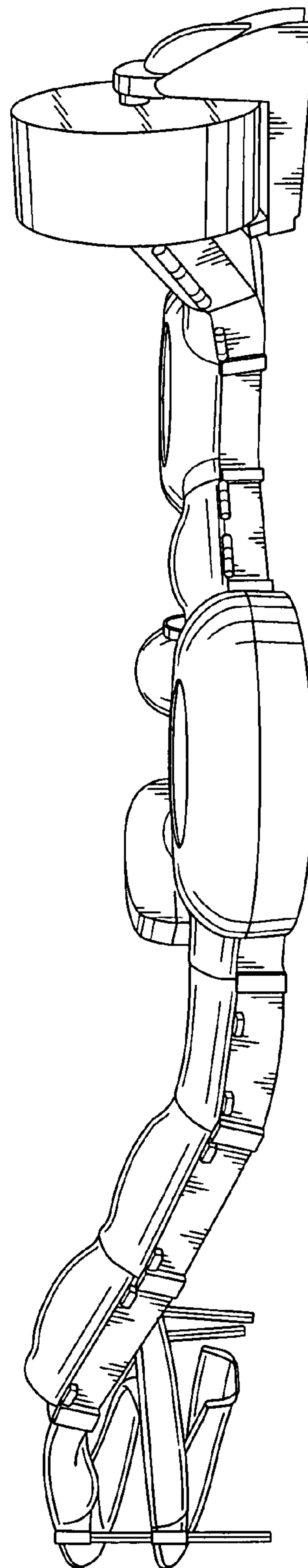

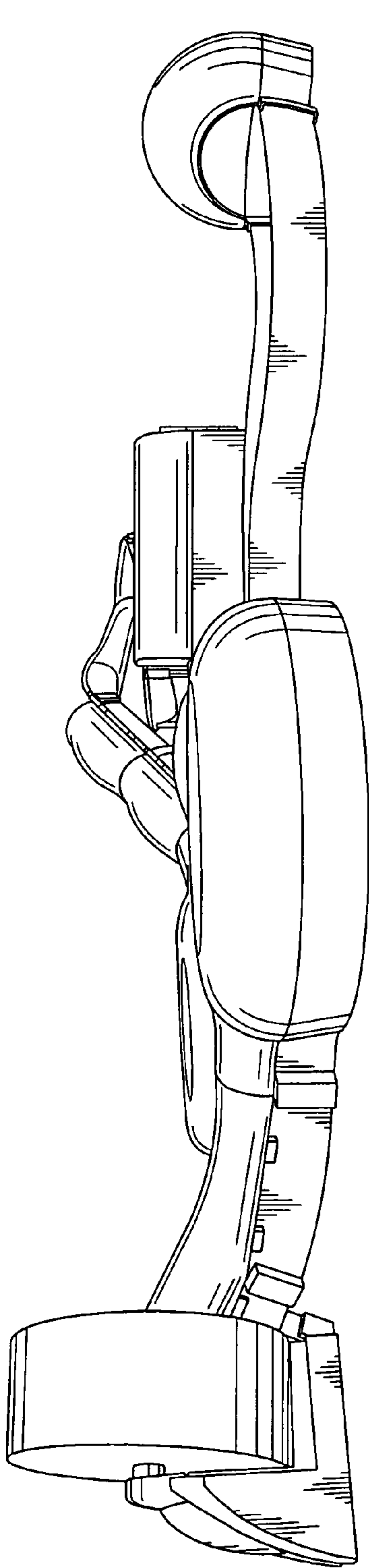

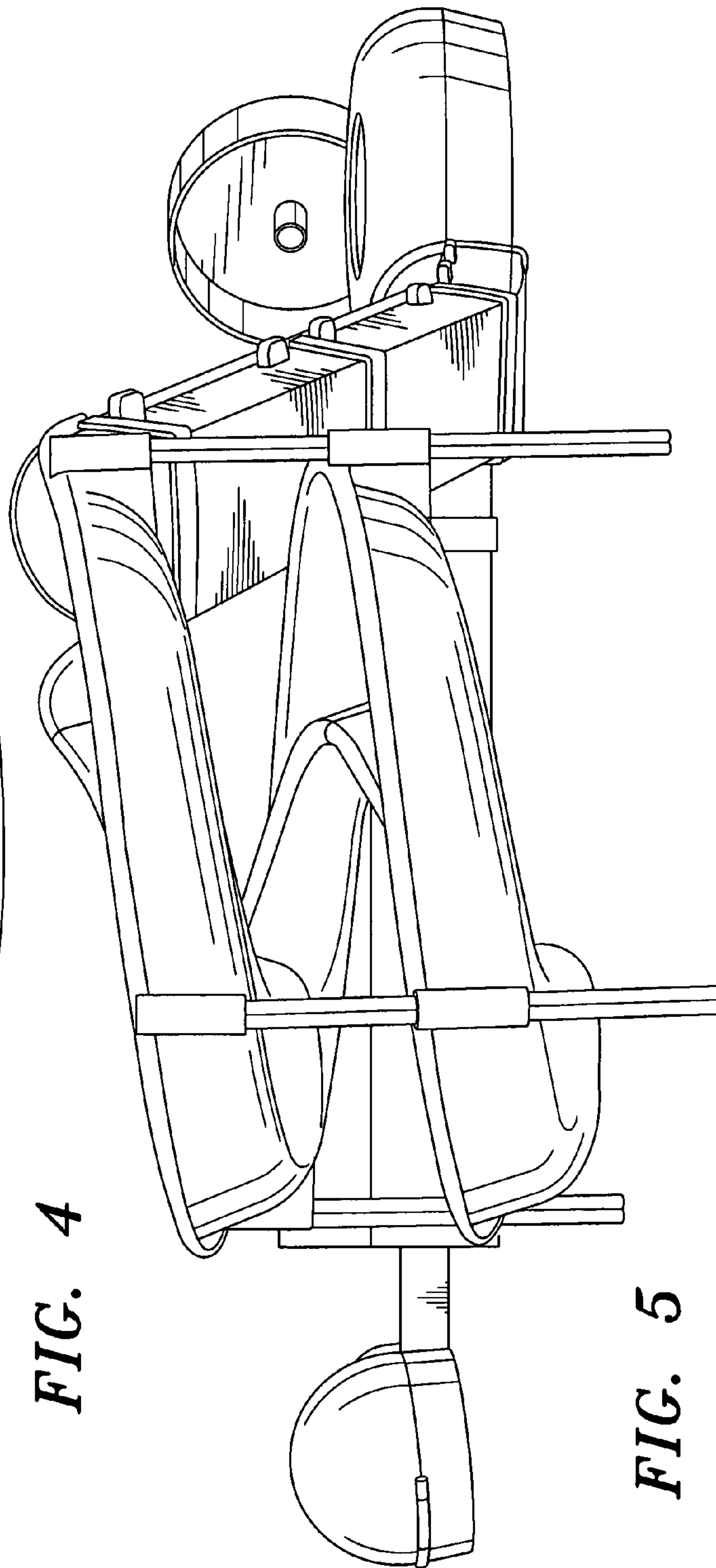

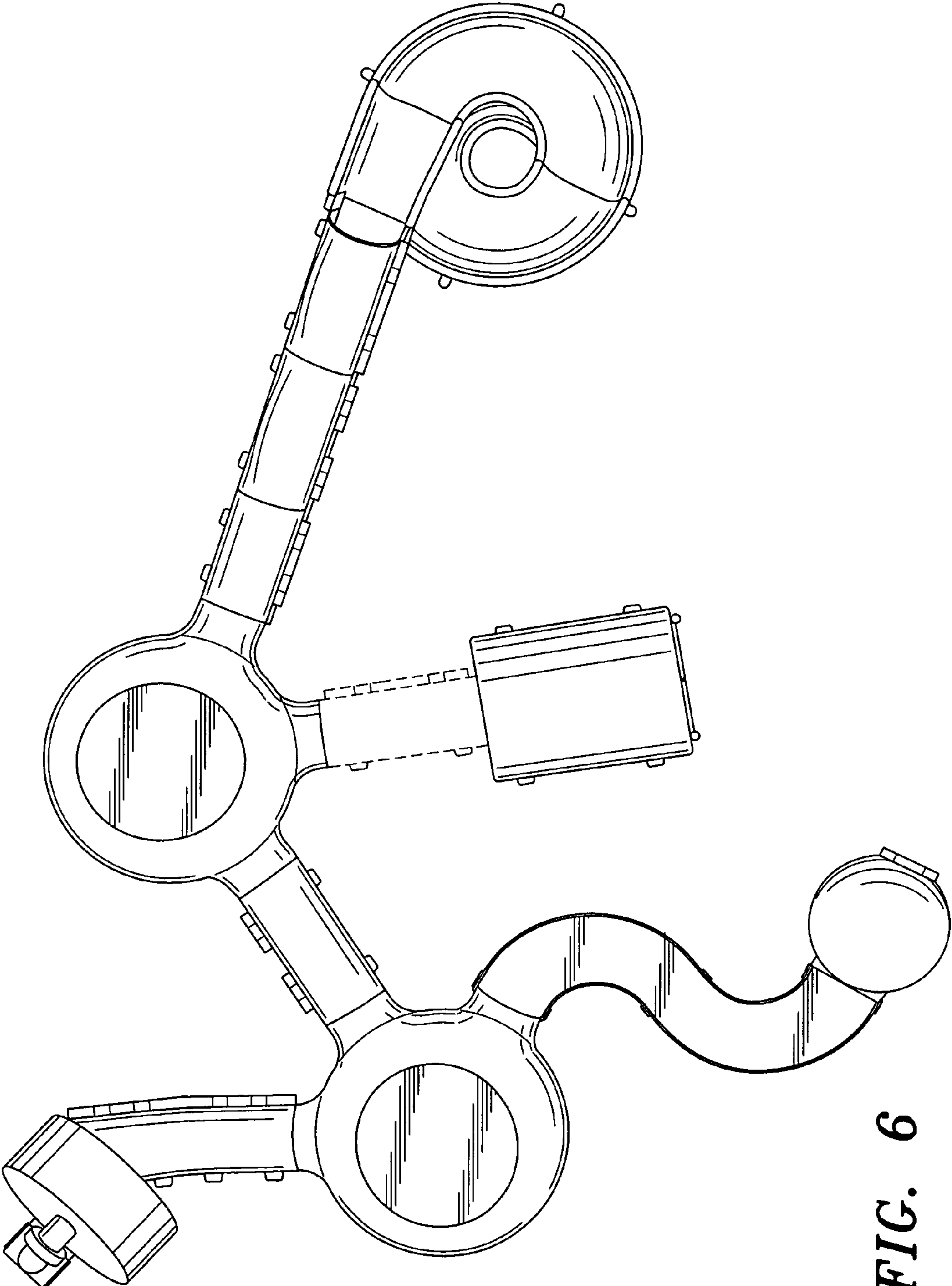

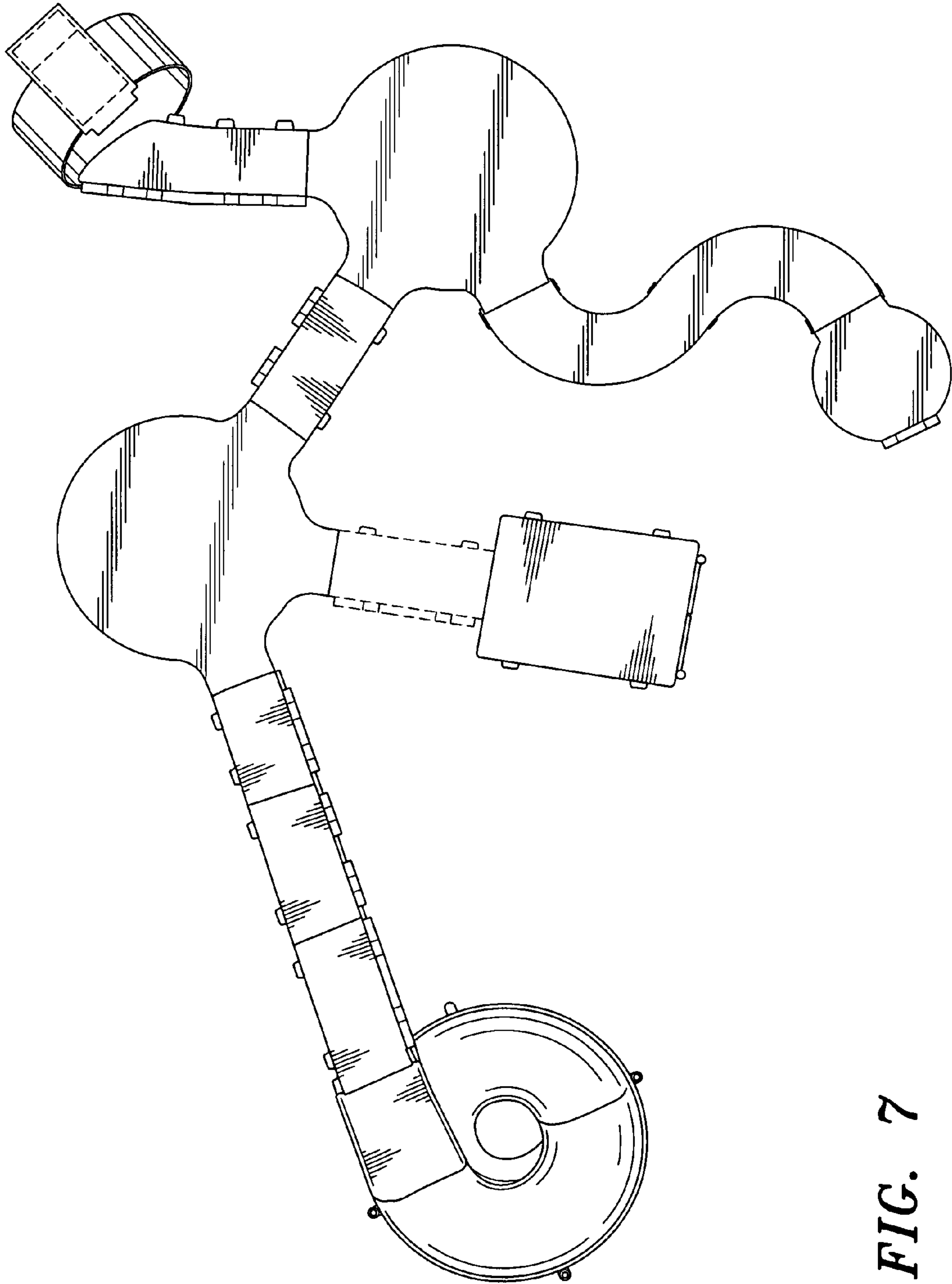
