(57) **CLAIM**

The ornamental design for an air conditioner, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom, and right side perspective view of an air conditioner showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; and, FIG. 8 is a vertical cross-sectional view thereof taken along line 8-8 in FIG. 2, with the broken-line disclosure understood to show internal elements which are part of the article in which the claimed design is embodied, but which form no part of the claimed design.

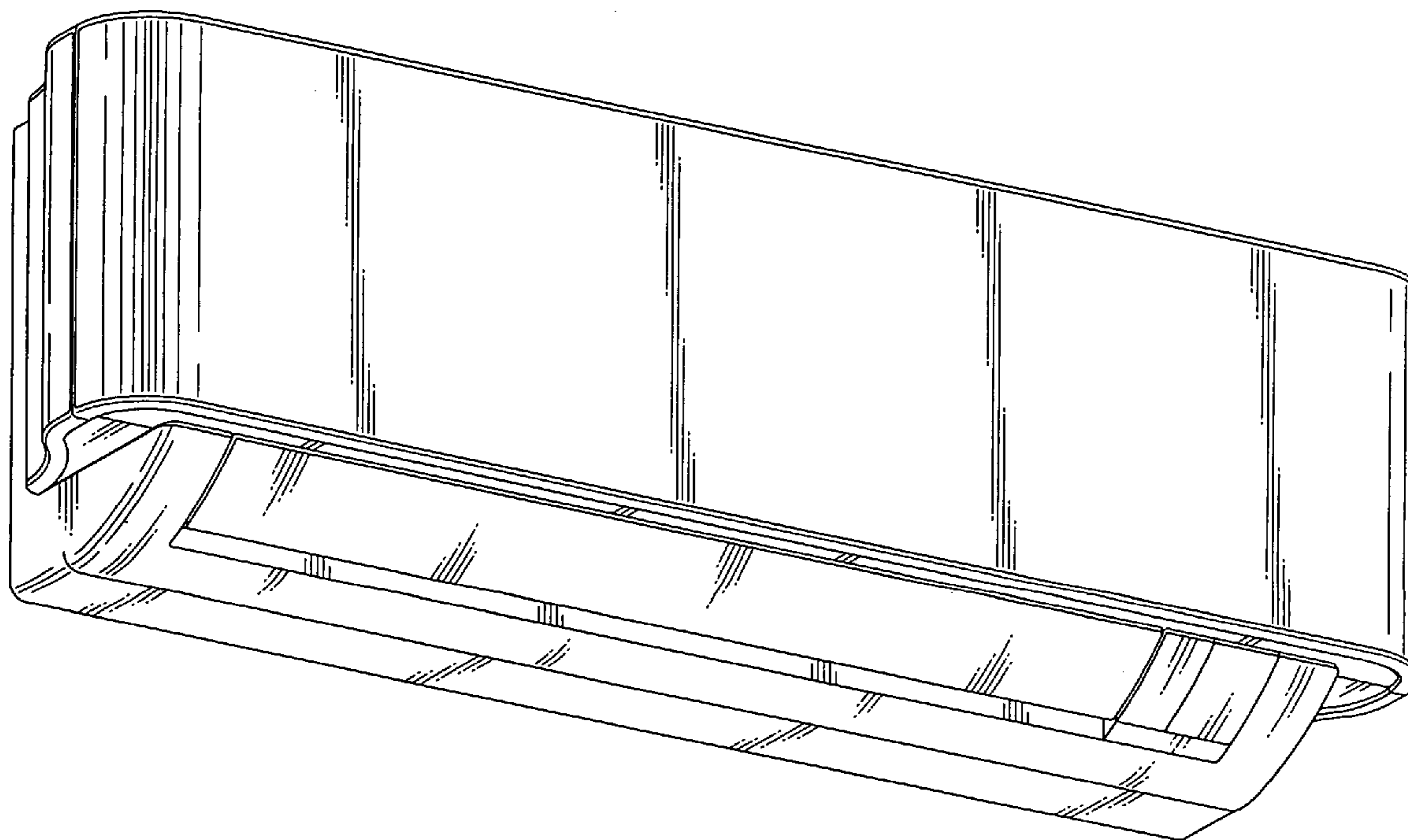

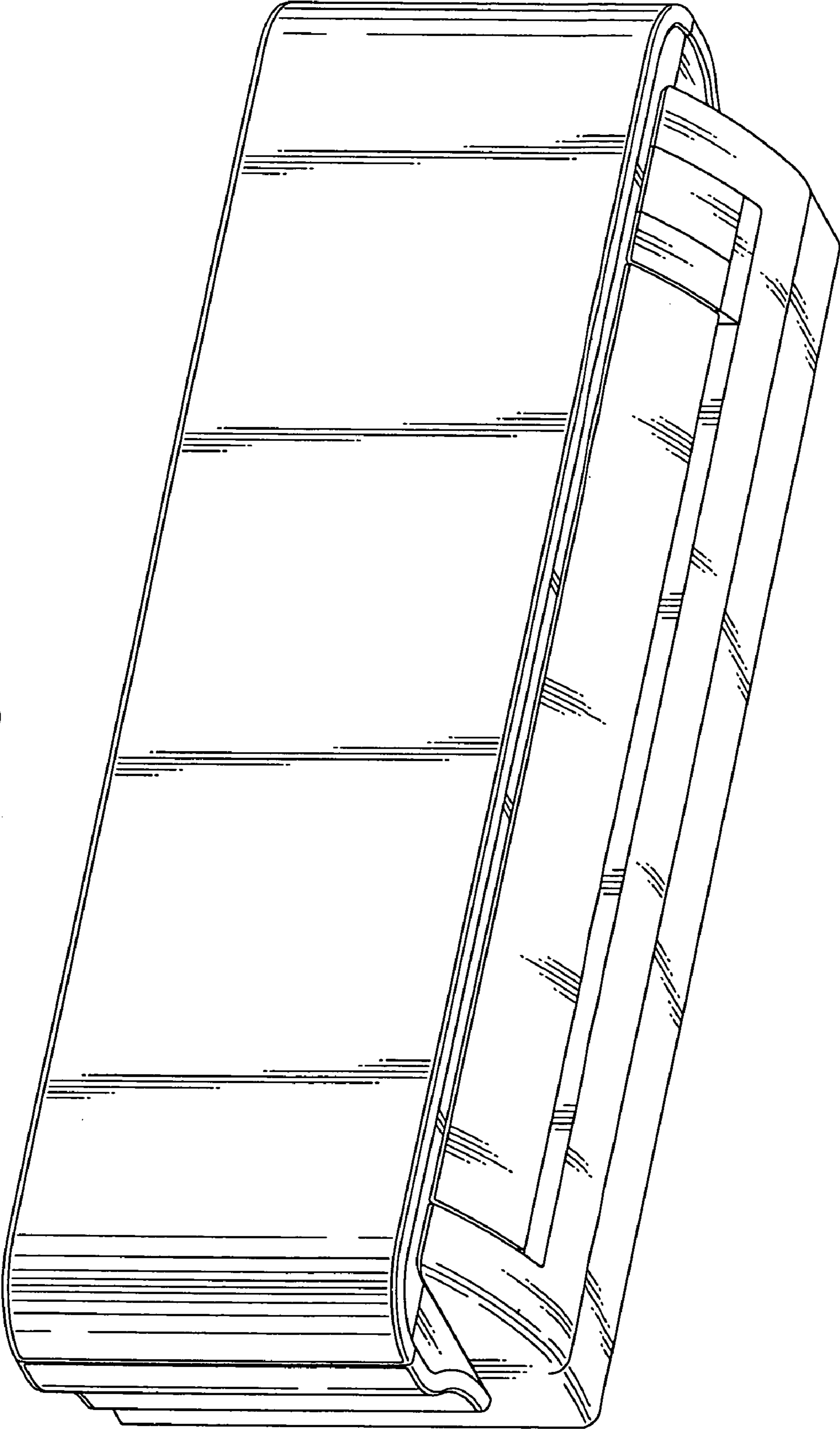

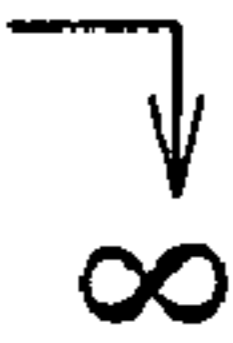
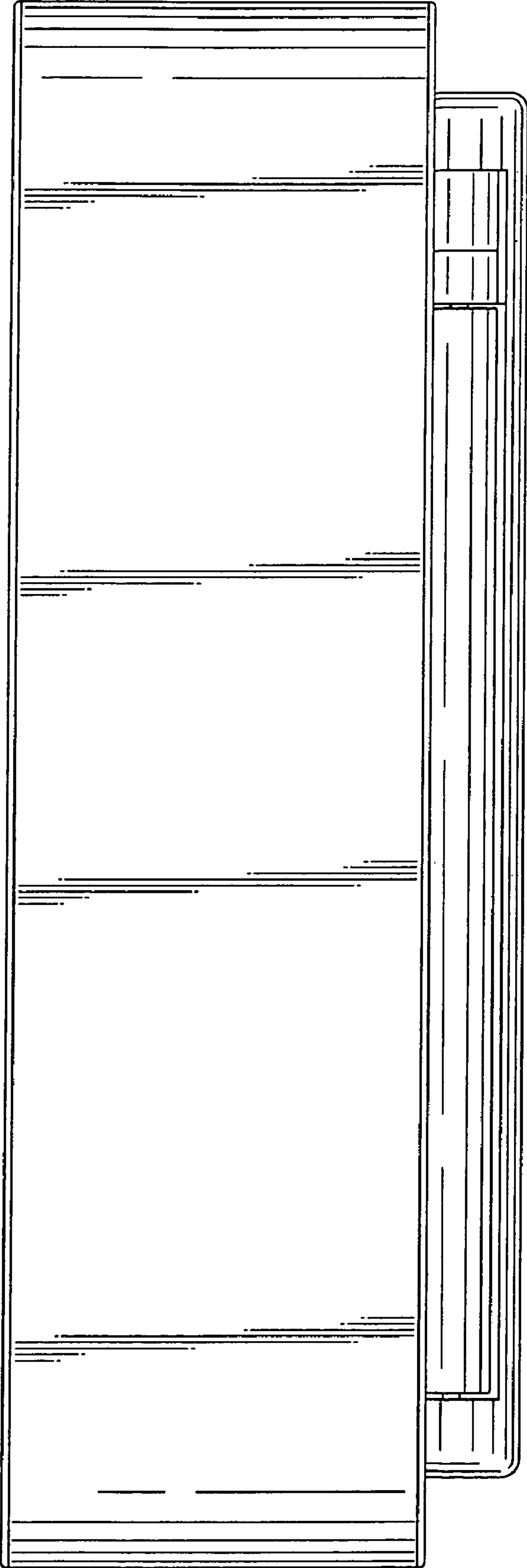
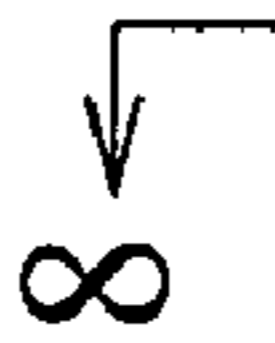

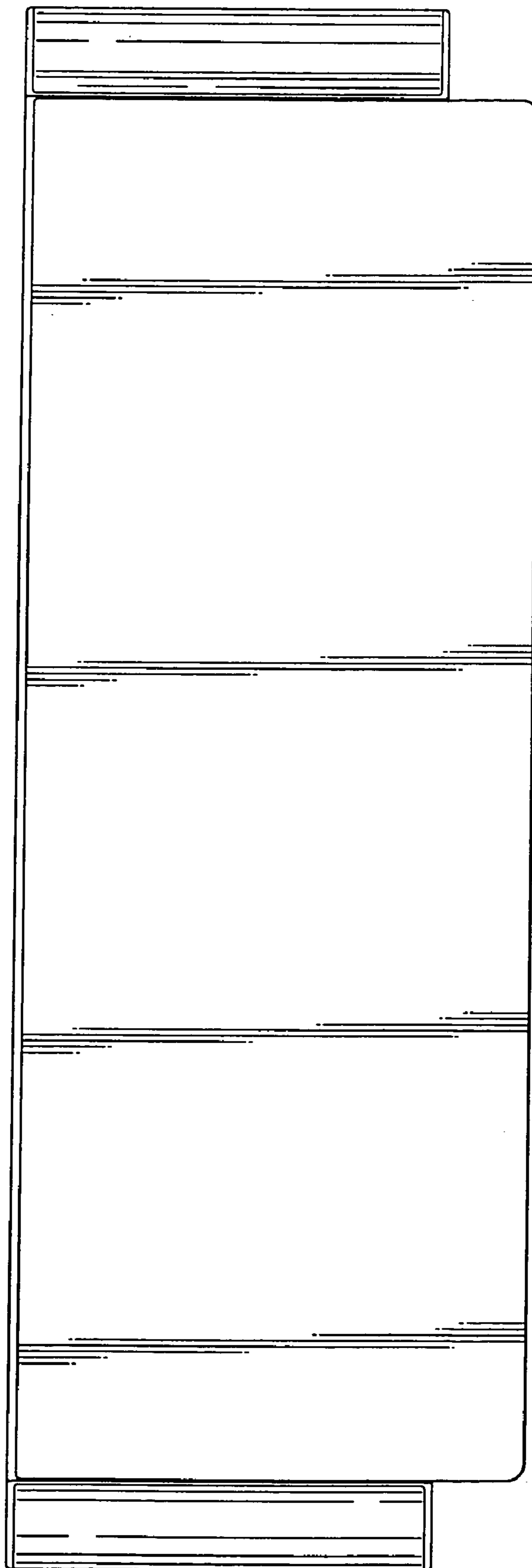

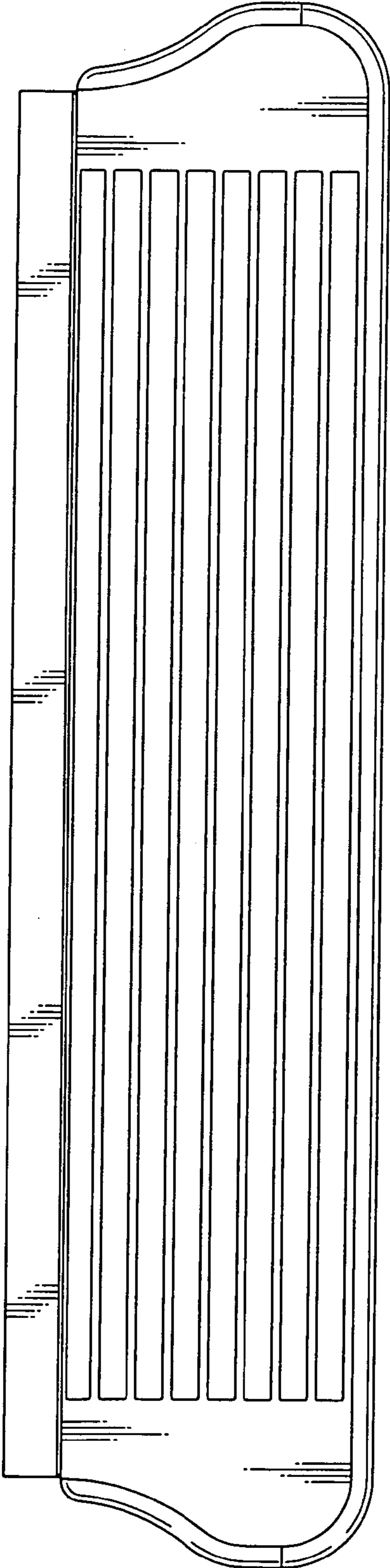

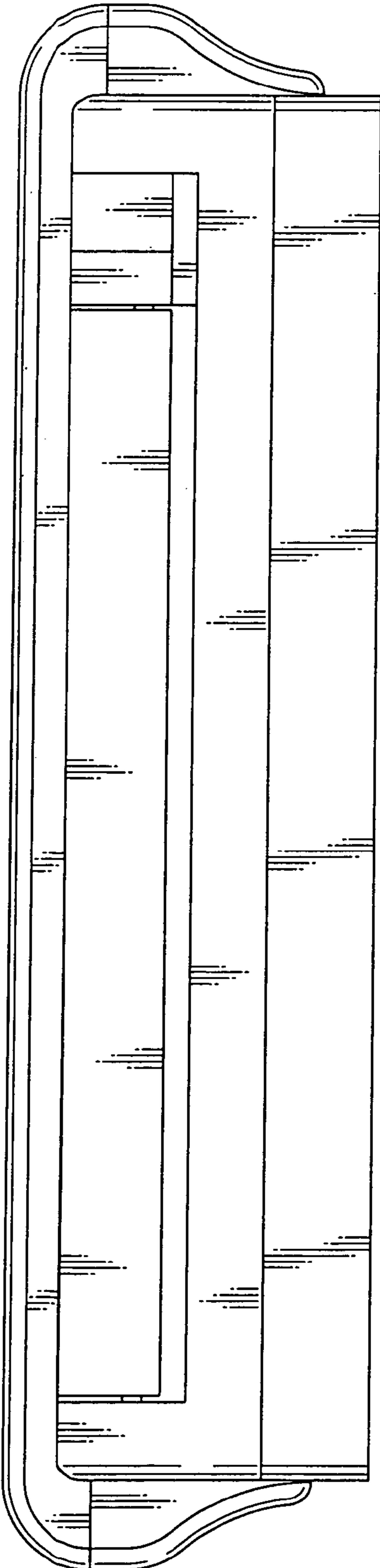

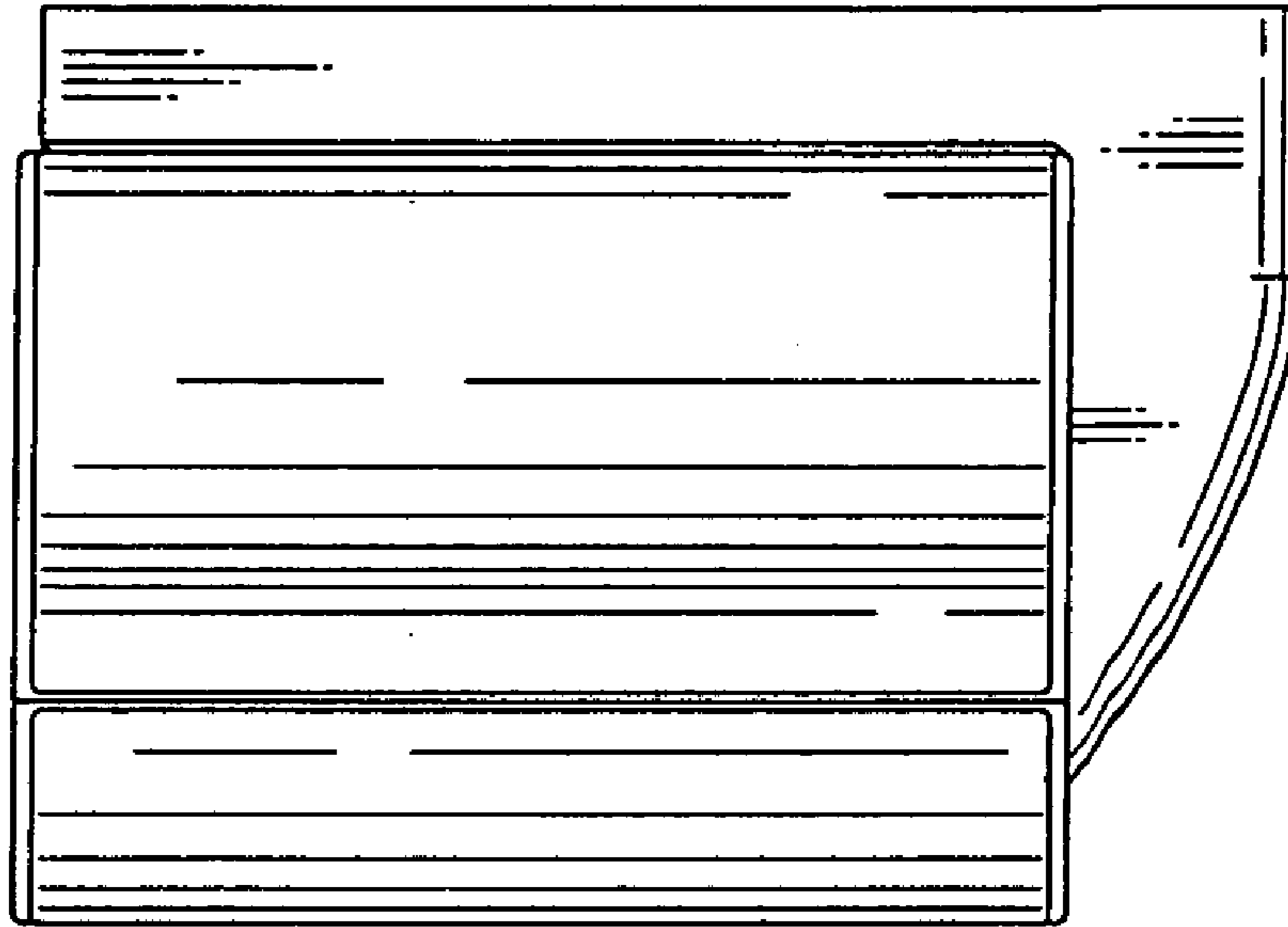

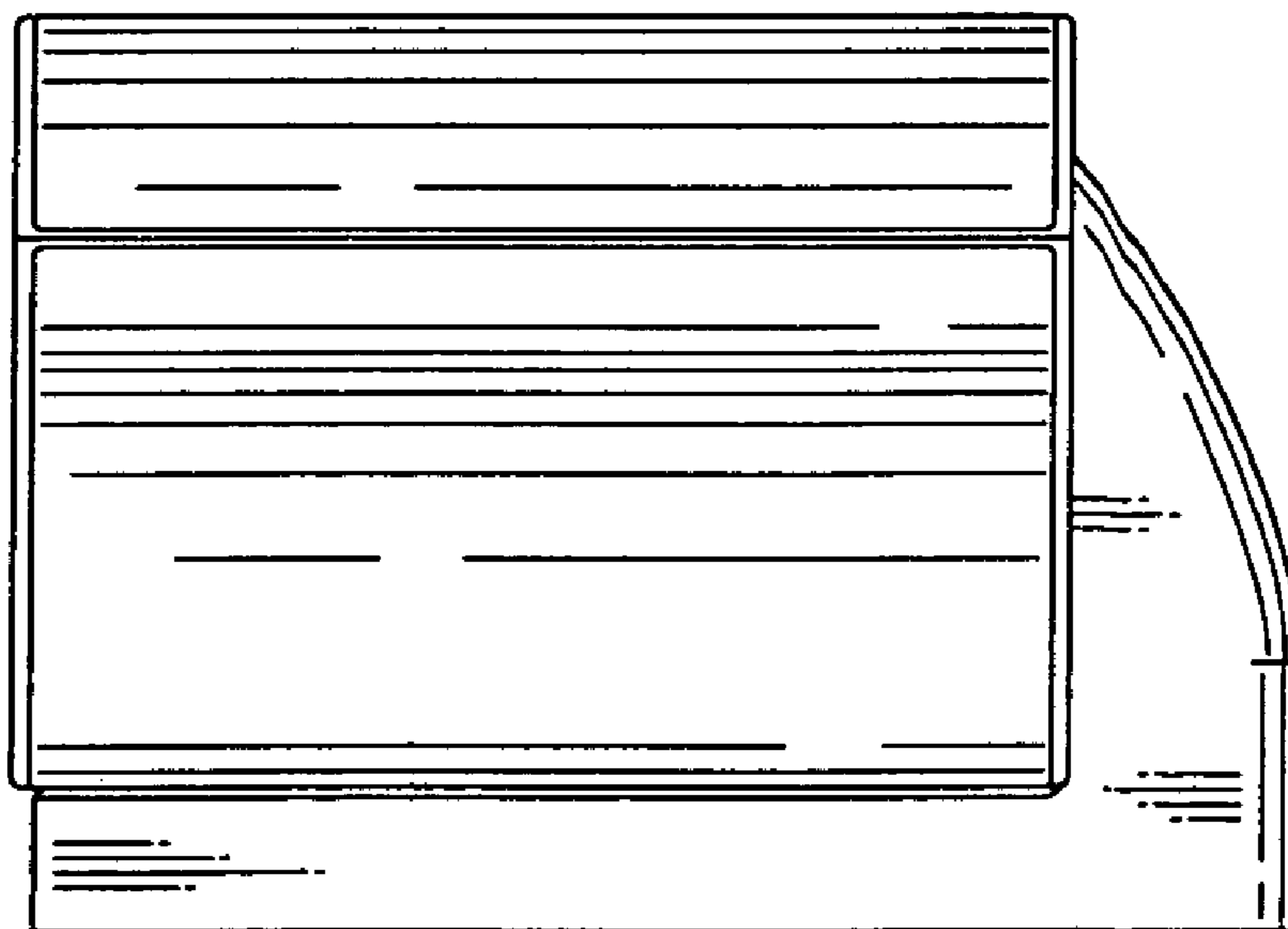
